(57) **CLAIM**

We claim the ornamental design for the four-pronged display hook back for slatwall, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a four-pronged display hook back for slatwall showing our new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a left side elevational view thereof;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a right side elevational view thereof; and,
FIG. 6 is a bottom plan view thereof.

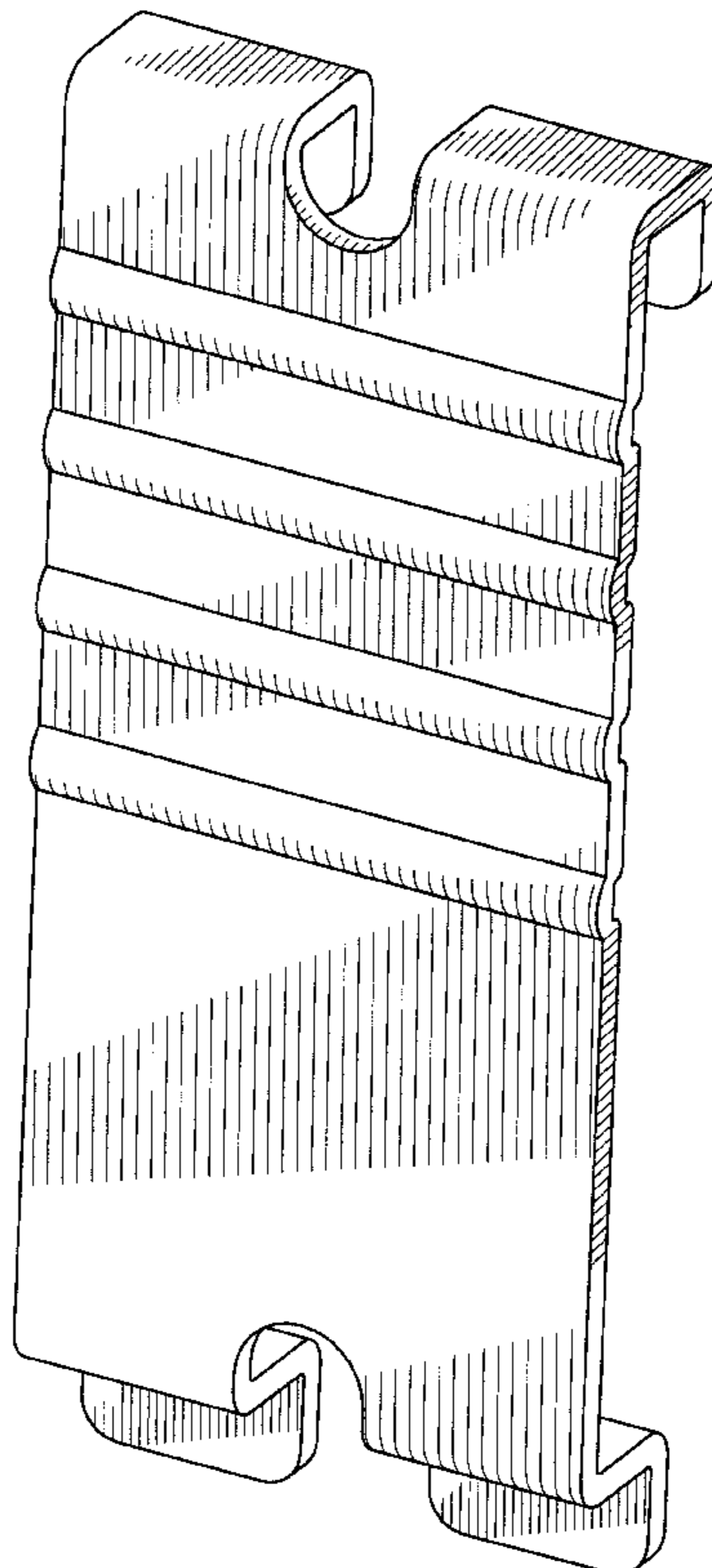

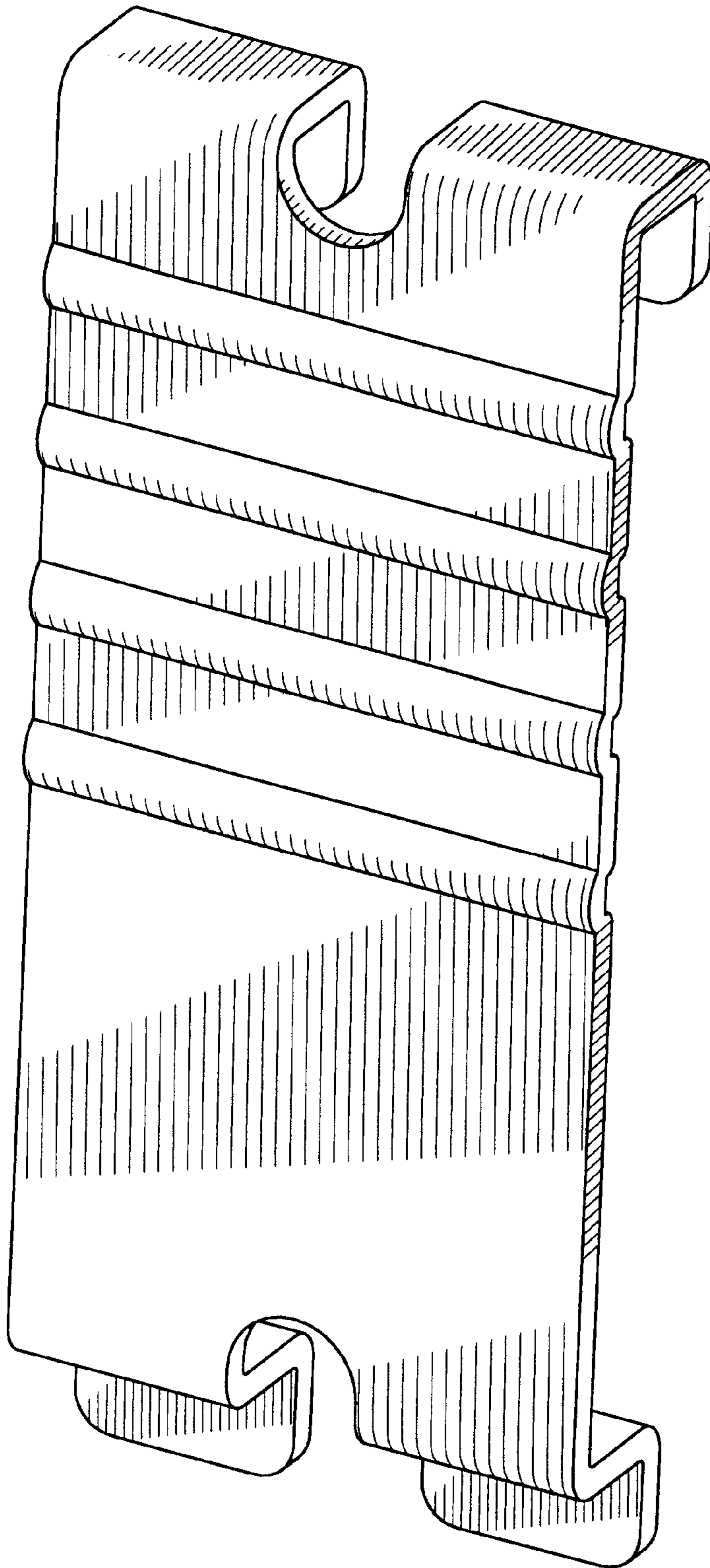

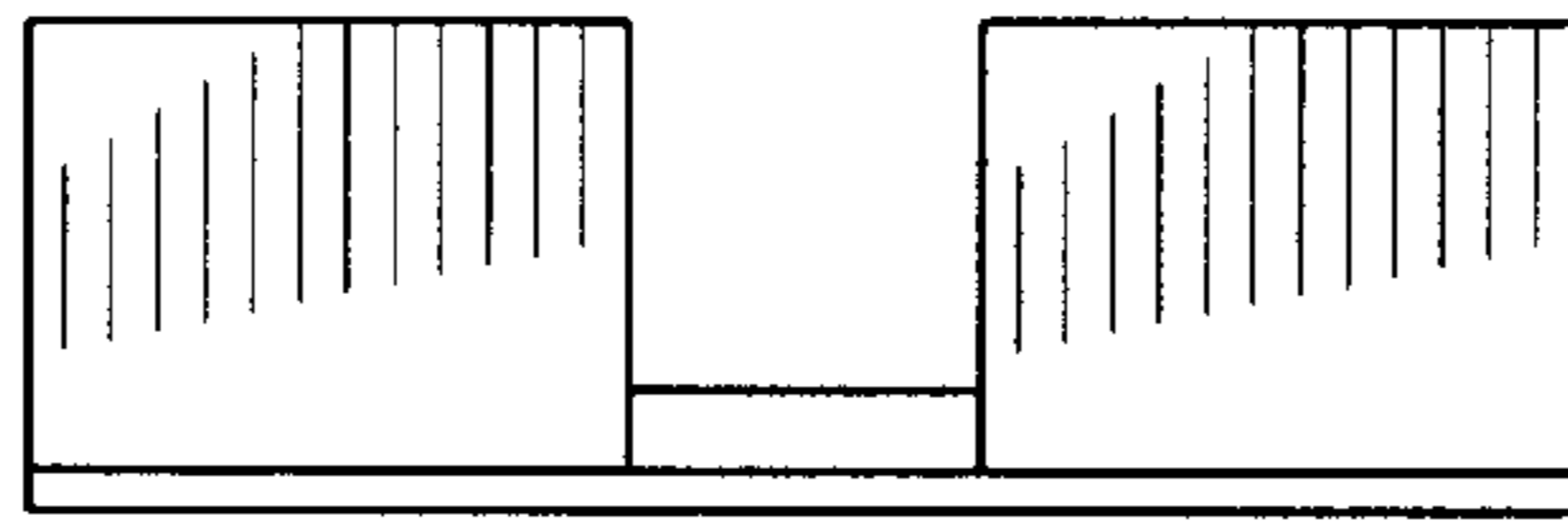

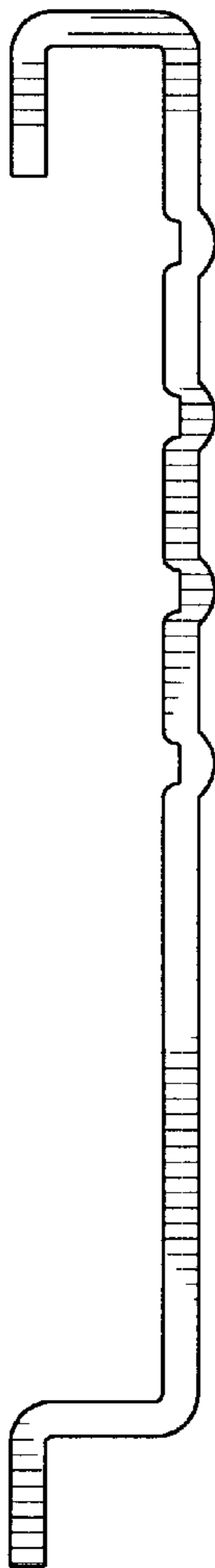

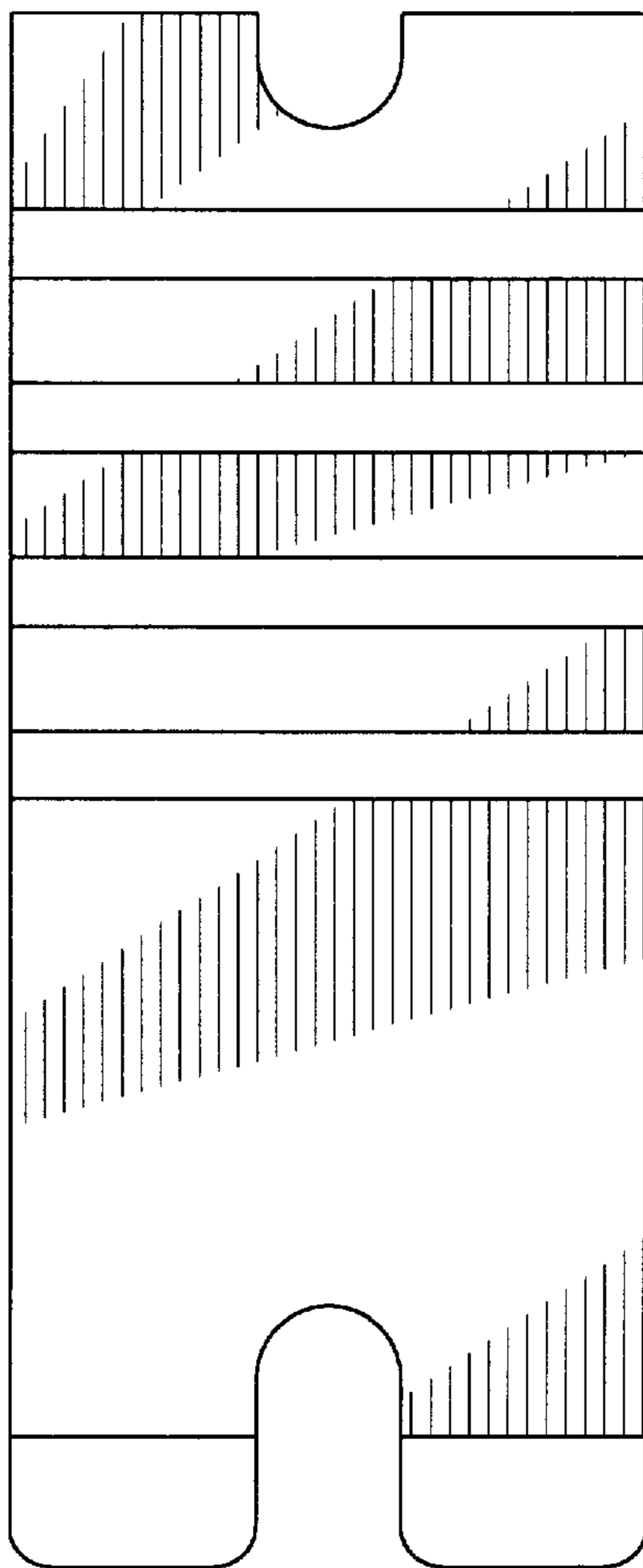

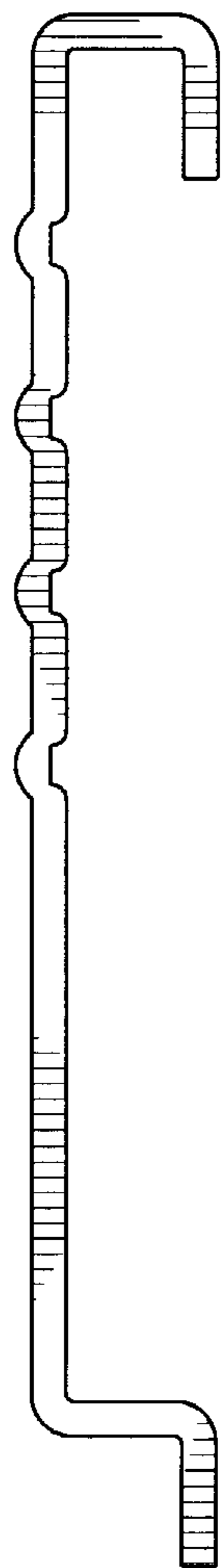
