The ornamental design of a small flower vase, as shown.

**DESCRIPTION**

FIG. 1 is a front elevation view of a small flower vase showing my new design;  
 FIG. 2 is a rear elevation view thereof;  
 FIG. 3 is a side elevation view thereof;  
 FIG. 4 is a top plan view thereof;  
 FIG. 5 is a bottom plan view thereof;  
 FIG. 6 is a perspective view thereof;  
 FIG. 7 is a cross-sectional view taken in the direction of the arrows on line 7—7 of FIG. 4; and,  
 FIG. 8 is a cross-sectional view taken in the direction of the arrows on line 8—8 of FIG. 4.

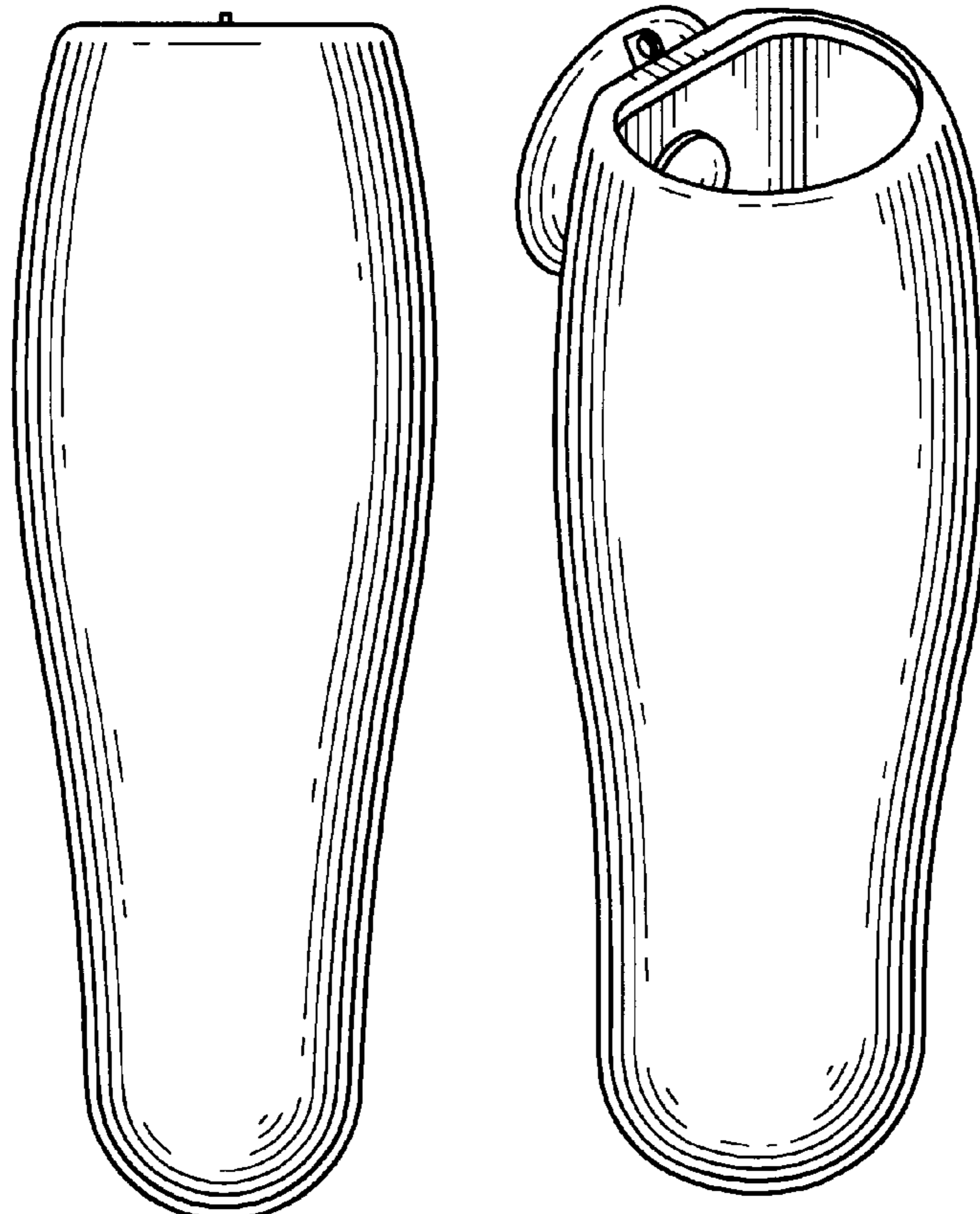

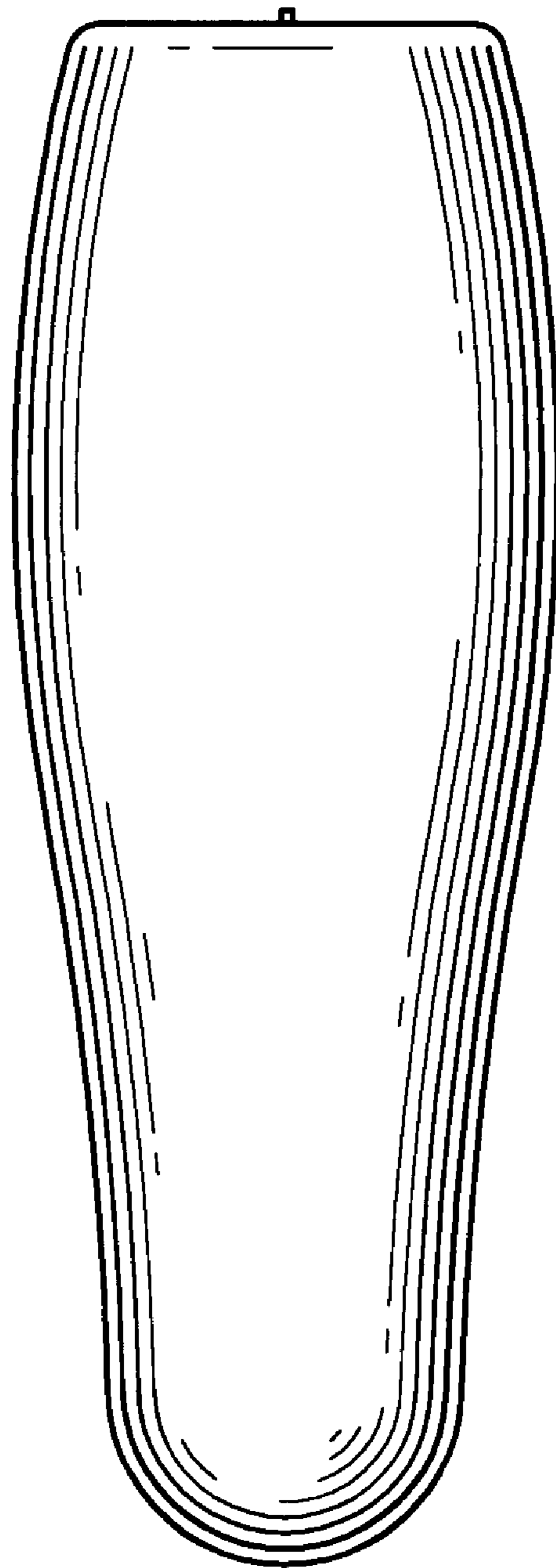

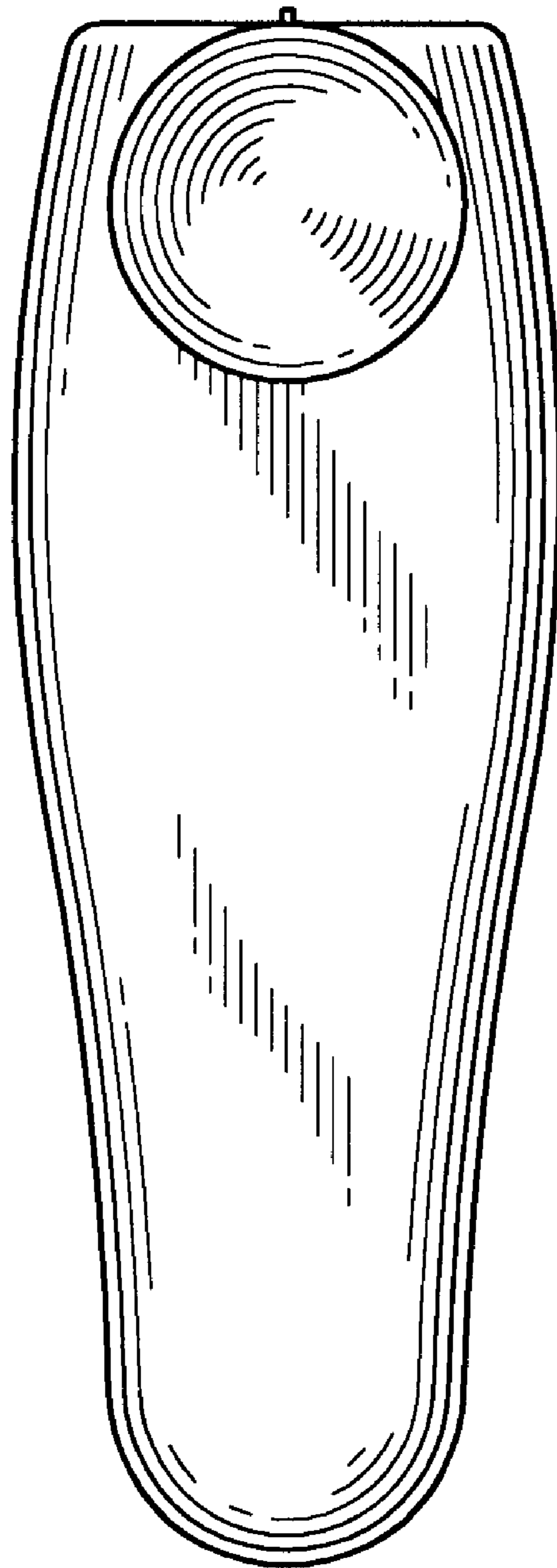
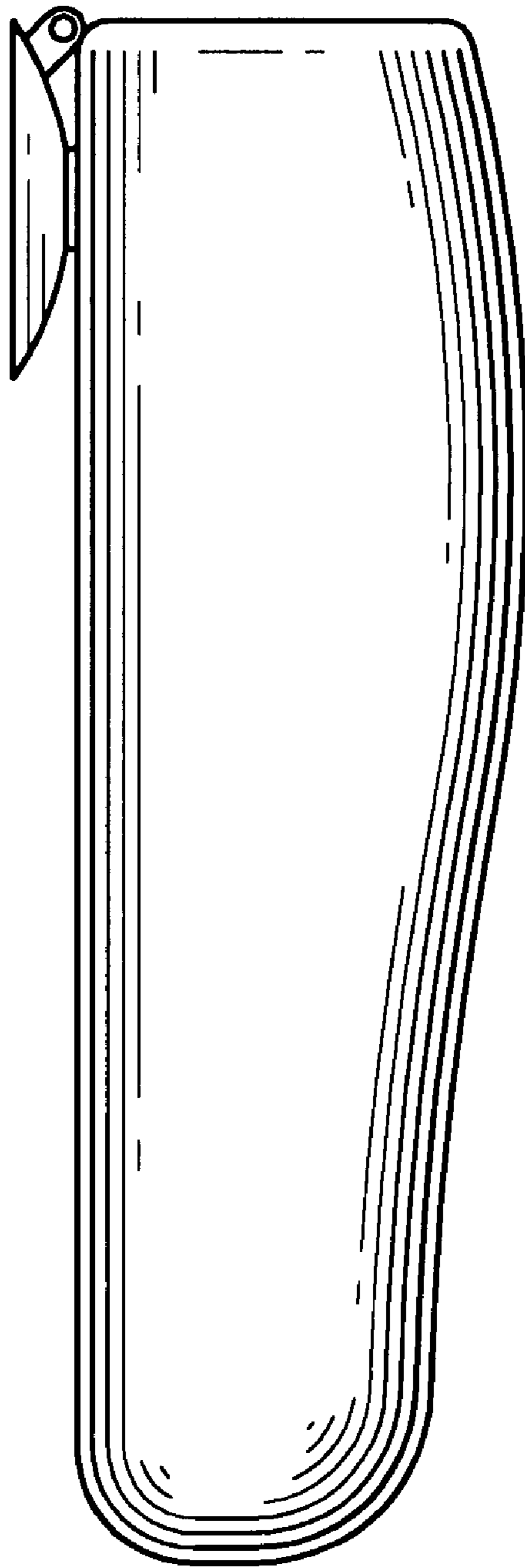
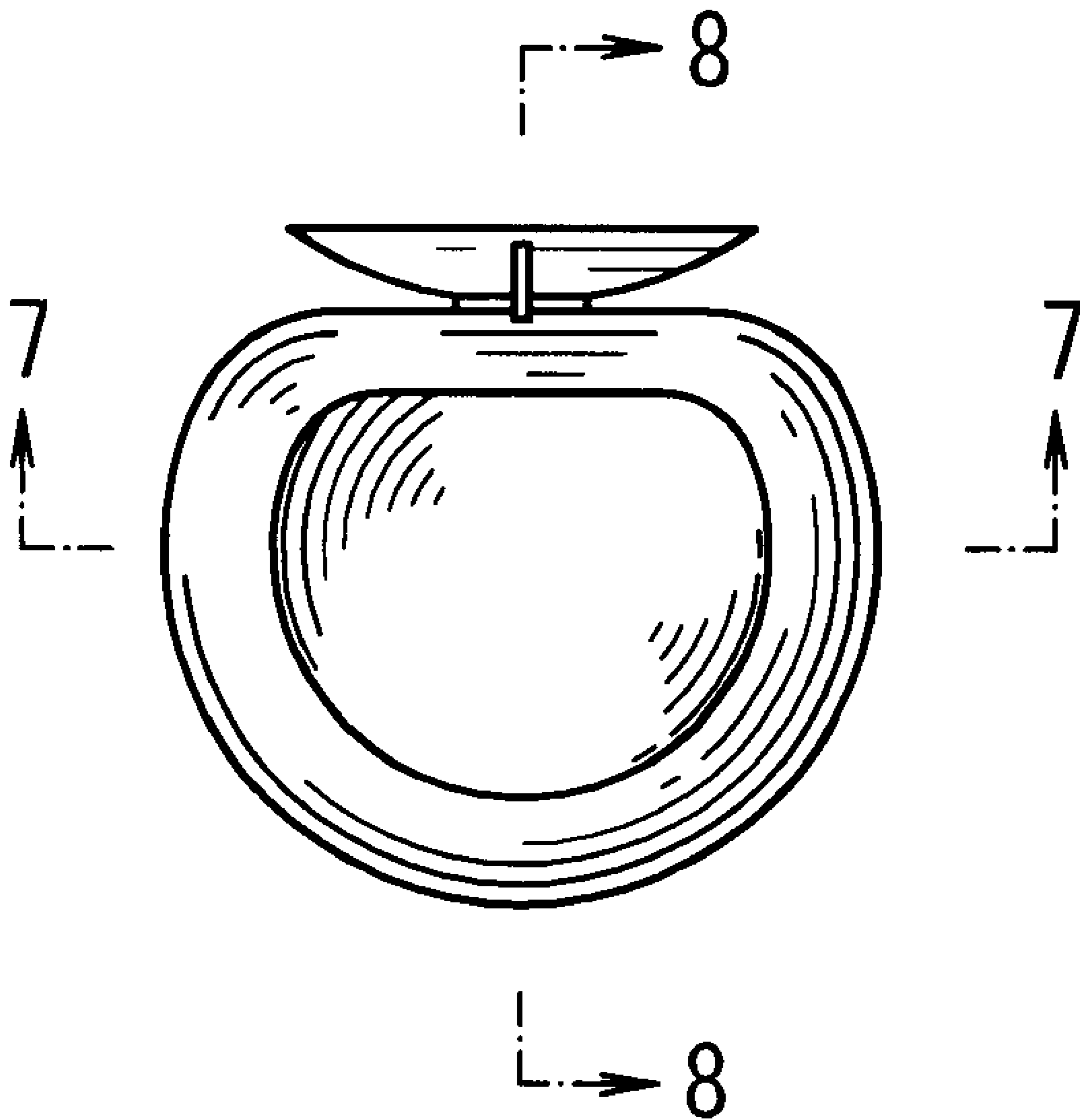

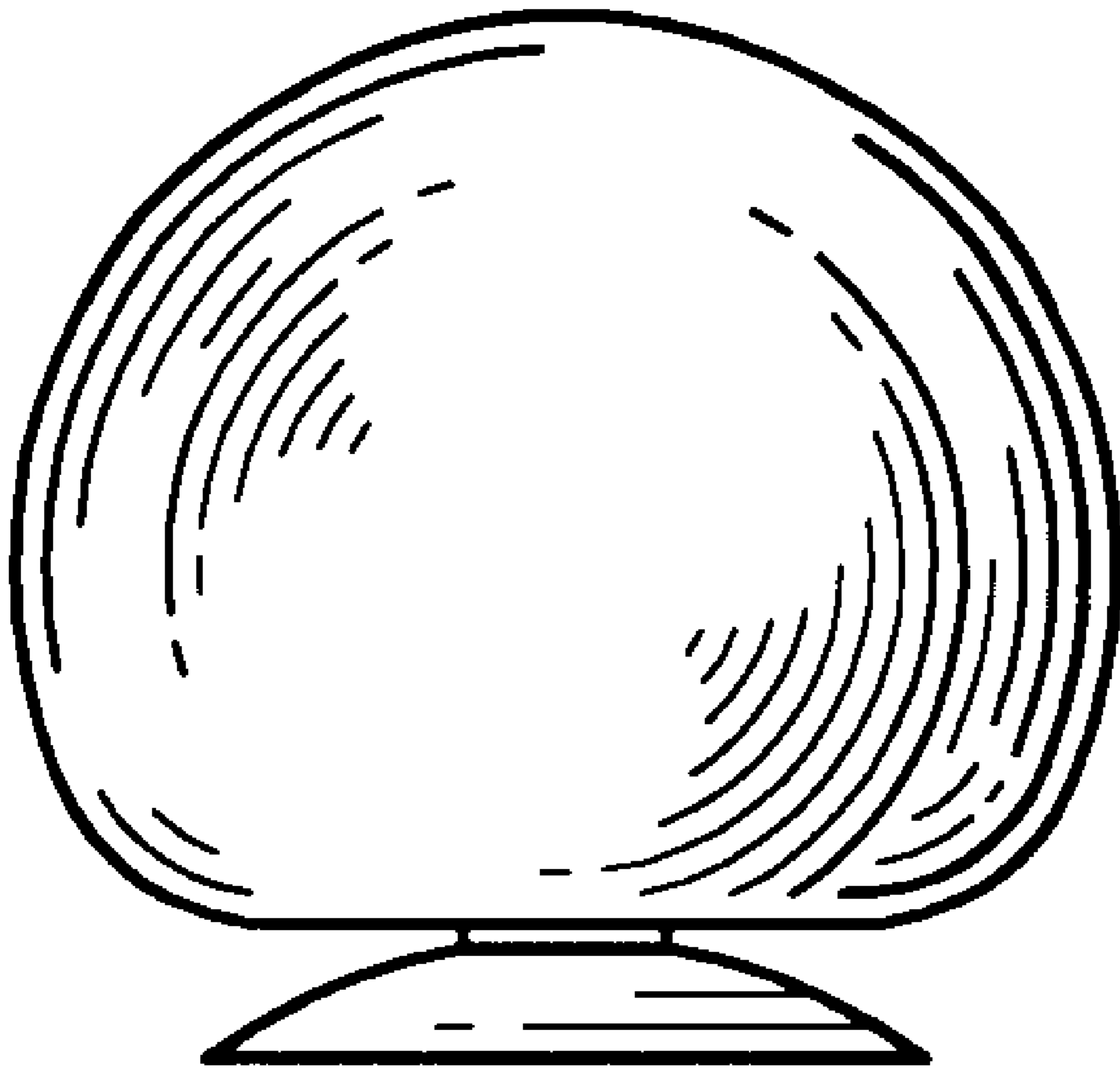

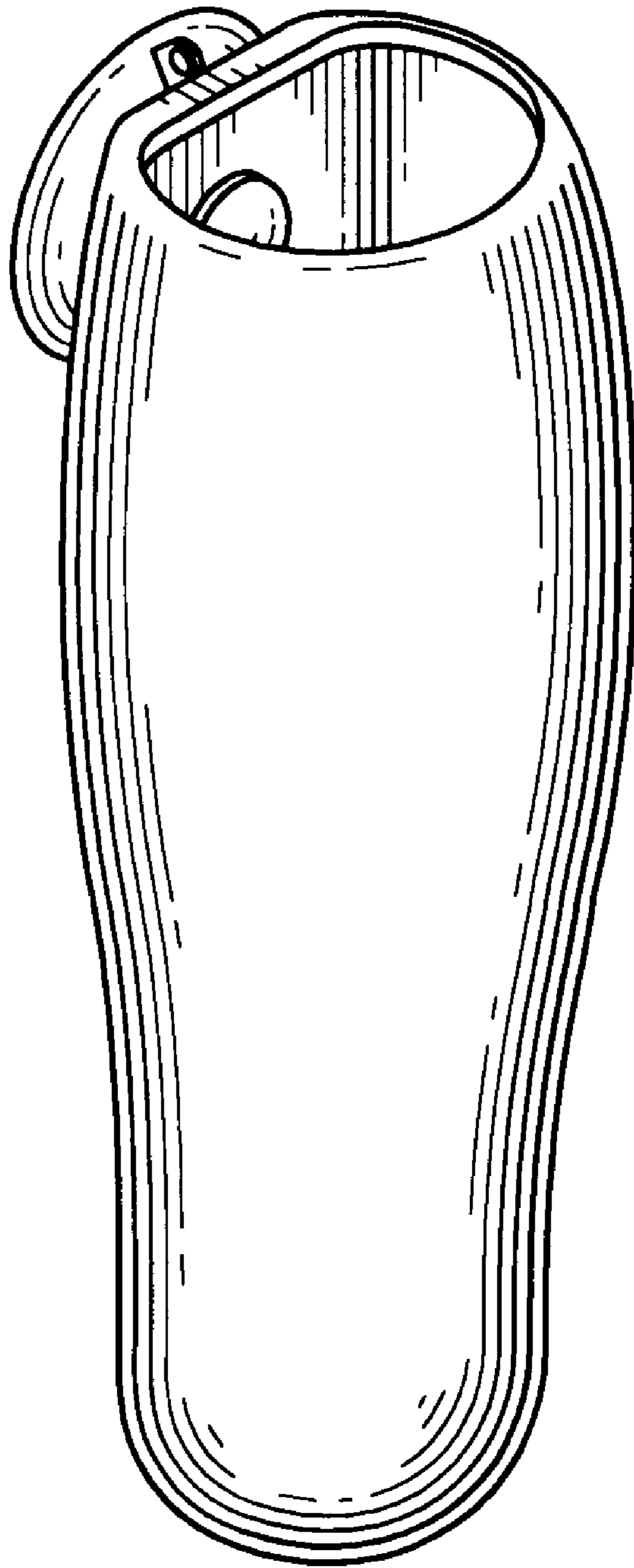

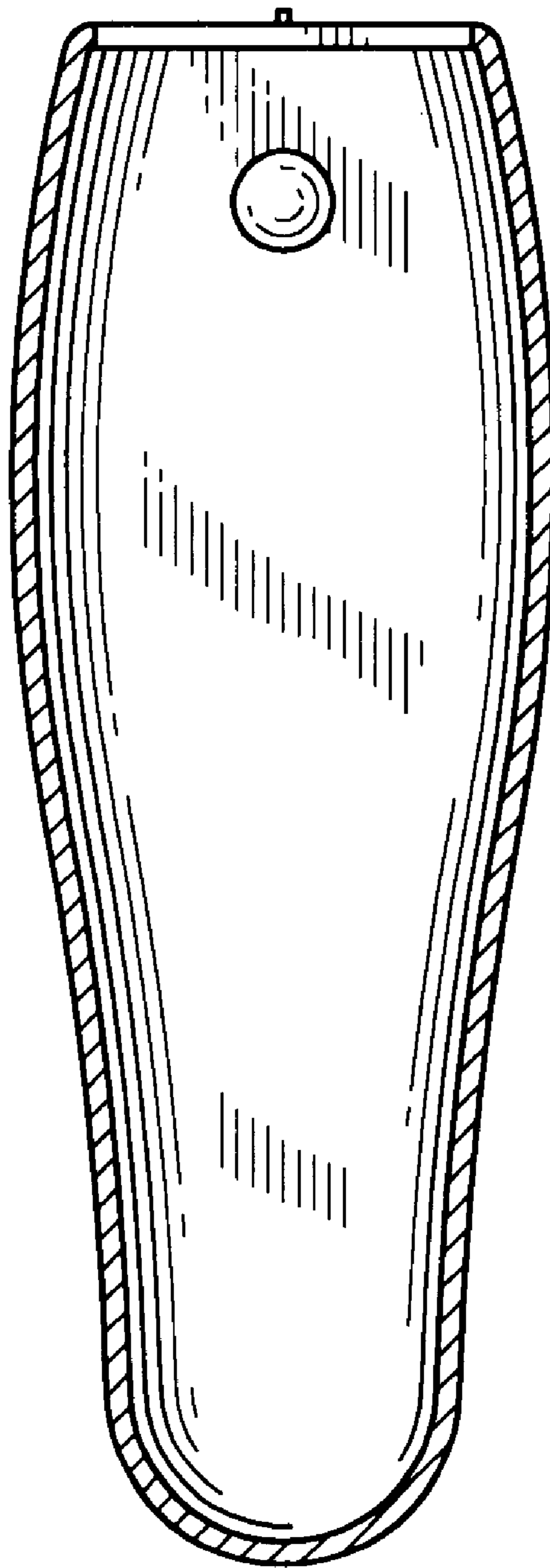
