FIG. 6 is a rear elevation of our pen or pencil holder design.

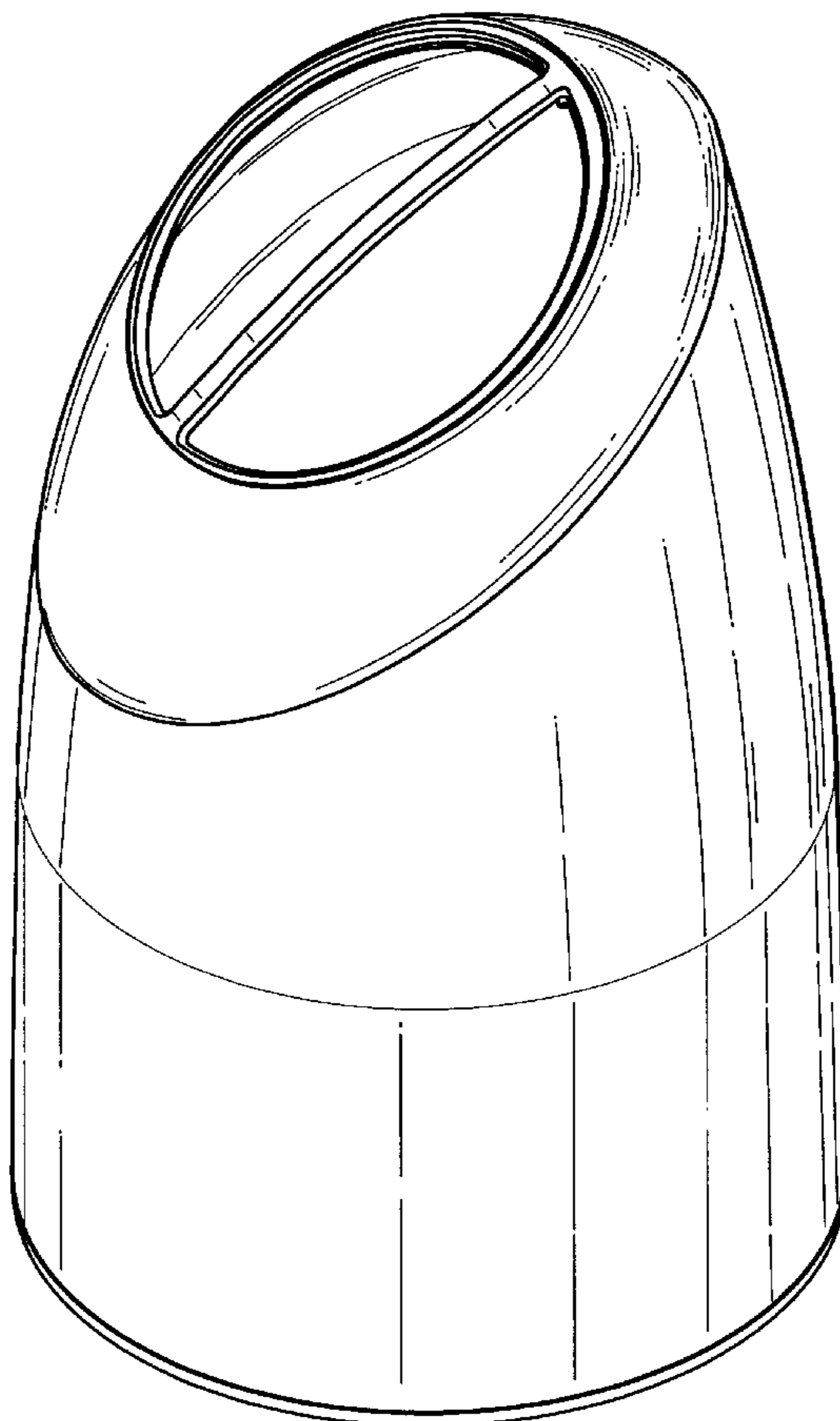
It is to be understood that the bottom of our pen or pencil holder design is plain and unornamented.

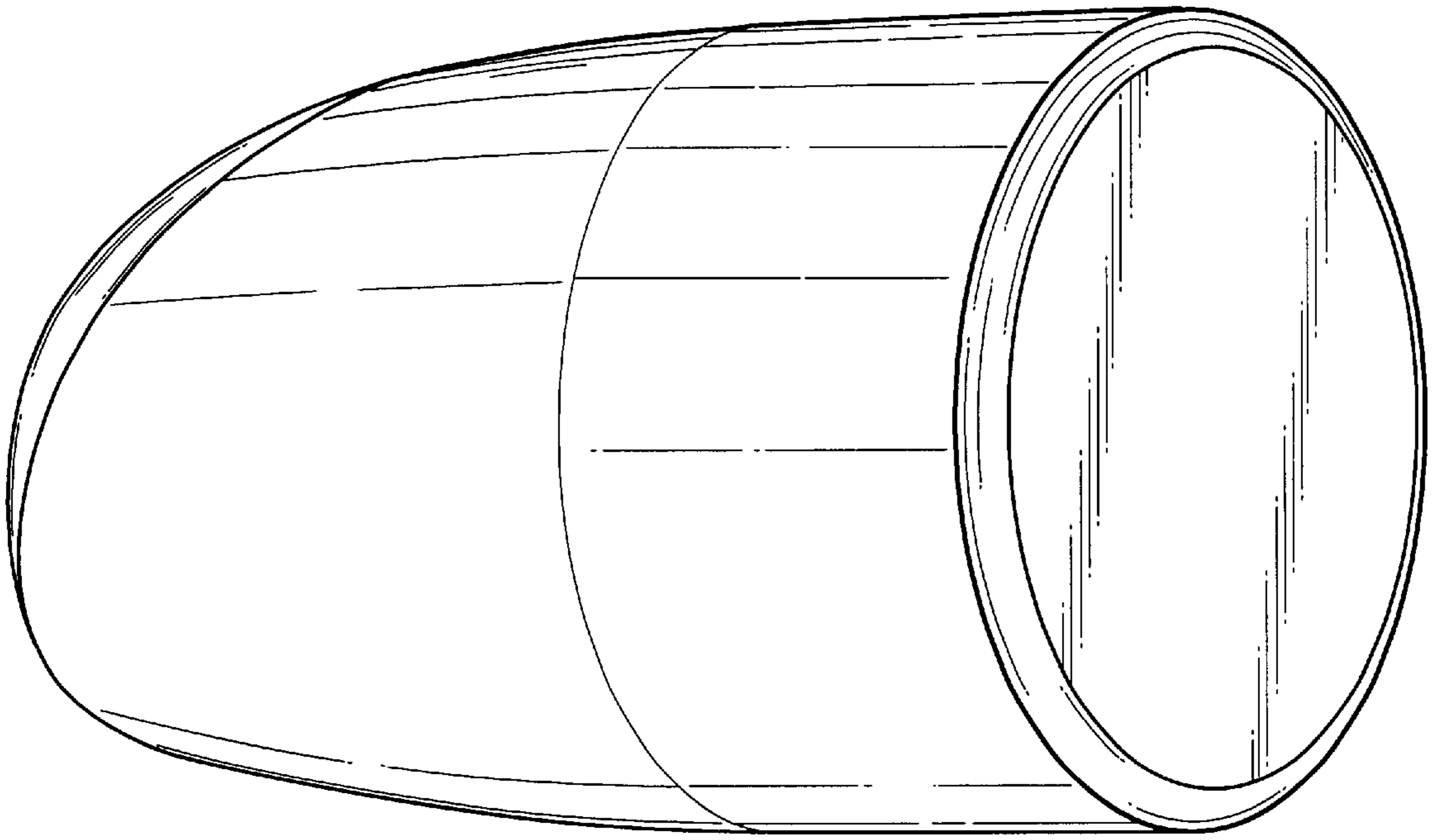

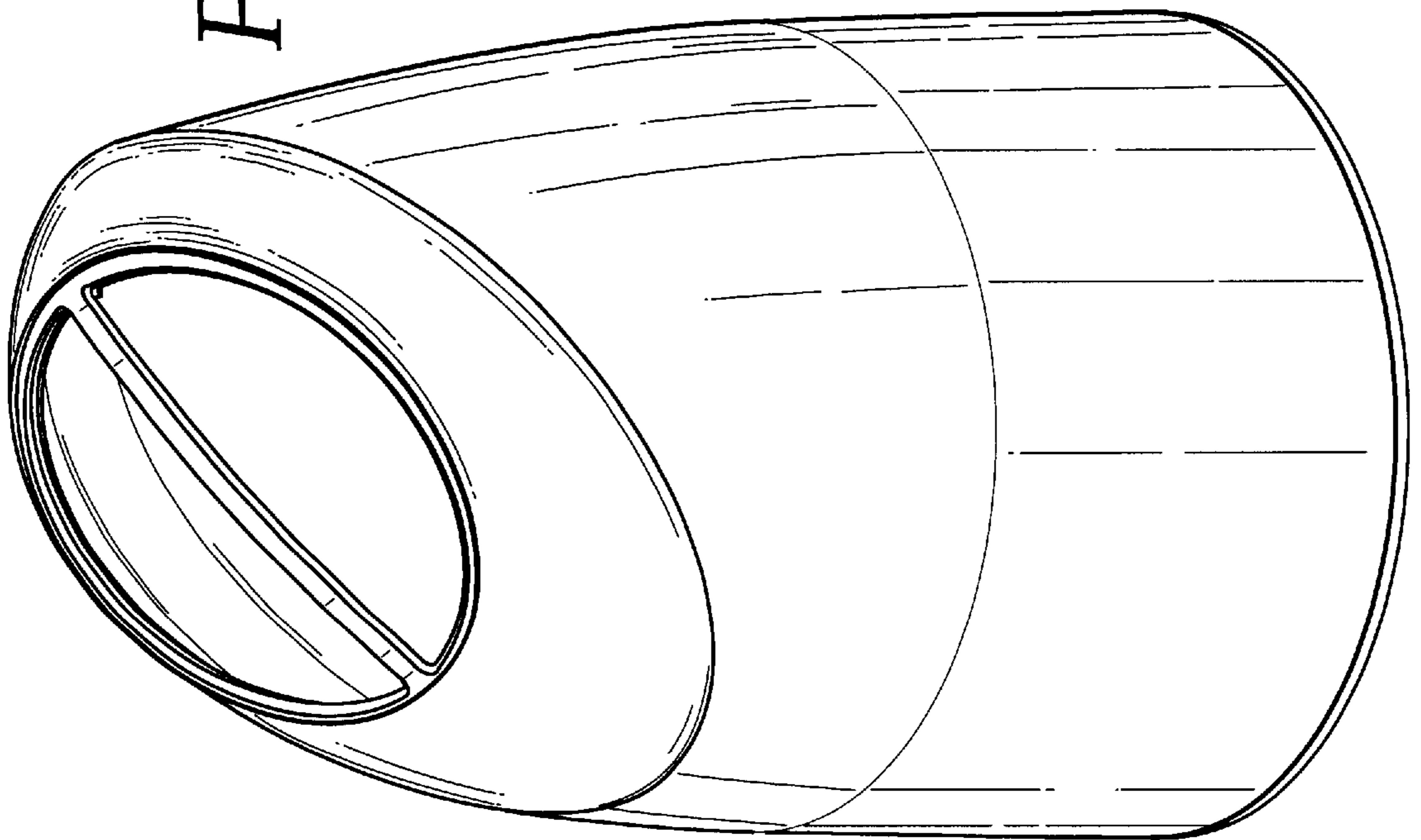

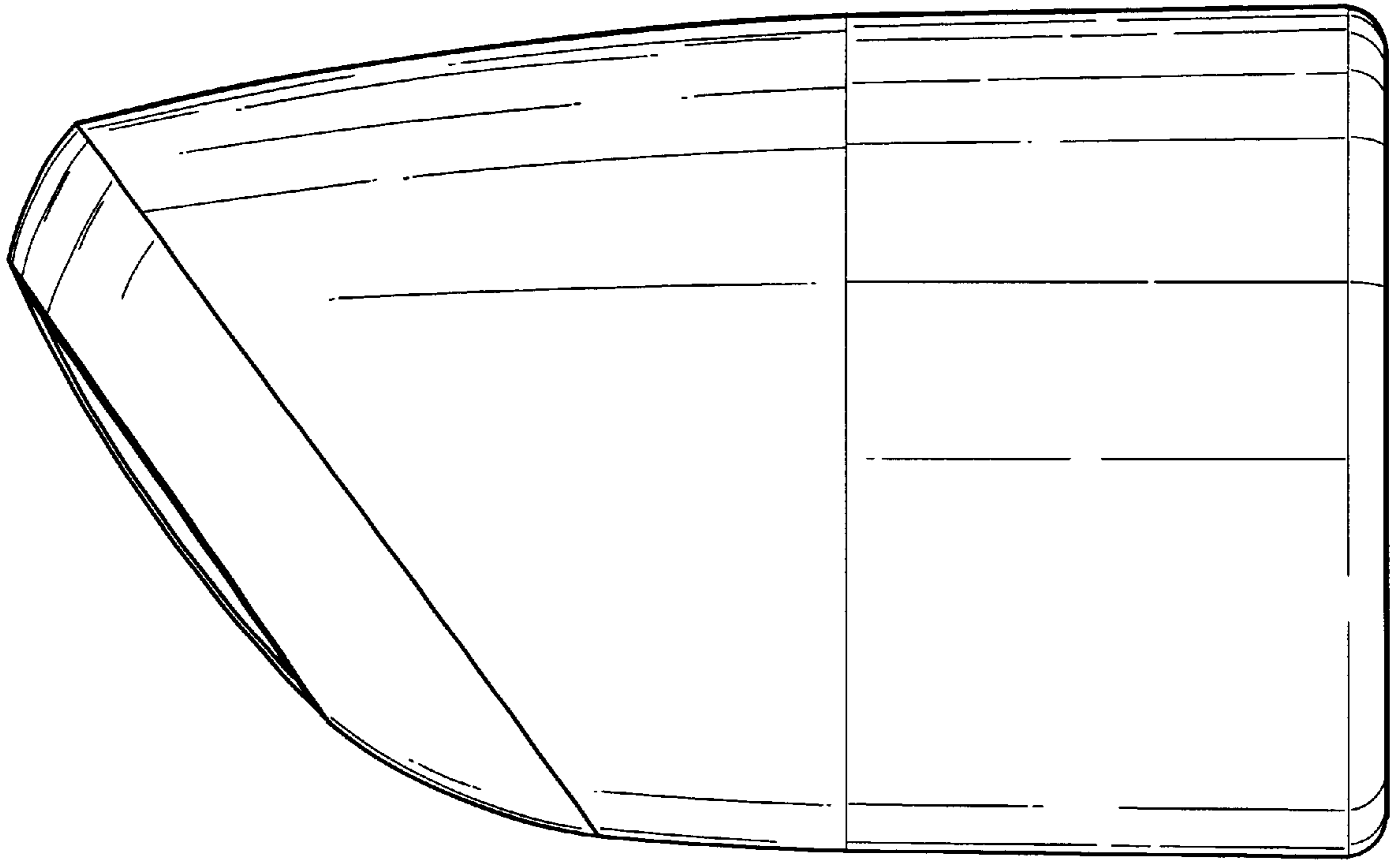

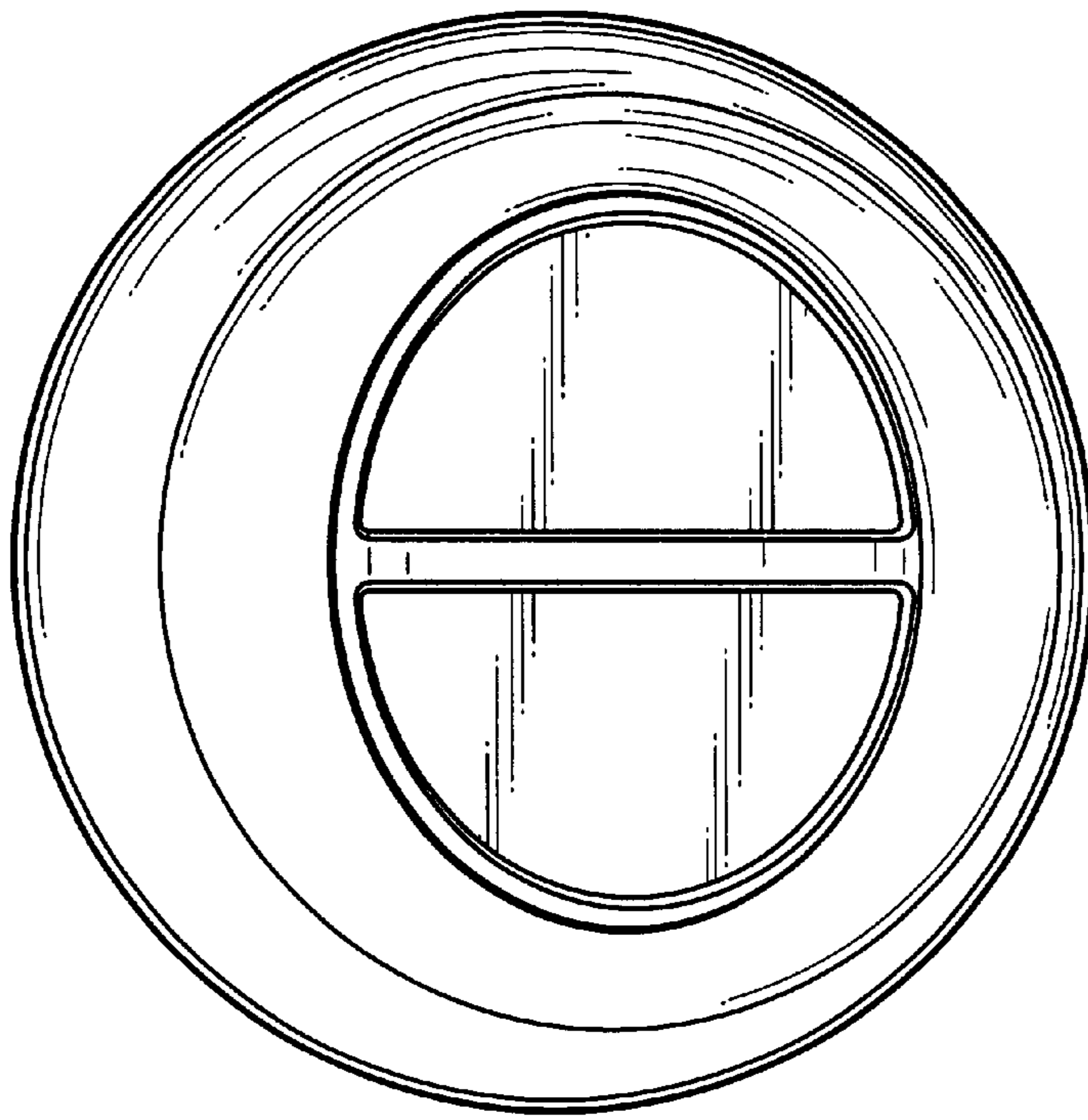

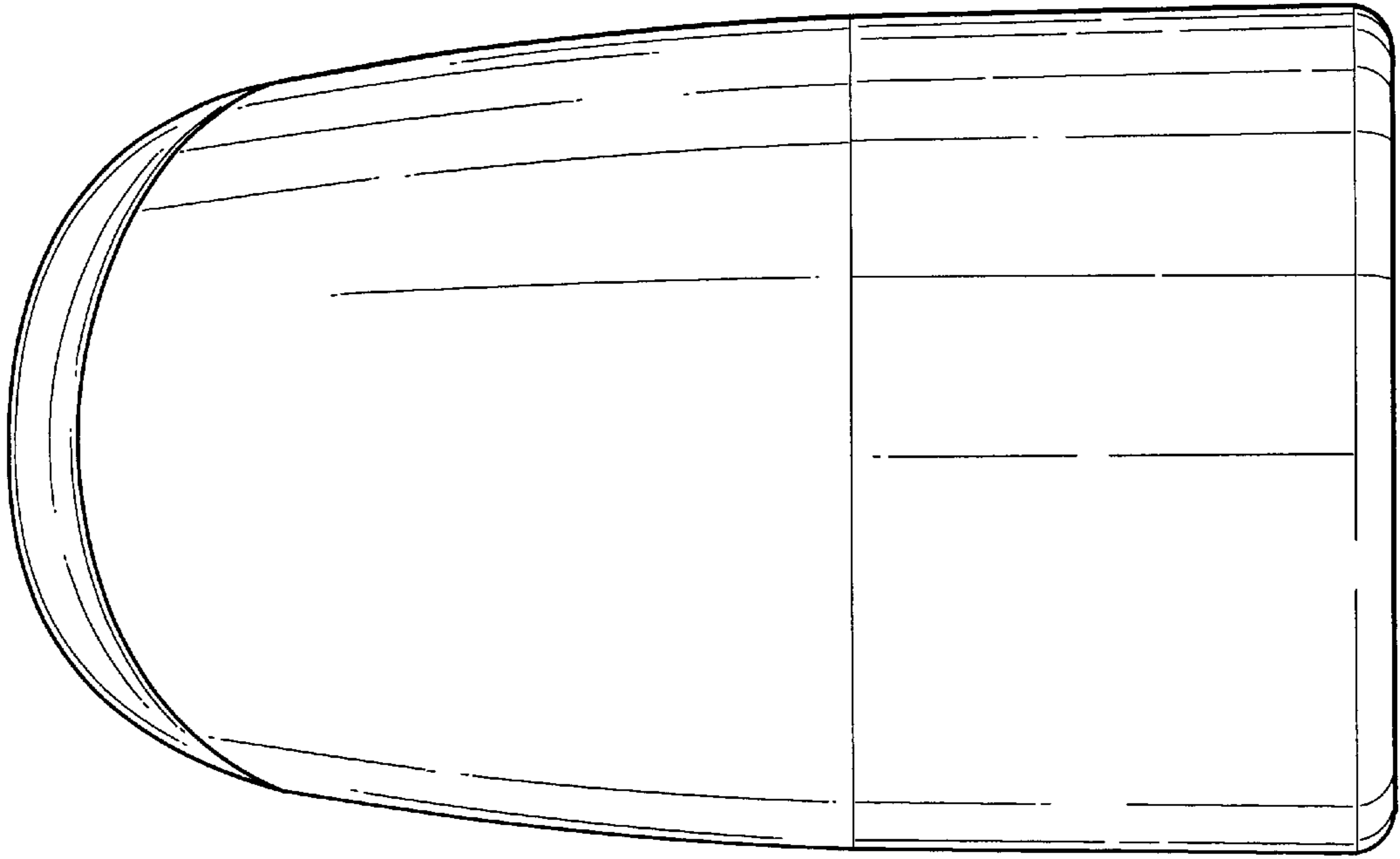

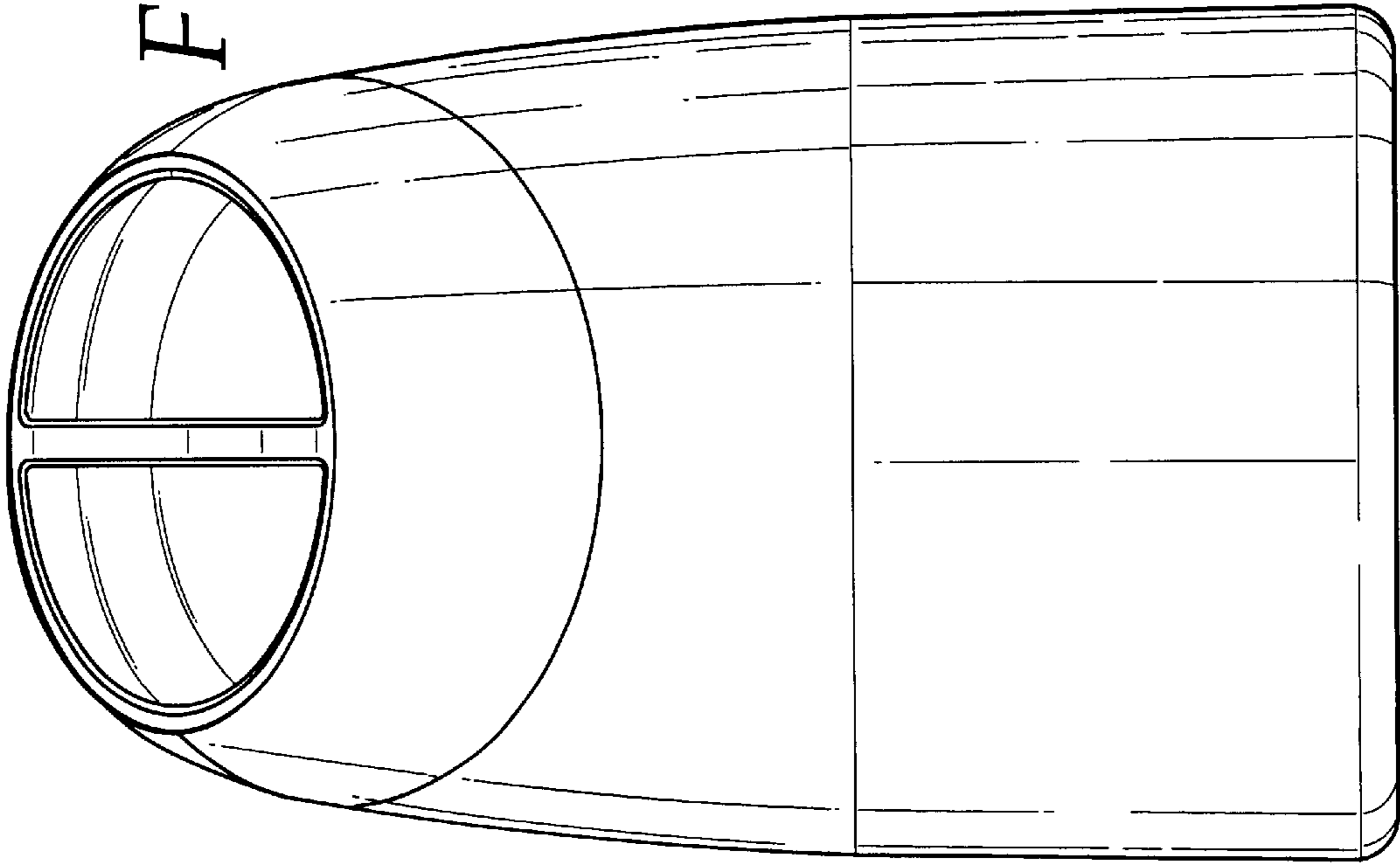
