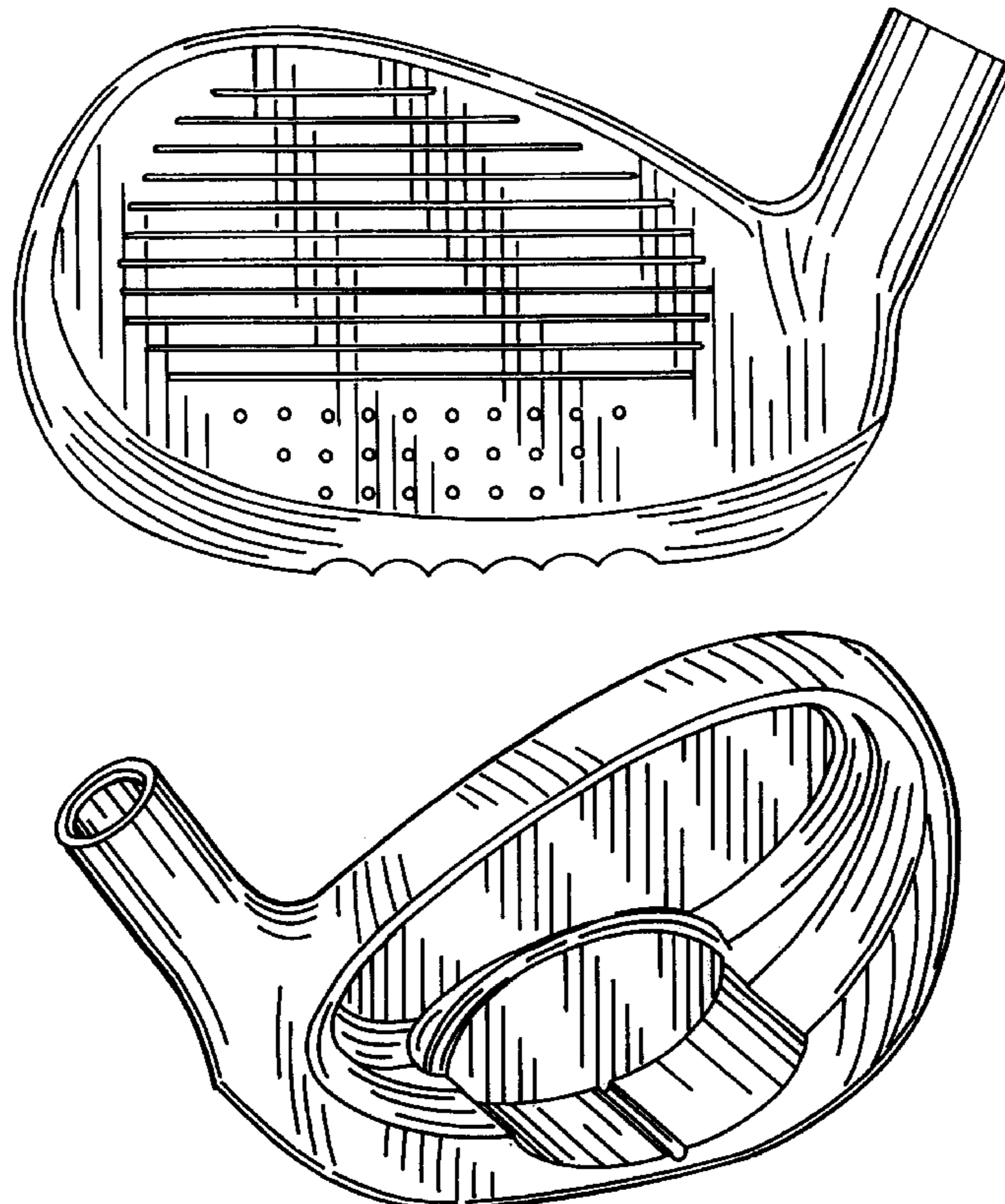
FIG. 1 is a front view of a golf club head in accordance with a preferred embodiment of the present invention;

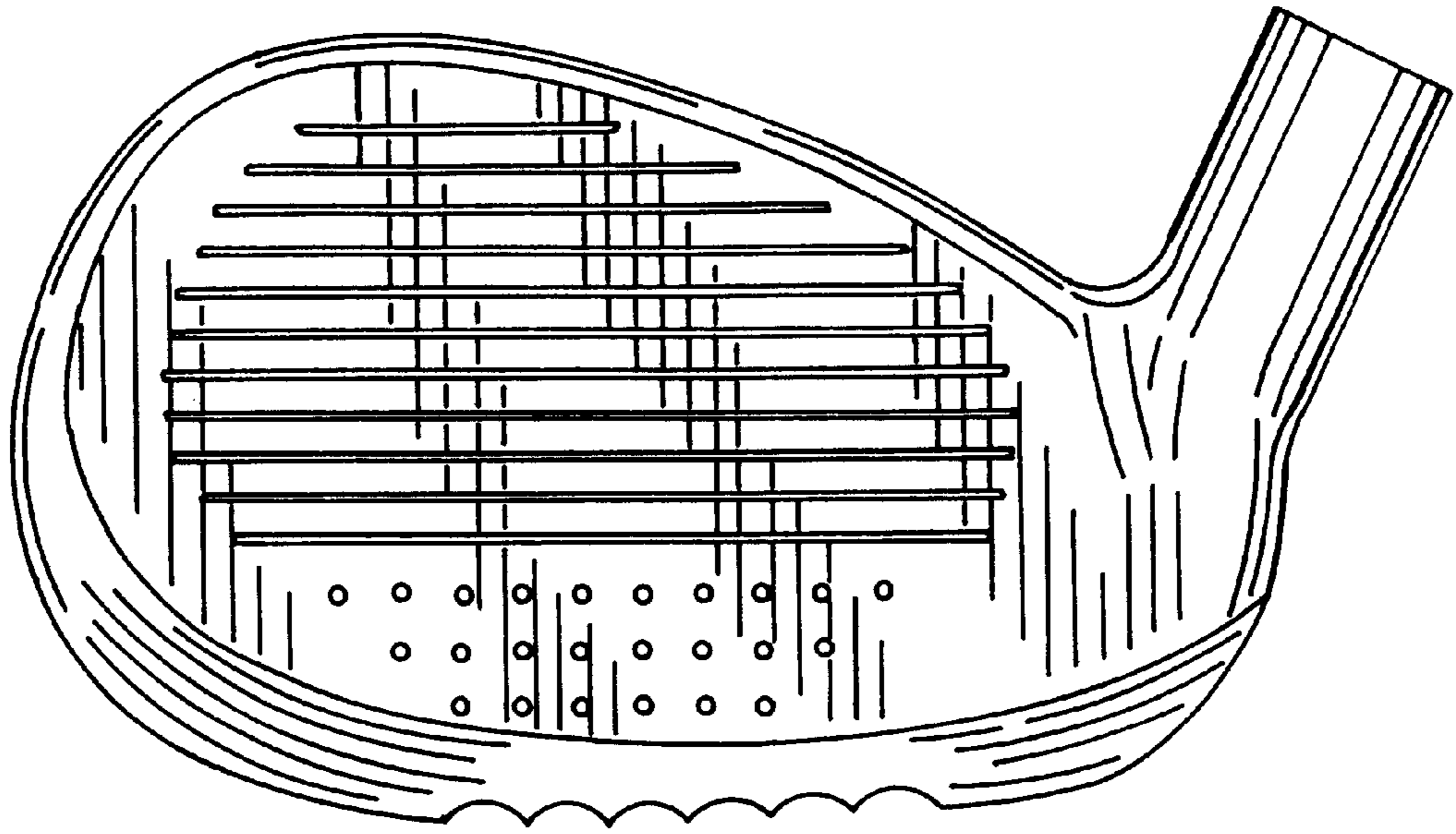

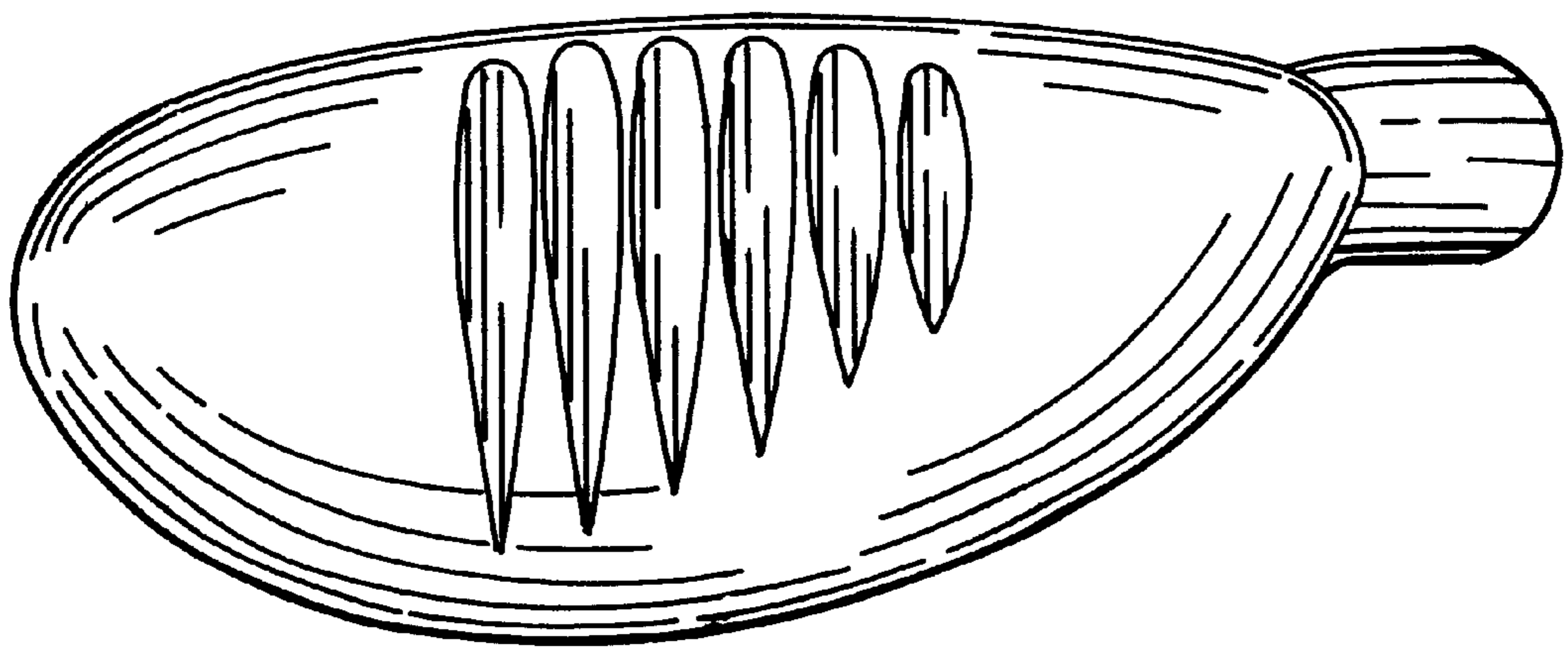

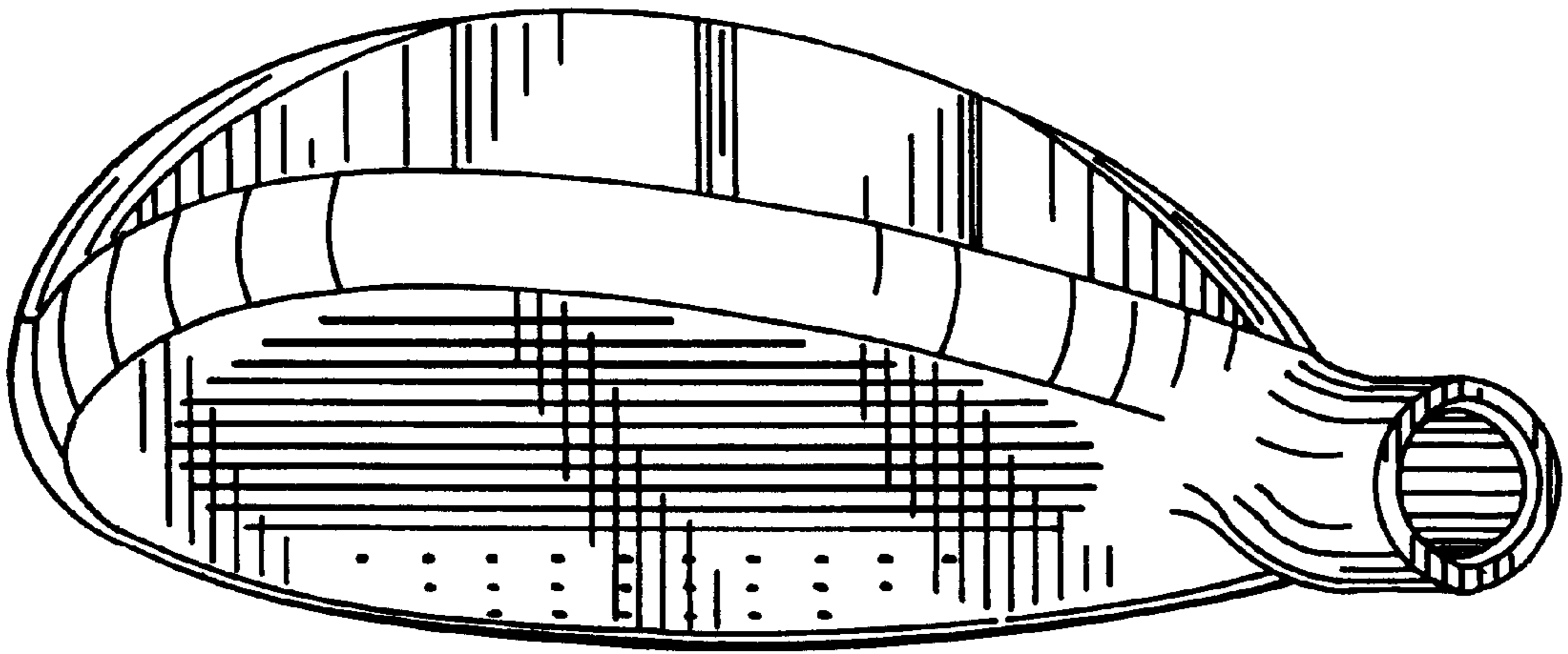

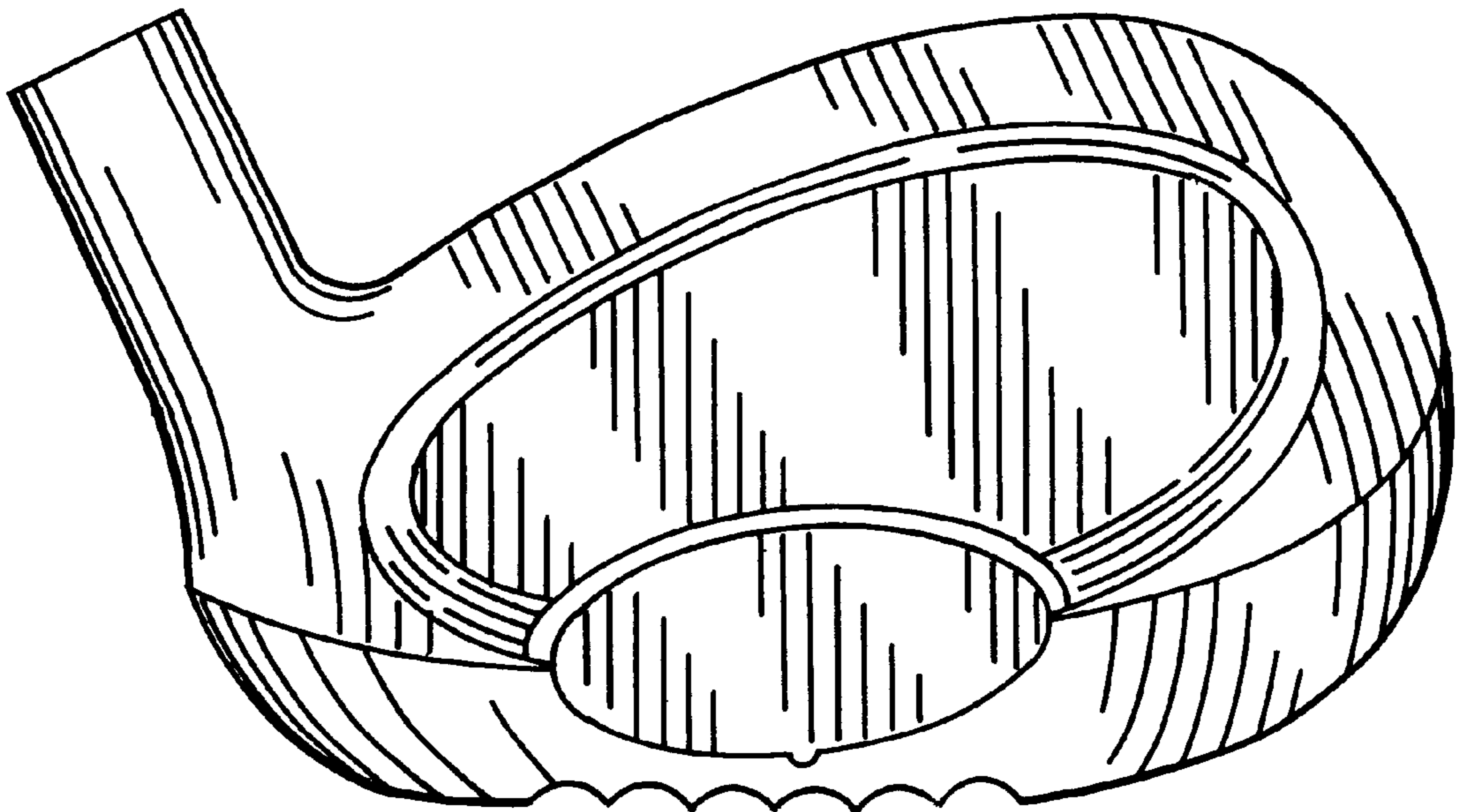

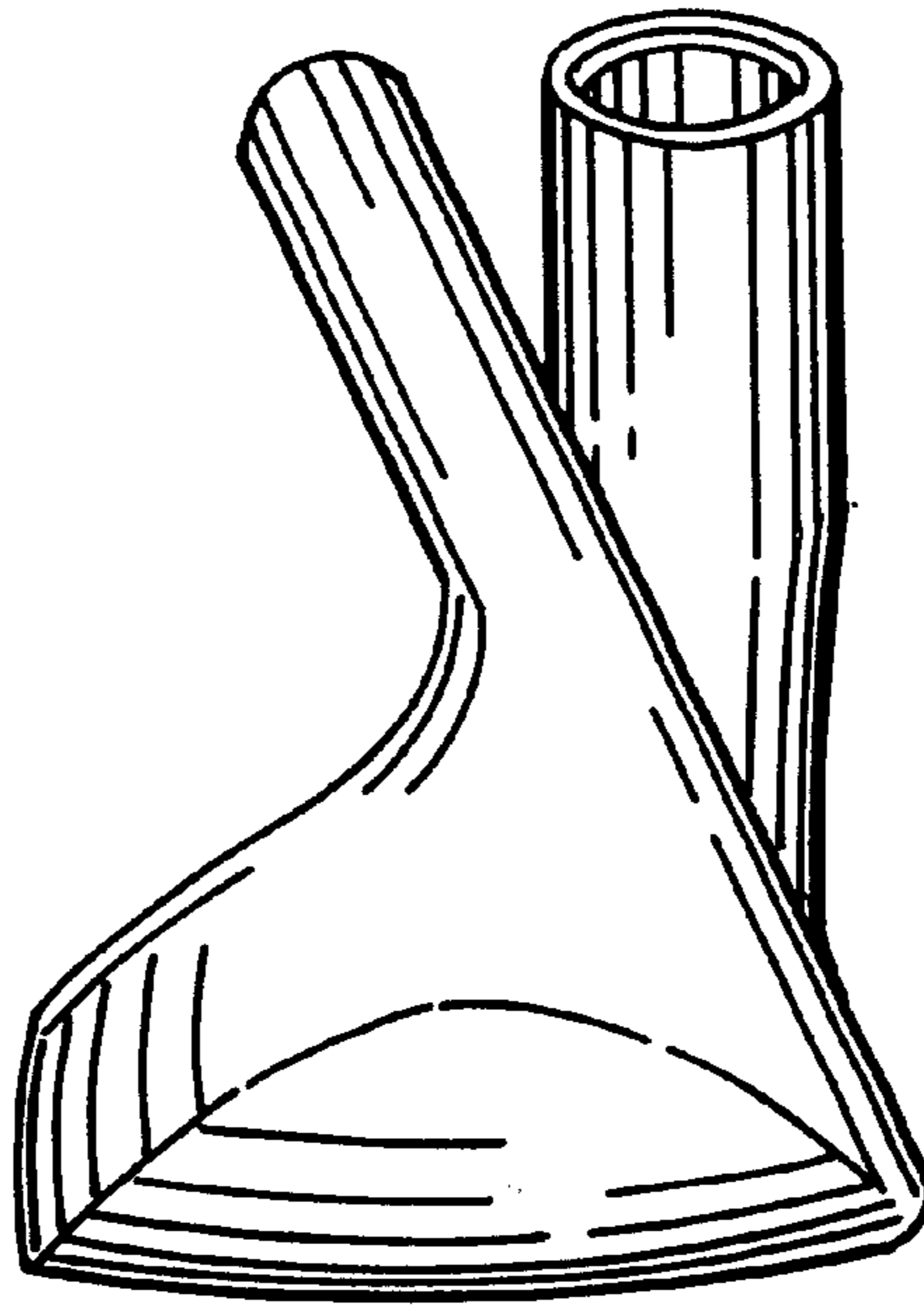

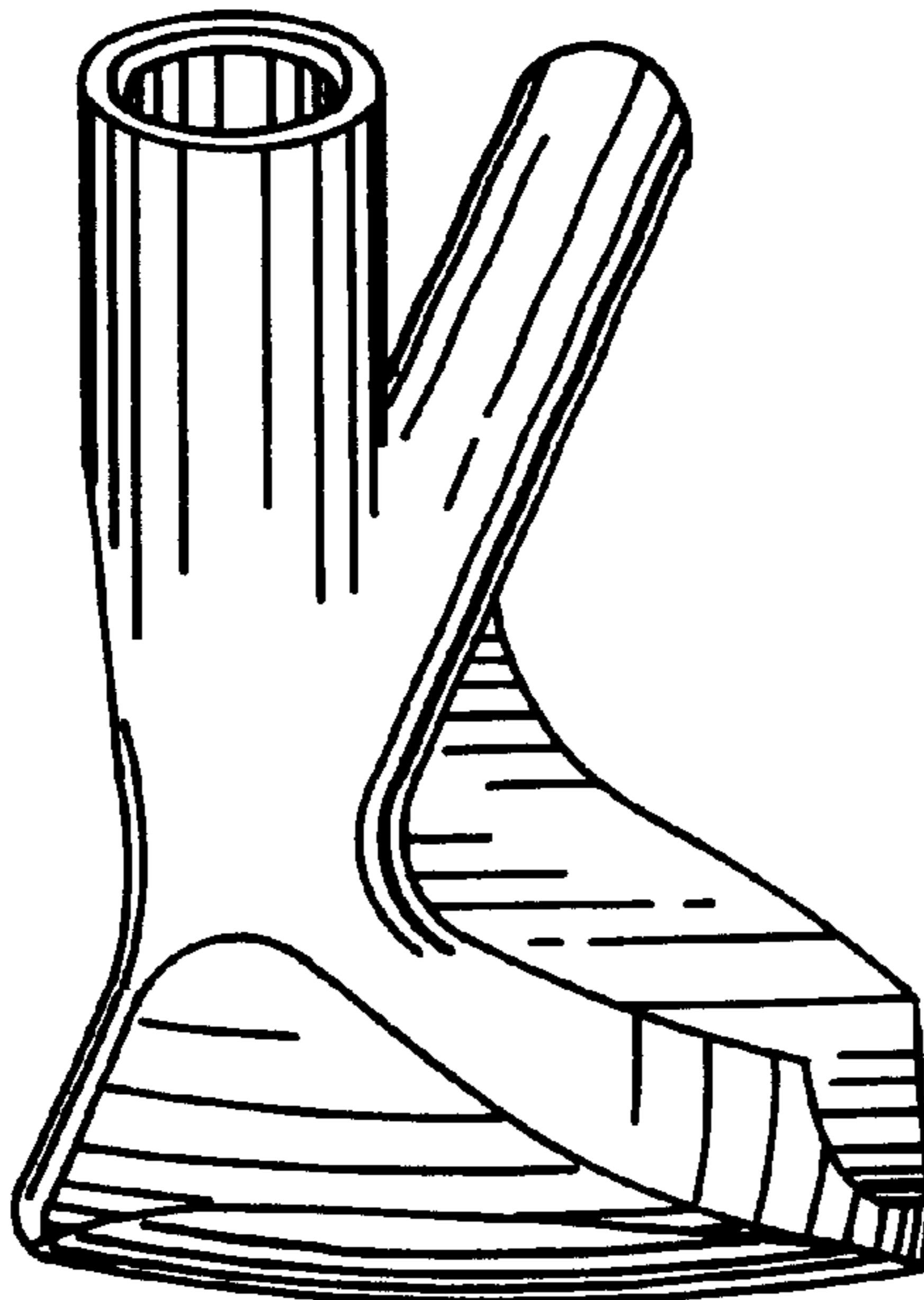

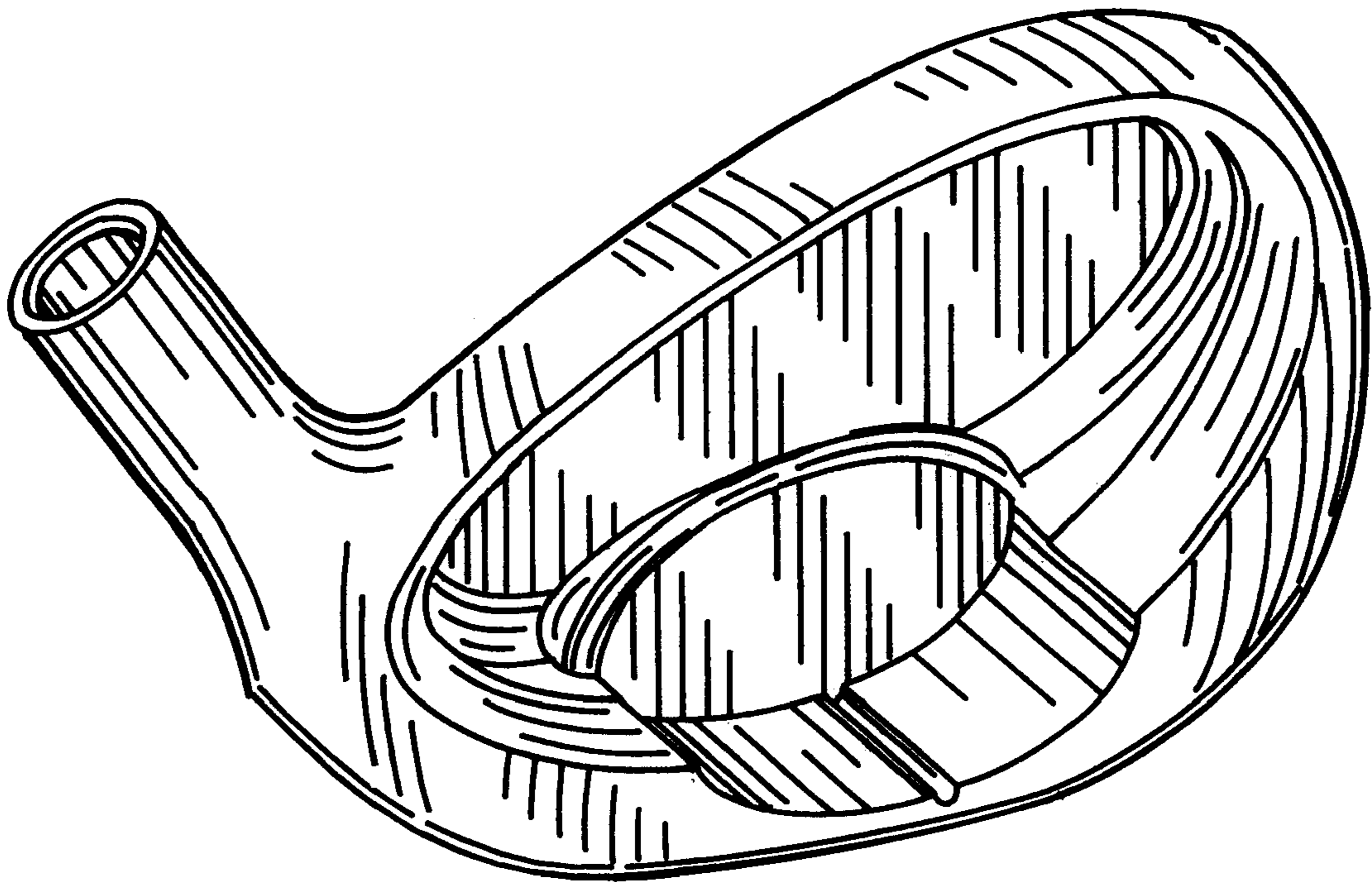
