(57) **CLAIM**

We claim the ornamental design for a golf club head, as shown and described.

DESCRIPTION

FIG. 1 is a bottom front perspective view of a first embodiment of a golf club head in accordance with our new design, wherein the portions of the golf club head's face and sole encircled by broken lines are not part of the design.

FIG. 2 is a front elevational view of the golf club head of FIG. 1.

FIG. 3 is a rear elevational view of the golf club head of FIG. 1.

FIG. 4 is a right side elevational view of the golf club head of FIG. 1.

FIG. 5 is a left side elevational view of the golf club head of FIG. 1.

FIG. 6 is a top plan view of the golf club head of FIG. 1.

FIG. 7 is a bottom plan view of the golf club head of FIG. 1.

FIG. 8 is a bottom front perspective view of a second embodiment of a golf club head in accordance with our new design, wherein the portions of the golf club head's face and sole encircled by broken lines are not part of the design.

FIG. 9 is a front elevational view of the golf club head of FIG. 8.

FIG. 10 is a rear elevational view of the golf club head of FIG. 8.

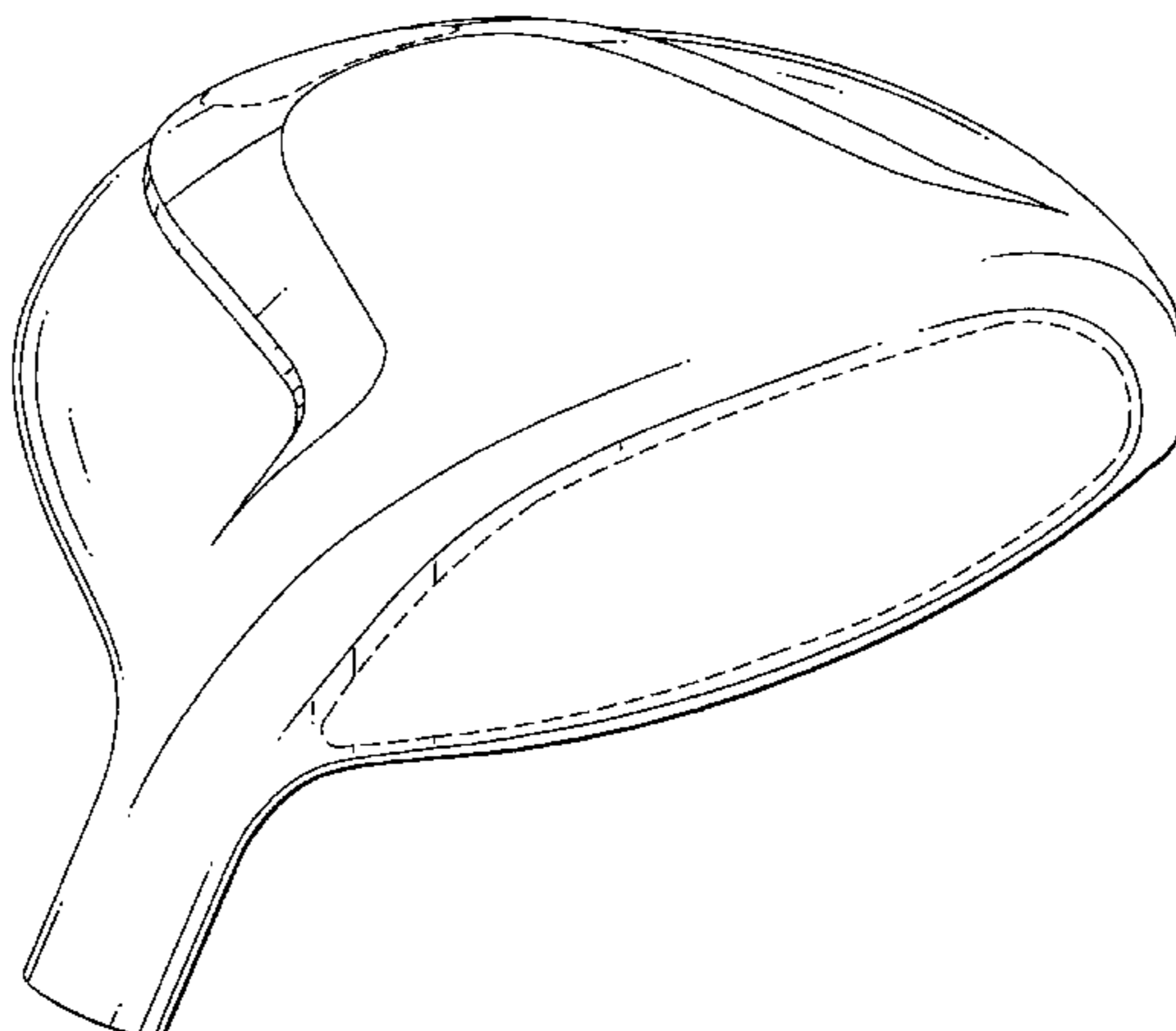
FIG. 11 is a right side elevational view of the golf club head of FIG. 8.

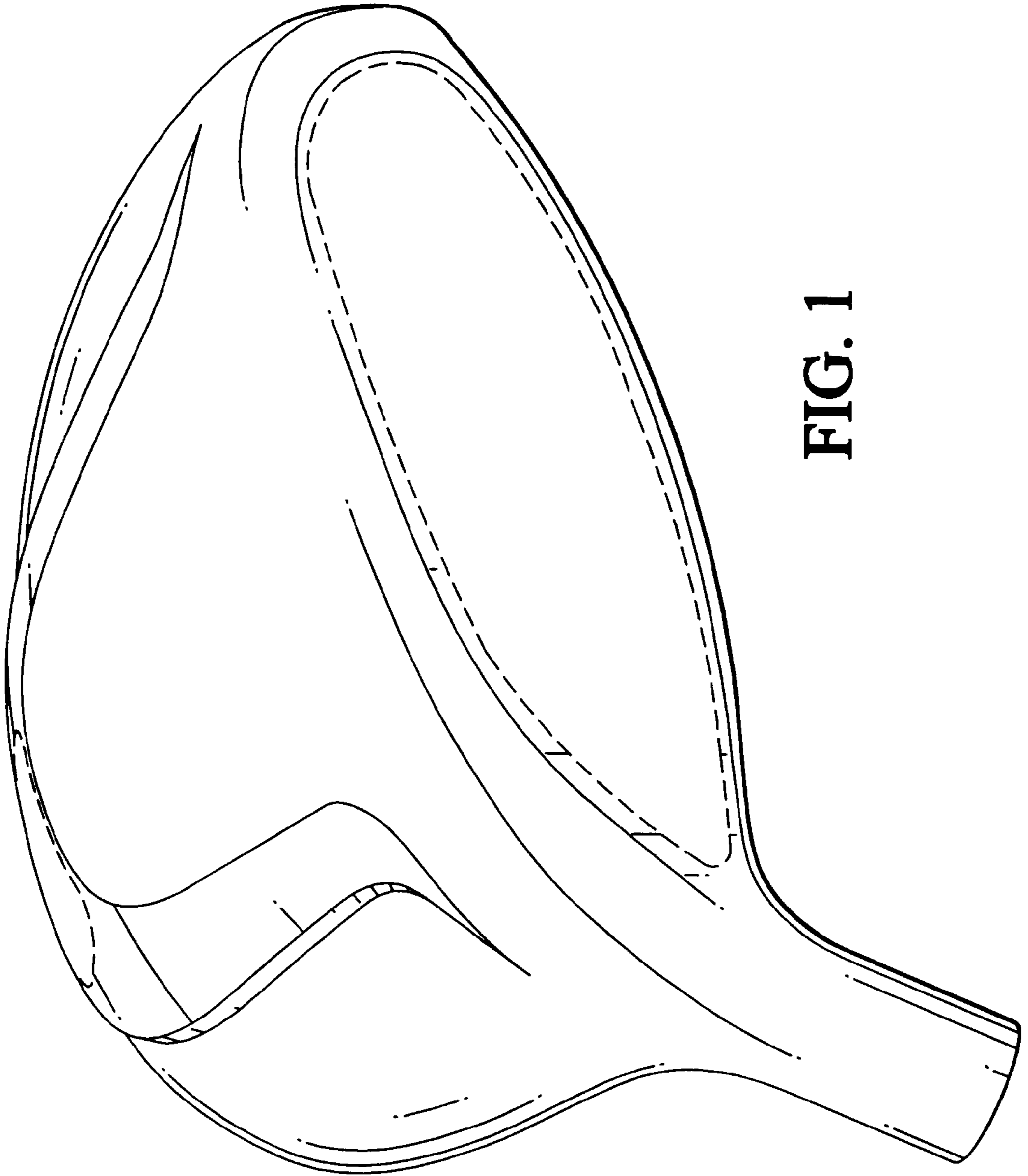

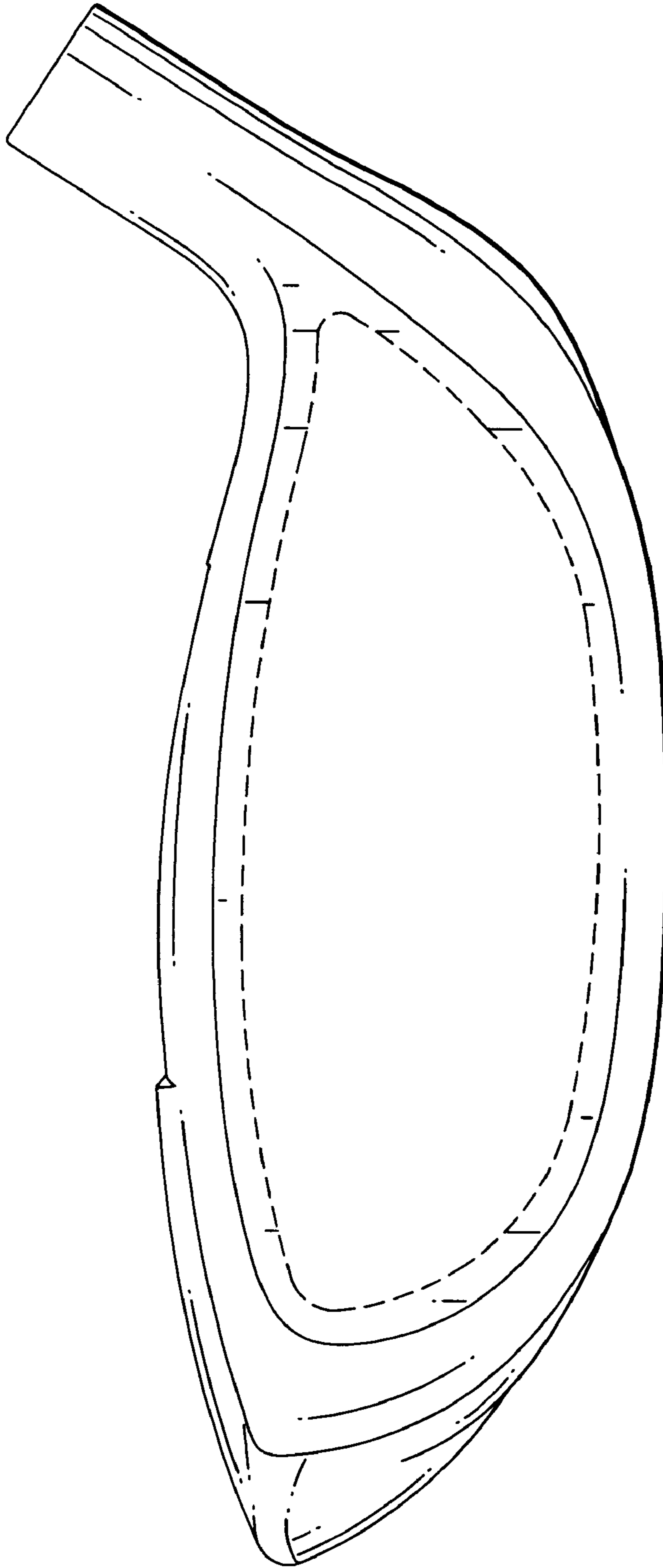

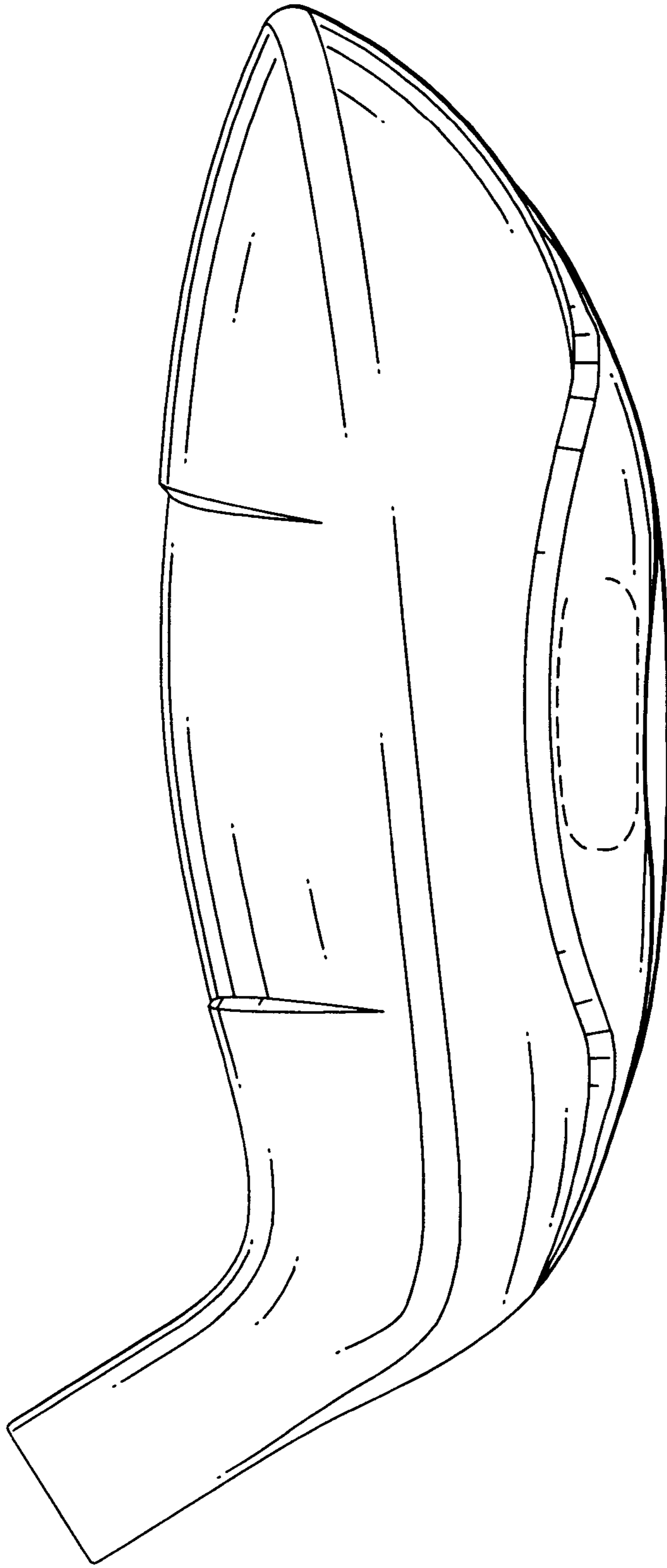

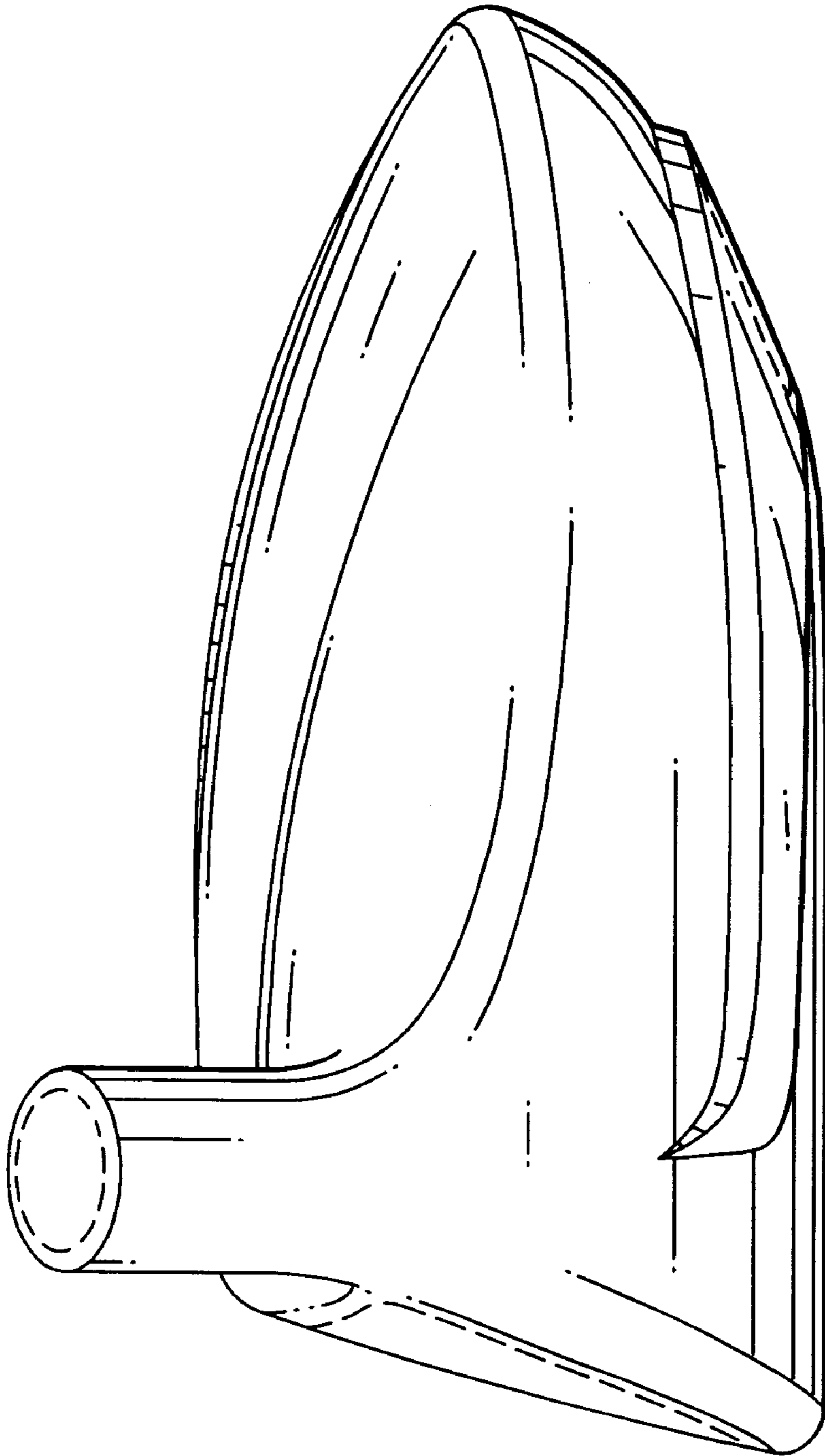

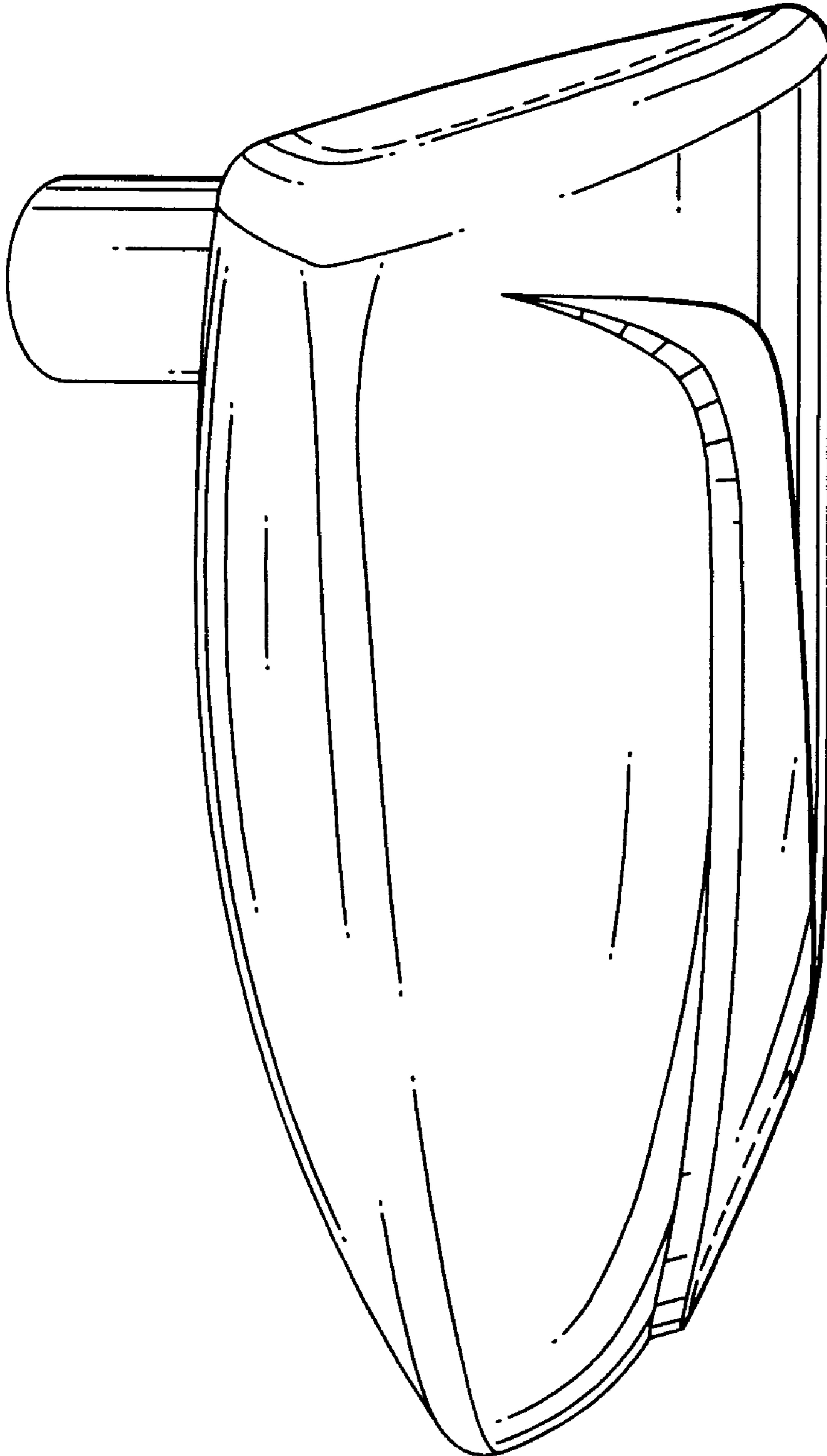

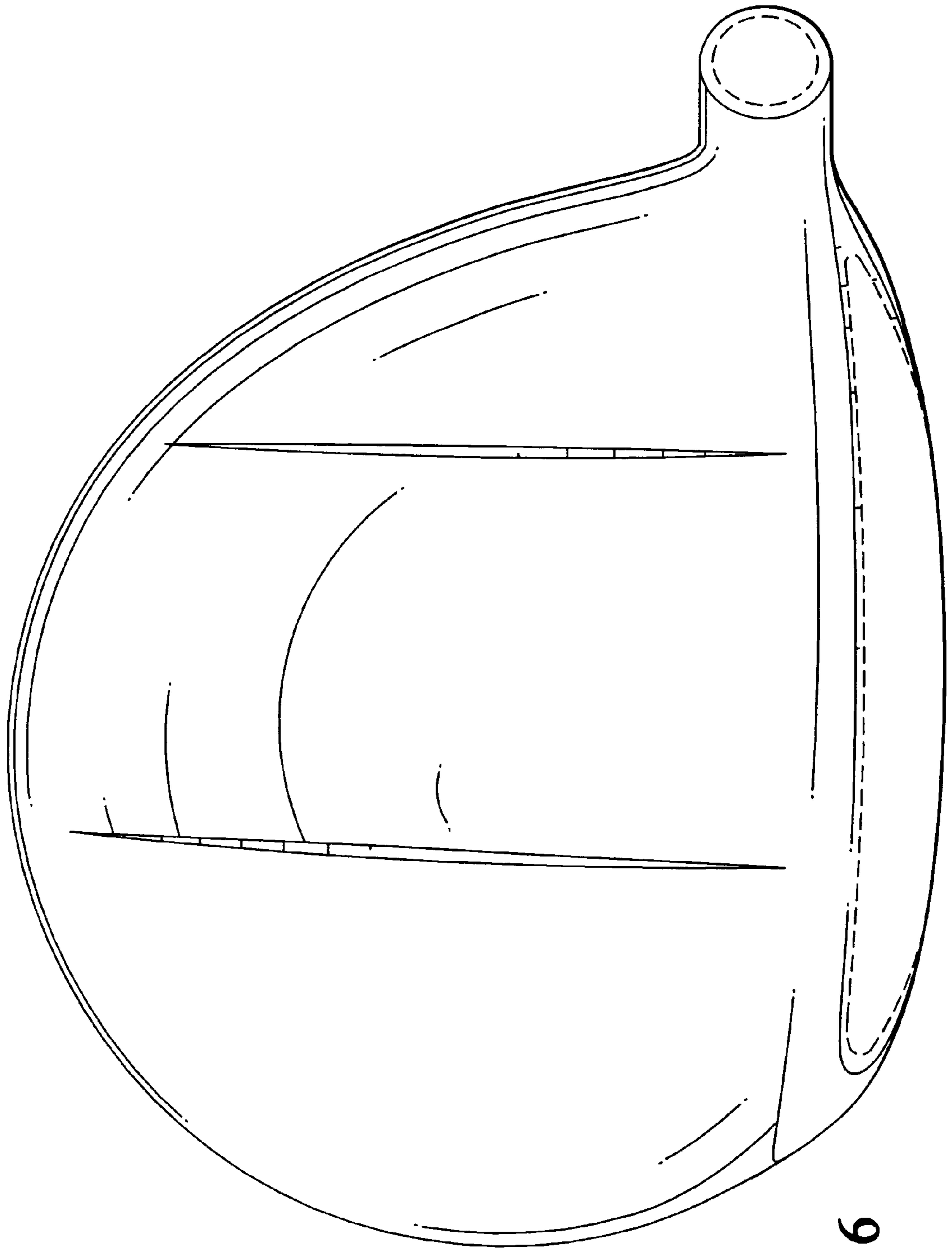

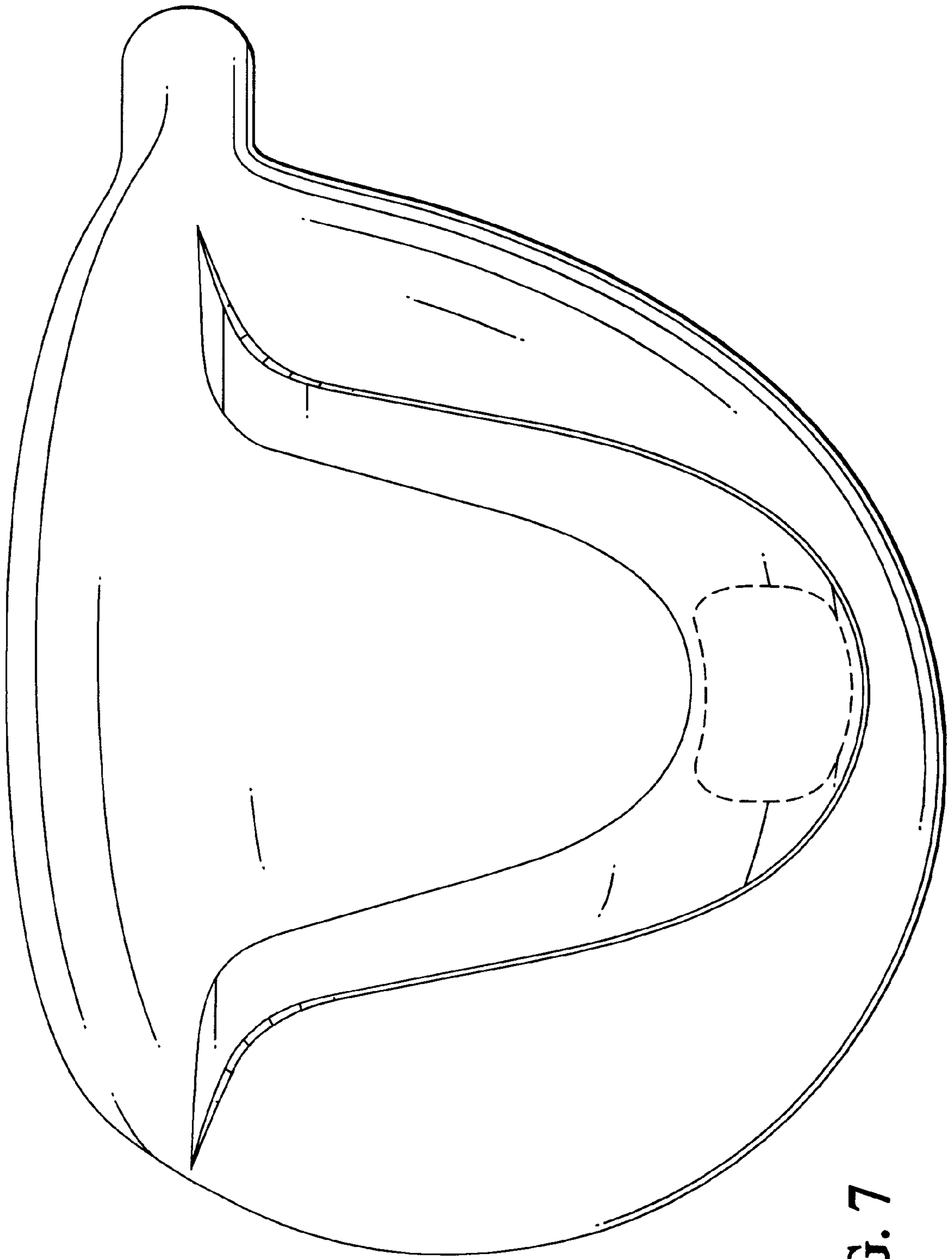

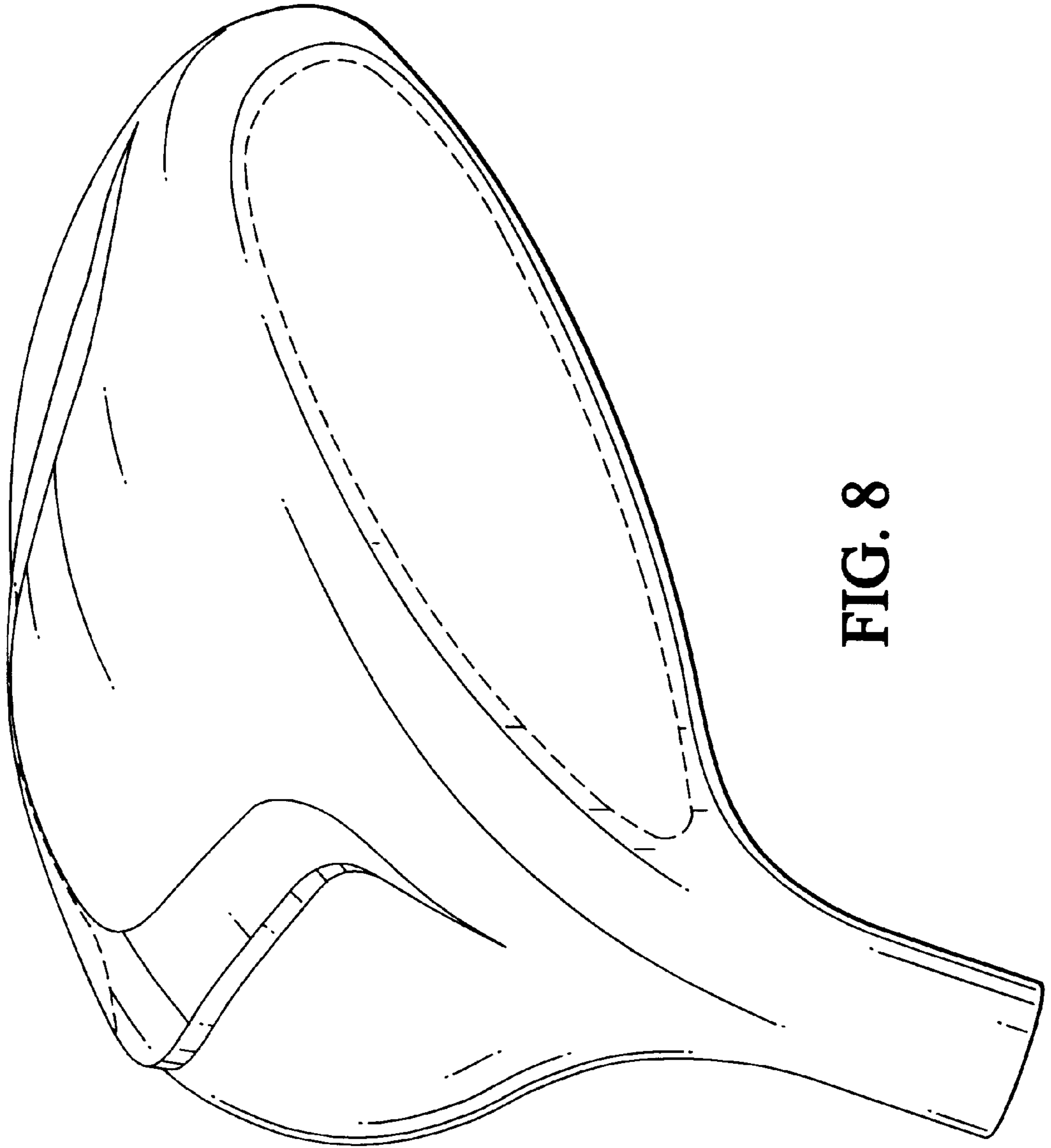

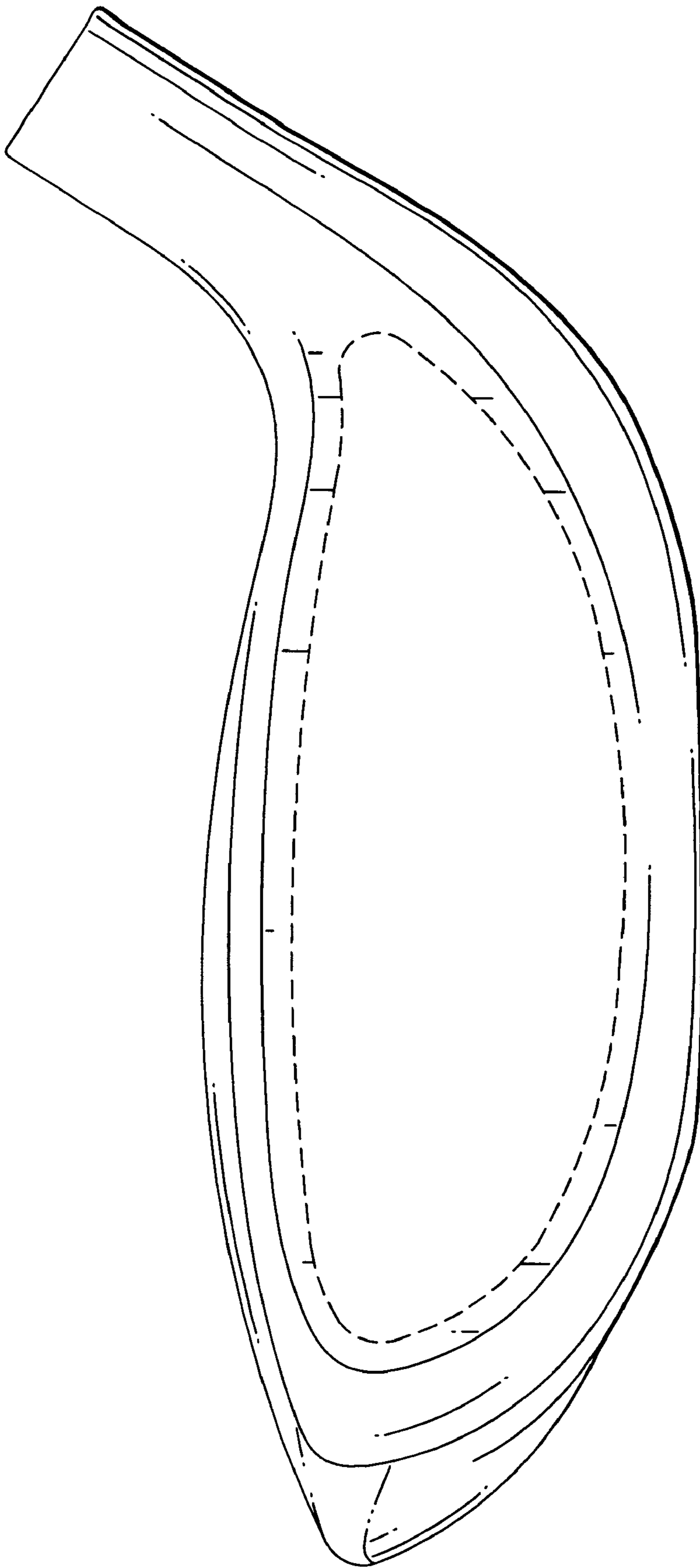

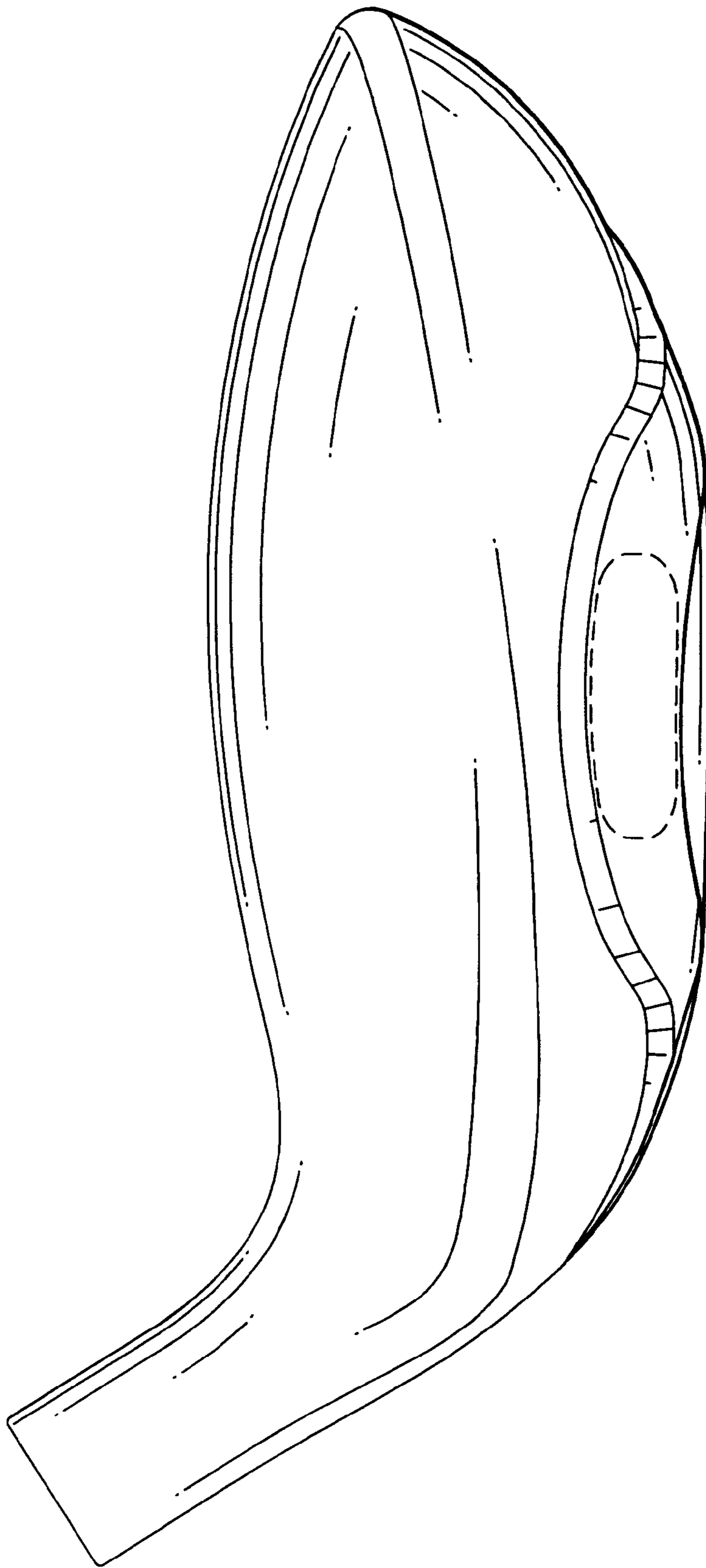

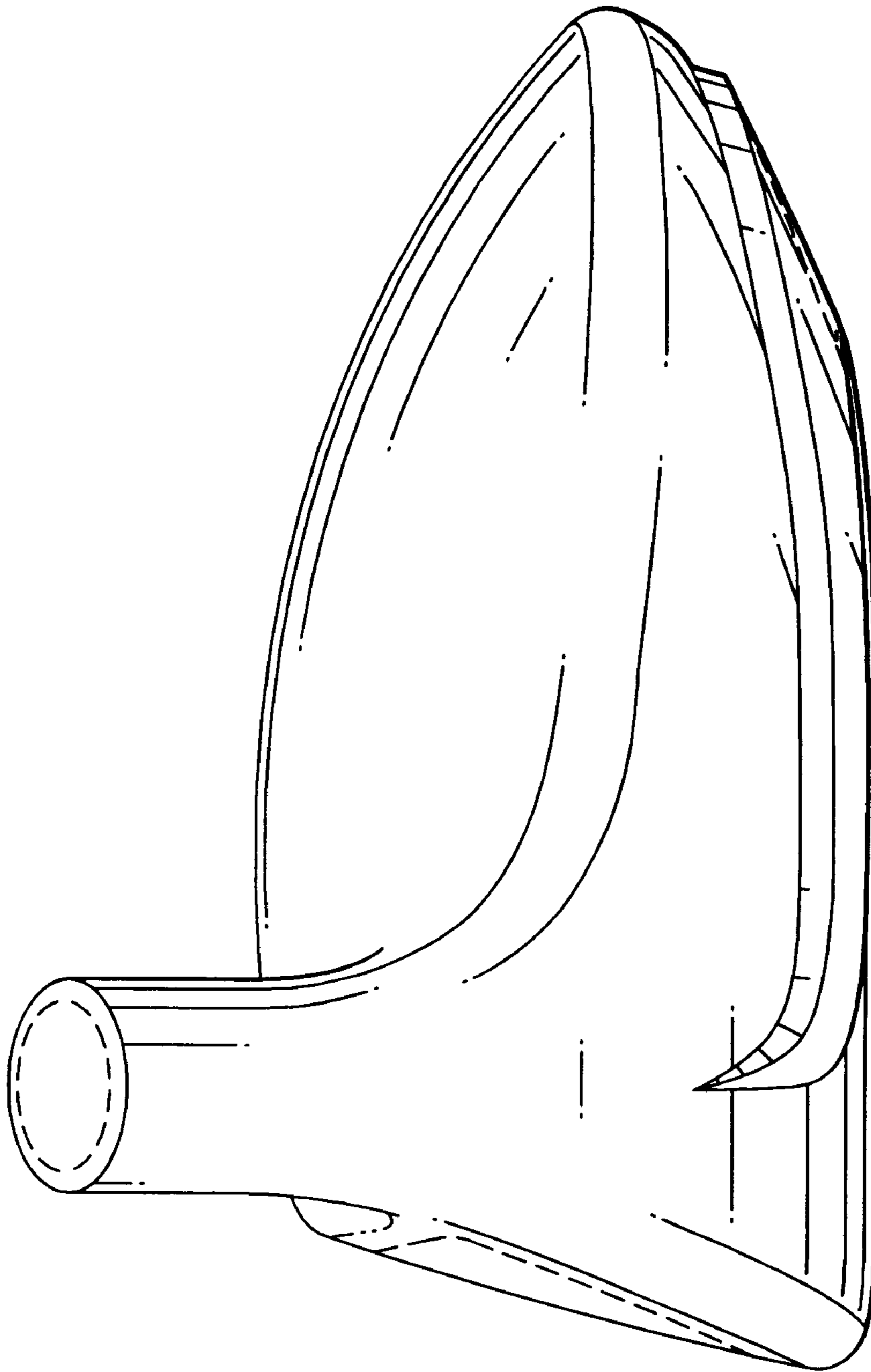

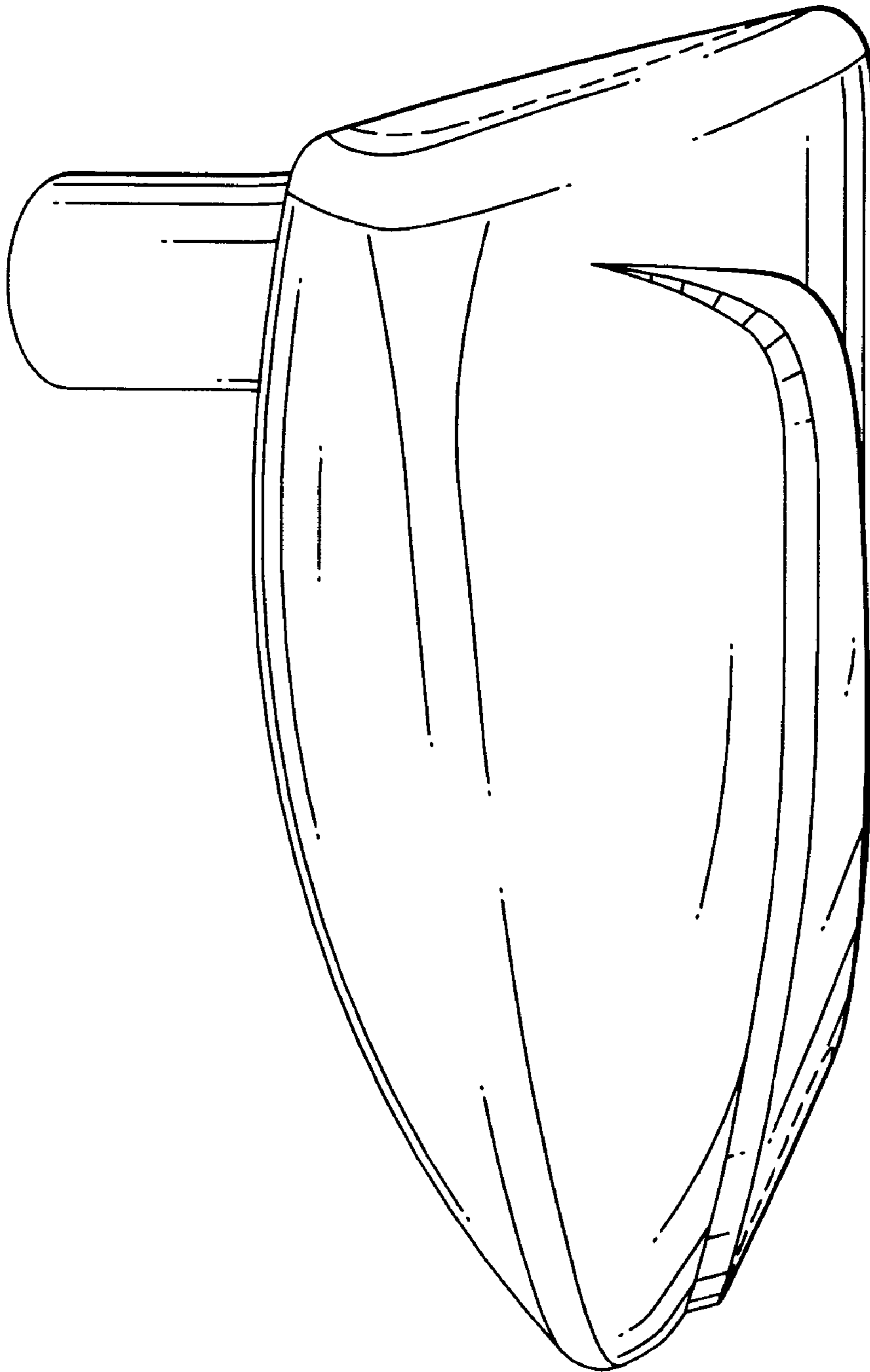

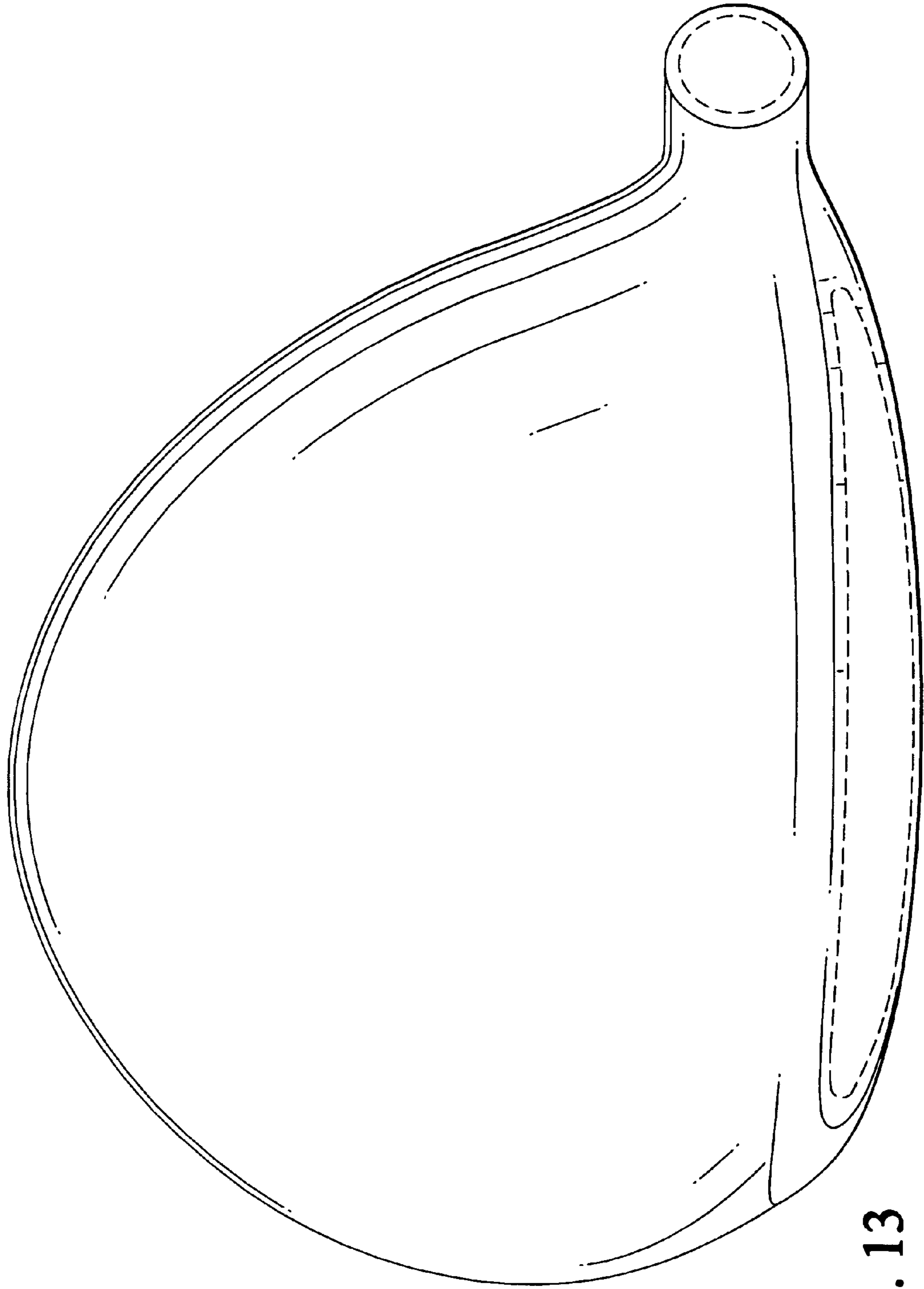

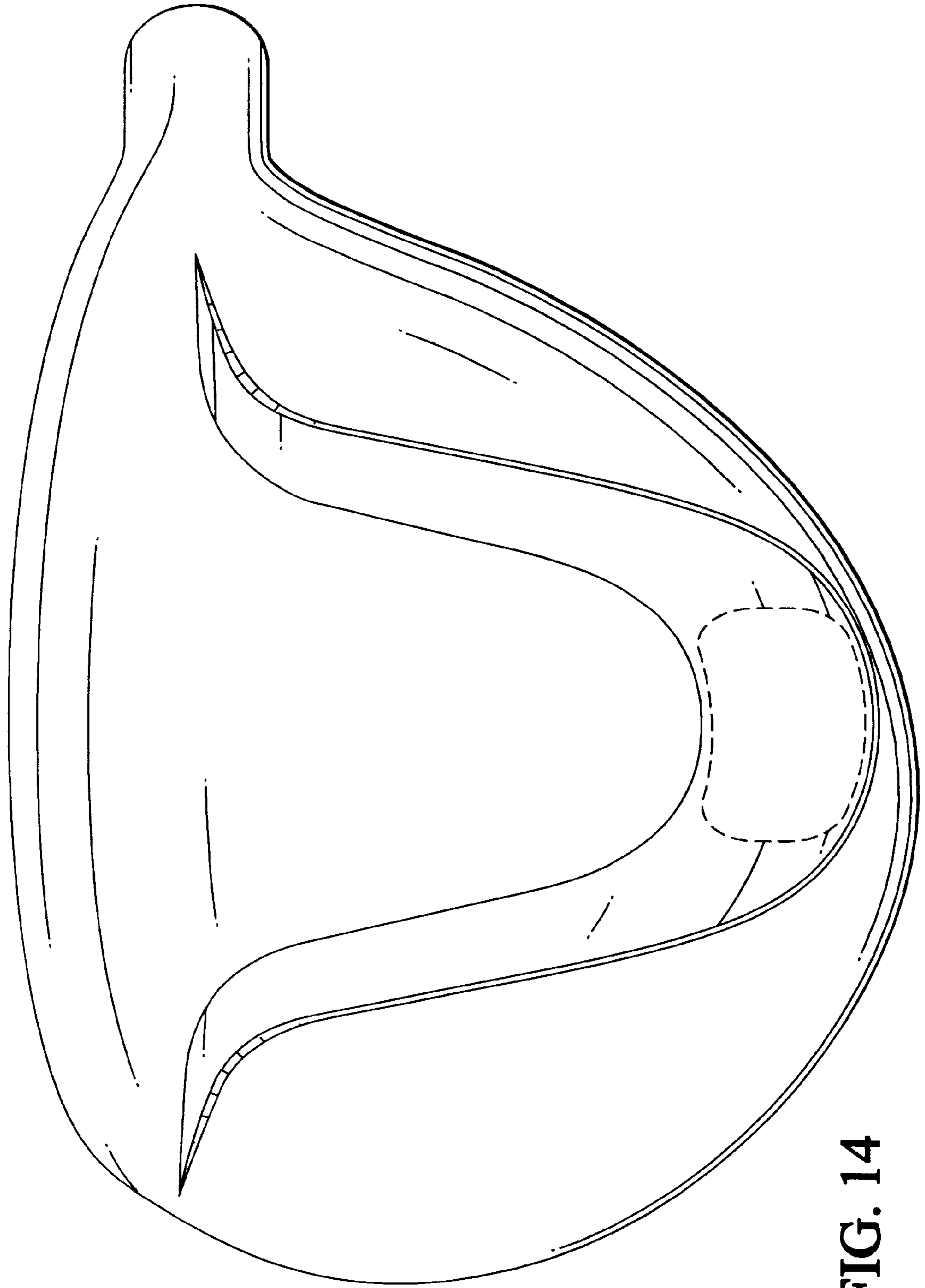
