FIG. 2: is a front elevation view thereof;

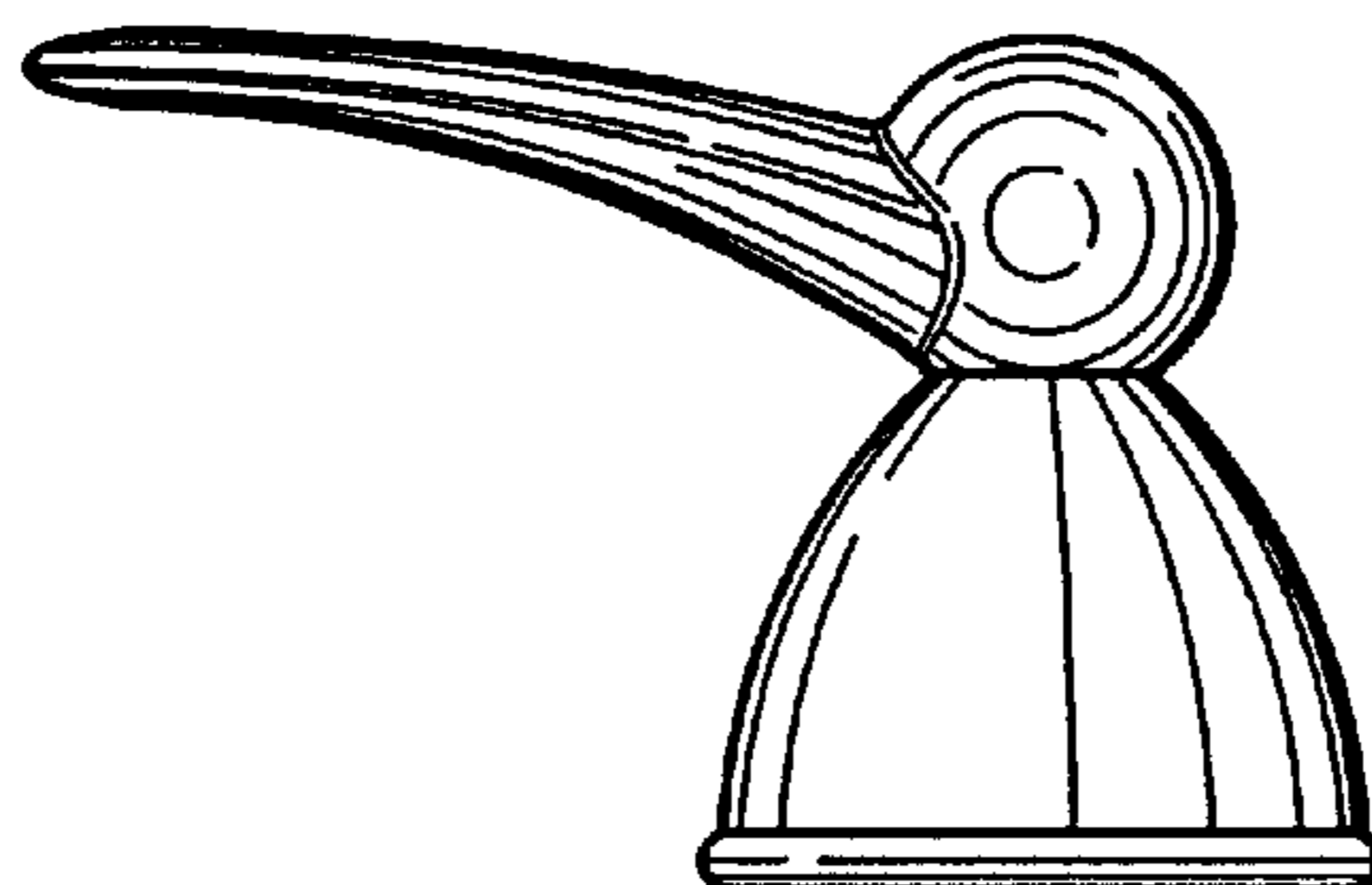
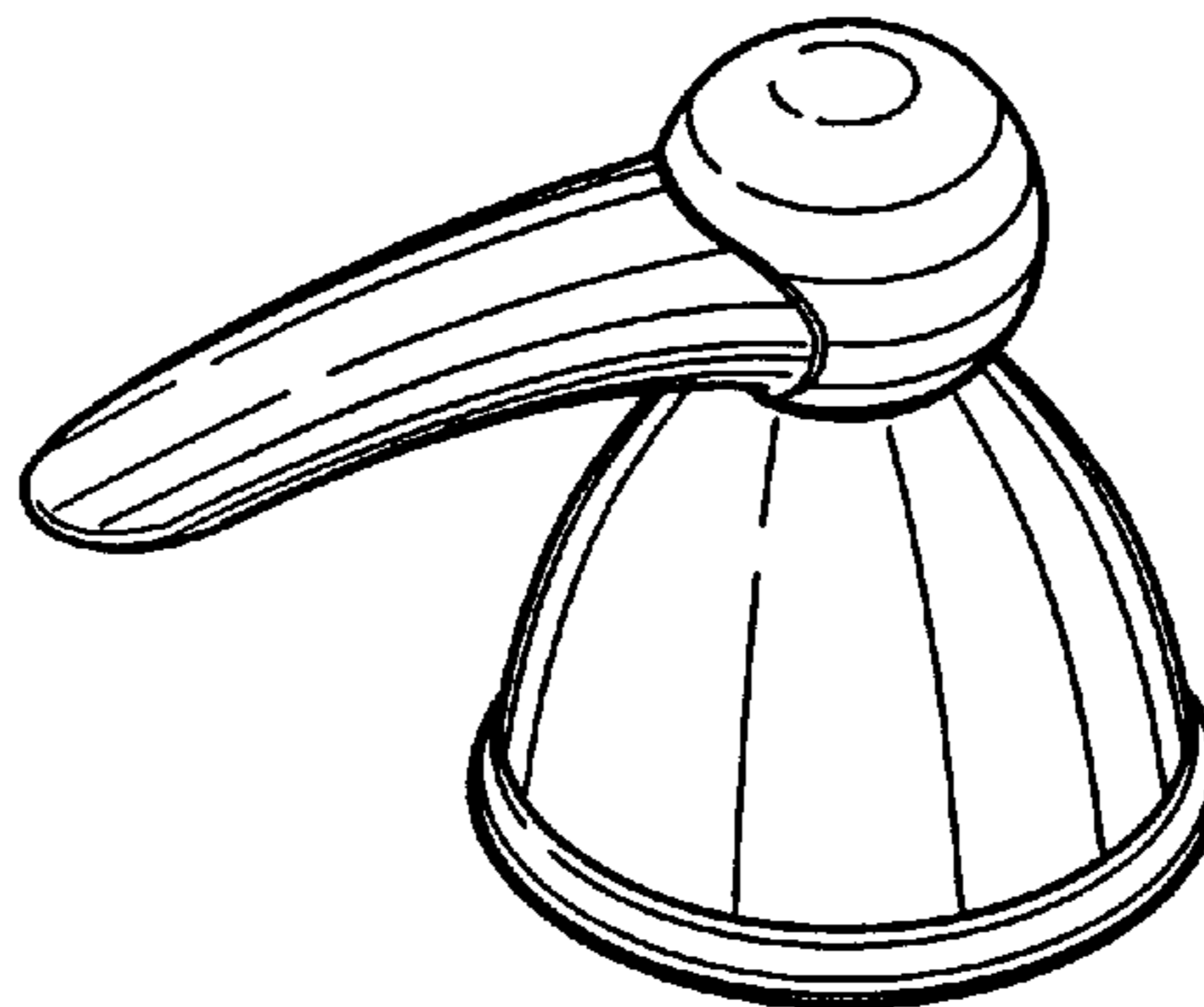
FIG. 3: is a top plan view thereof;

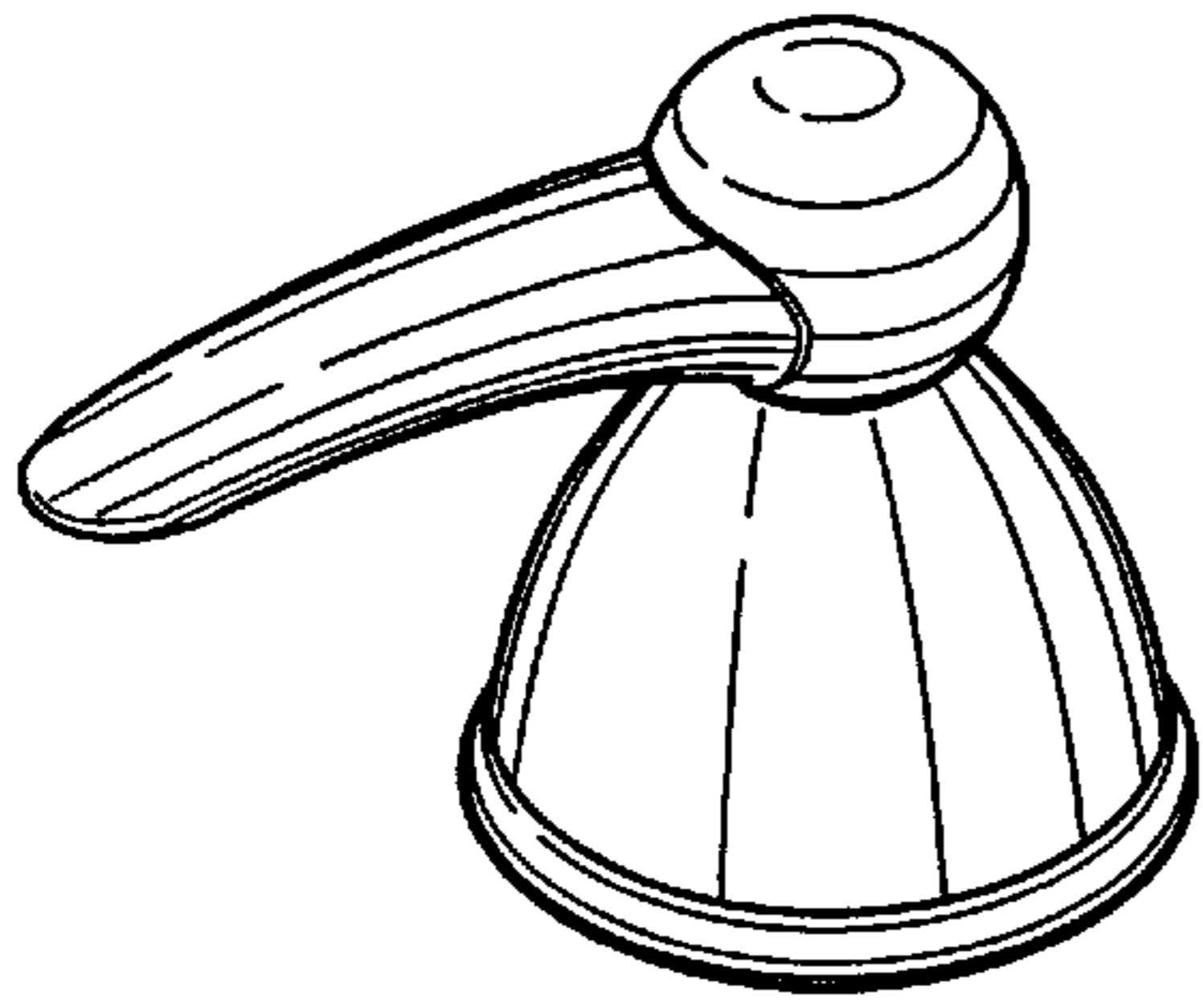

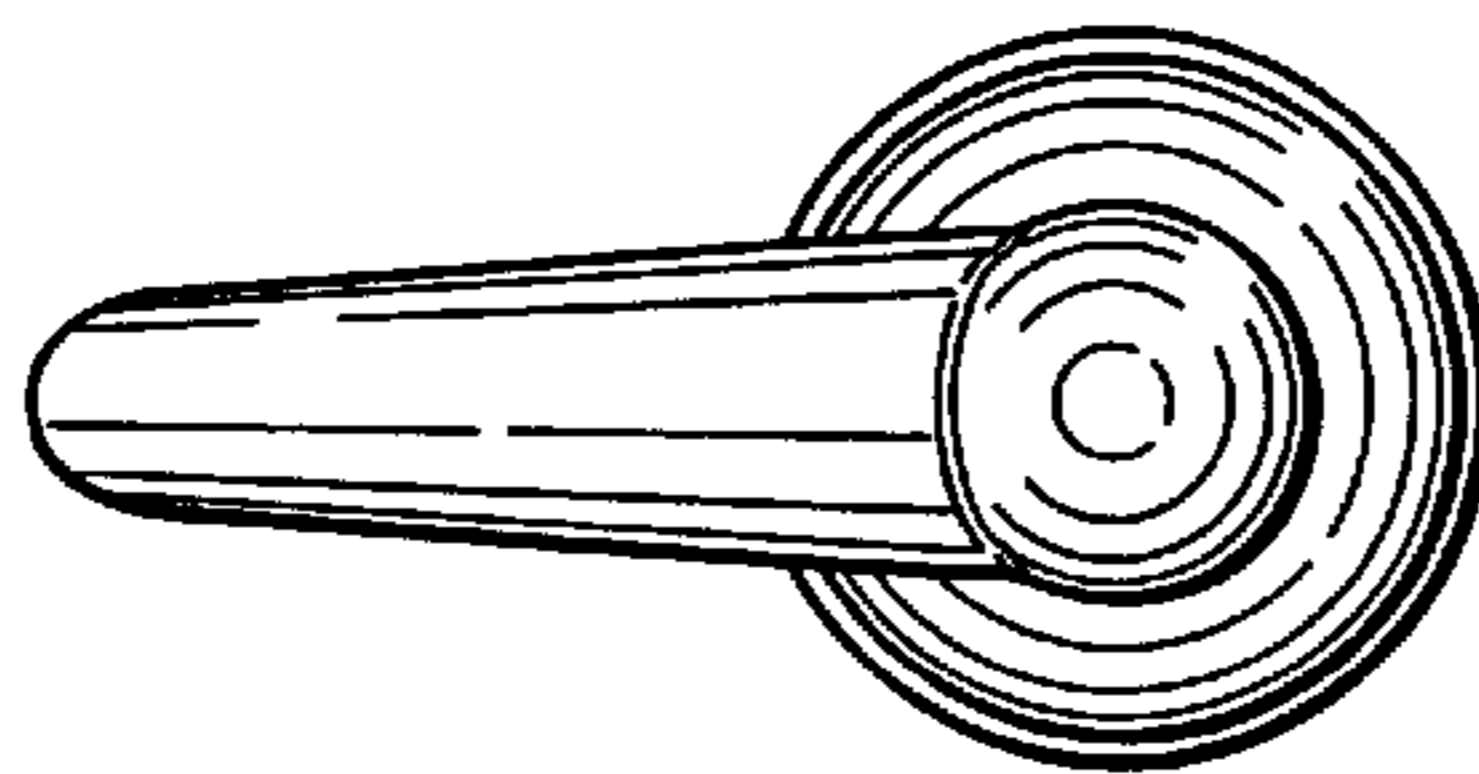

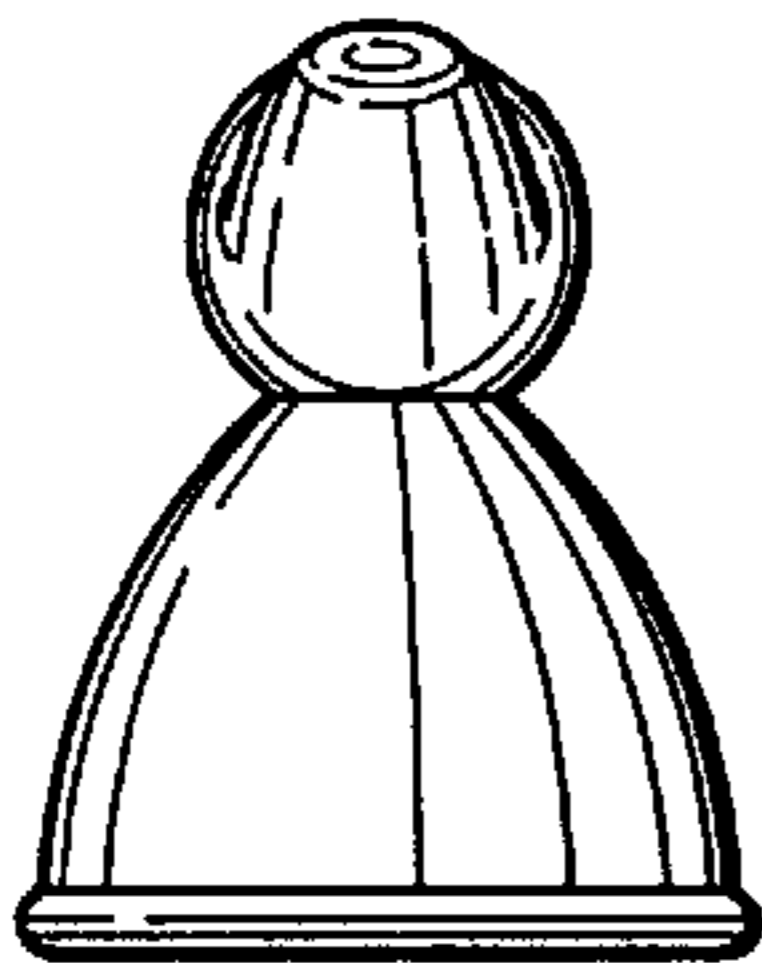

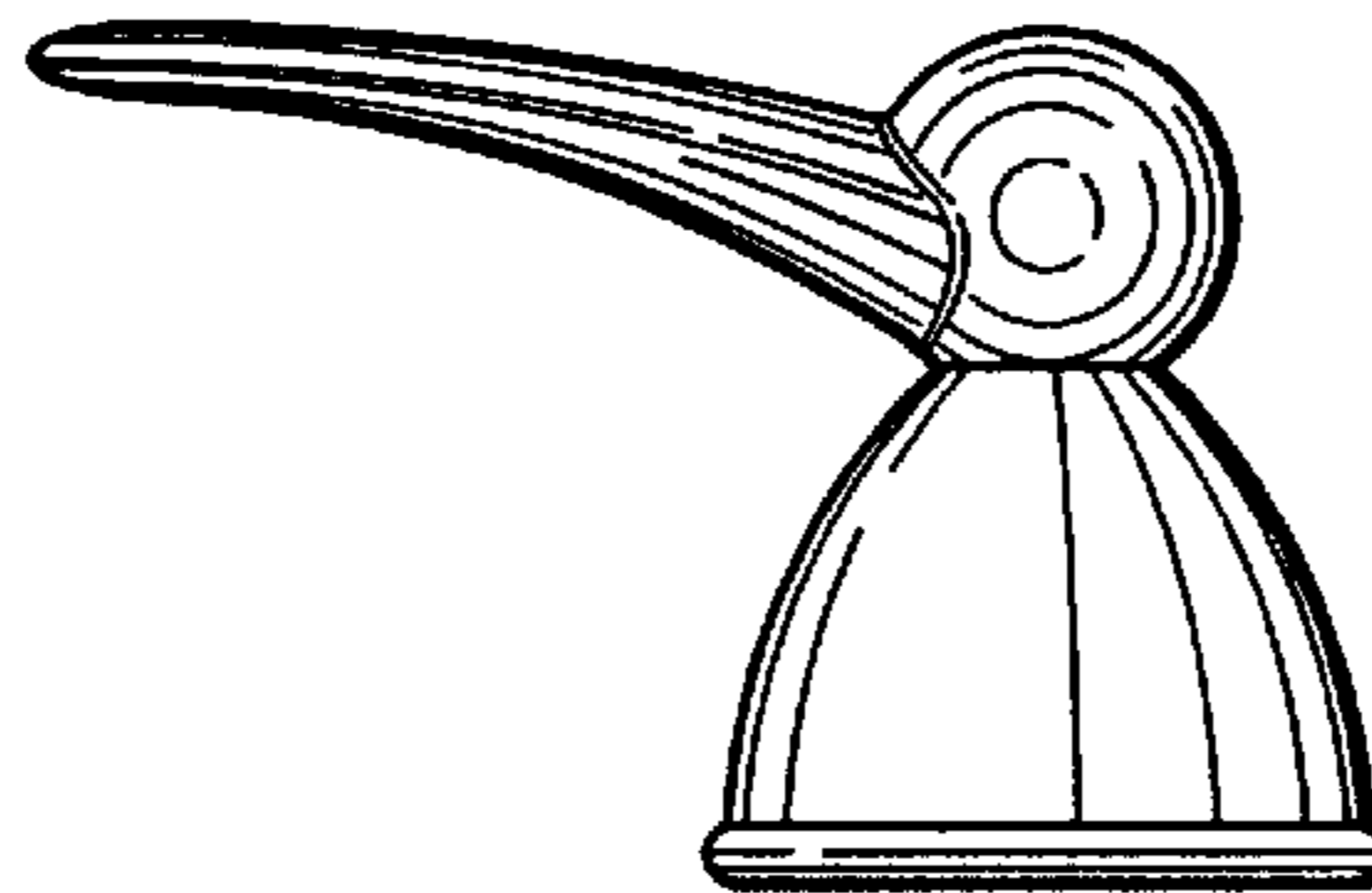

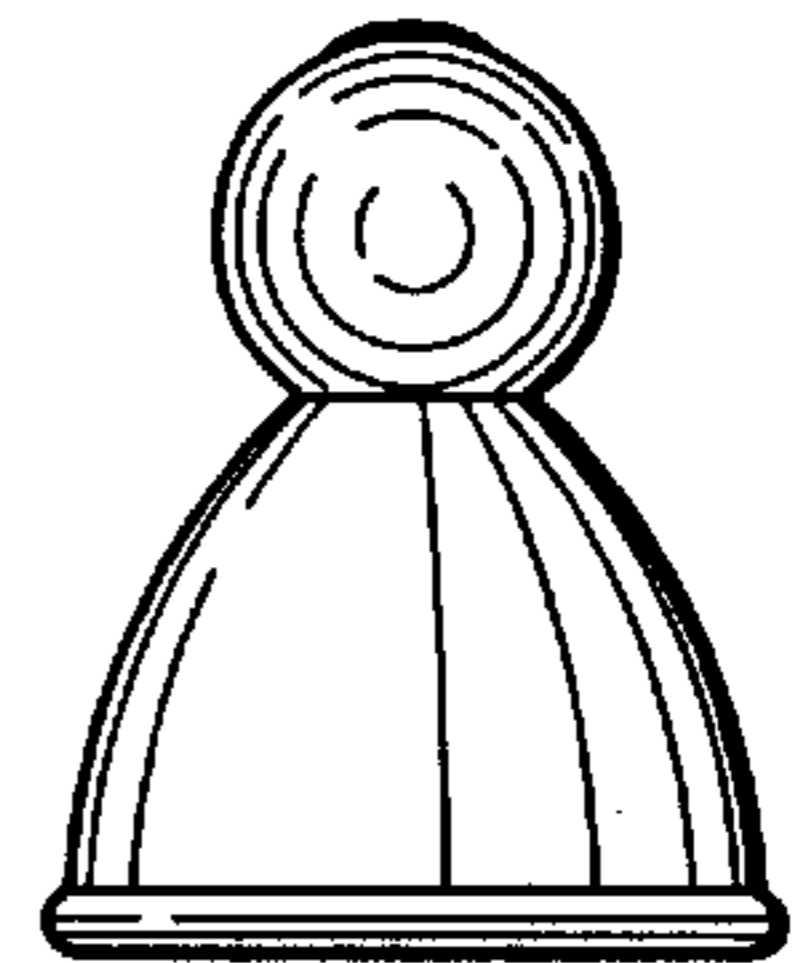

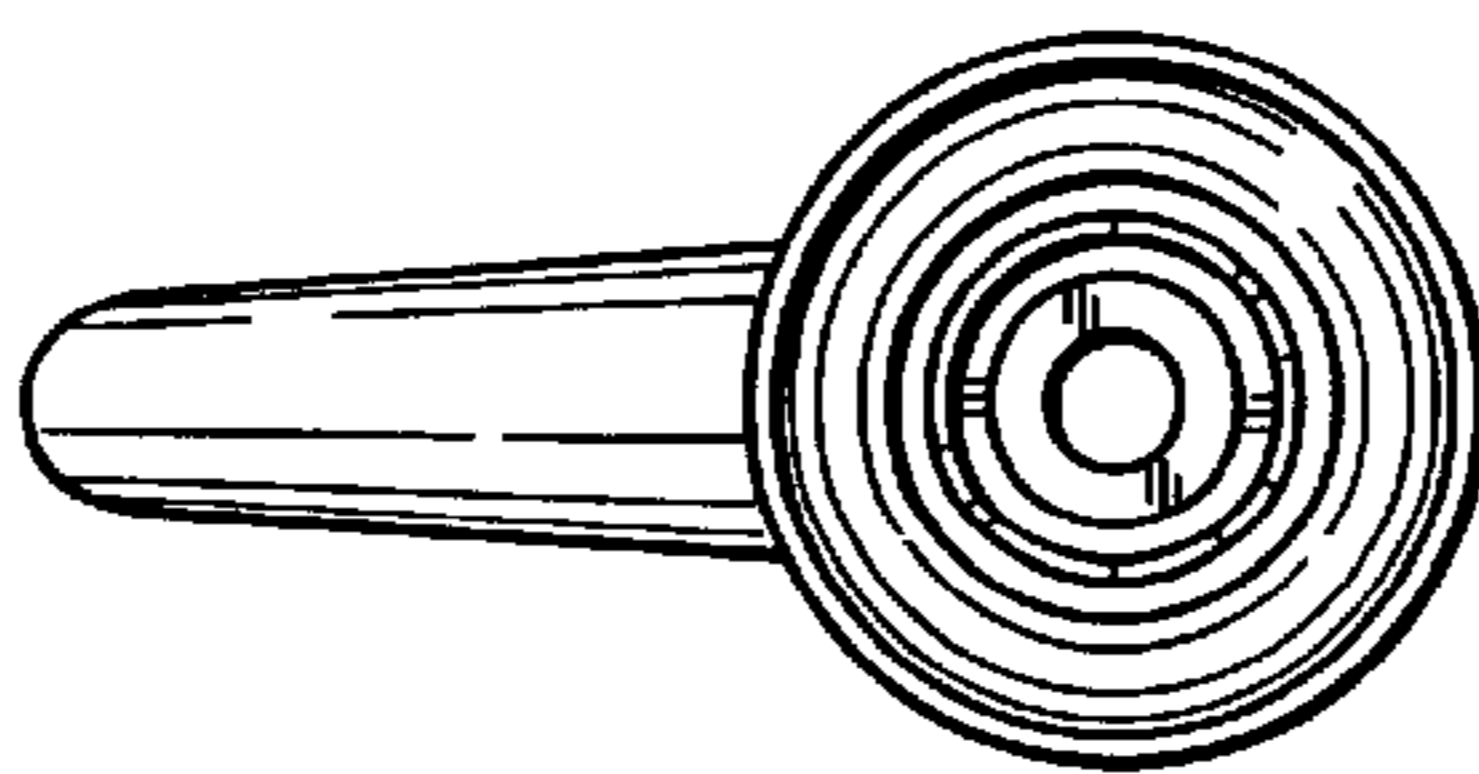
