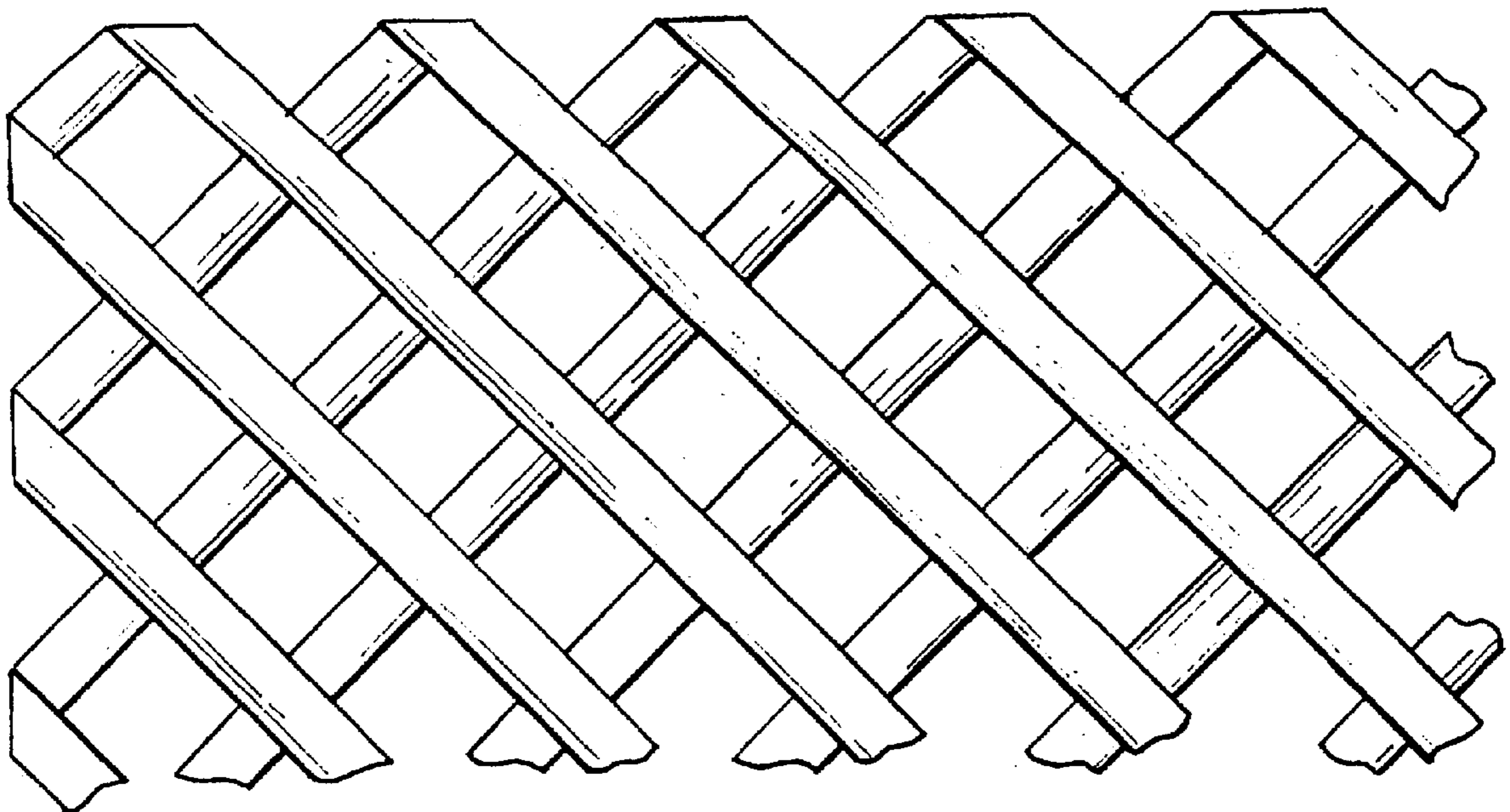
I claim the ornamental design for a plastic lattice, as shown and described.

DESCRIPTION

FIG. 1 is a fragmentary front elevational view of a portion of a plastic lattice embodying my design, the pattern is repetitive throughout the design as illustrated in this view, and the rear view is a mirror image of the front view; FIG. 2 is an enlarged fragmentary perspective view of the plastic lattice; FIG. 3 is a greatly enlarged cross sectional view taken along line 3—3 of FIG. 2; and, FIG. 4 is a greatly enlarged cross sectional view taken along line 4—4 of FIG. 2.

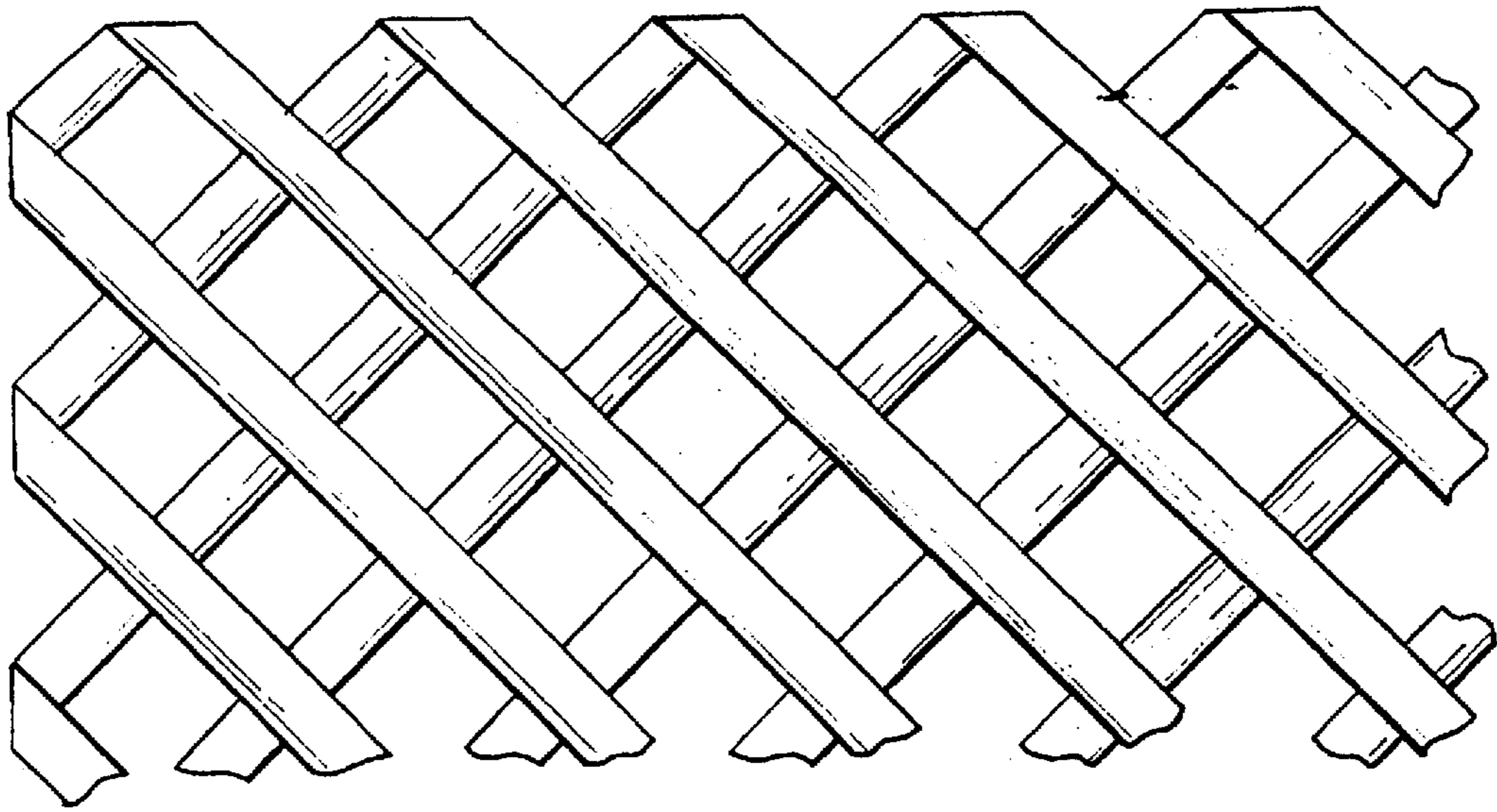

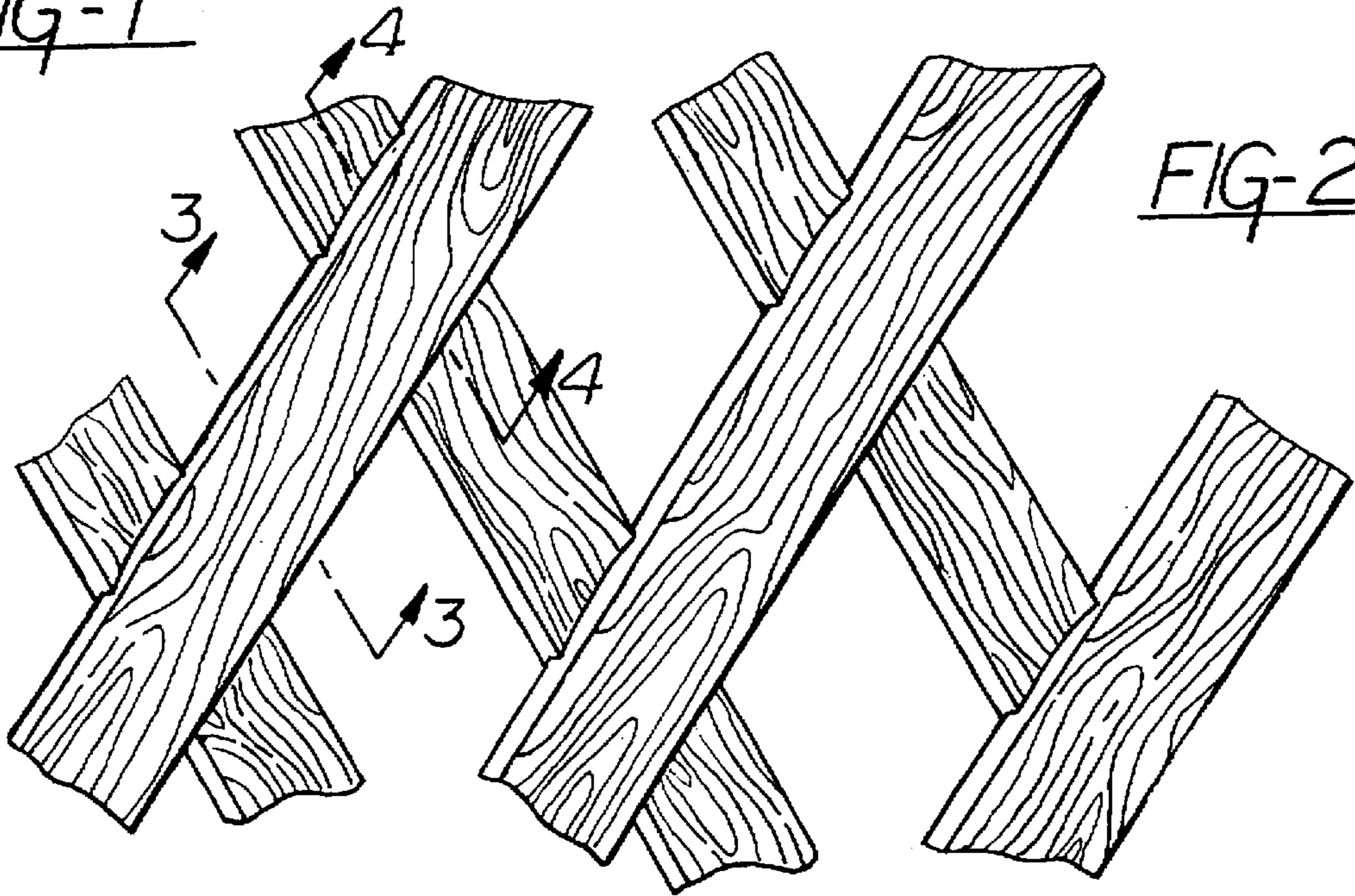

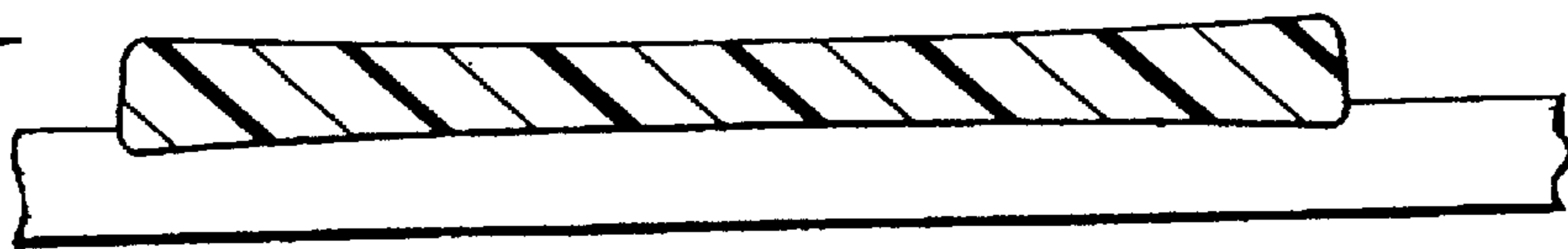
