**DESCRIPTION**

FIG. 5 is a right side view of the media storage rack of FIG. 1;

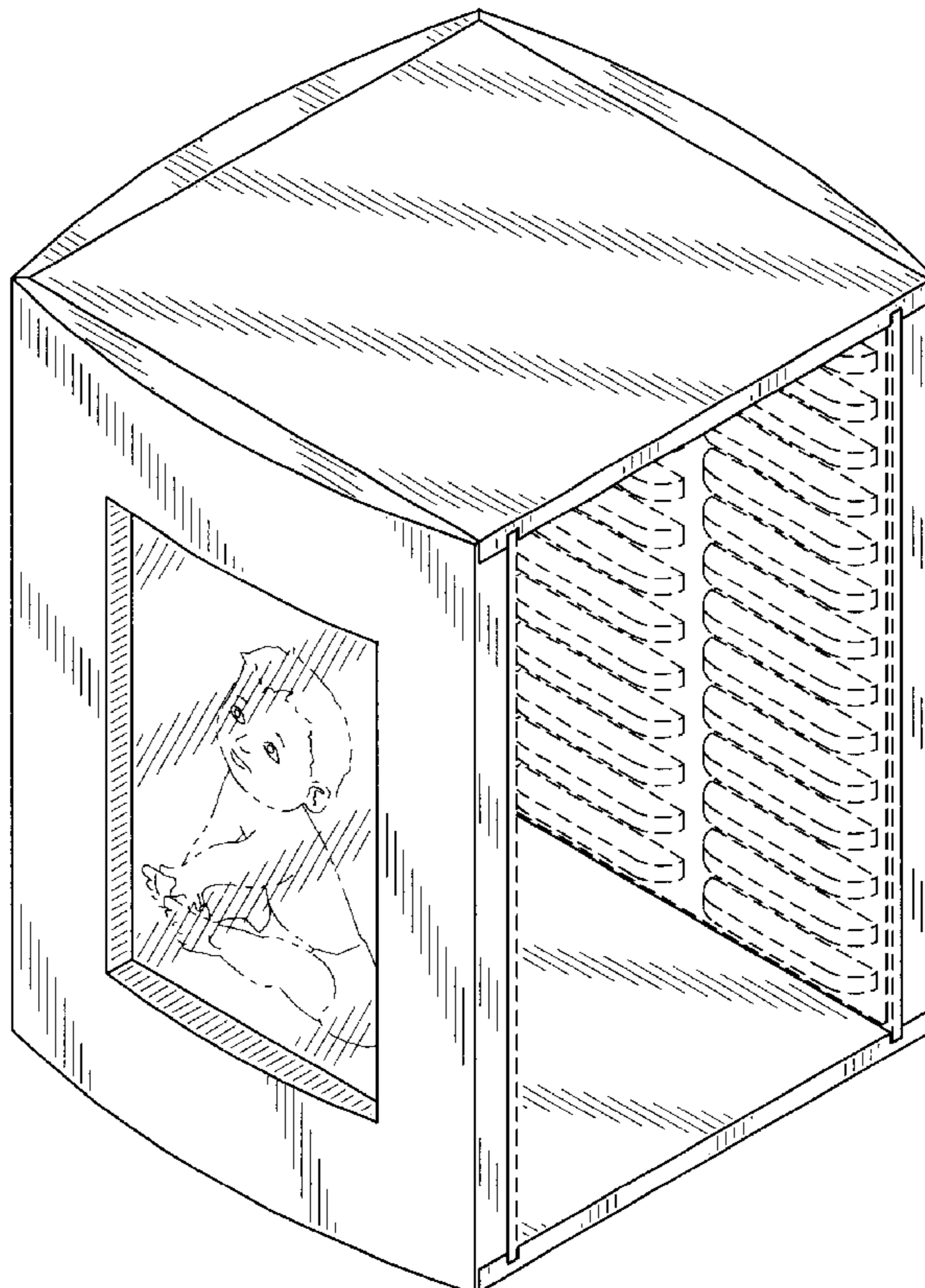
FIG. 6 is a rear view of the media storage rack of FIG. 1;

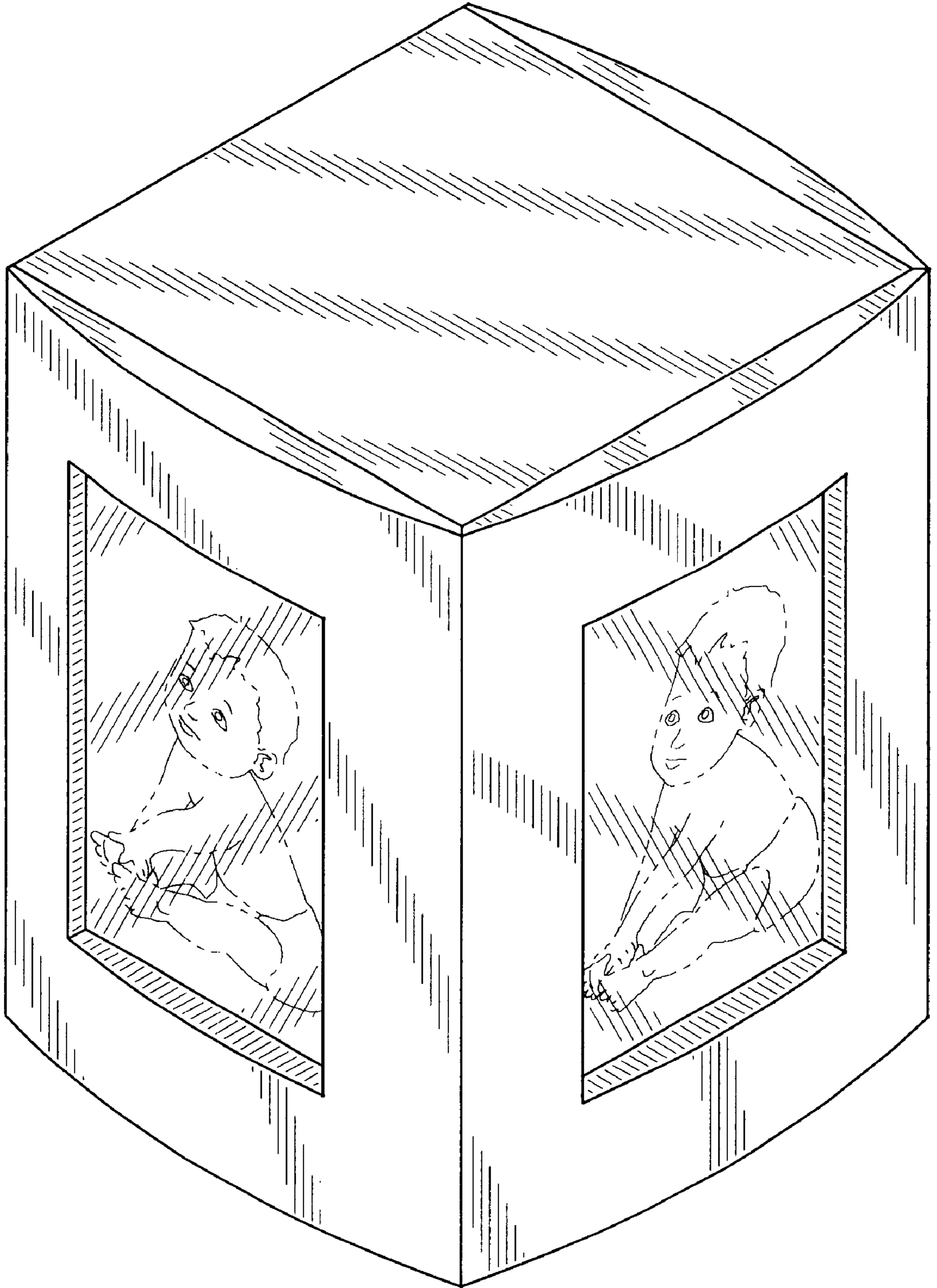

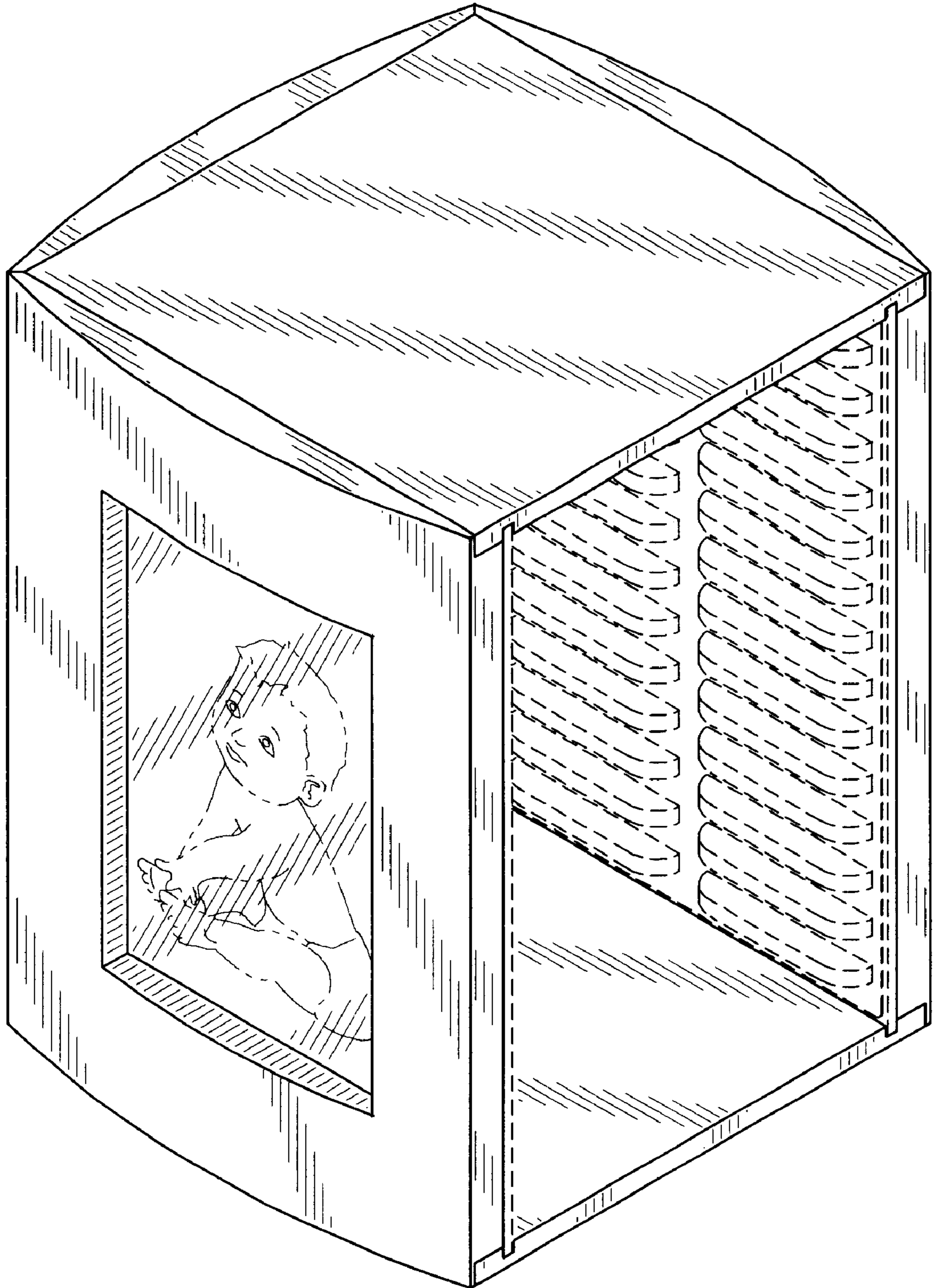

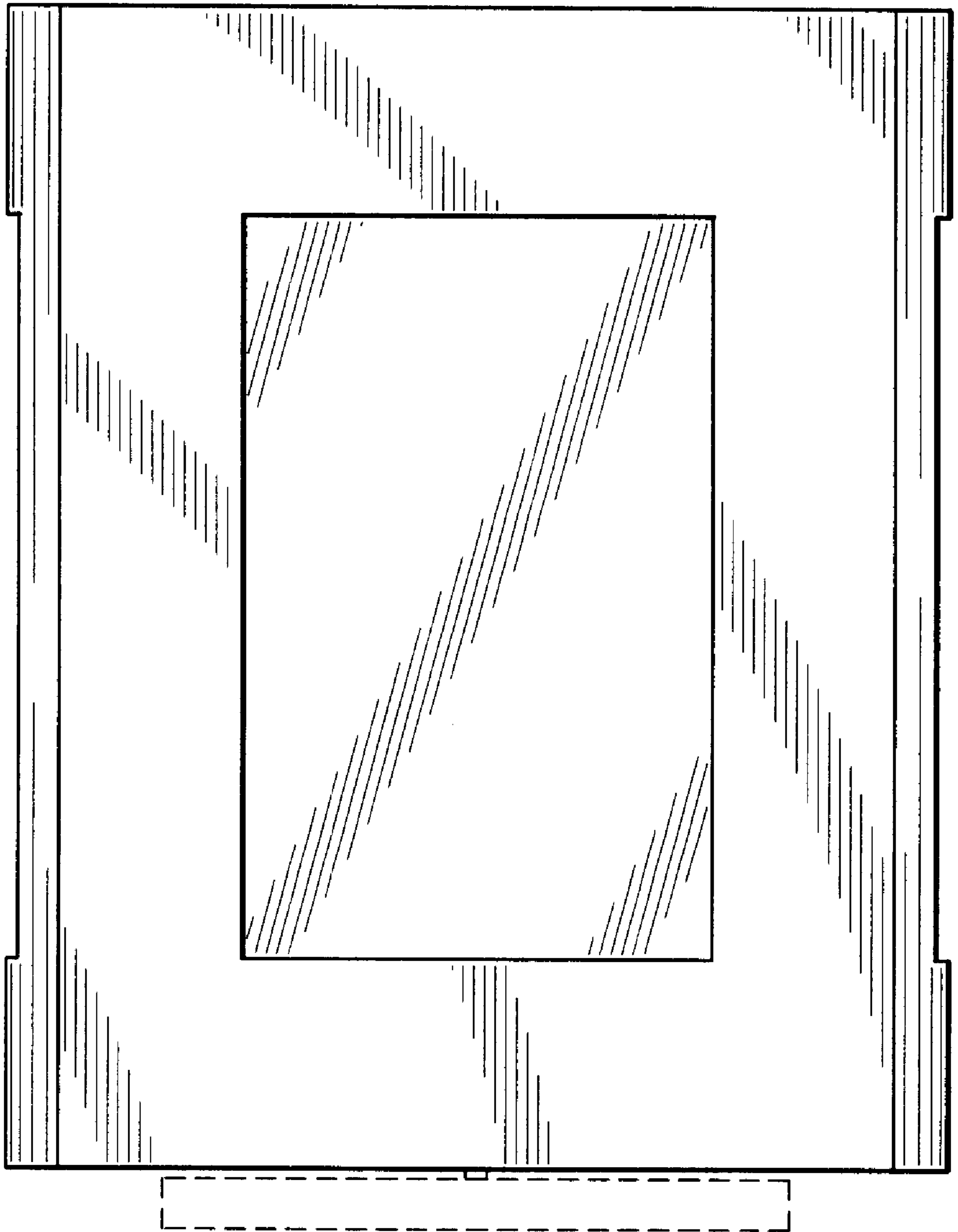

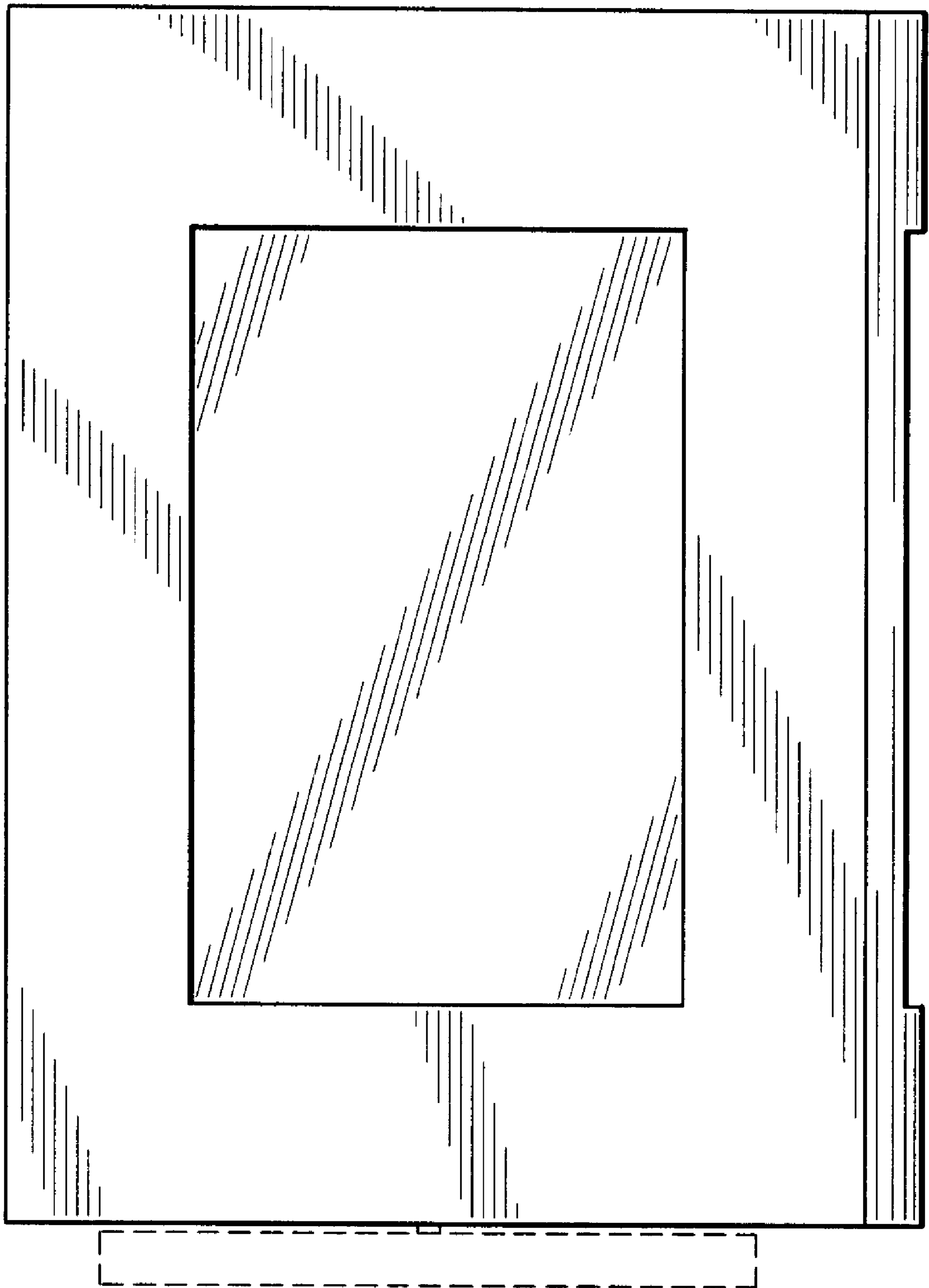

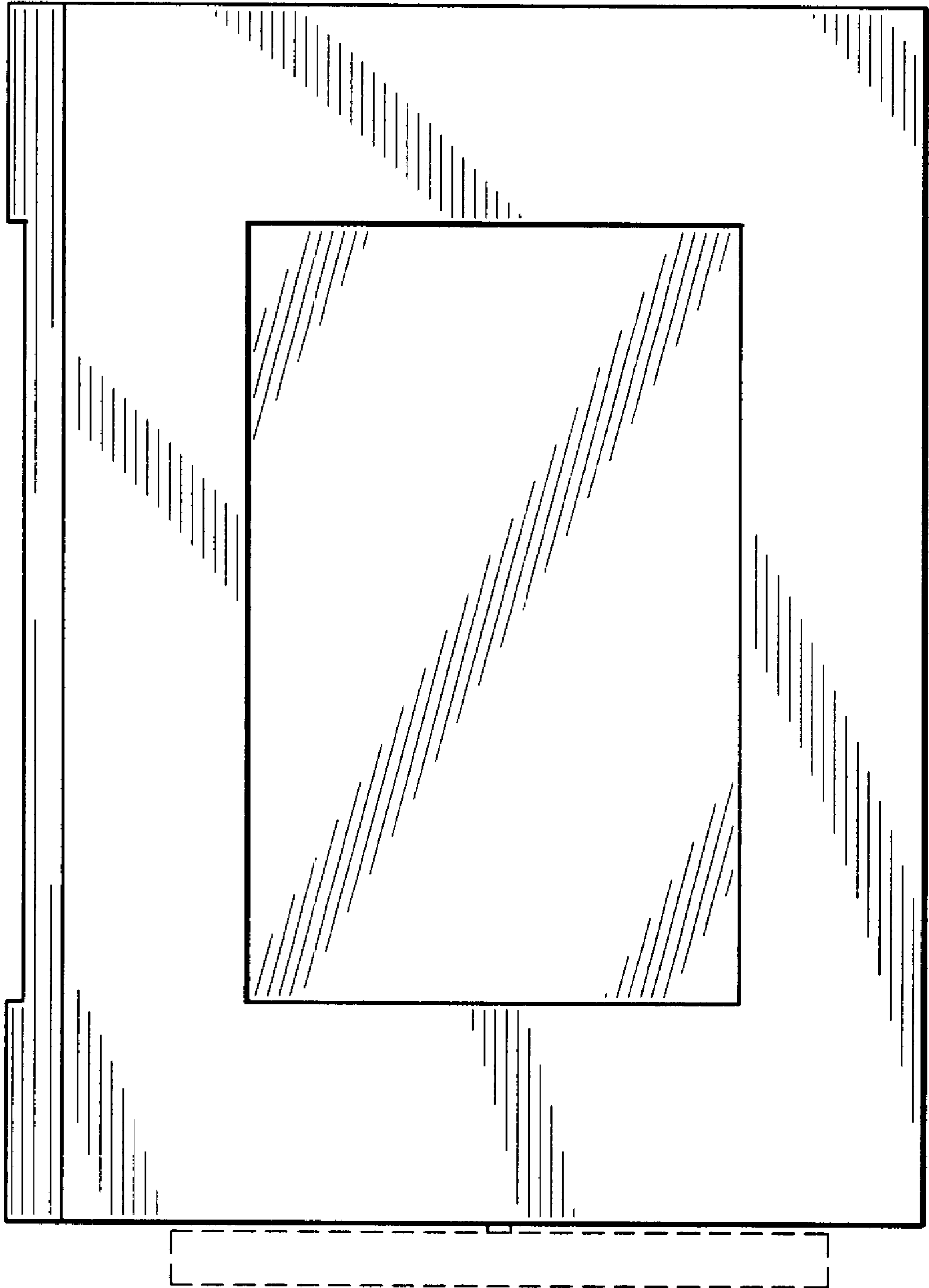

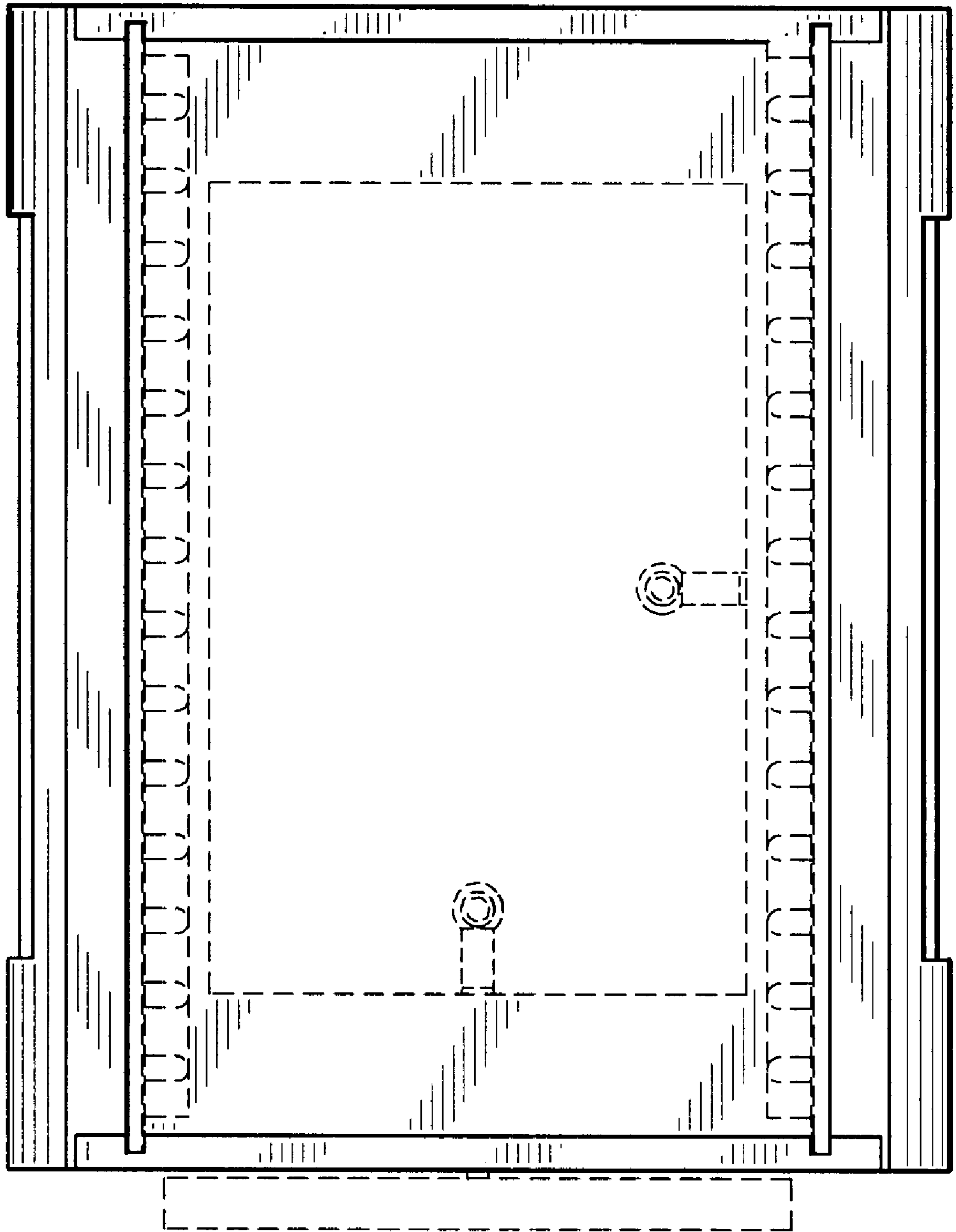

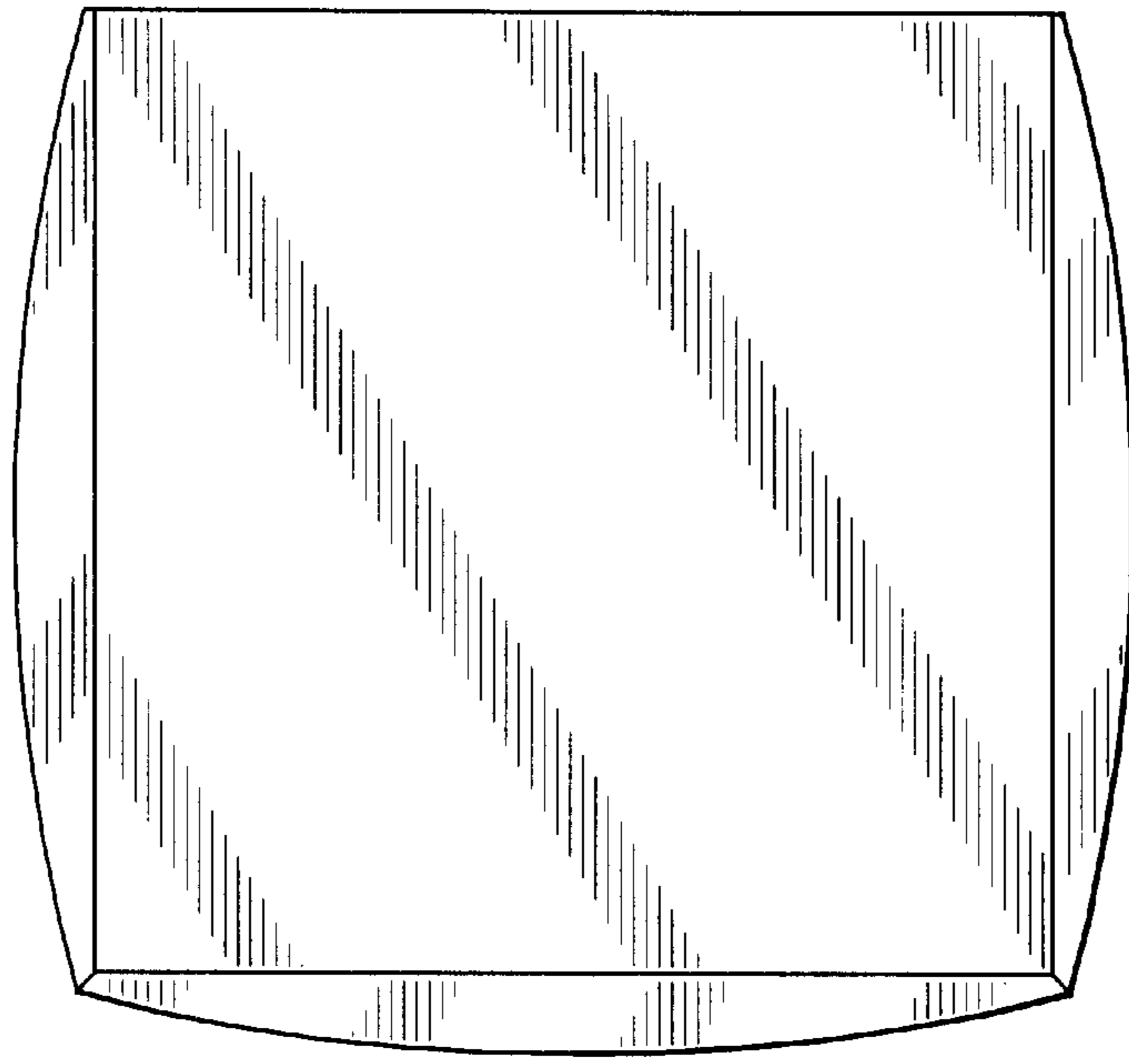

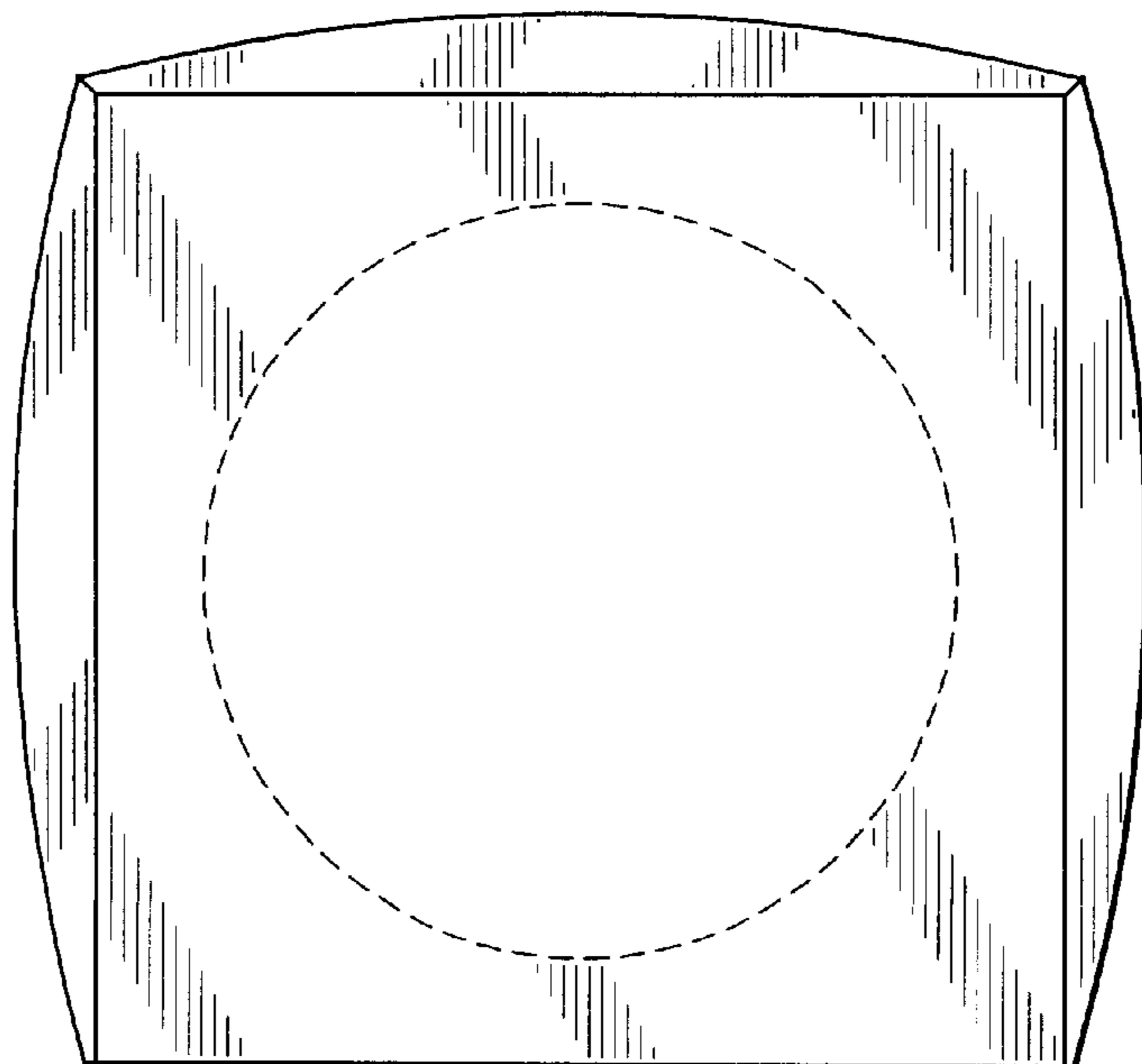
