DESCRIPTION

FIG. 1 is an isometric view of the back-to-back seating unit of my design;

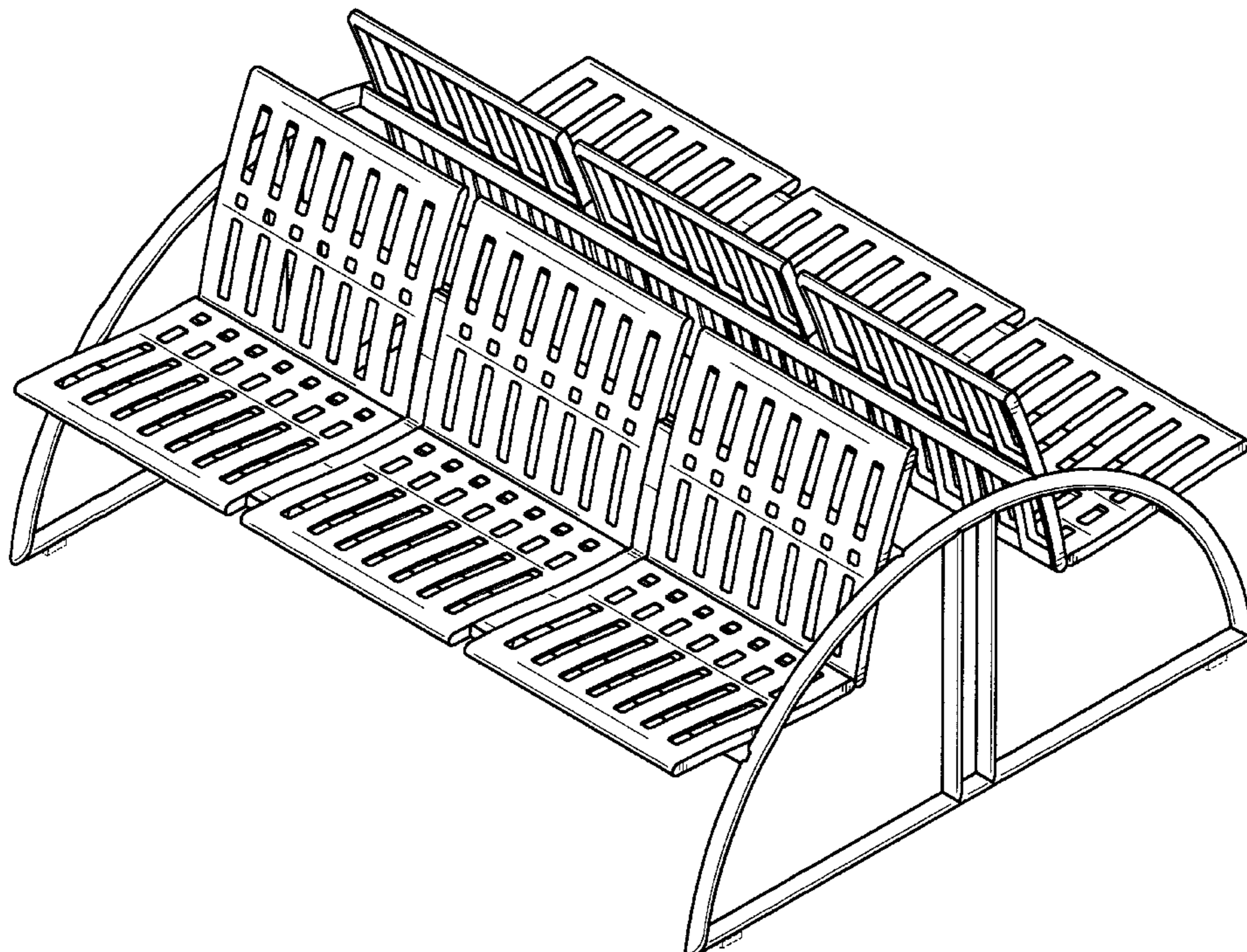
FIG. 2 is a top plan view thereof;

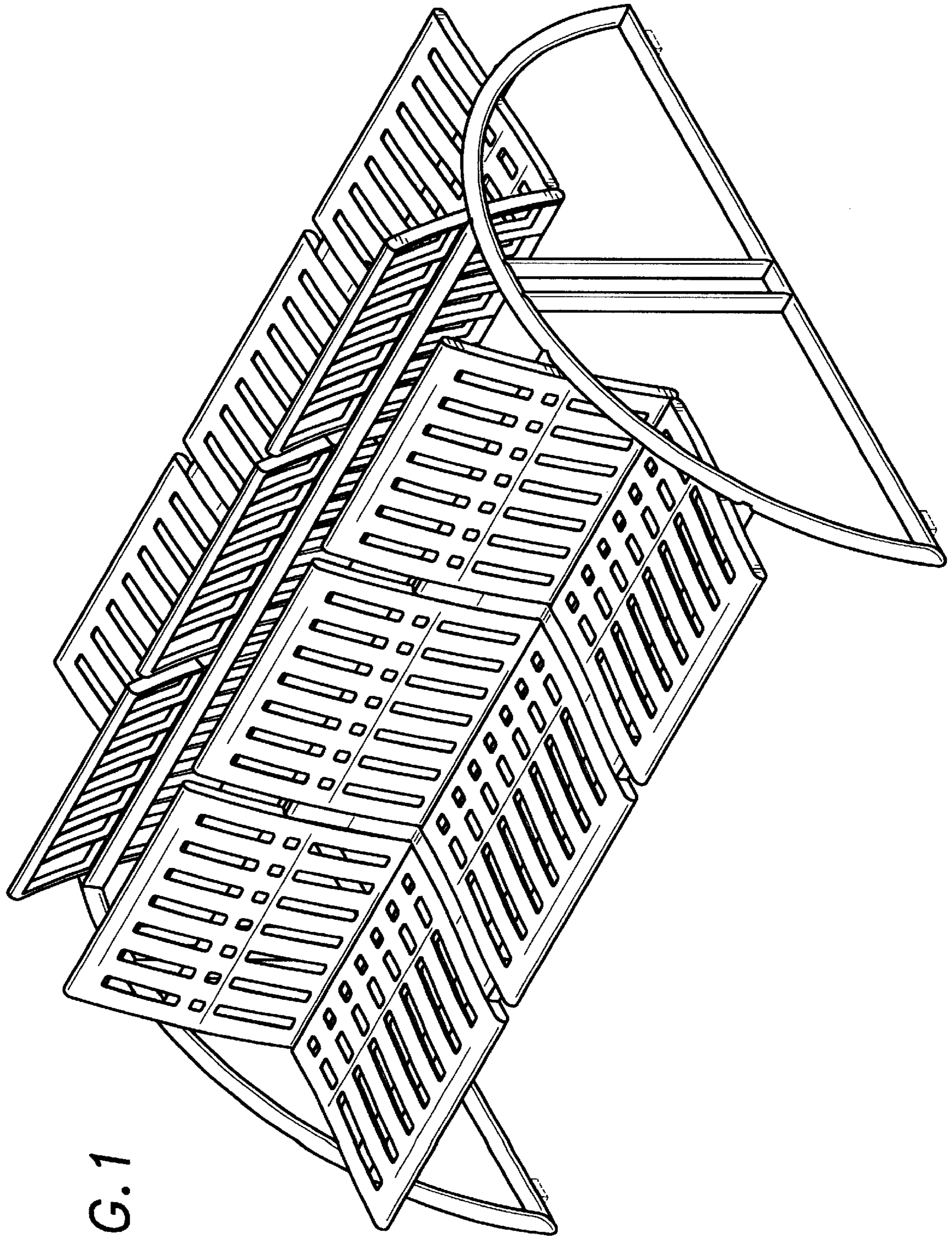

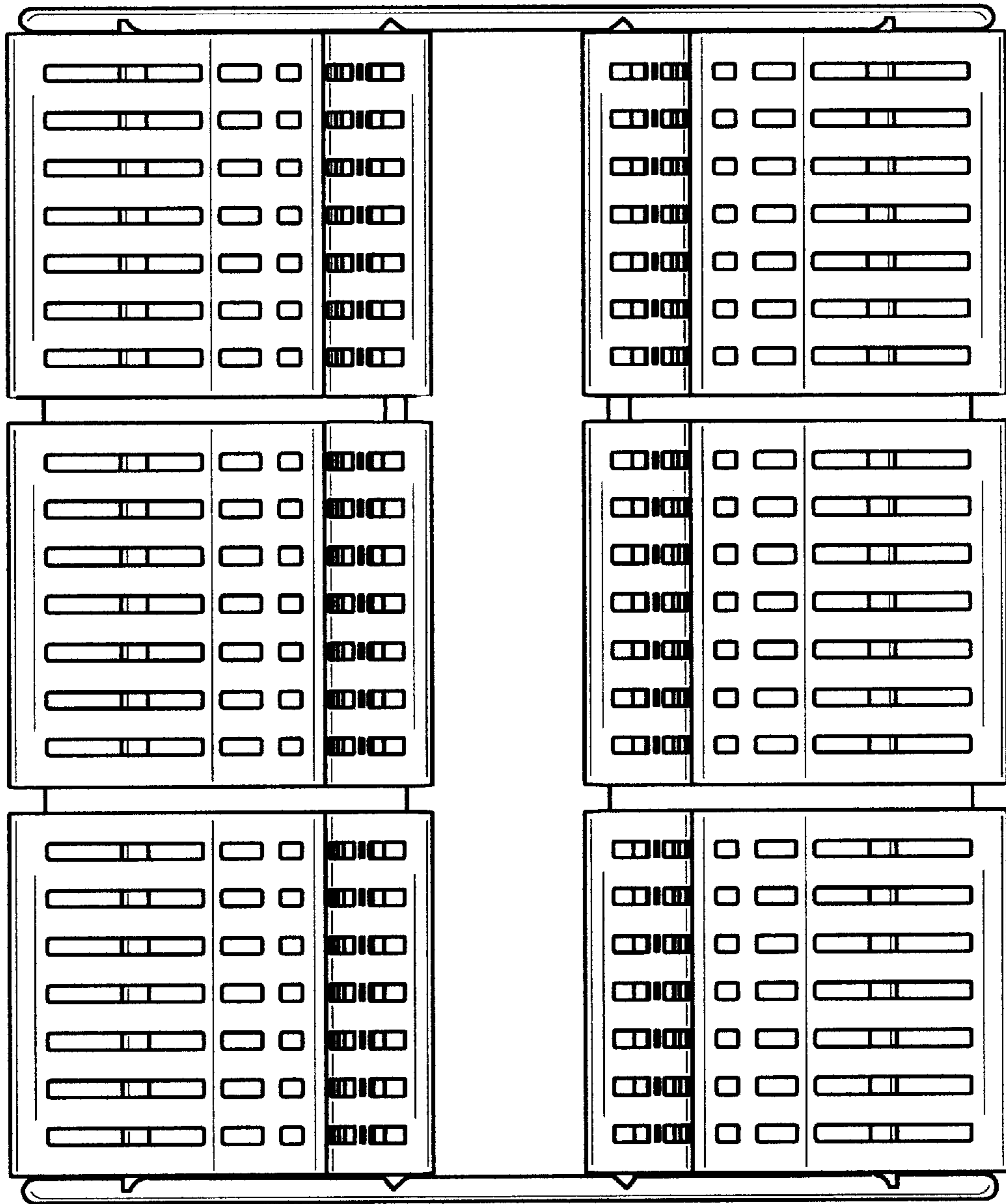

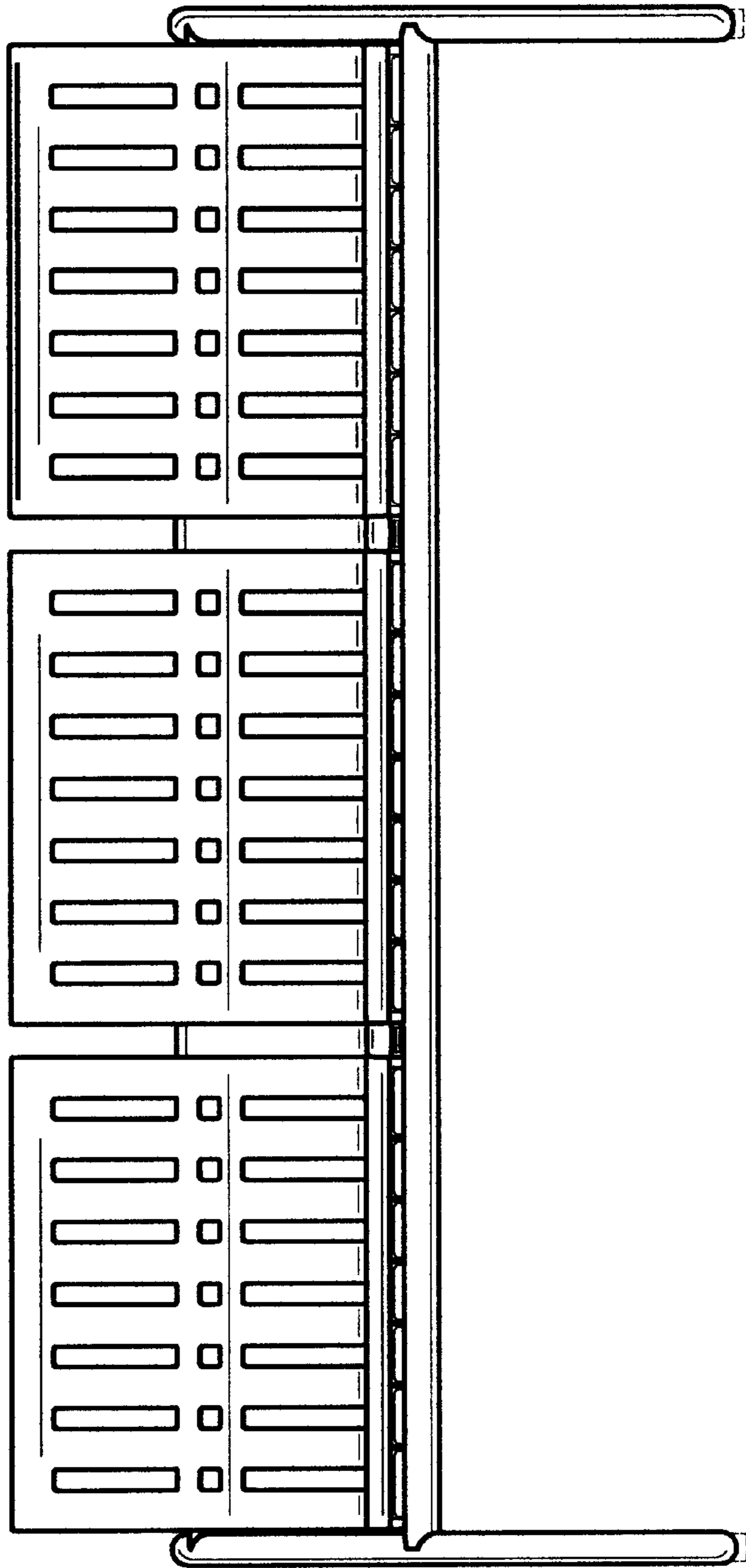
