(57) **CLAIM**

The ornamental design for a bed, as shown and described.

DESCRIPTION

FIG. 1 is a front left perspective view of a bed showing my new design;

FIG. 2 is a front perspective thereof;

FIG. 3 is a side view thereof;

FIG. 4 is a front perspective view of the headboard of FIG. 1;

FIG. 5 is a front perspective view of the footboard of FIG. 1;

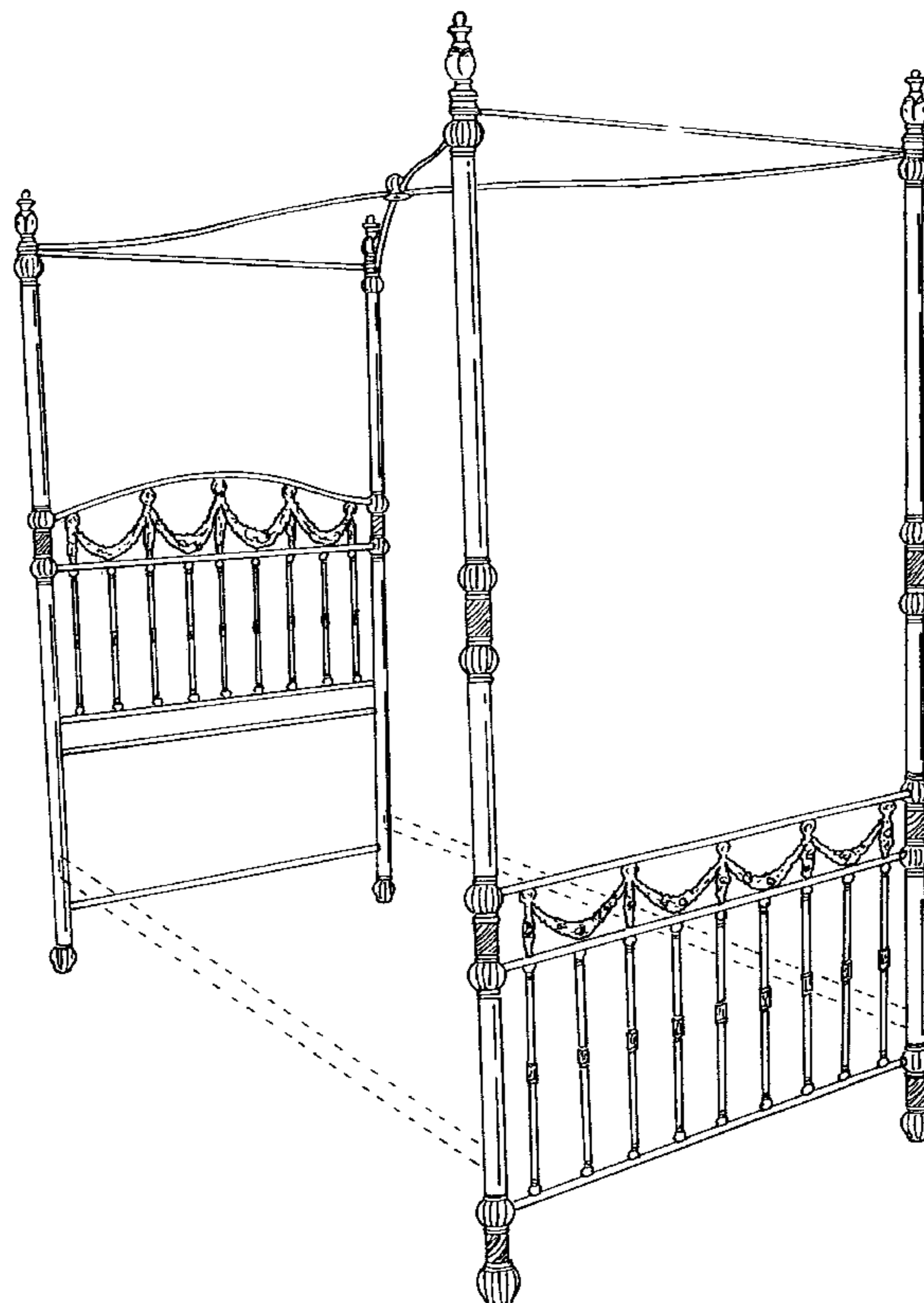
FIG. 6 is an enlarged partial front view of the left upper portion of the headboard of FIG. 1, illustrating the decorative repeat pattern thereon;

FIG. 7 is an enlarged partial front view of one post of the embodiment of FIG. 1, illustrating a finial and surface configuration;

FIG. 8 is an enlarged partial front view of the center portion of one of the corner posts of the embodiment of FIG. 1; and,

FIG. 9 is an enlarged perspective view of the top central portion of the canopy of the embodiment of FIG. 1.

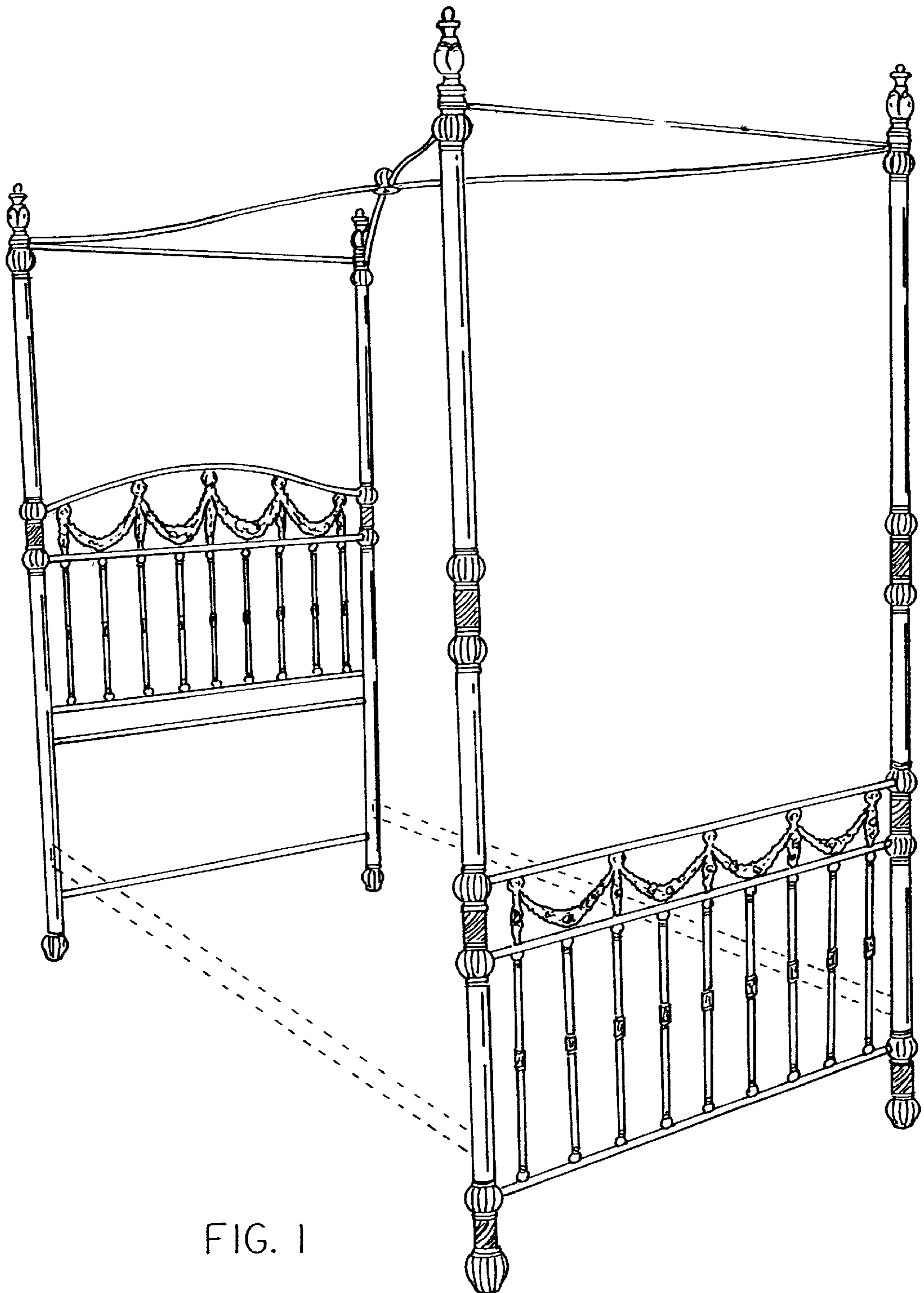

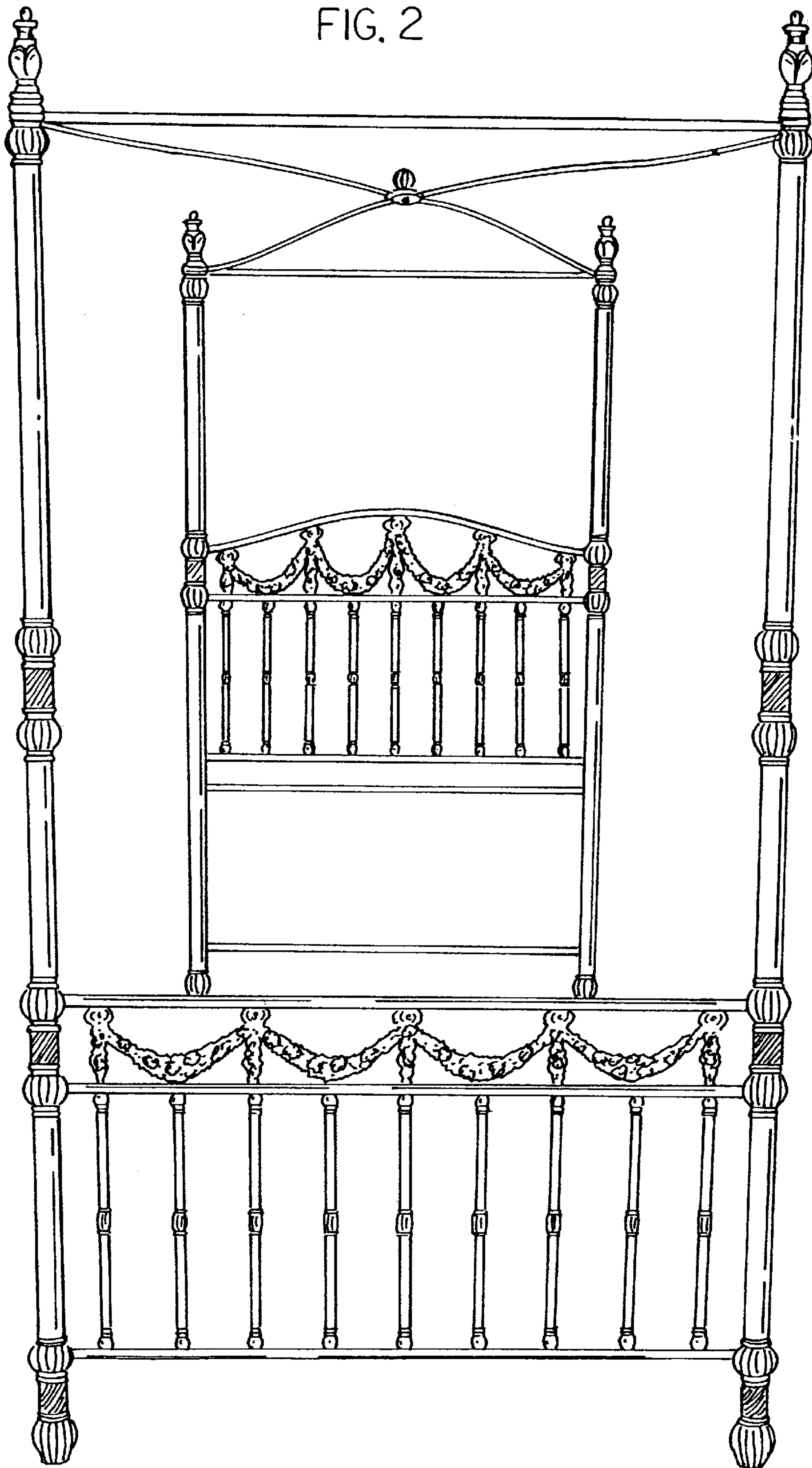
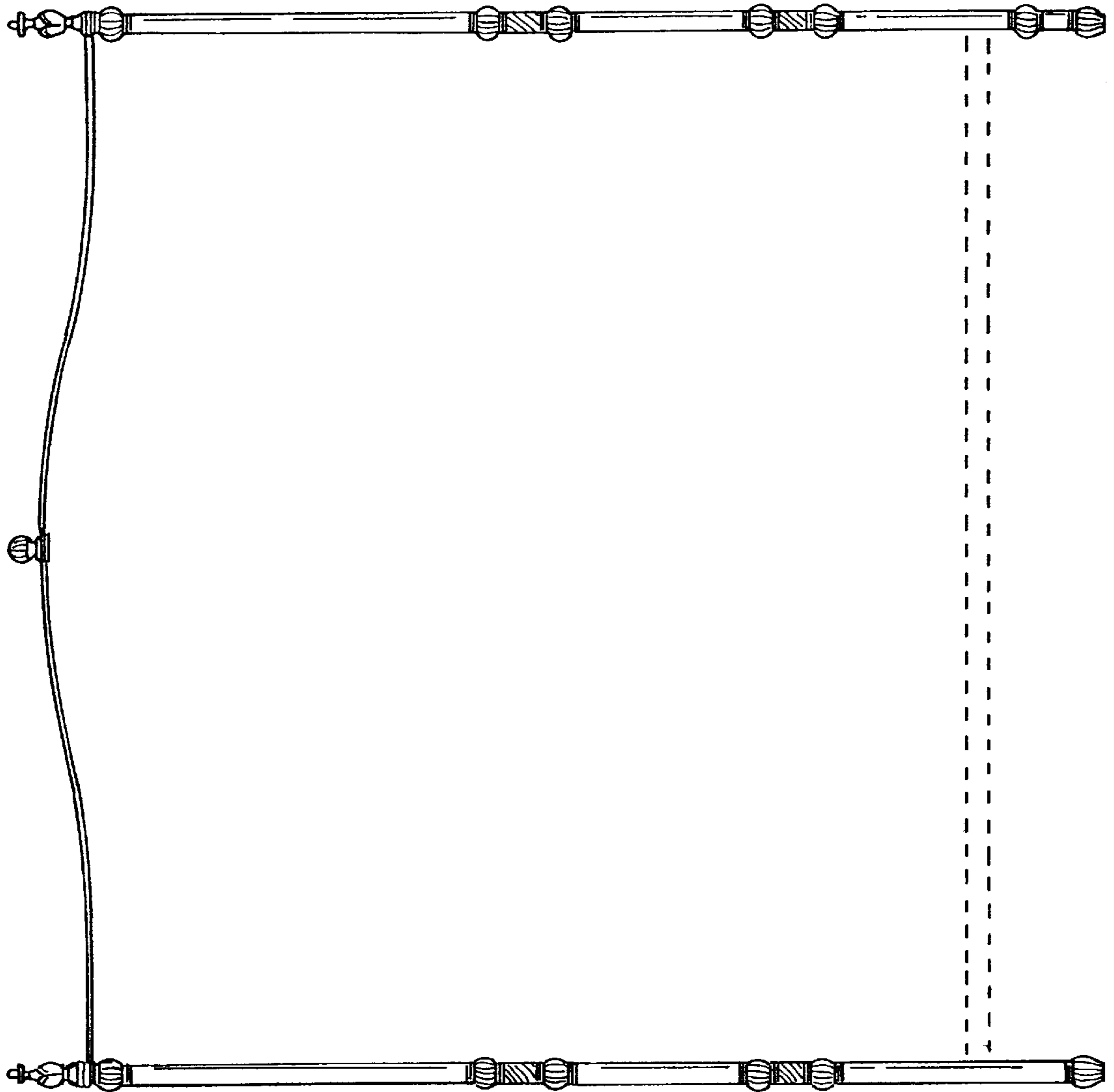

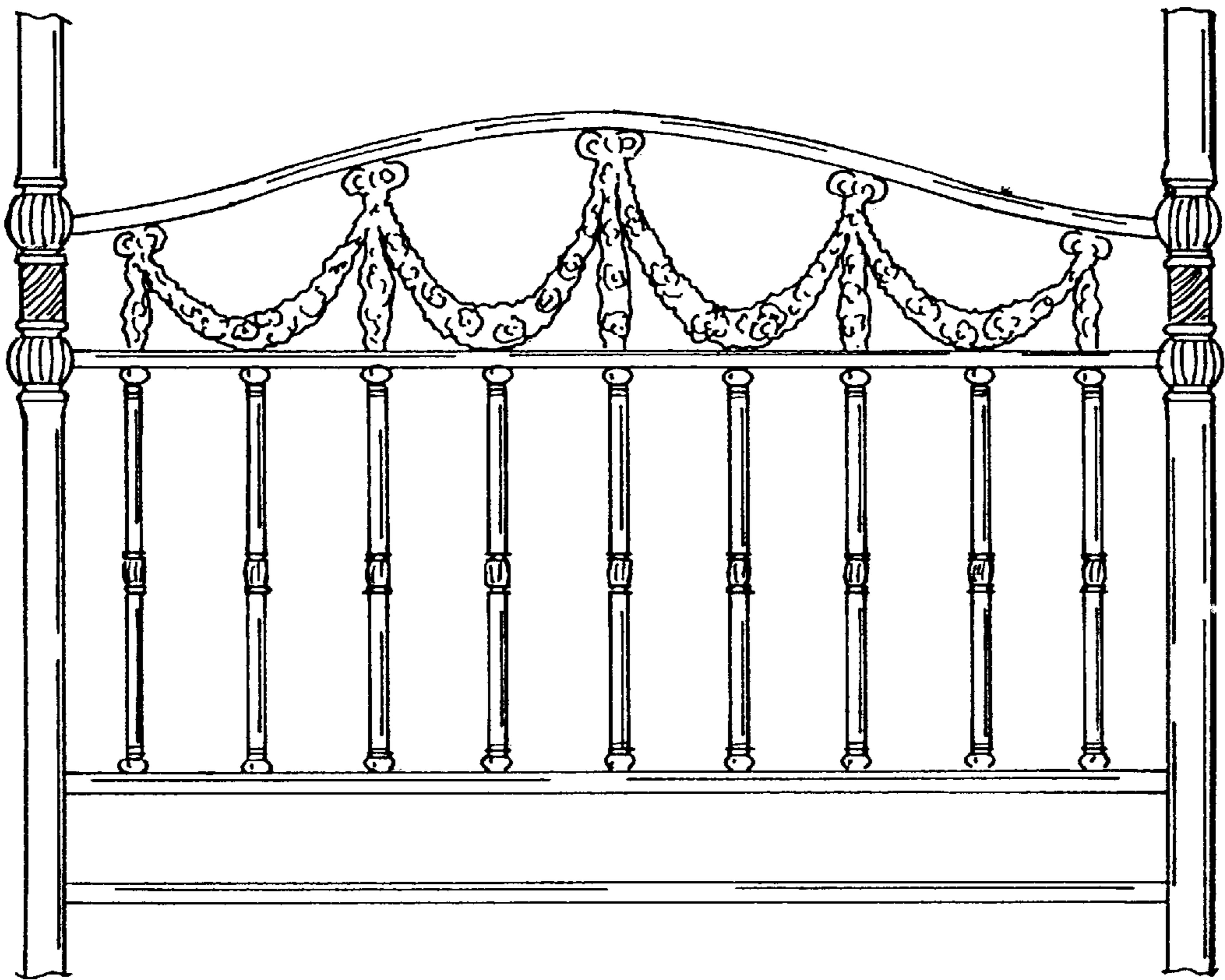
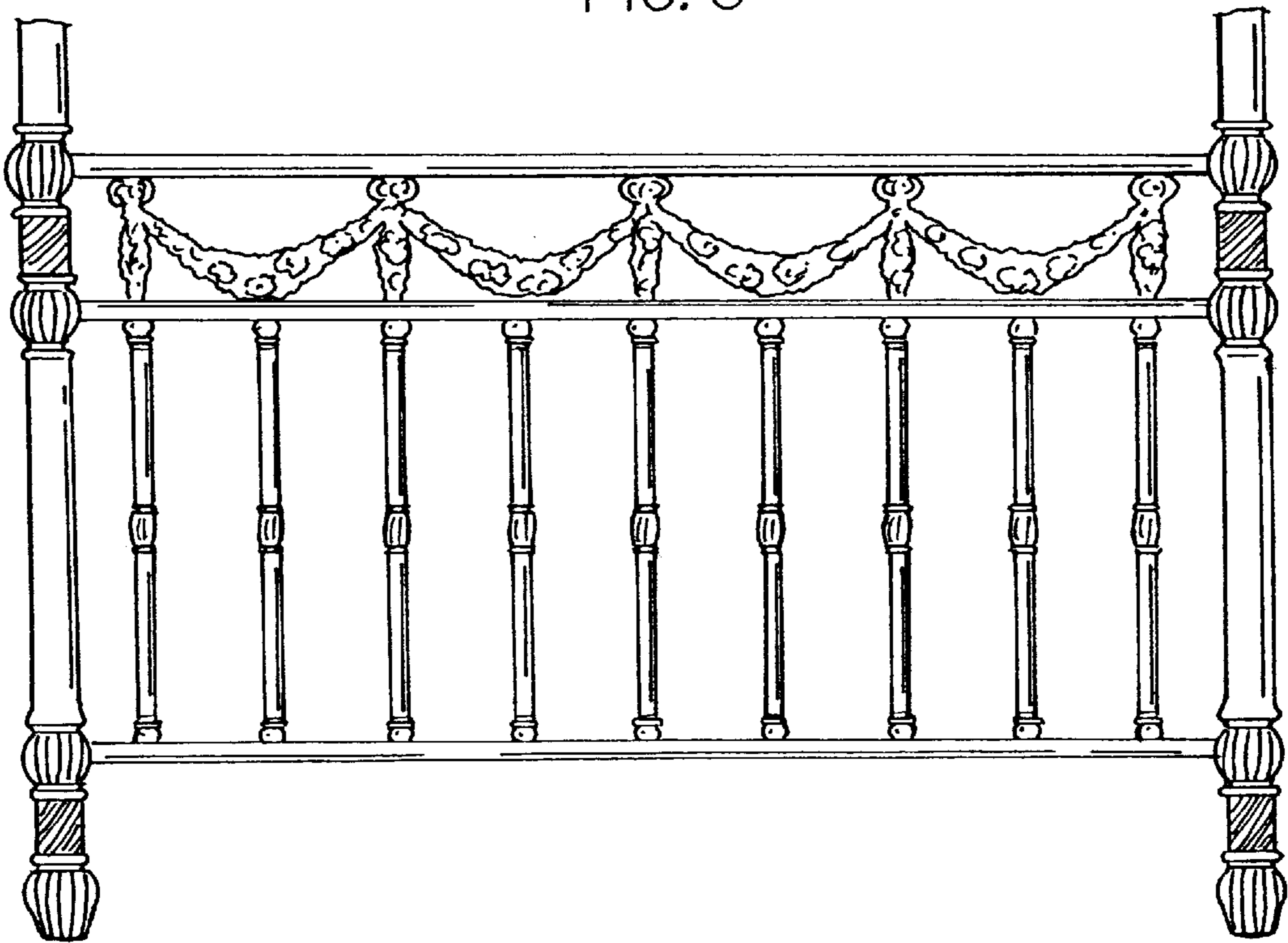

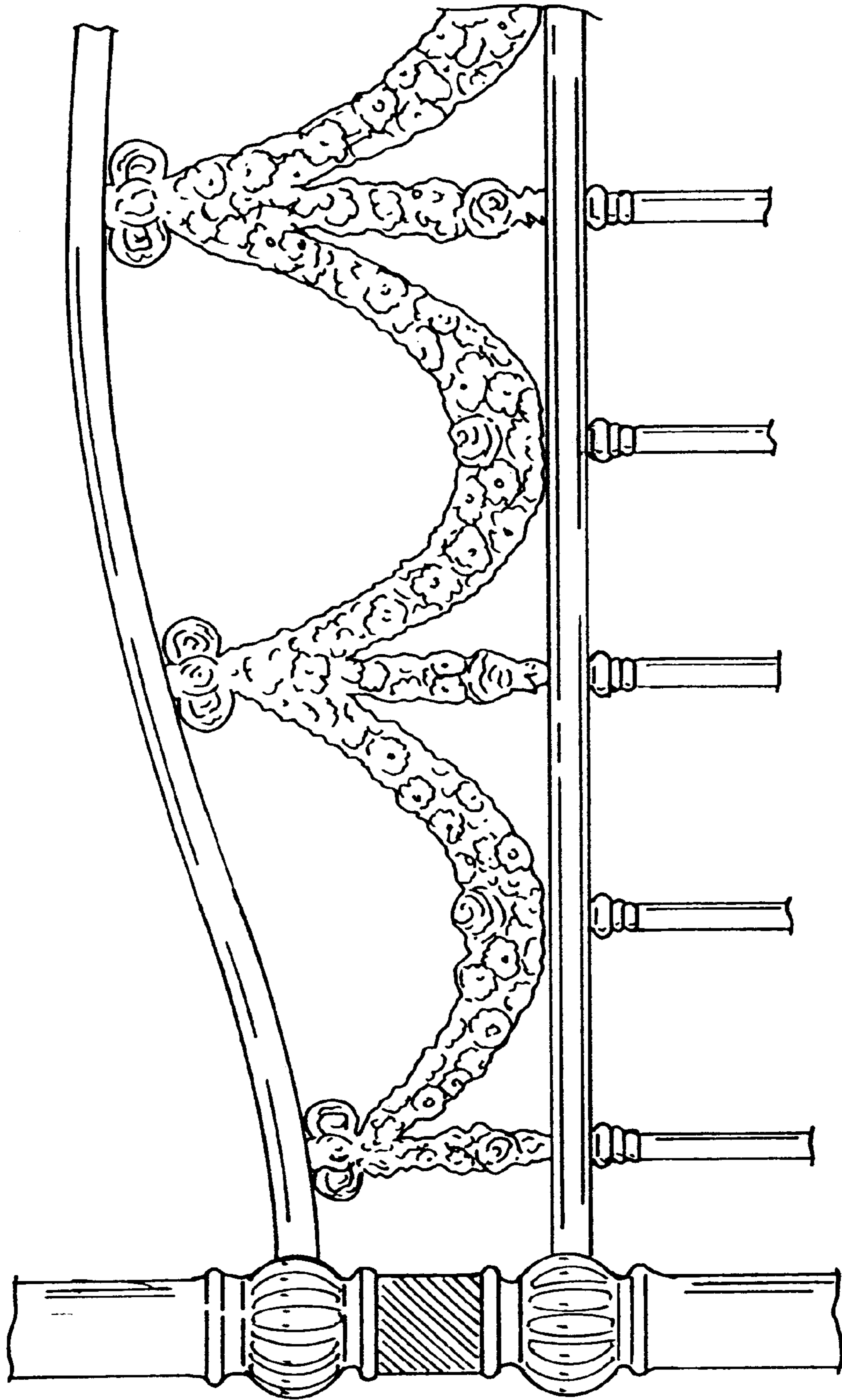

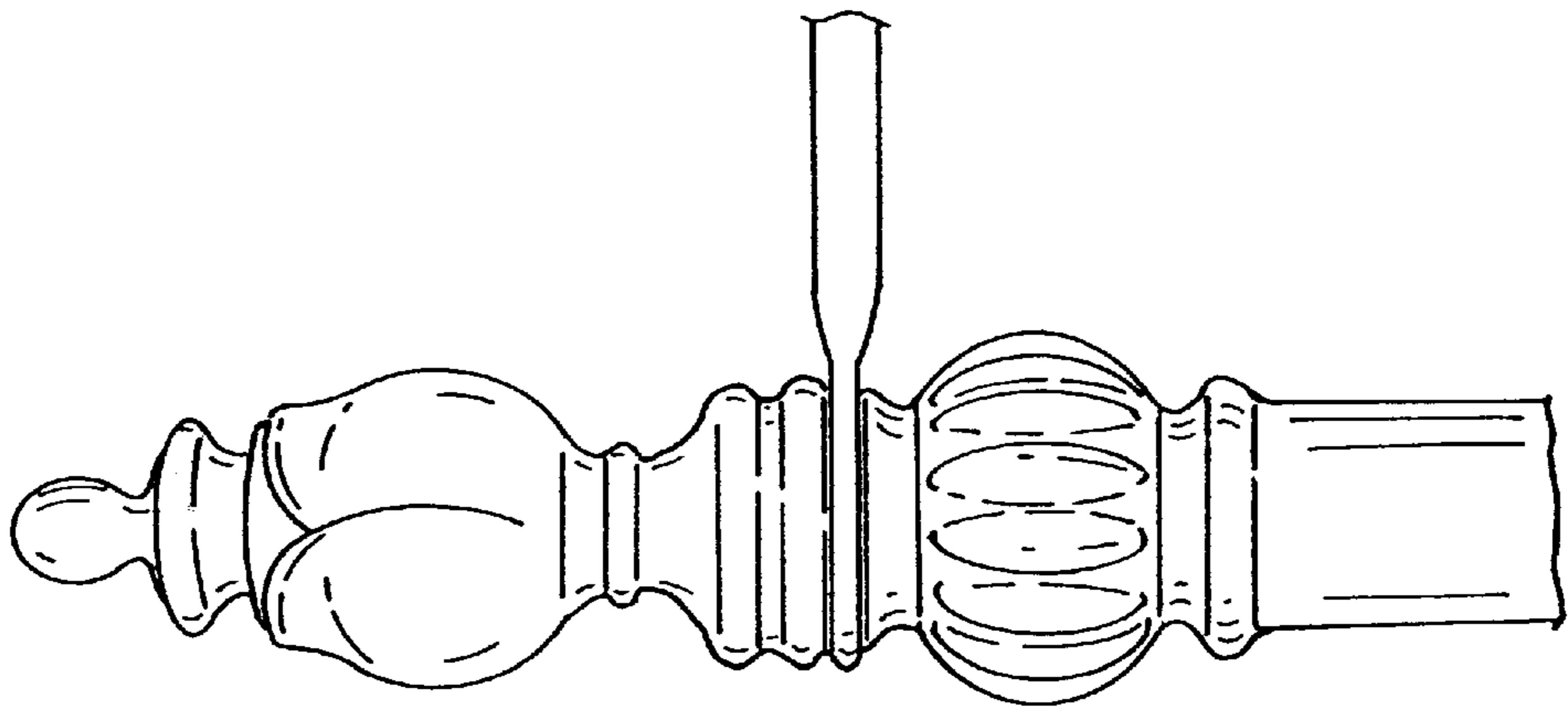

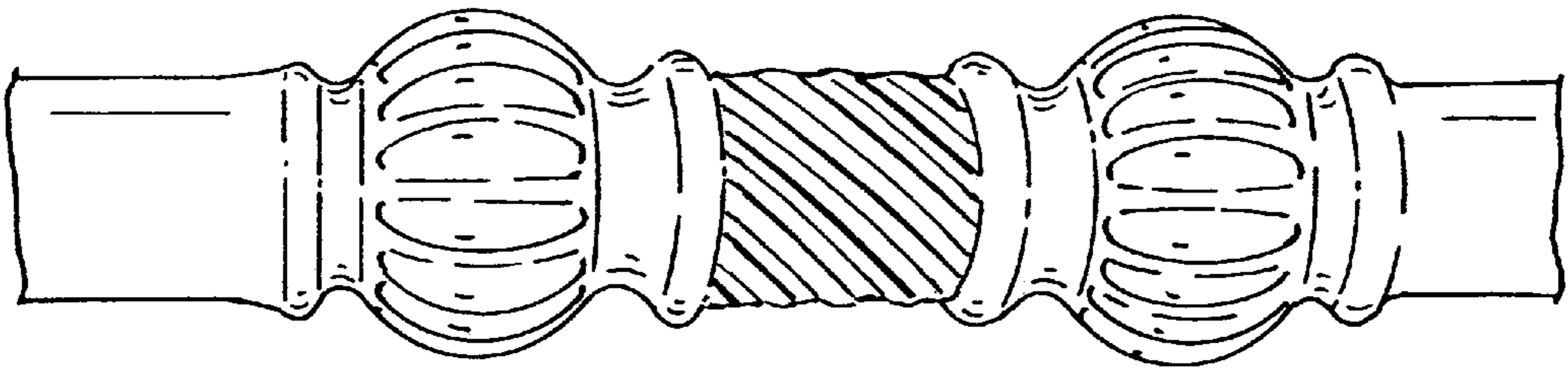
