FIG. 3 is a right side elevational view thereof;

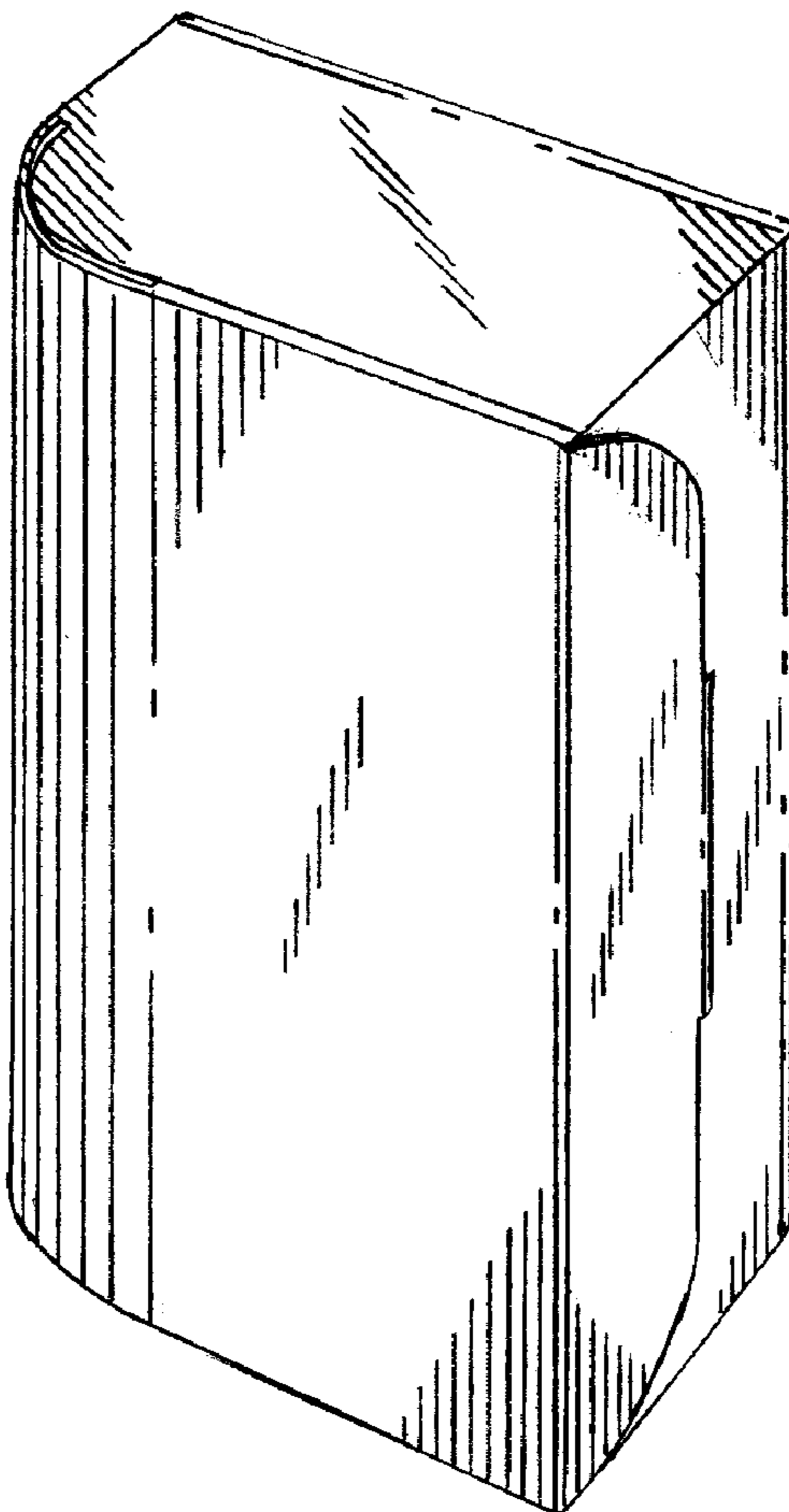
FIG. 4 is a rear elevational view thereof;

FIG. 5 is a left side elevational view thereof; and,

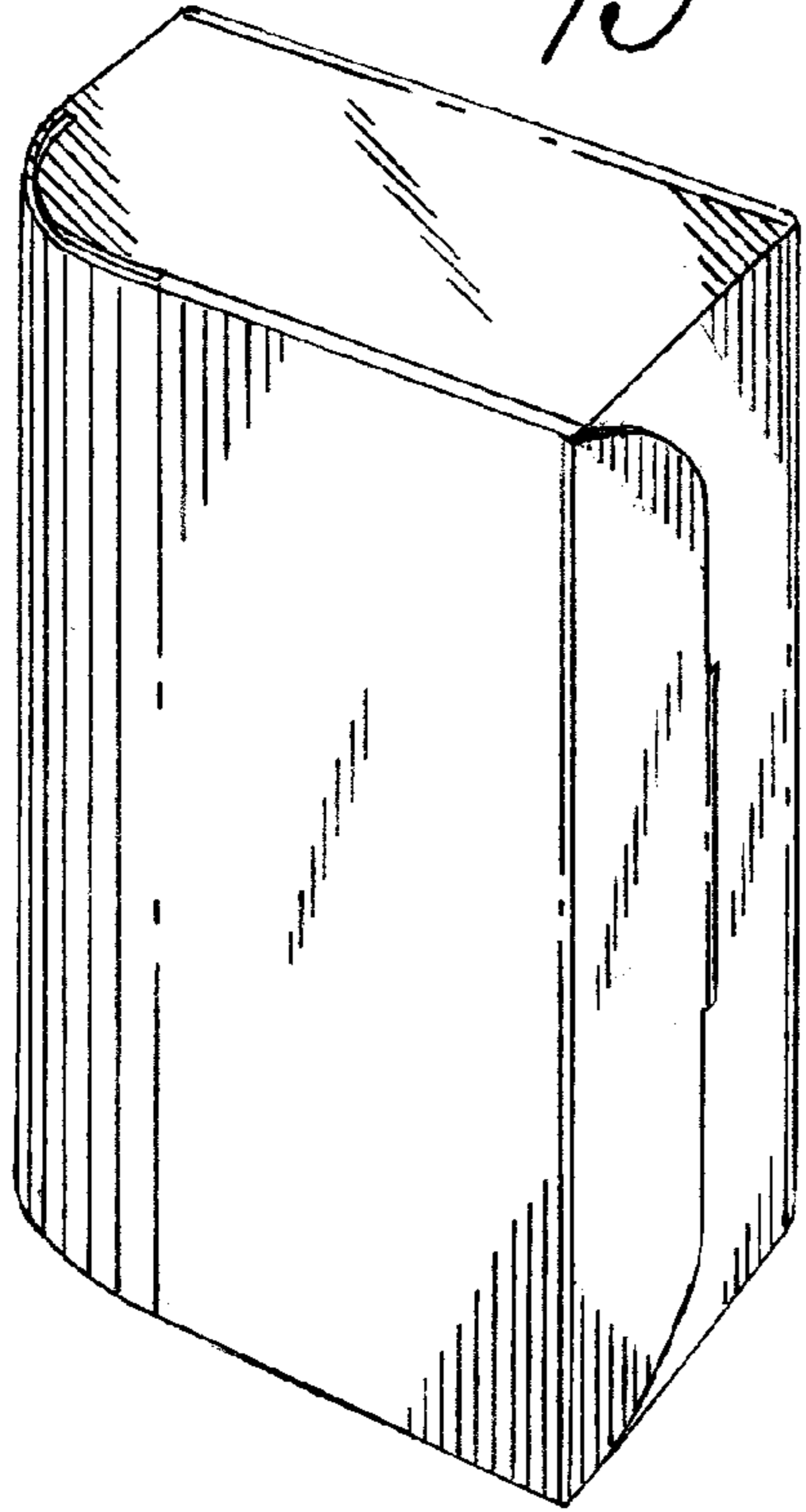
FIG. 6 is a top plan view thereof, the bottom plan view being identical.

The package shown in the figures may preferably be used, inter alia, for storing personal care products.

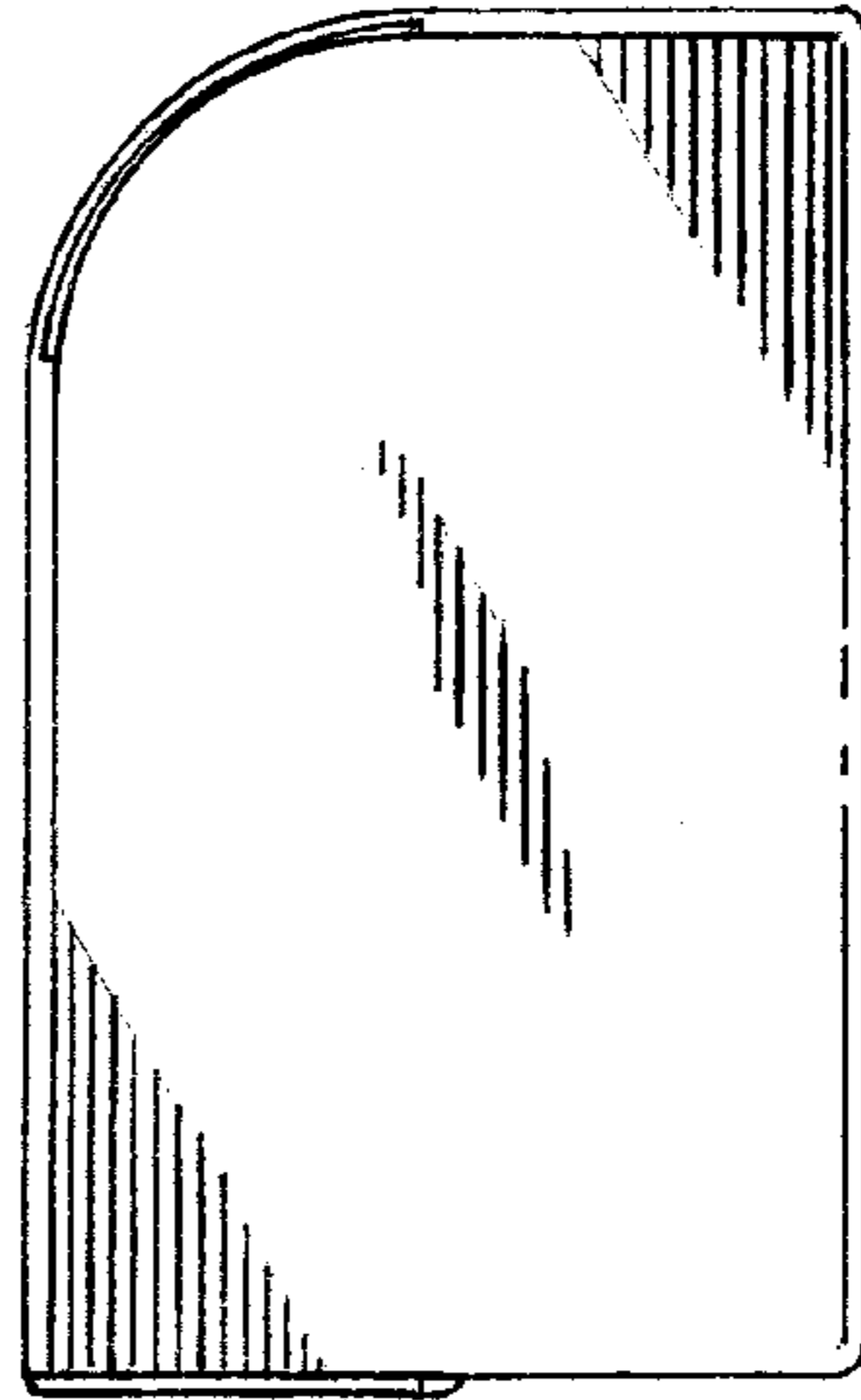

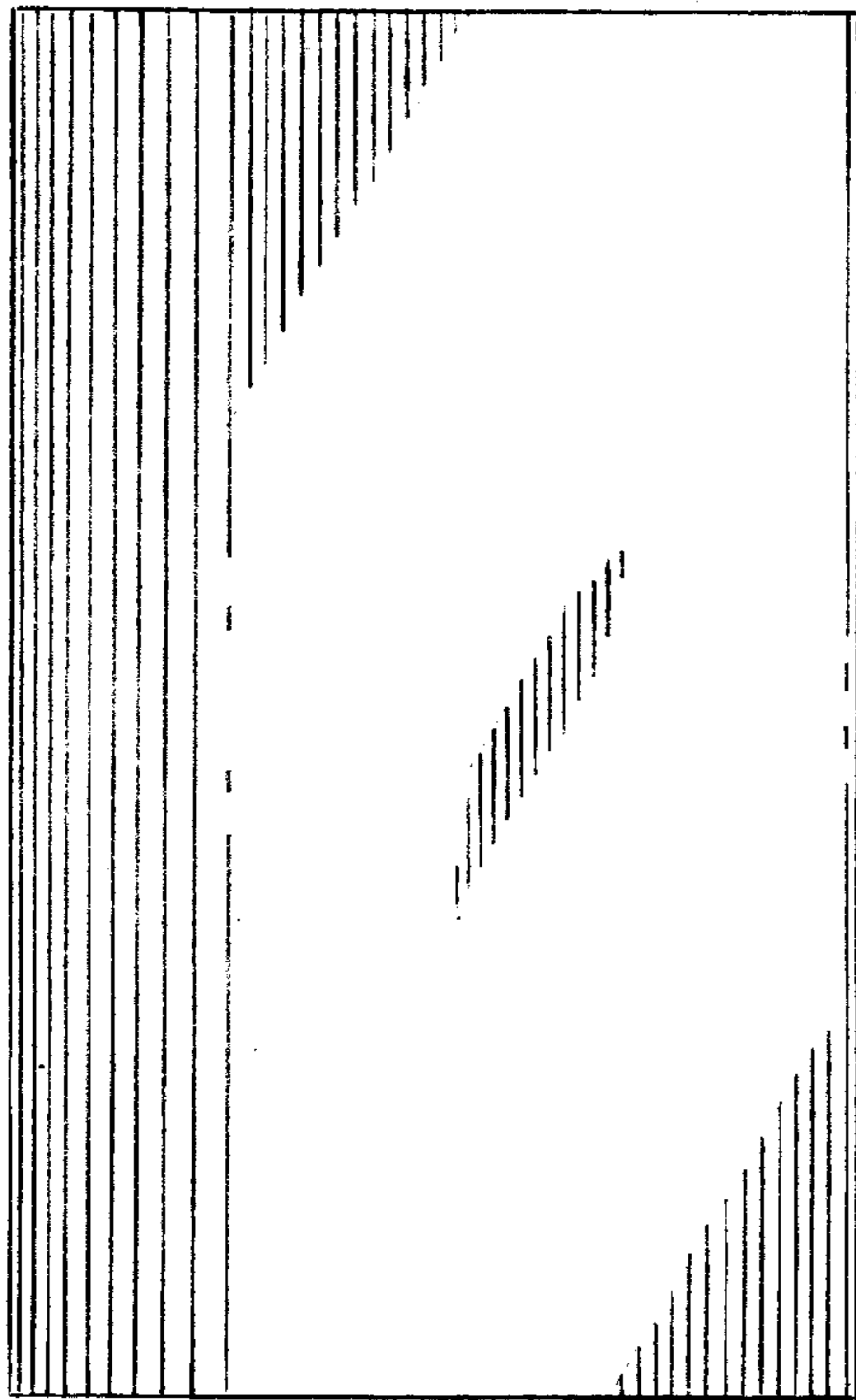

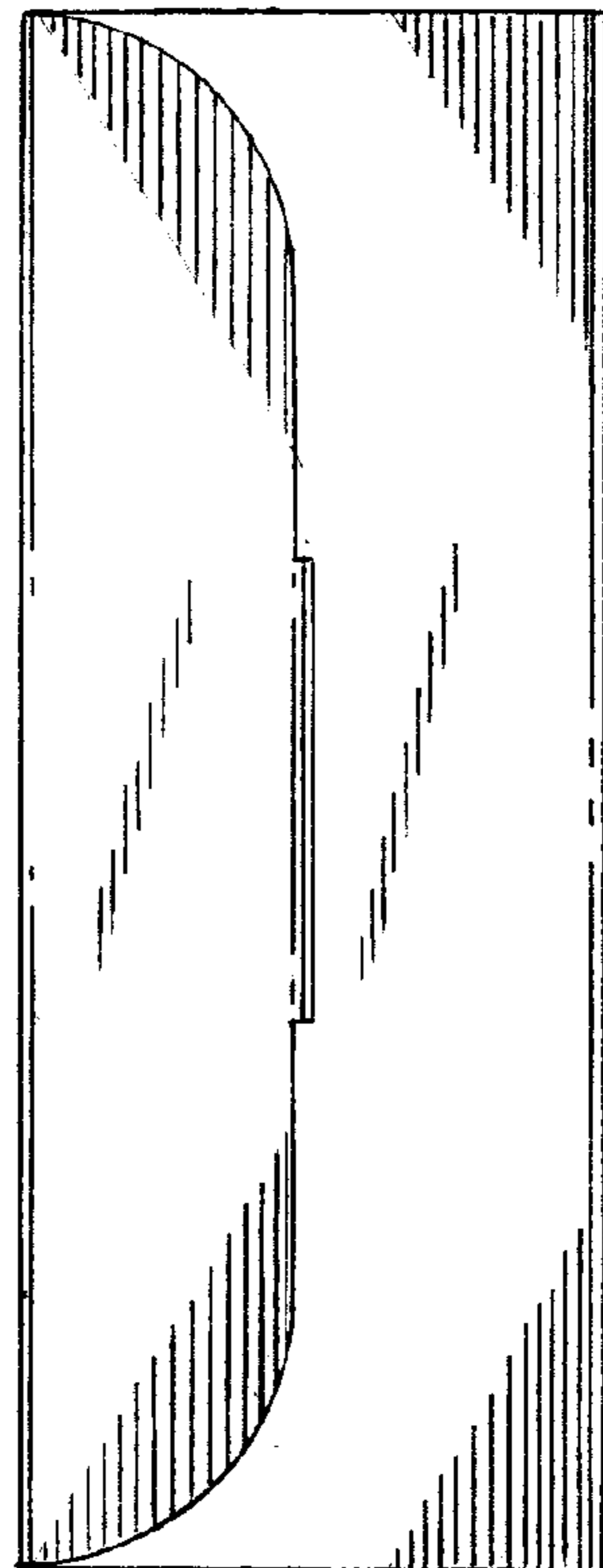

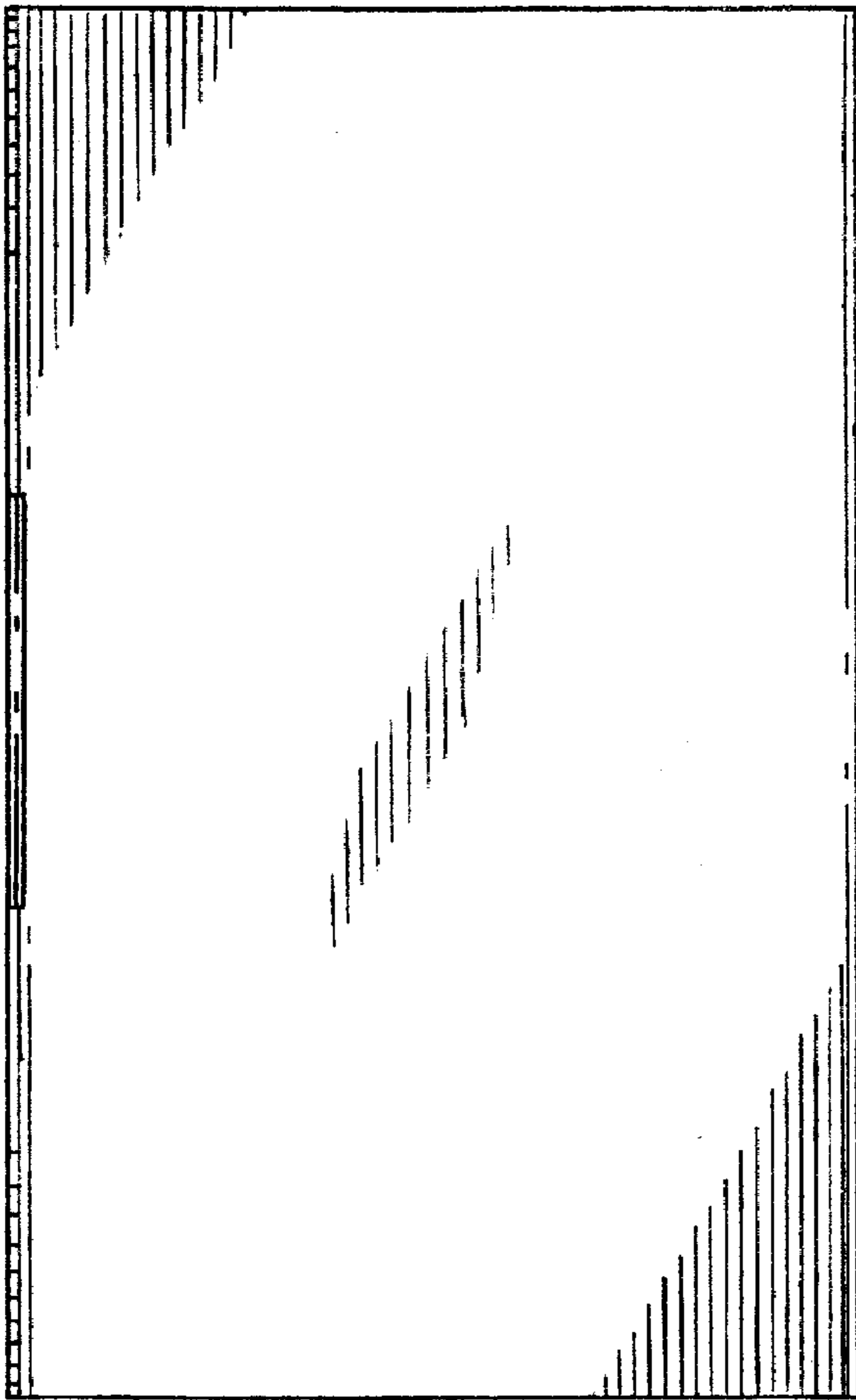
