FIG. 2 is a side elevational view thereof;

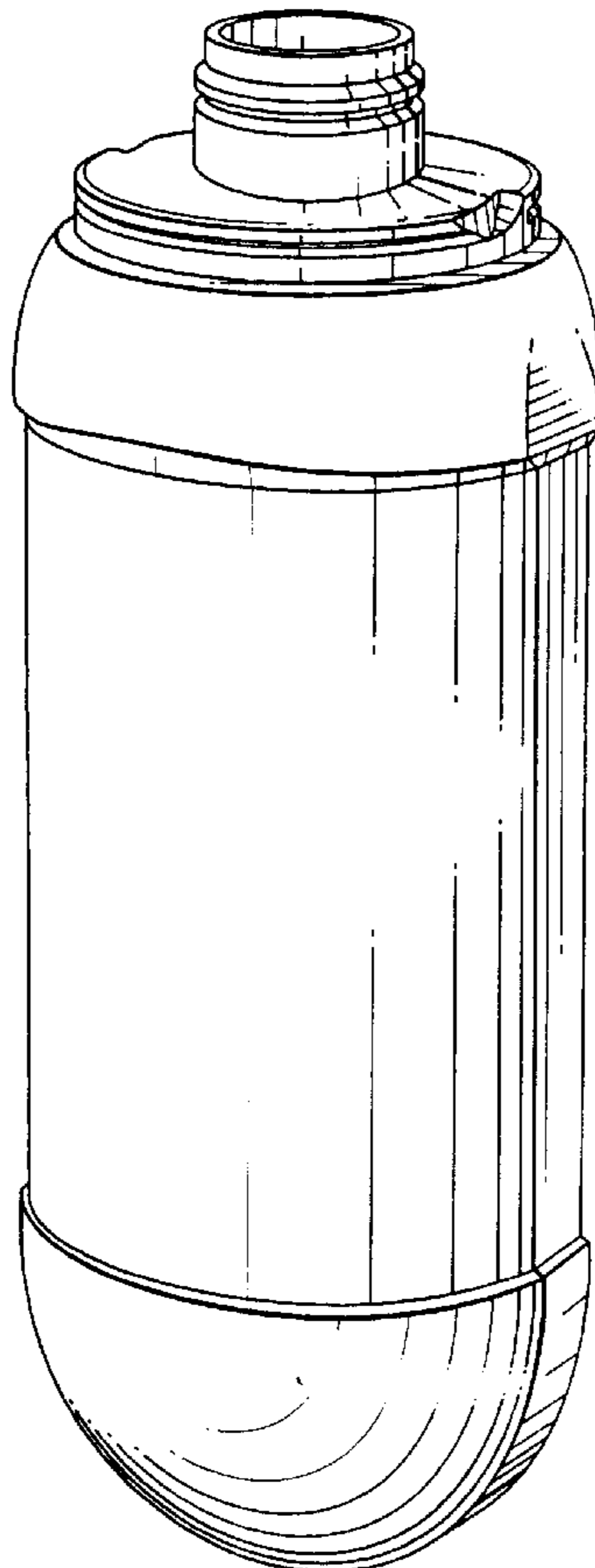
FIG. 3 is an end elevational view thereof as seen from the right hand side of FIG. 2;

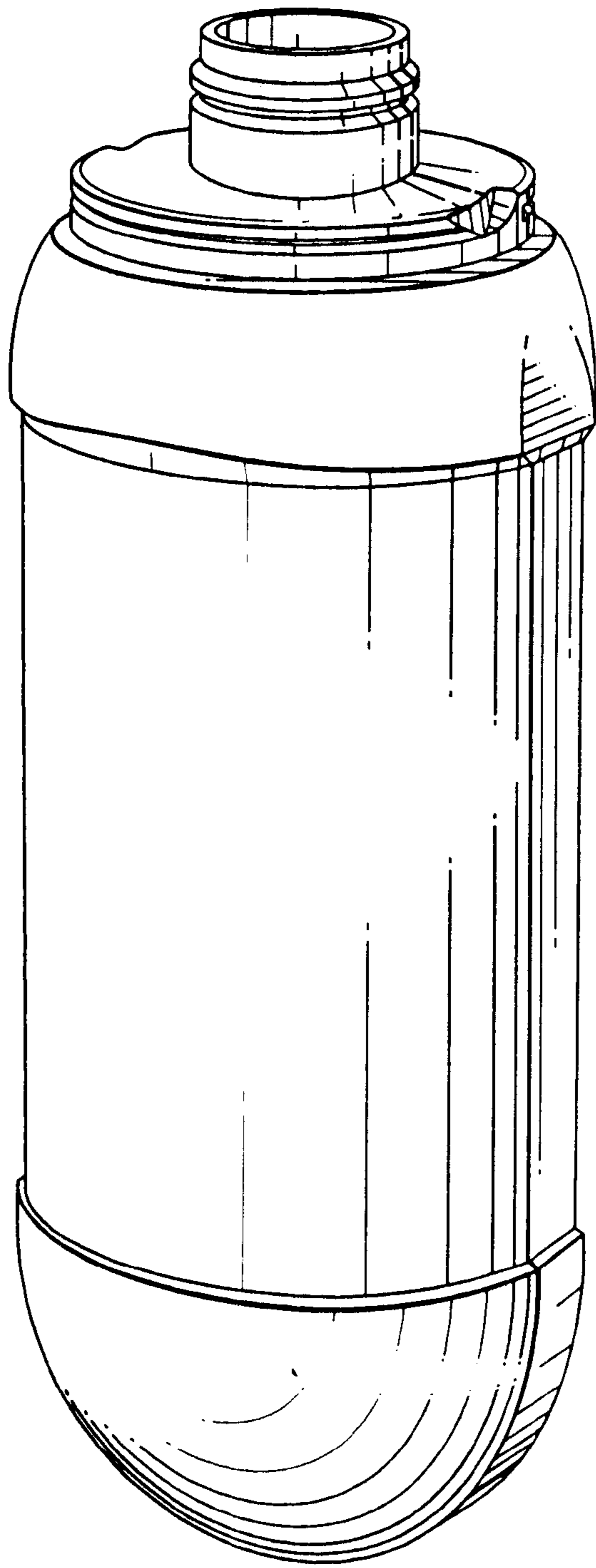

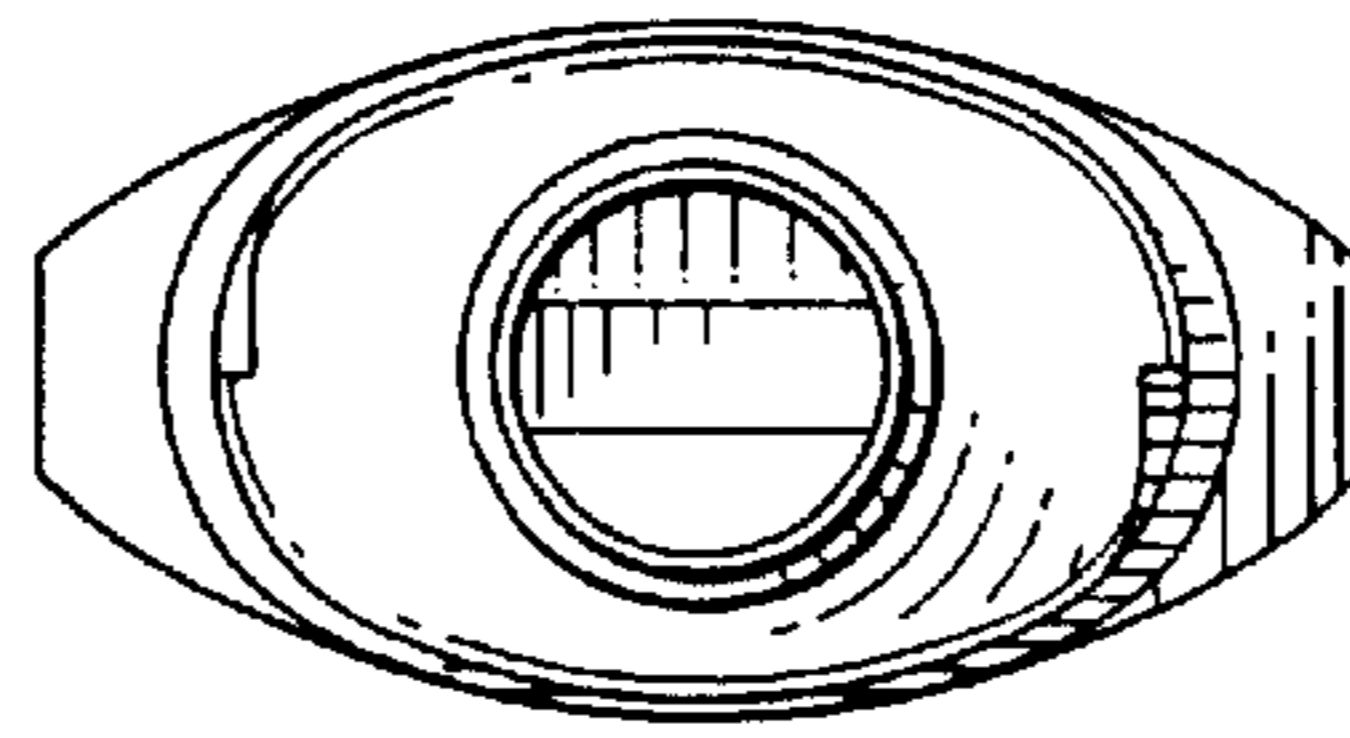

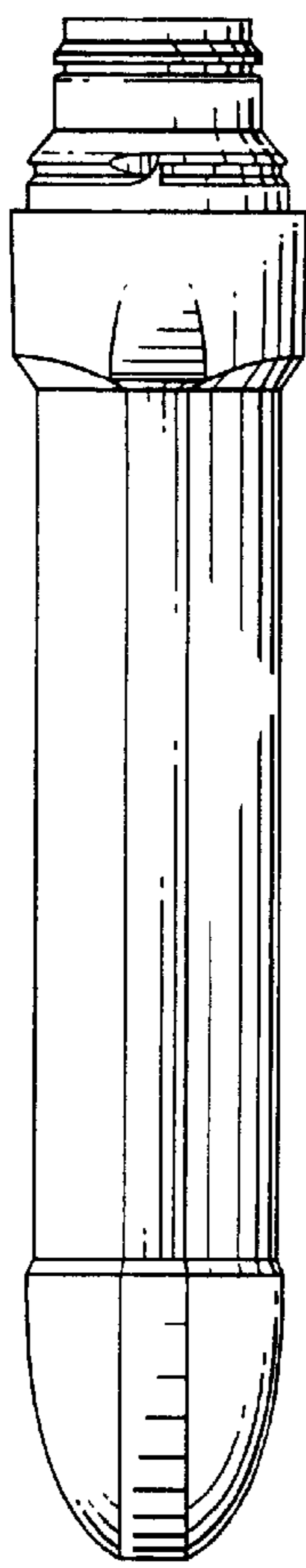

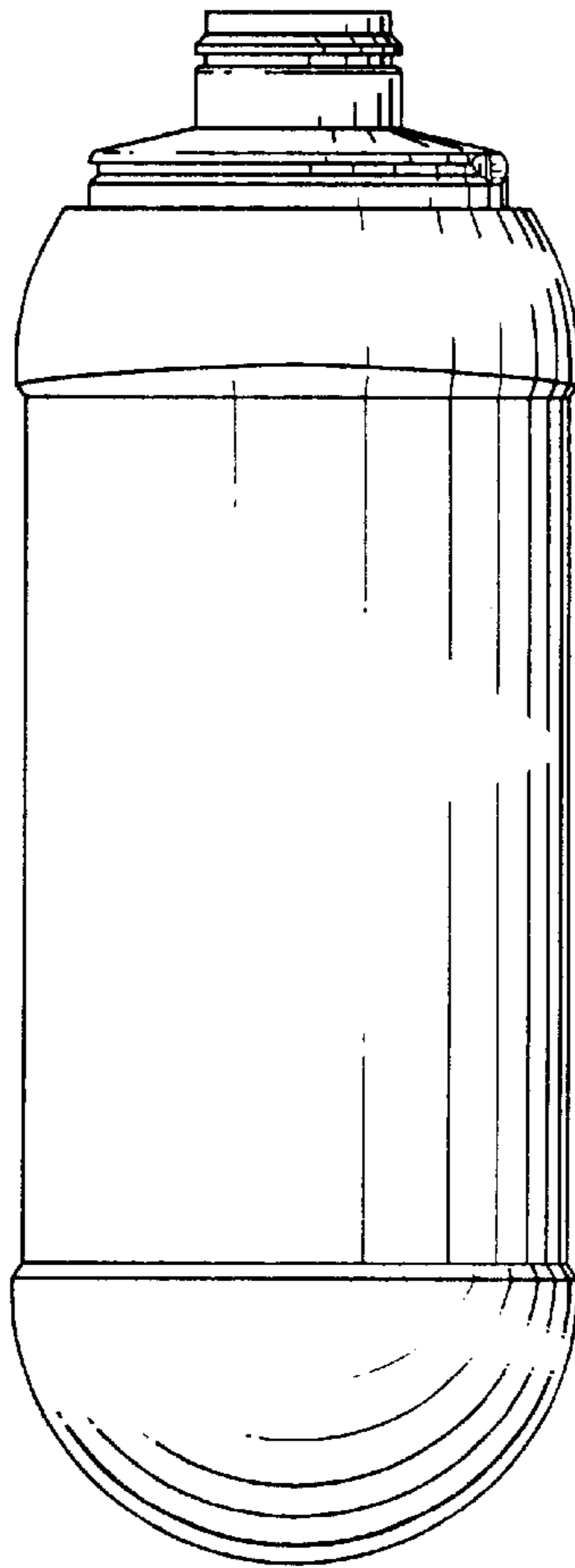

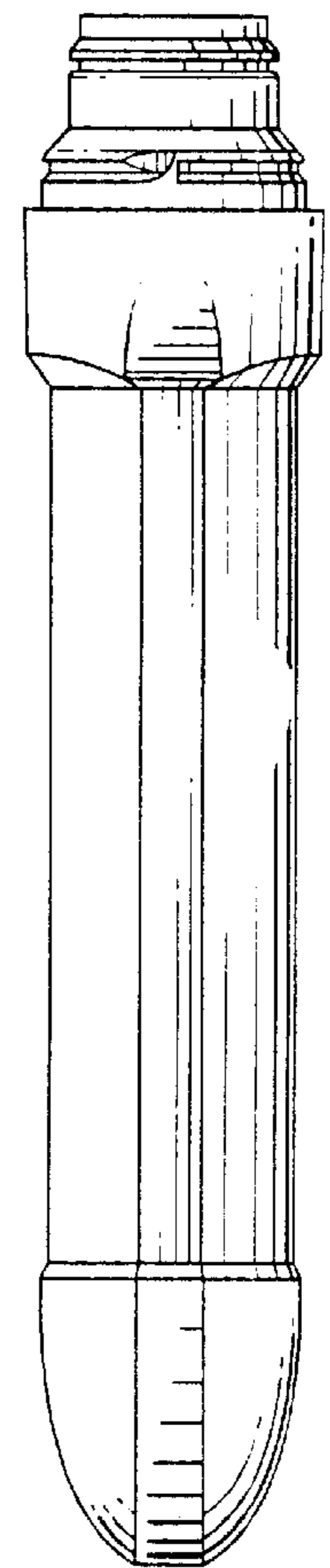

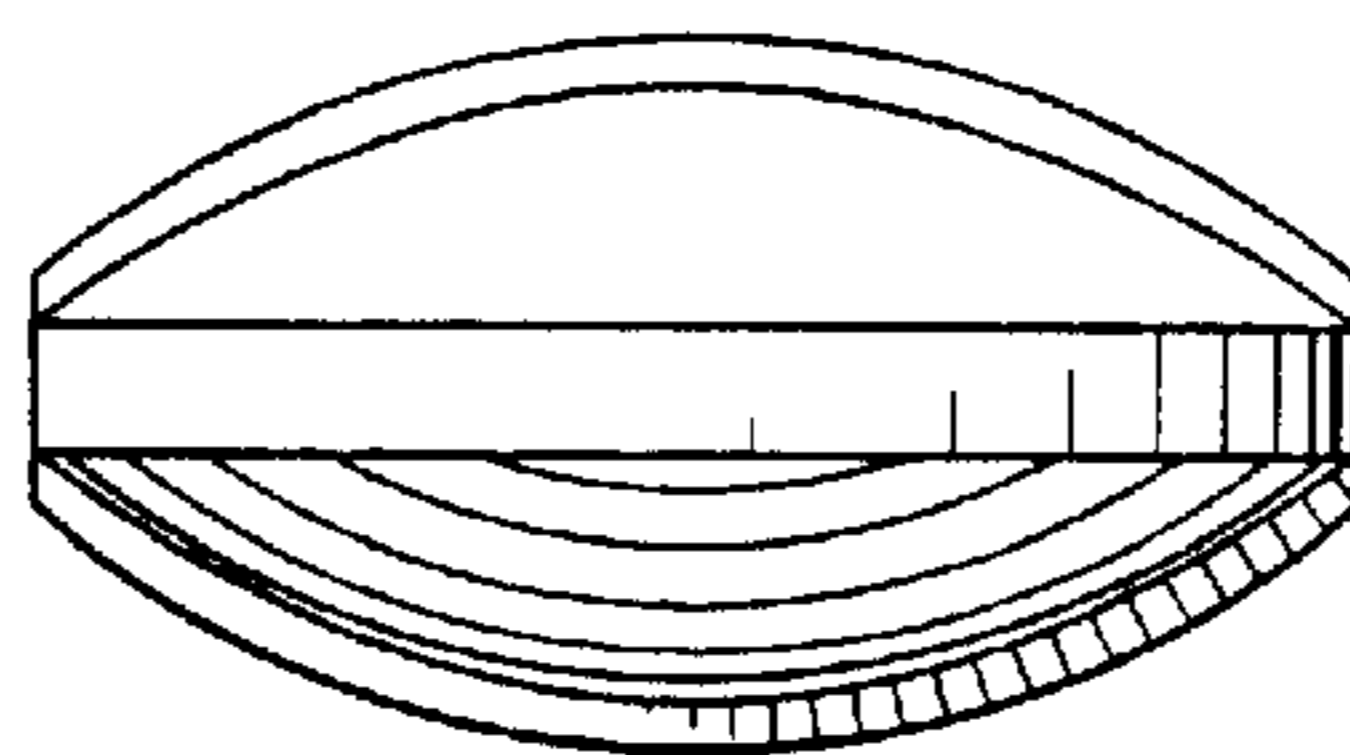
