(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a left side perspective view of a first embodiment of a bottle showing my new design;

FIG. 2 is a top plan view of FIG. 1, shown at an enlarged scale;

FIG. 3 is a right side perspective view of FIG. 1, shown at the same scale as FIG. 1;

FIG. 4 is a left side elevational view of FIG. 1;

FIG. 5 is a front elevational view of FIG. 1;

FIG. 6 is a right side elevational view of FIG. 1;

FIG. 7 is a left side perspective view of a second embodiment of the bottle of FIG. 1;

FIG. 8 is a top plan view of FIG. 7, shown at an enlarged scale;

FIG. 9 is a right side perspective view of FIG. 7, shown at the same scale as FIG. 7;

FIG. 10 is a left side elevational view of FIG. 7;

FIG. 11 is a front elevational view of FIG. 7;

FIG. 12 is a right side elevational view of FIG. 7;

FIG. 13 is a left side perspective view of a third embodiment of the bottle of FIG. 1;

FIG. 14 is a top plan view of FIG. 13, shown at an enlarged scale;

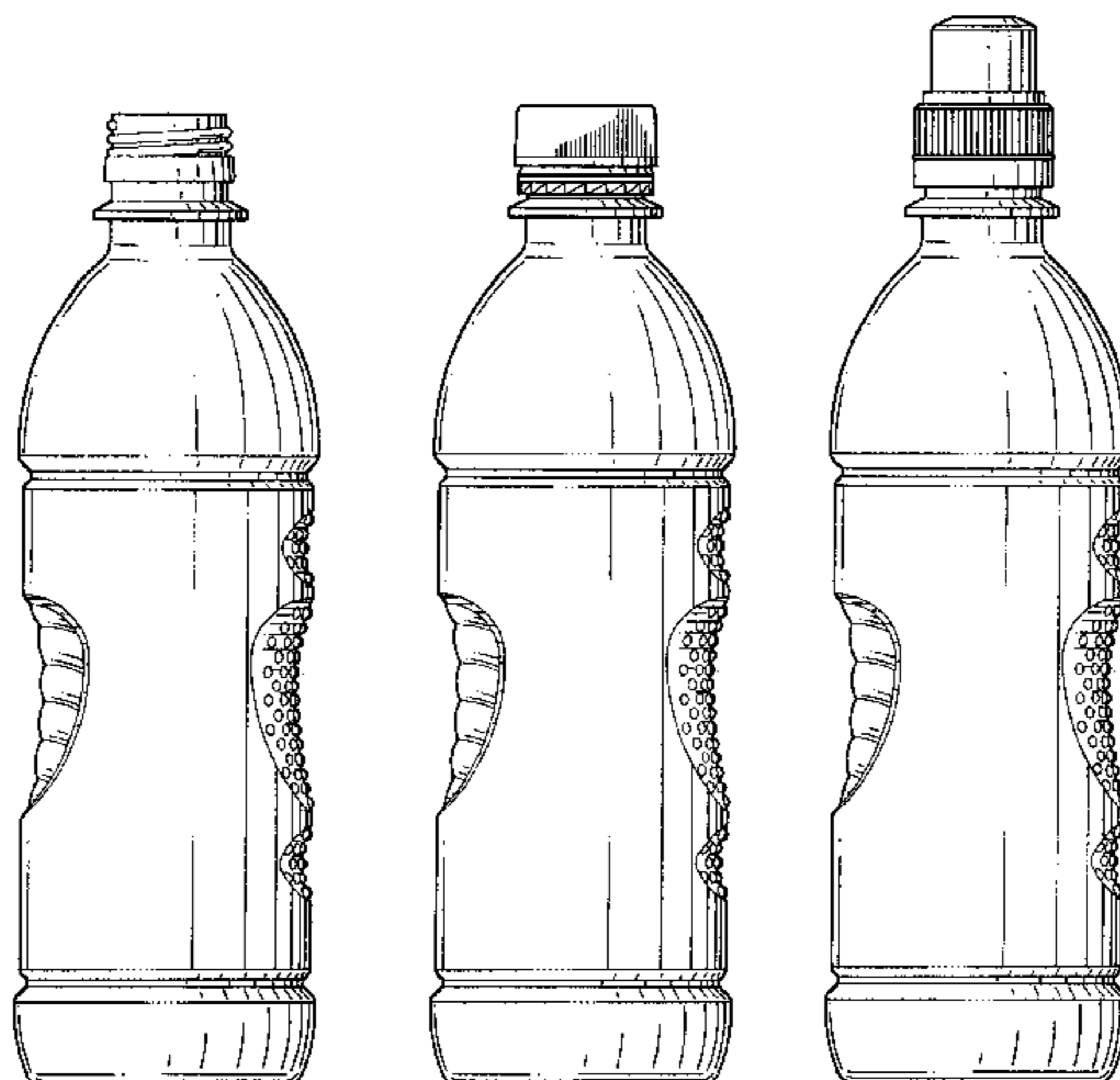
FIG. 15 is a right side perspective view of FIG. 13, shown at the same scale as FIG. 13;

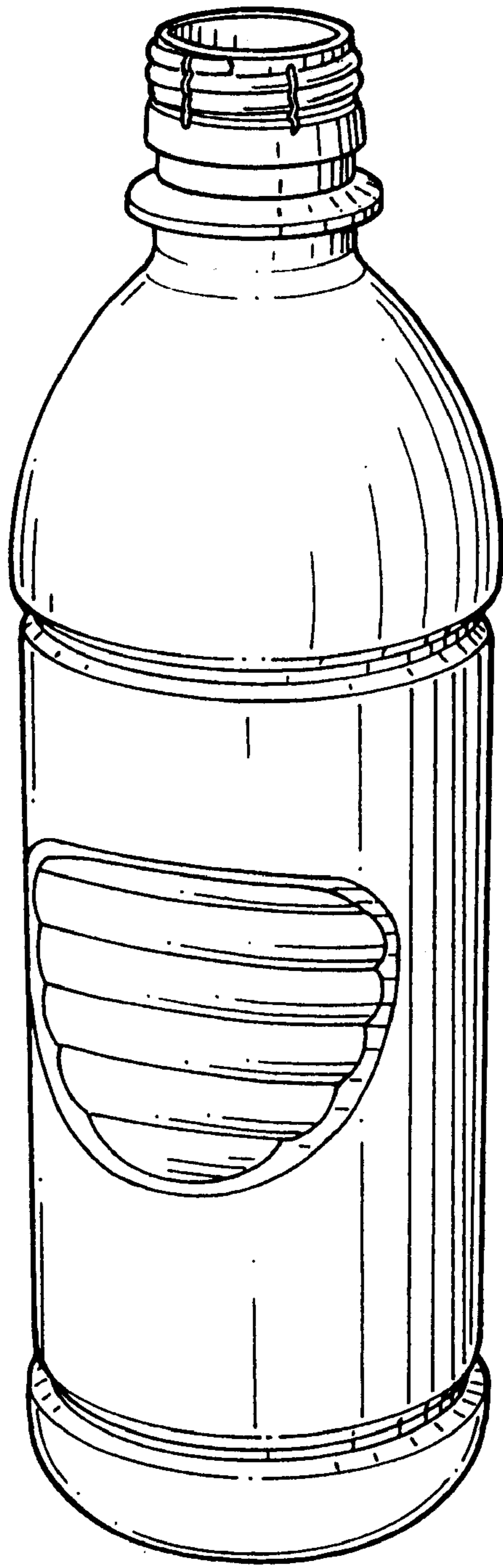
FIG. 16 is a left side elevational view of FIG. 13;

FIG. 17 is a front elevational view of FIG. 13; and,

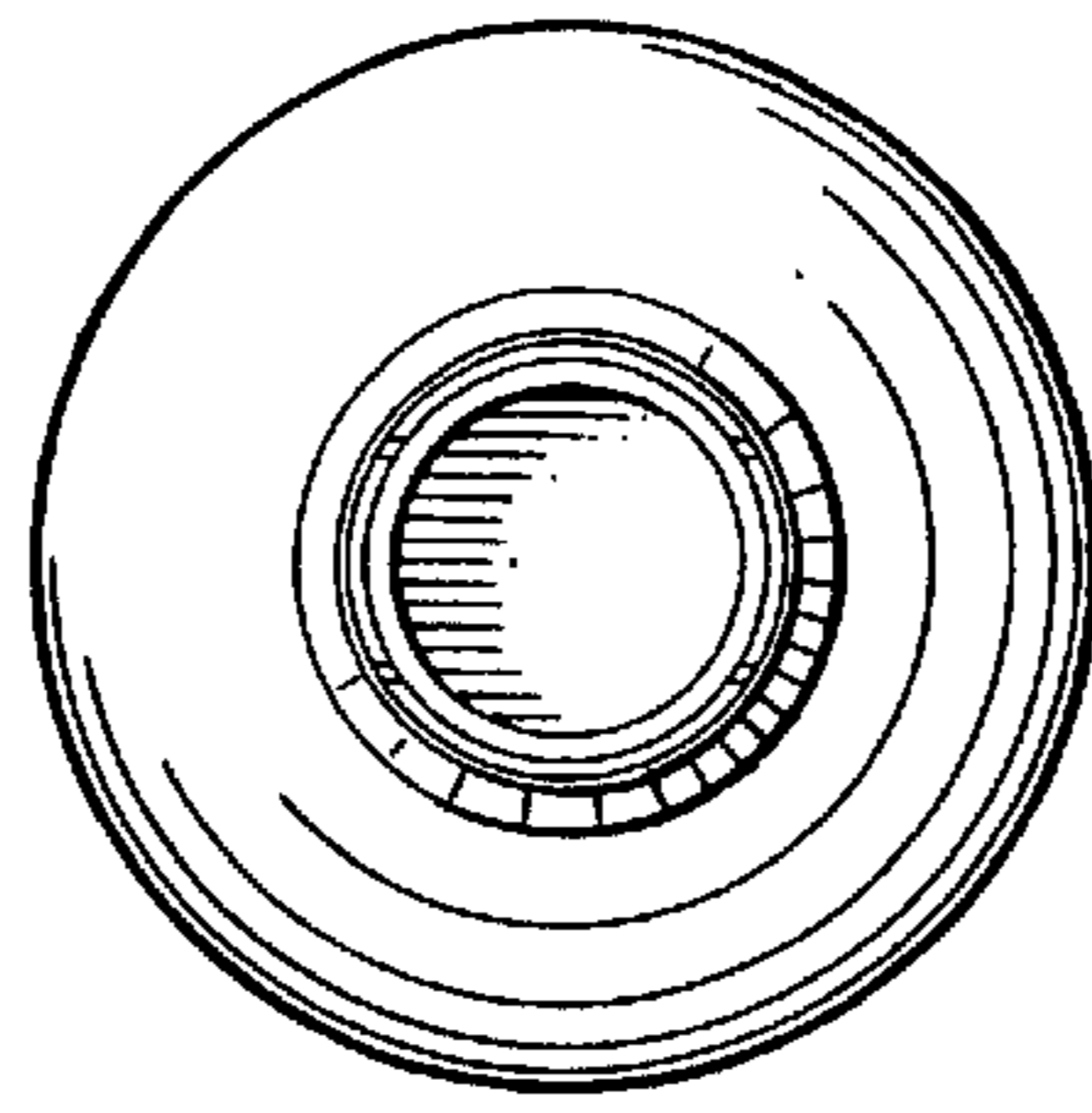
FIG. 18 is a right side elevational view of FIG. 13.

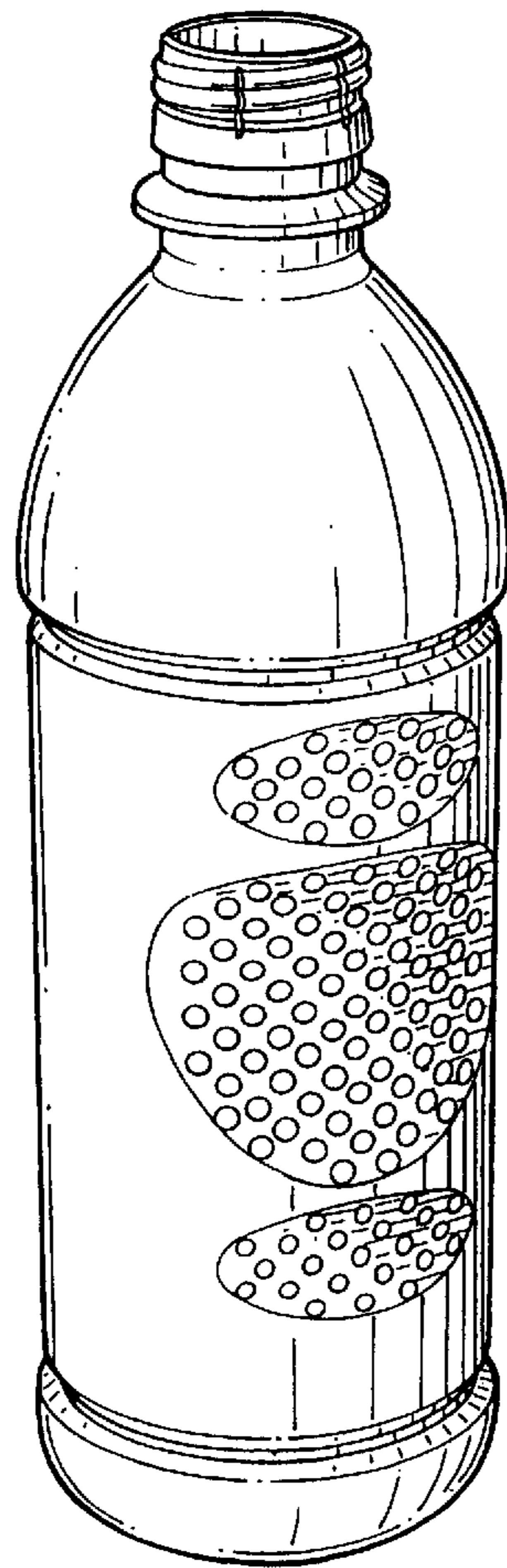




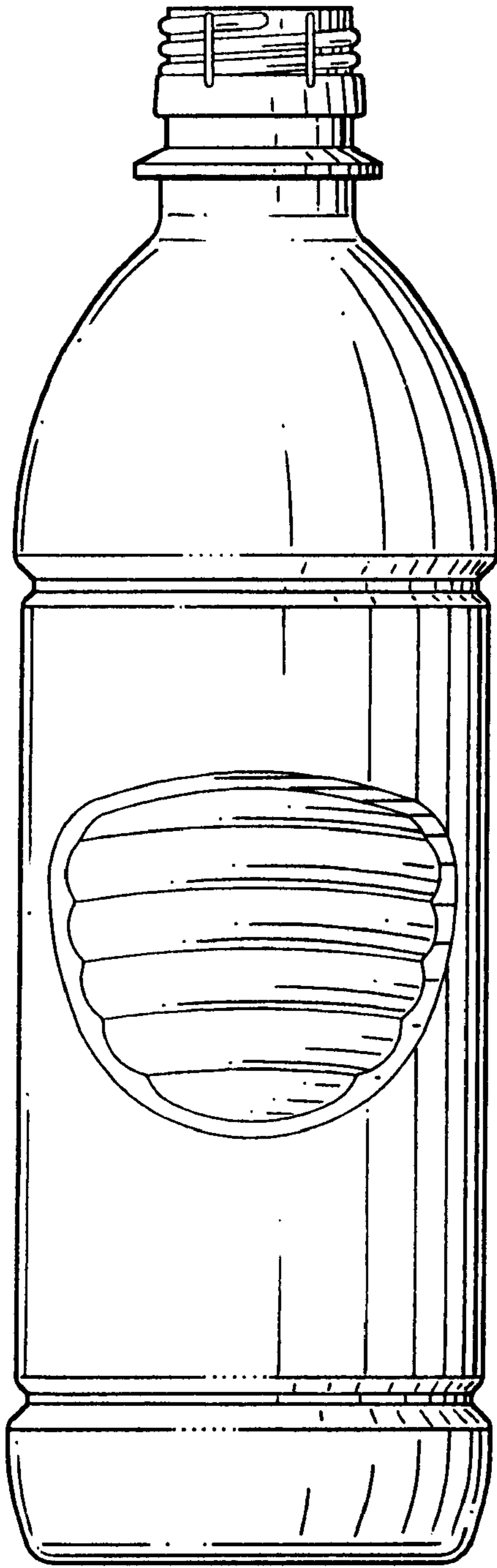

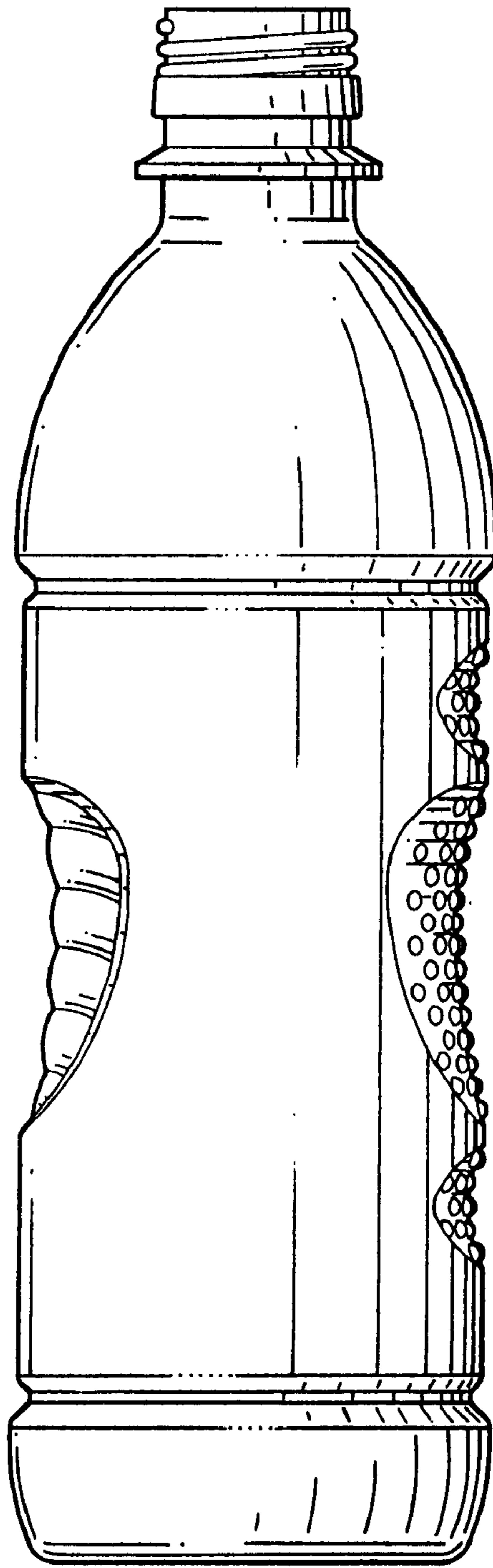

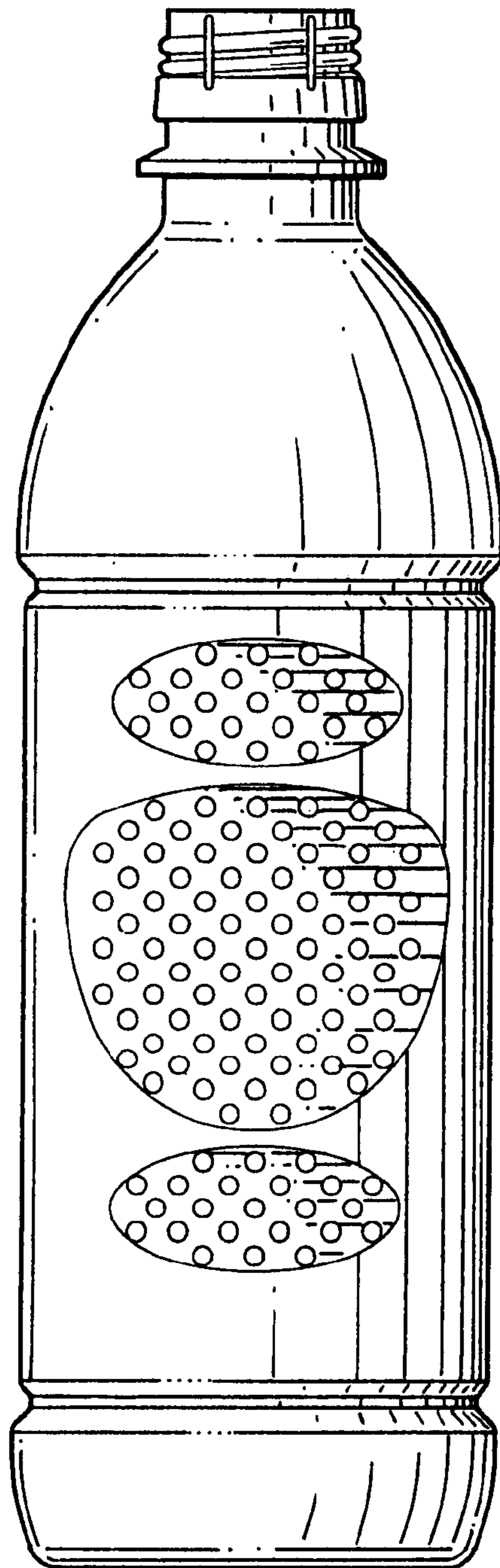

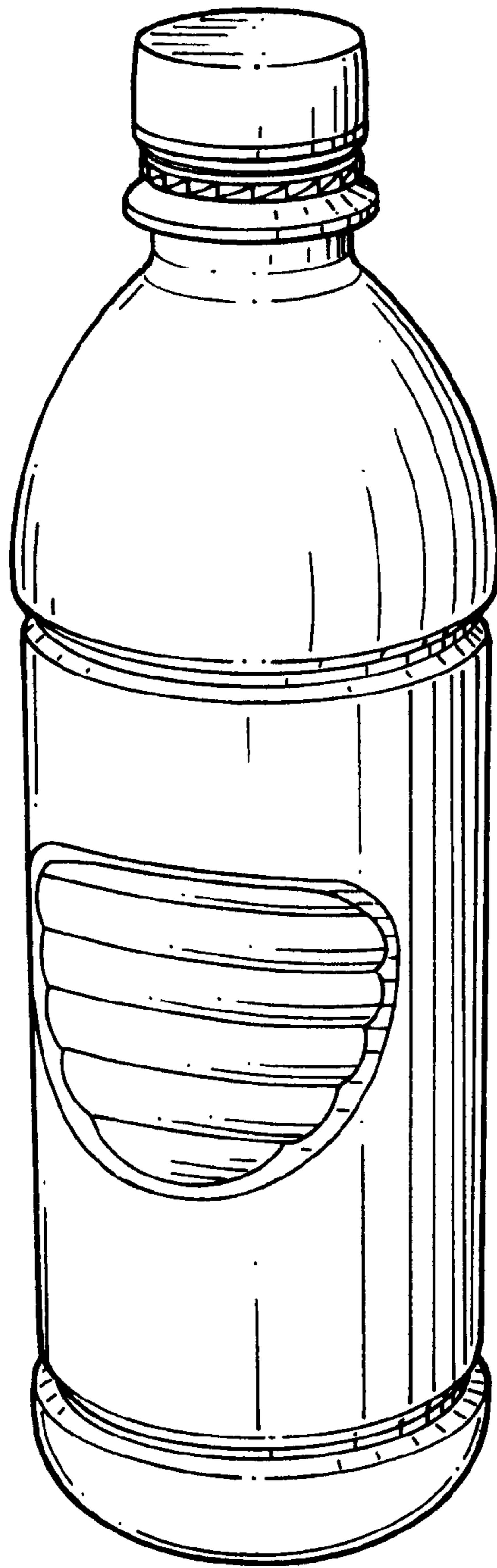

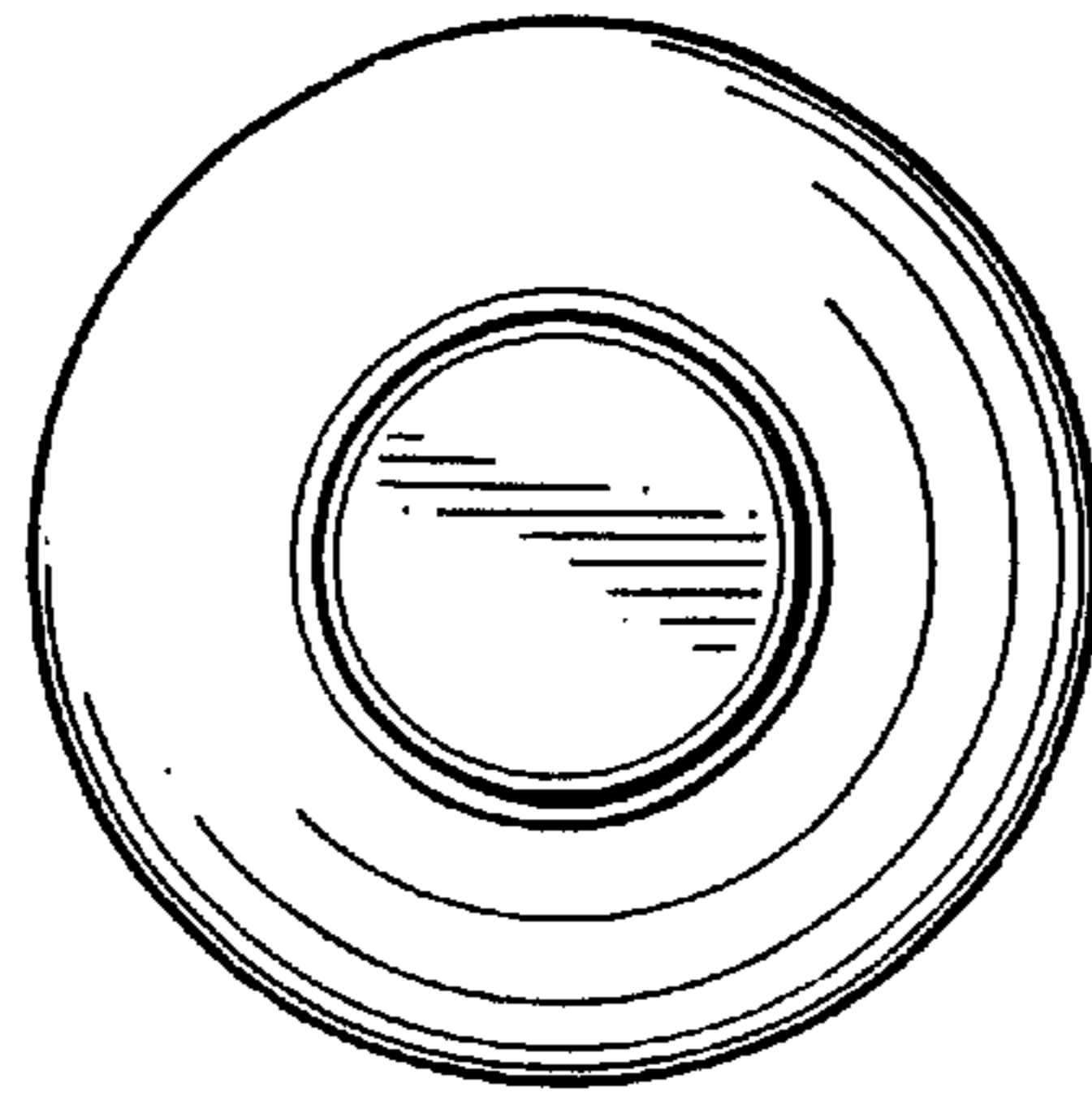

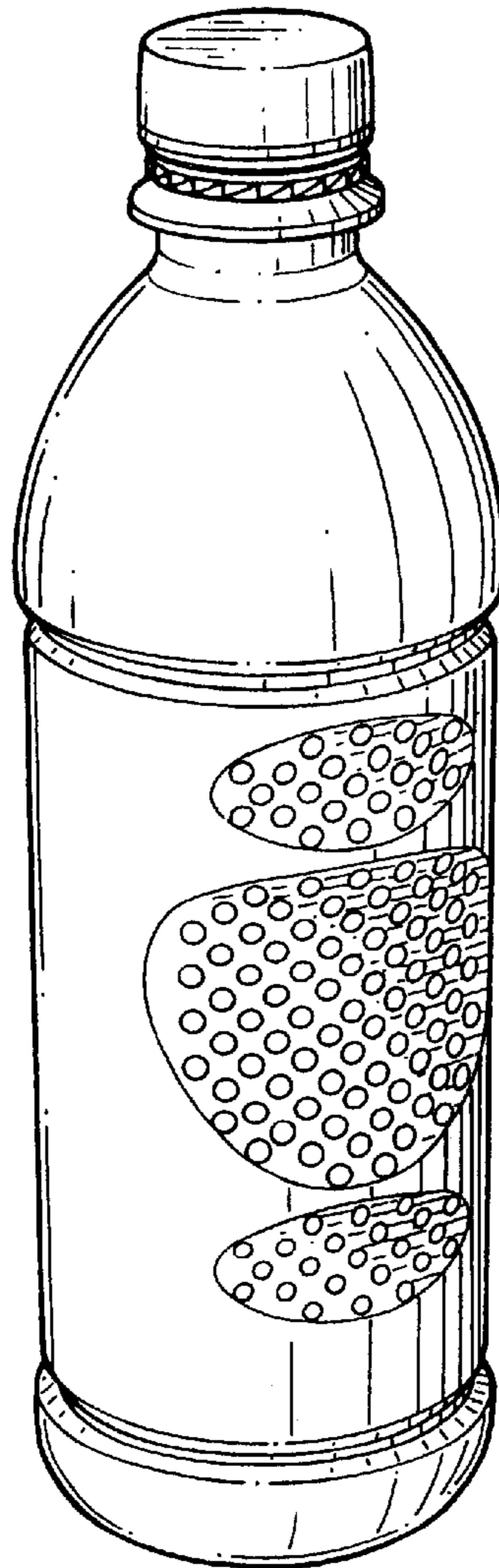

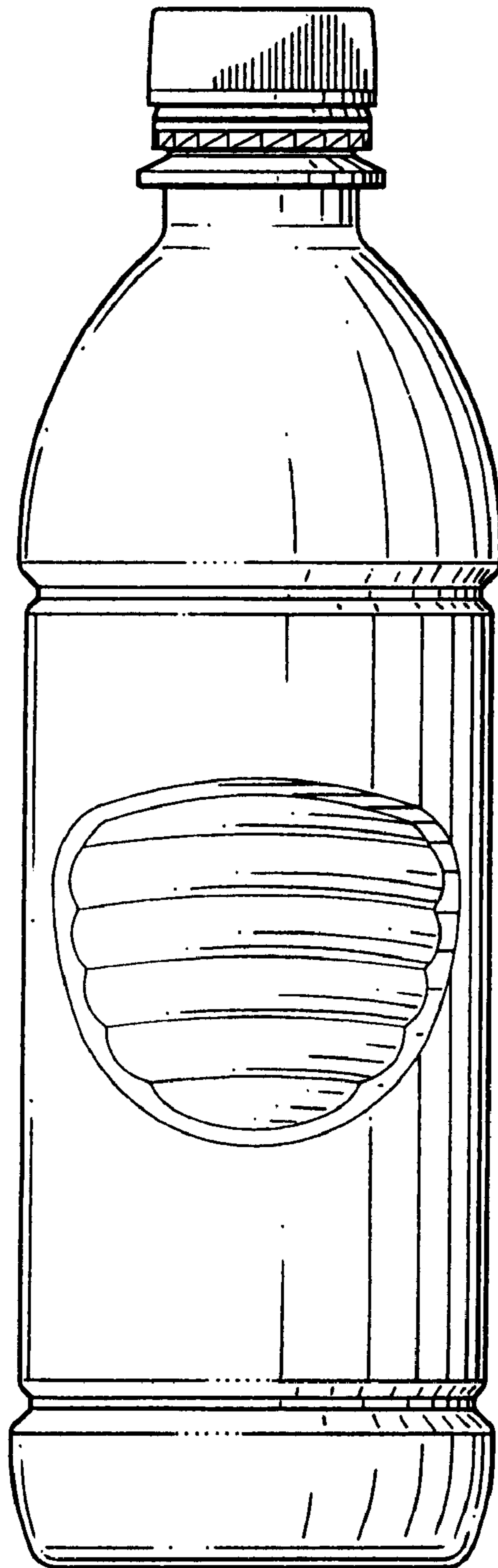

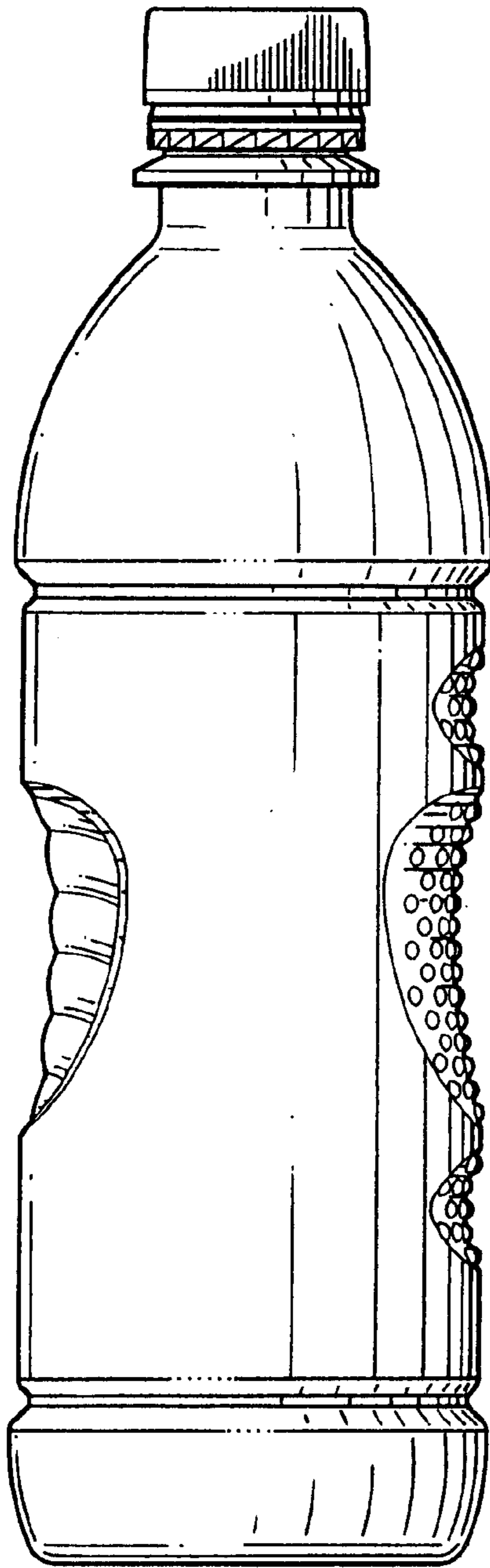

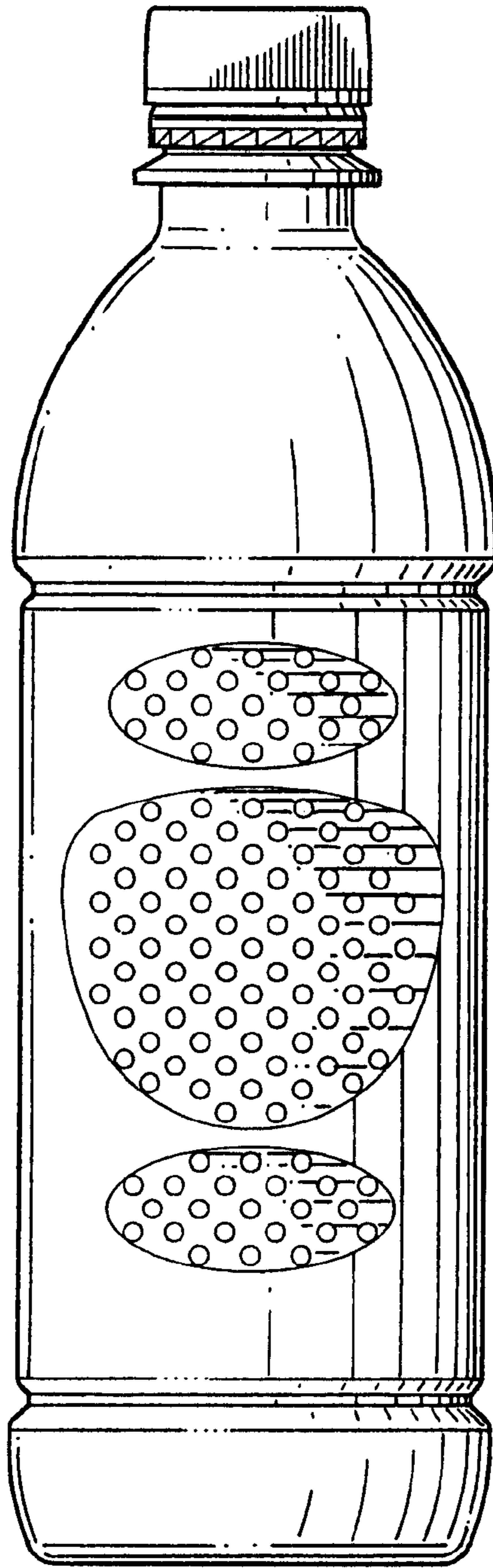




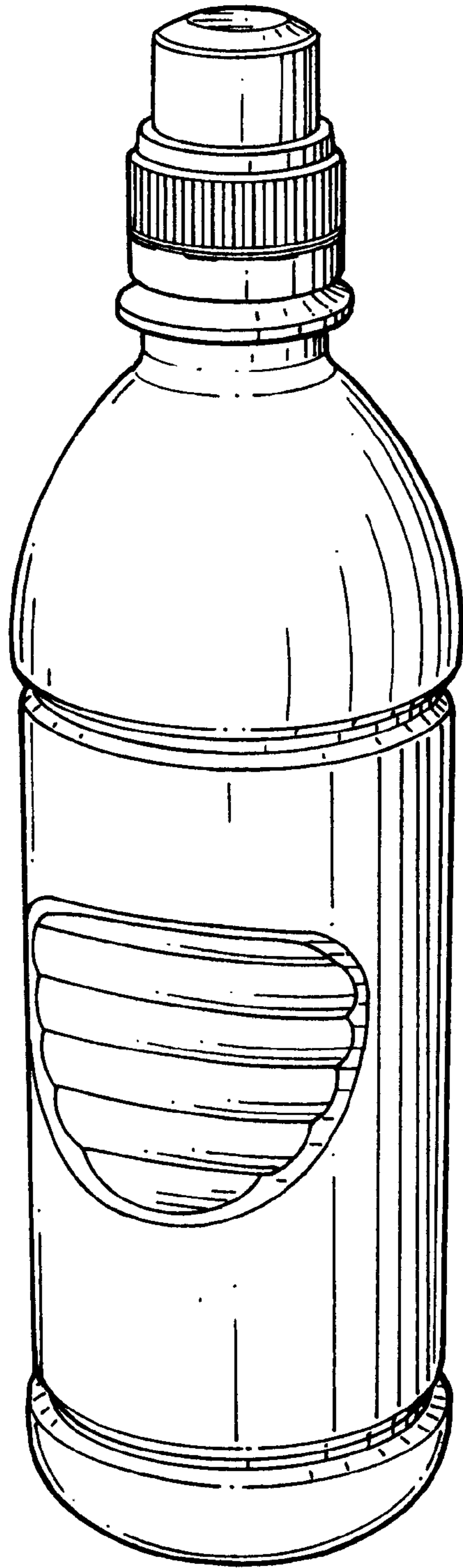

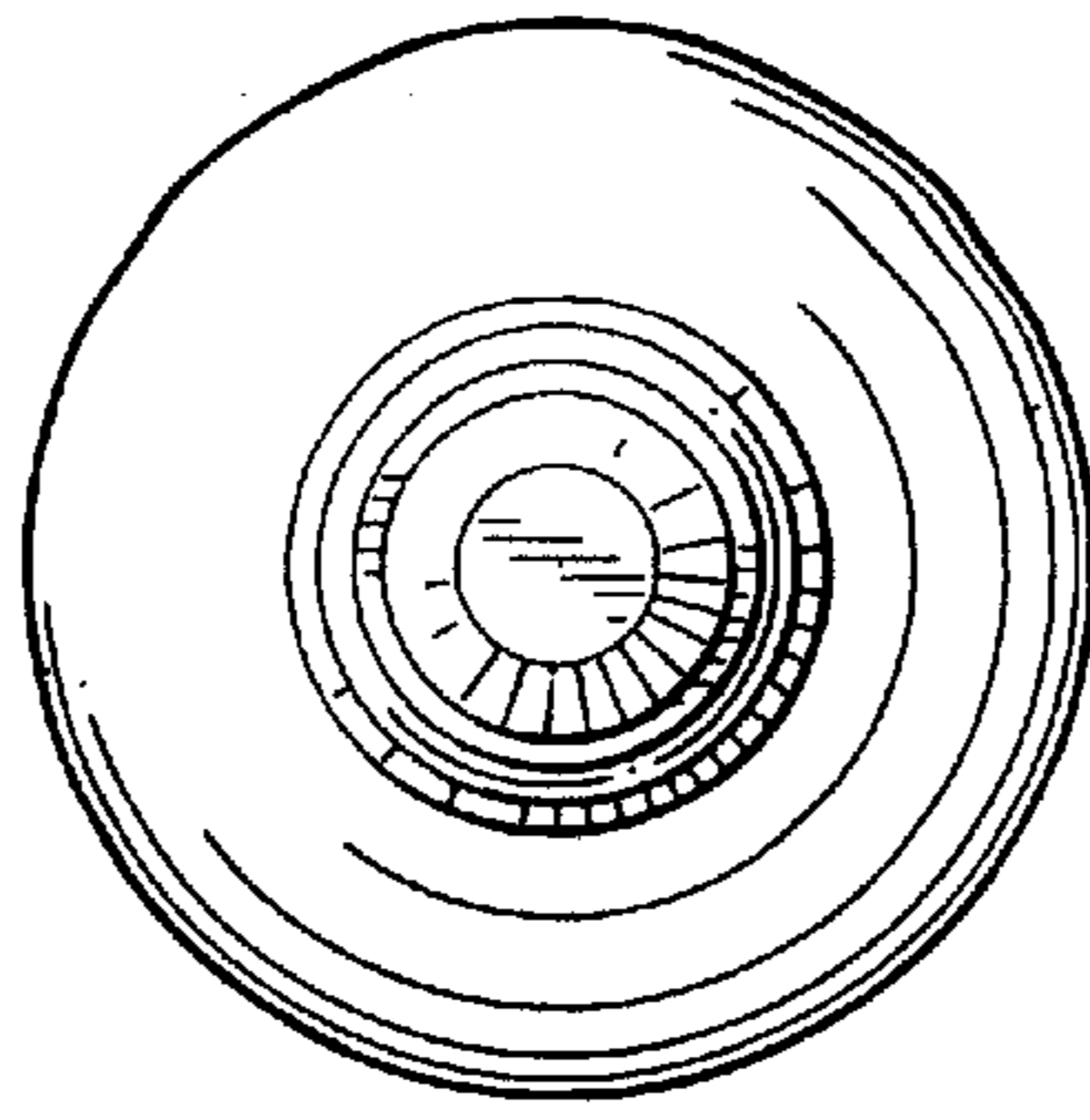

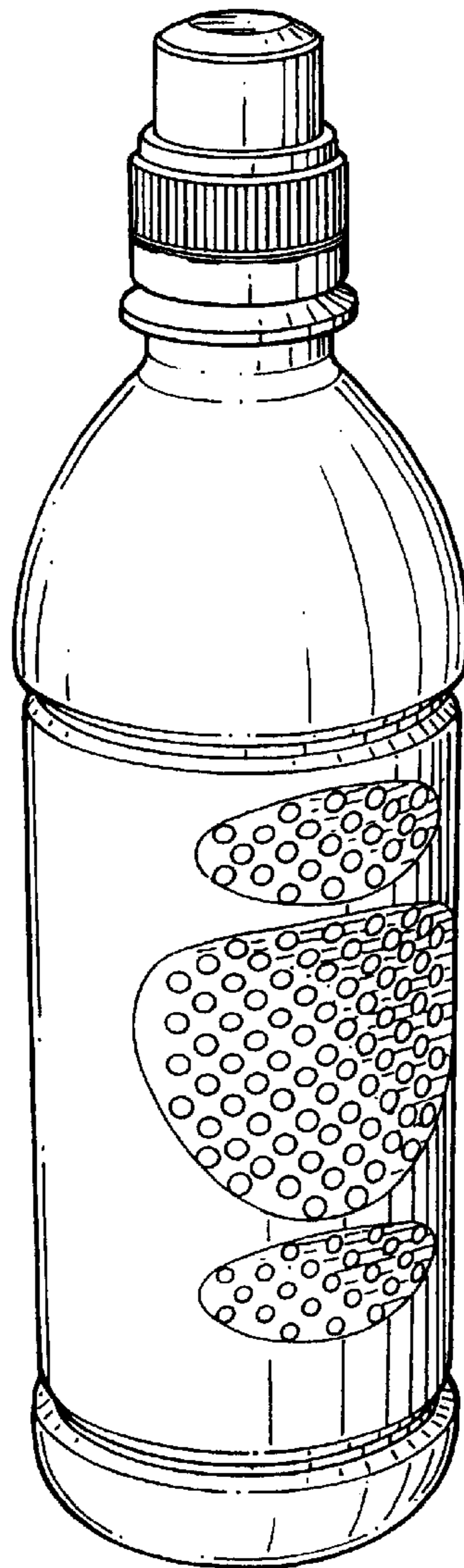

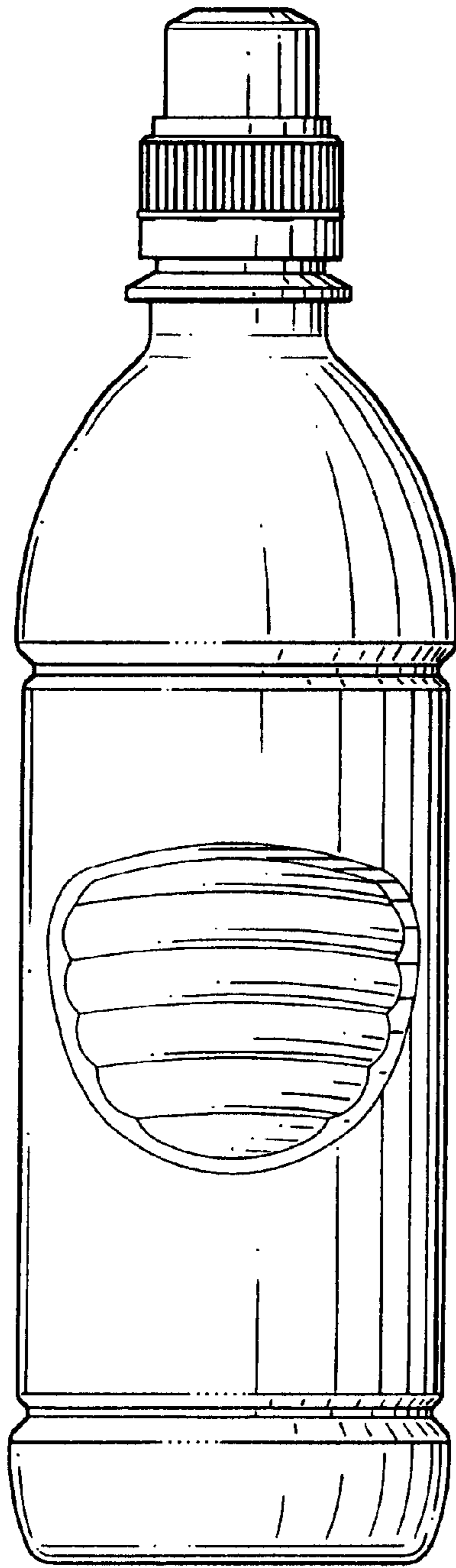

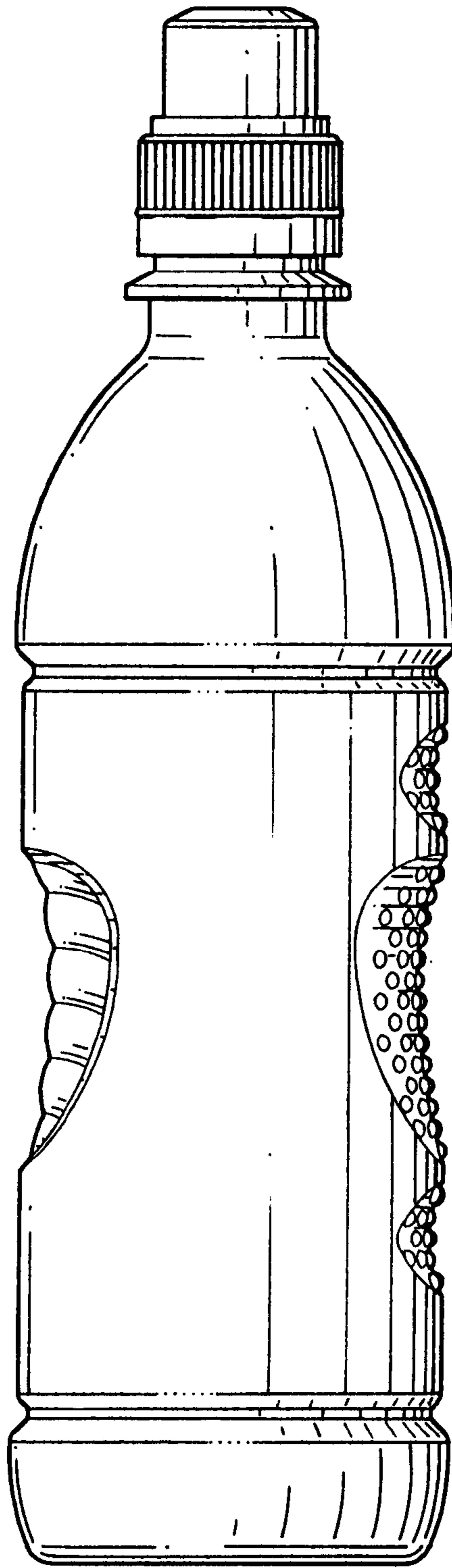

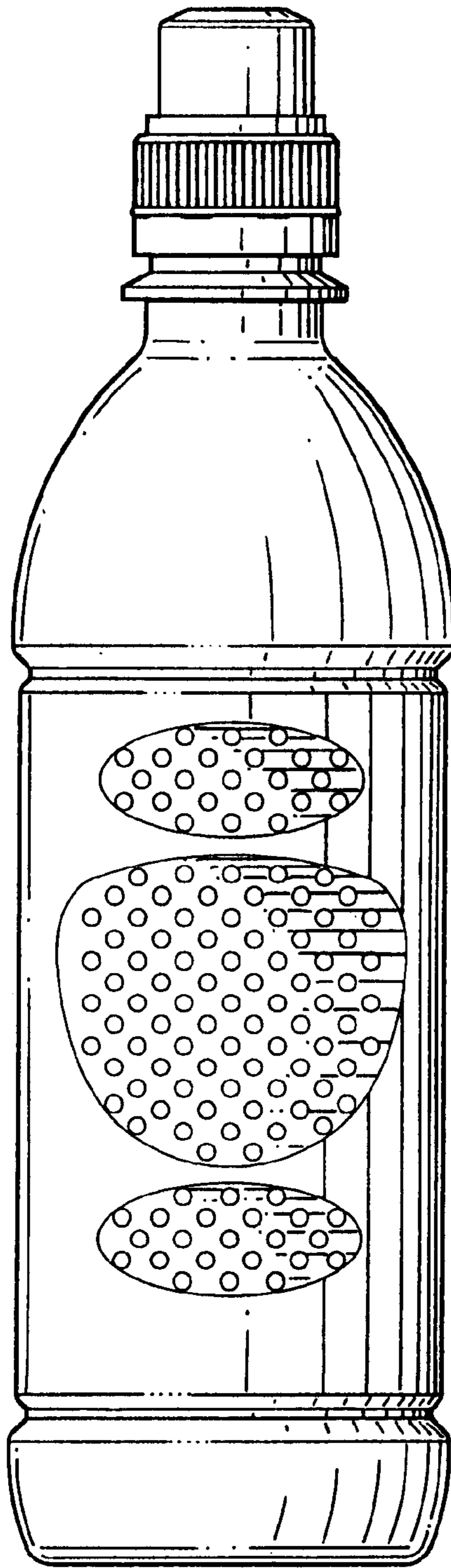
