I claim the ornamental design for a watch case, as shown and described.

**DESCRIPTION**

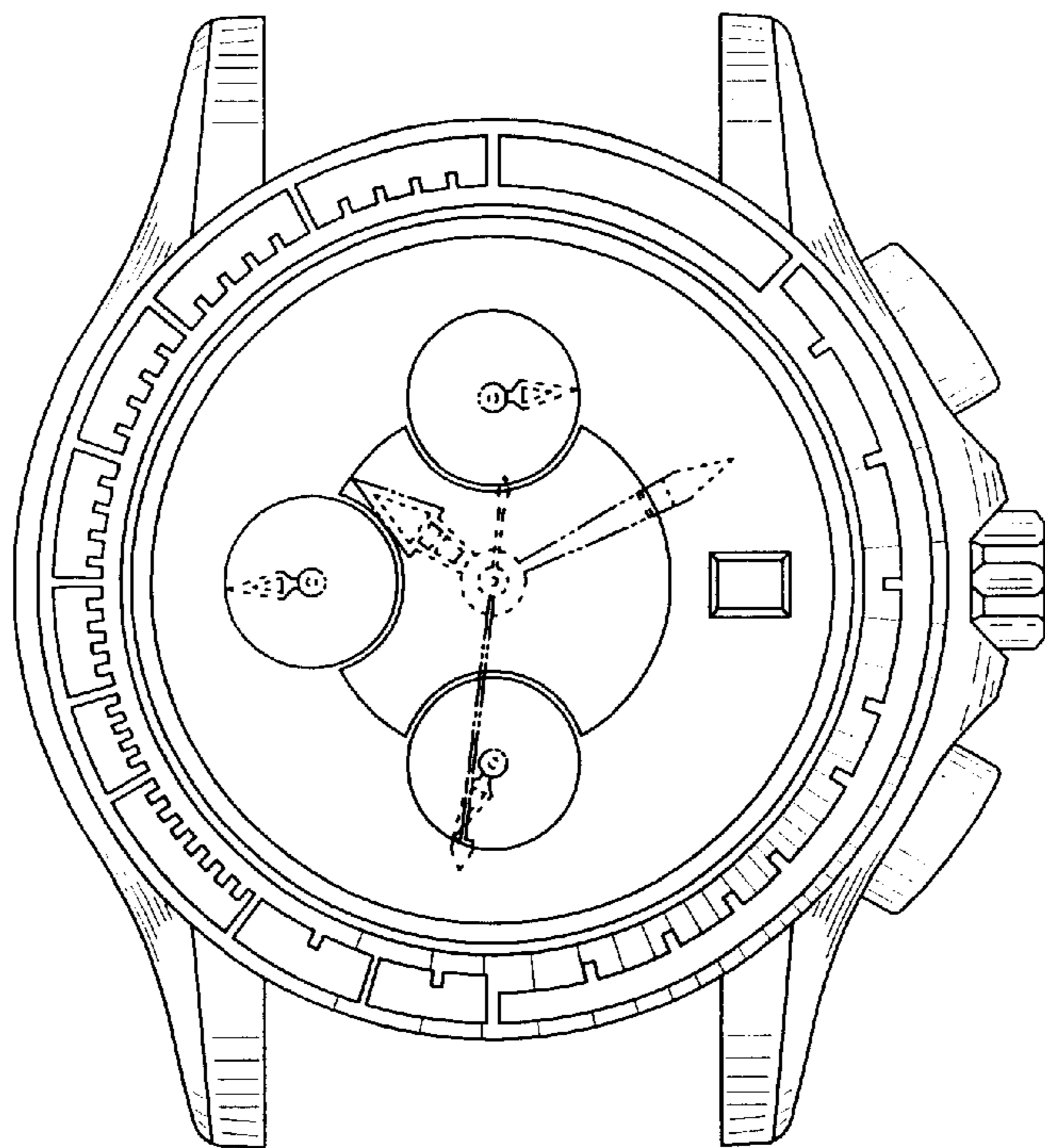
FIG. 1 is a top perspective view of a watch case showing my new design;

FIG. 2 is a top plan view of the watch case of the invention; FIG. 3 is a bottom plan view of the watch case of the invention;

FIG. 4 is a right plan view of the watch case of the invention; FIG. 5 is a left plan view of the watch case of the invention; FIG. 6 is a front plan view of the watch case of the invention; and,

FIG. 7 is a back plan view of the watch case of the invention. The broken line showing of FIGS. 1-5 of the watch case is for illustrative purpose only and forms no part of the claimed design.

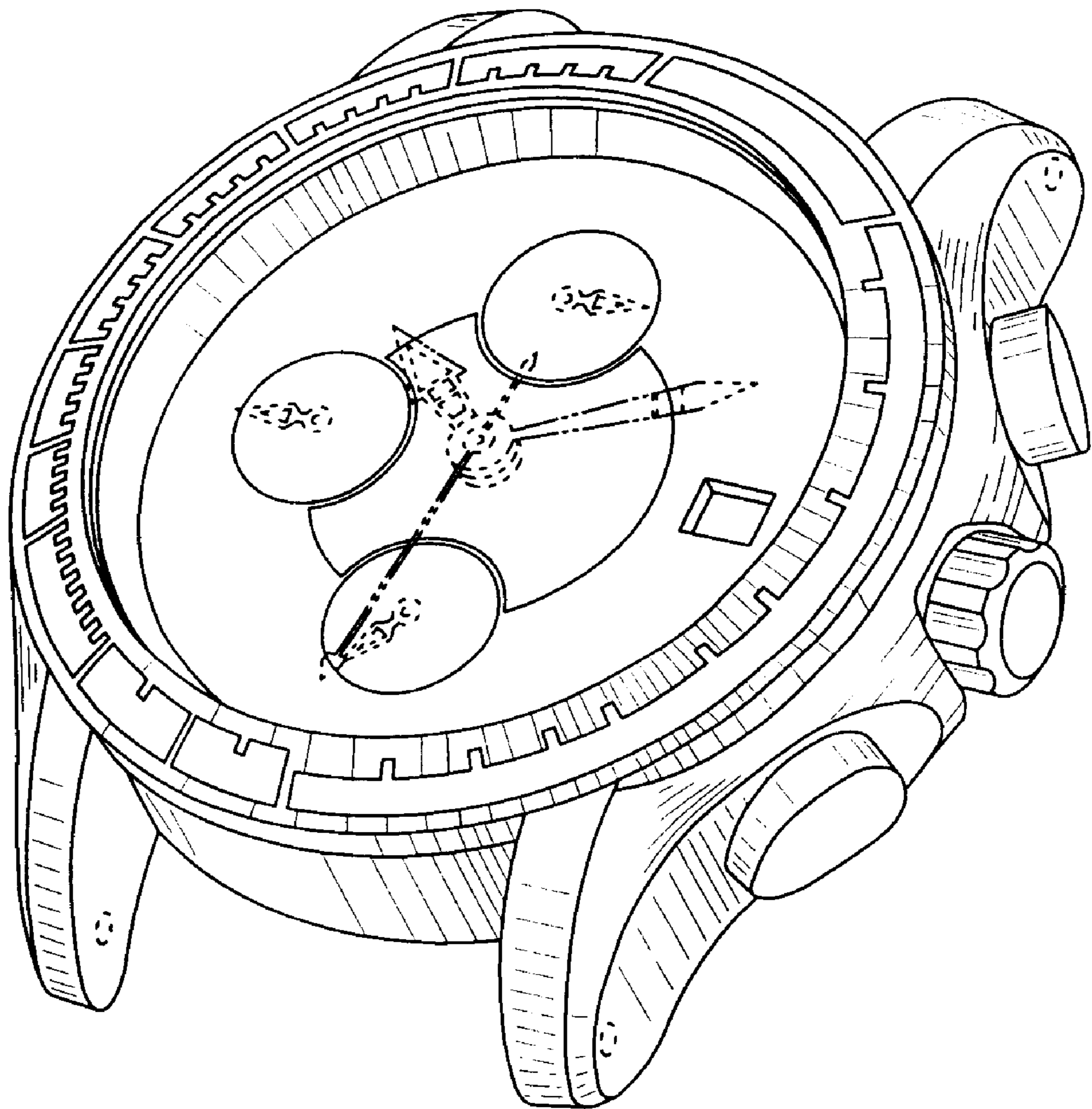

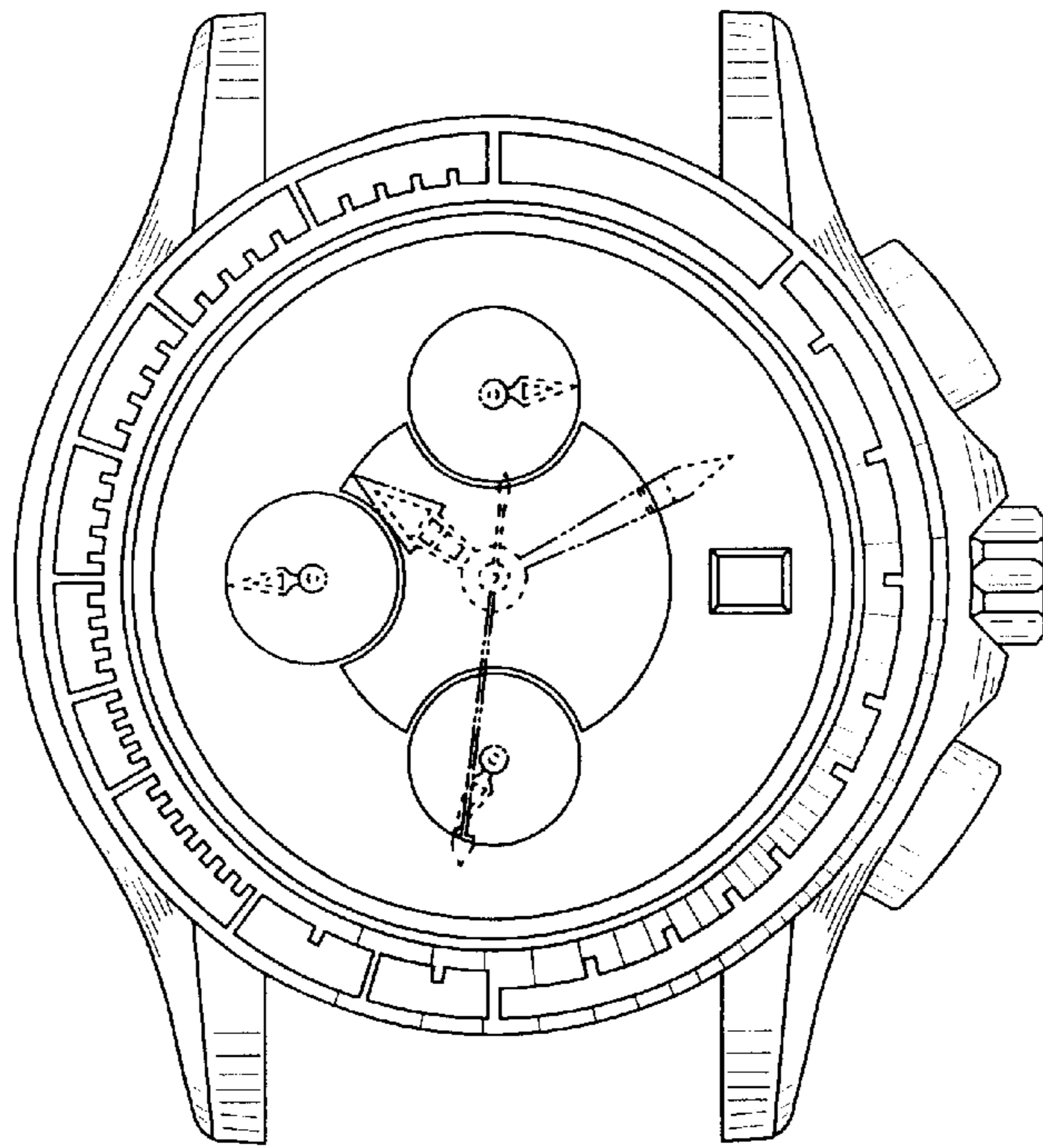
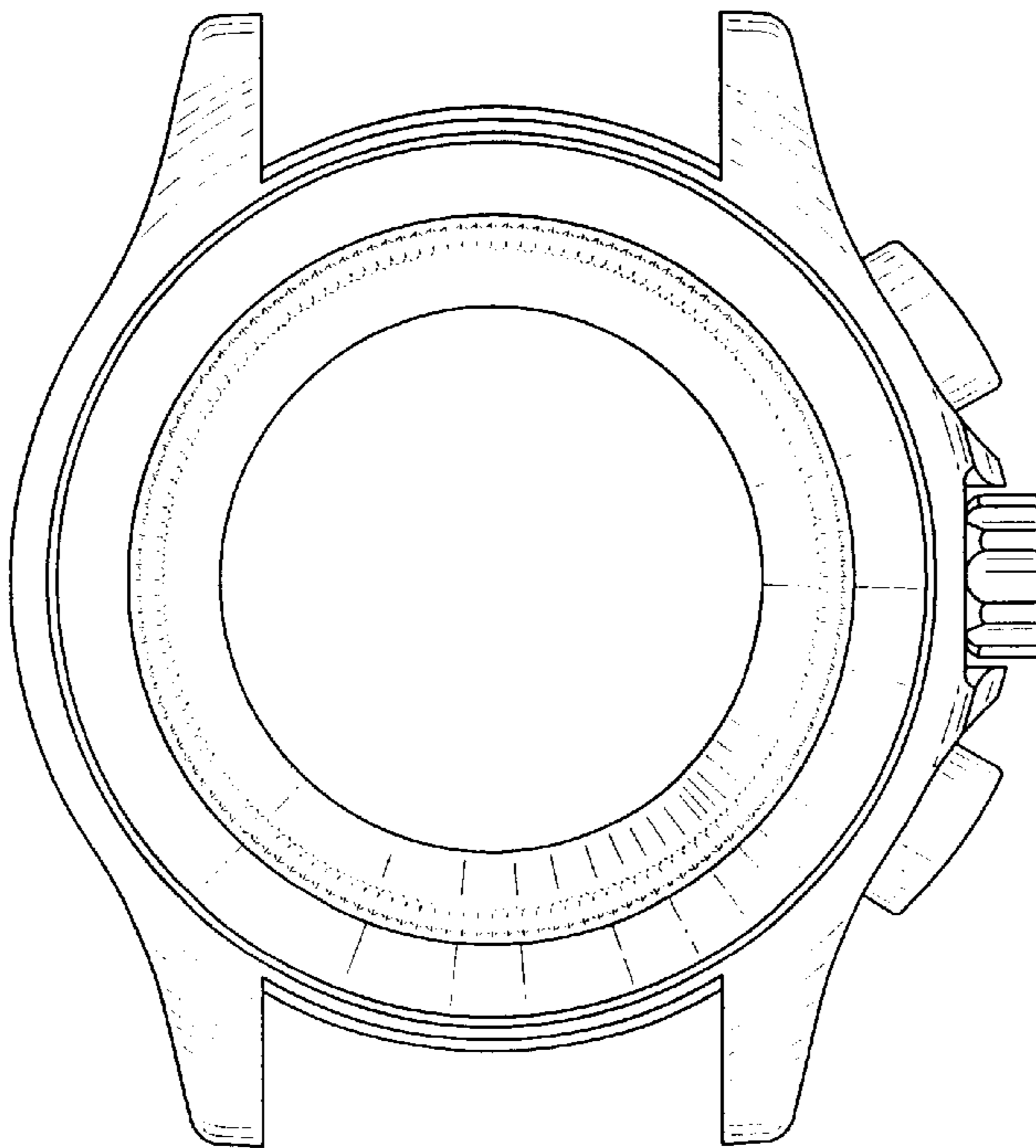
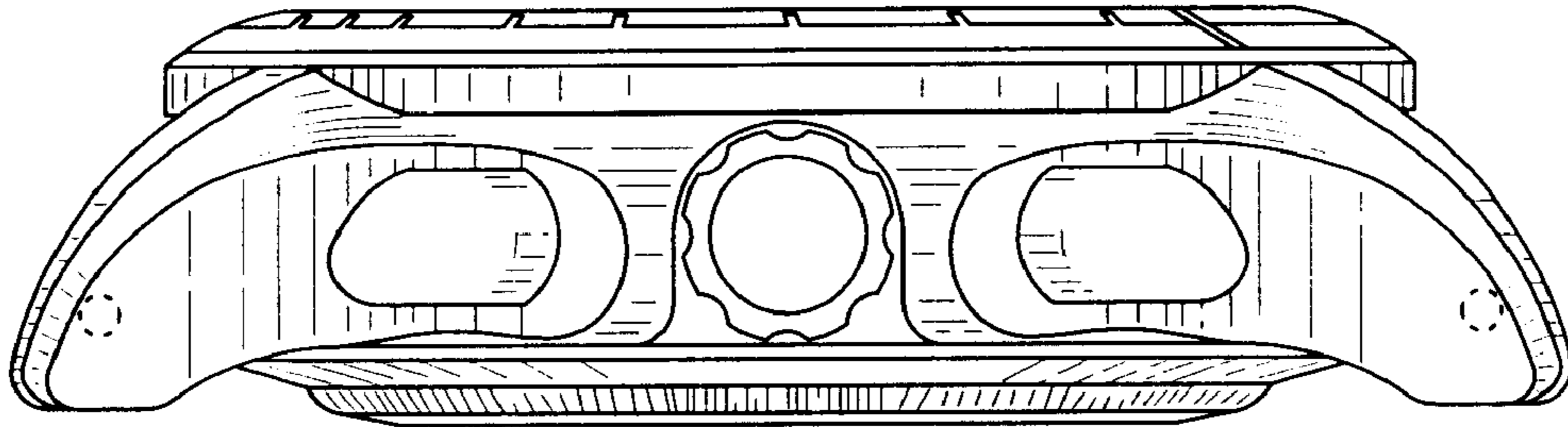


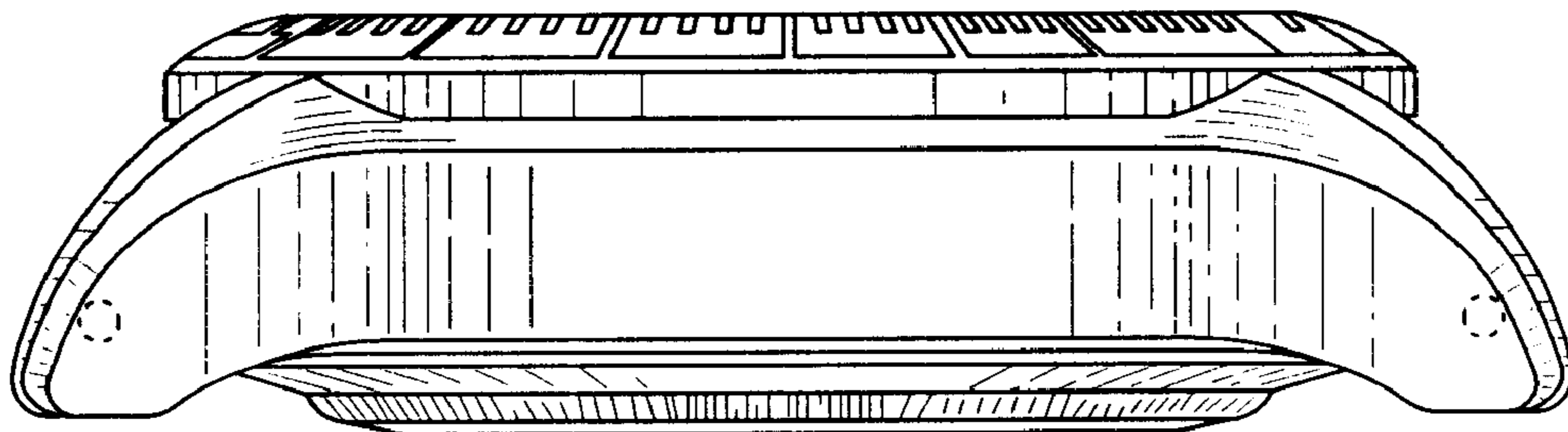

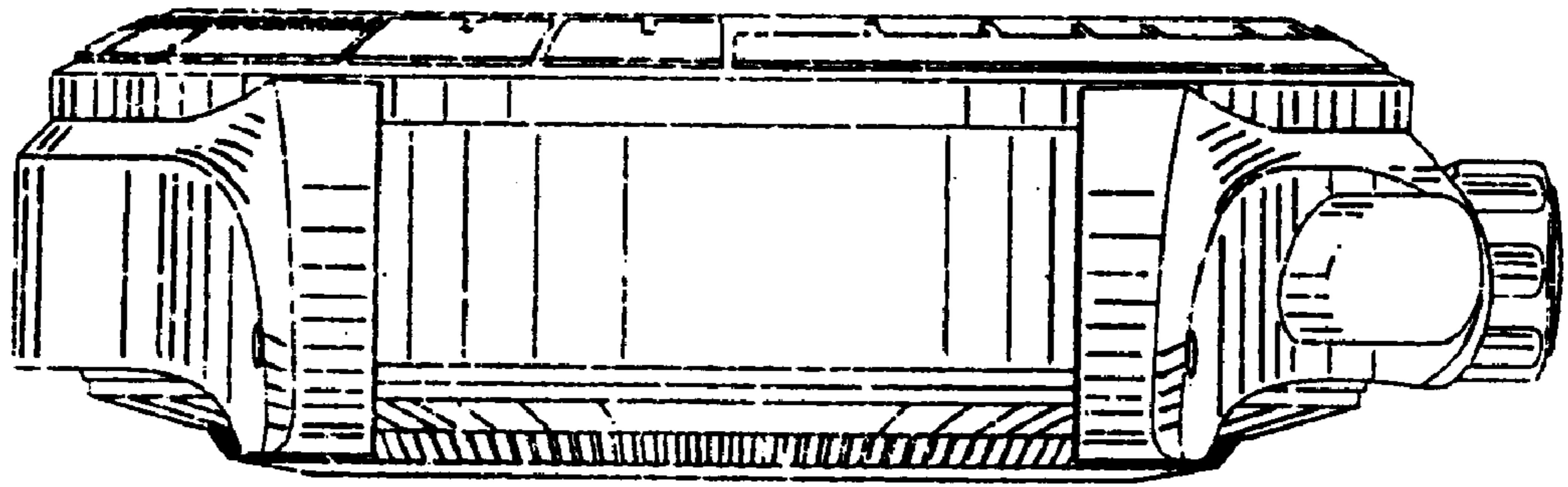

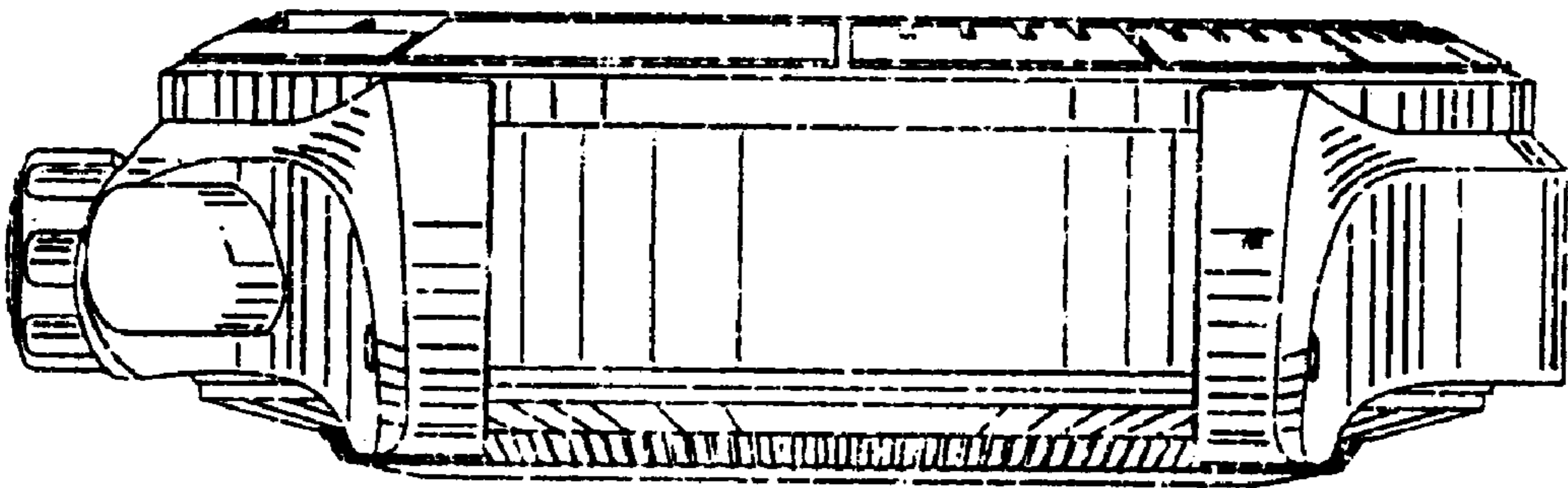
