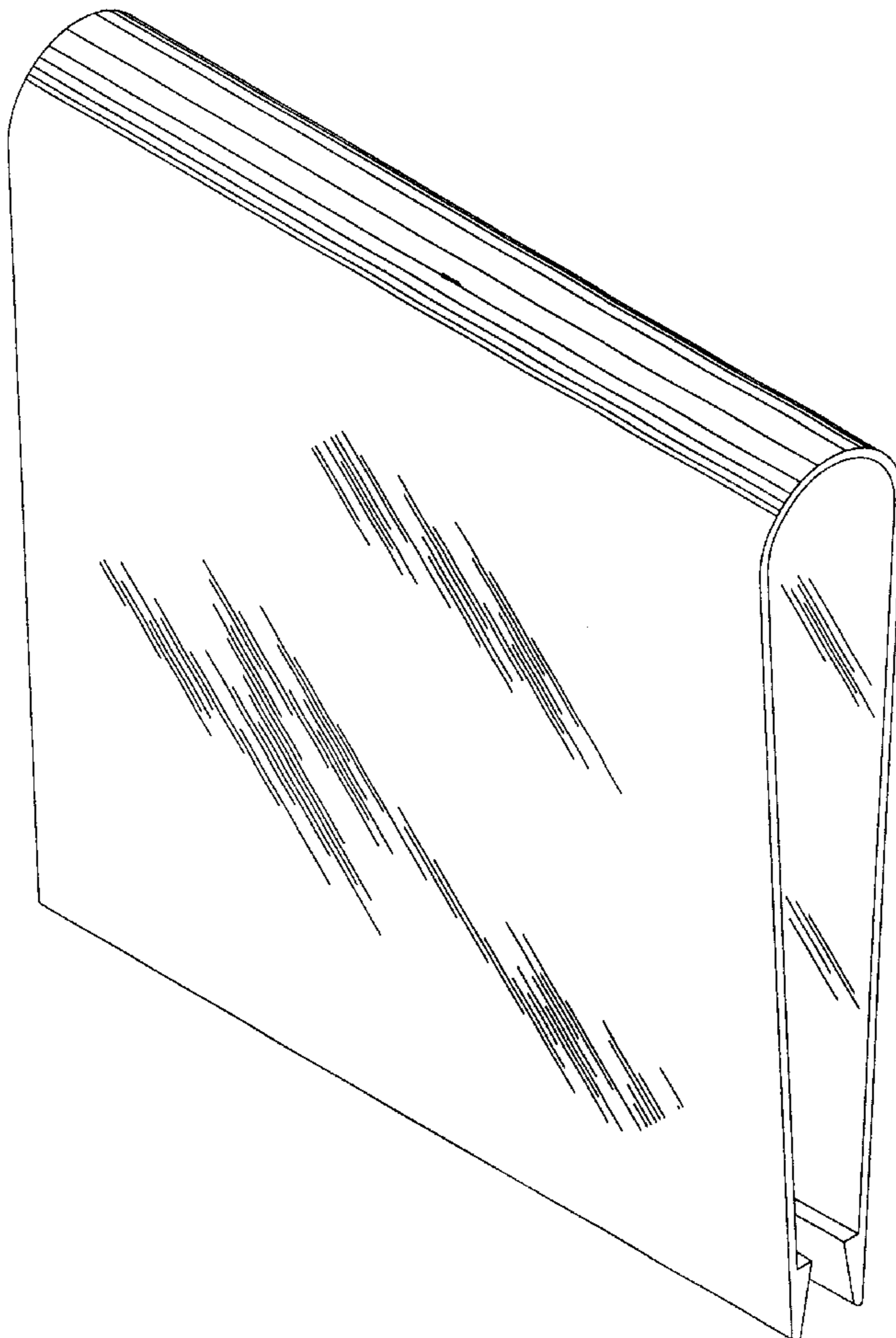
(57) **CLAIM**

I claim the ornamental design for an automobile visor and clip, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of an automobile visor and clip showing my design;

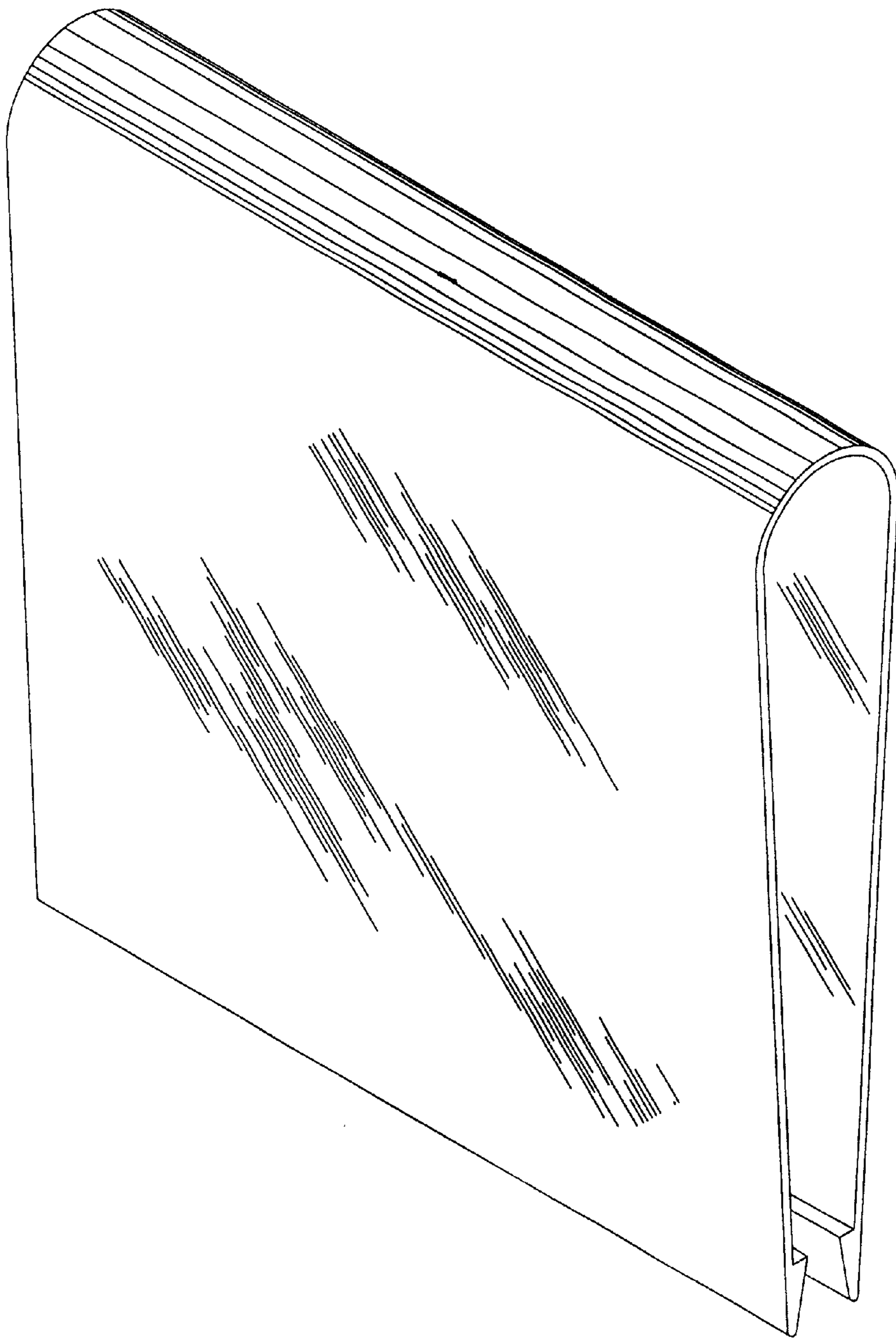

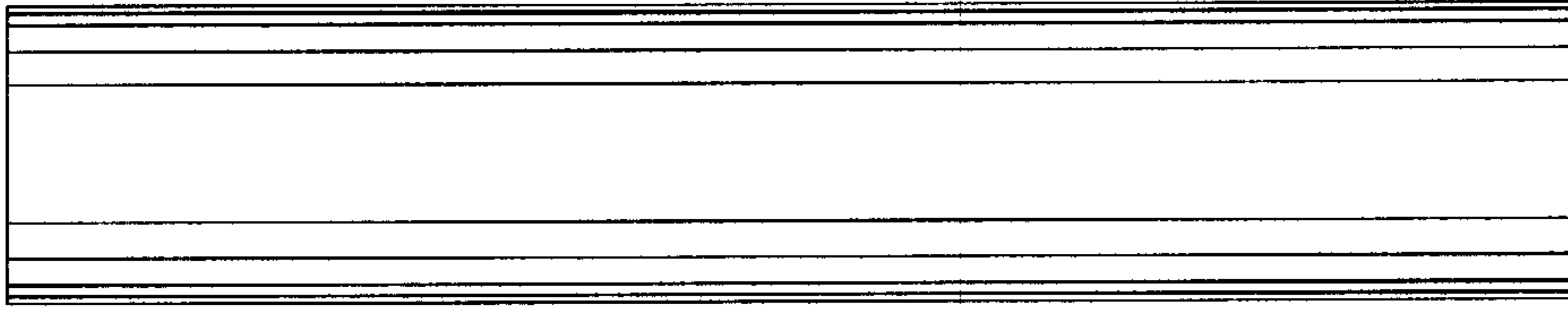

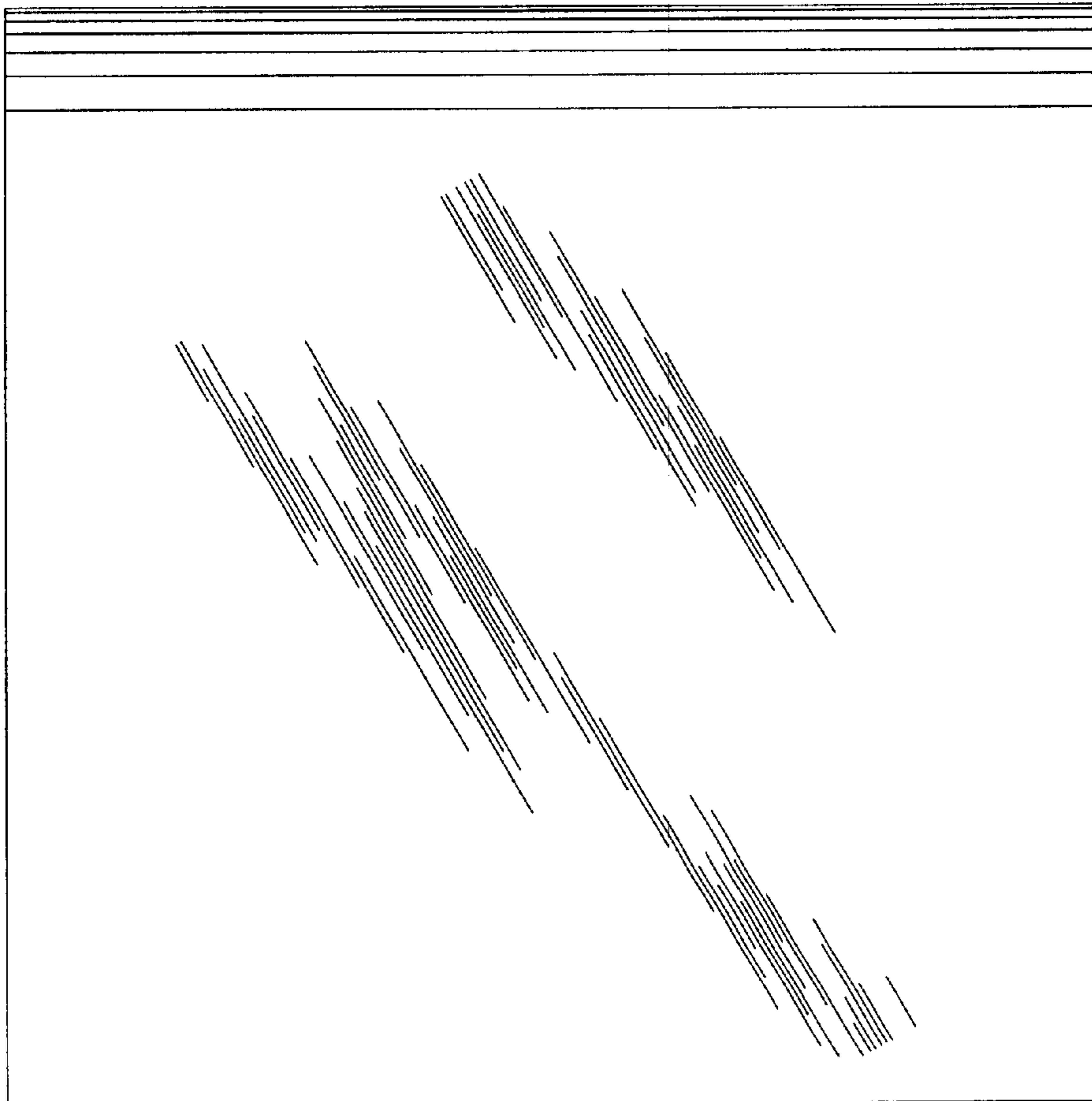

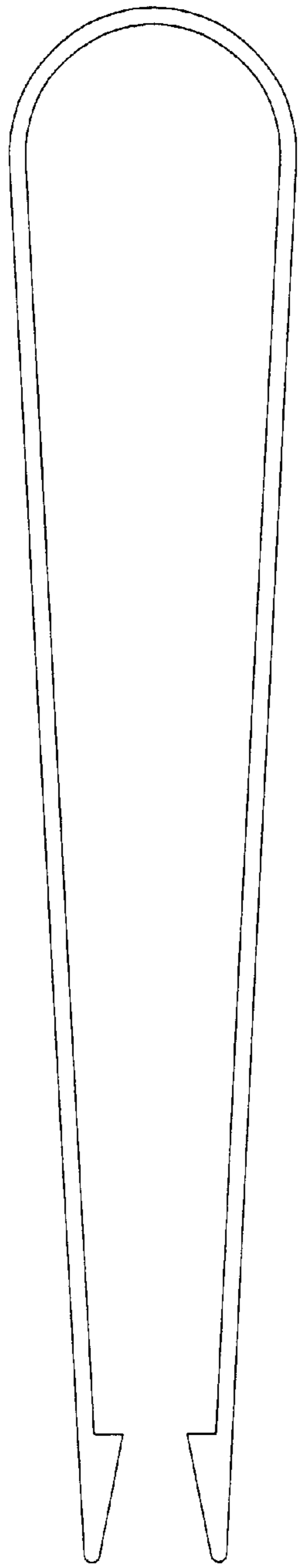

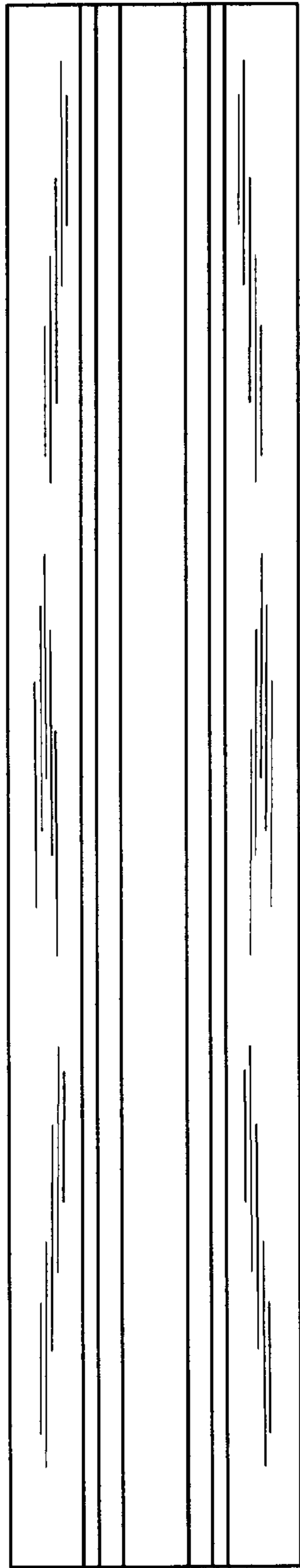
