(57) **CLAIM**

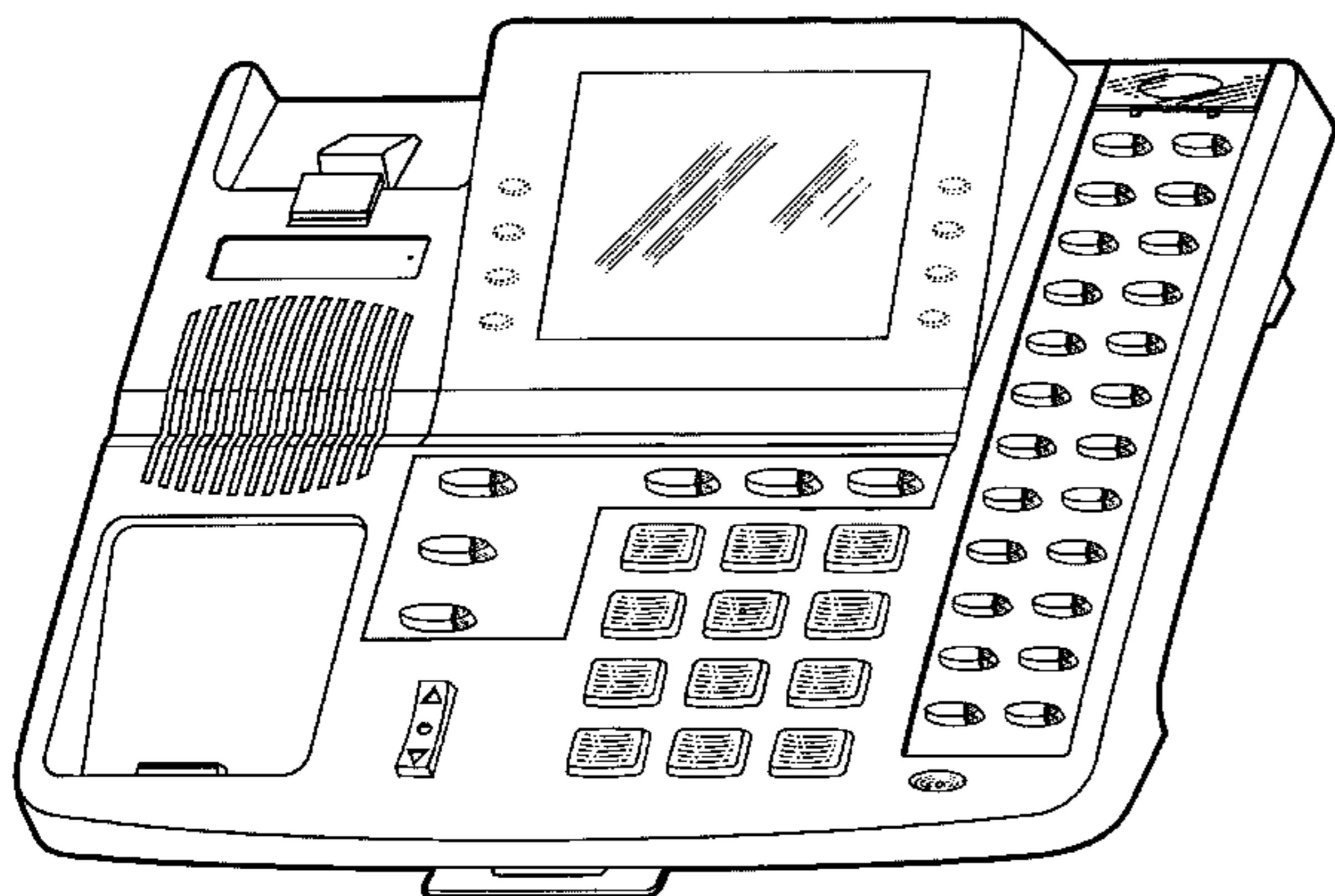
The ornamental design for a telephone, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a telephone showing my new design;
FIG. 2 is a top view thereof;
FIG. 3 is a perspective view of a second embodiment of a telephone showing my new design;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a front view thereof;
FIG. 7 is a rear view thereof;
FIG. 8 is a bottom perspective view thereof; and,
FIG. 9 is a bottom view thereof.

The appearance of the second embodiment is the same as the first in all respects except for the smaller display. The broken lines throughout the views are for illustrative purposes only and form no part of the claimed design.

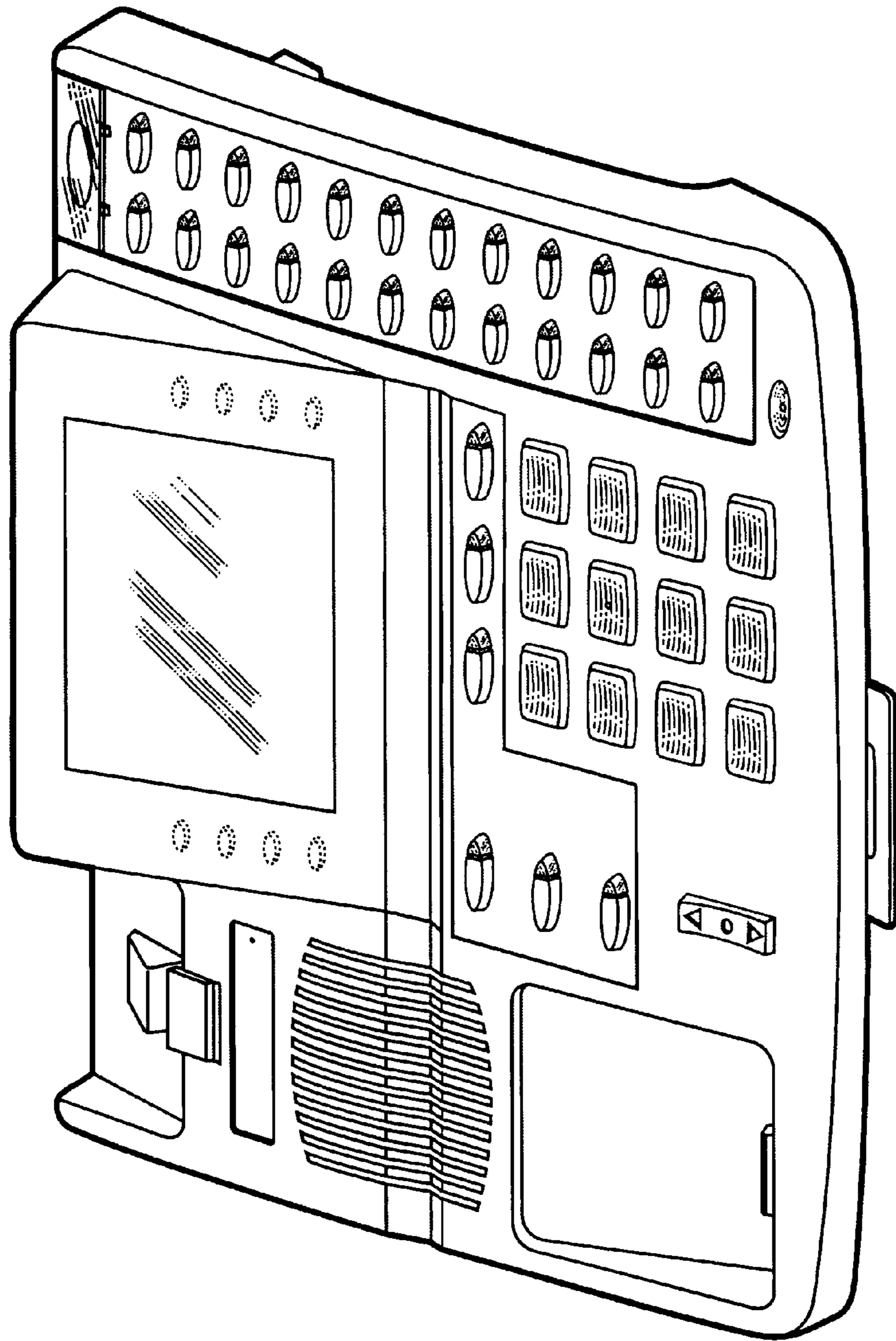

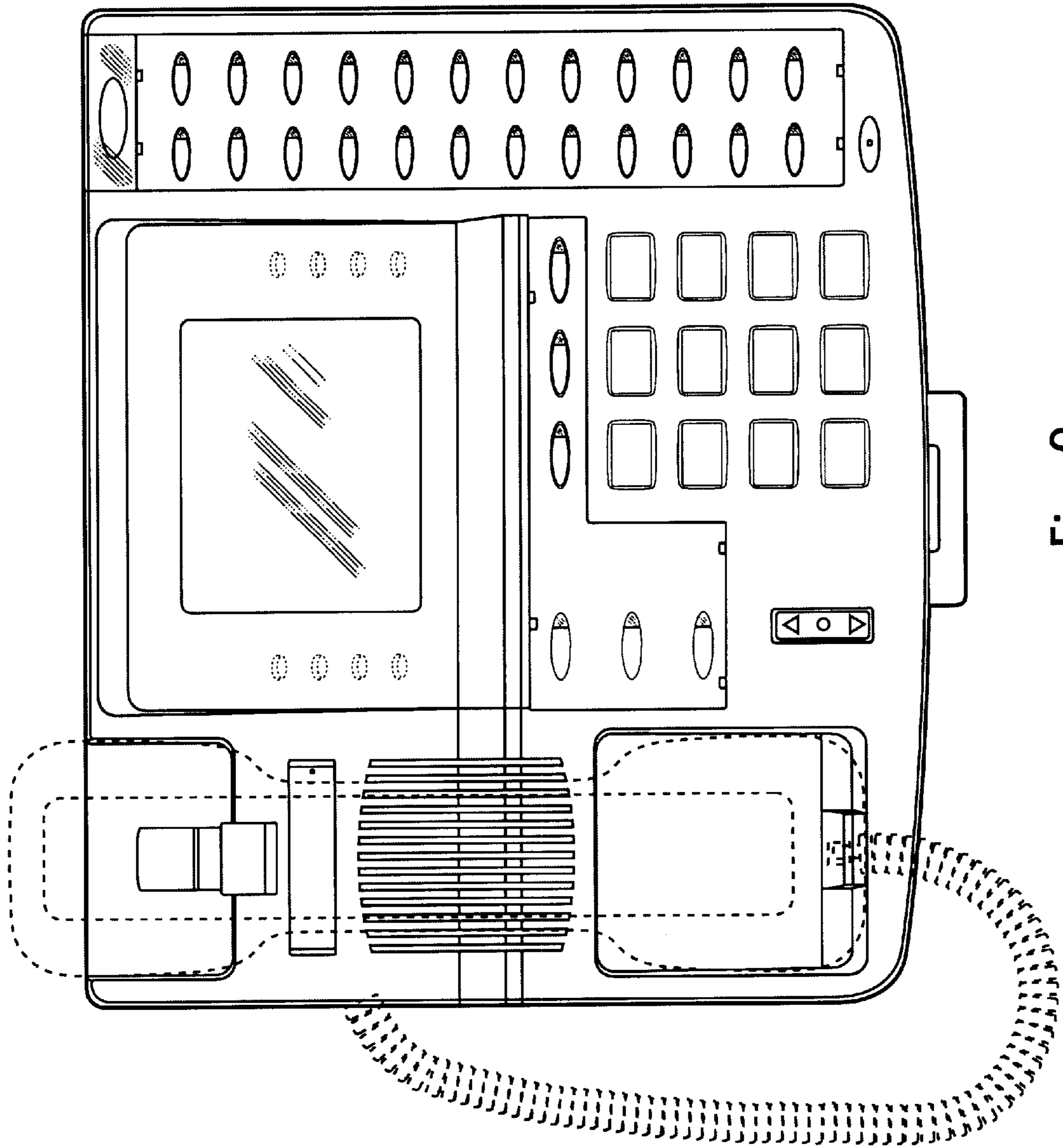

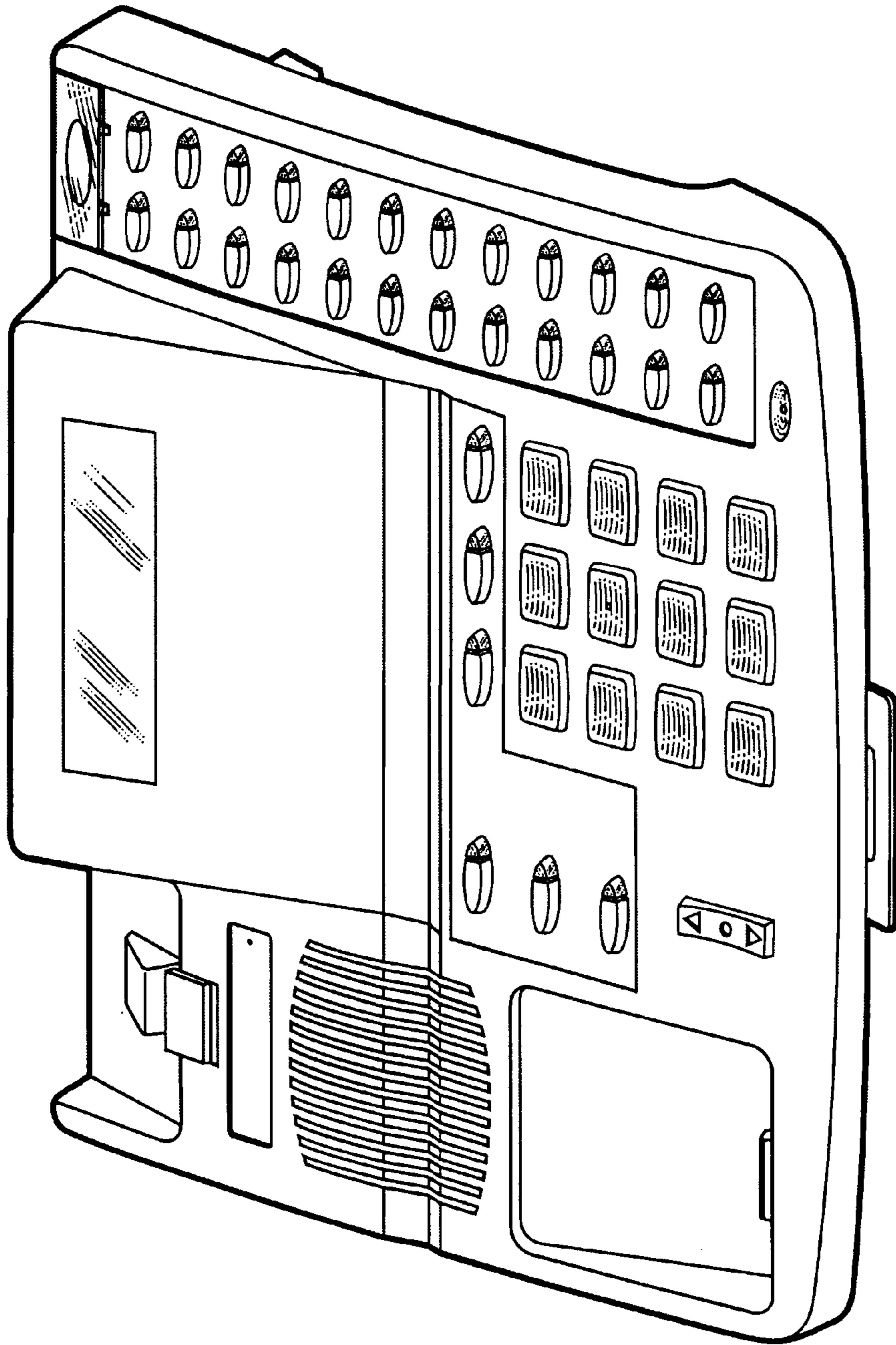

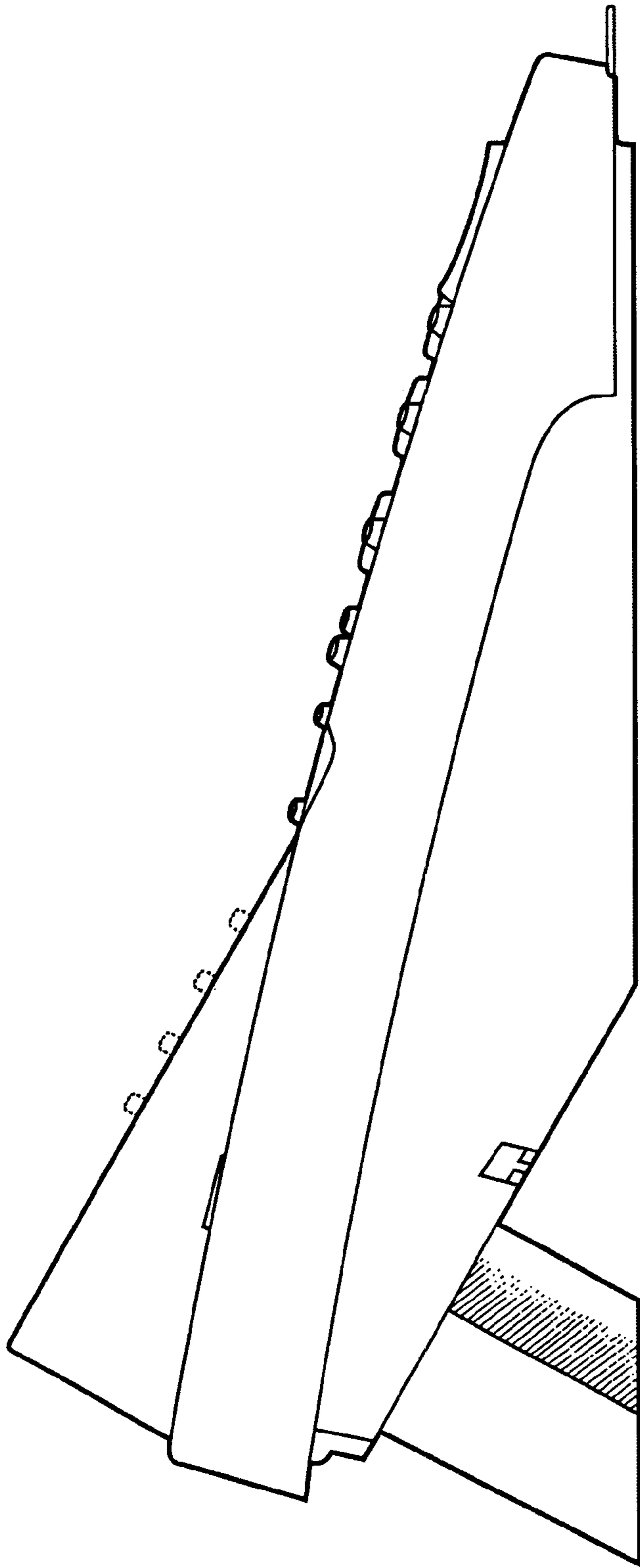

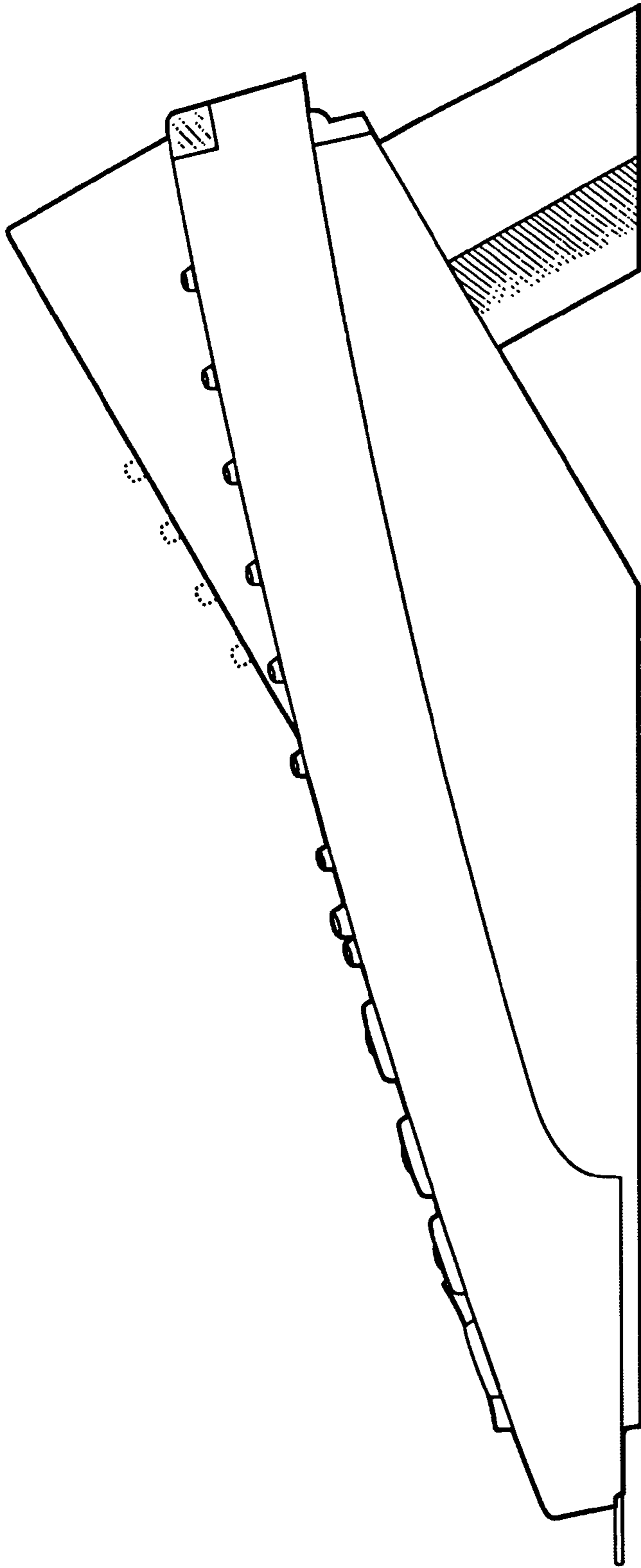

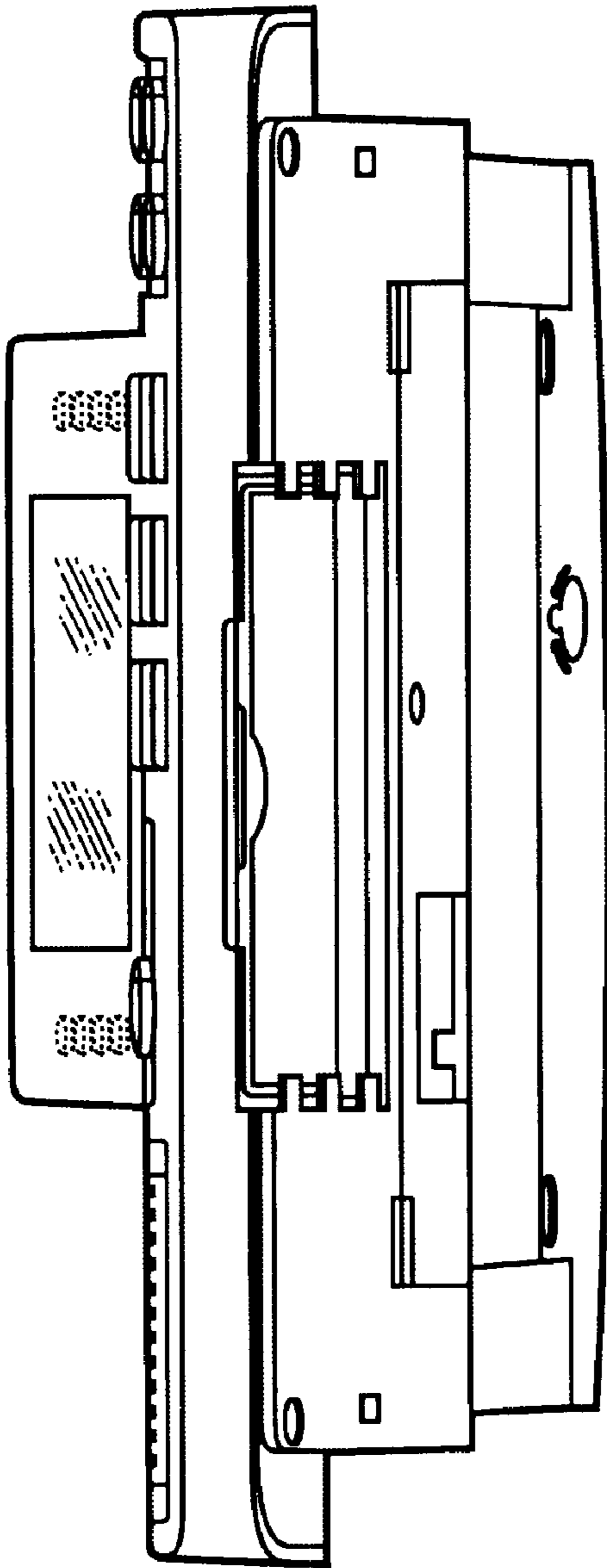

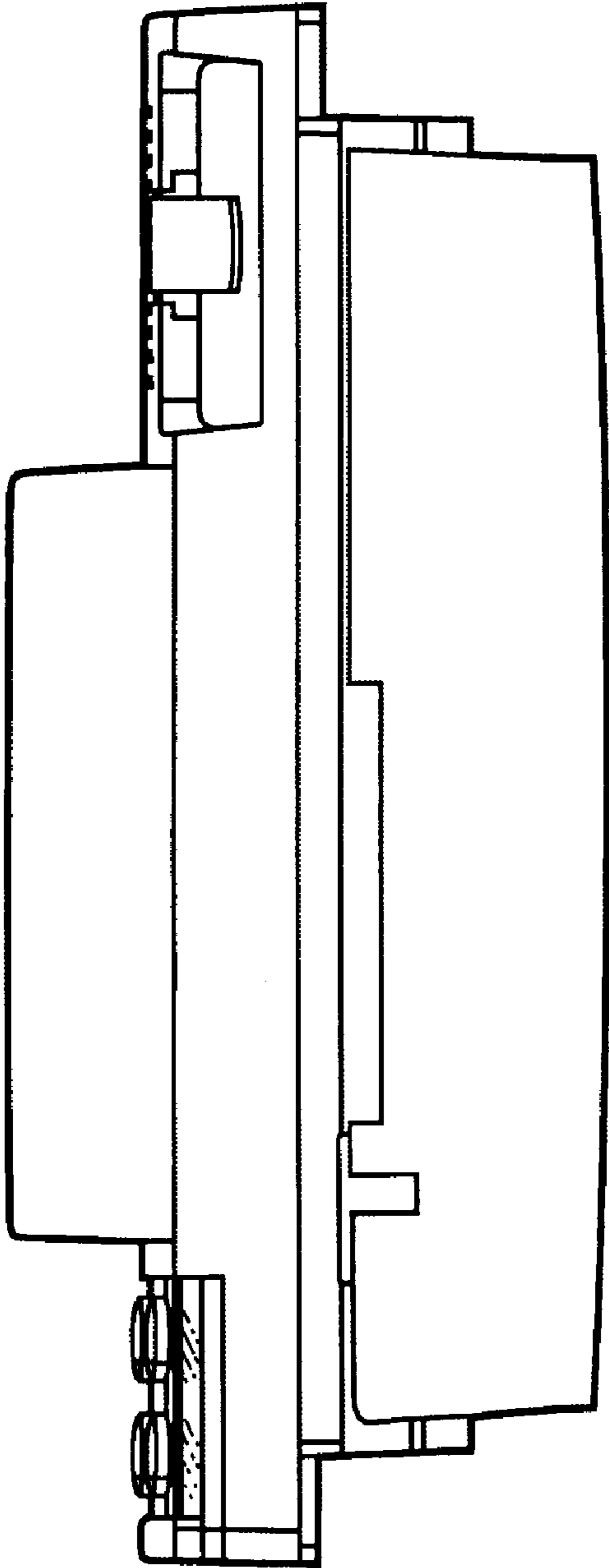

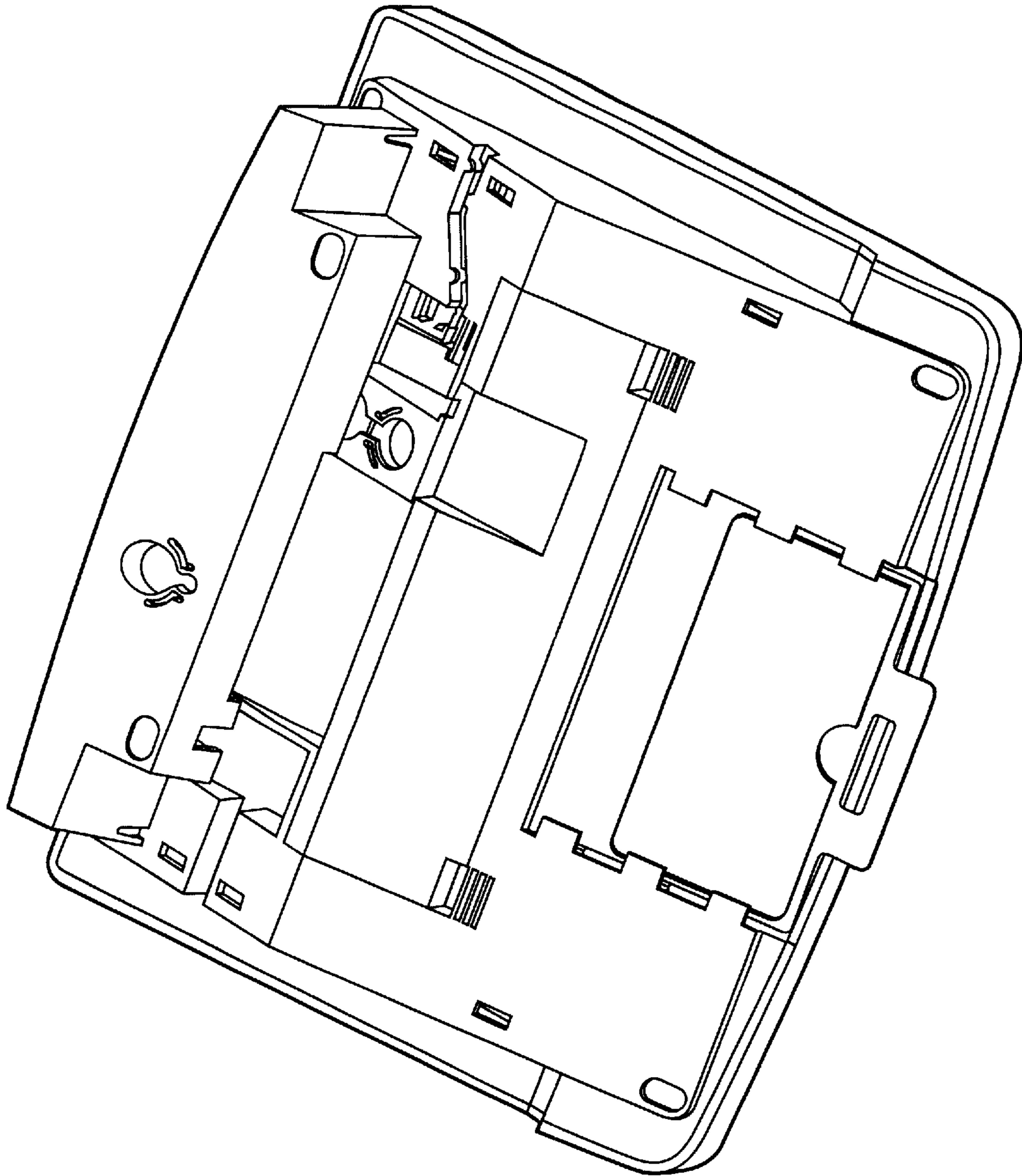

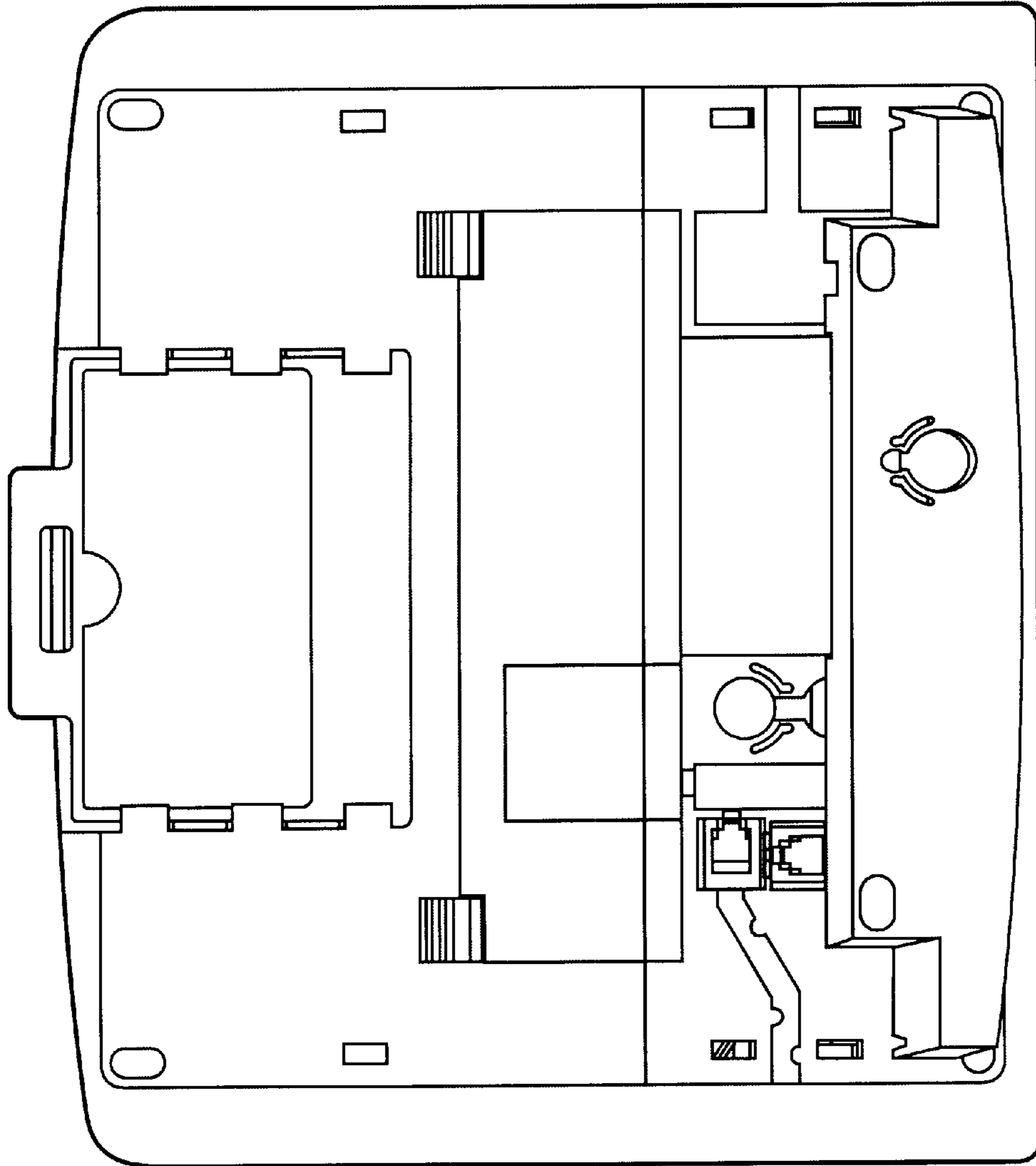
