(57) **CLAIM**

The ornamental design for a headset, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a headset showing our new design;

FIG. 2 is a left side view thereof;

FIG. 3 is a right side view thereof;

FIG. 4 is a bottom view thereof;

FIG. 5 is a front view thereof;

FIG. 6 is a top view thereof;

FIG. 7 is a back view thereof;

FIG. 8 is a perspective view thereof with the microphone shown in a second alternative position;

FIG. 9 is a left side view thereof with the microphone shown in the second alternative position of FIG. 8;

FIG. 10 is a right side view thereof with the microphone shown in the second alternative position of FIG. 8;

FIG. 11 is a bottom view thereof with the microphone shown in the second alternative position of FIG. 8;

FIG. 12 is a front view thereof with the microphone shown in the second alternative position of FIG. 8;

FIG. 13 is a top view thereof with the microphone shown in the second alternative position of FIG. 8;

FIG. 14 is a back view thereof with the microphone shown in the second alternative position of FIG. 8;

FIG. 15 is a back view of an alternative embodiment of the headset showing our new design with the microphone shown in the second alternative position;

FIG. 16 is a top view of the alternative embodiment thereof of FIG. 15;

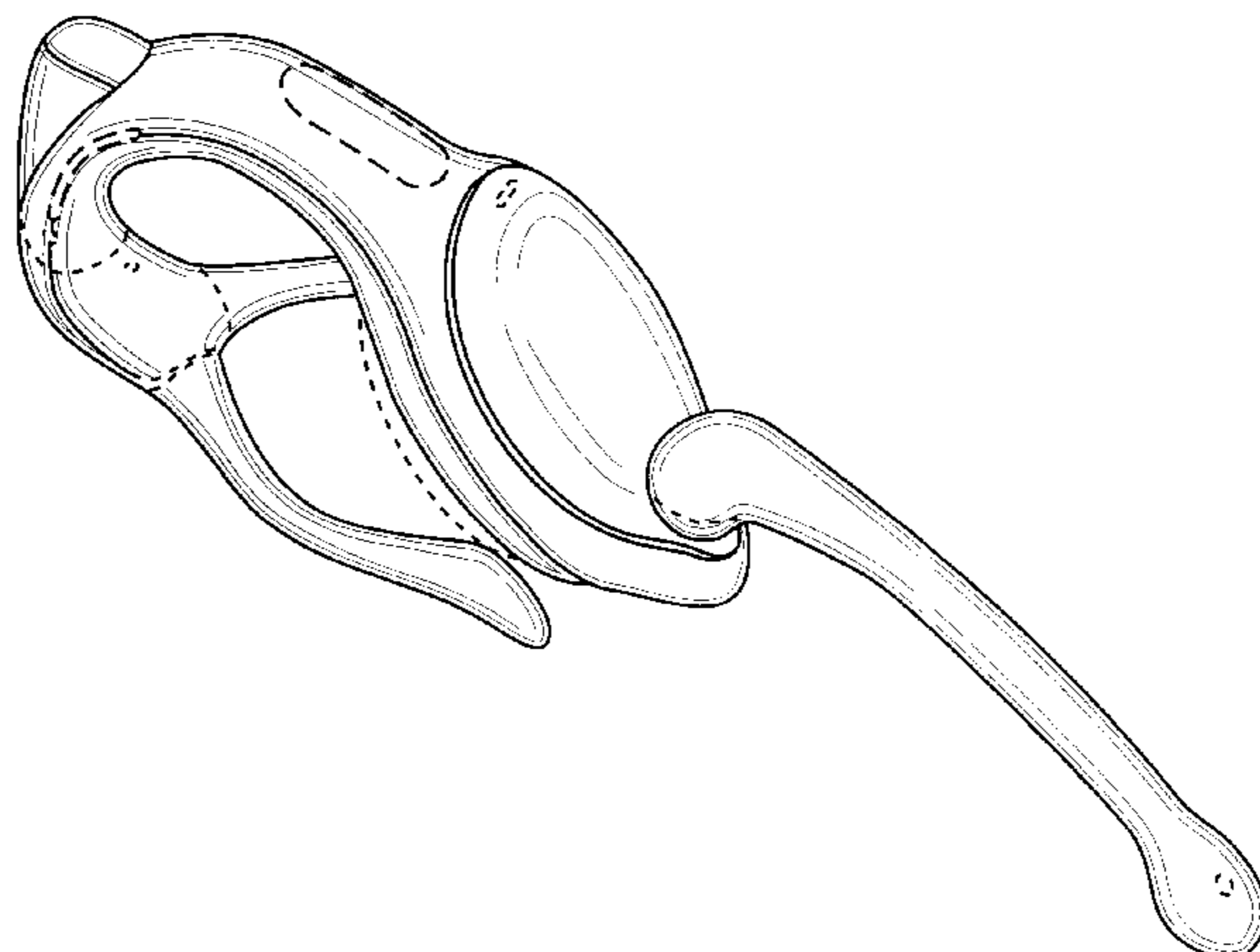
FIG. 17 is a front view of the alternative embodiment thereof of FIG. 15;

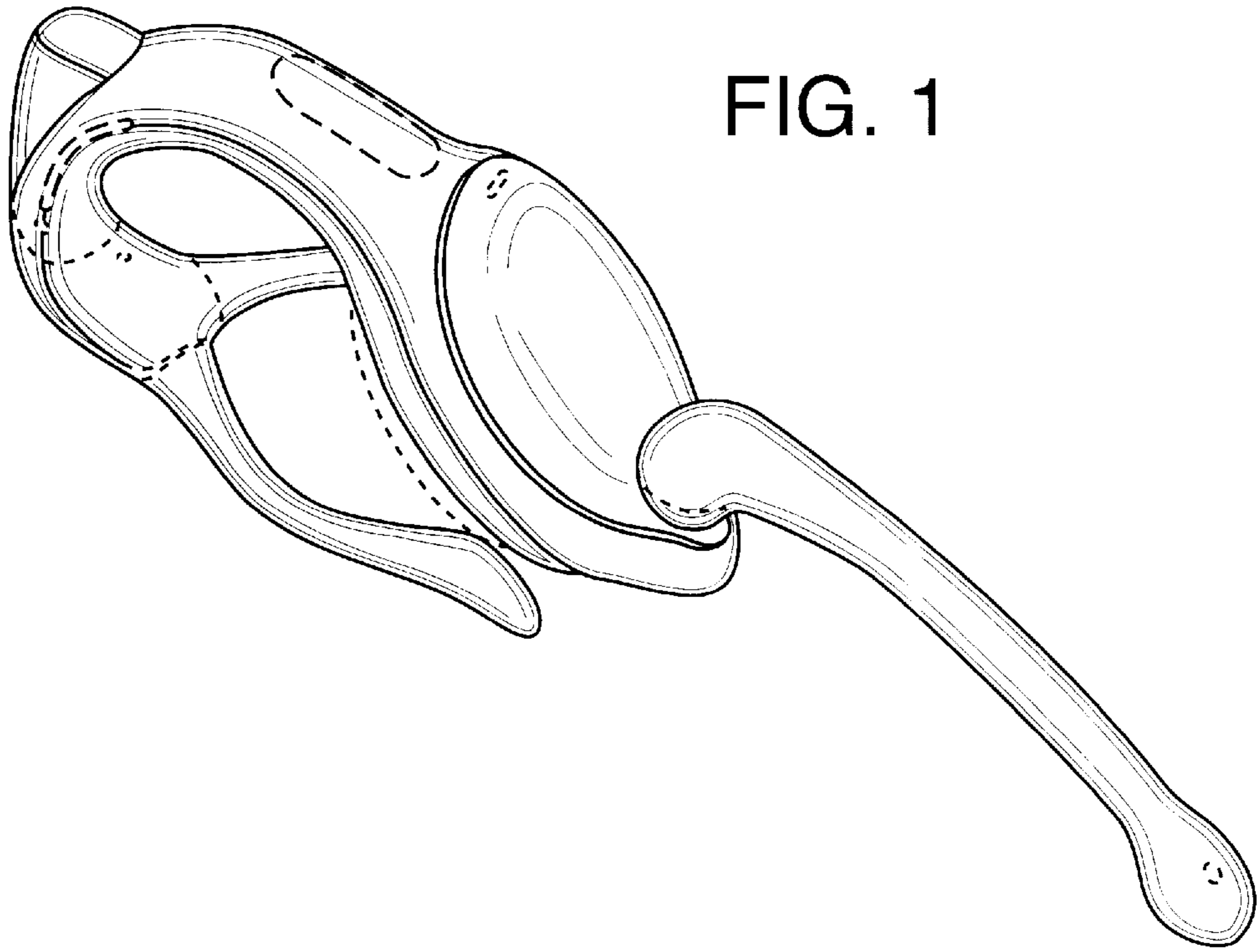

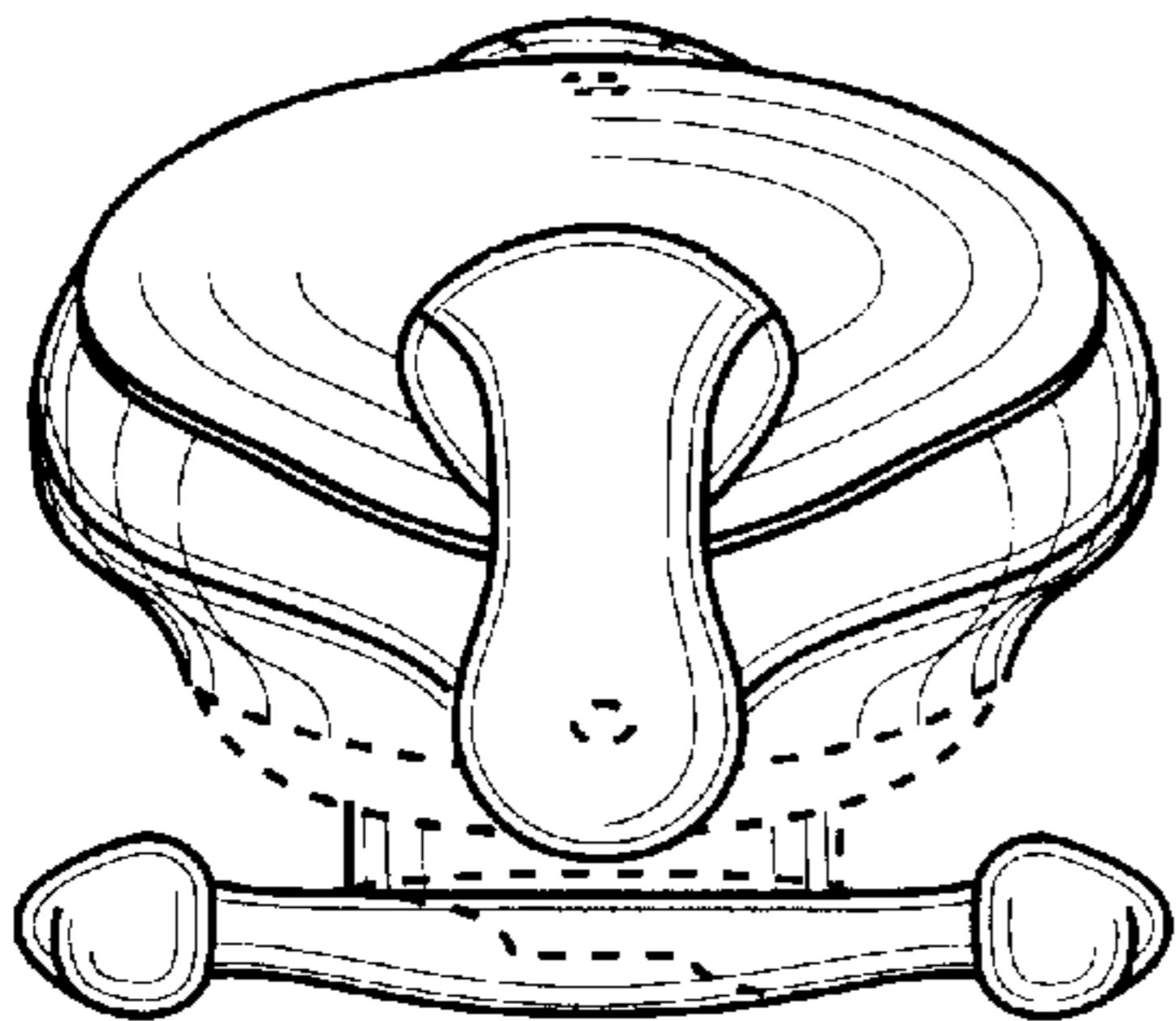

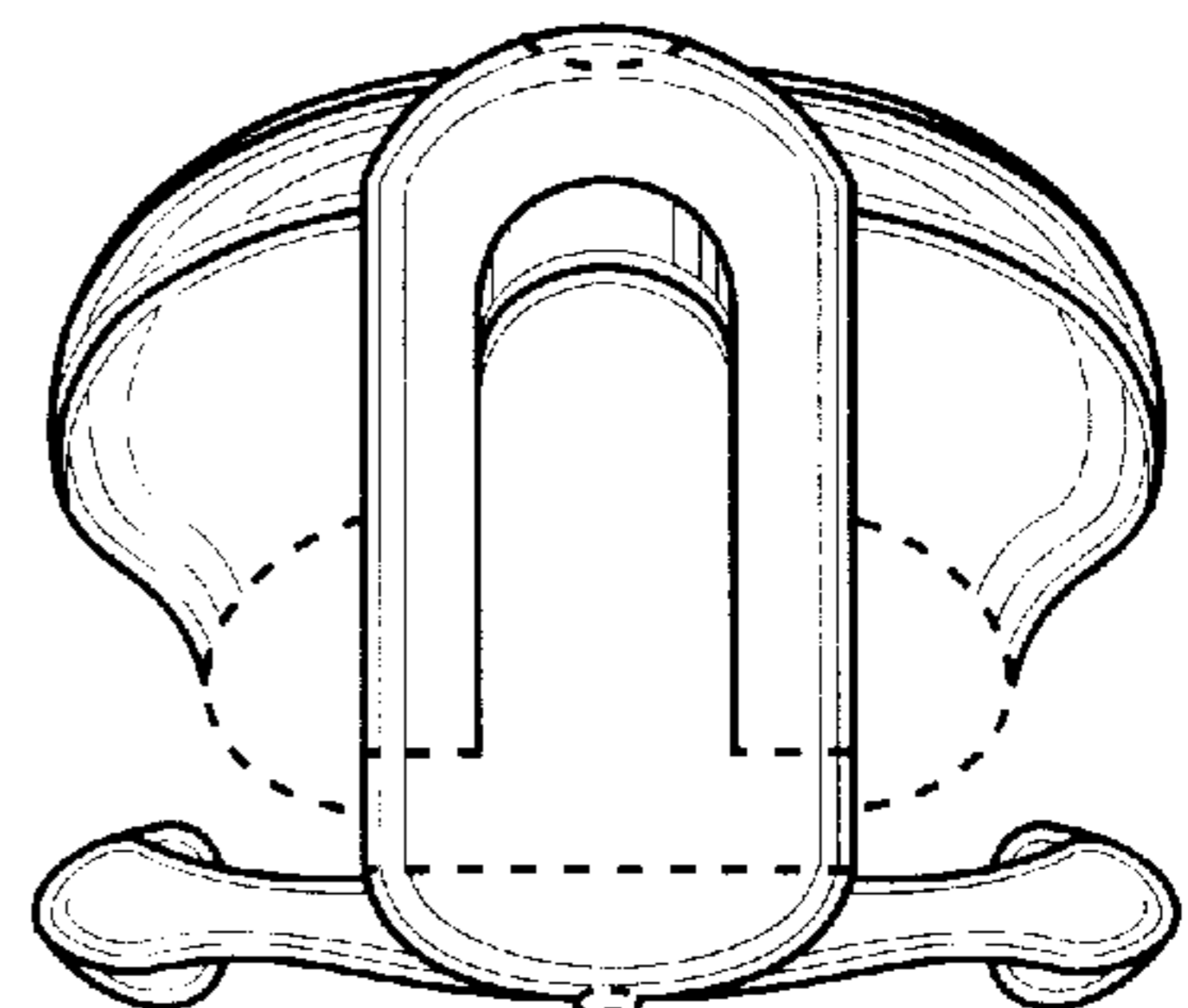

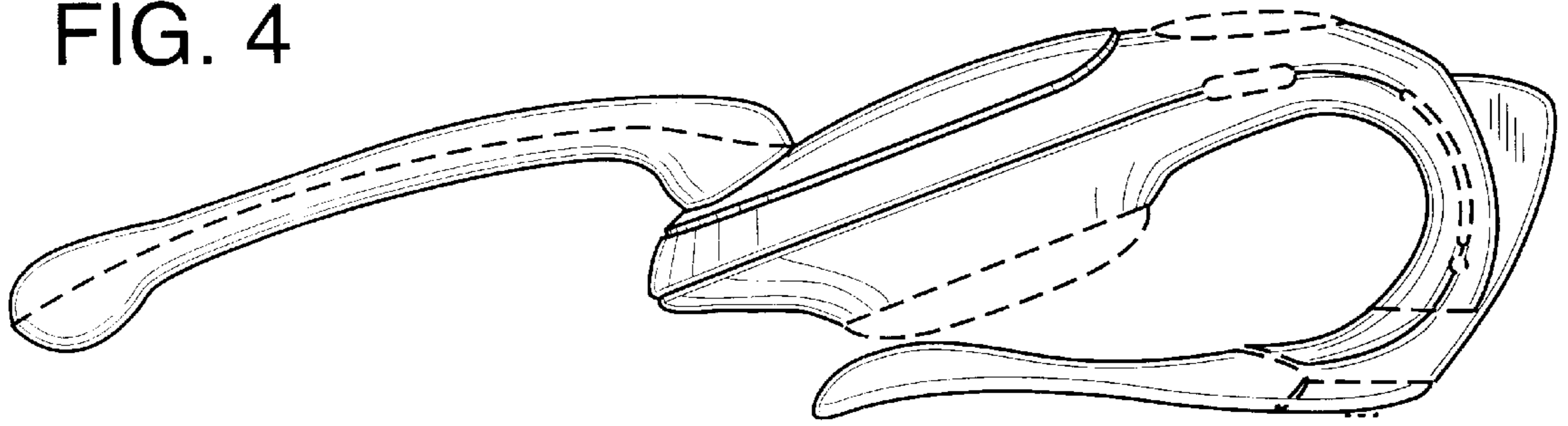

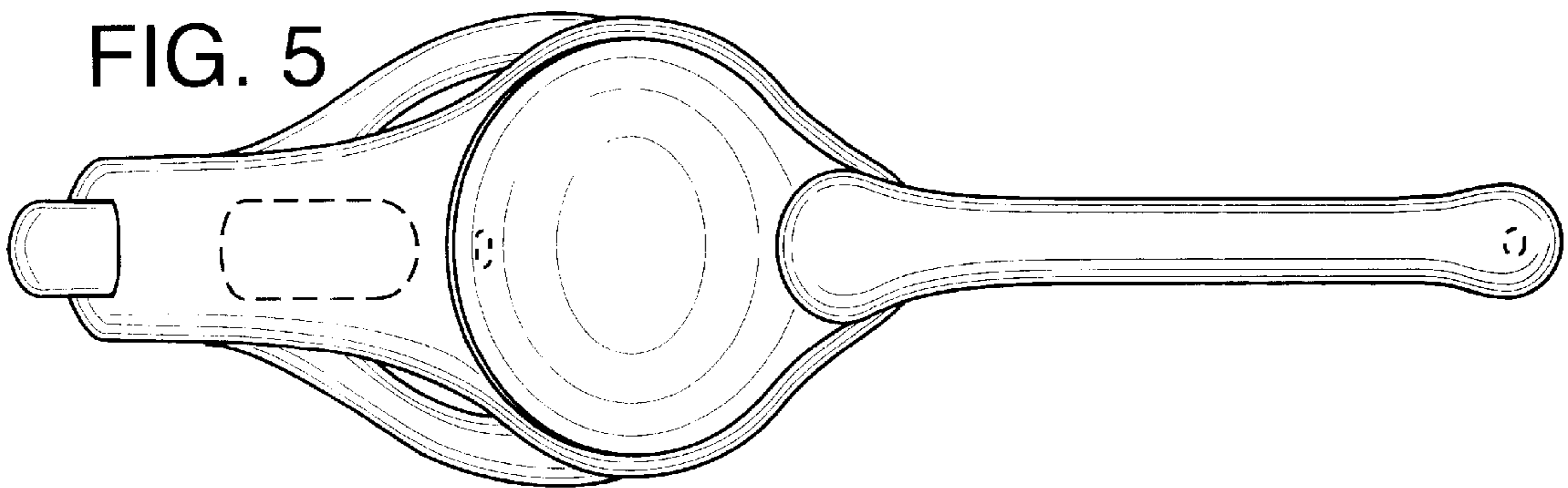

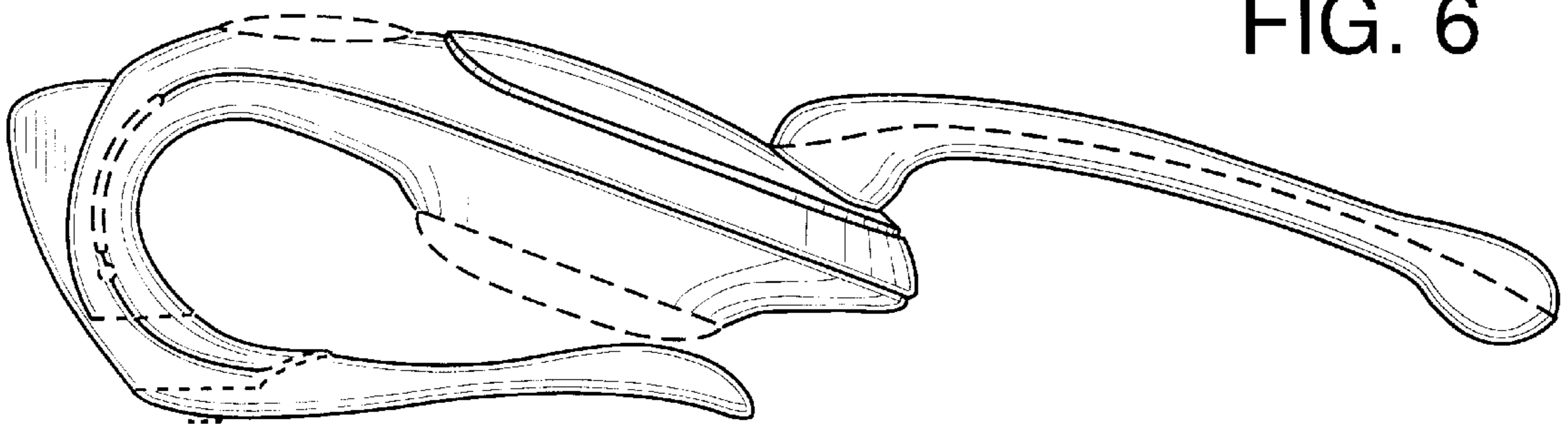
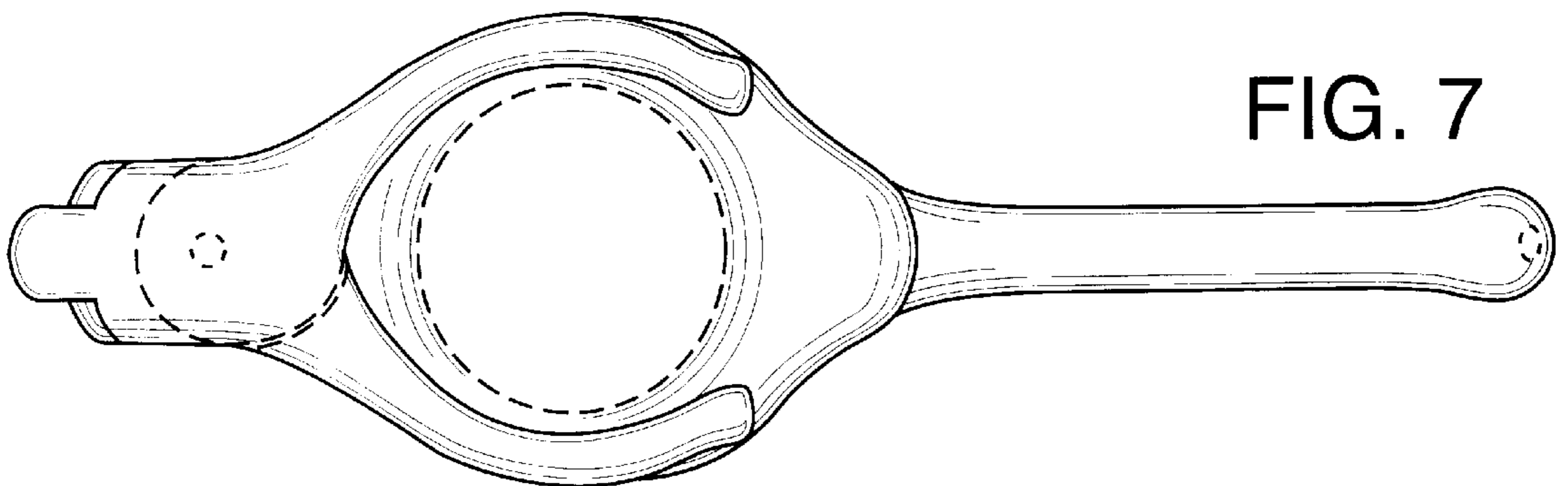

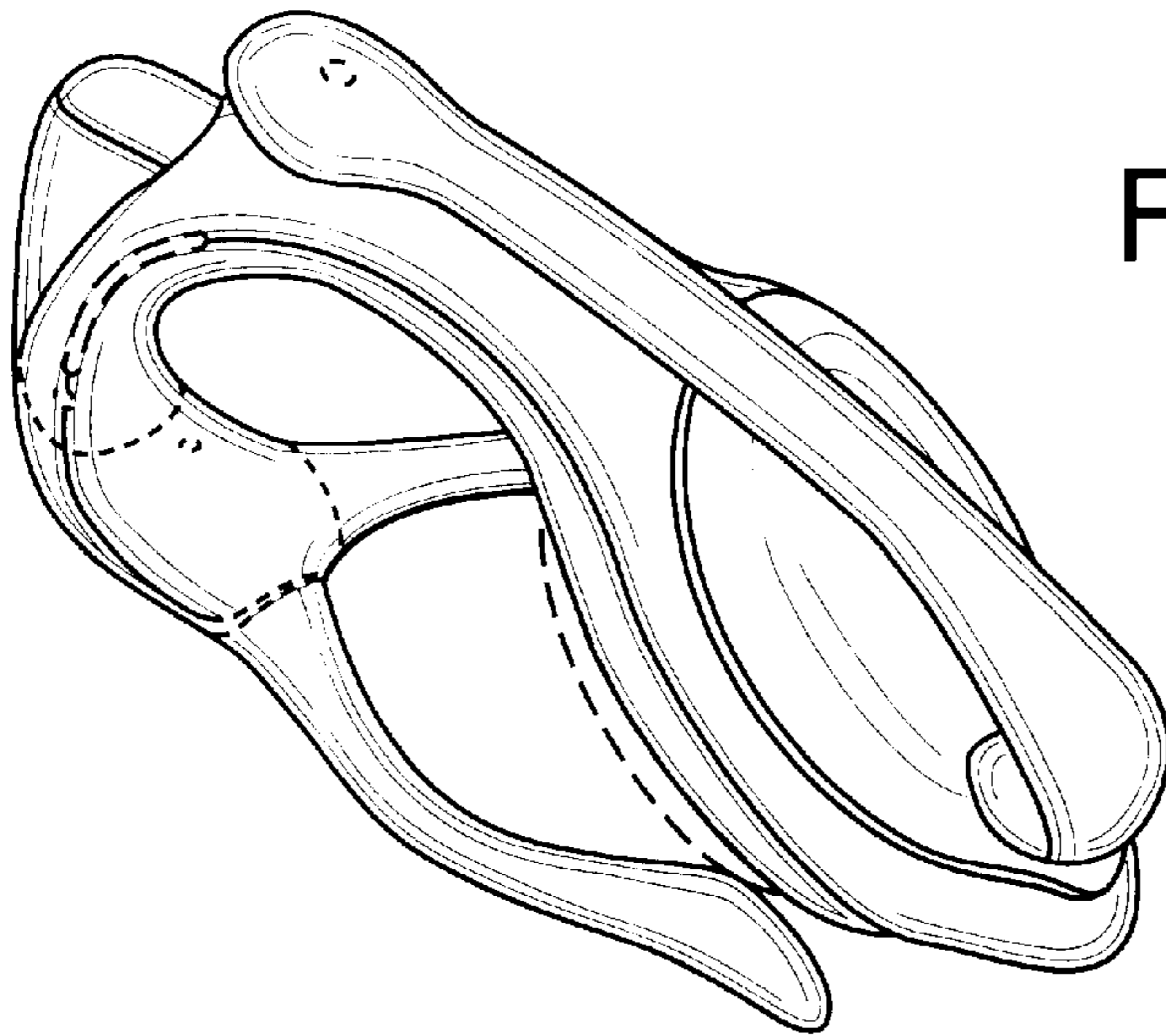

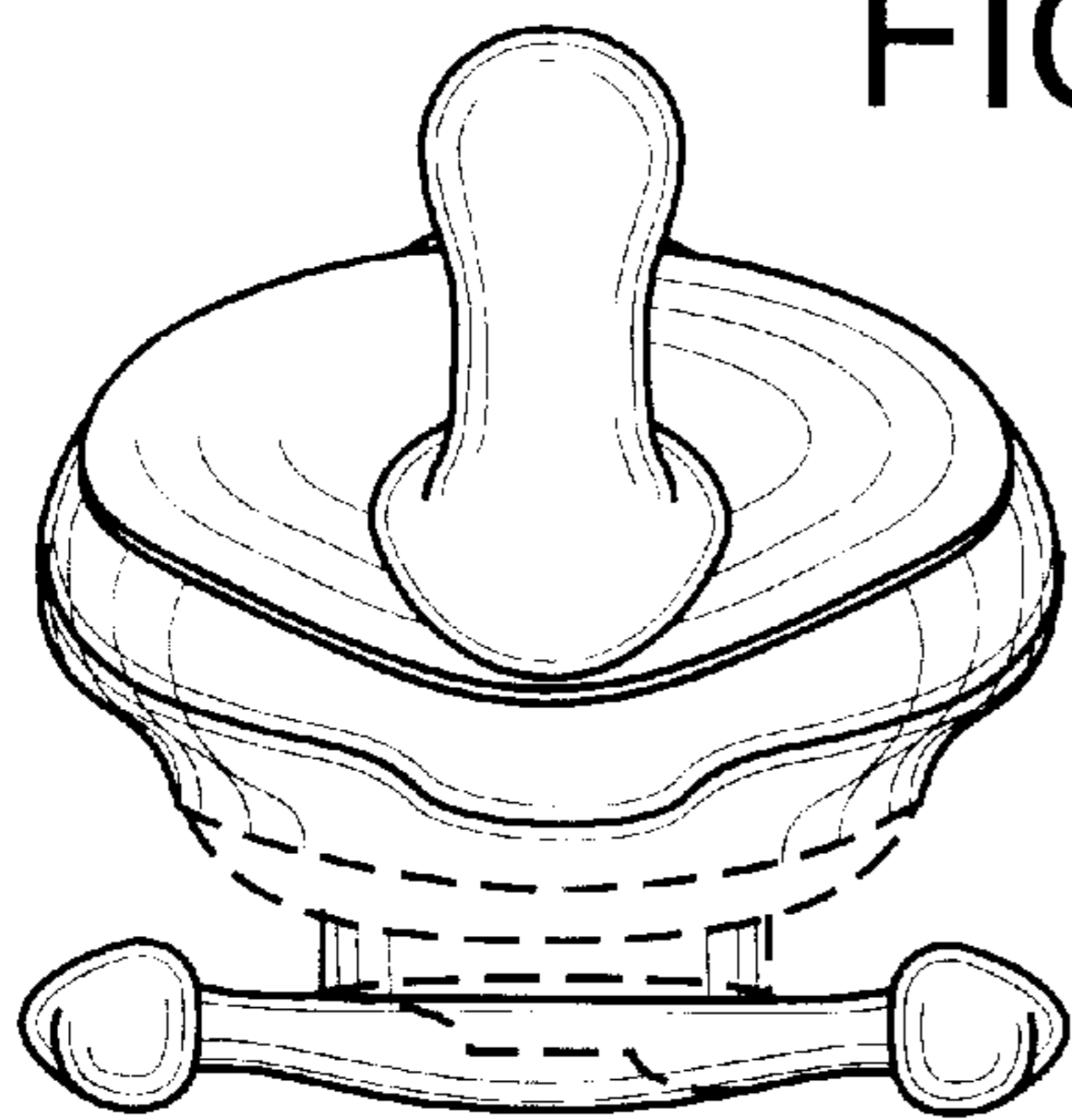

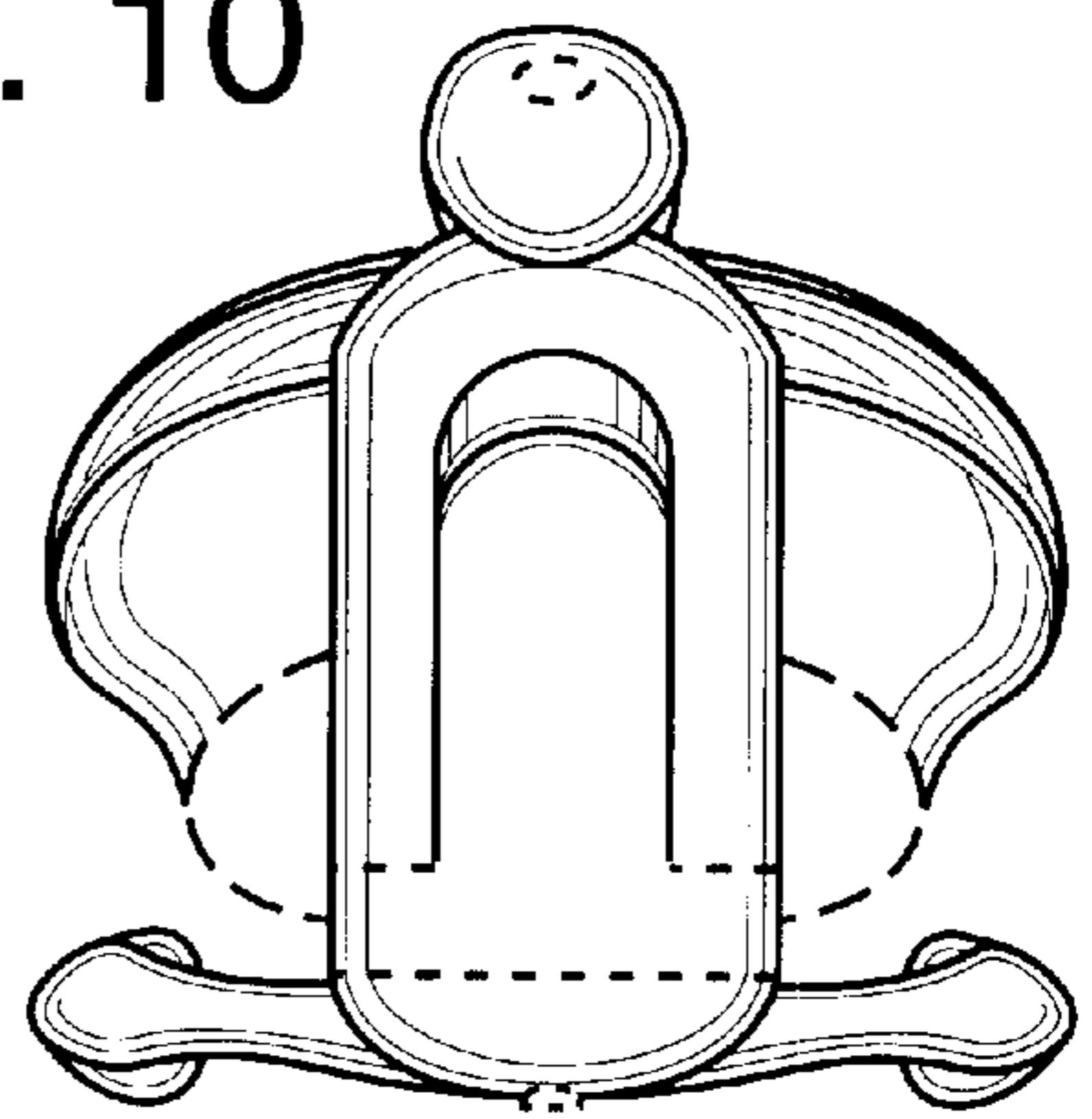

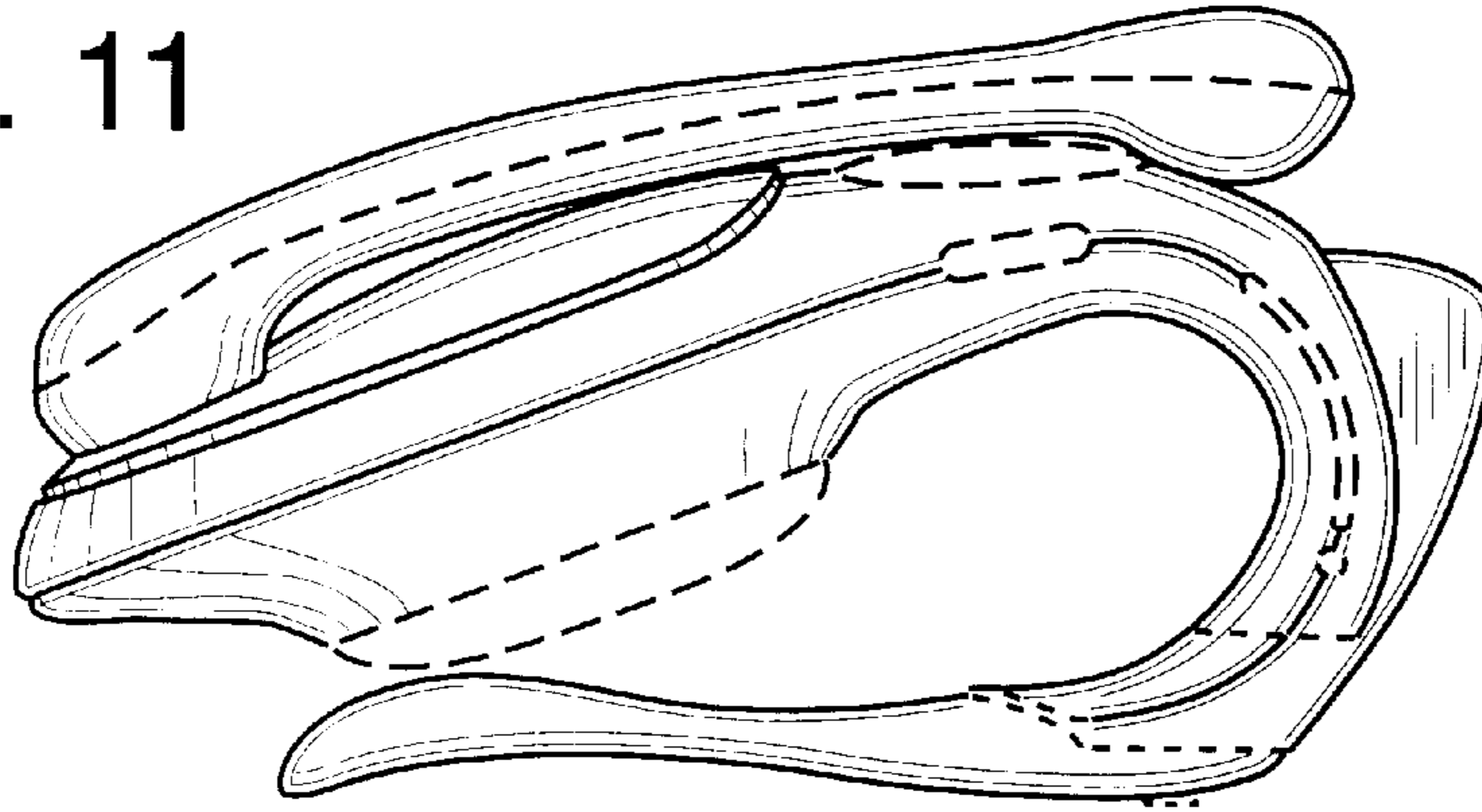

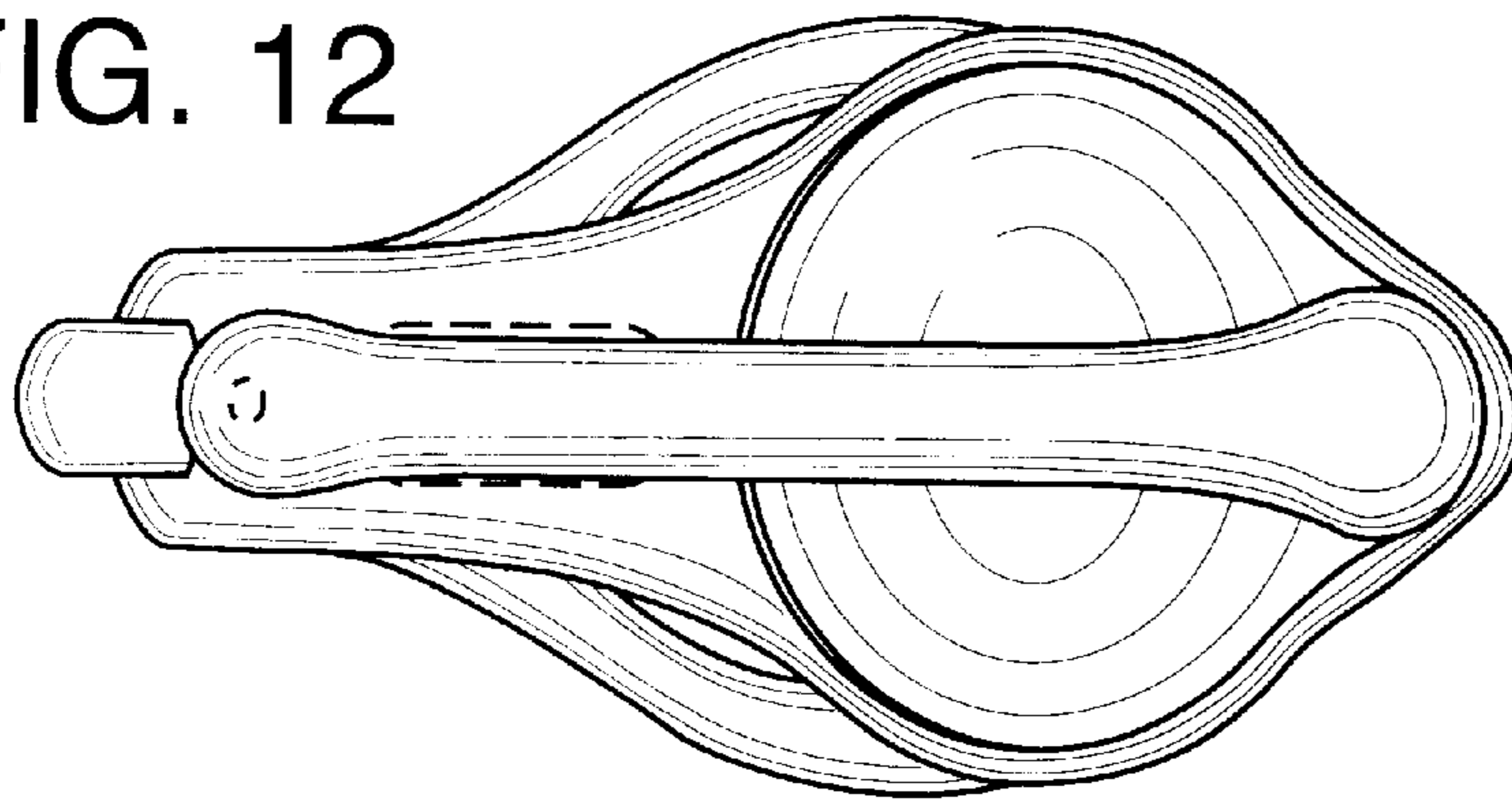

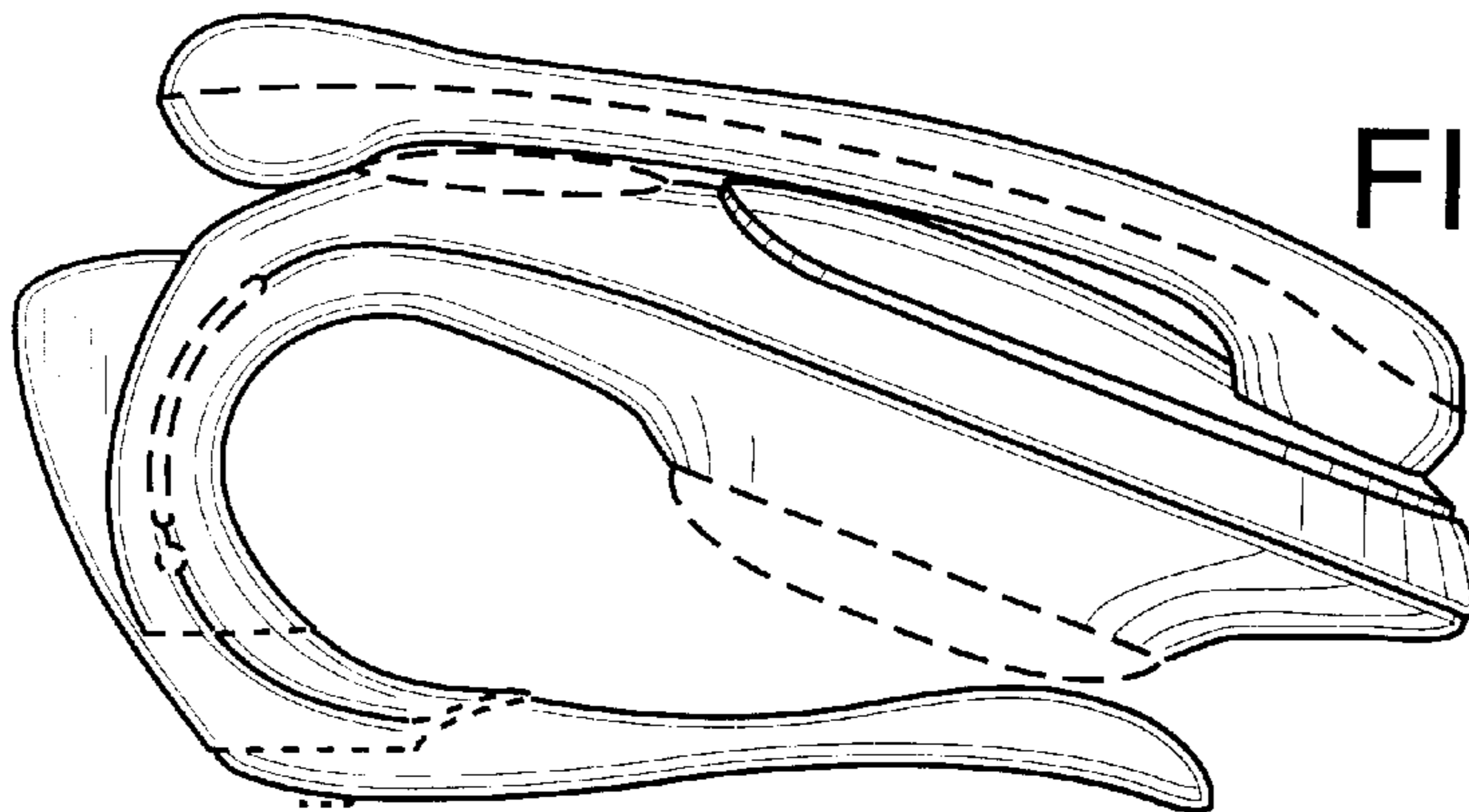

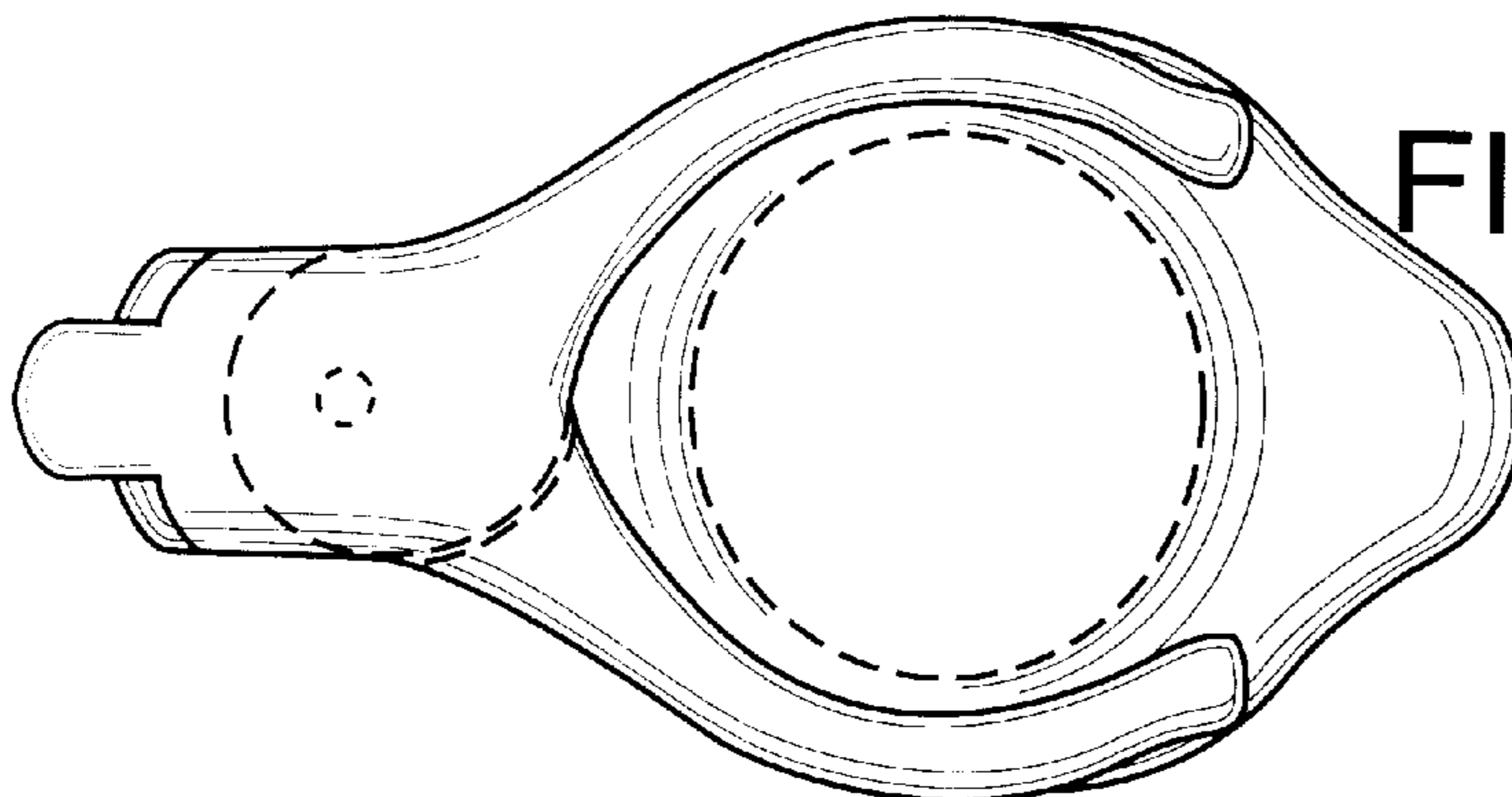

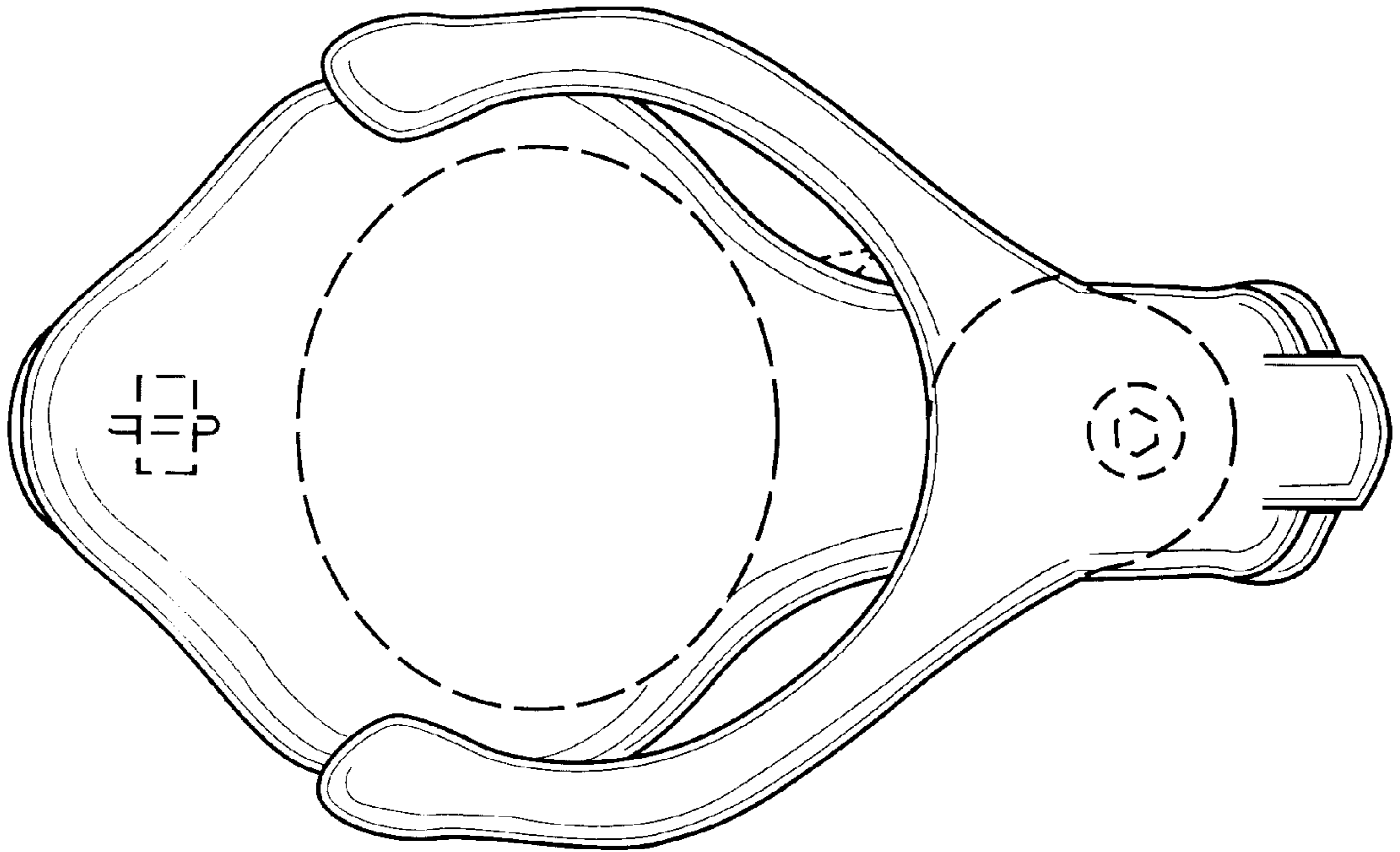

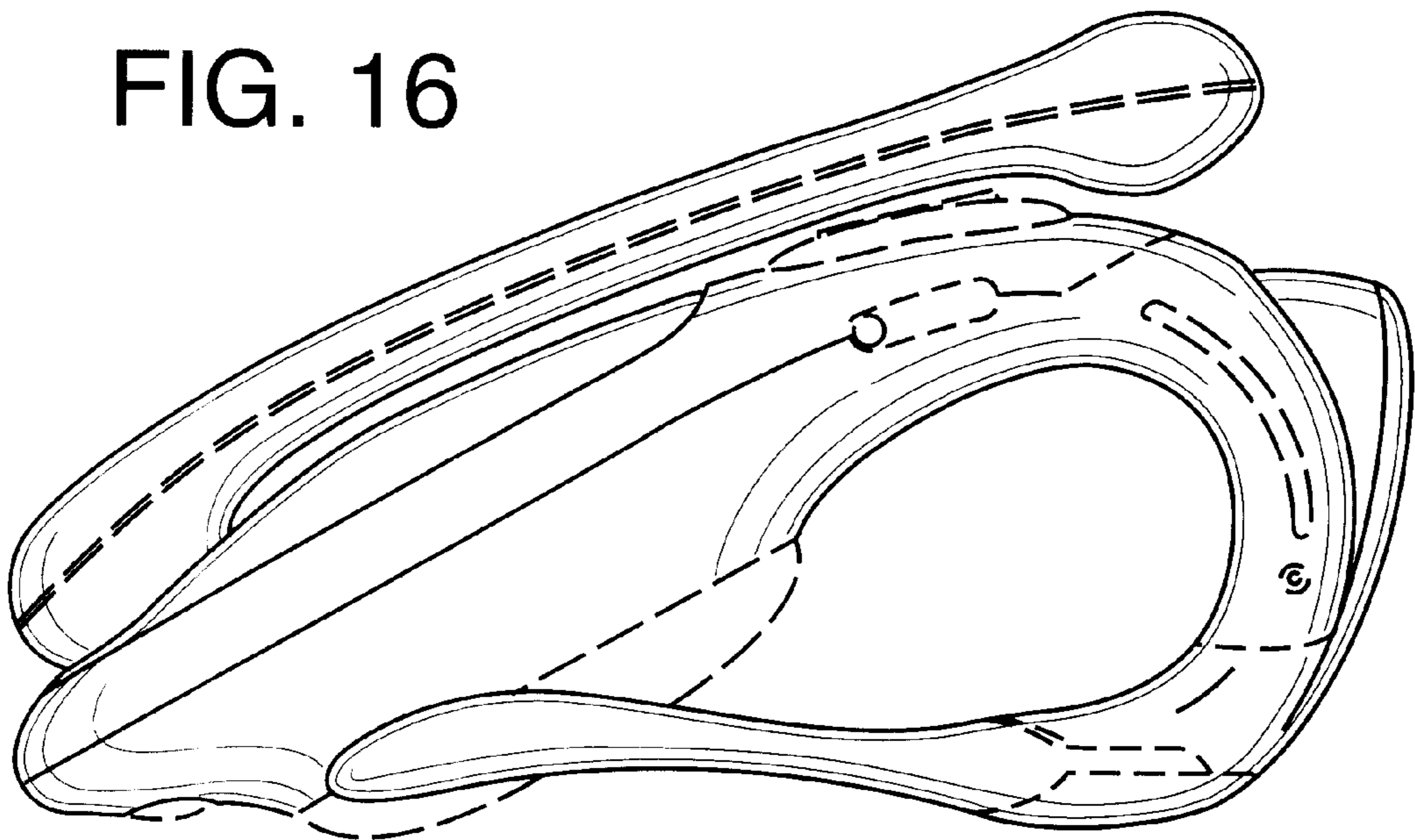

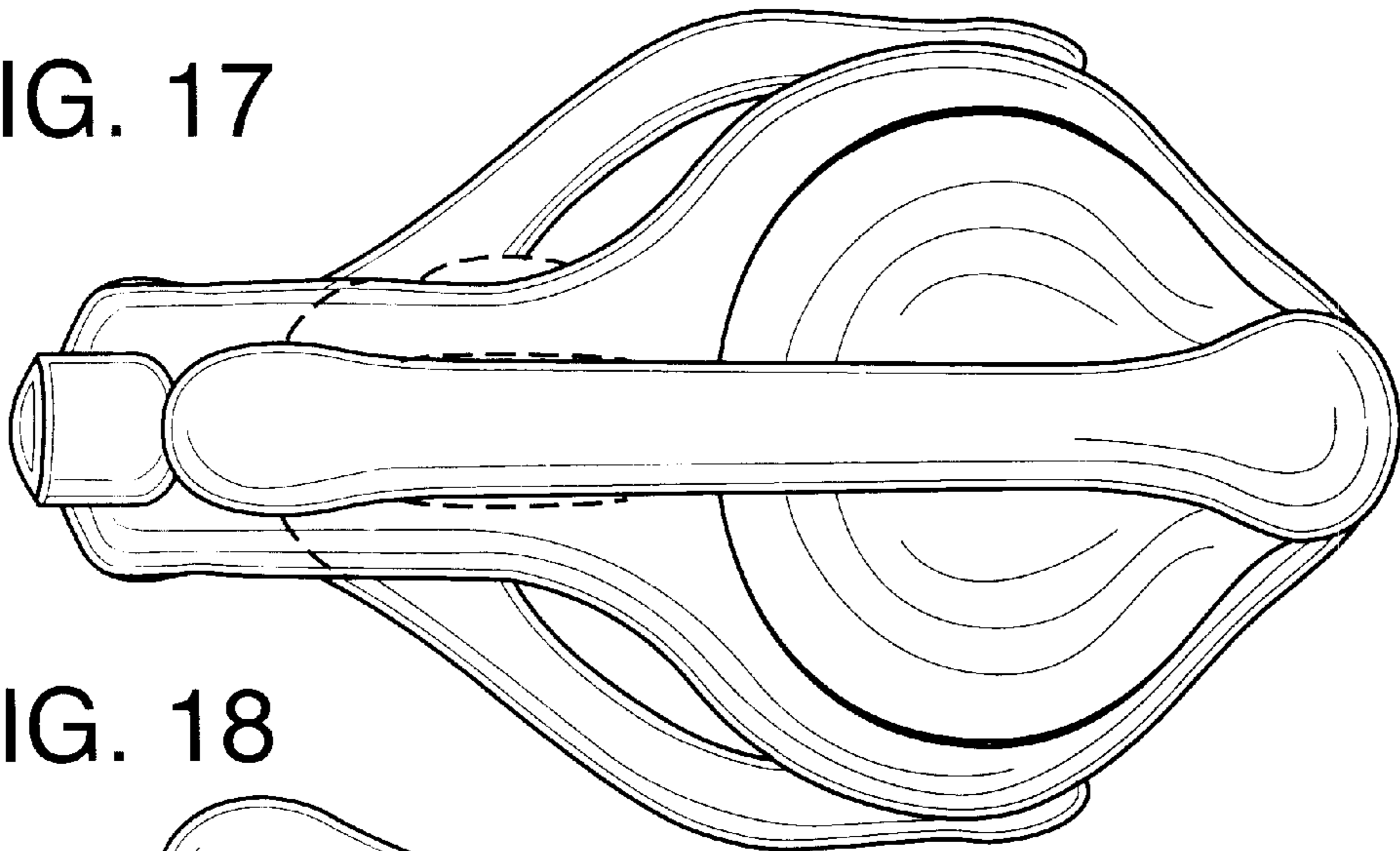

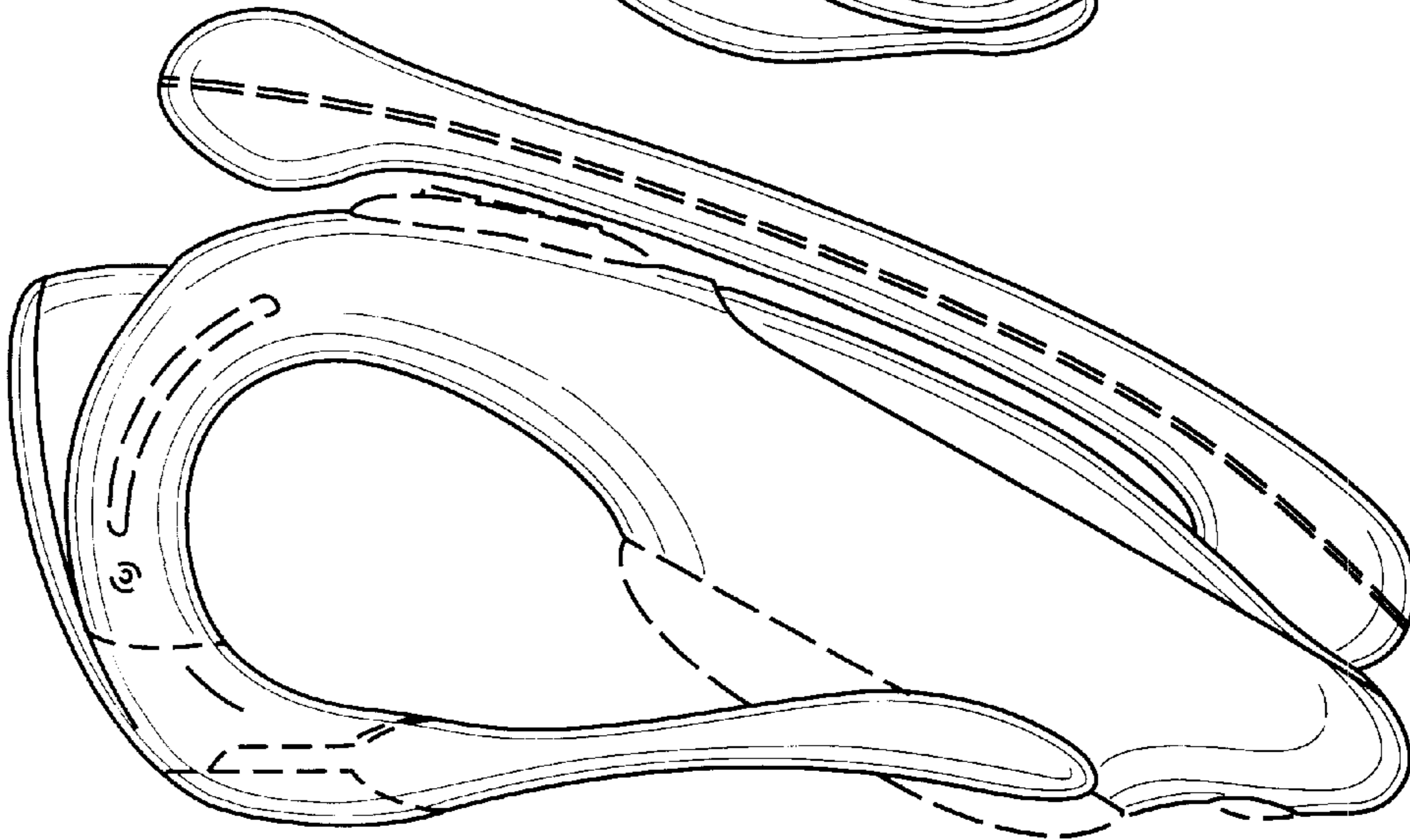
