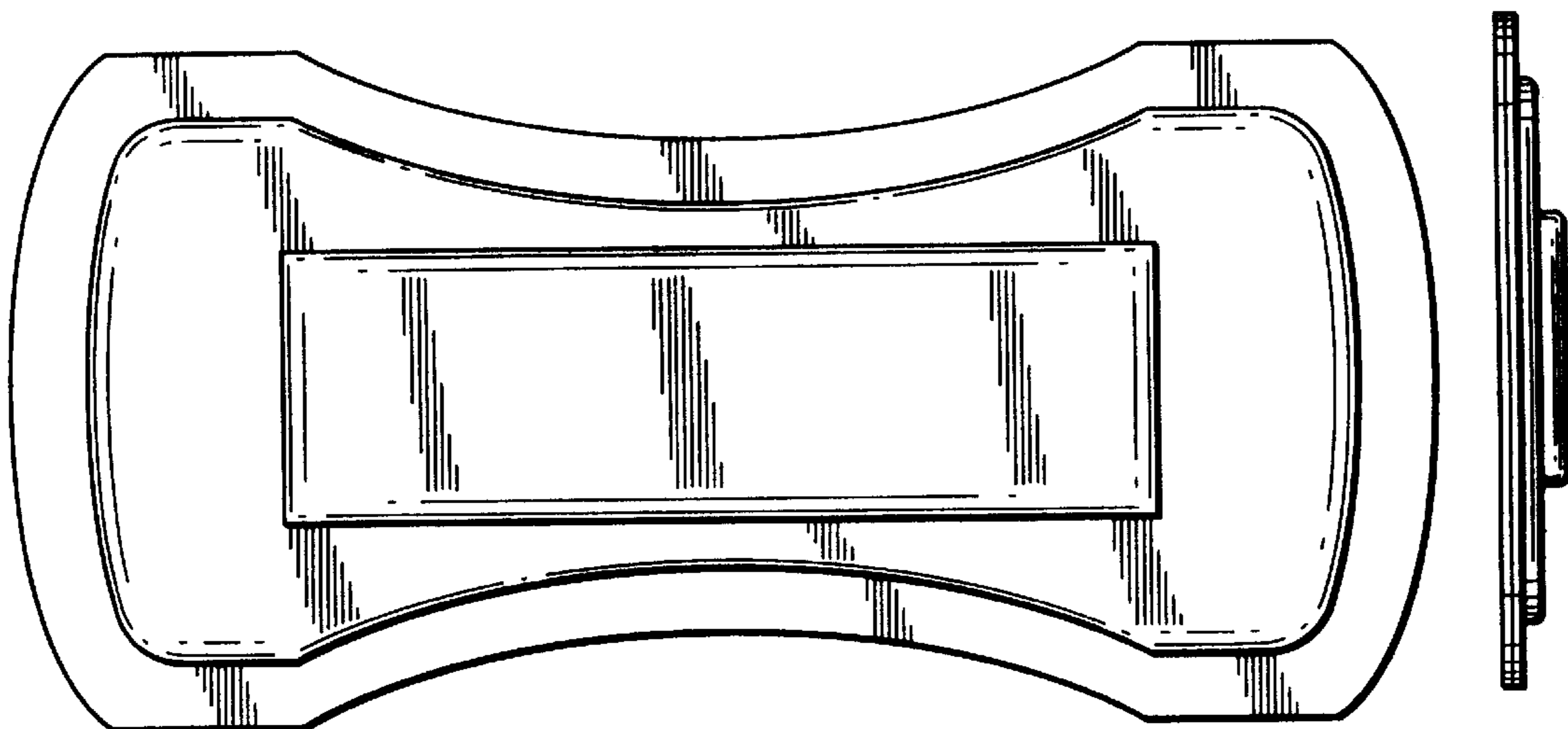
(57) **CLAIM**

We claim the ornamental design for a supplement insert pad for absorbent garments with liquid delay layer, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a supplemental insert pad for absorbent garments with liquid delay layer.
 FIG. 2 is a front elevation view of a supplemental insert pad for absorbent garments with liquid delay layer.
 FIG. 3 is a rear elevation view of a supplemental insert pad for absorbent garments with liquid delay layer.
 FIG. 4 is a bottom plan view of a supplemental insert pad for absorbent garments with liquid delay layer.
 FIG. 5 is a left side elevation view of a supplemental insert pad for absorbent garments with liquid delay layer; and,
 FIG. 6 is a right side elevation view of a supplemental insert pad for absorbent garments with liquid delay layer.

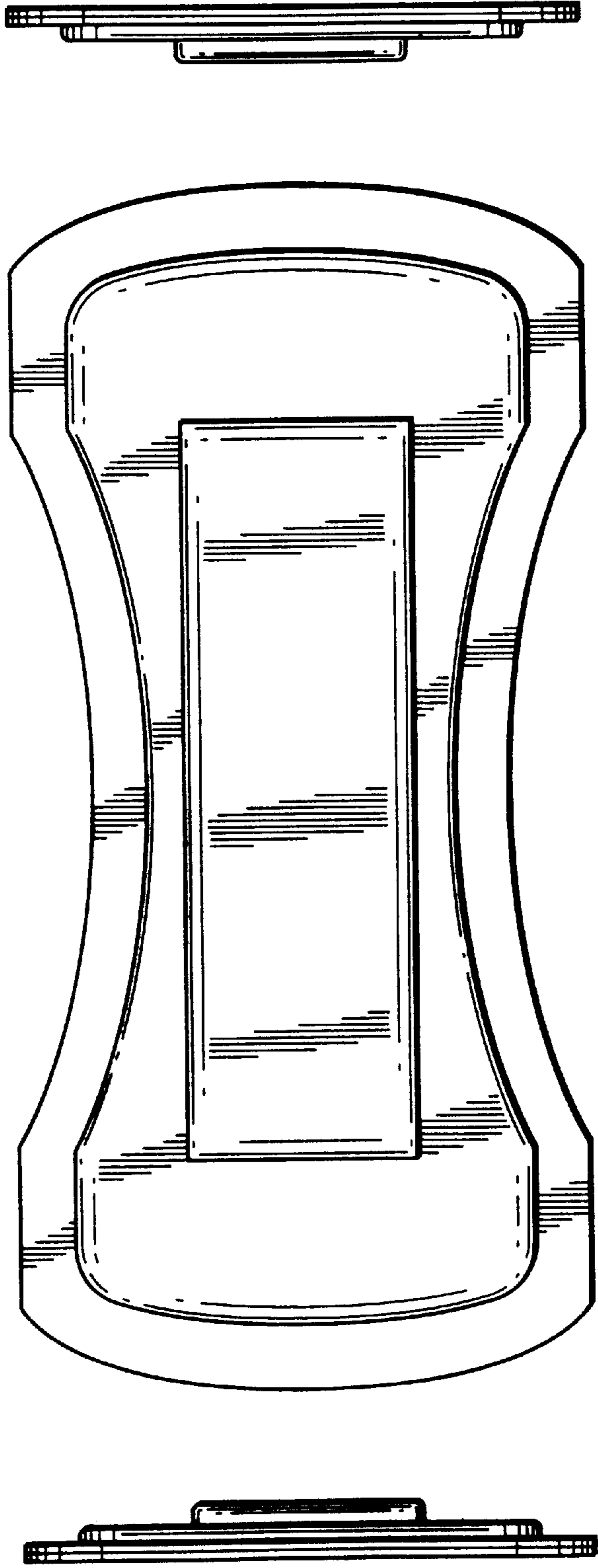
