(57) **CLAIM**

The ornamental design for a portfolio, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a portfolio showing my new design, the emblem/latch shown in phantom lines does not form latch part of my design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a right side elevational view thereof, the left side elevational view being the mirror image;

FIG. 4 is a rear plan view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a enlarged view of the area indicated in FIG. 6 showing the surface pattern;

FIG. 8 is a perspective view of an alternative embodiment of a portfolio showing my new design, the emblem/latch shown in phantom lines does not form part of my design;

FIG. 9 is a front elevational view of the embodiment of FIG. 8;

FIG. 10 is a right side elevational view of the embodiment of FIG. 8, the left side elevational view being the mirror image thereof;

FIG. 11 is a rear elevational view of the embodiment of FIG. 8;

FIG. 12 is a top plan view of the embodiment of FIG. 8;

FIG. 13 is a bottom plan view of the embodiment of FIG. 8; and,

FIG. 14 is an enlarged view of the area indicated in FIG. 13 showing the surface pattern.

The broken line showings of the interior structure are for illustrative purposes only and form no part of the claimed design.

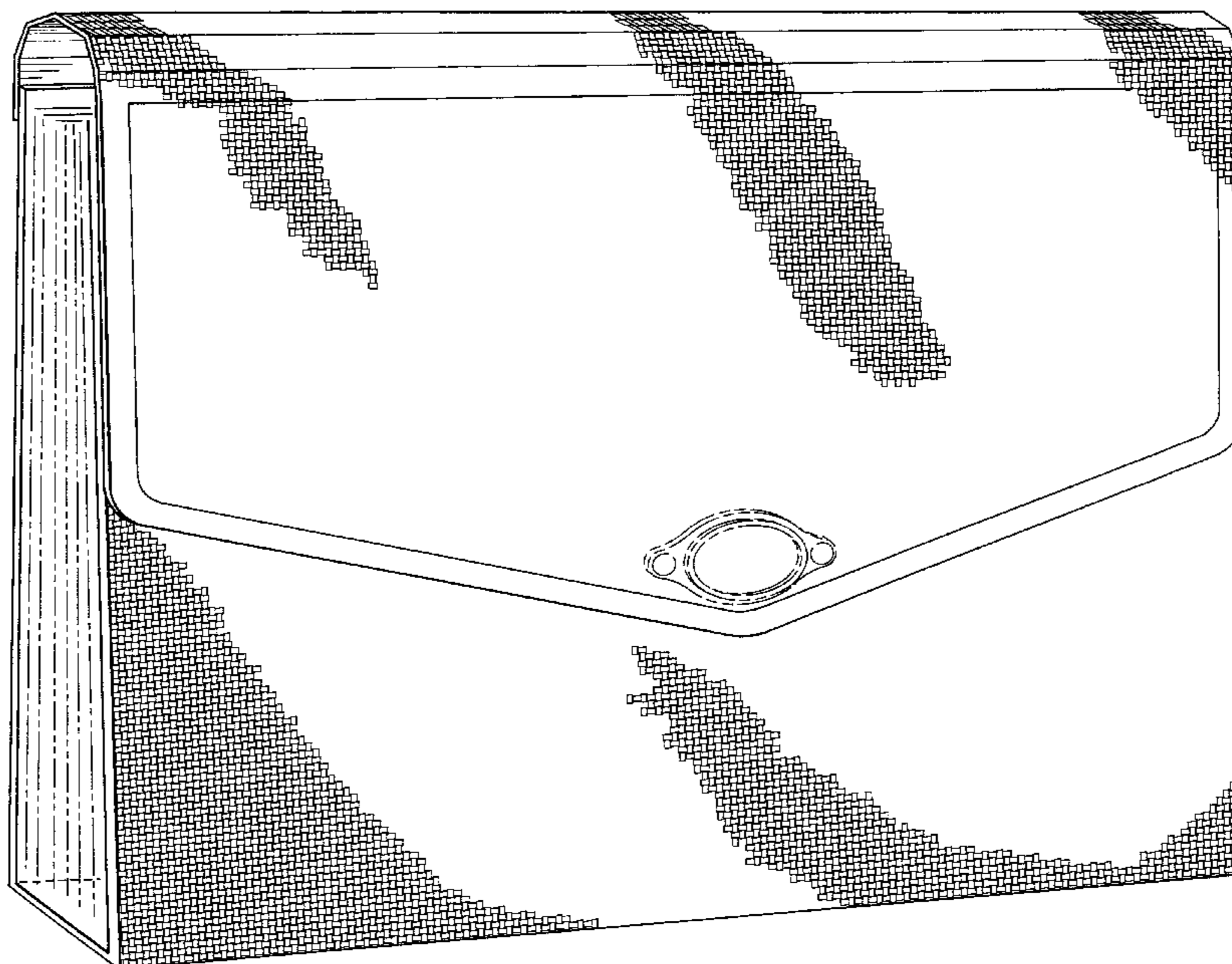

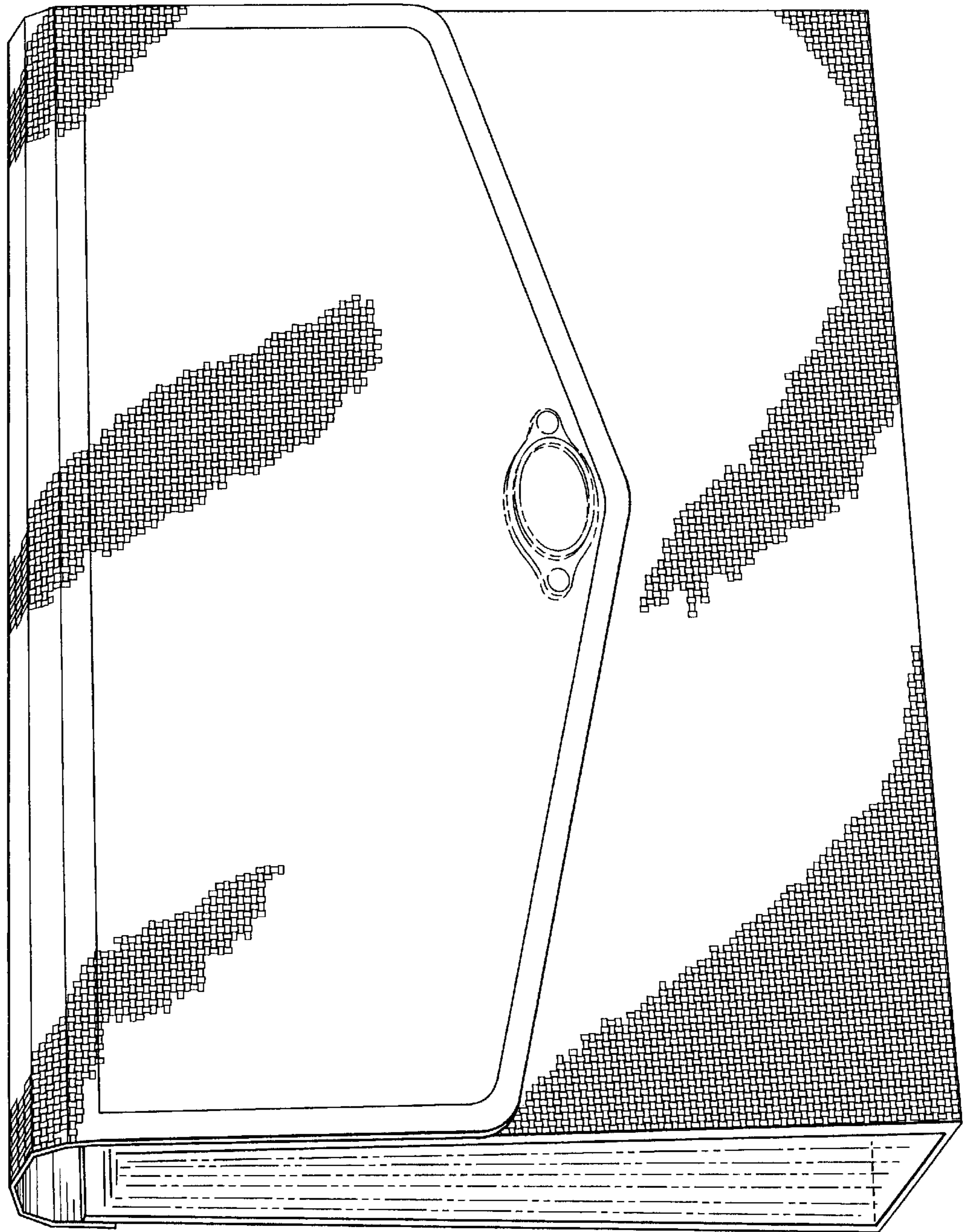

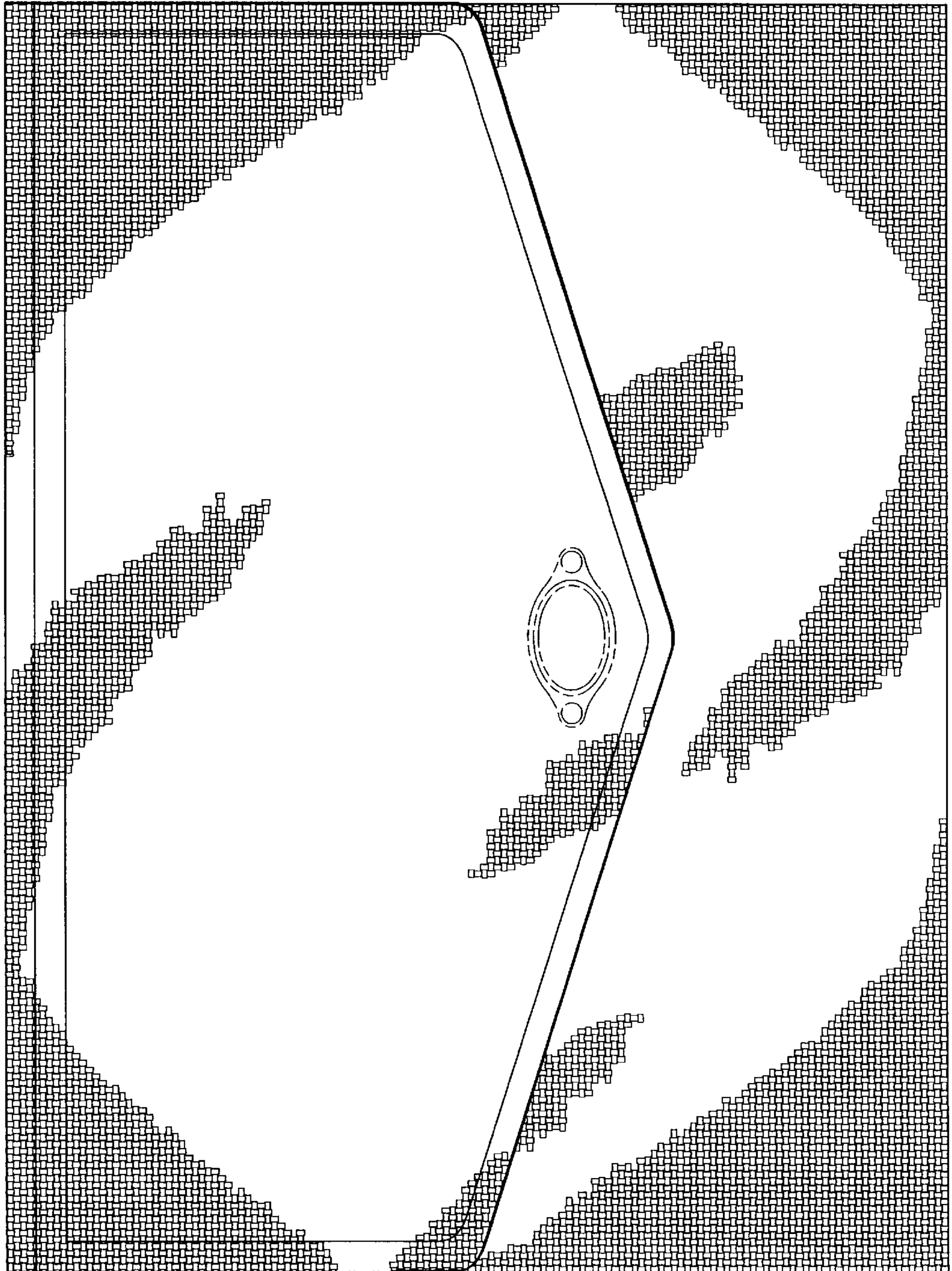

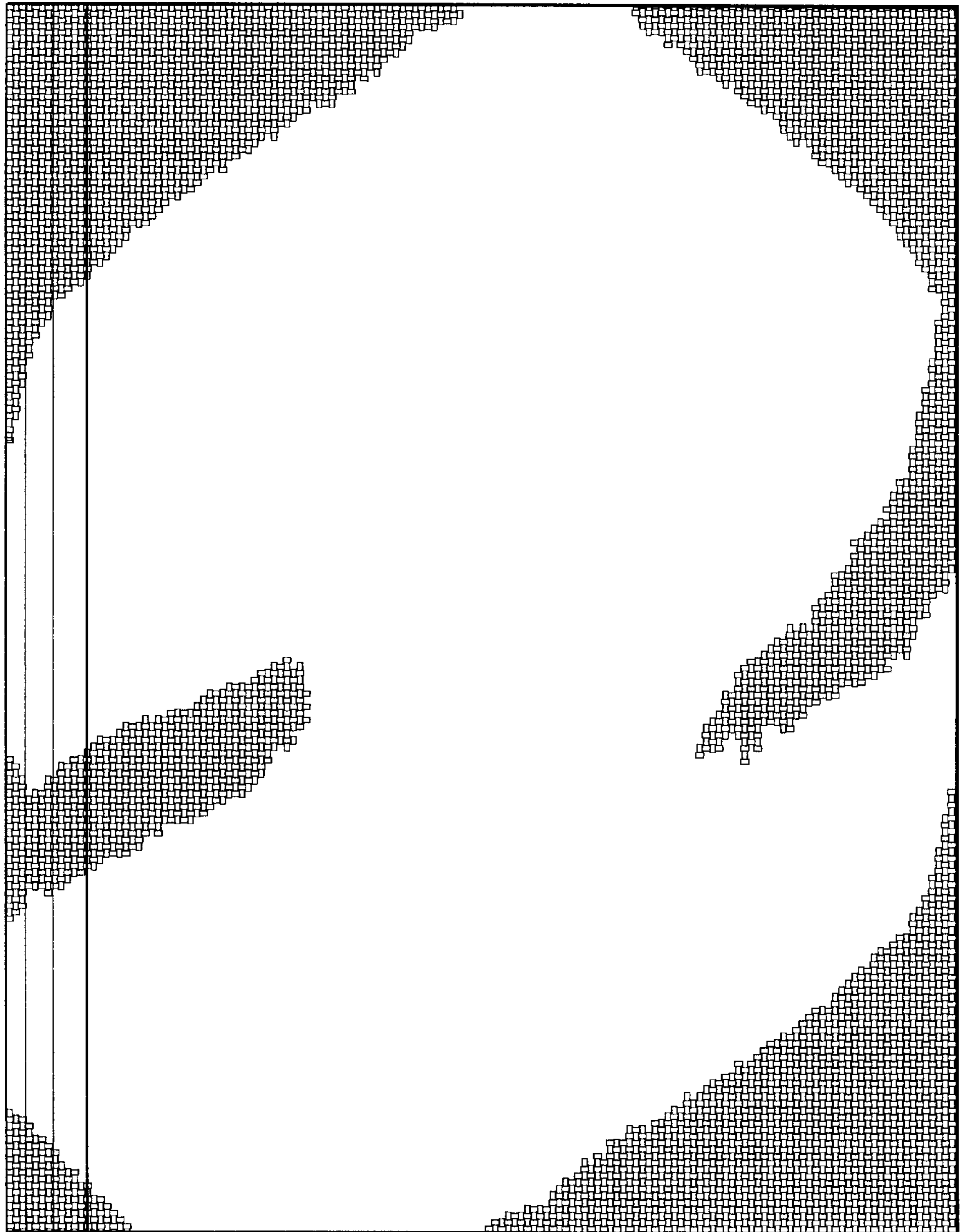

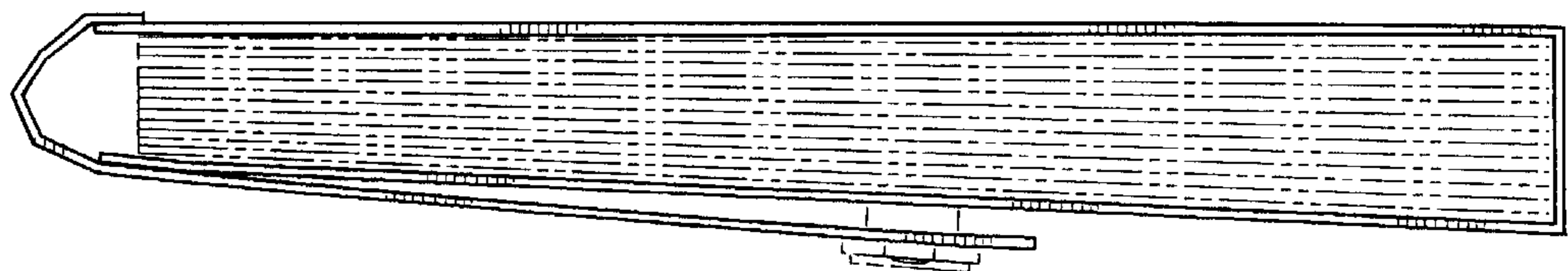

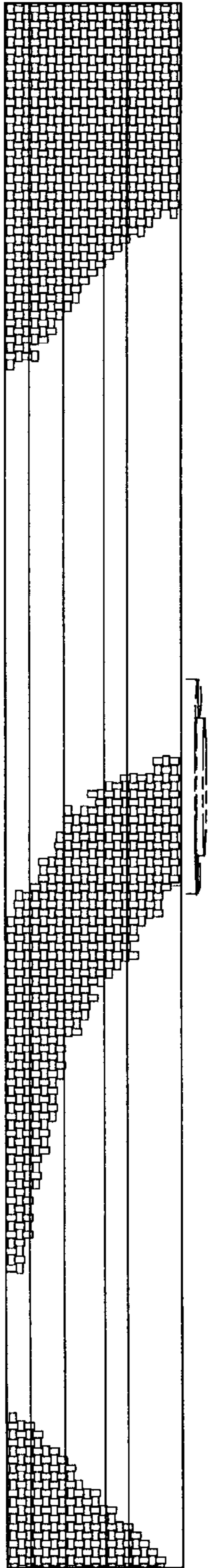

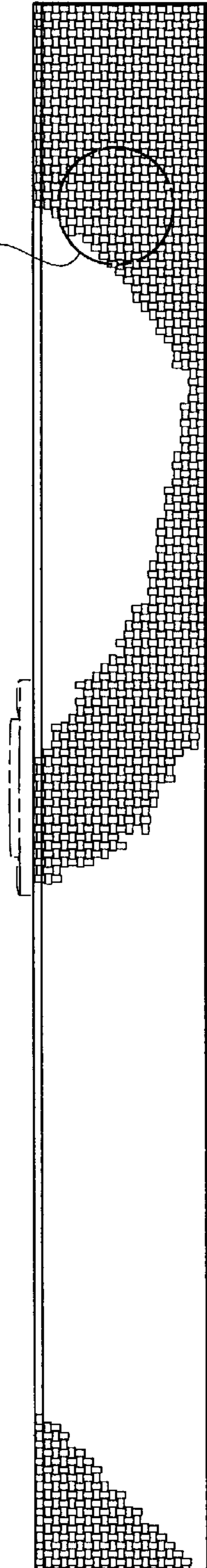

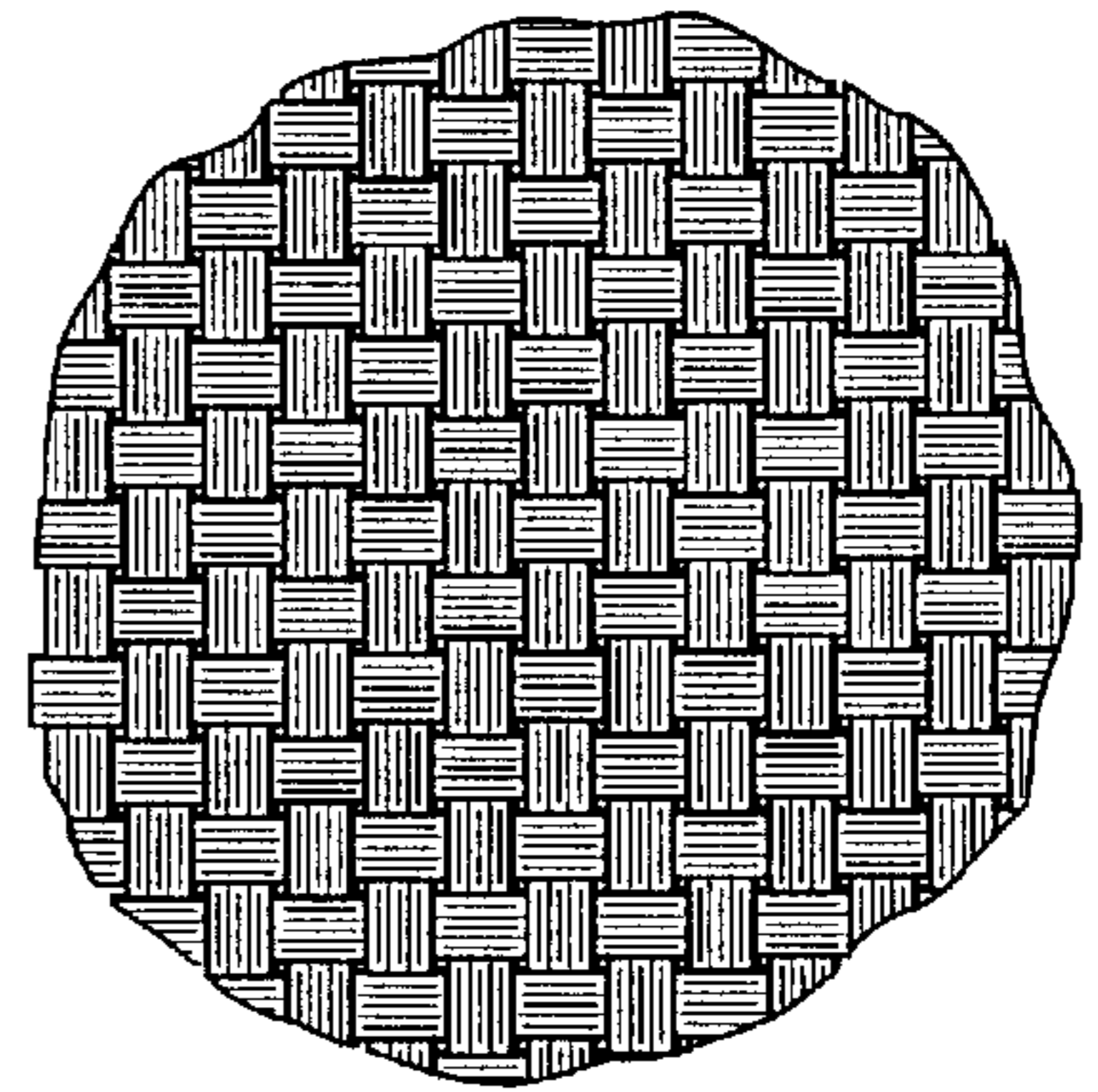

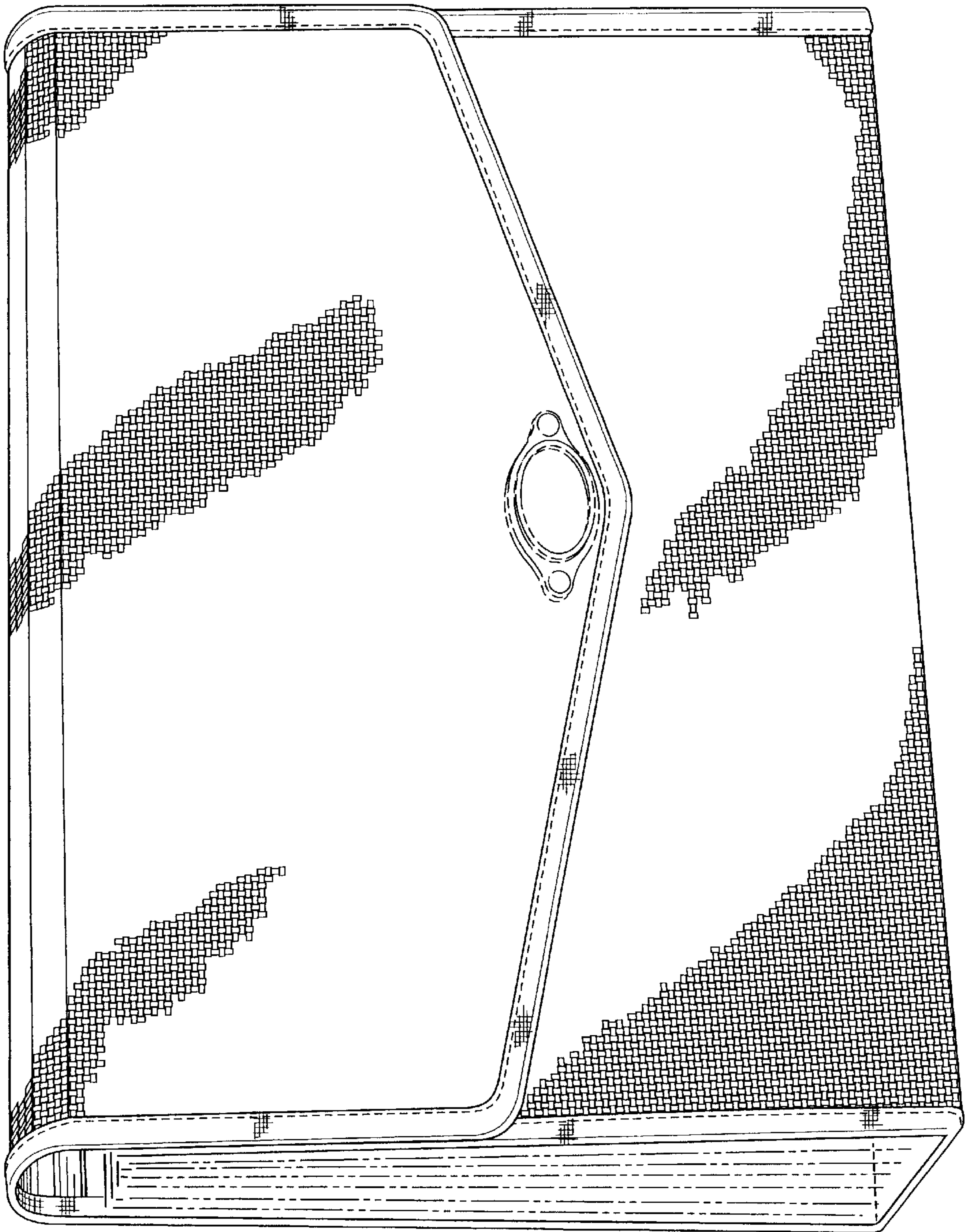

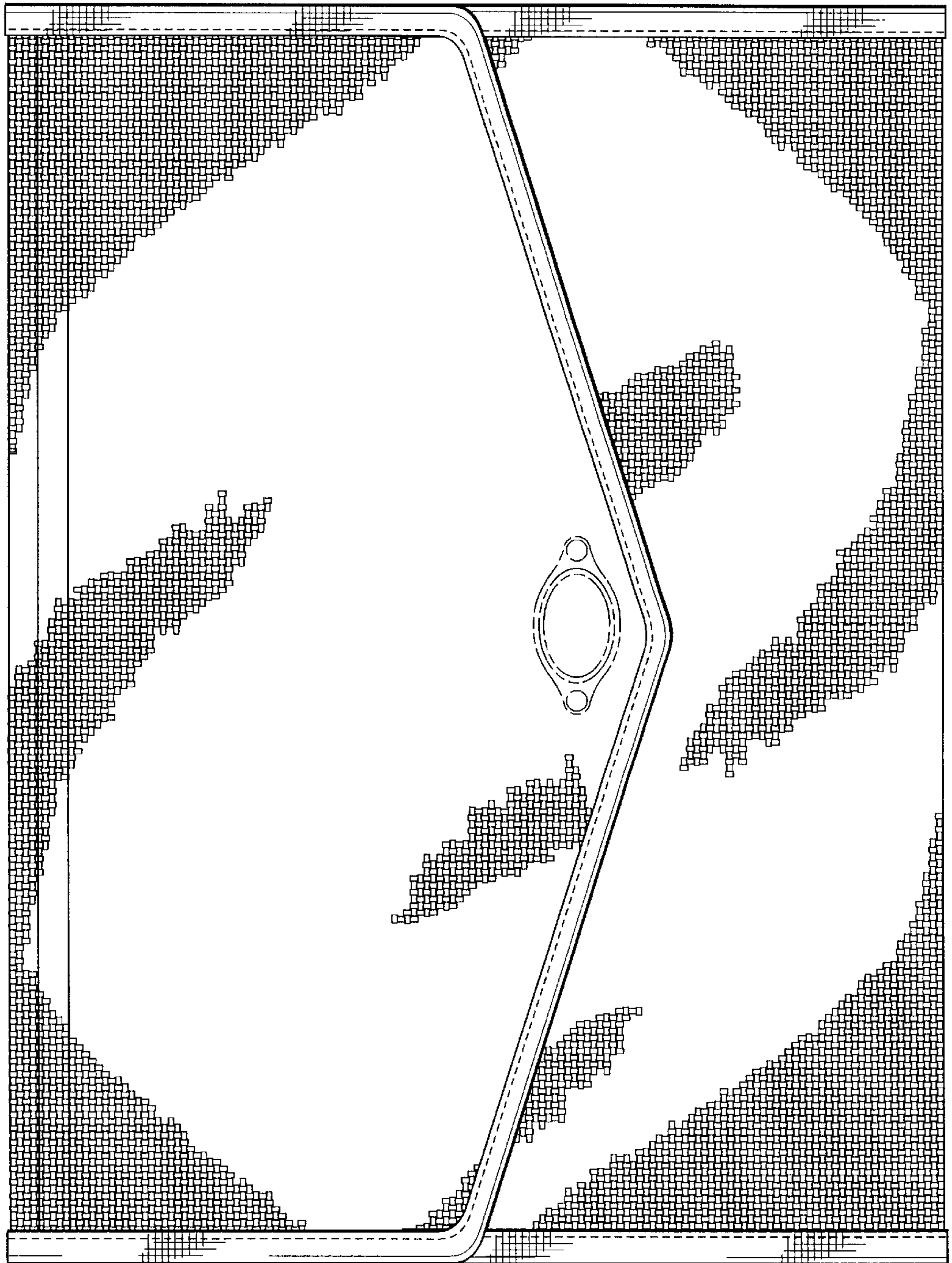

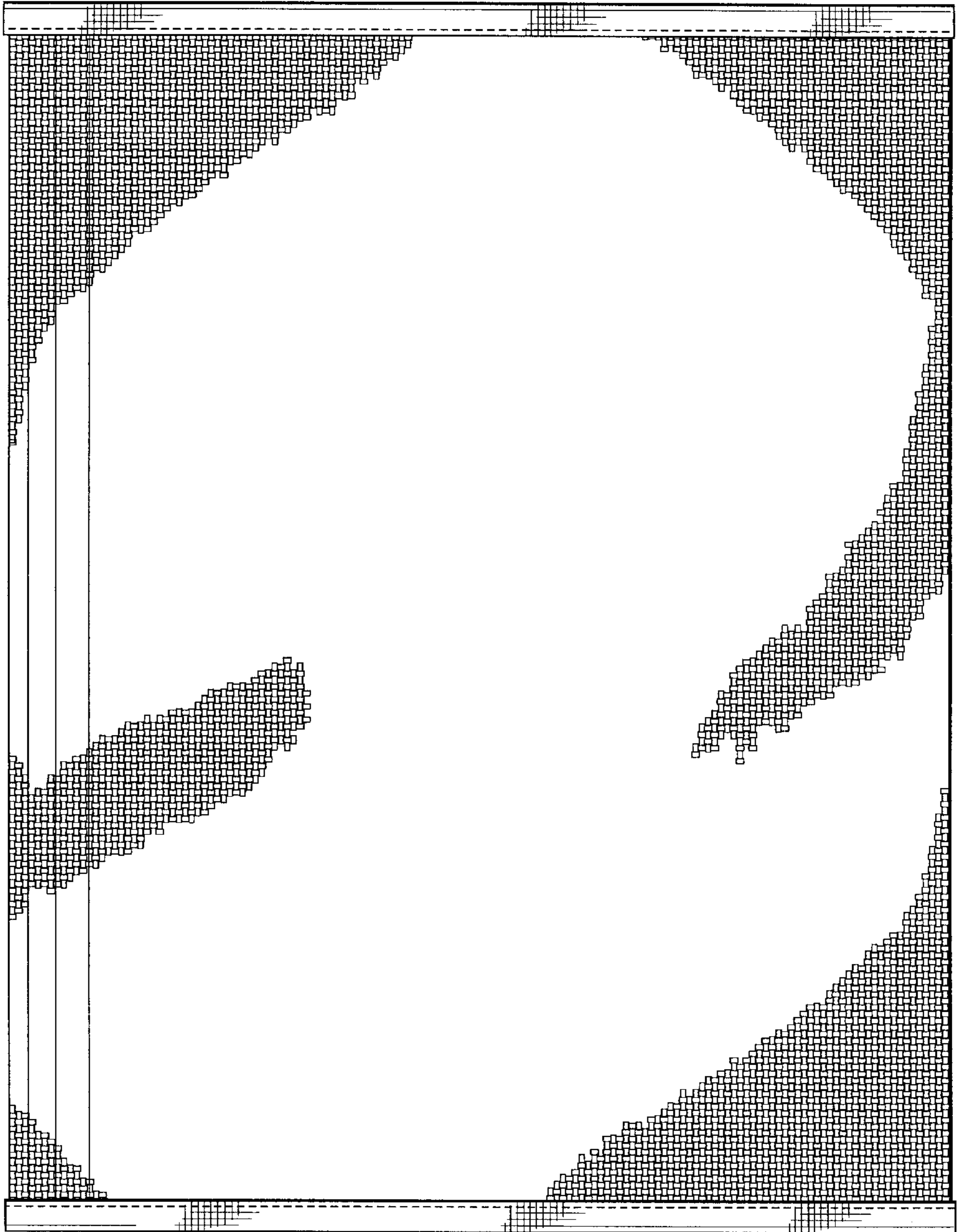

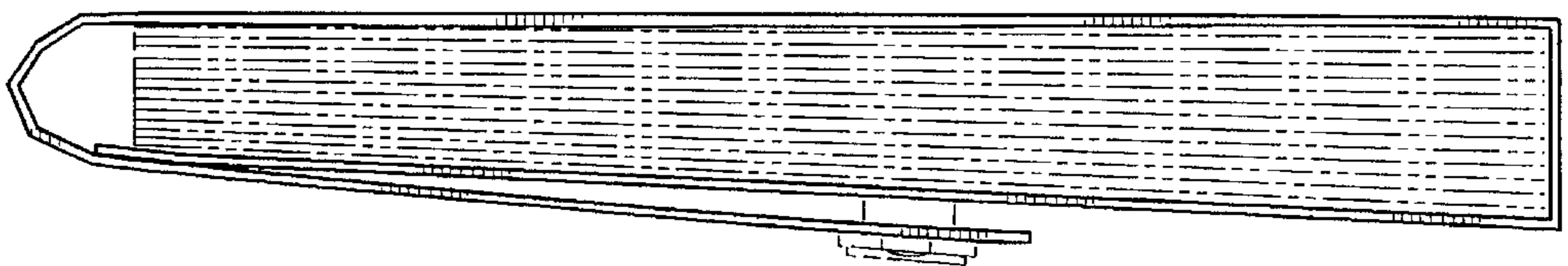

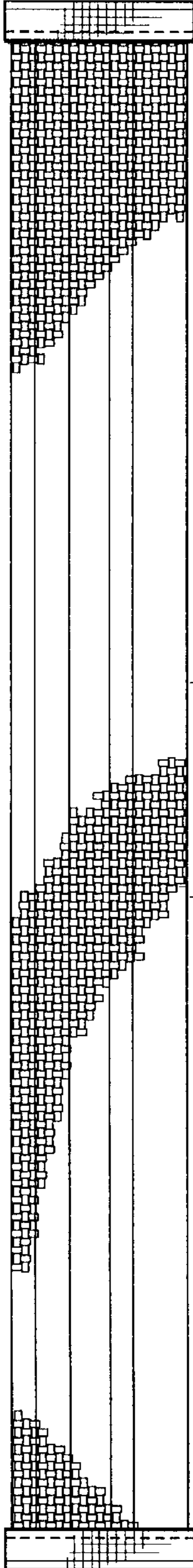

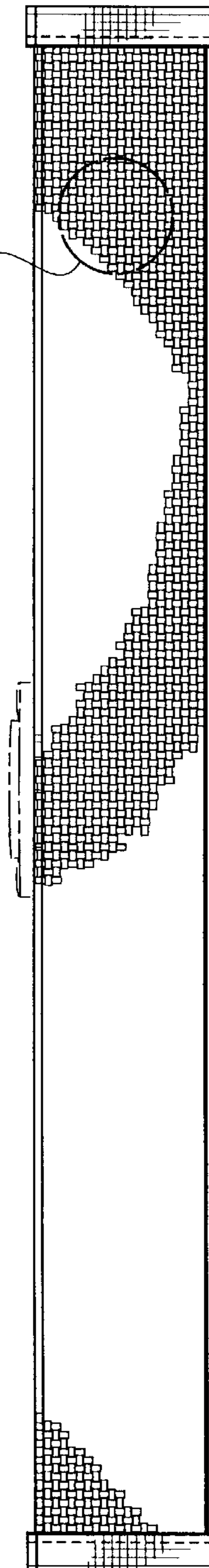
