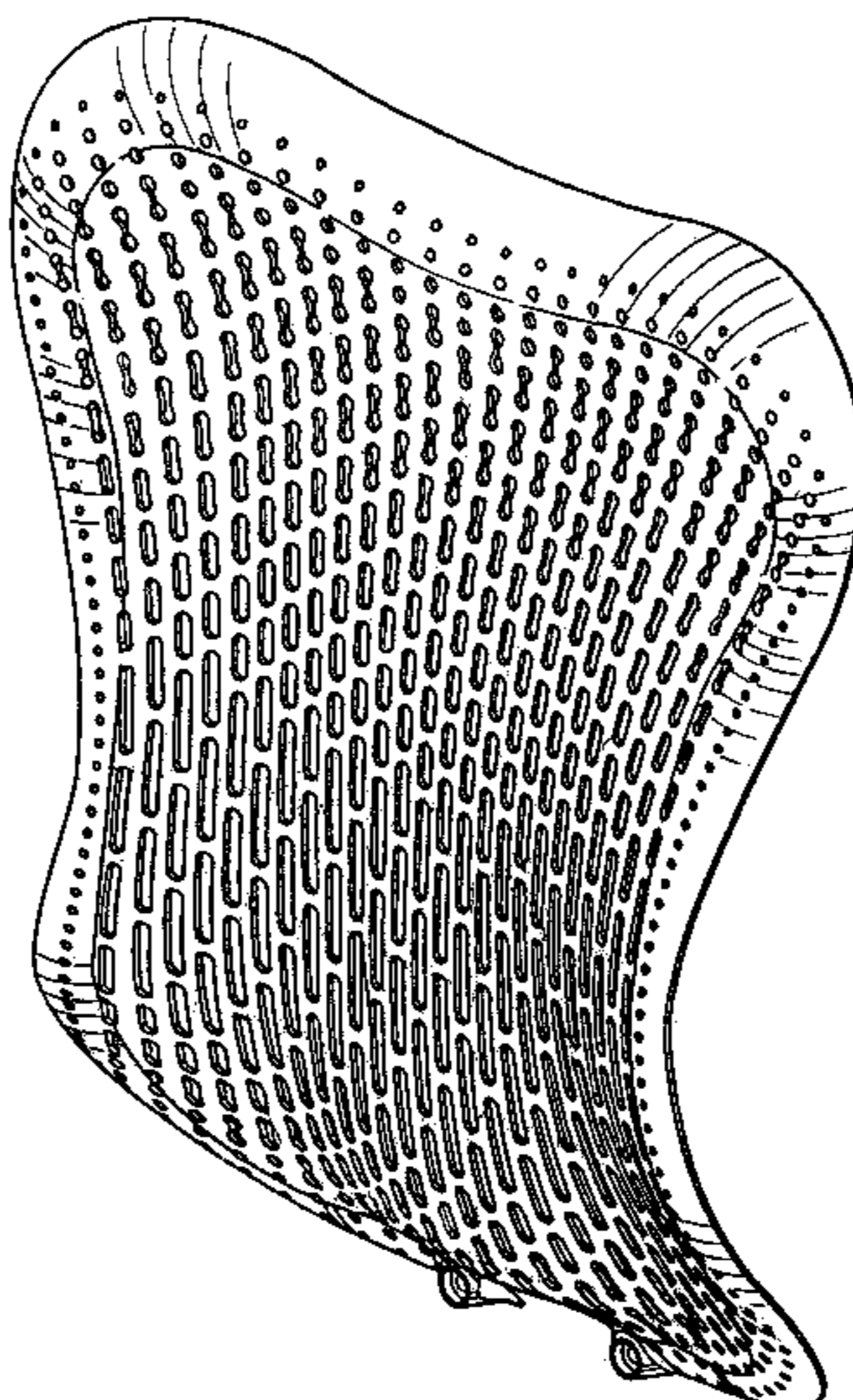
(57) **CLAIM**

The ornamental design for a back for a seating structure, as shown and described.

DESCRIPTION

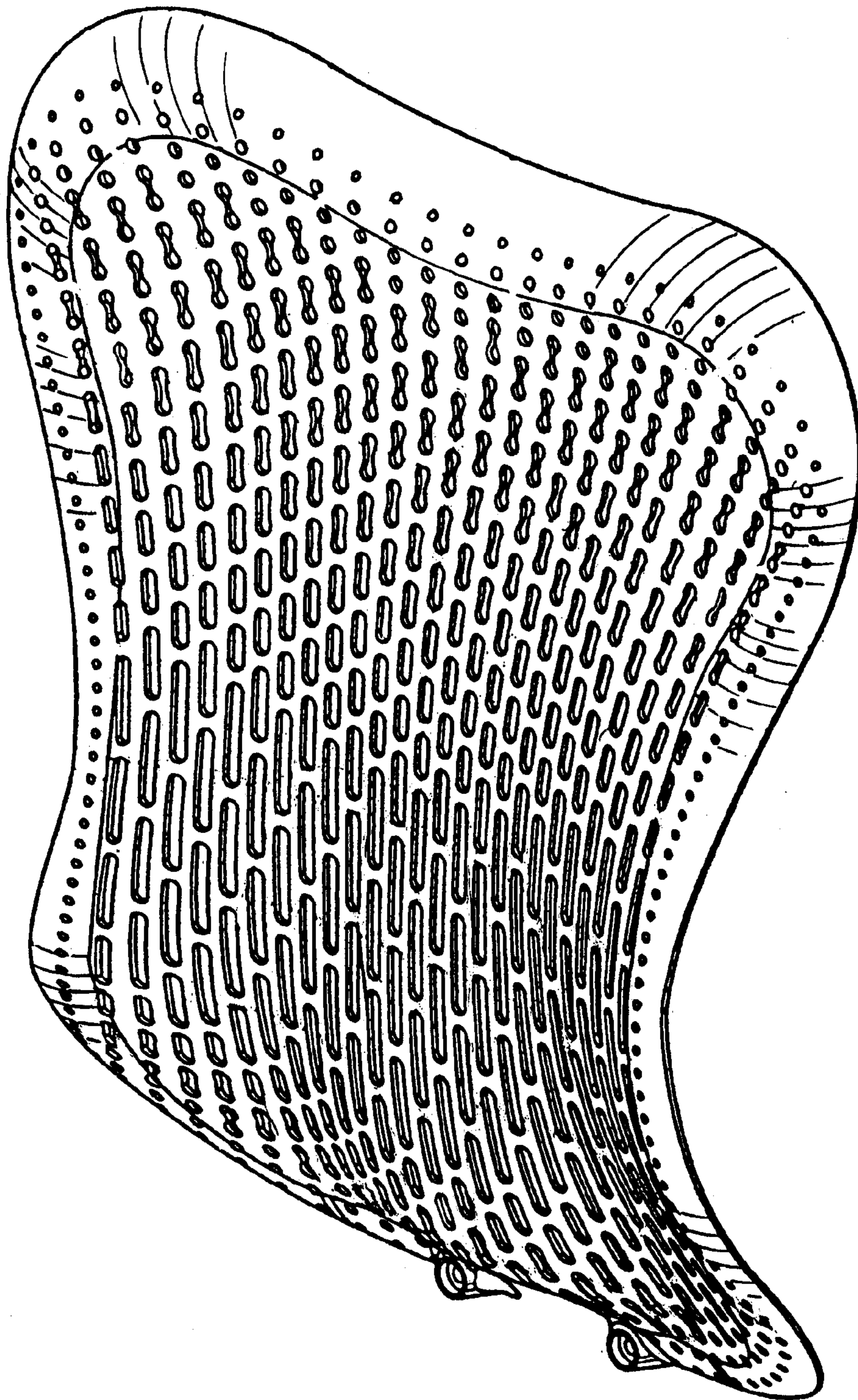

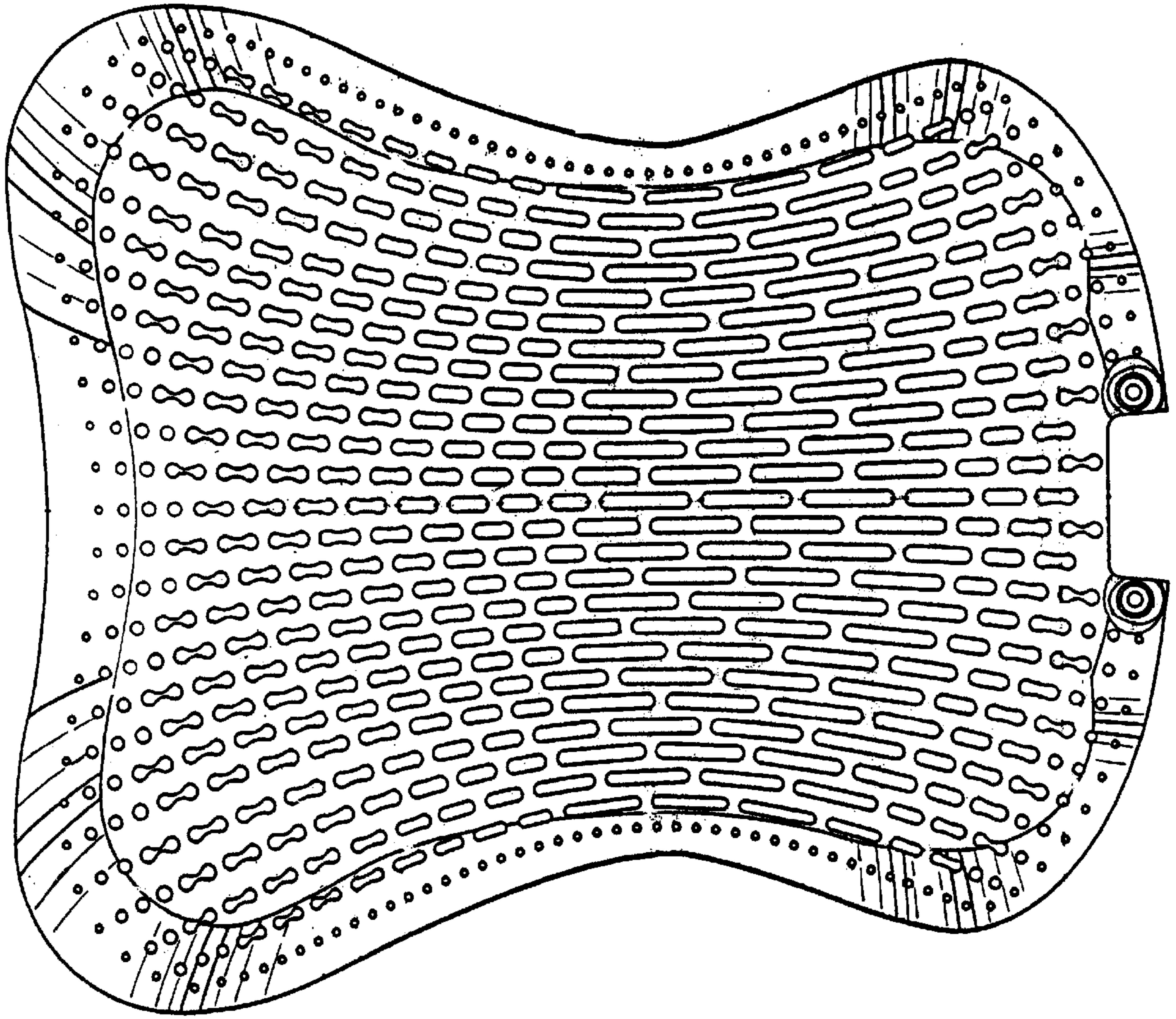

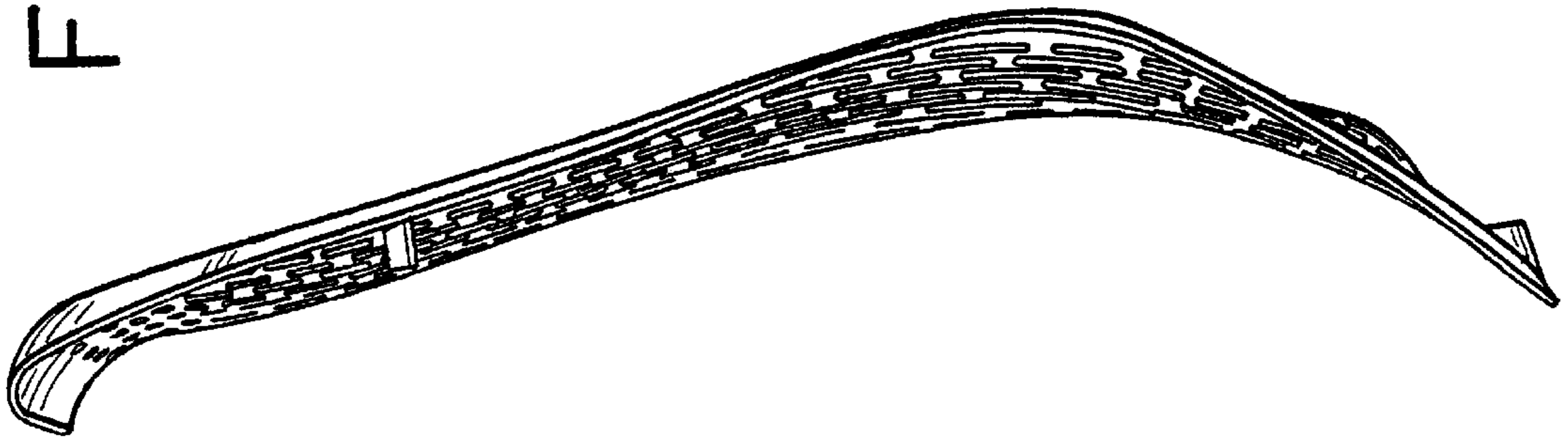

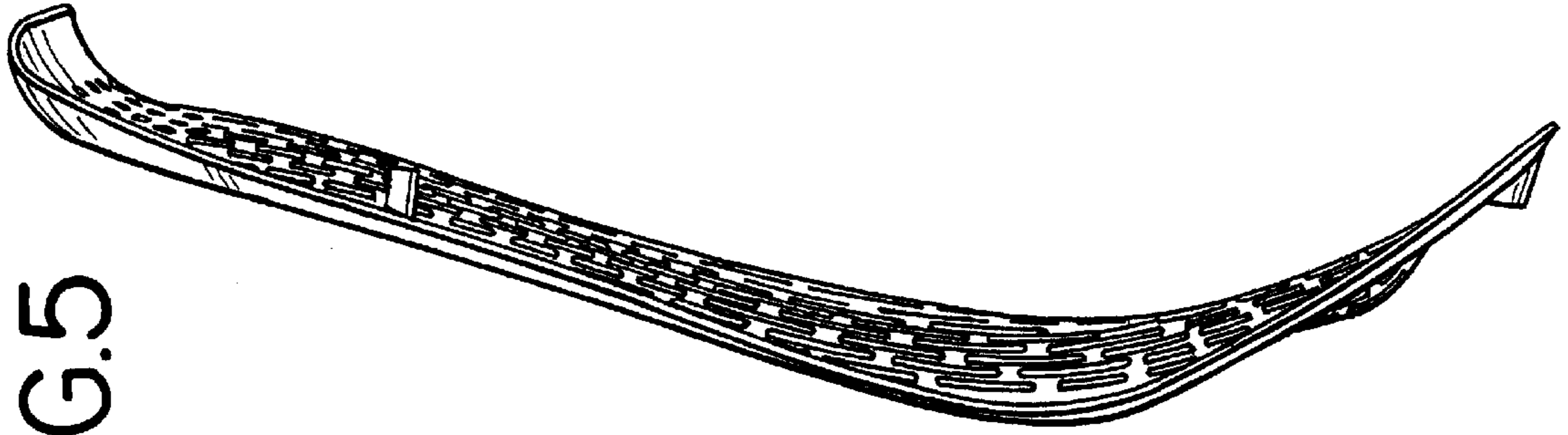

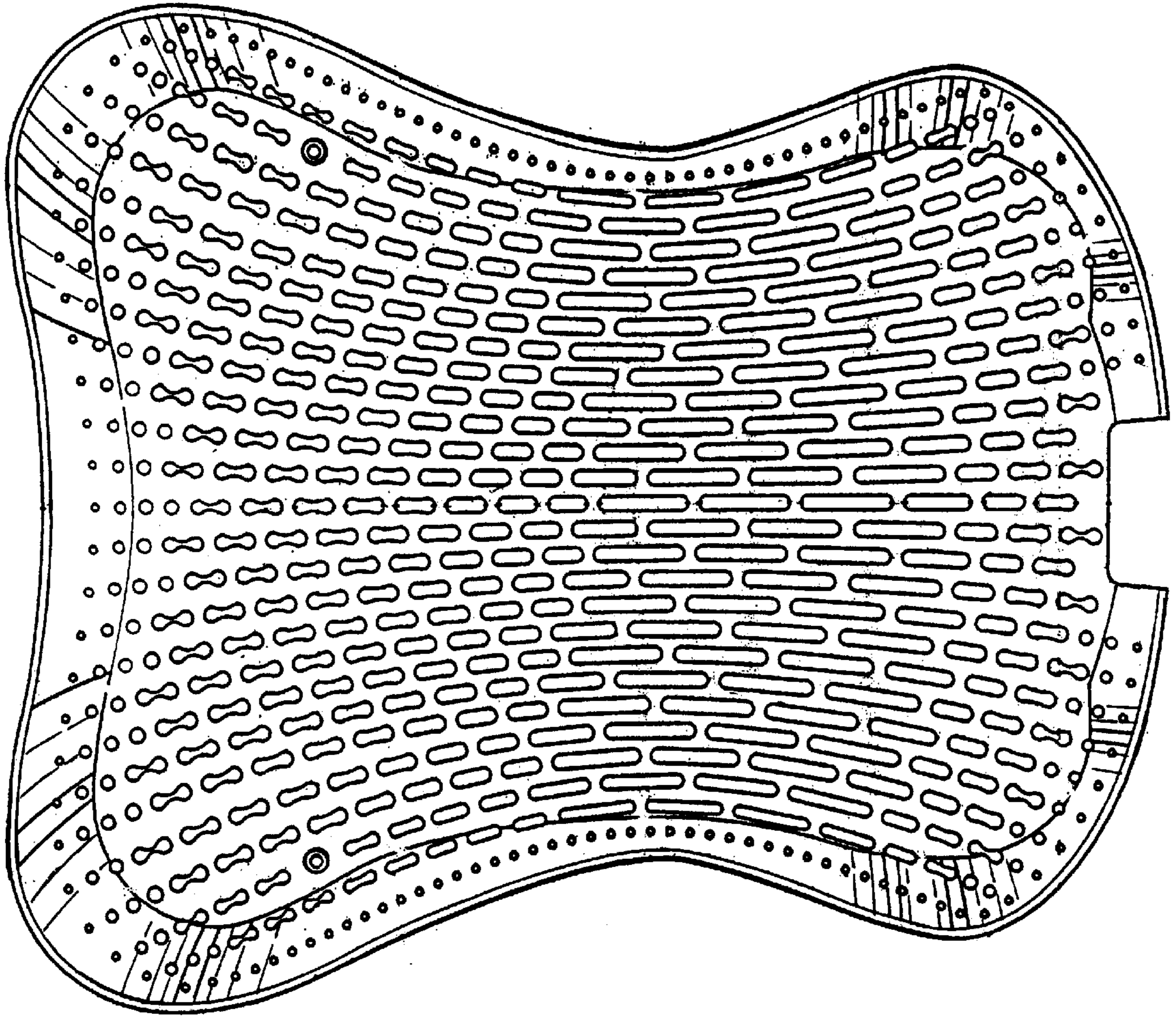

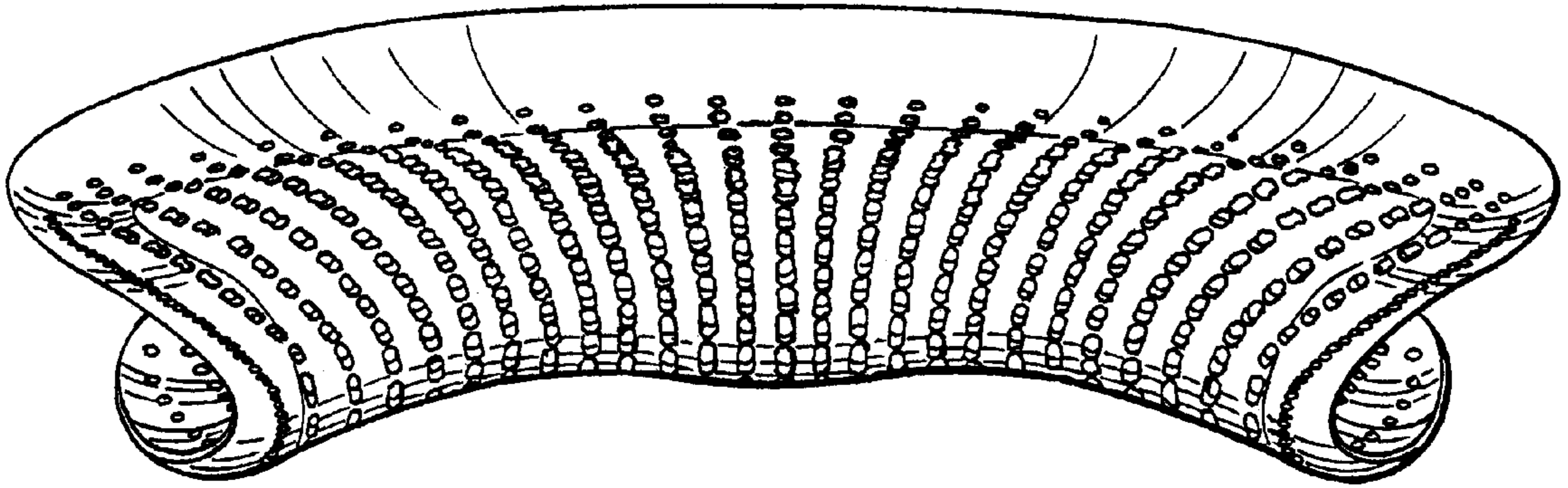
