FIG. 4 is a front elevational view thereof in a reduced scale;

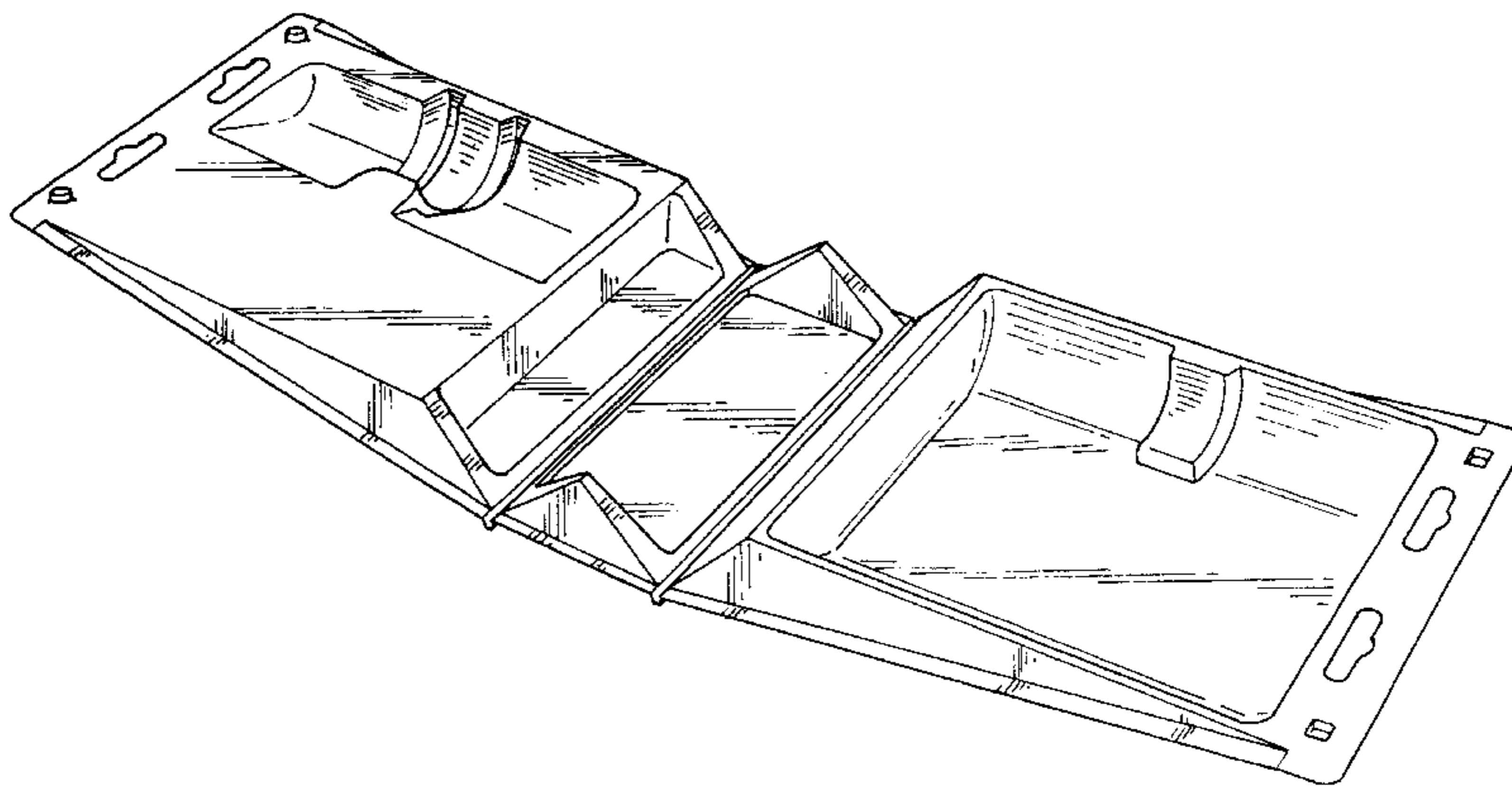
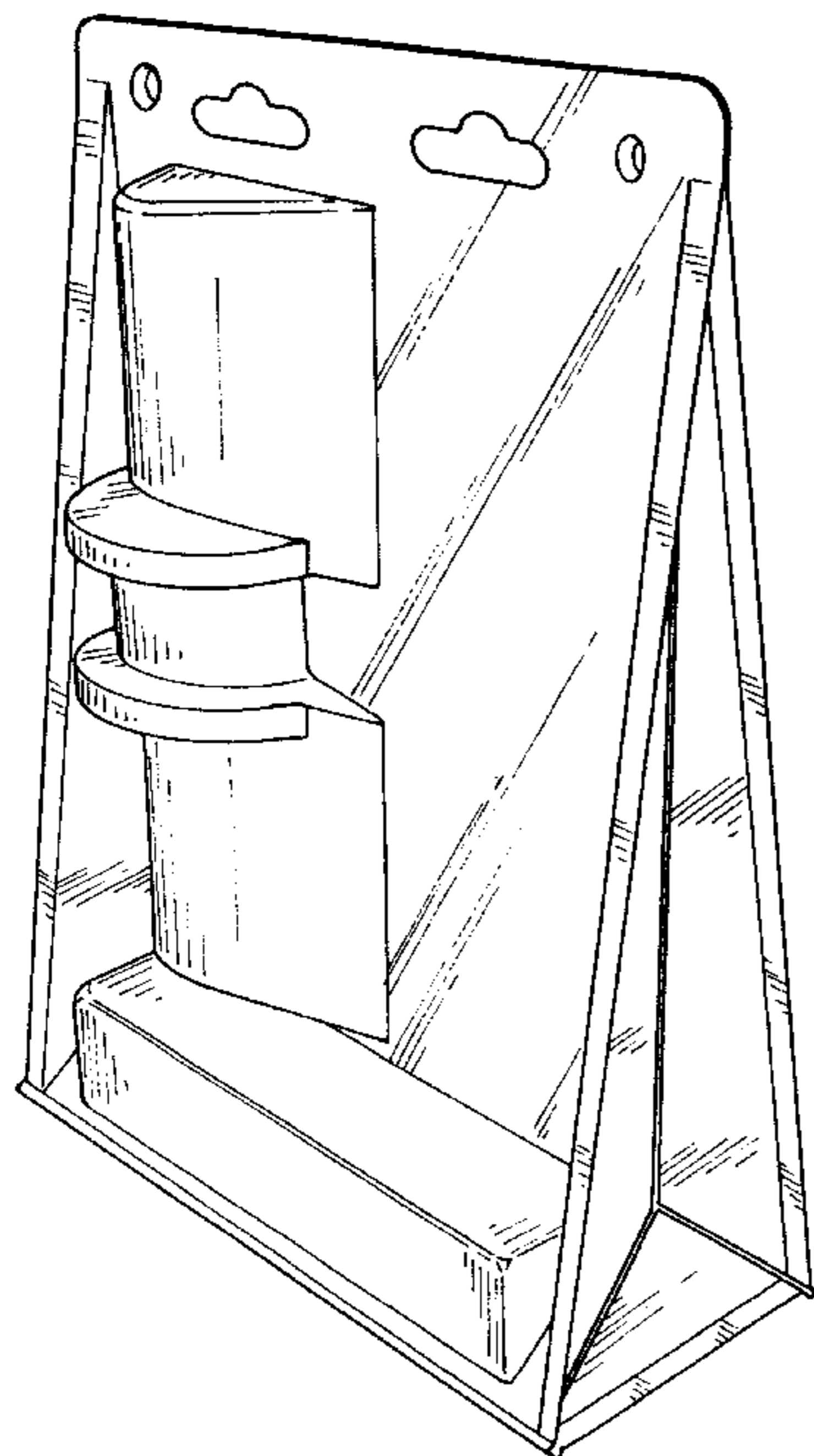
FIG. 5 is a bottom plan view thereof in a reduced scale;

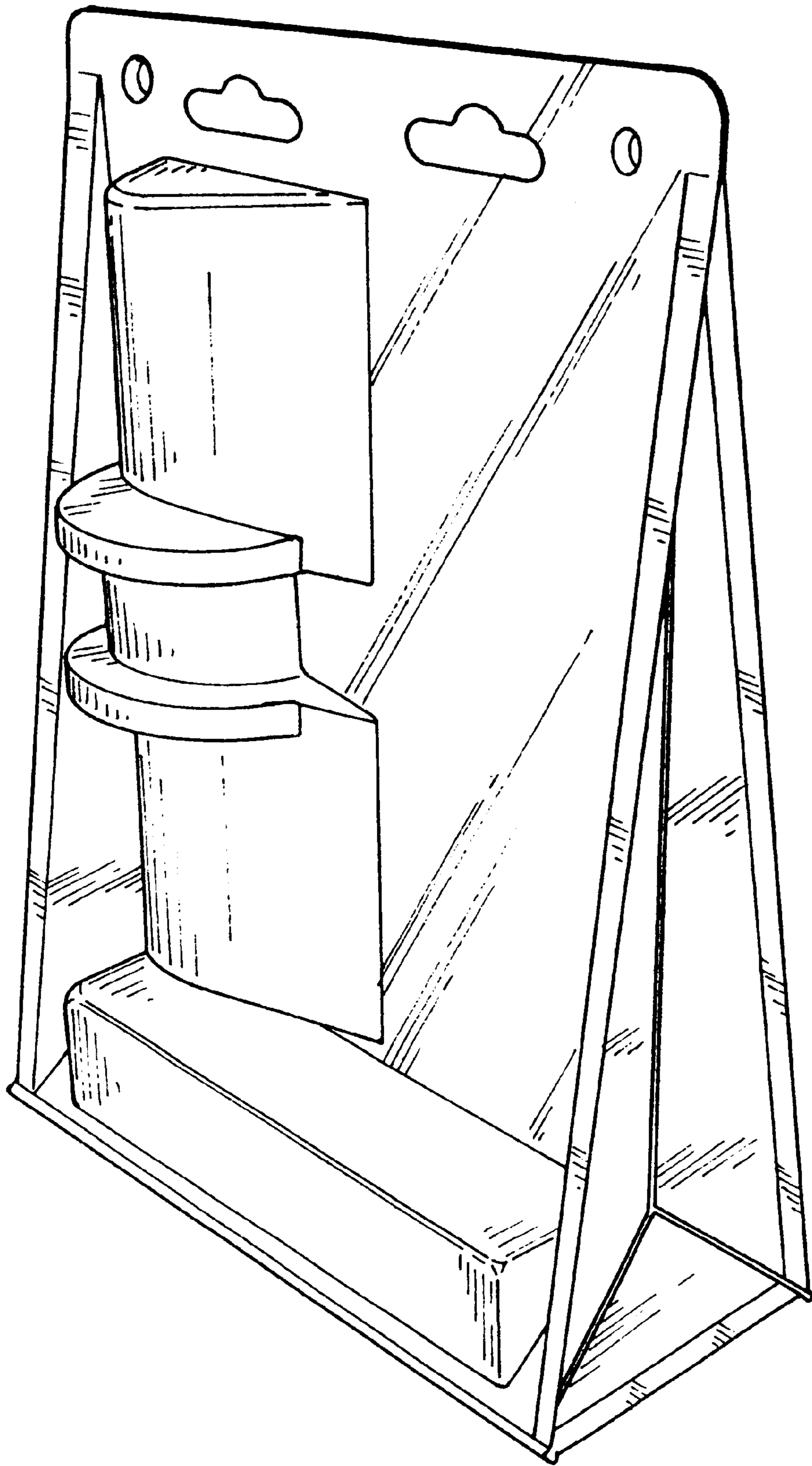
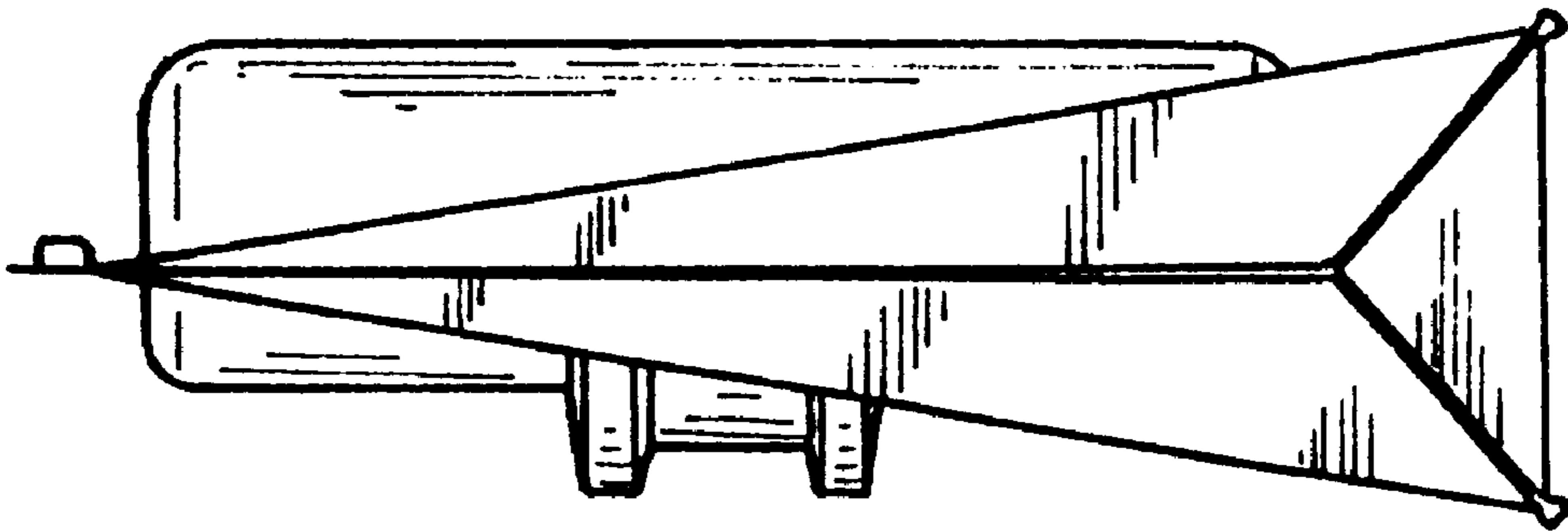
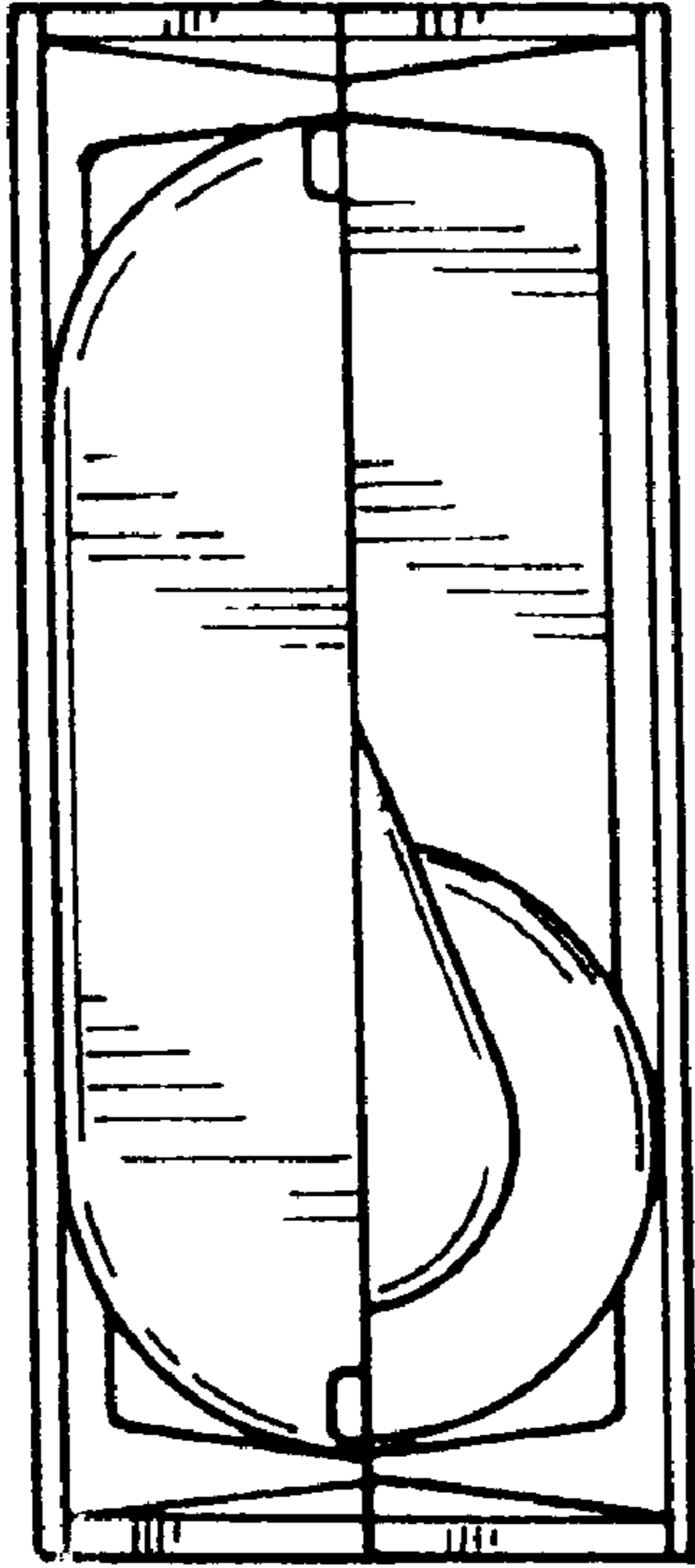


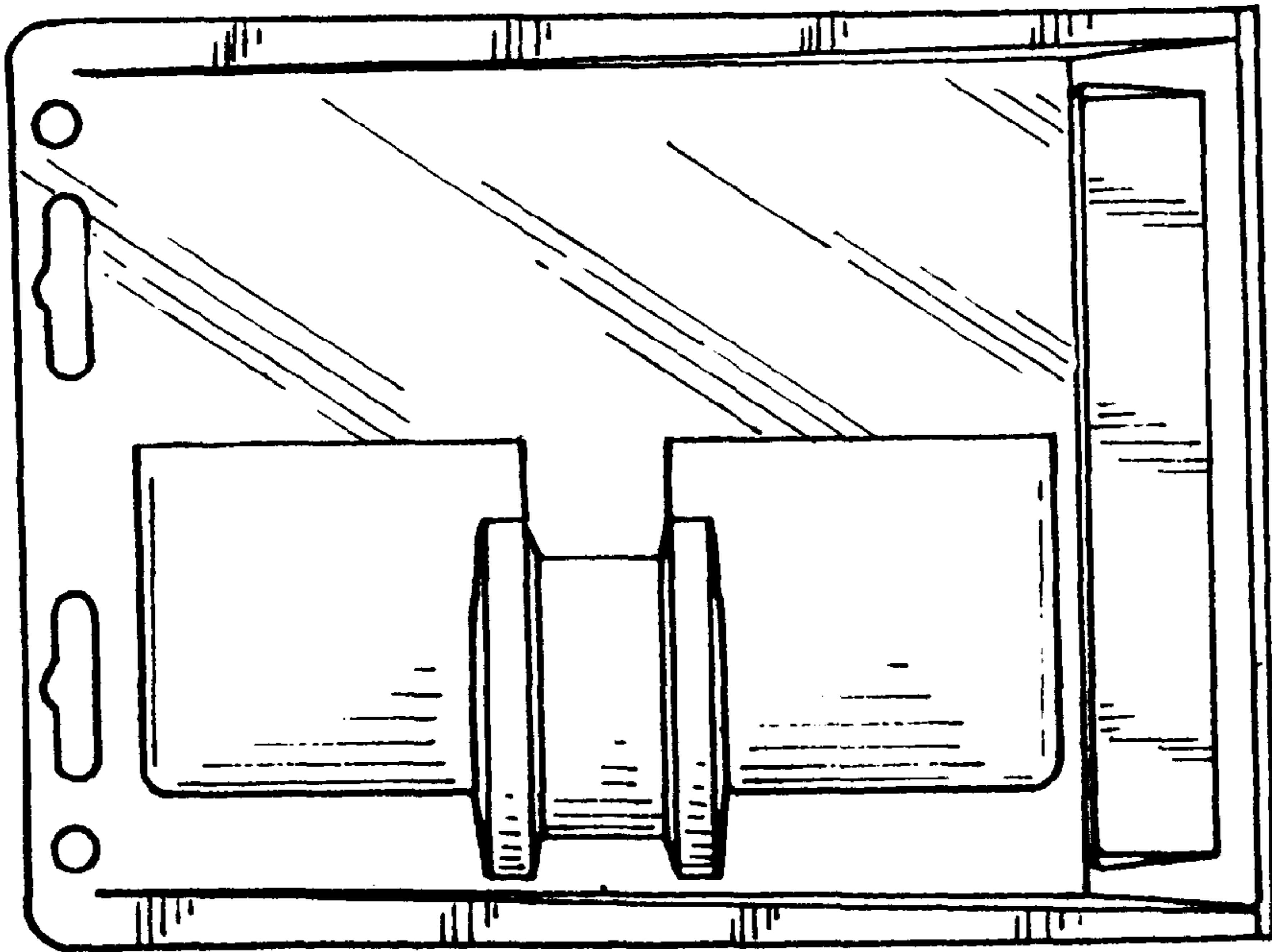

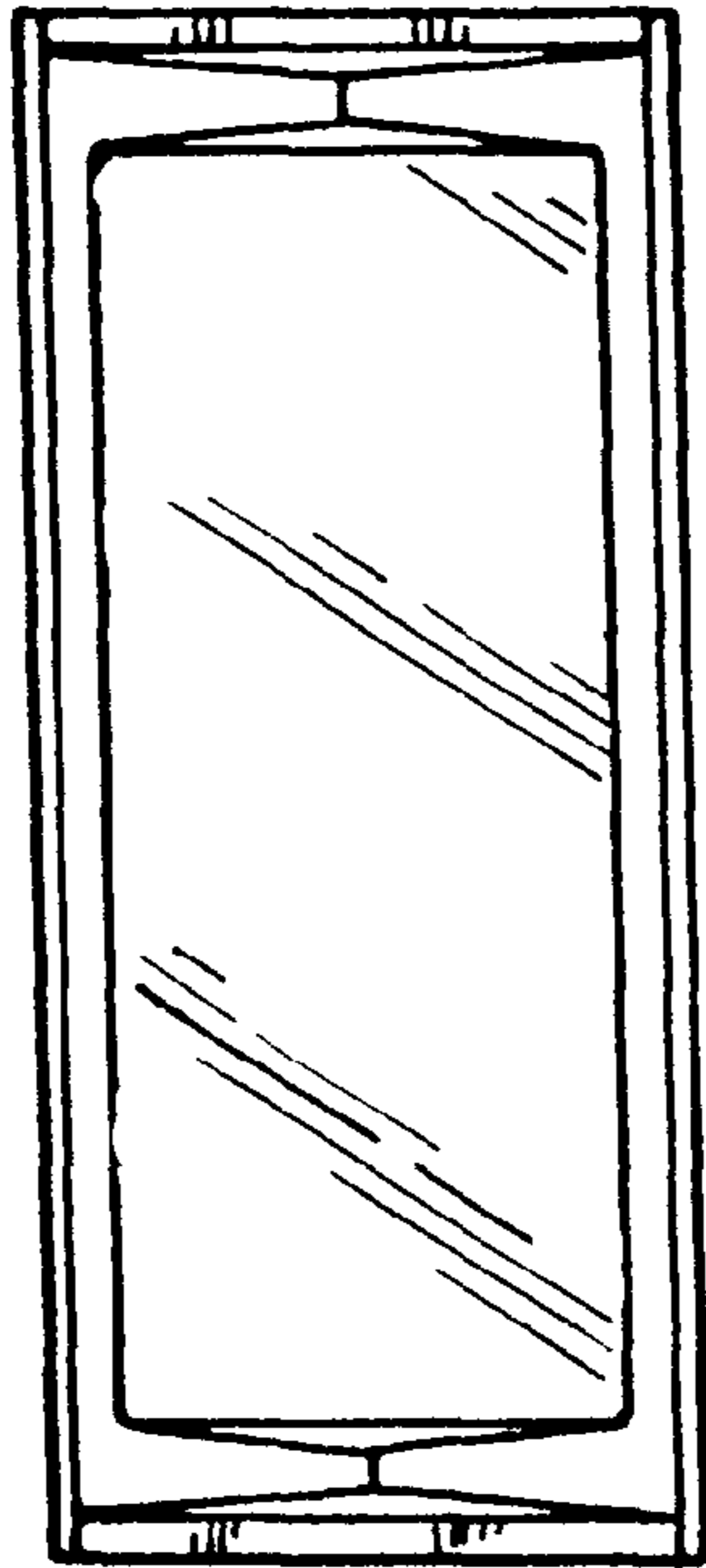

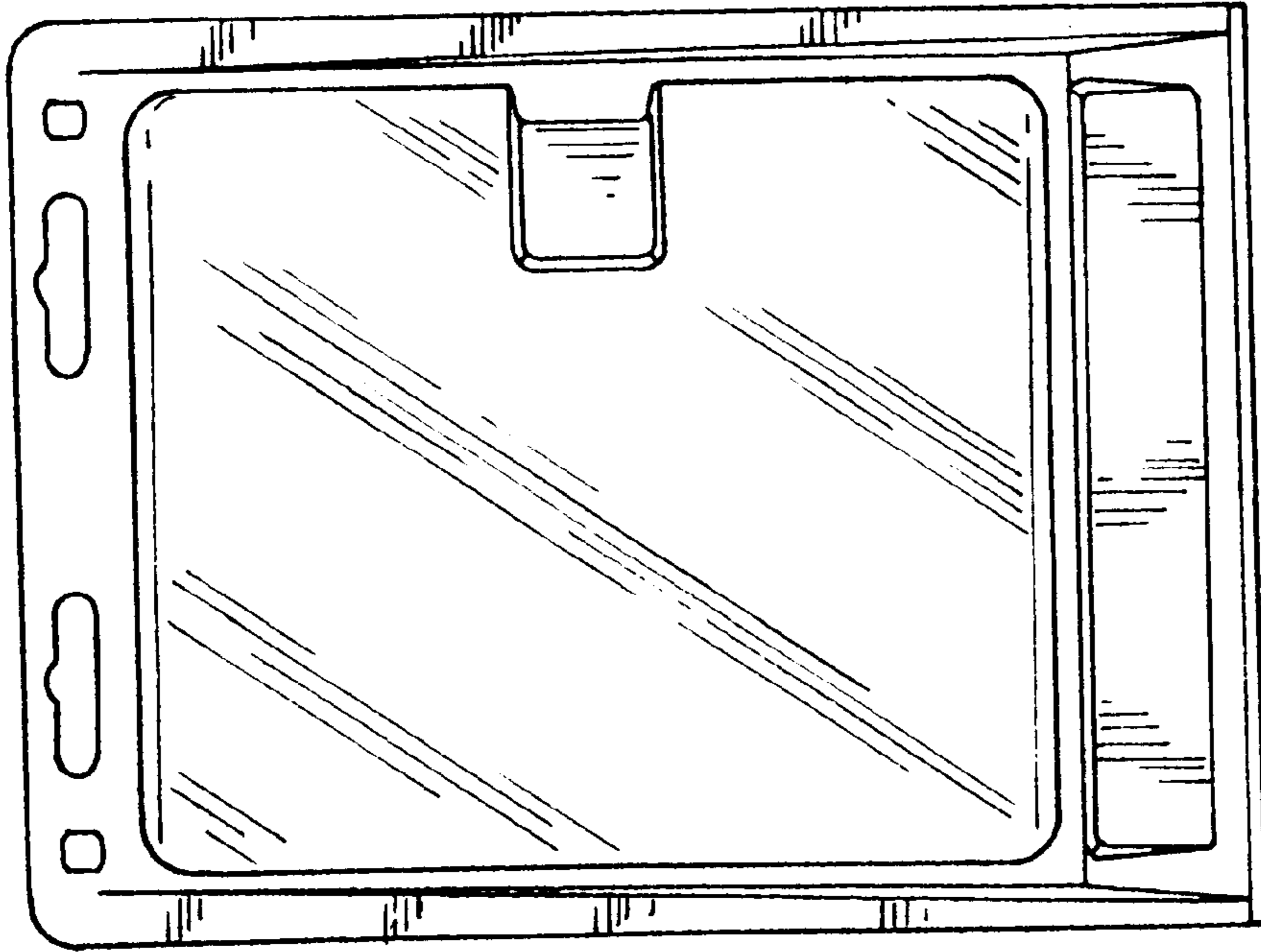

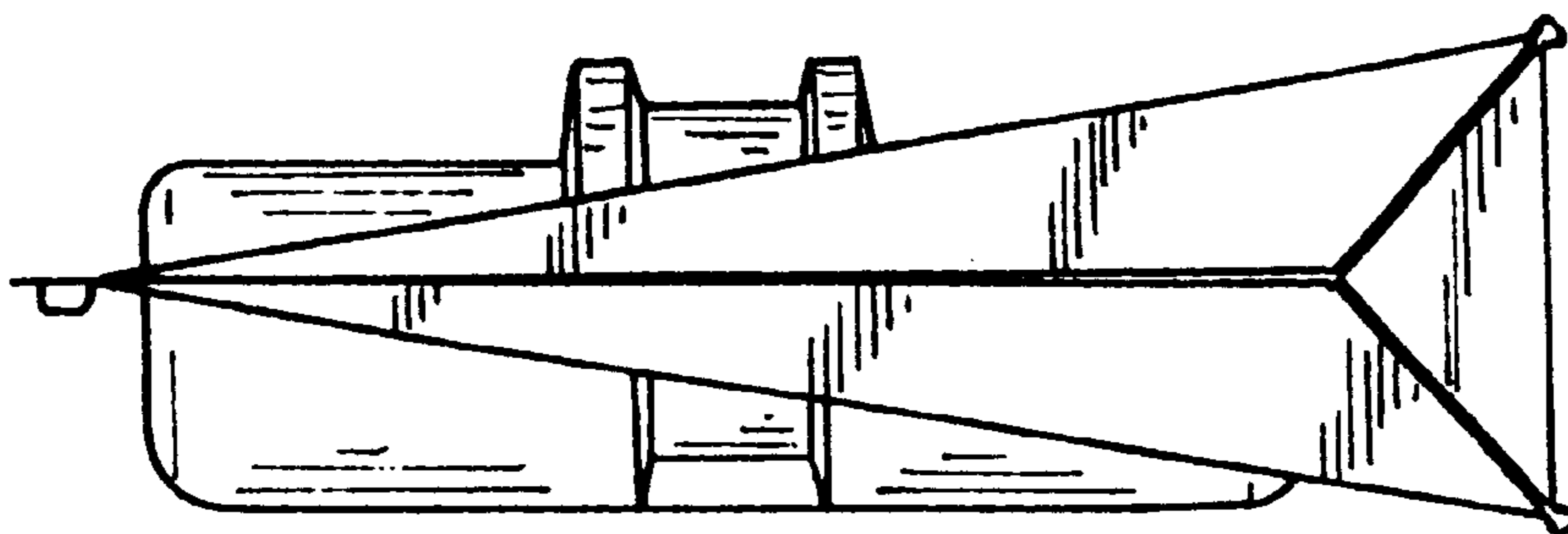

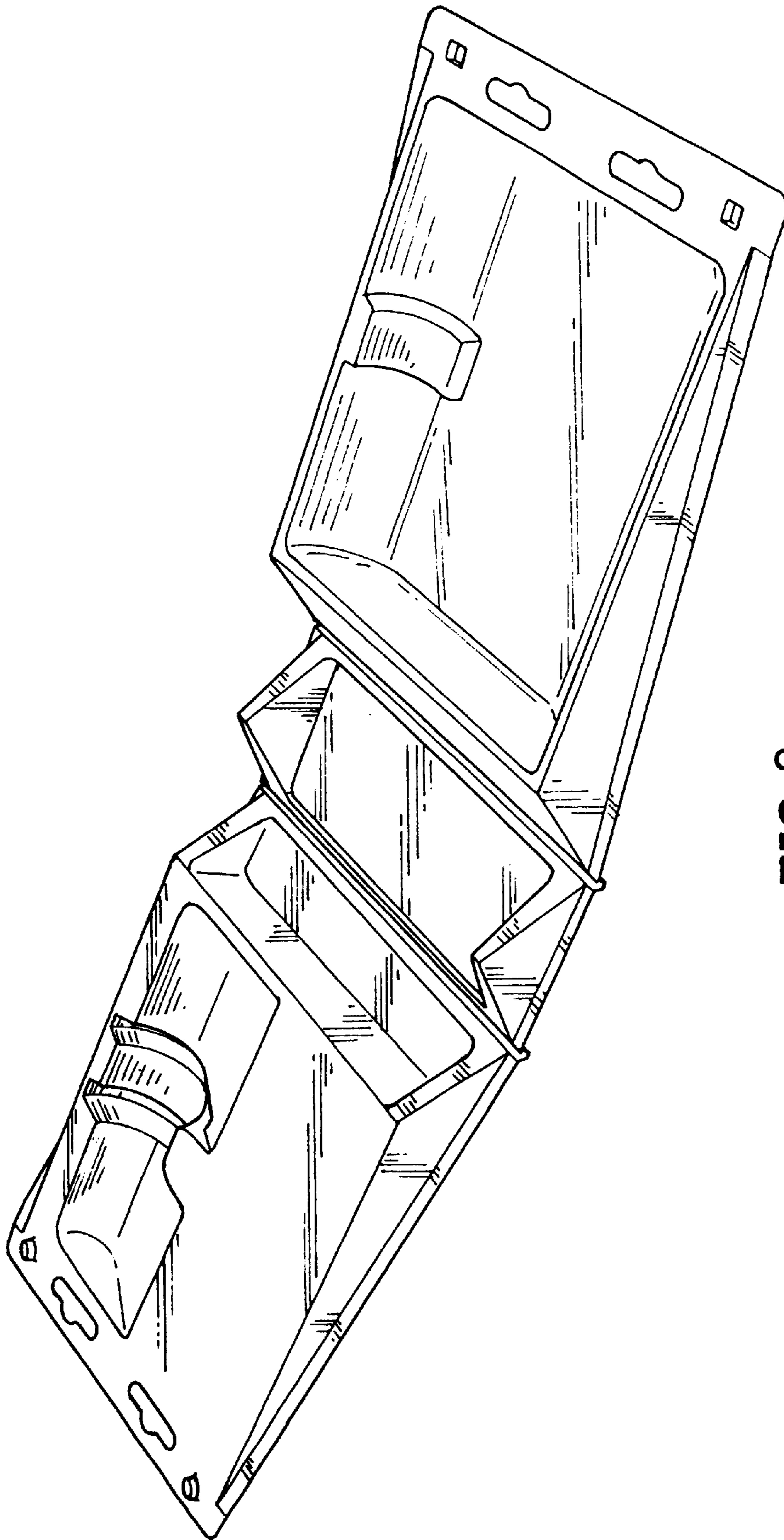
