(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view;
FIG. 2 is a front elevation thereof;
FIG. 3 is a right side elevation thereof, the left side elevation
being a mirror image of the same except for the unclaimed
threads;
FIG. 4 is a rear elevation thereof; and,
FIG. 5 is a bottom plan view.

The broken line showing of a pour spout and threads is for
illustrative purposes only and forms no part of the claimed
design. Also, the top solid line of the bottle collar forms the
boundary of the claim.

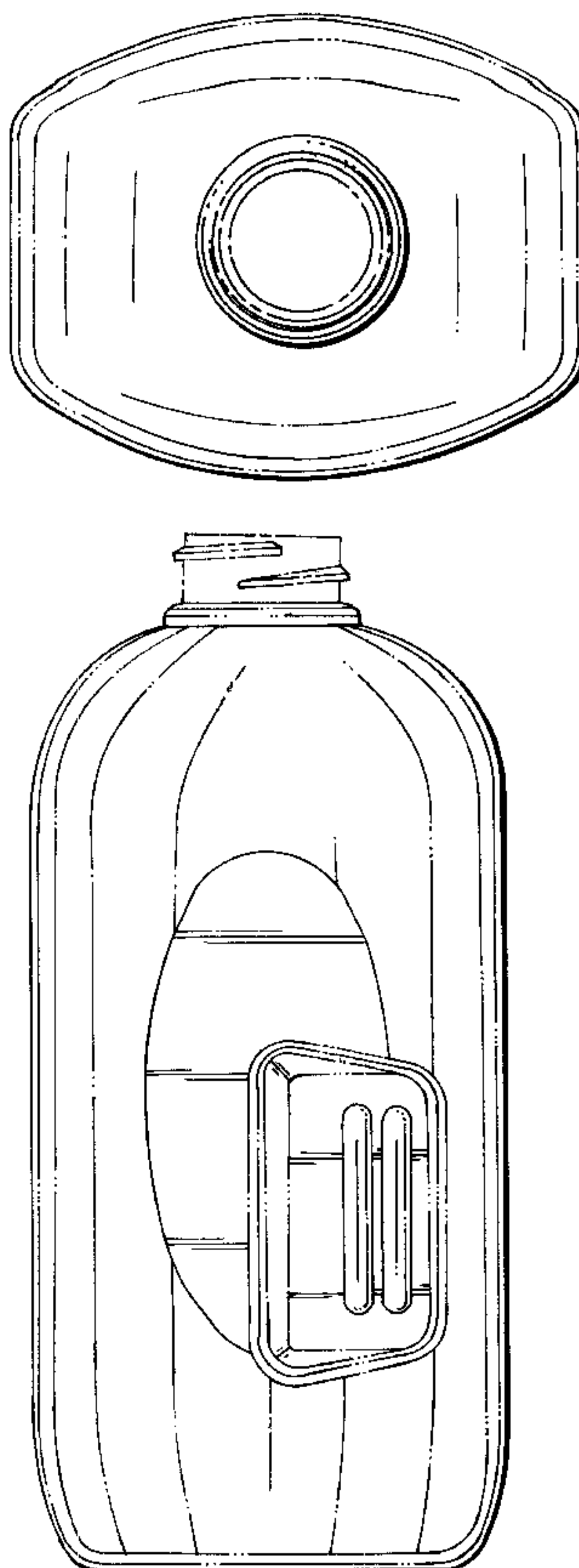

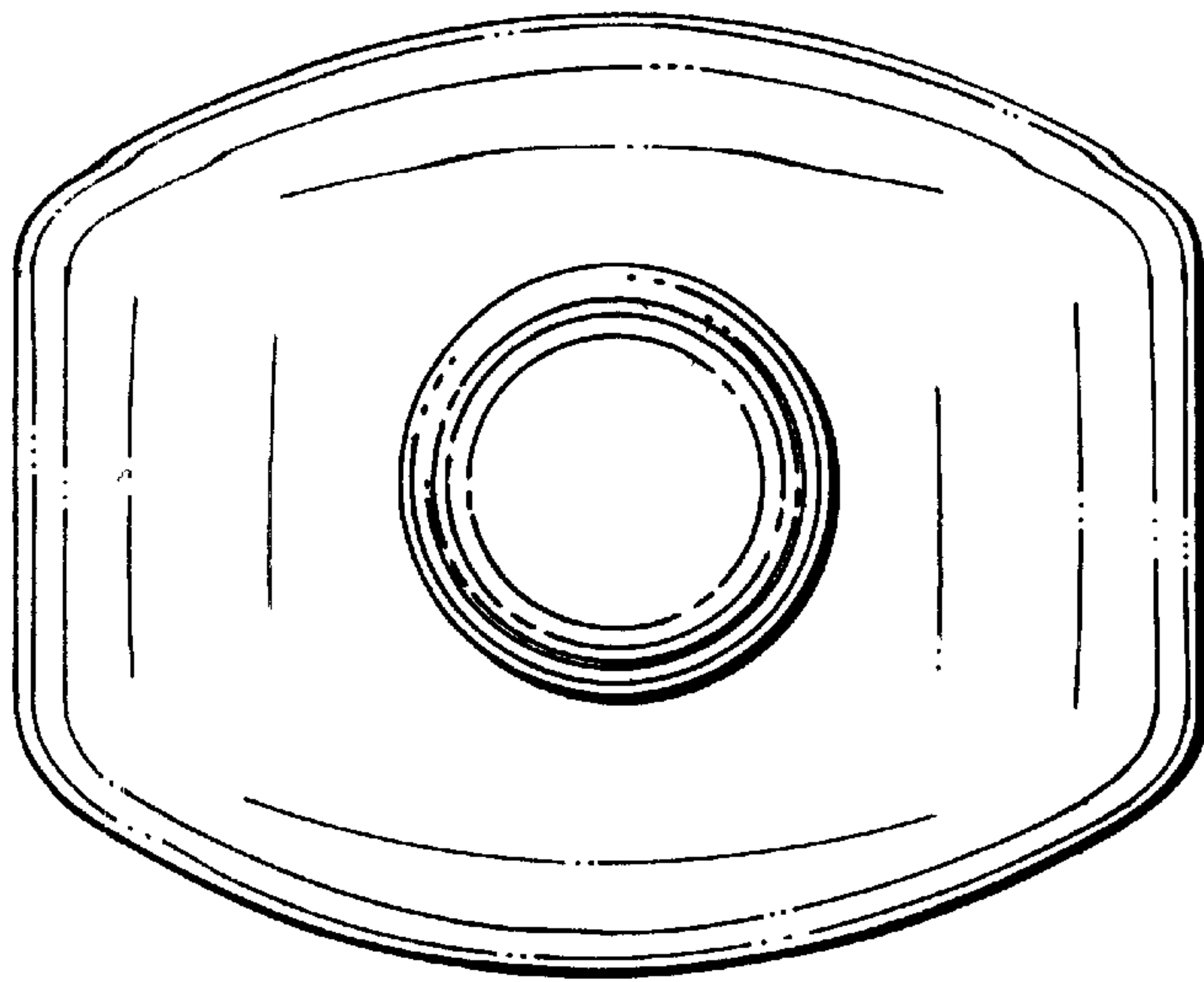
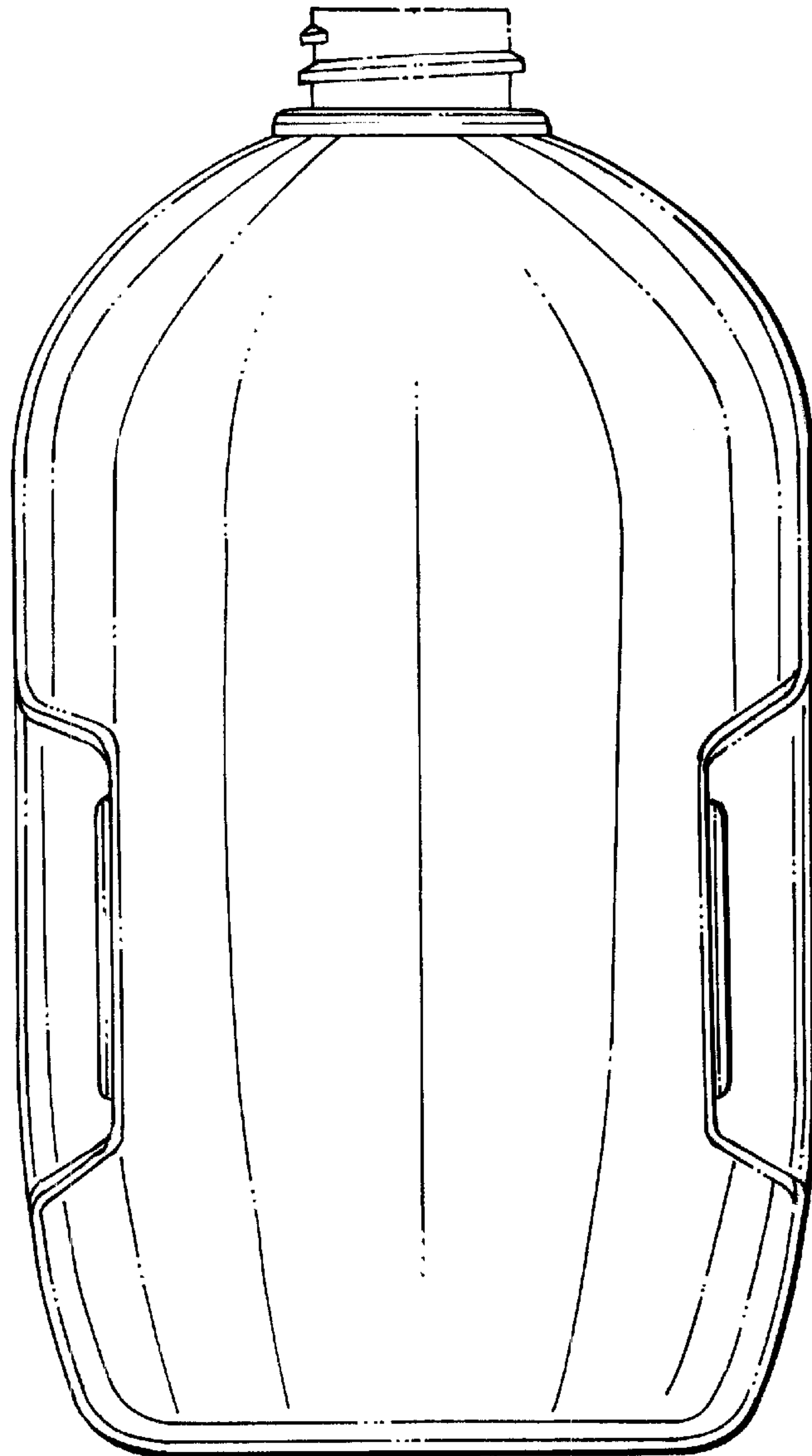

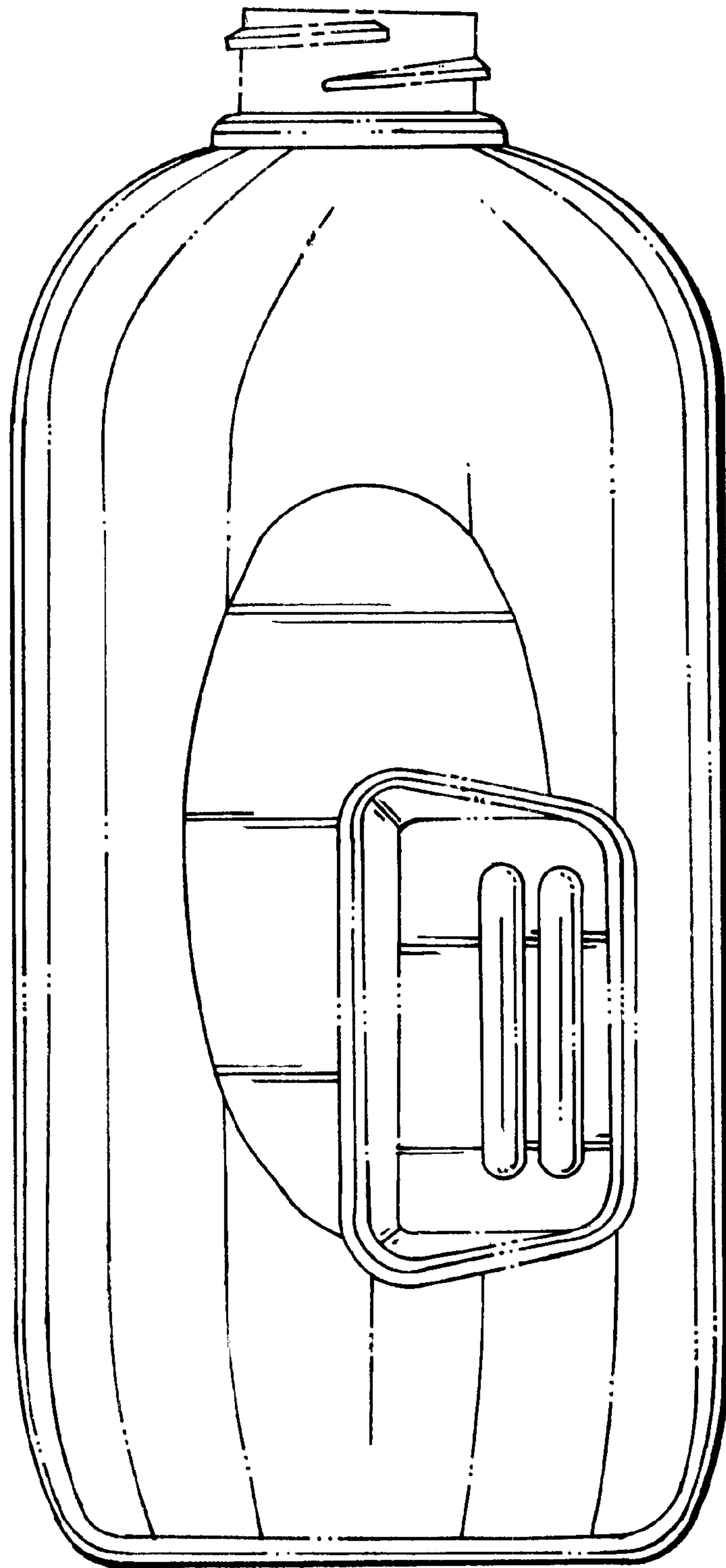

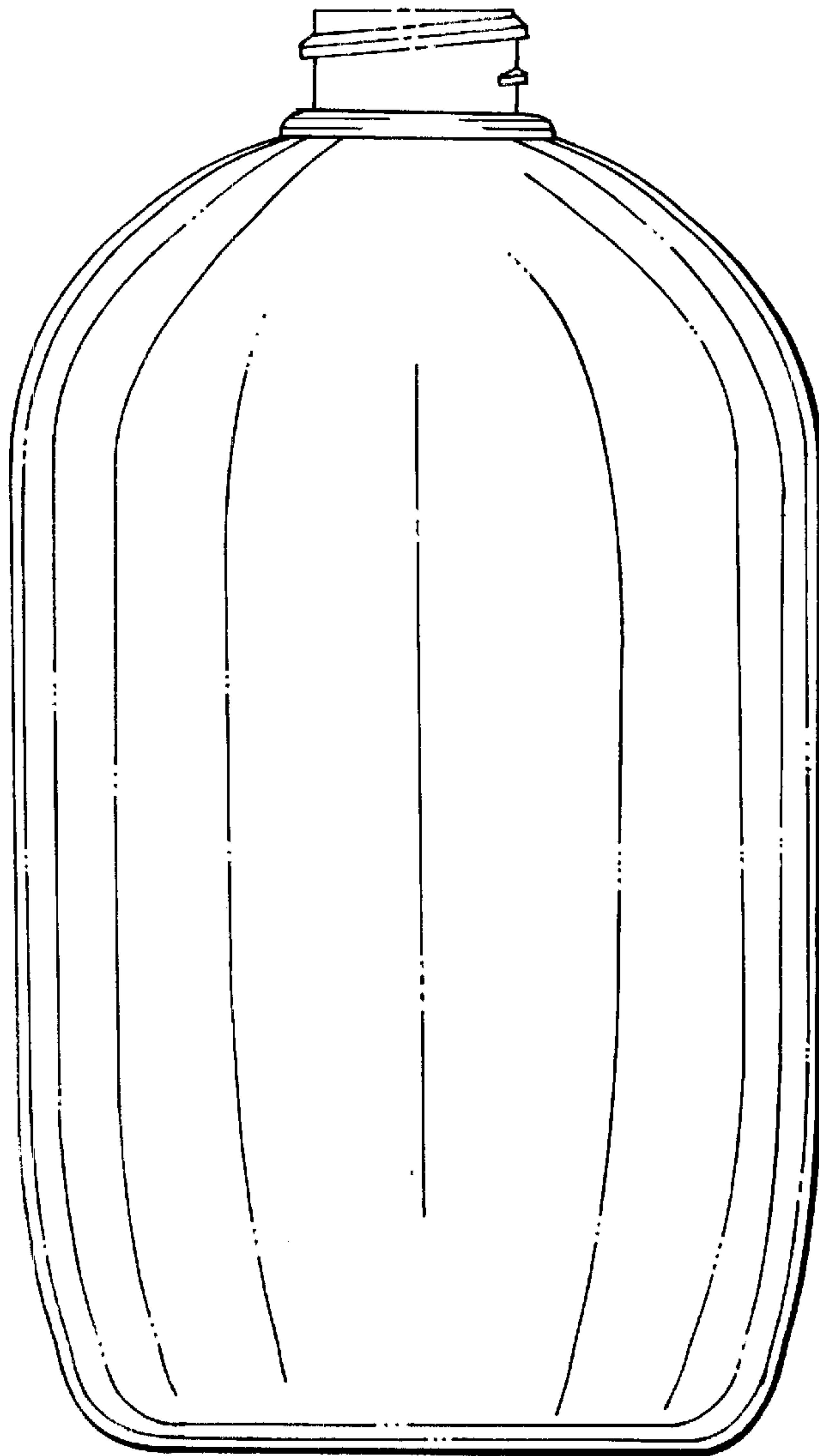
