FIG. 1 is a front view of the keypad for a handset; and, FIG. 2 is a perspective front view thereof.

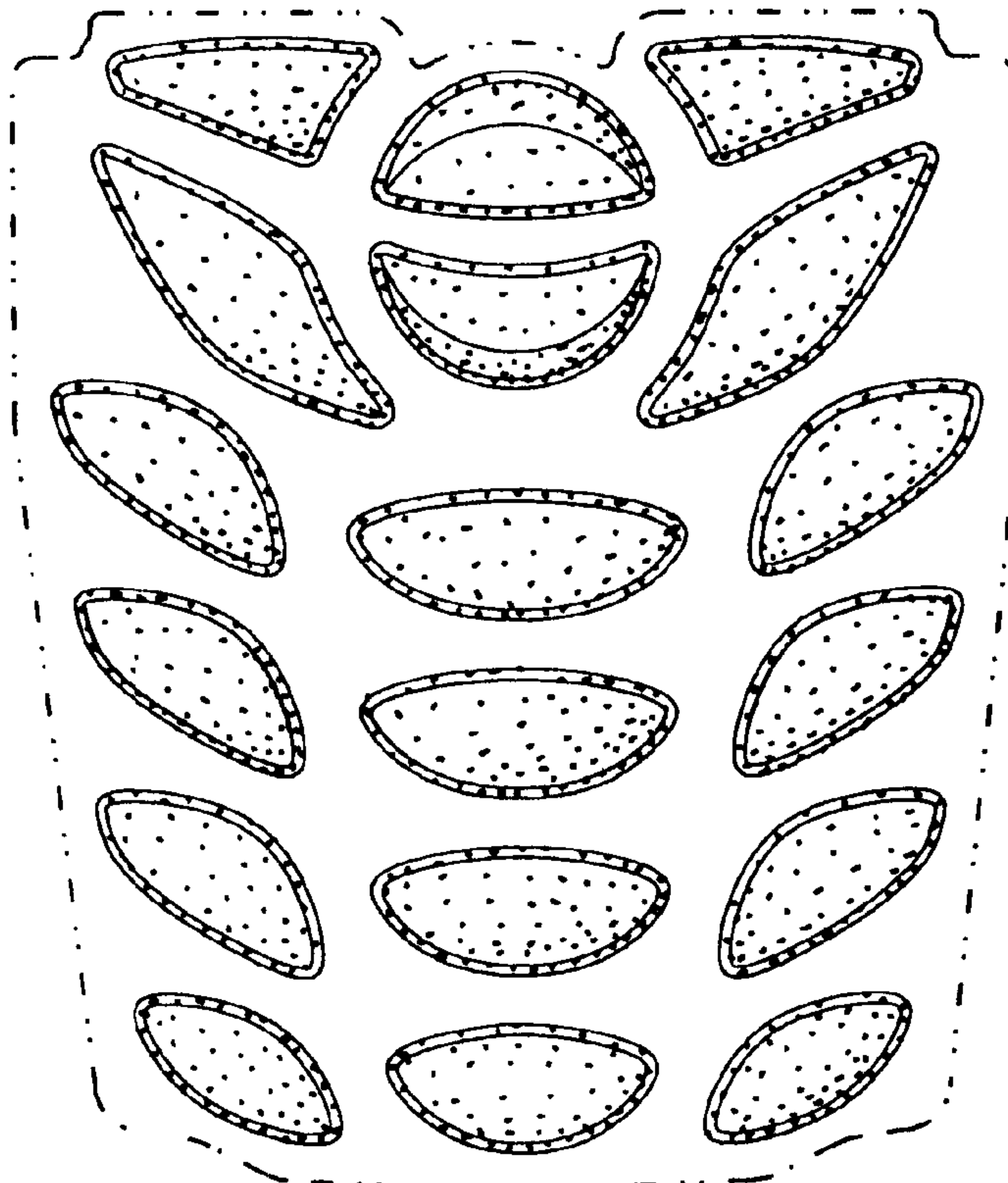
The broken line showing of environment in the figures is for illustrative purposes only and forms no part of the claimed design.

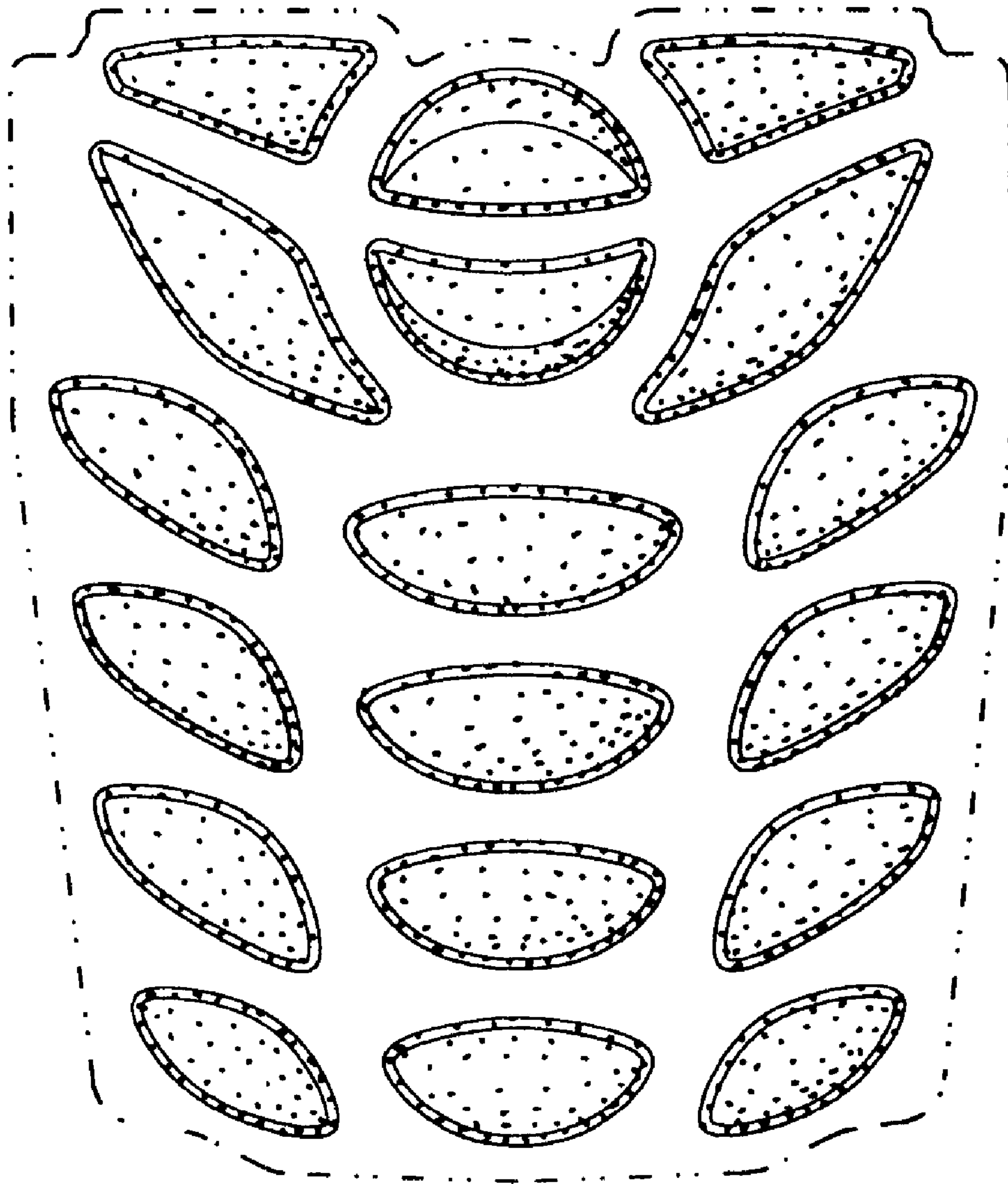

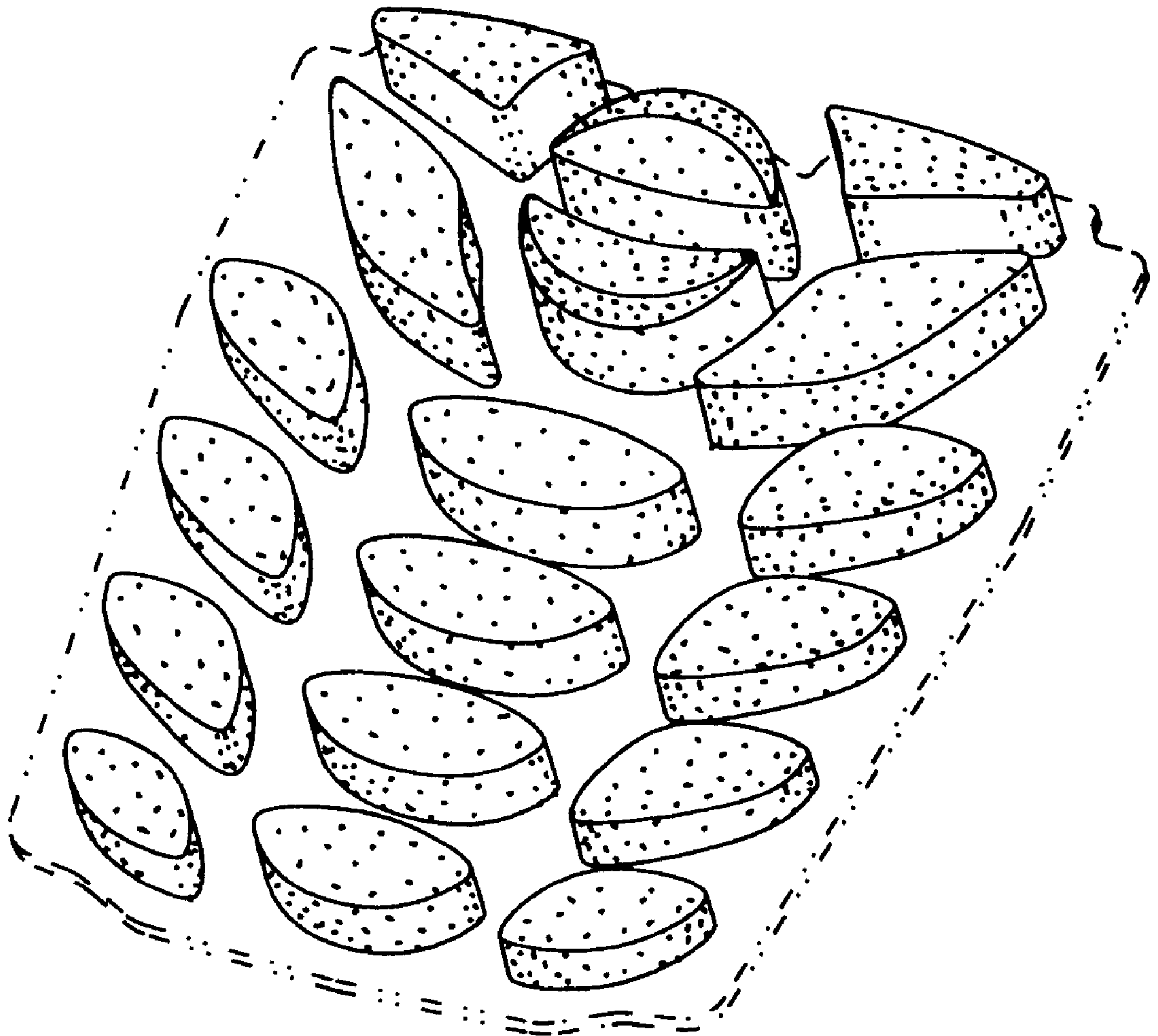
