I claim the ornamental design for a keypad for a handset, as shown and described.

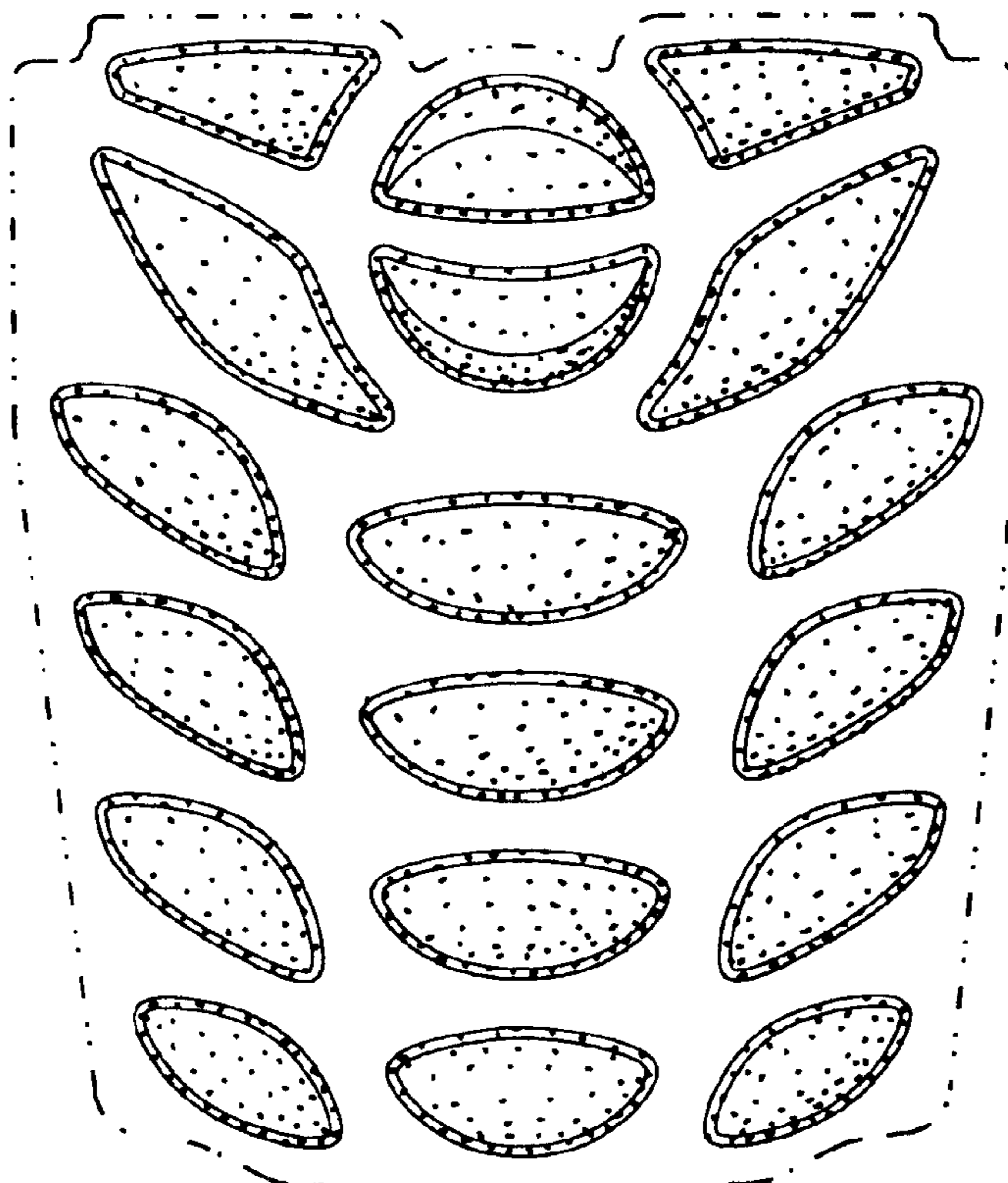
DESCRIPTION

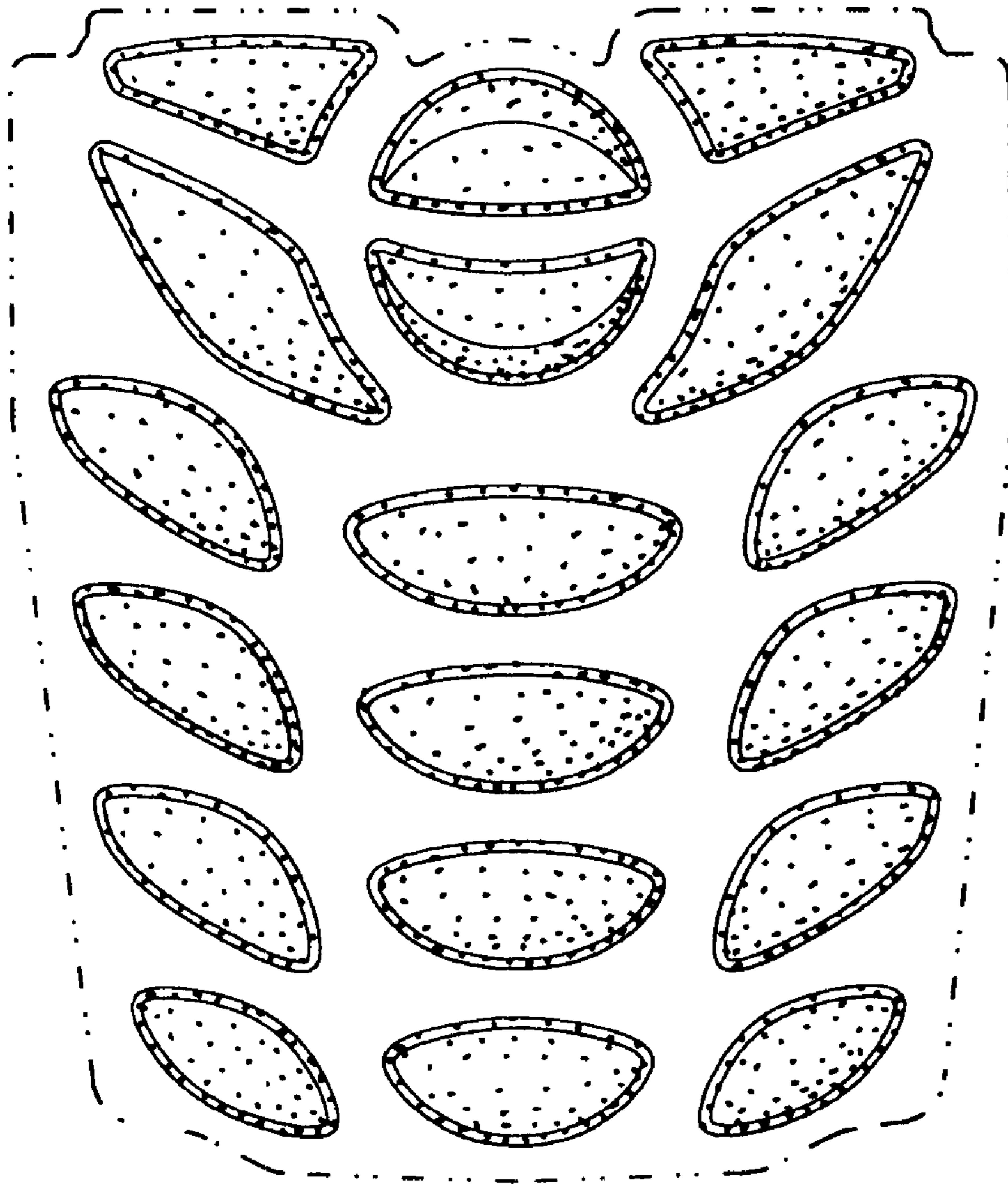

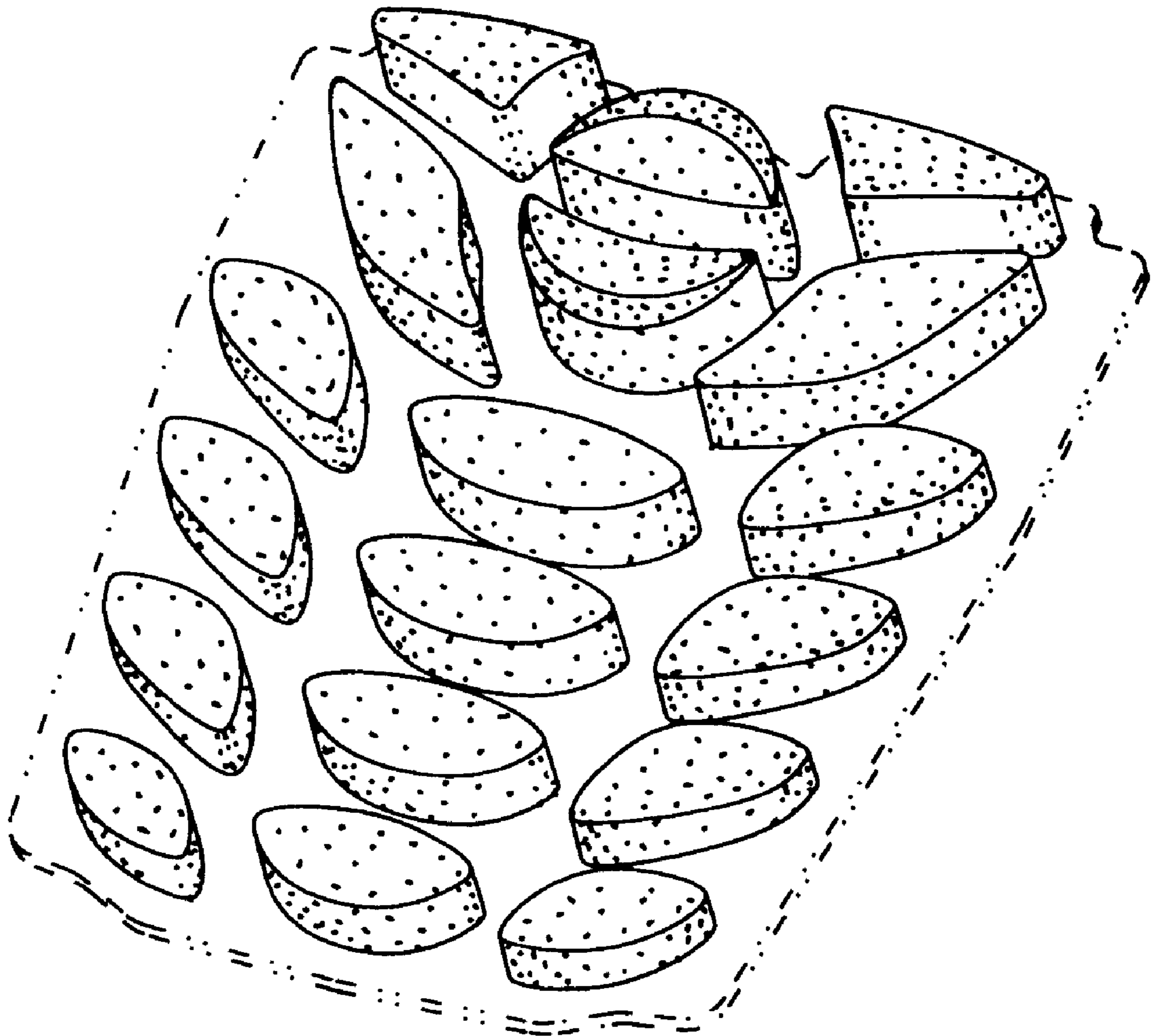
