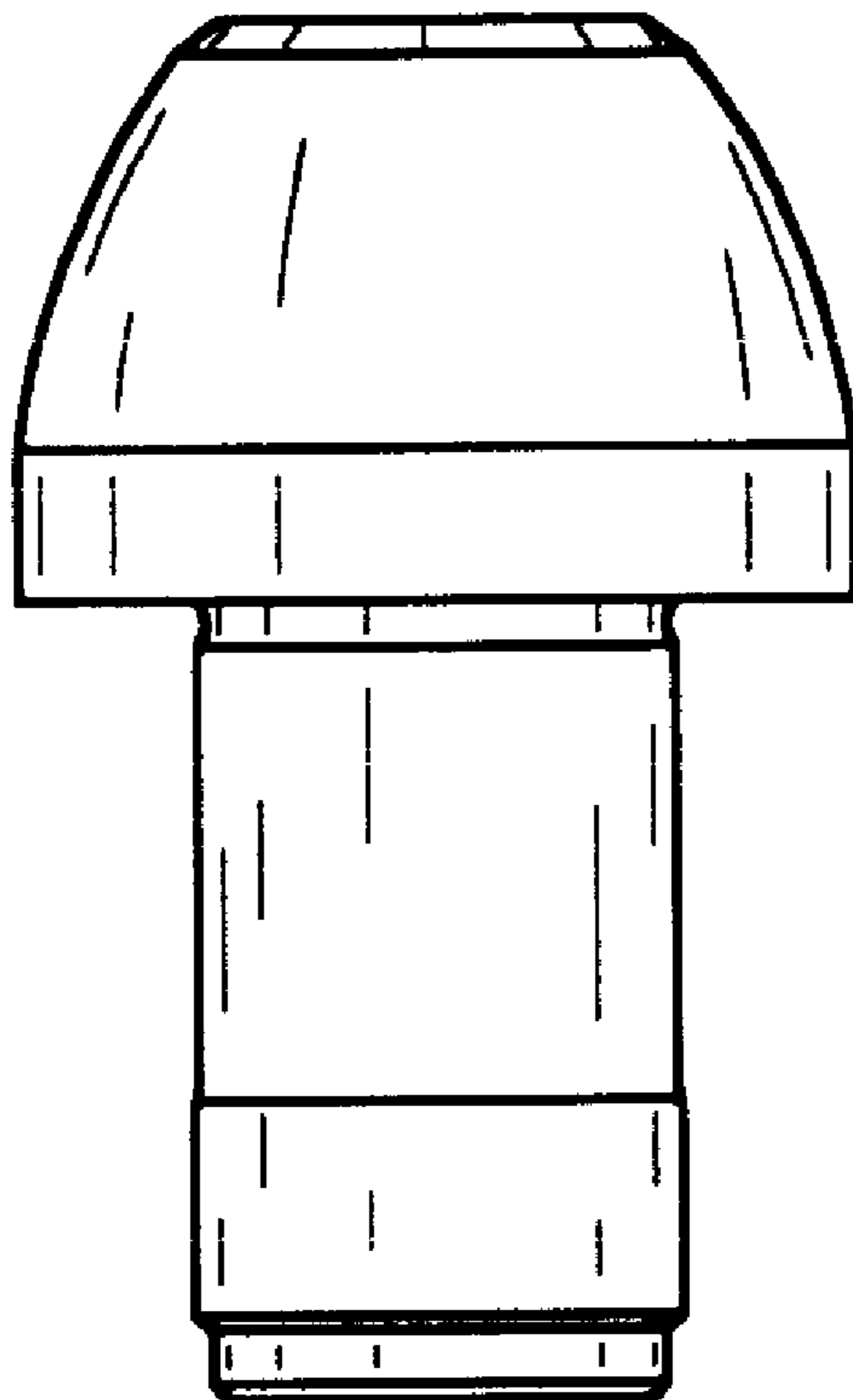
(57) **CLAIM**

The ornamental design for quick change bit holder with hardened insert, as shown and described.

DESCRIPTION

FIG. 1 is a right side elevational view of the quick change bit holder with hardened insert, showing my new design, FIG. 2 is a back side elevational view thereof, FIG. 3 is a left side elevational view thereof, FIG. 4 is a front elevational view thereof, FIG. 5 is a bottom plan view thereof; and, FIG. 6 is a top plan view thereof.

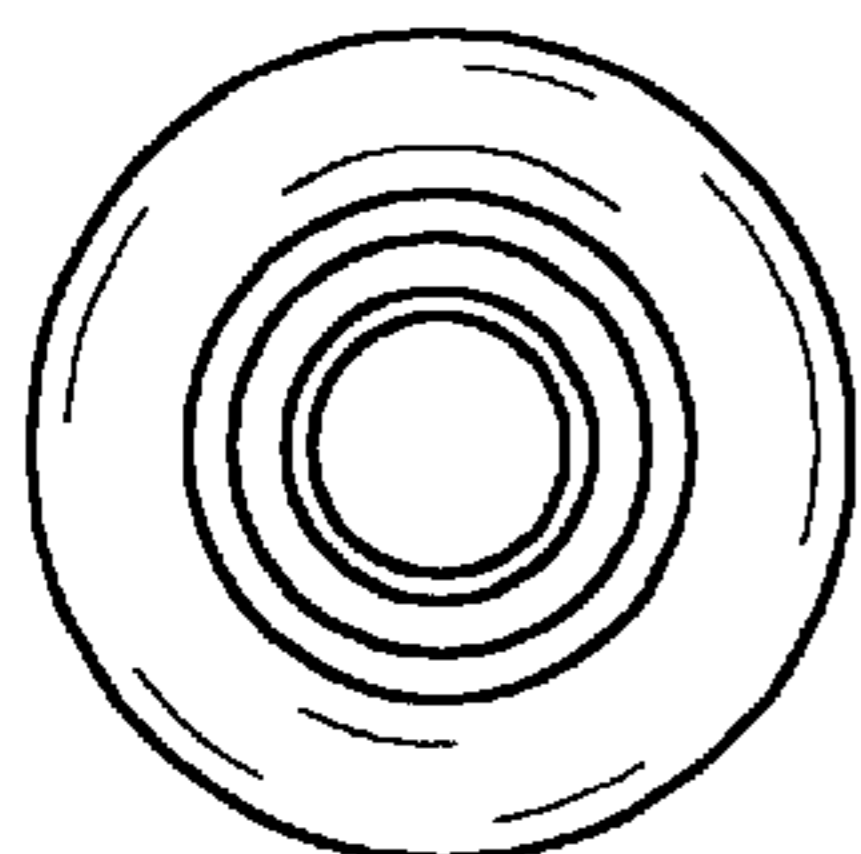

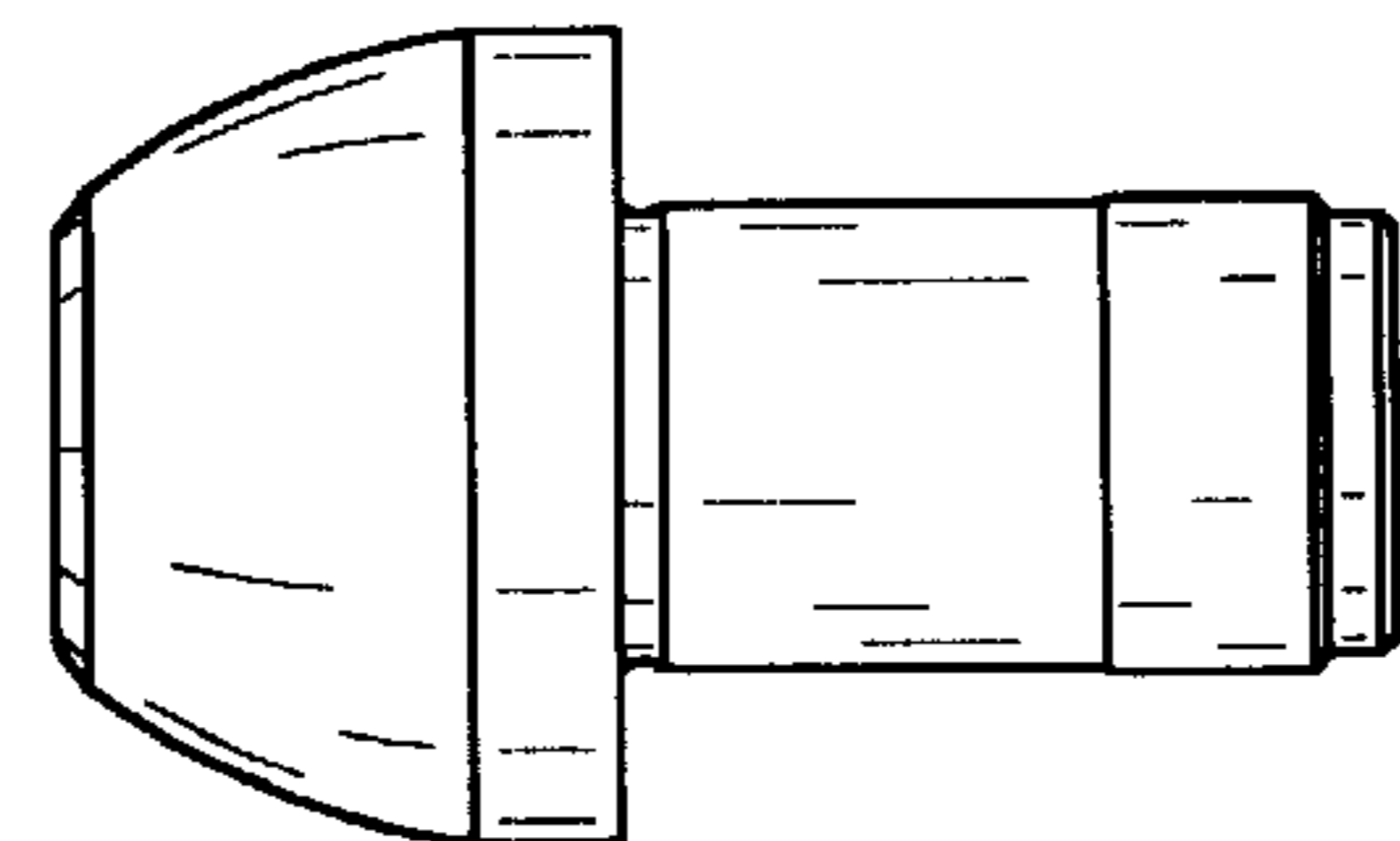

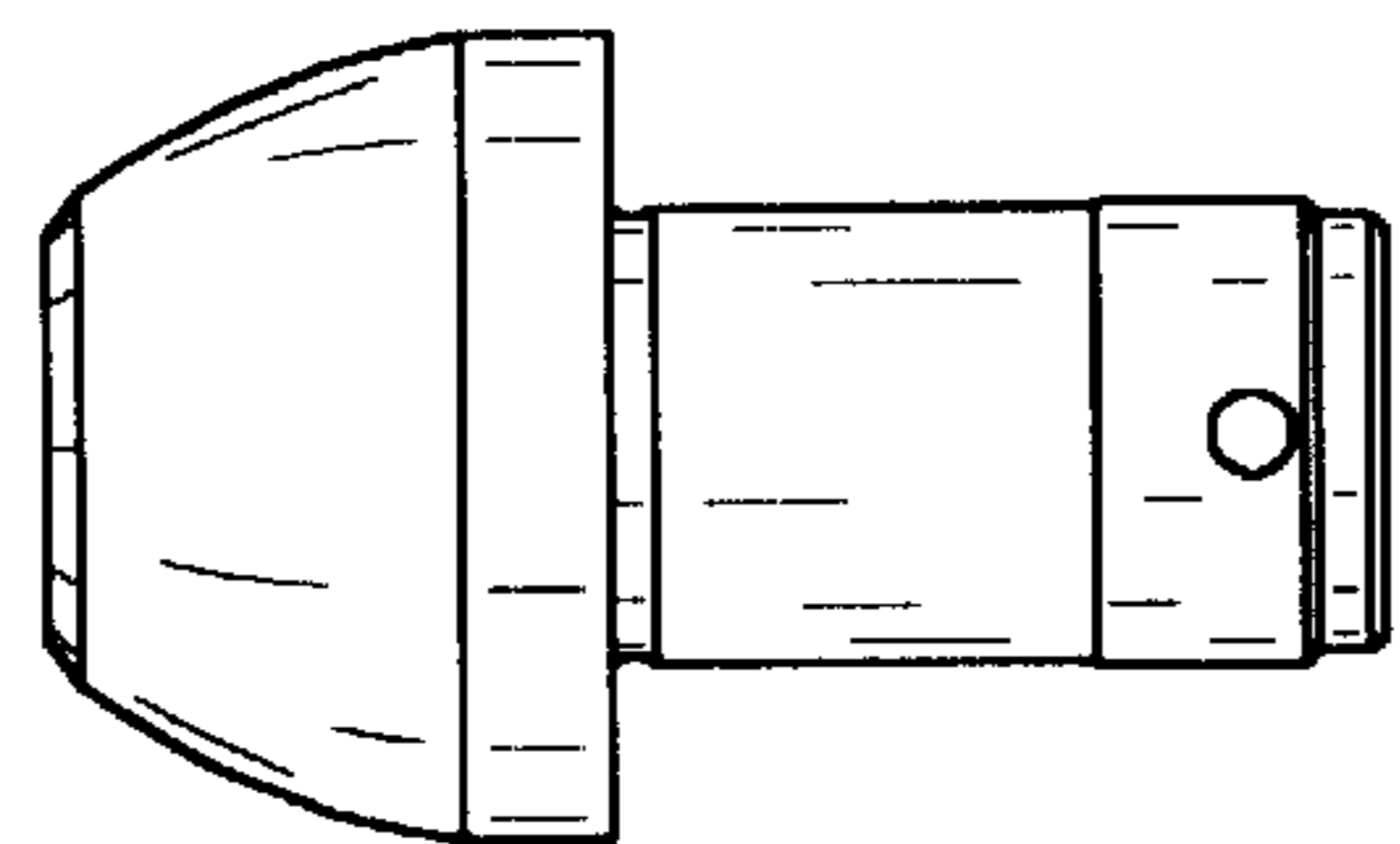

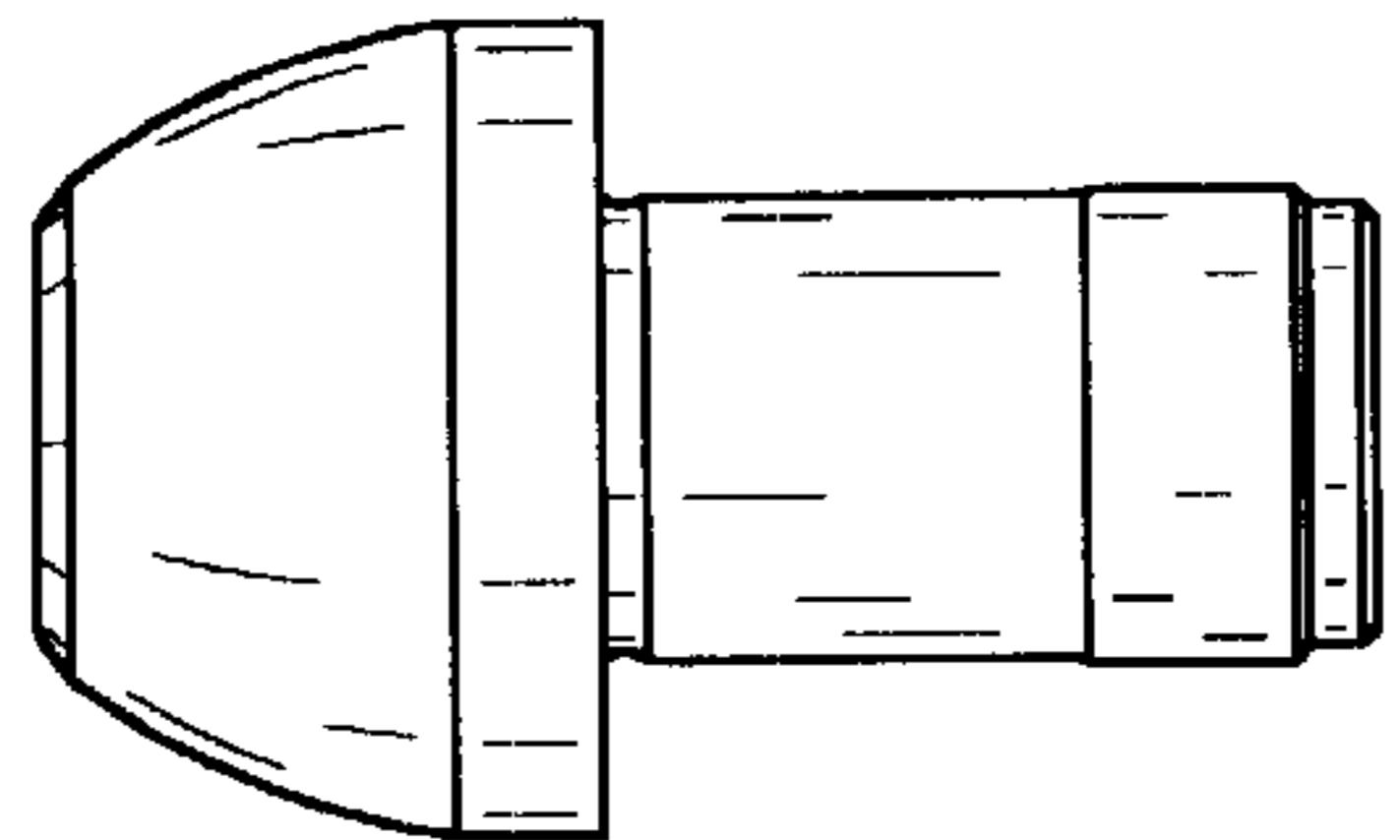

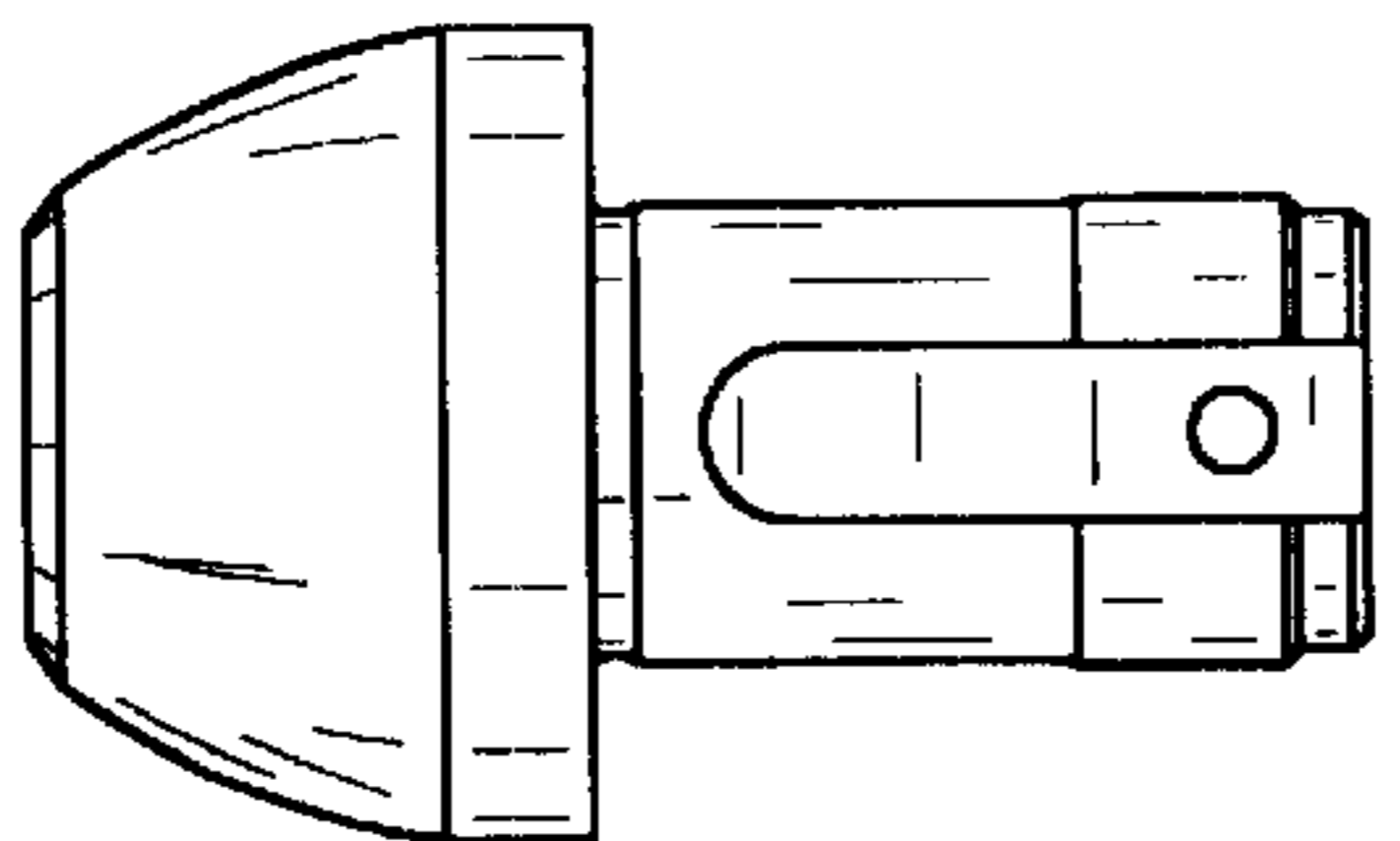

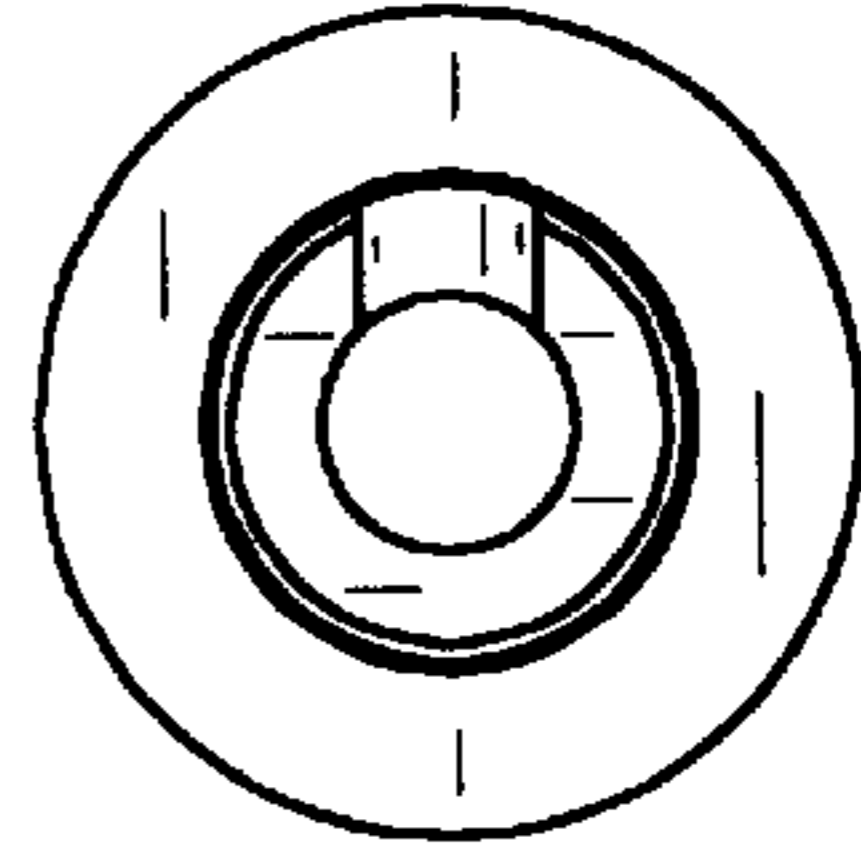
