(57) **CLAIM**

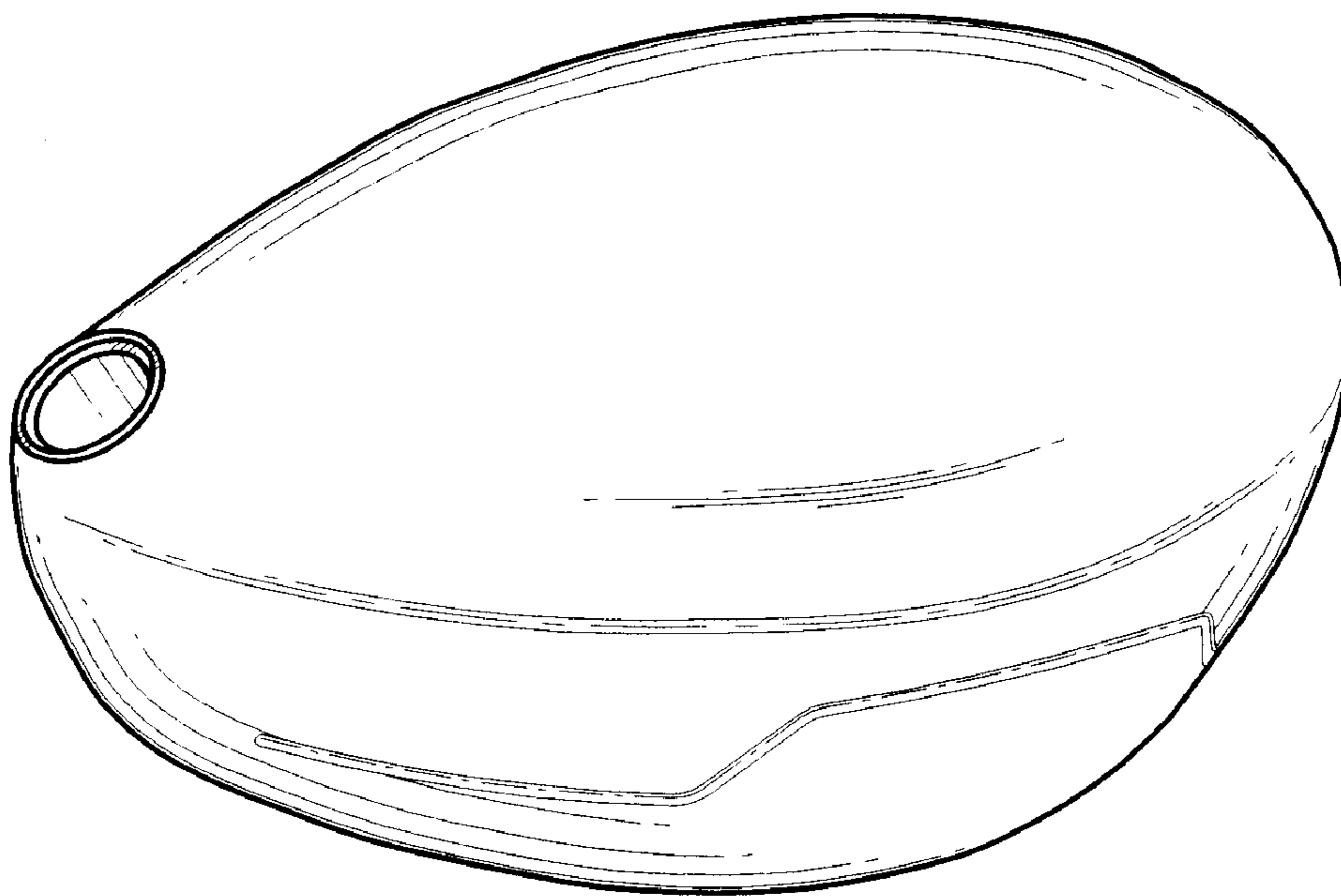
The ornamental design for a golf club head, as shown and described.

DESCRIPTION

FIG. 1 is a back perspective view of a golf club head; FIG. 2 is a front plan view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a heel side view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a toe side view thereof; and, FIG. 7 is a back plan view thereof.

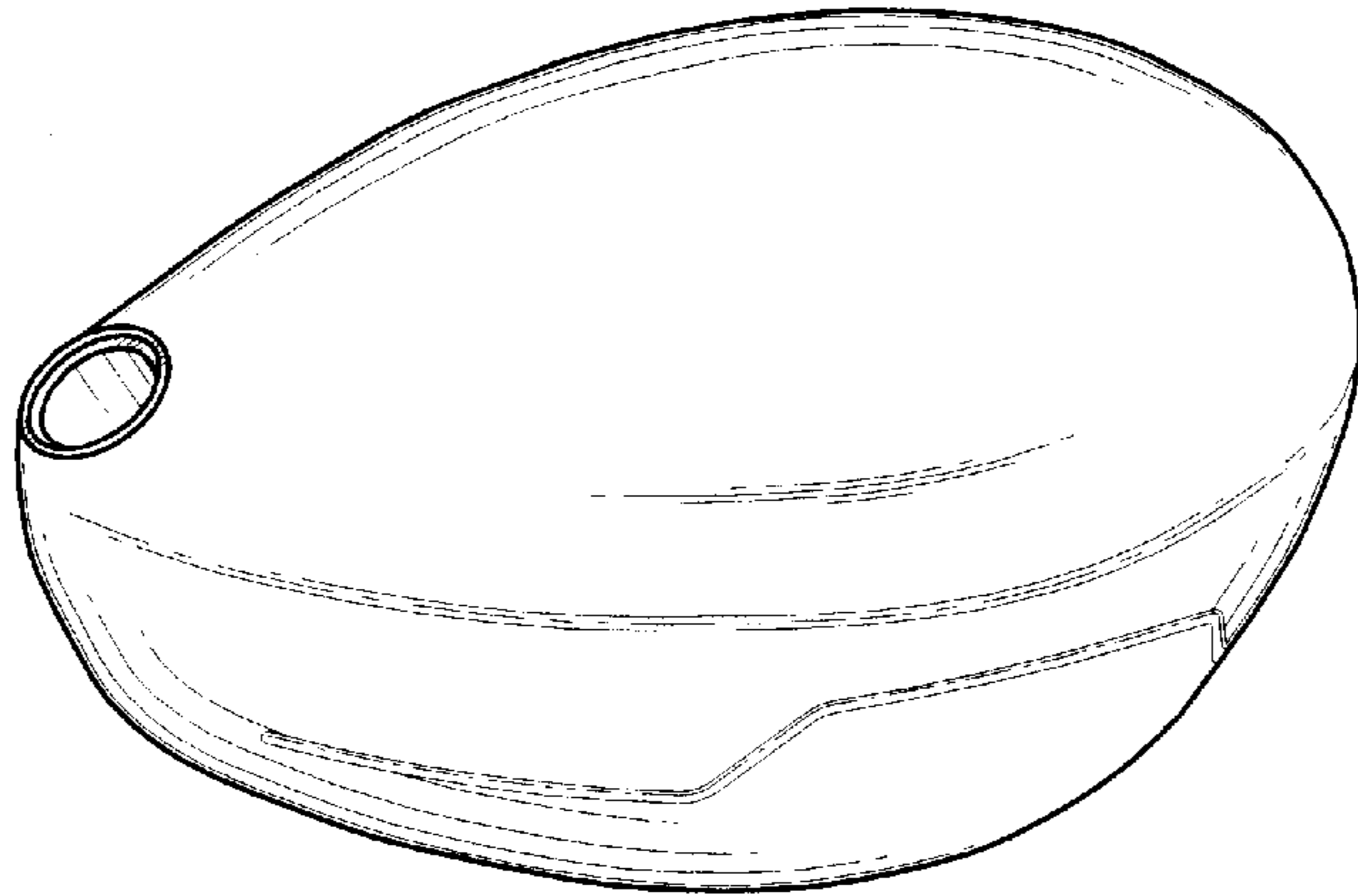

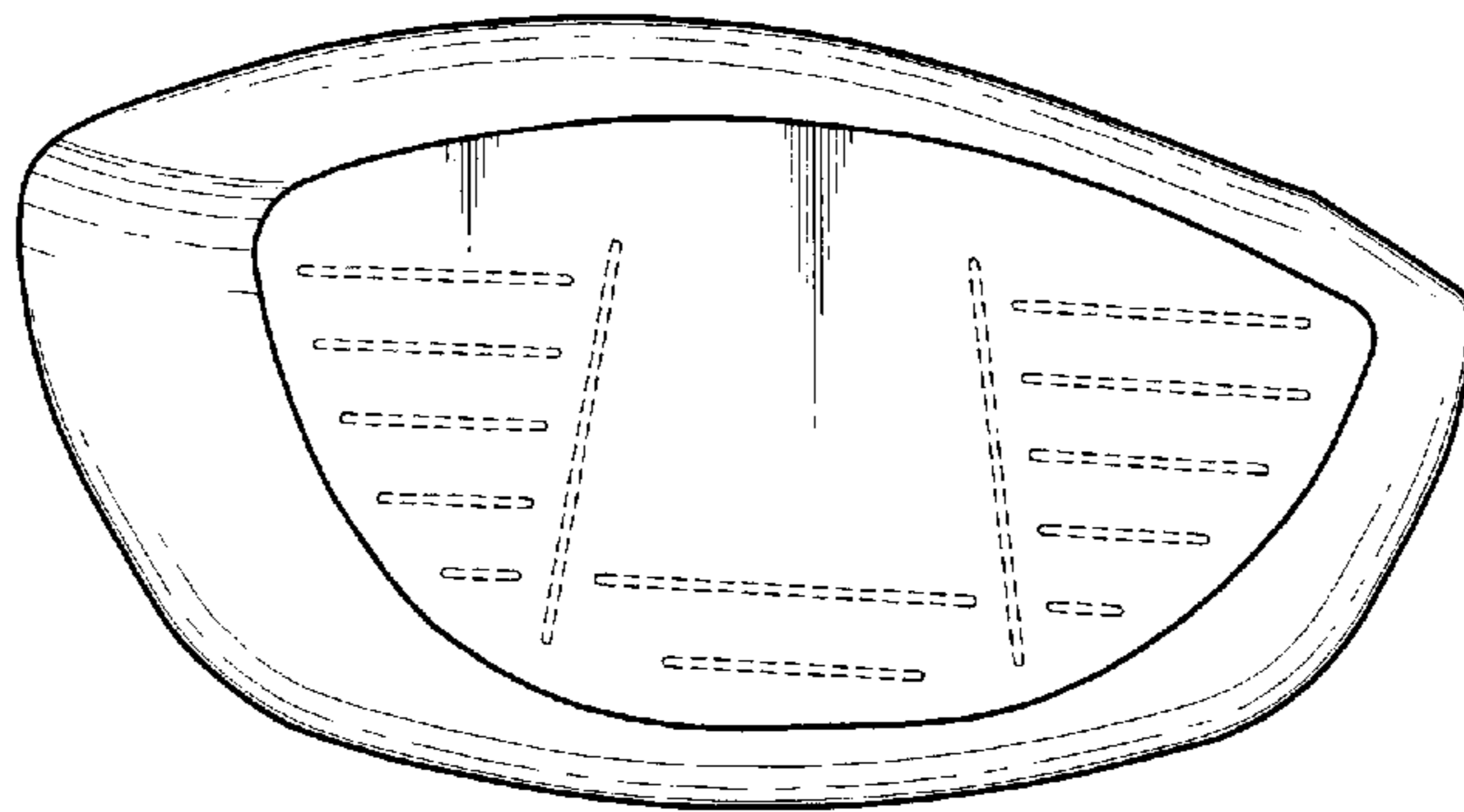

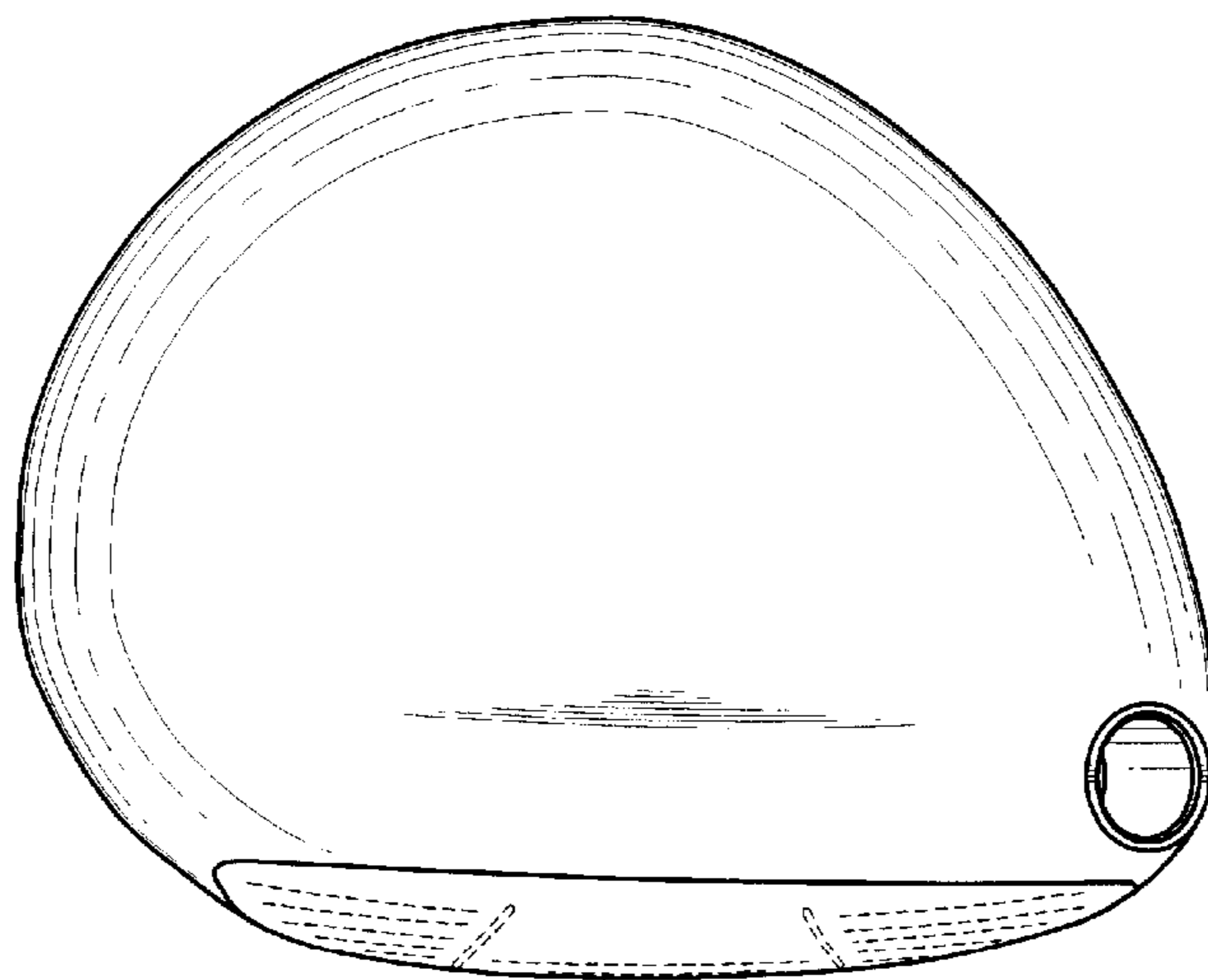

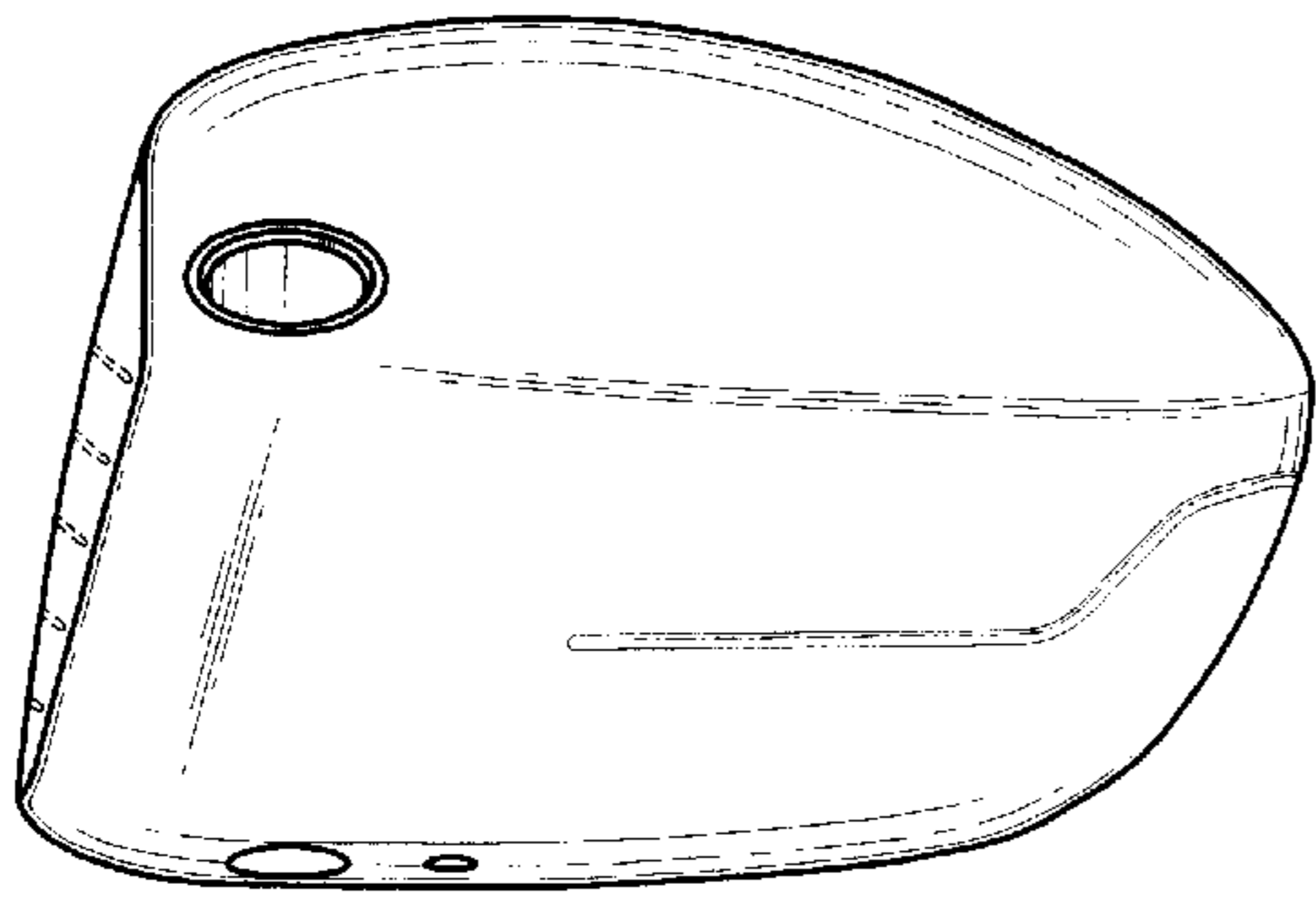

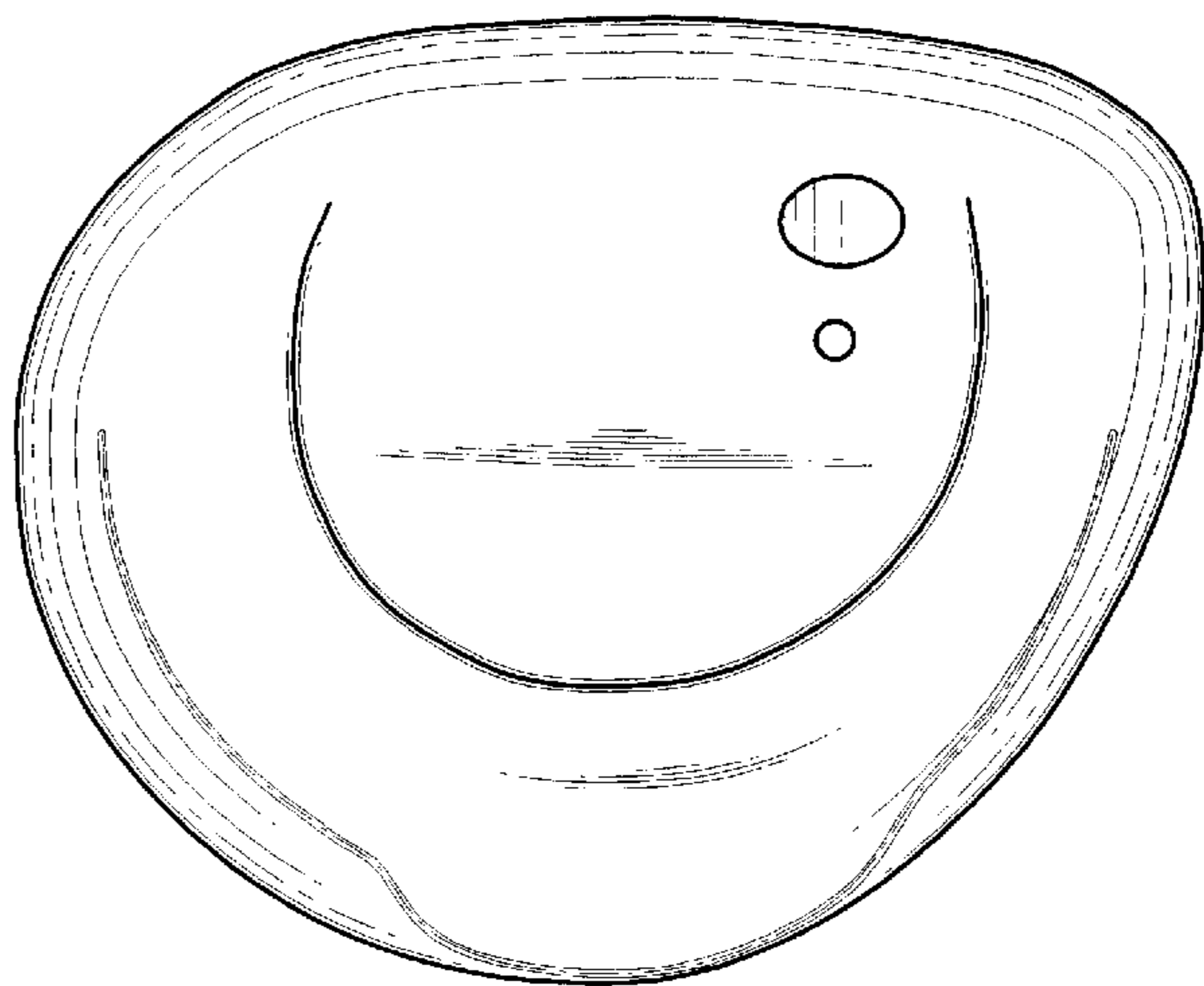

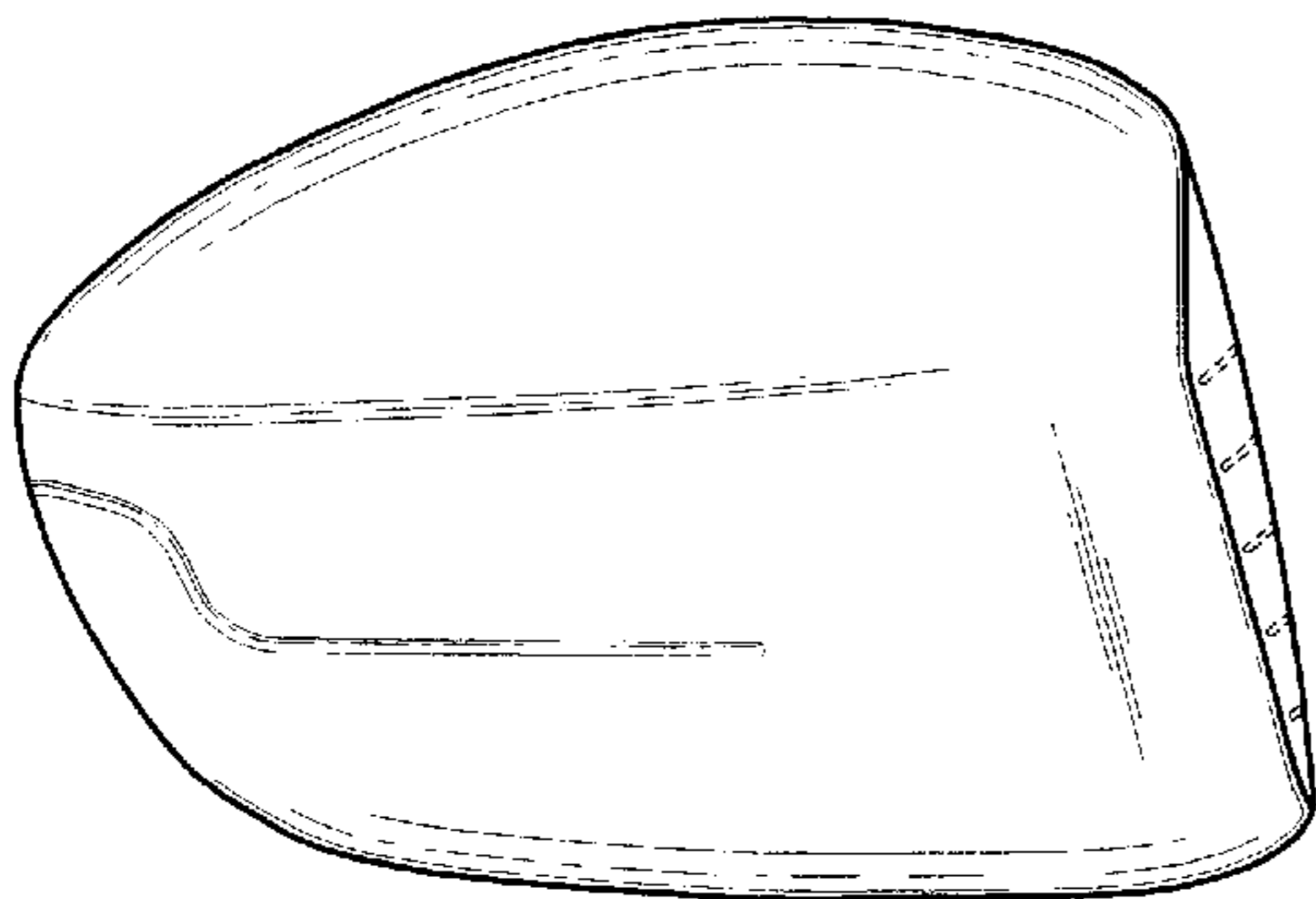

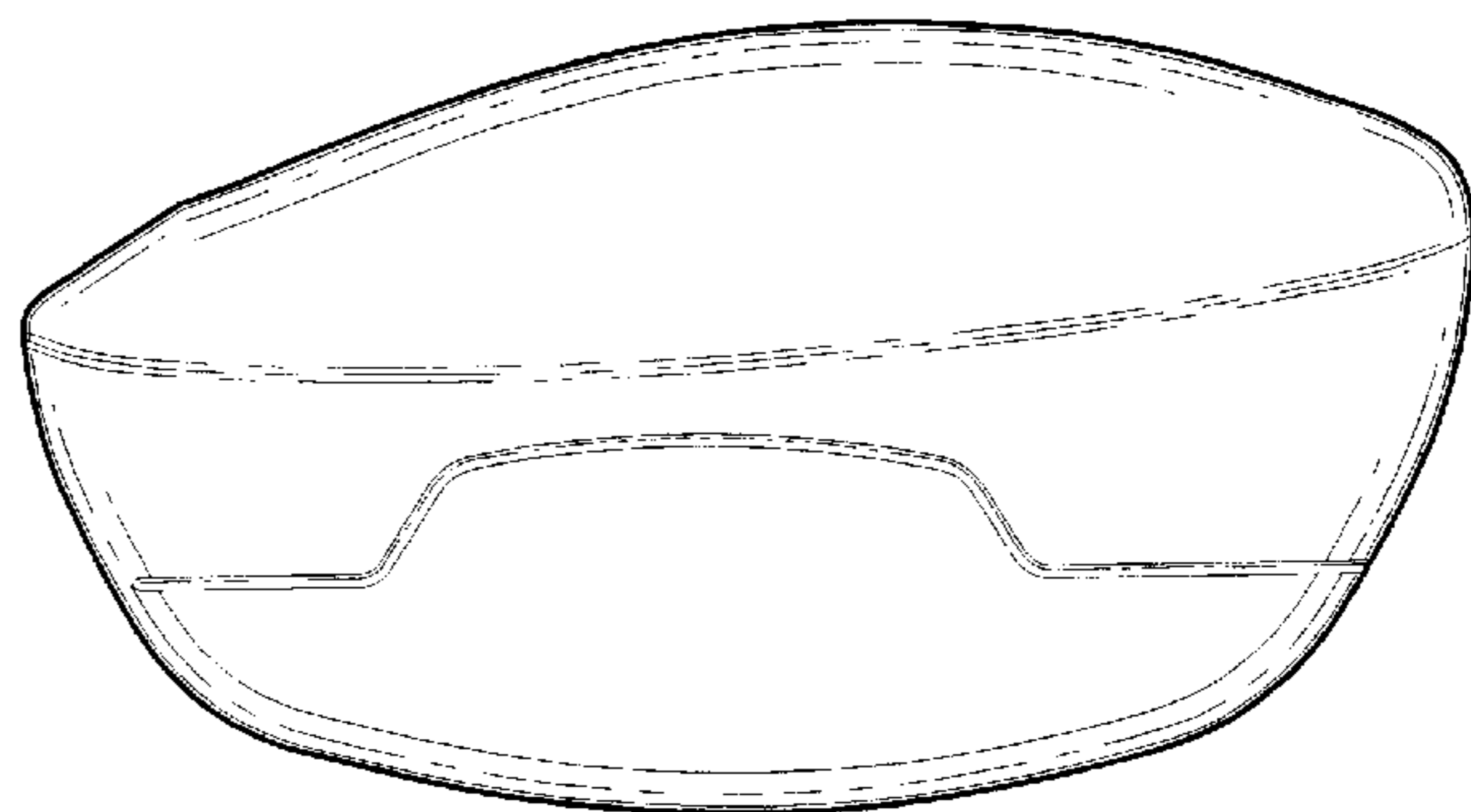
