(57) **CLAIM**

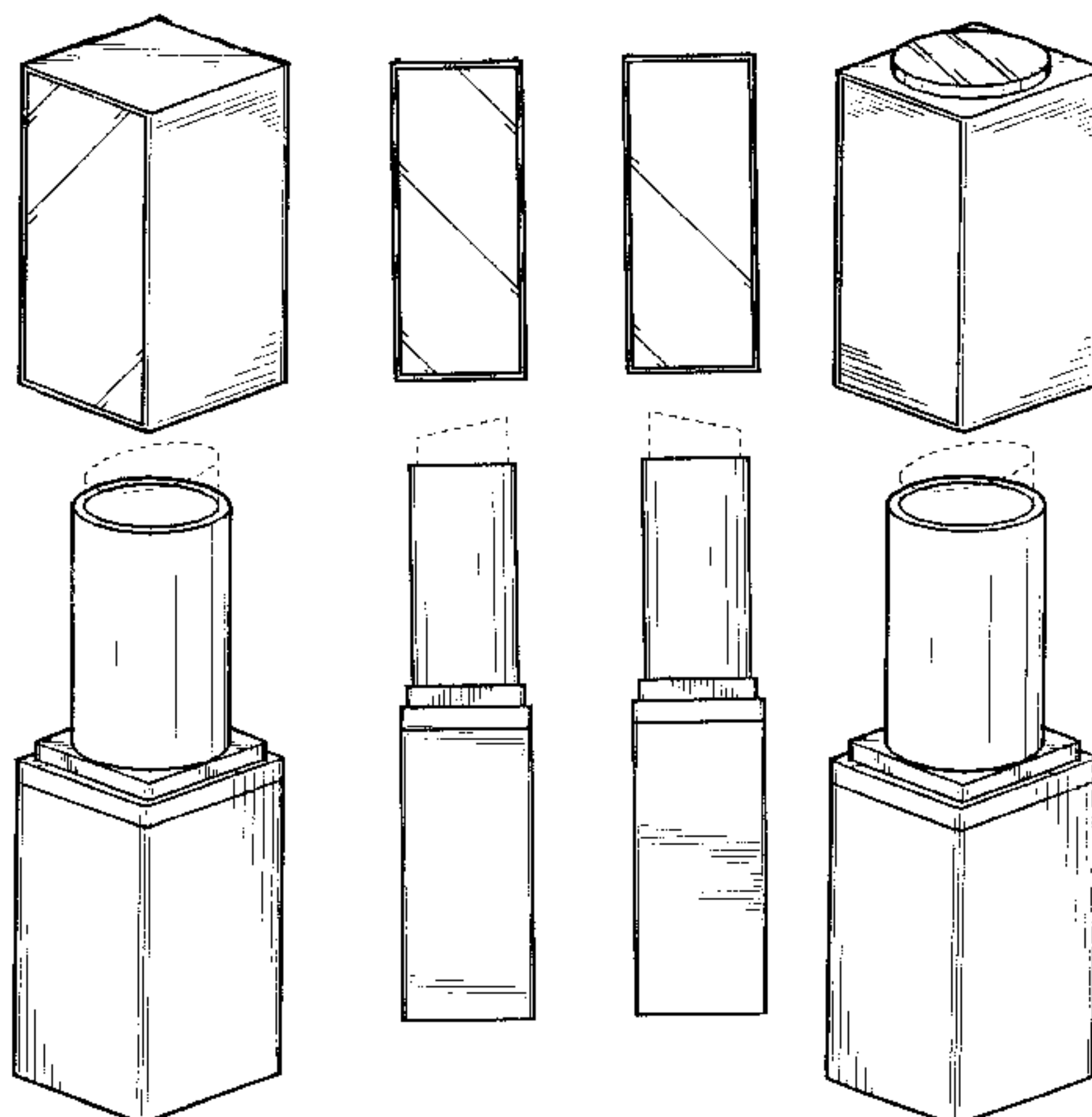
The ornamental design for a lipstick holder with reflective surface, as shown and described.

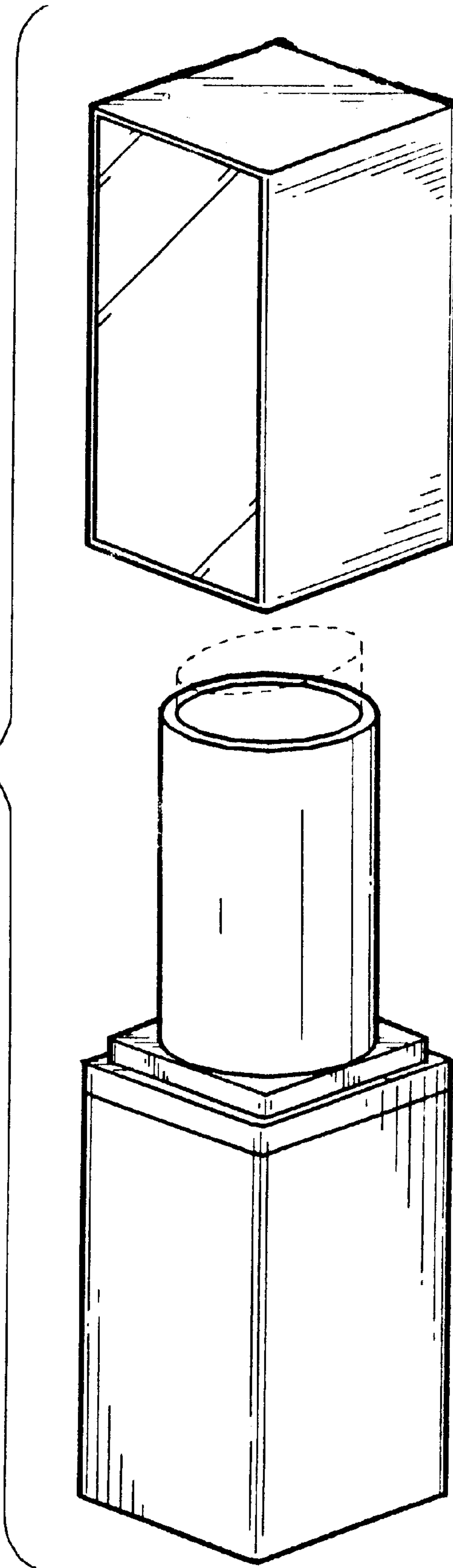

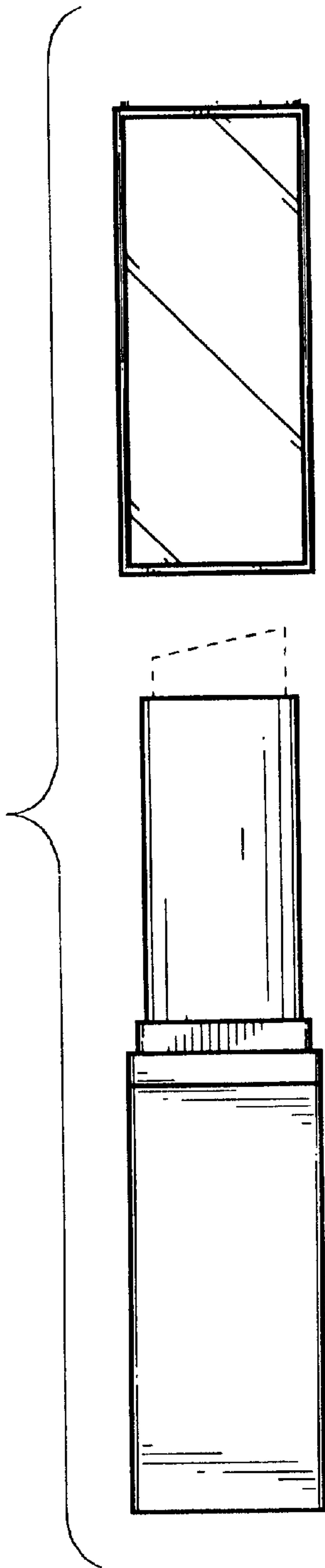

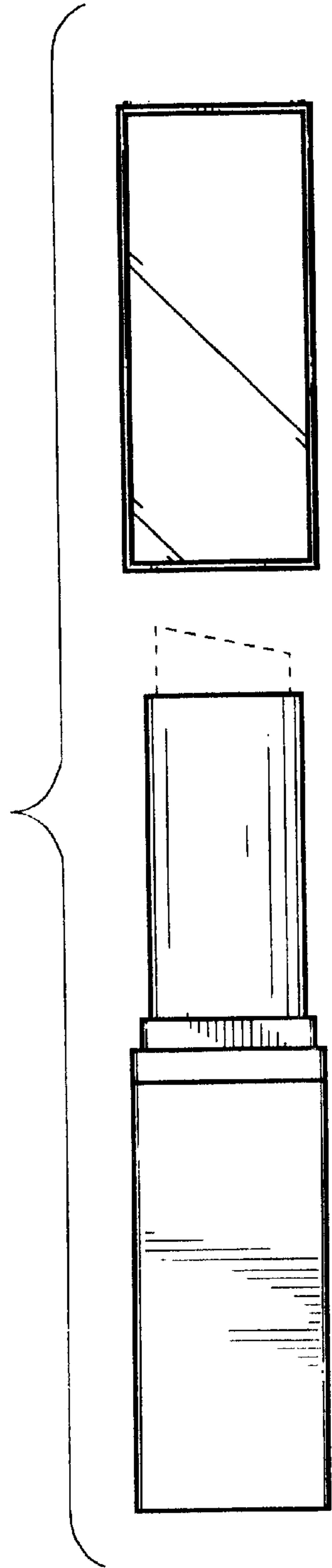

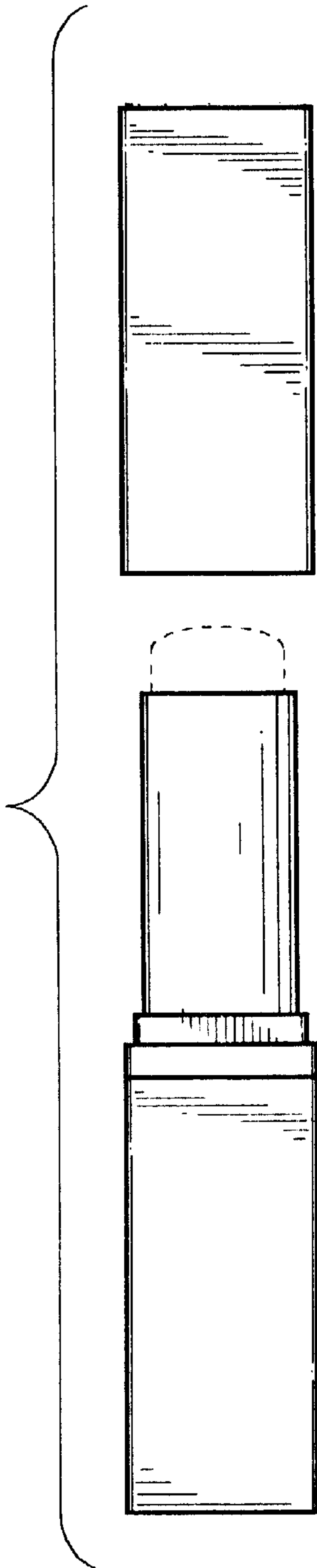
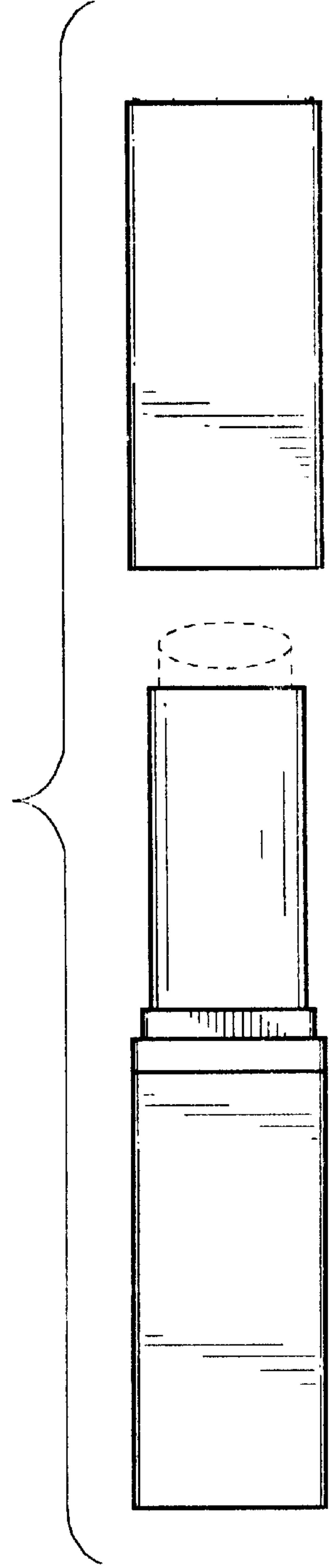

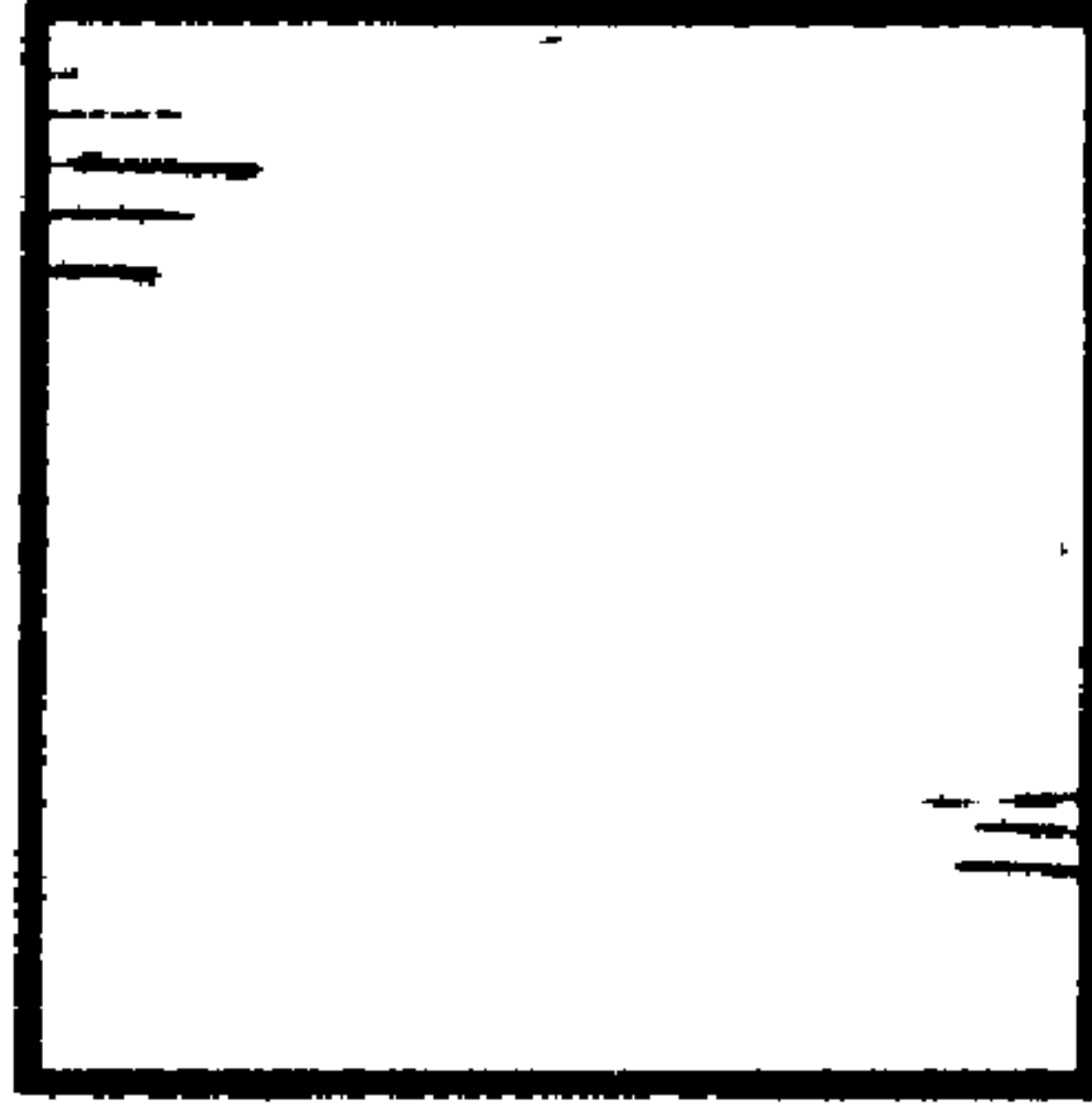

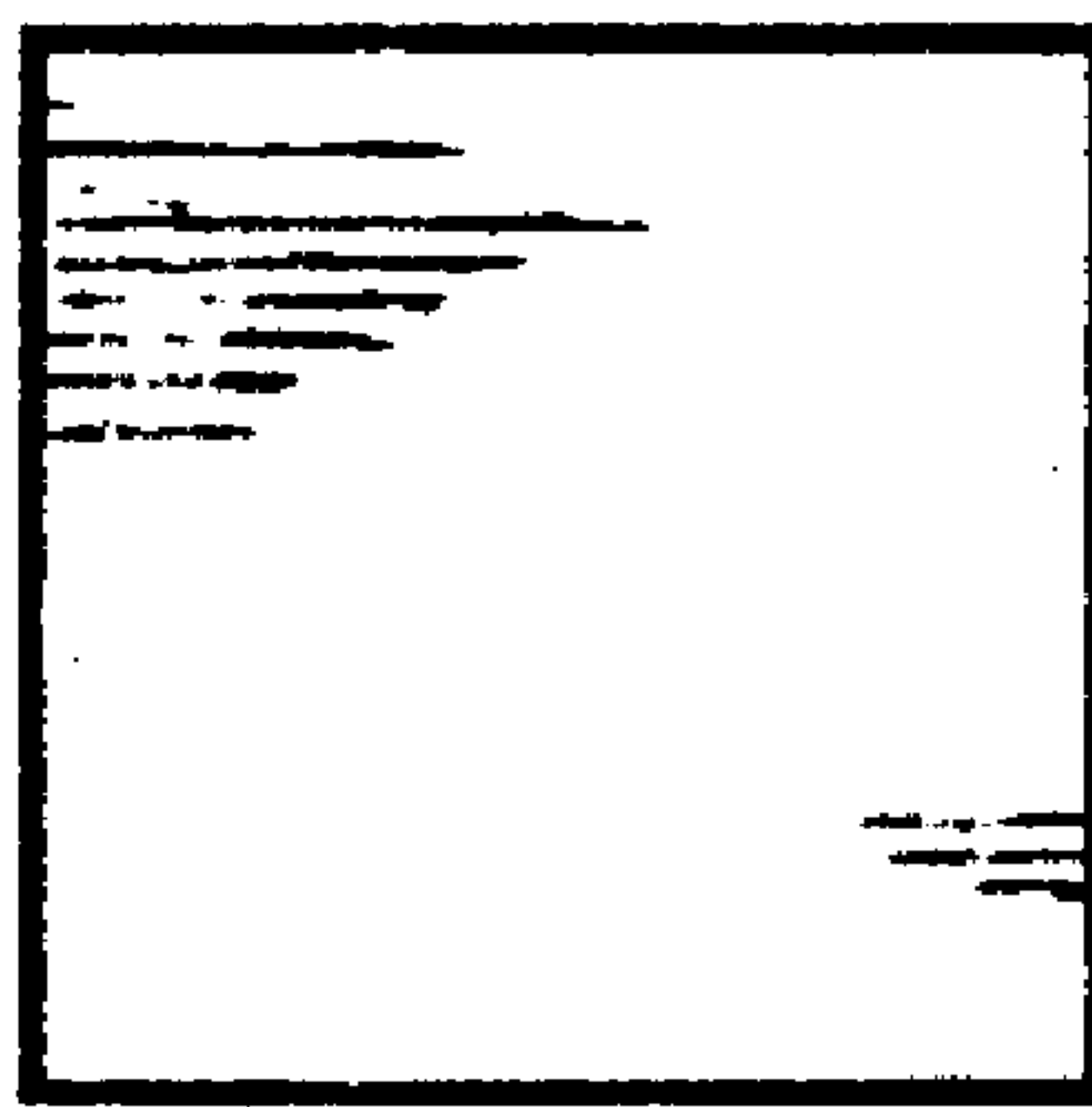

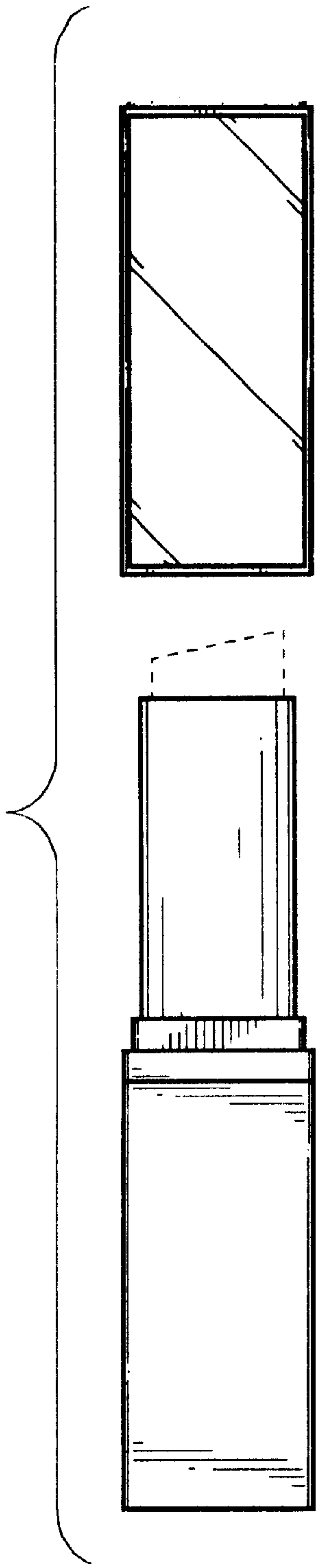

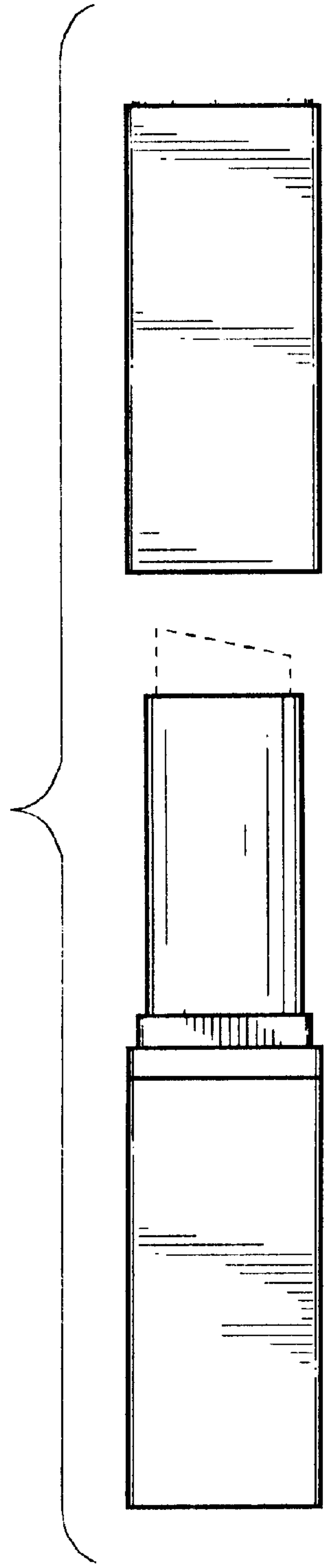

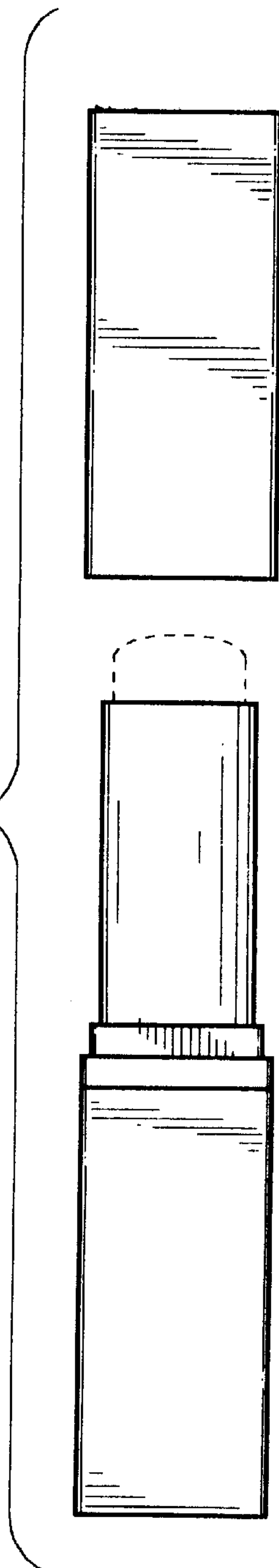

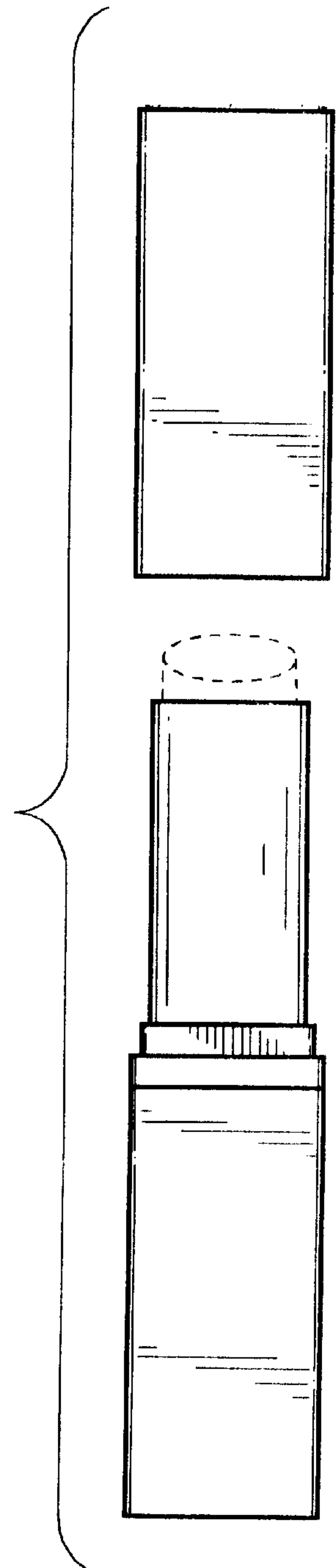

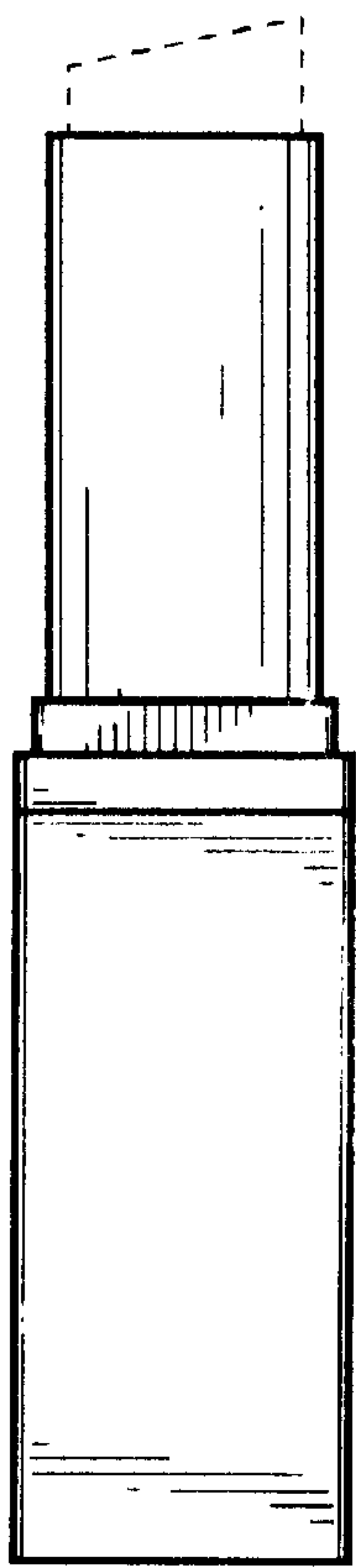
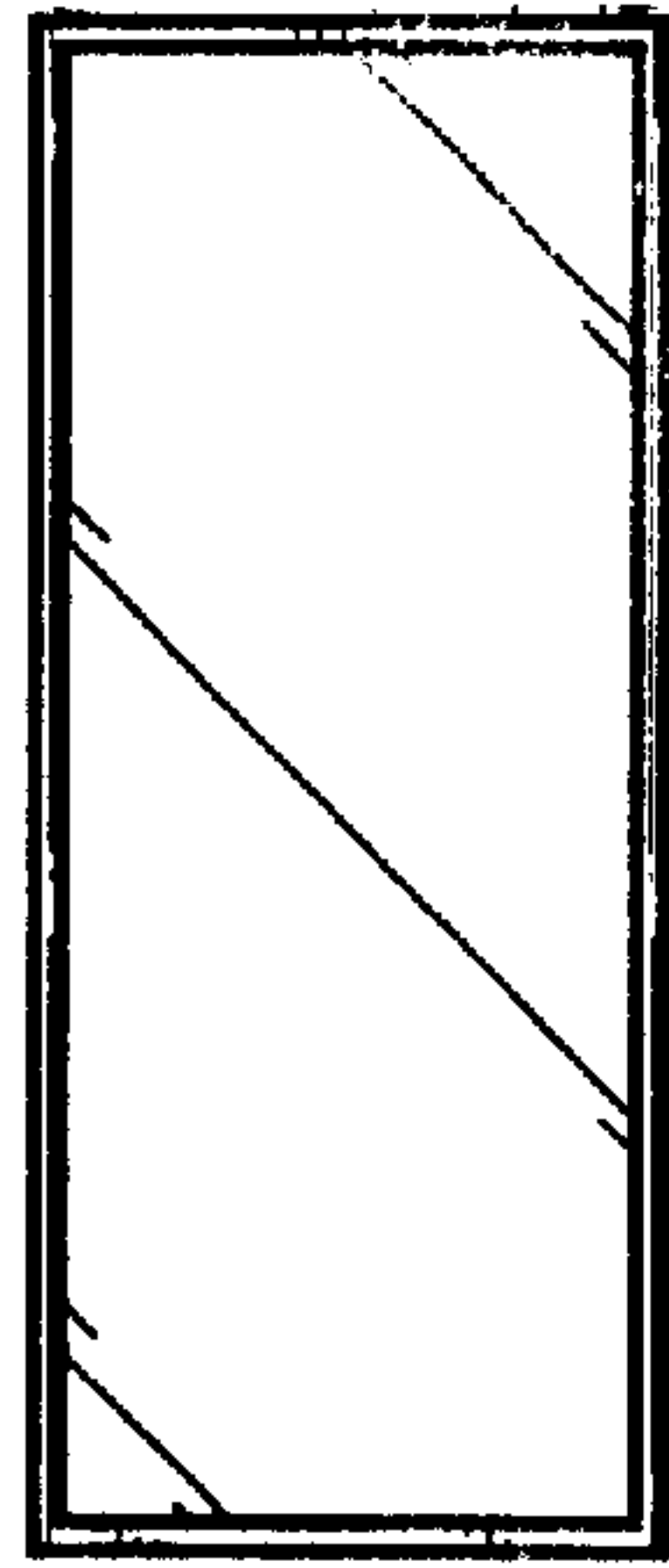

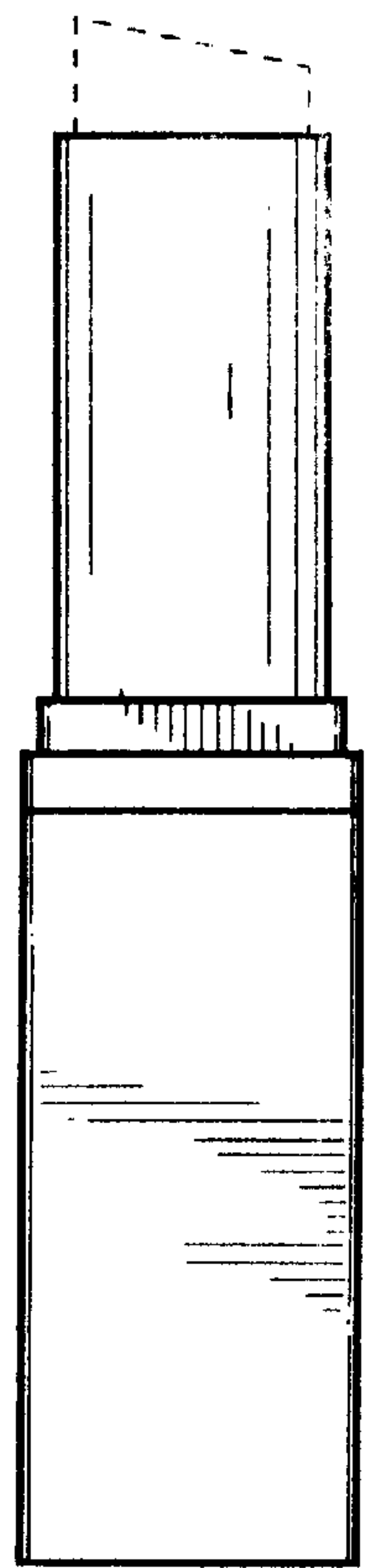
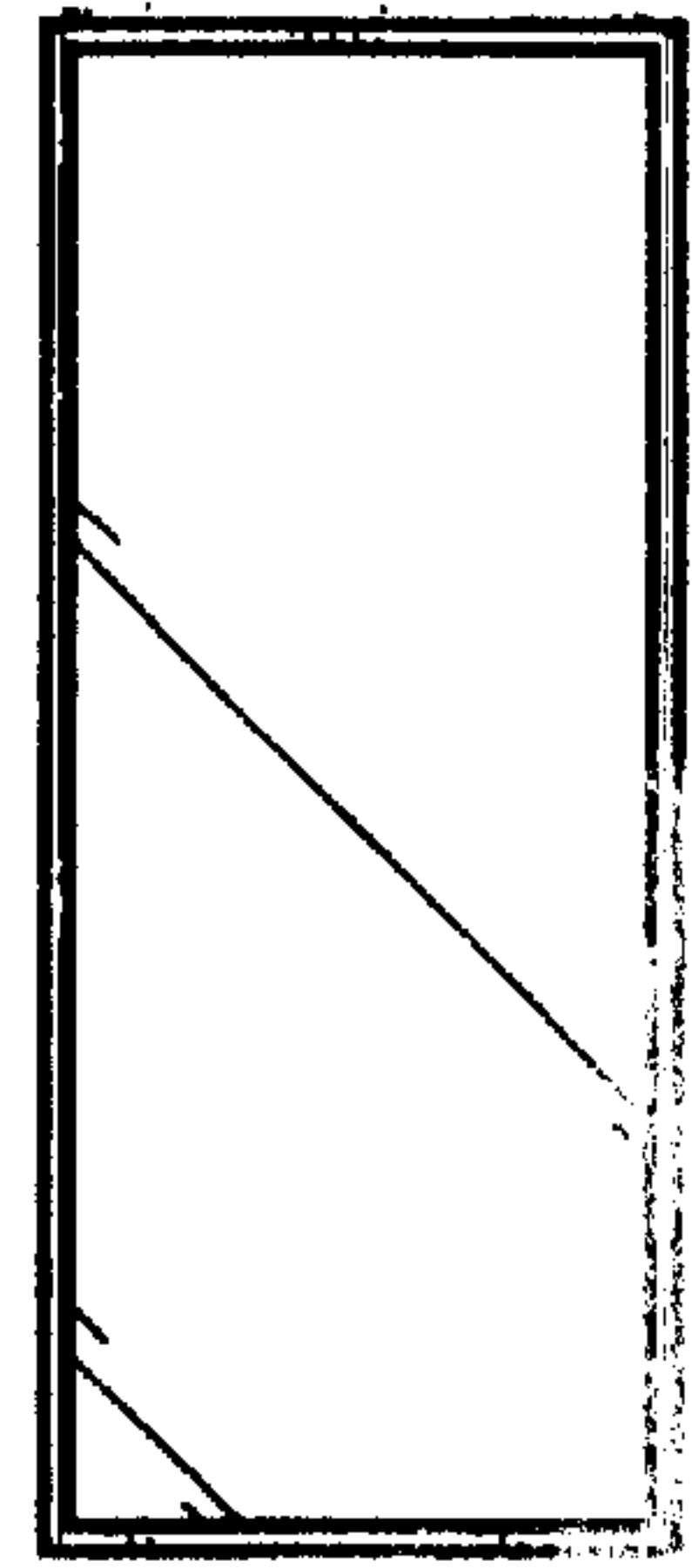

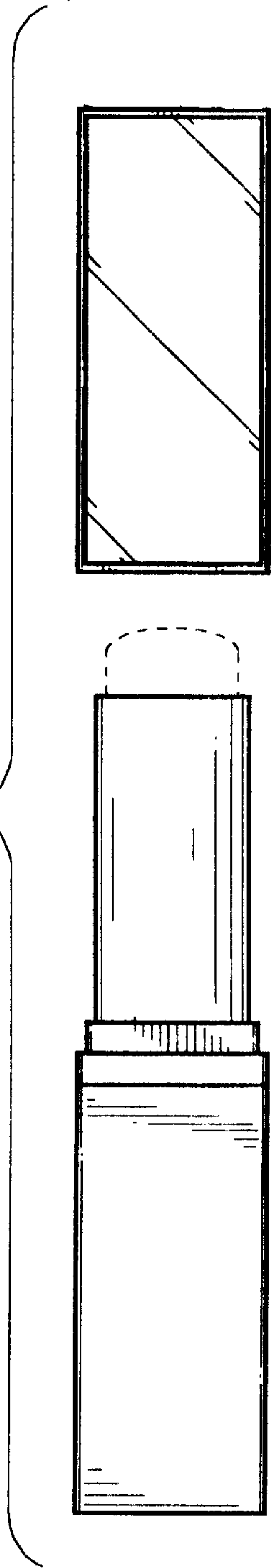

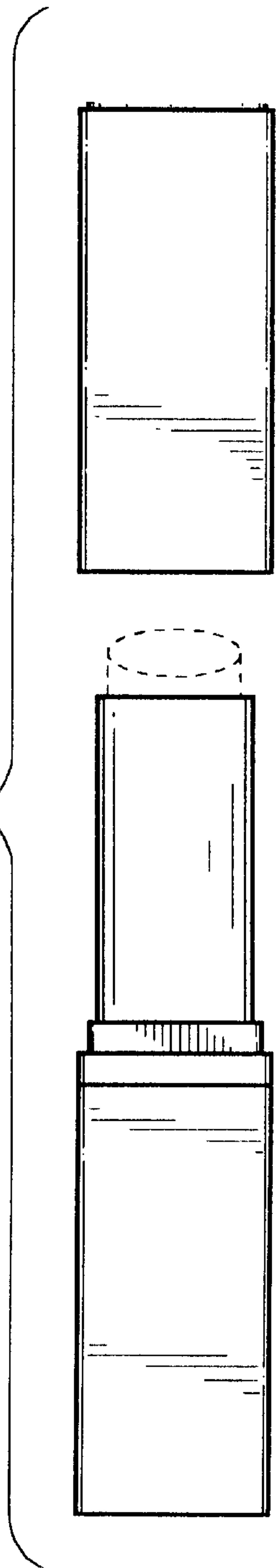

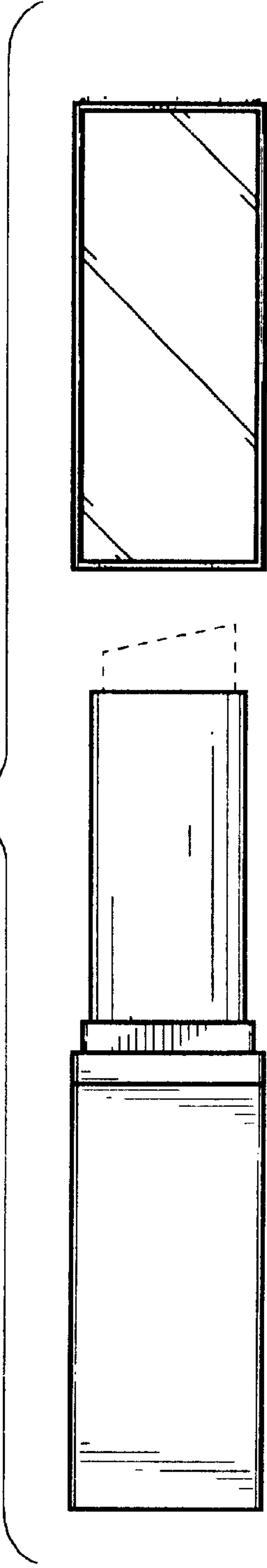

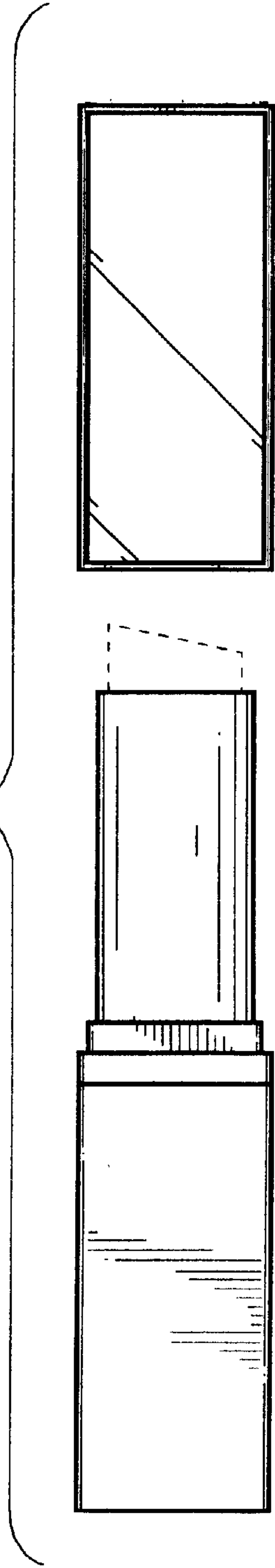

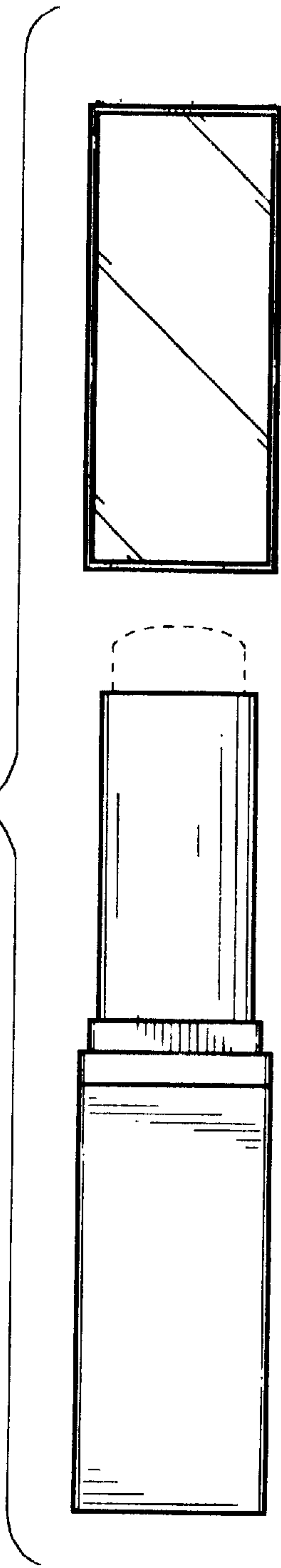

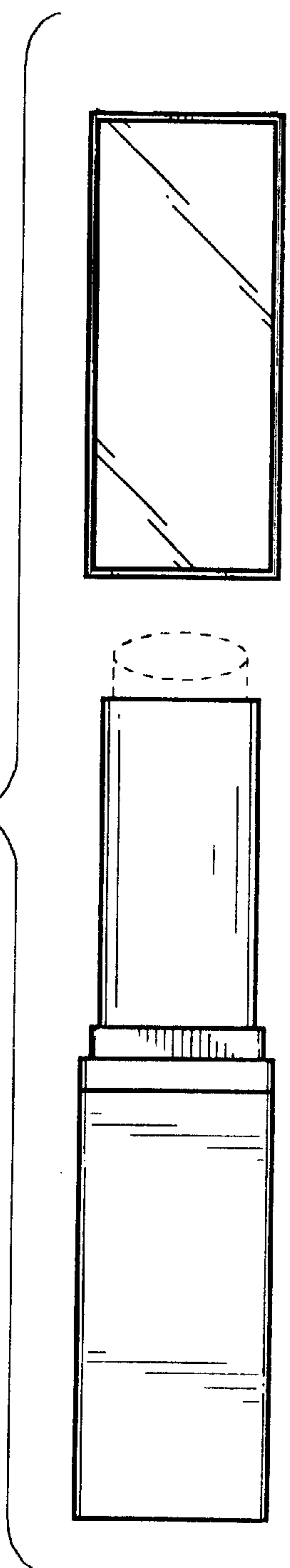

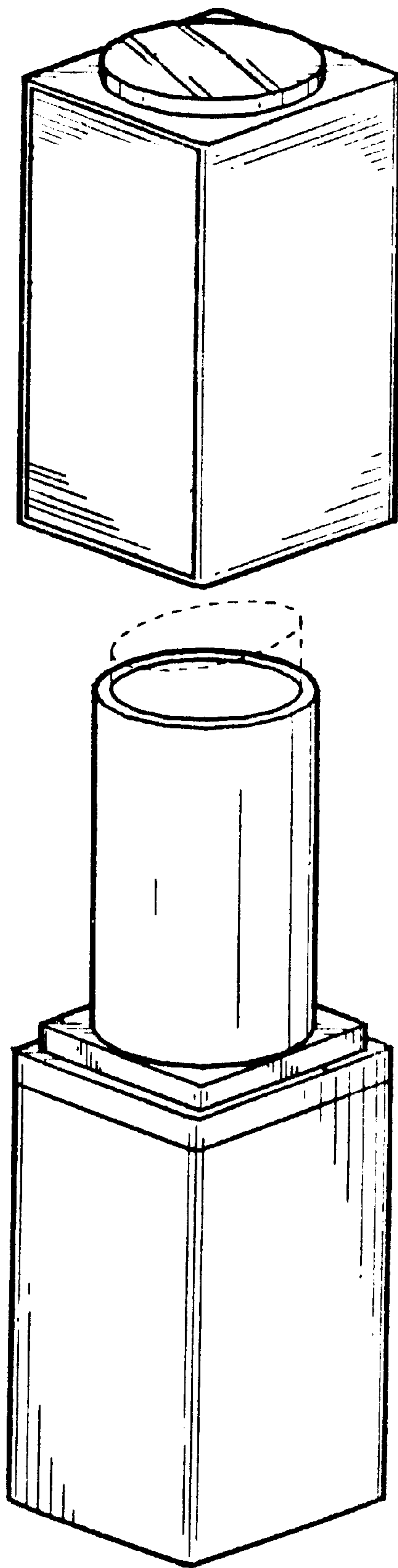

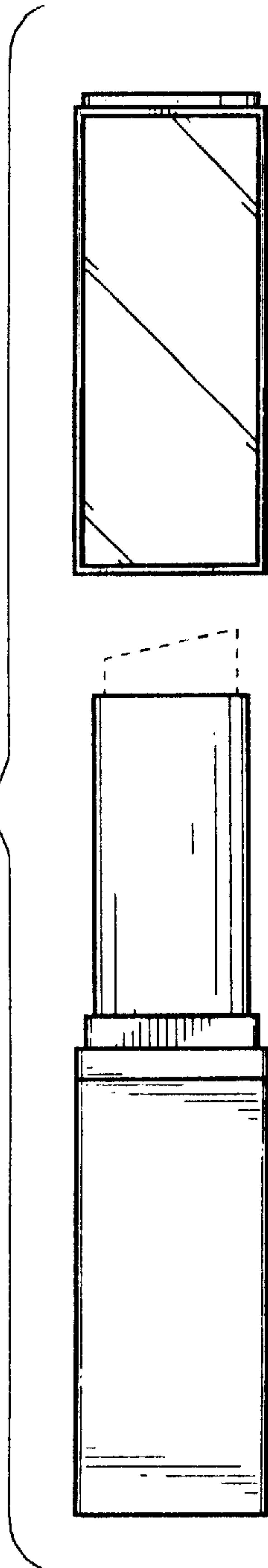

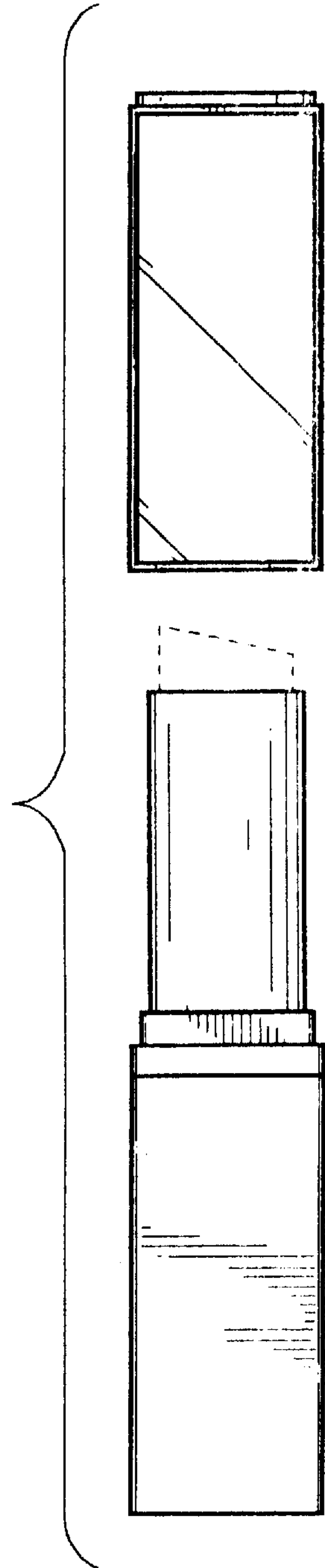

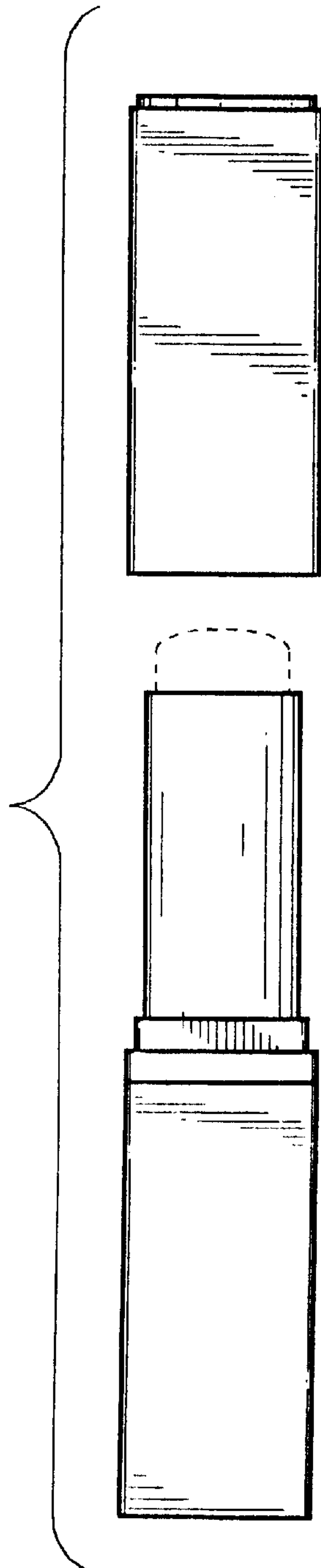
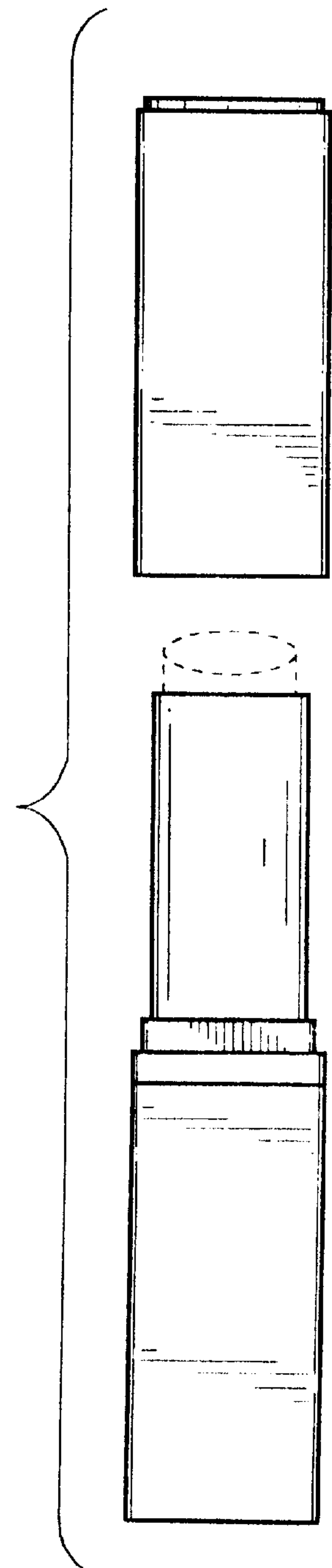

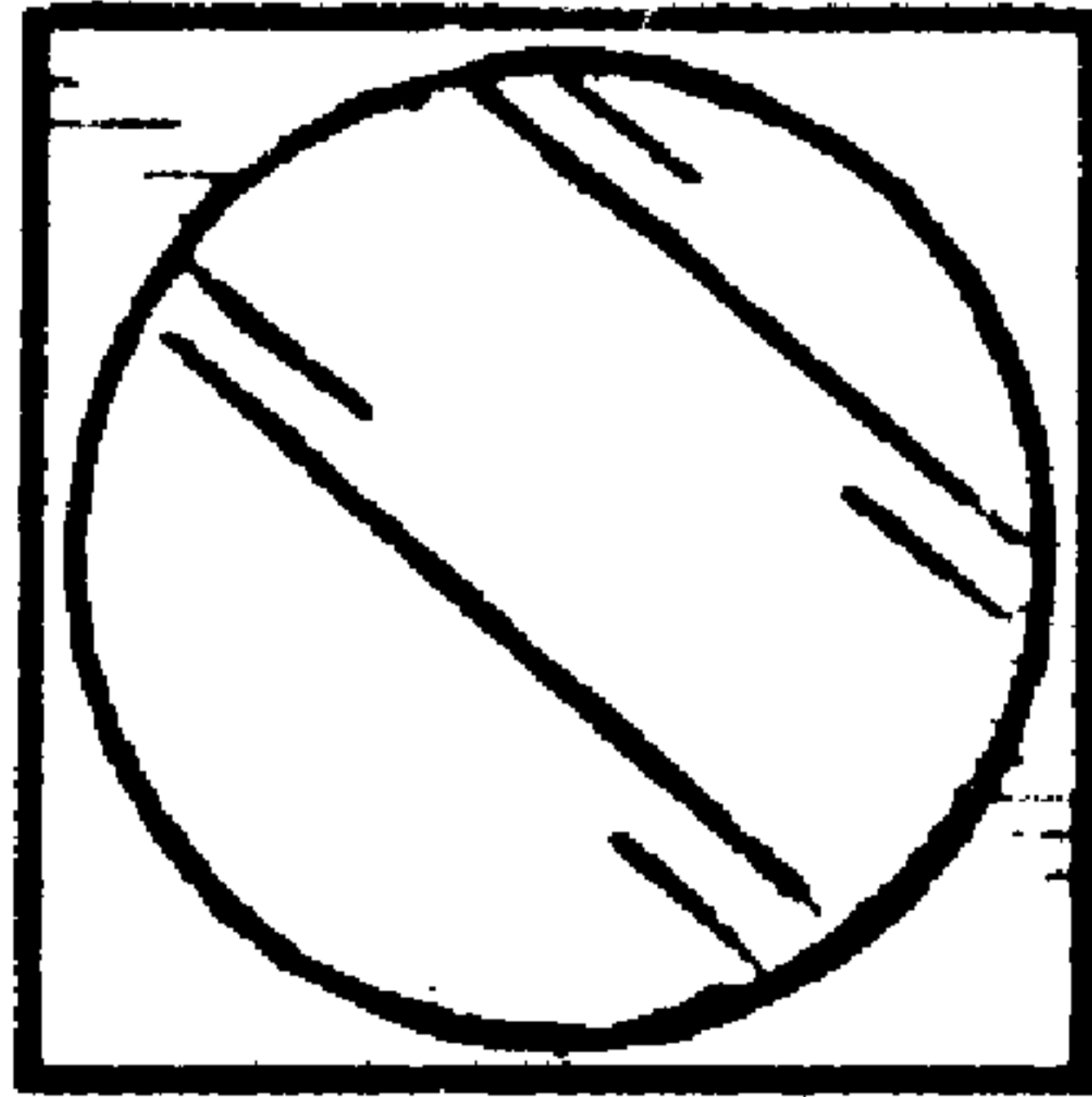

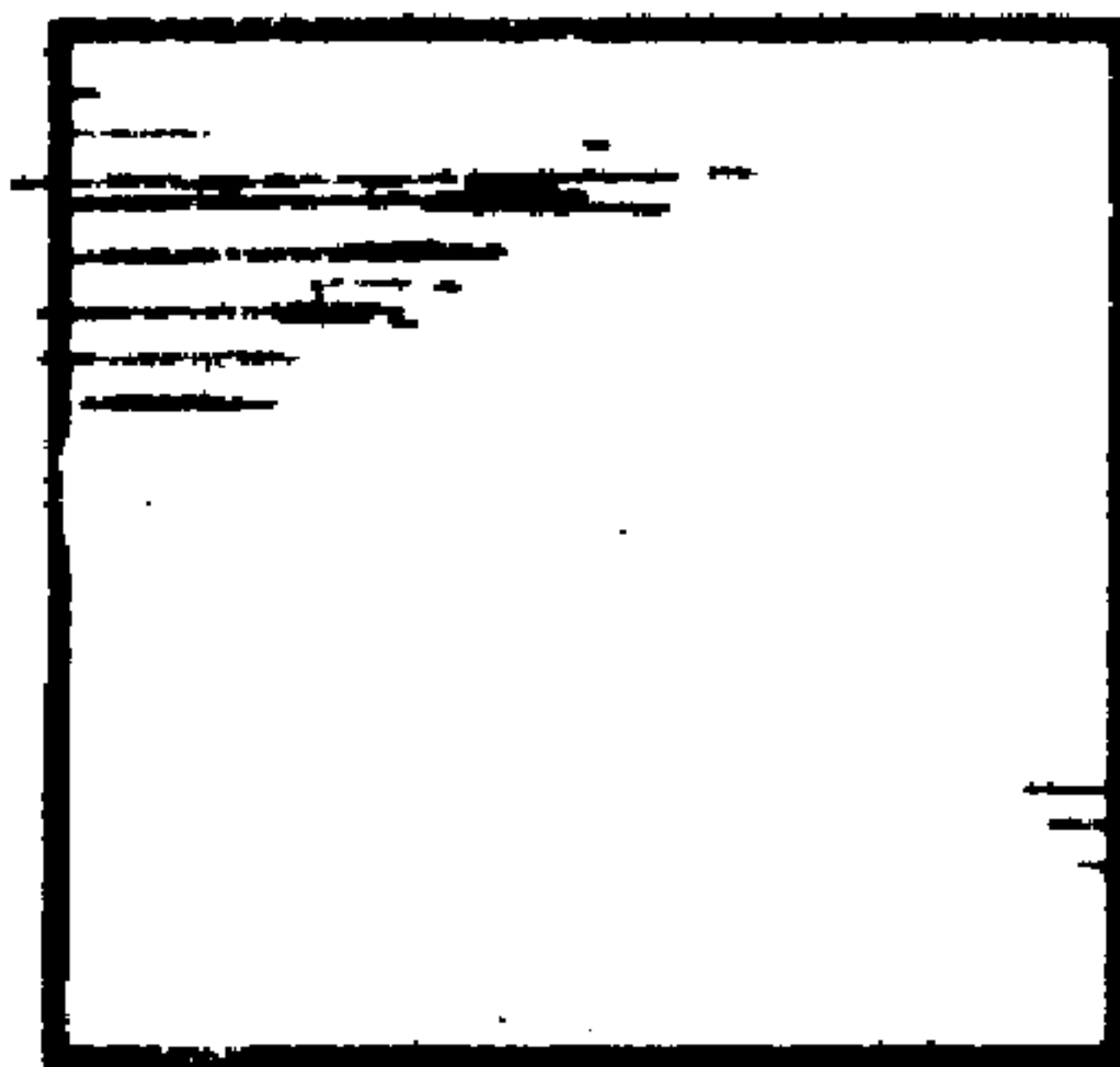

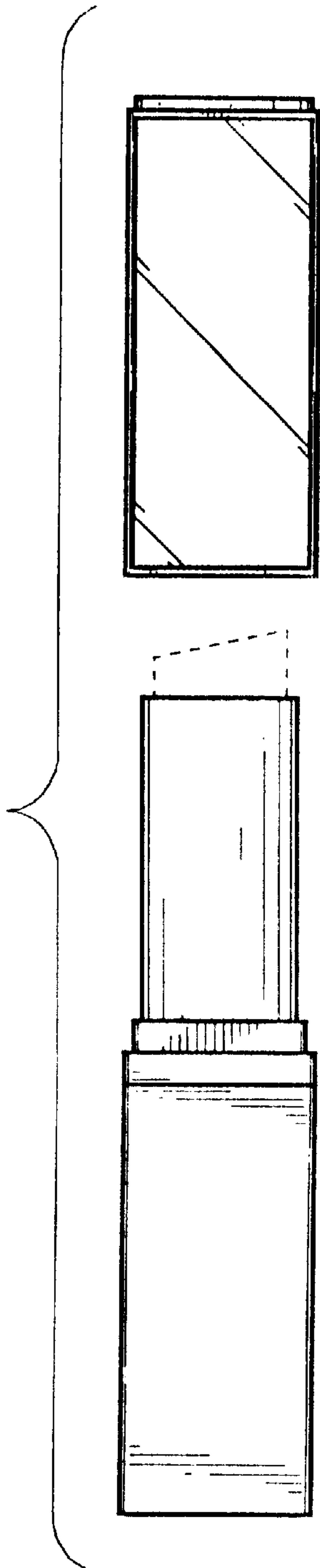

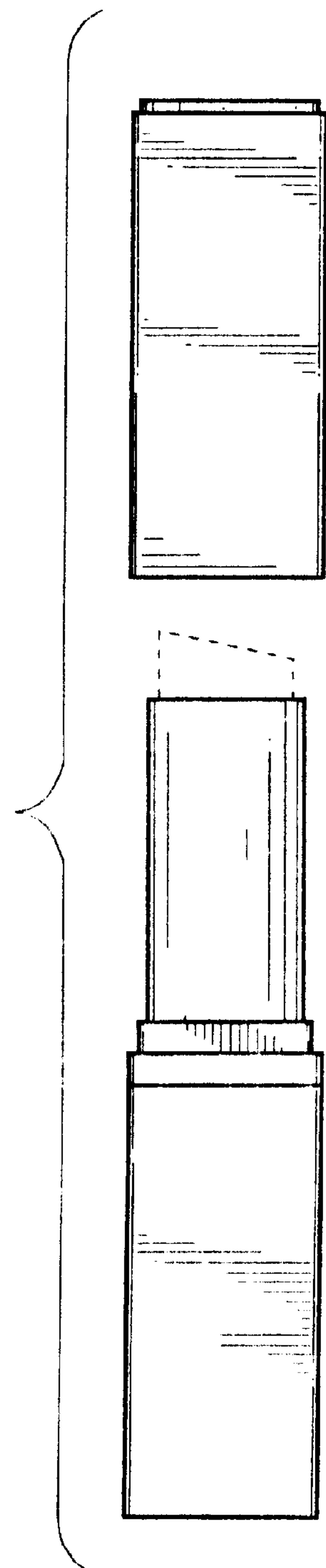

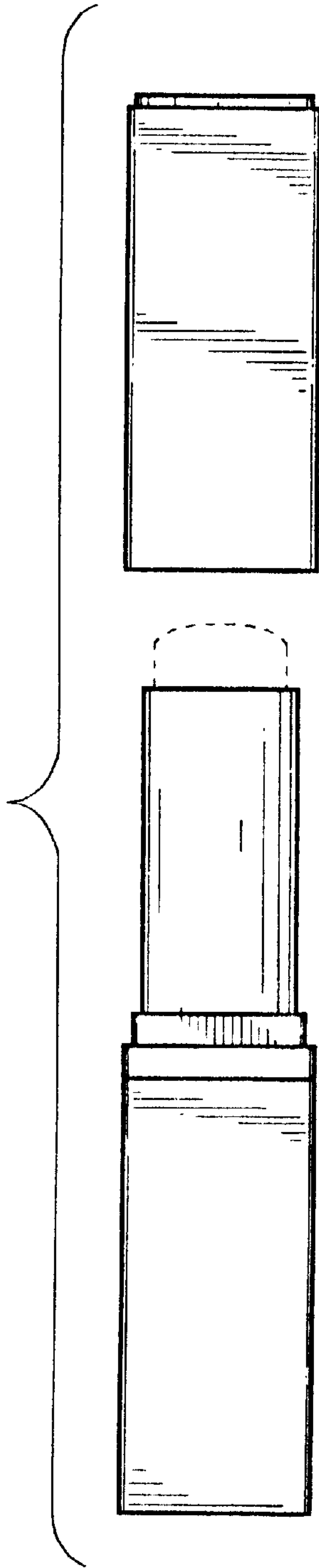

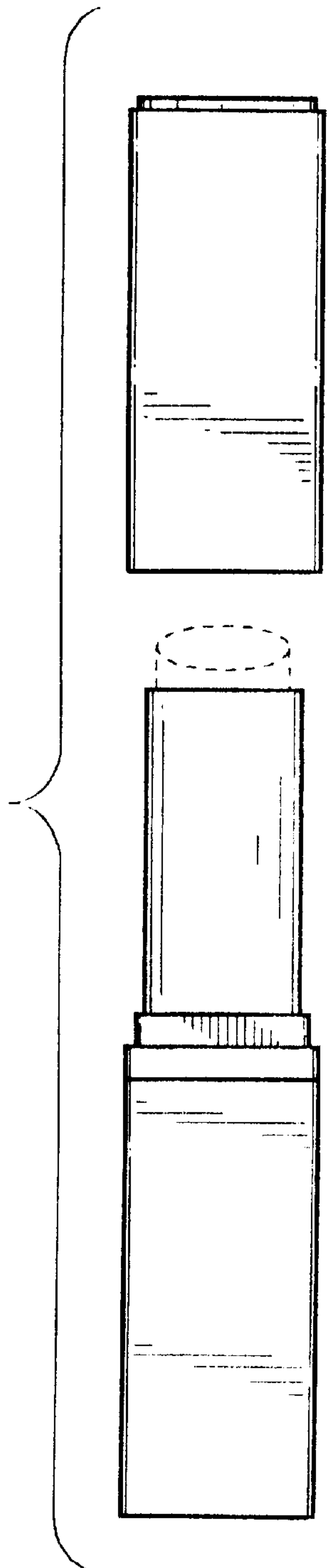

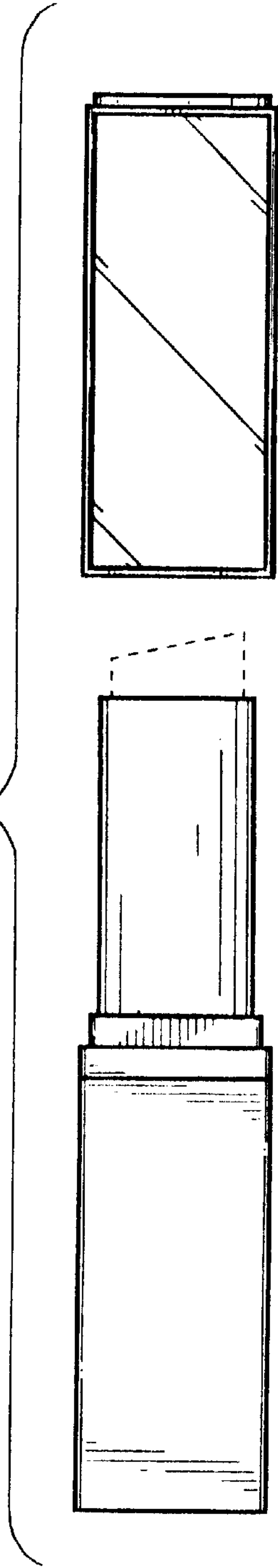

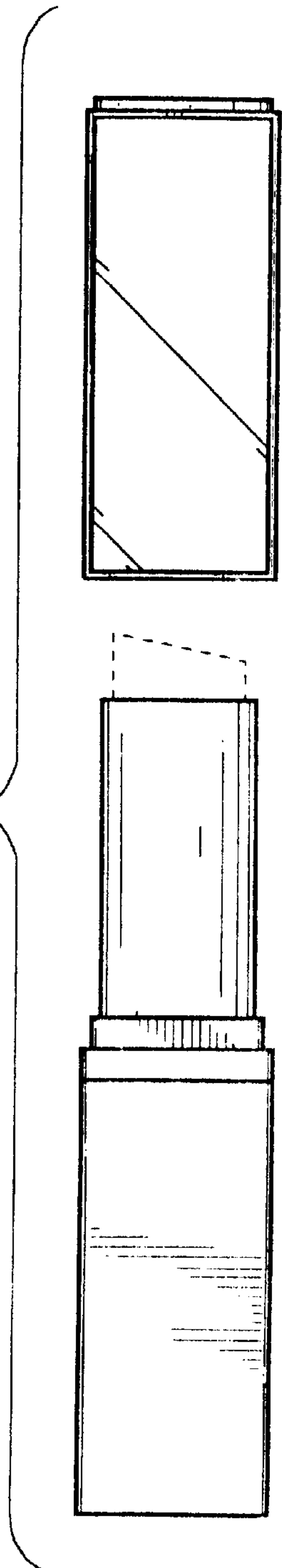

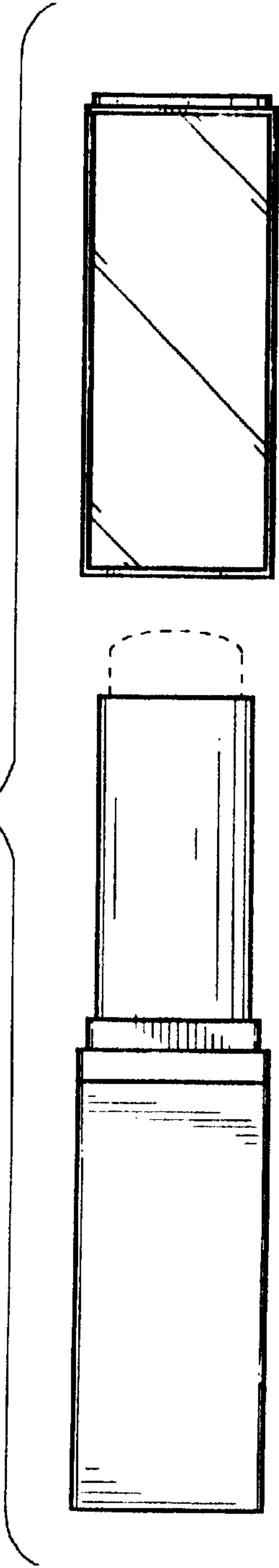

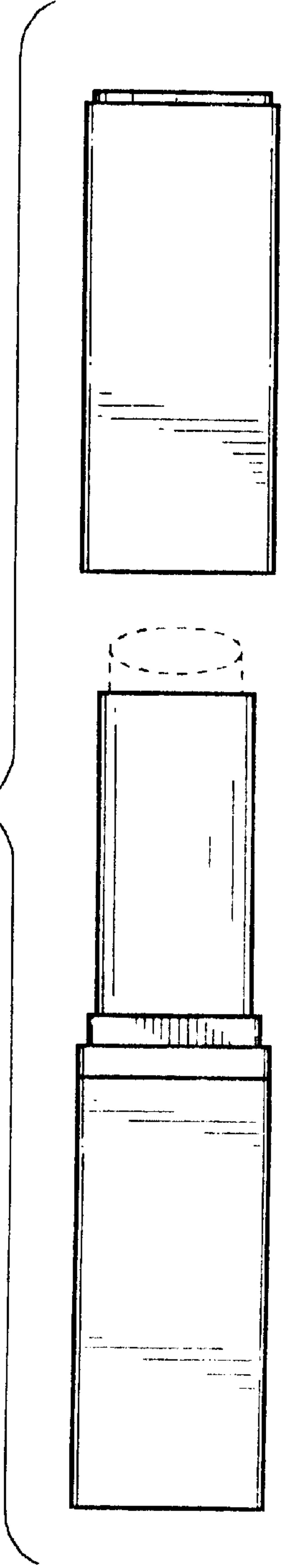

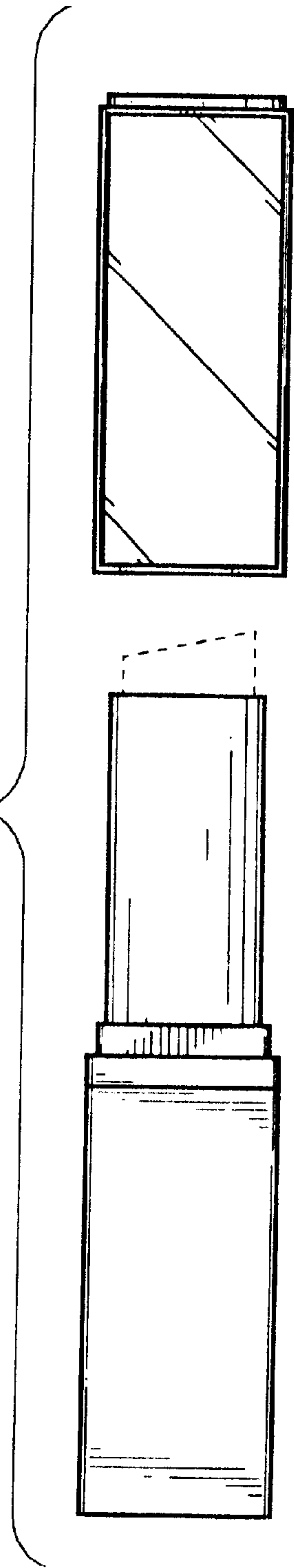

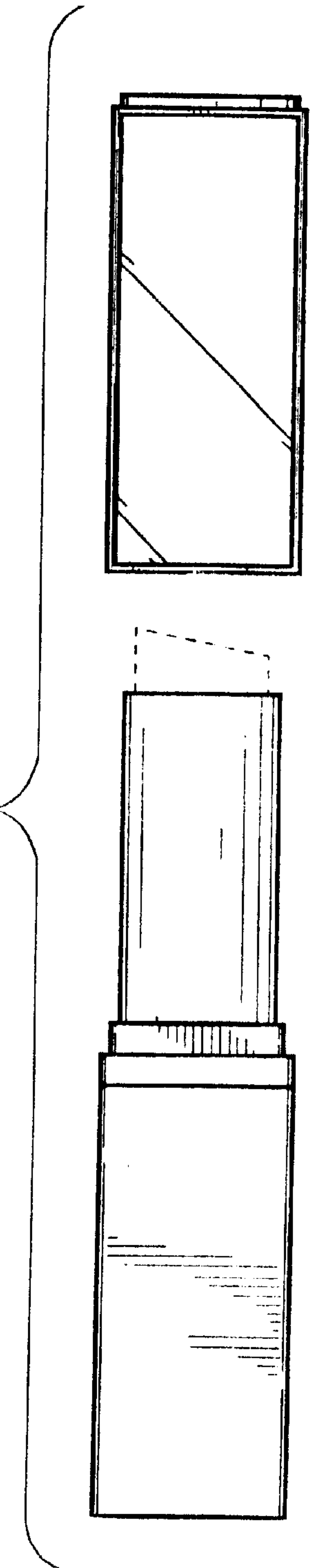

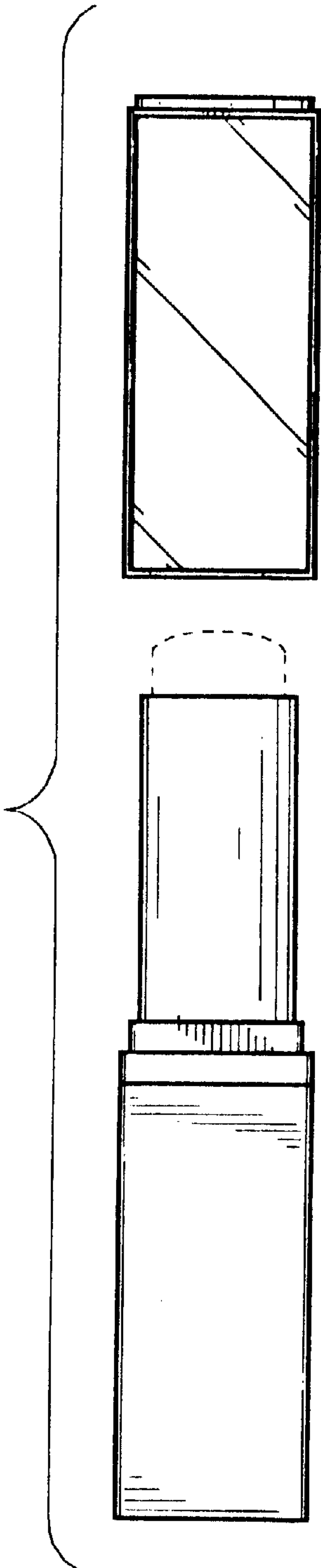
