FIG. 2 is a front elevational view thereof,

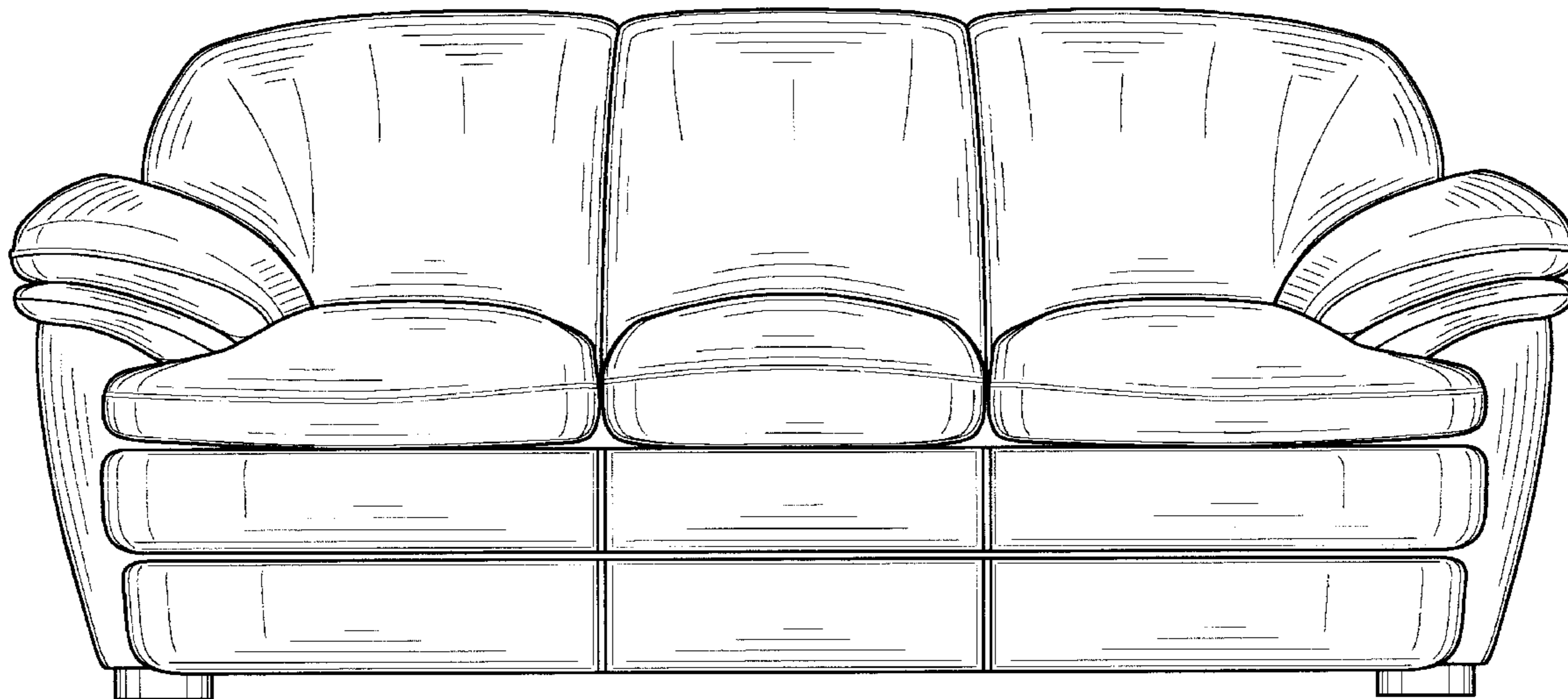
FIG. 3 is a top view thereof,

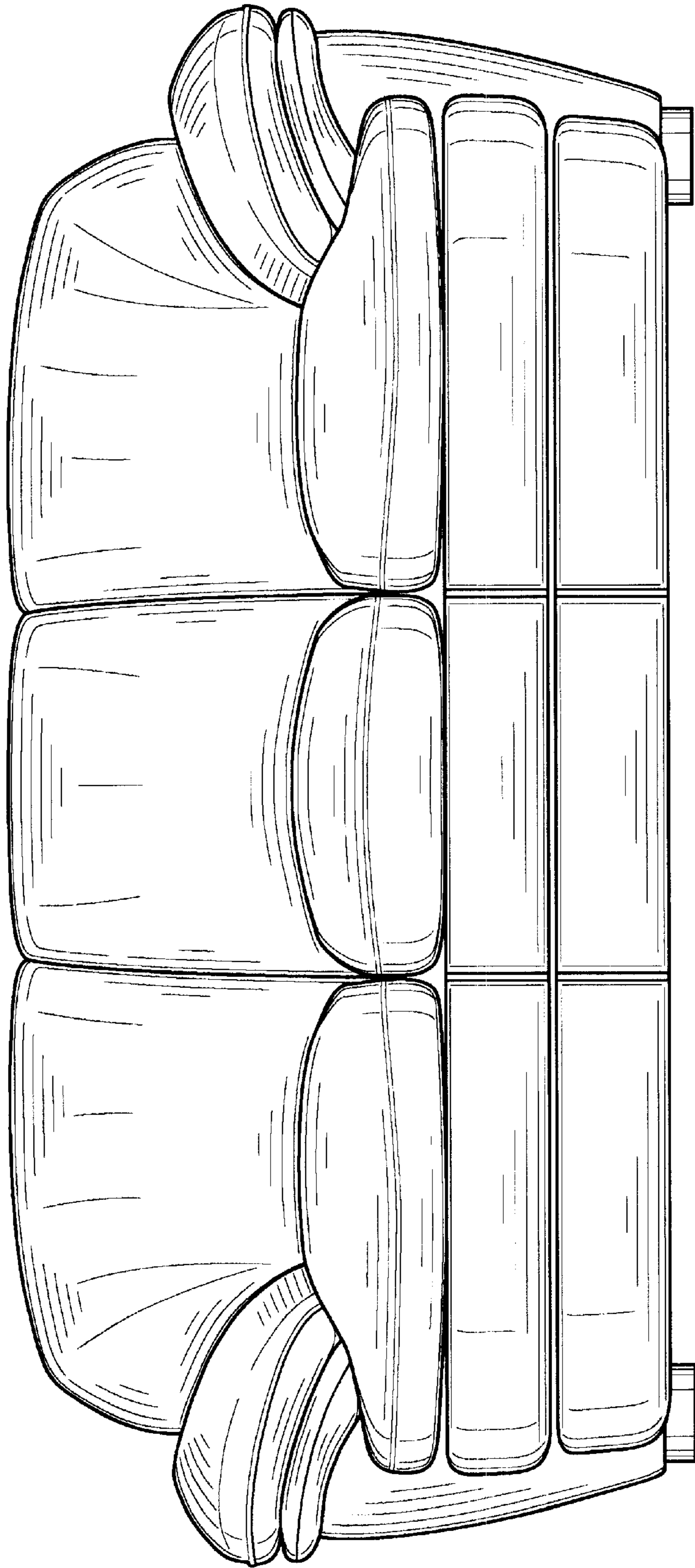

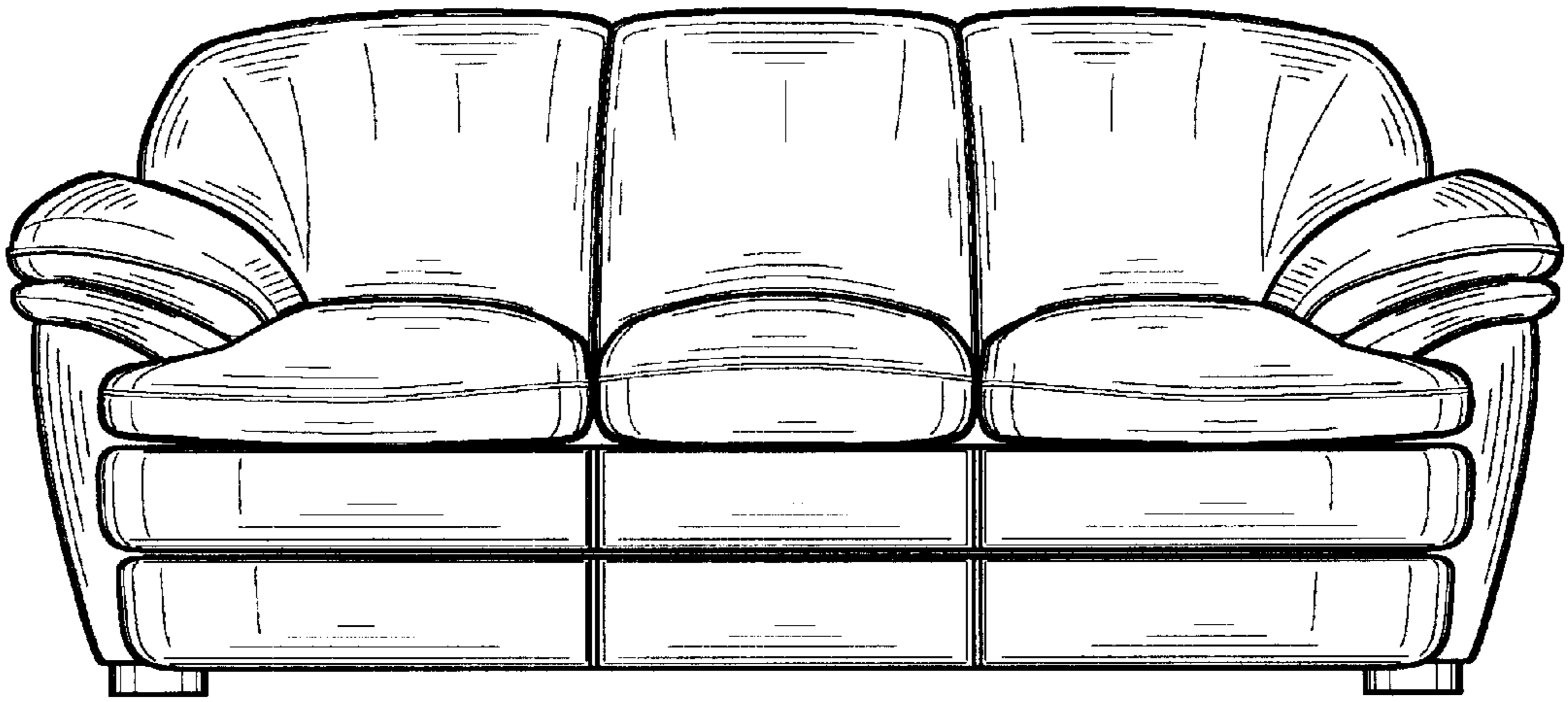

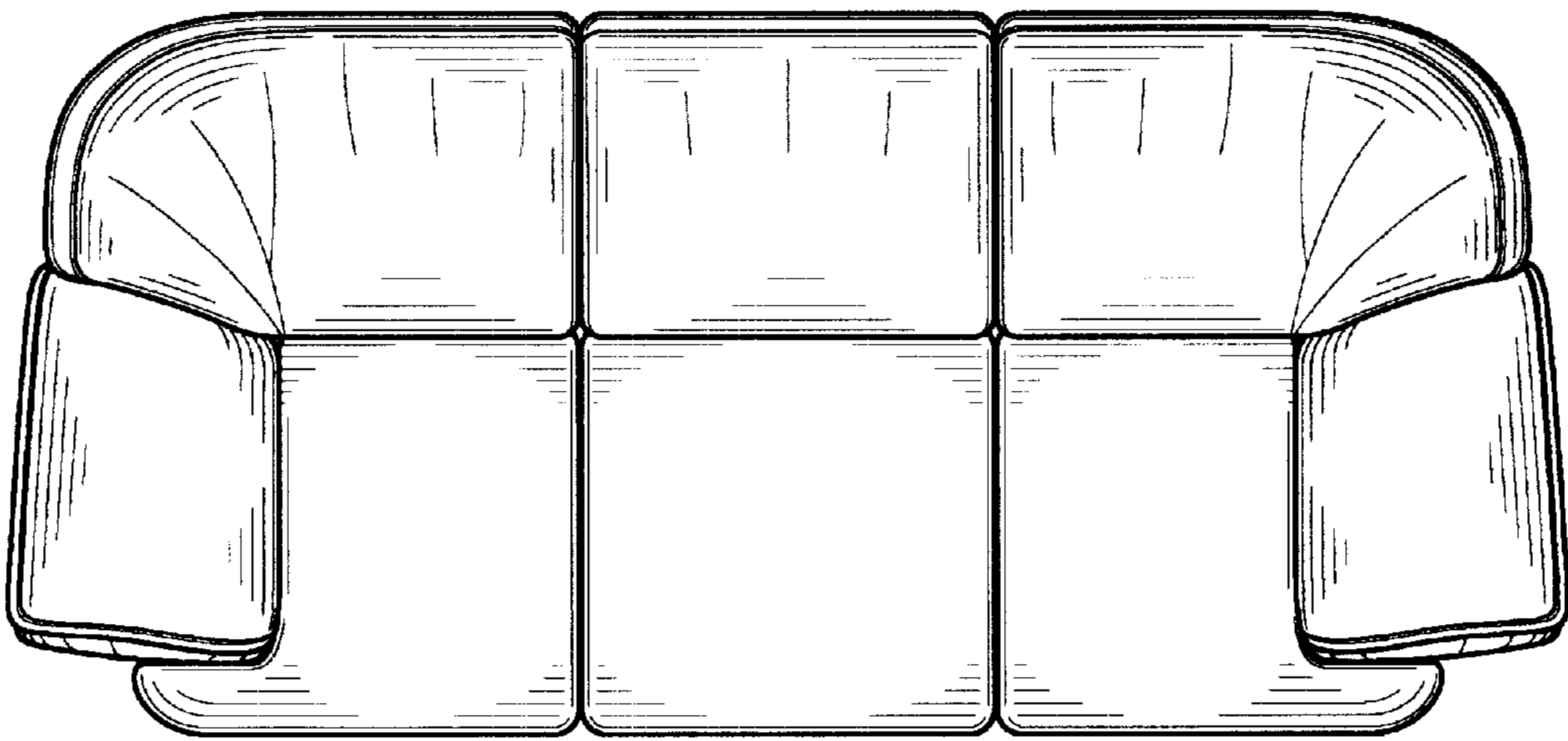

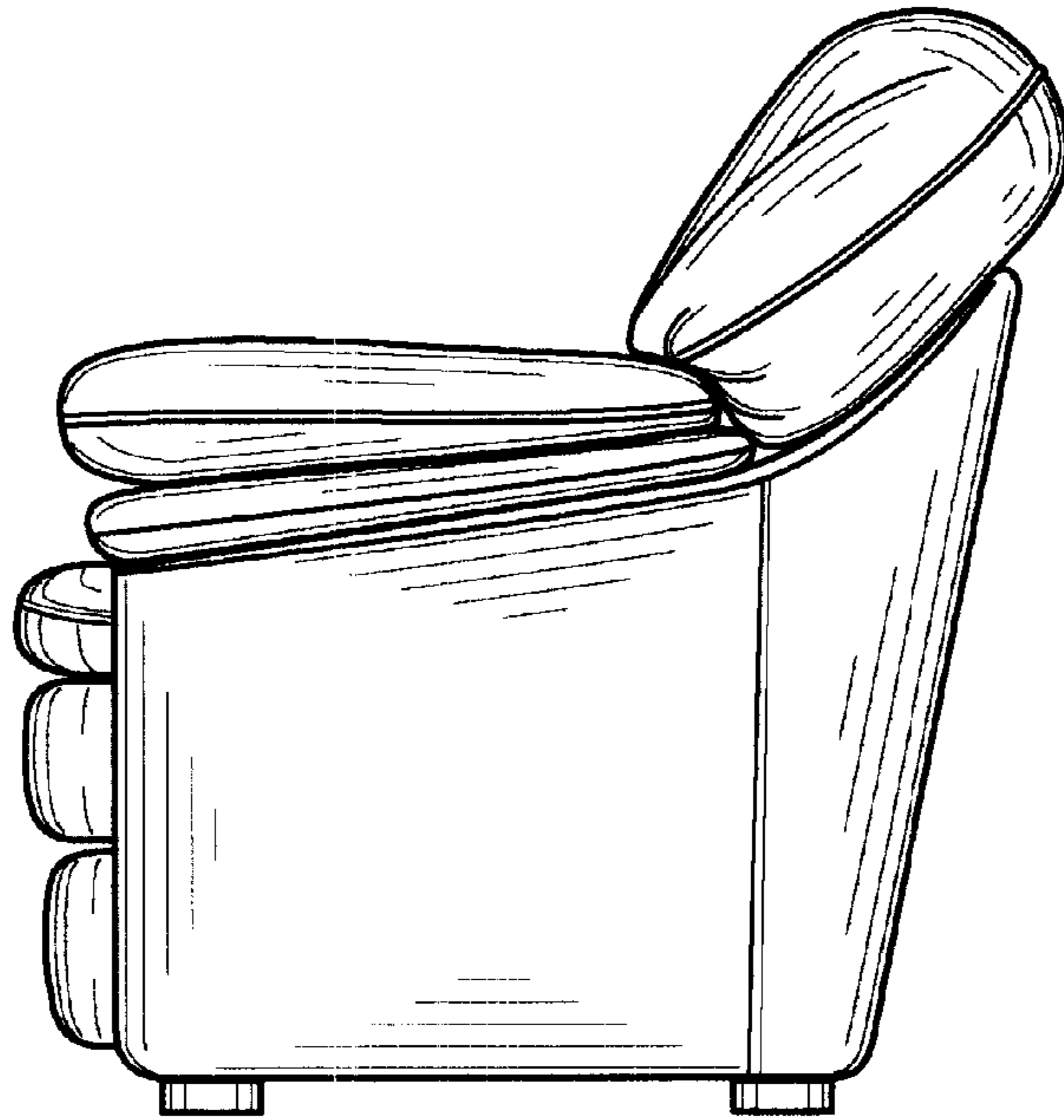

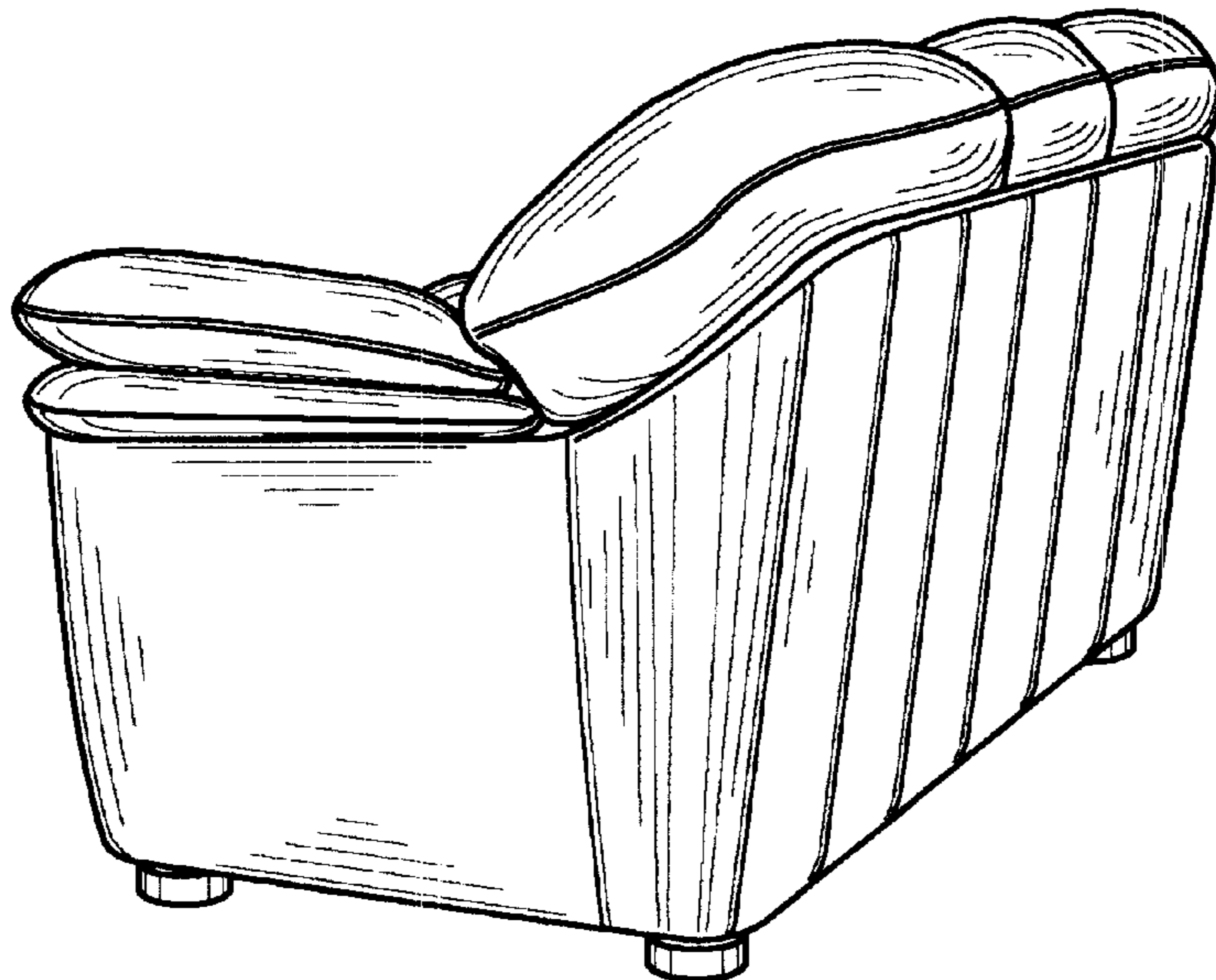

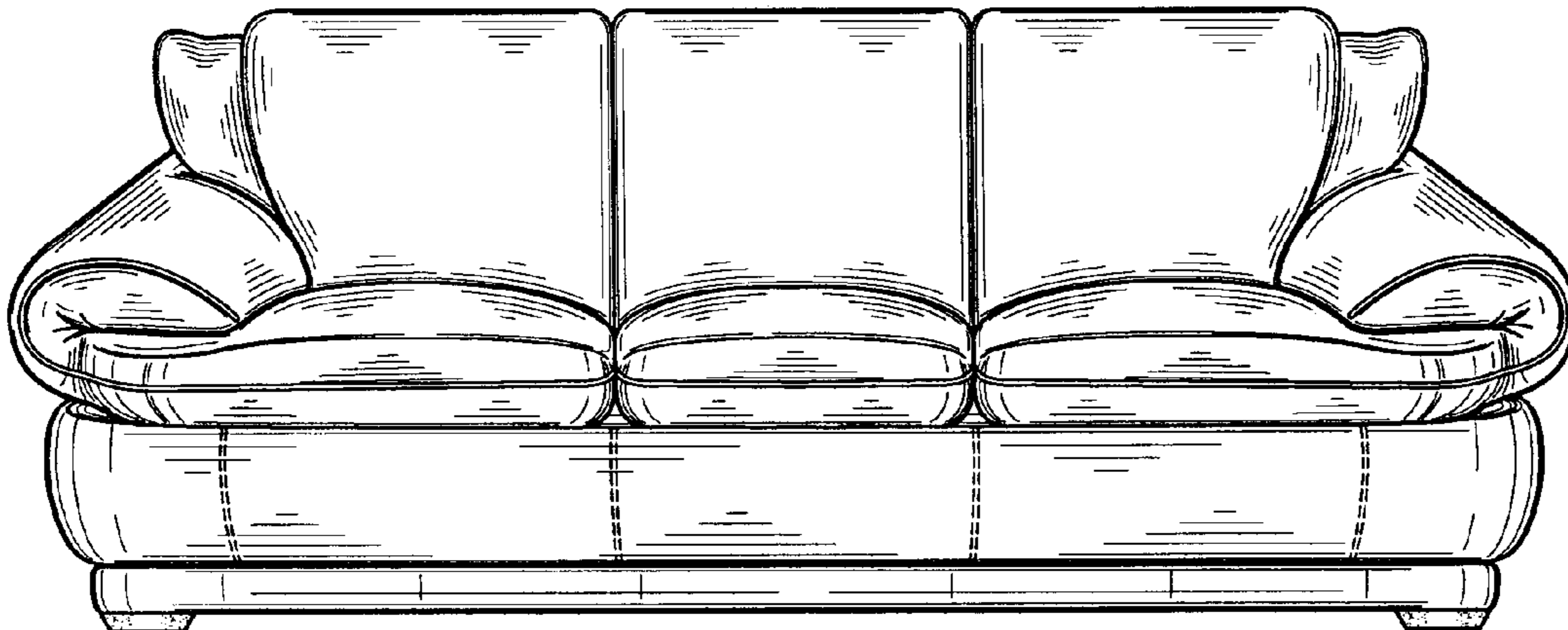

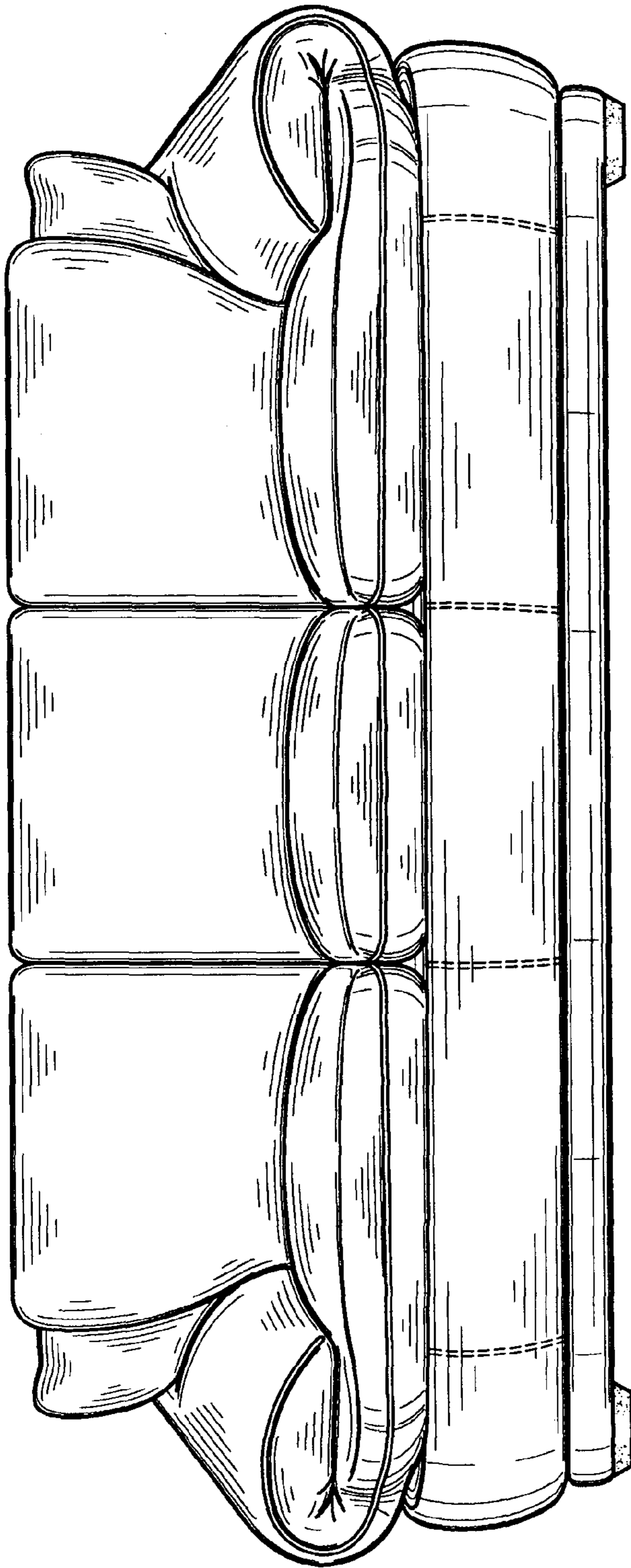

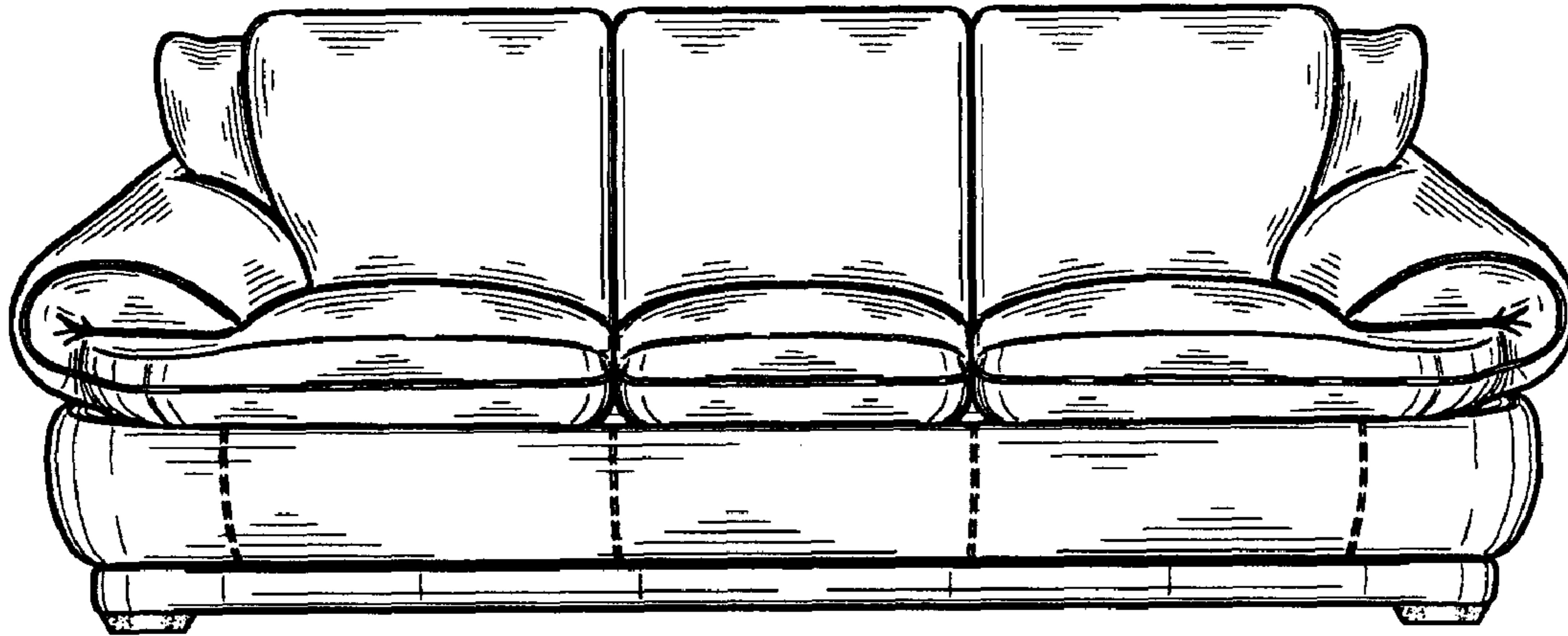

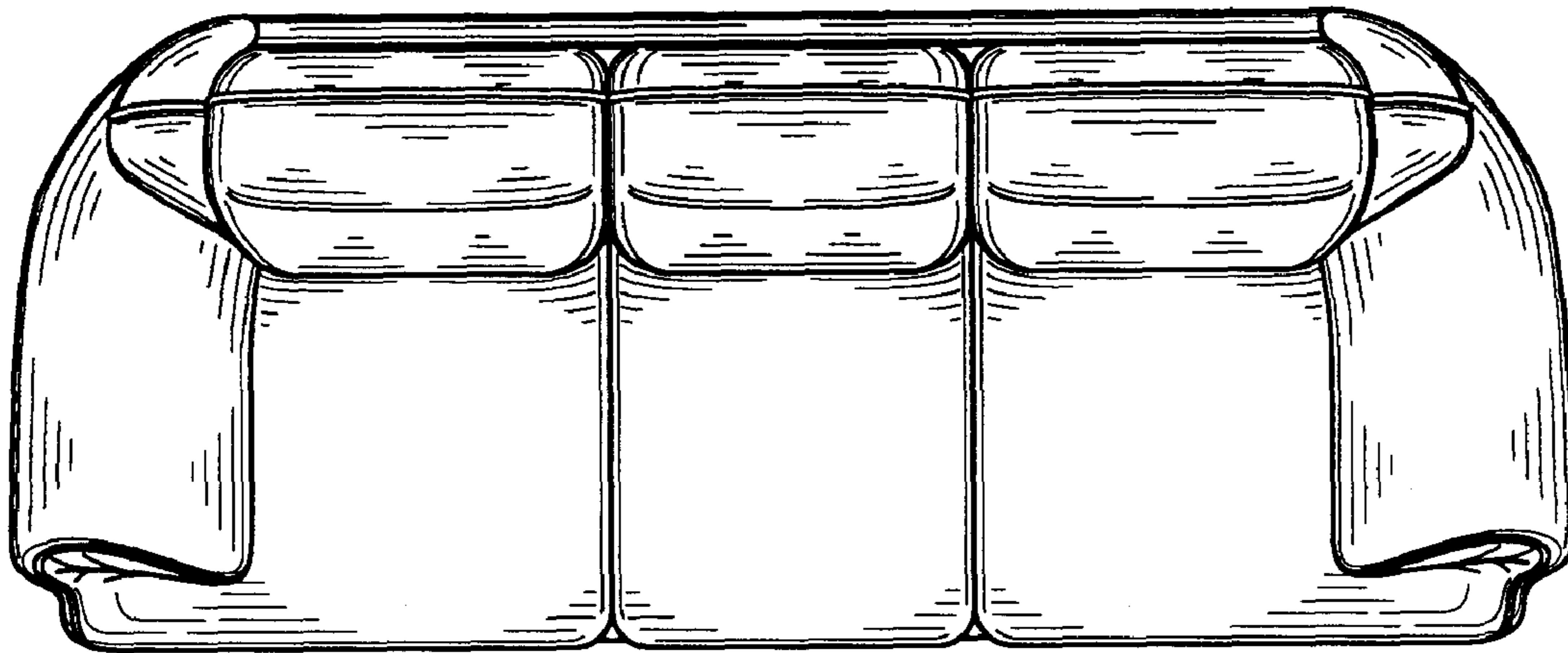

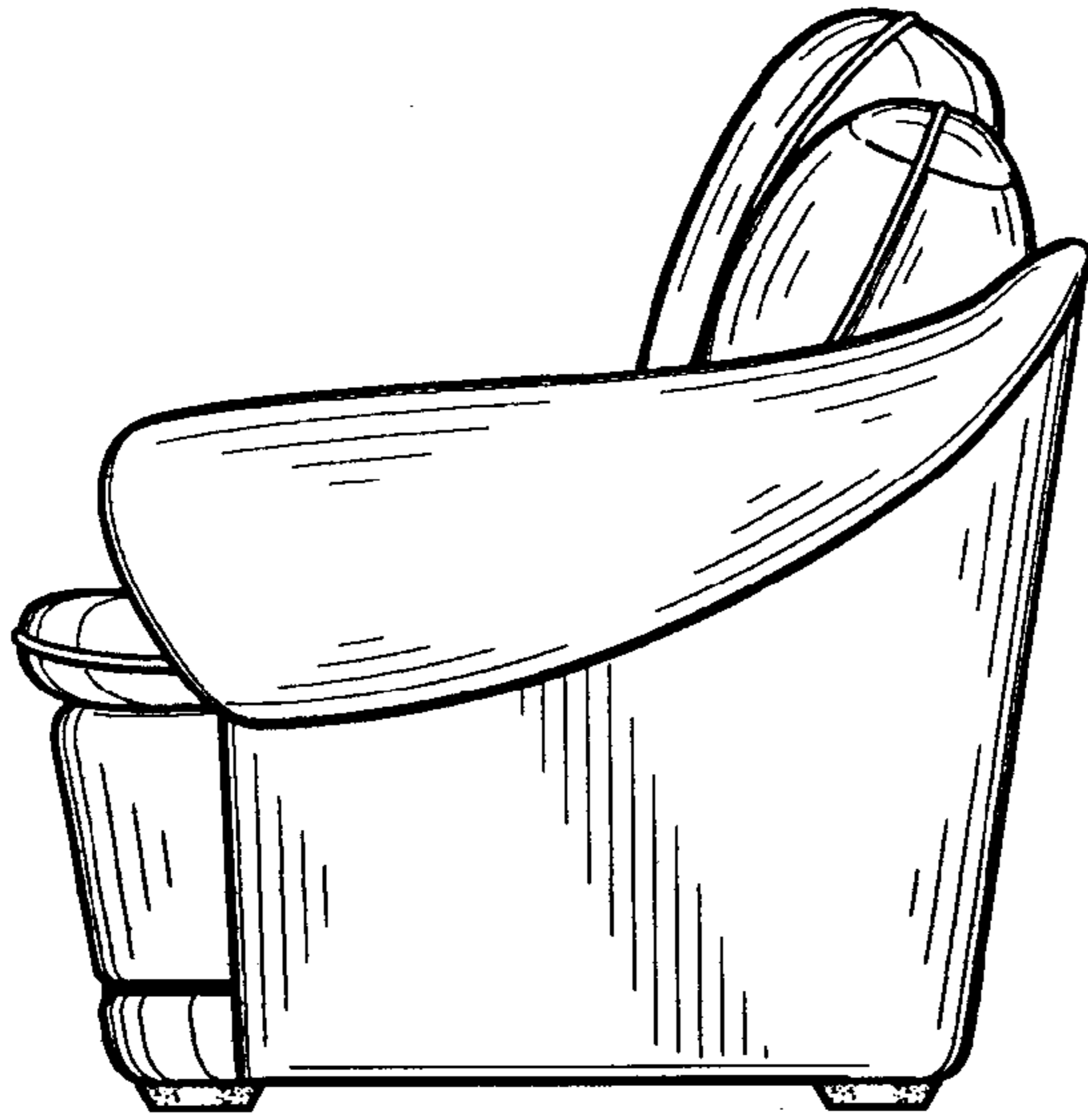

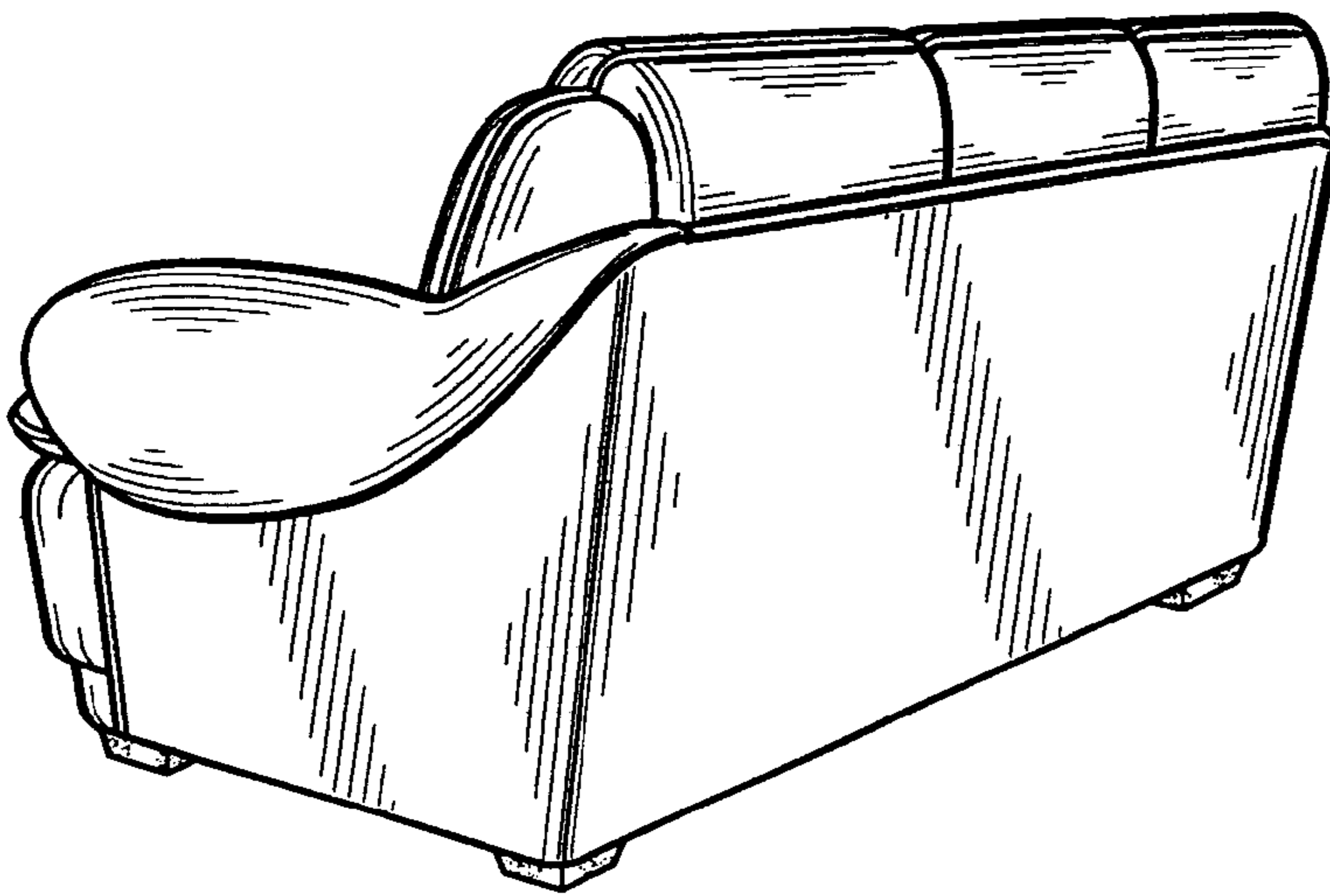
