FIG. 4 is a bottom plan view thereof;

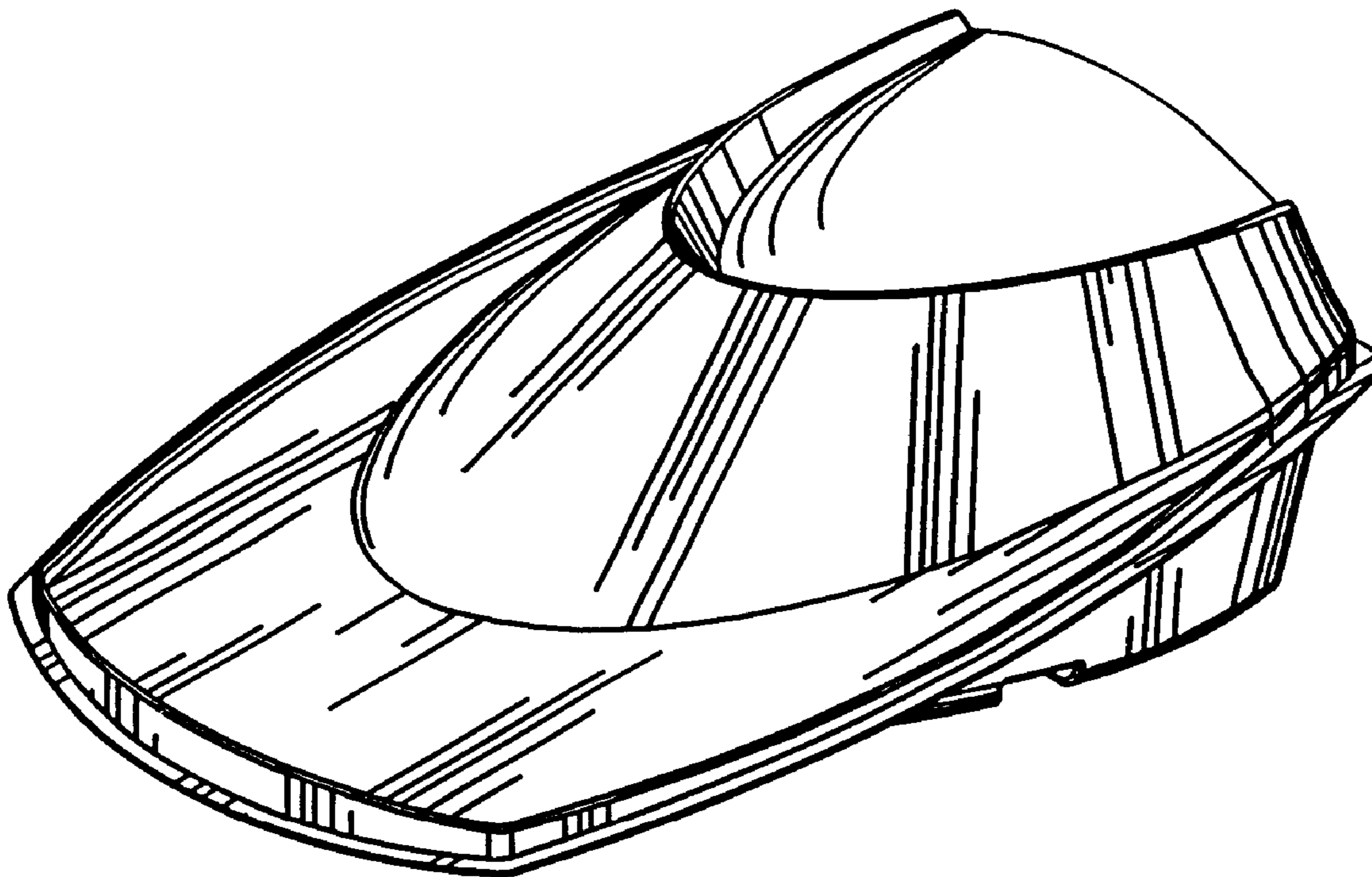
FIG. 5 is an exploded left side view thereof;

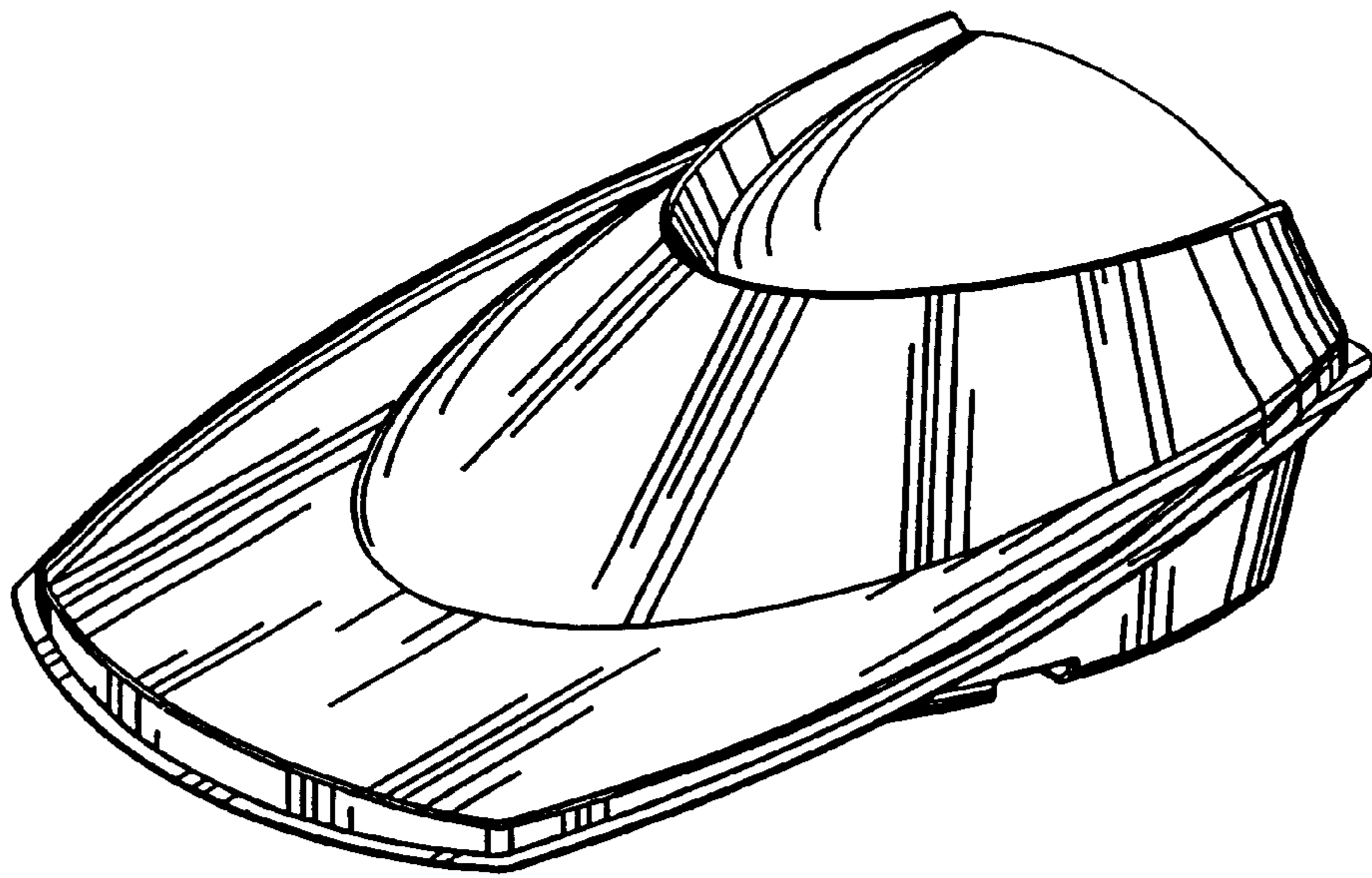

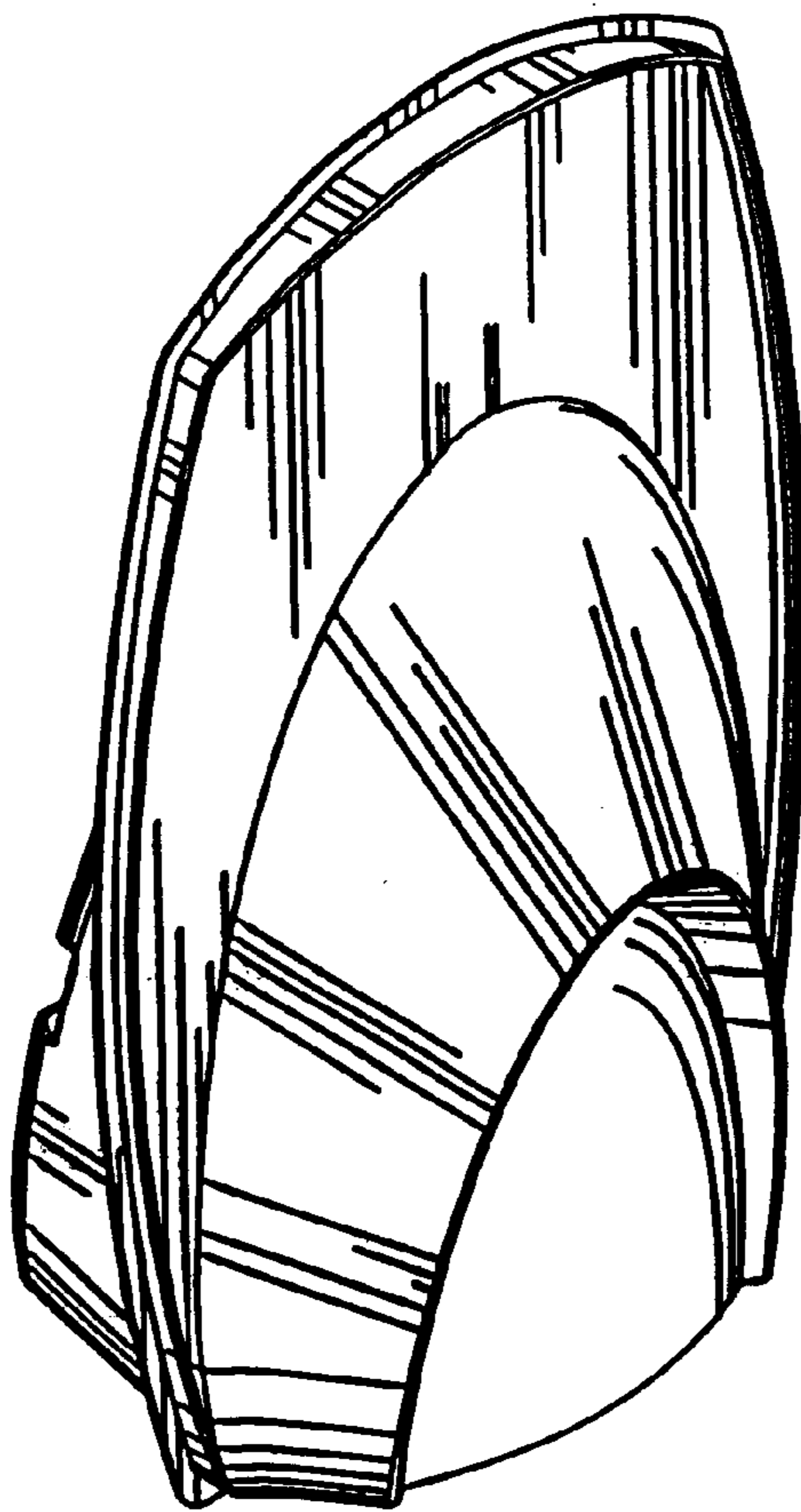

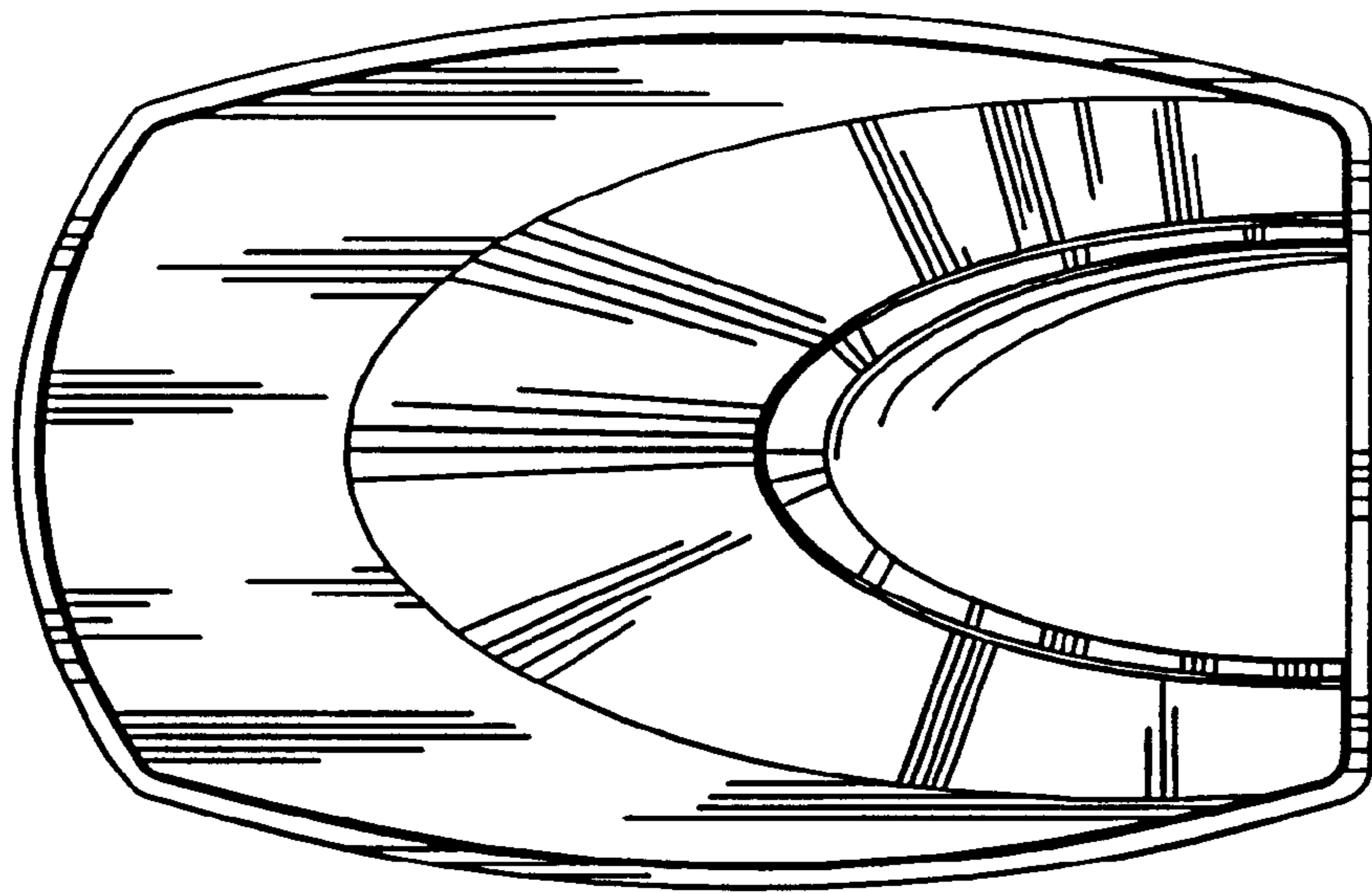

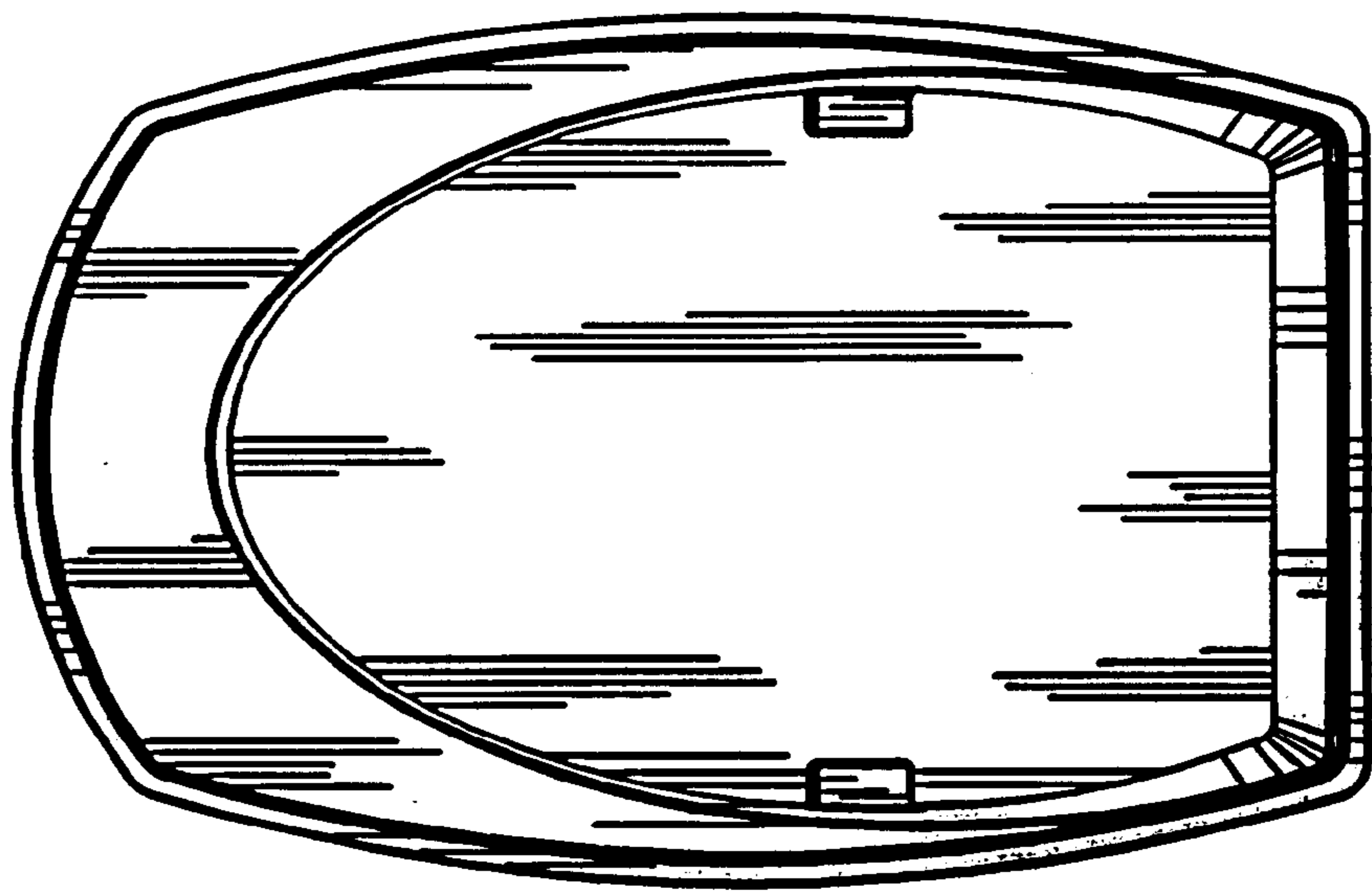

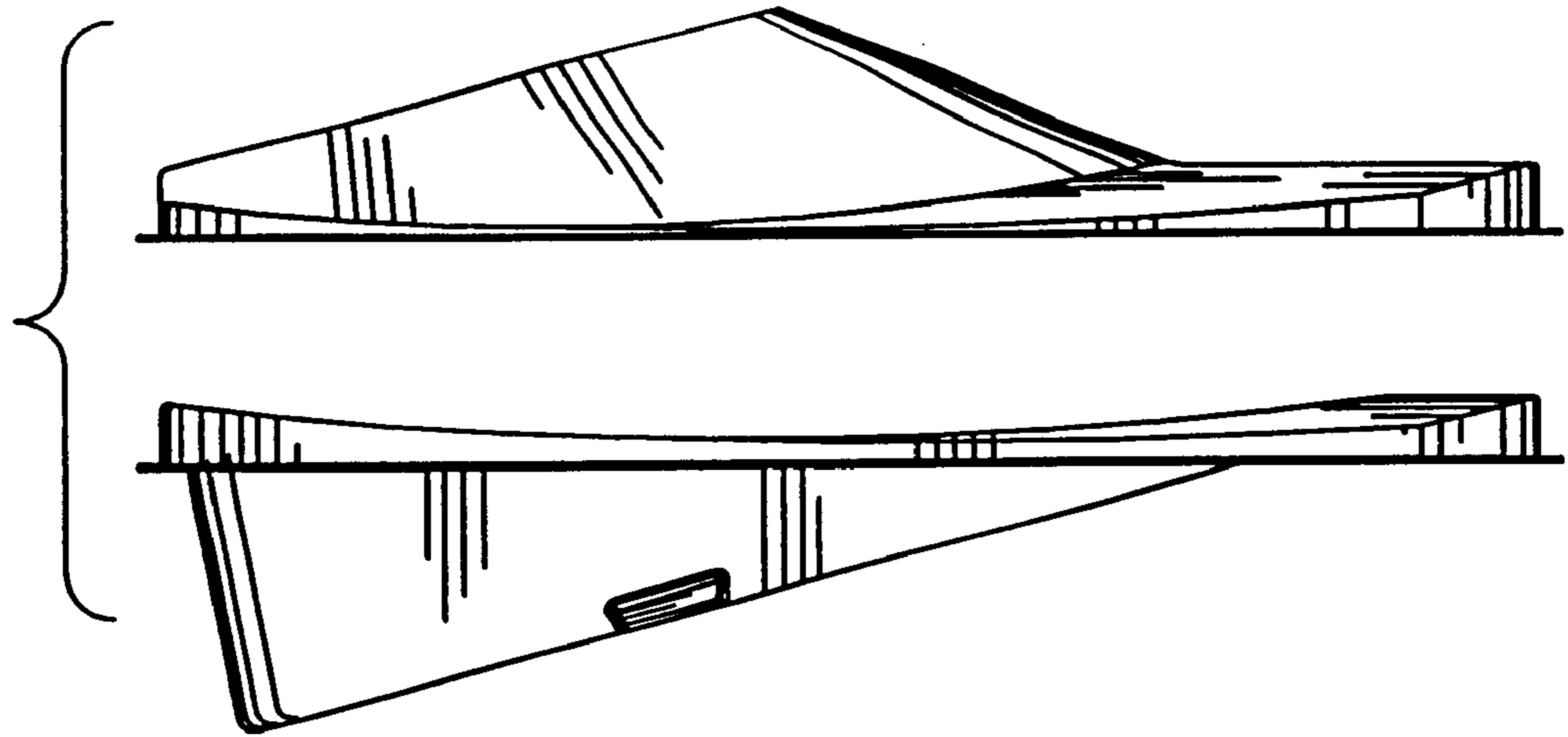

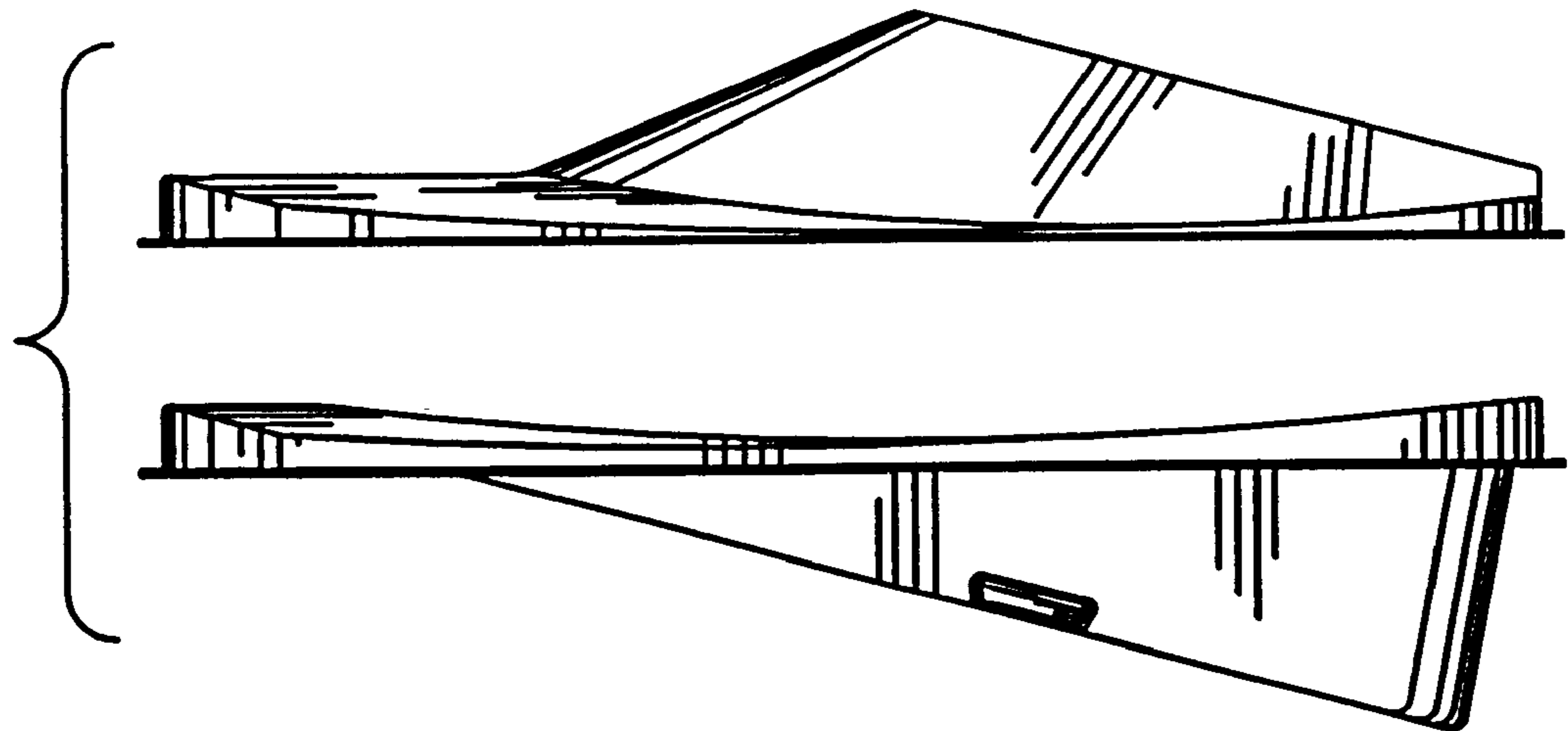

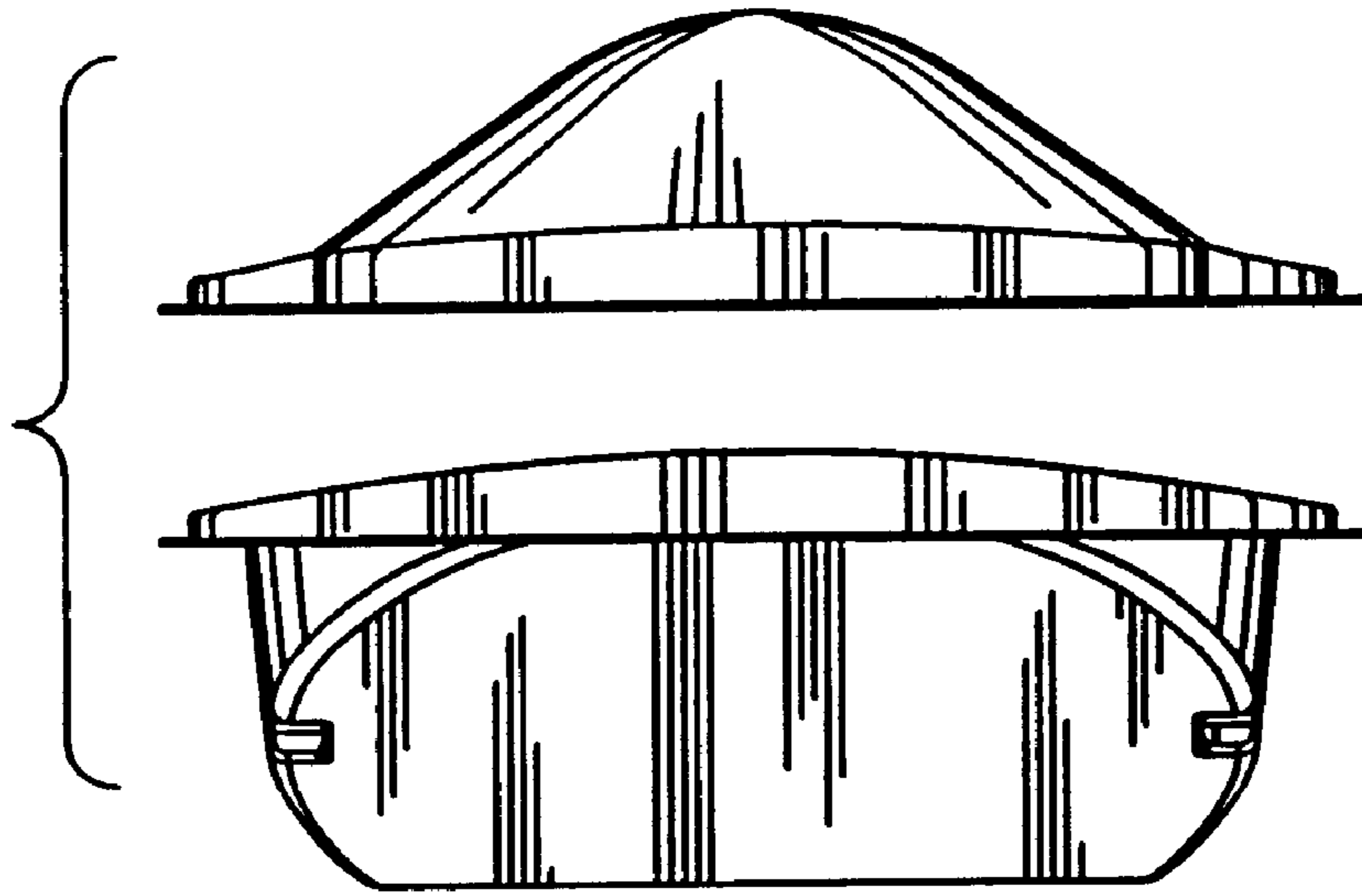

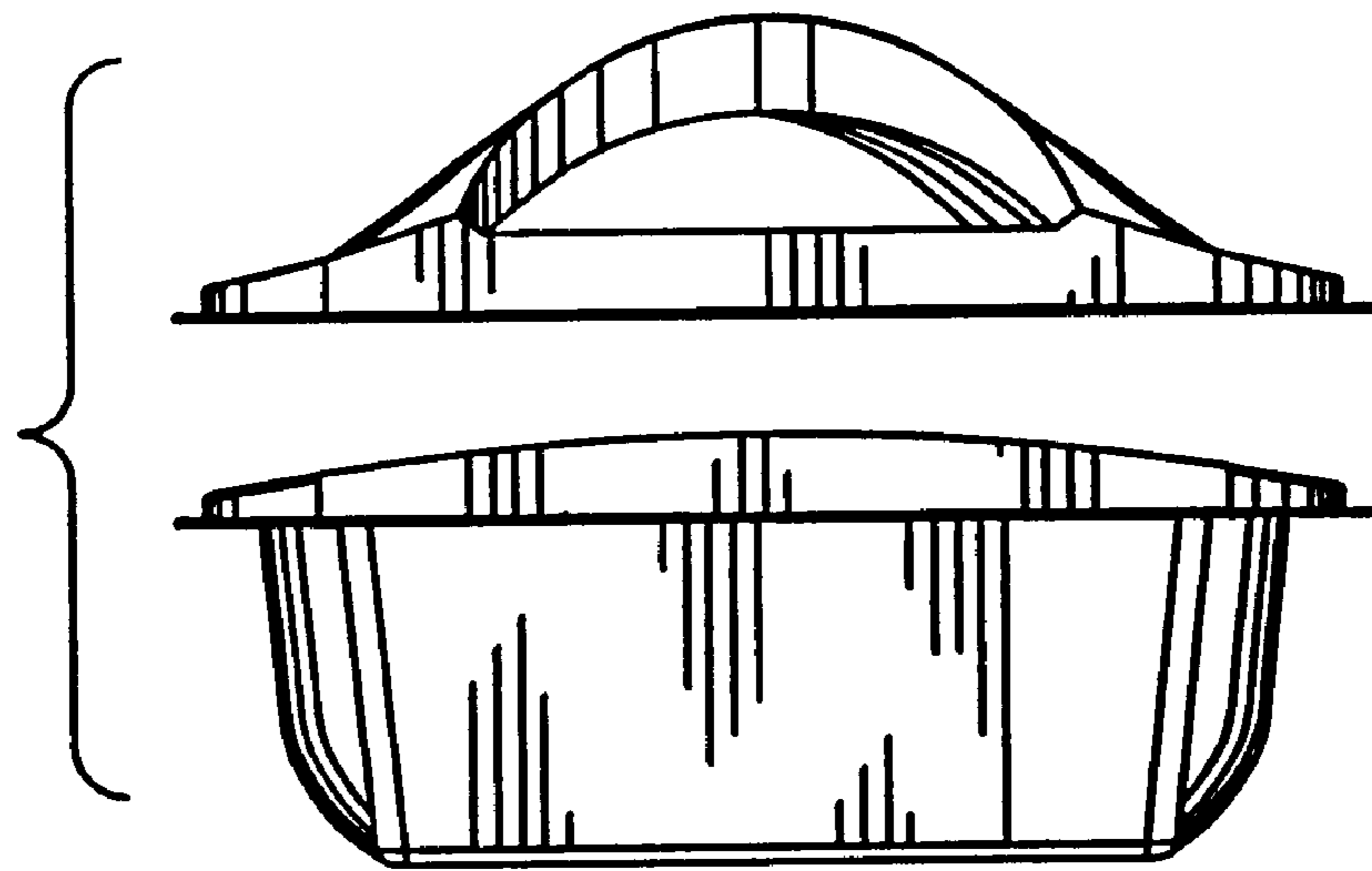
