The ornamental design for a bottle, as shown and described.

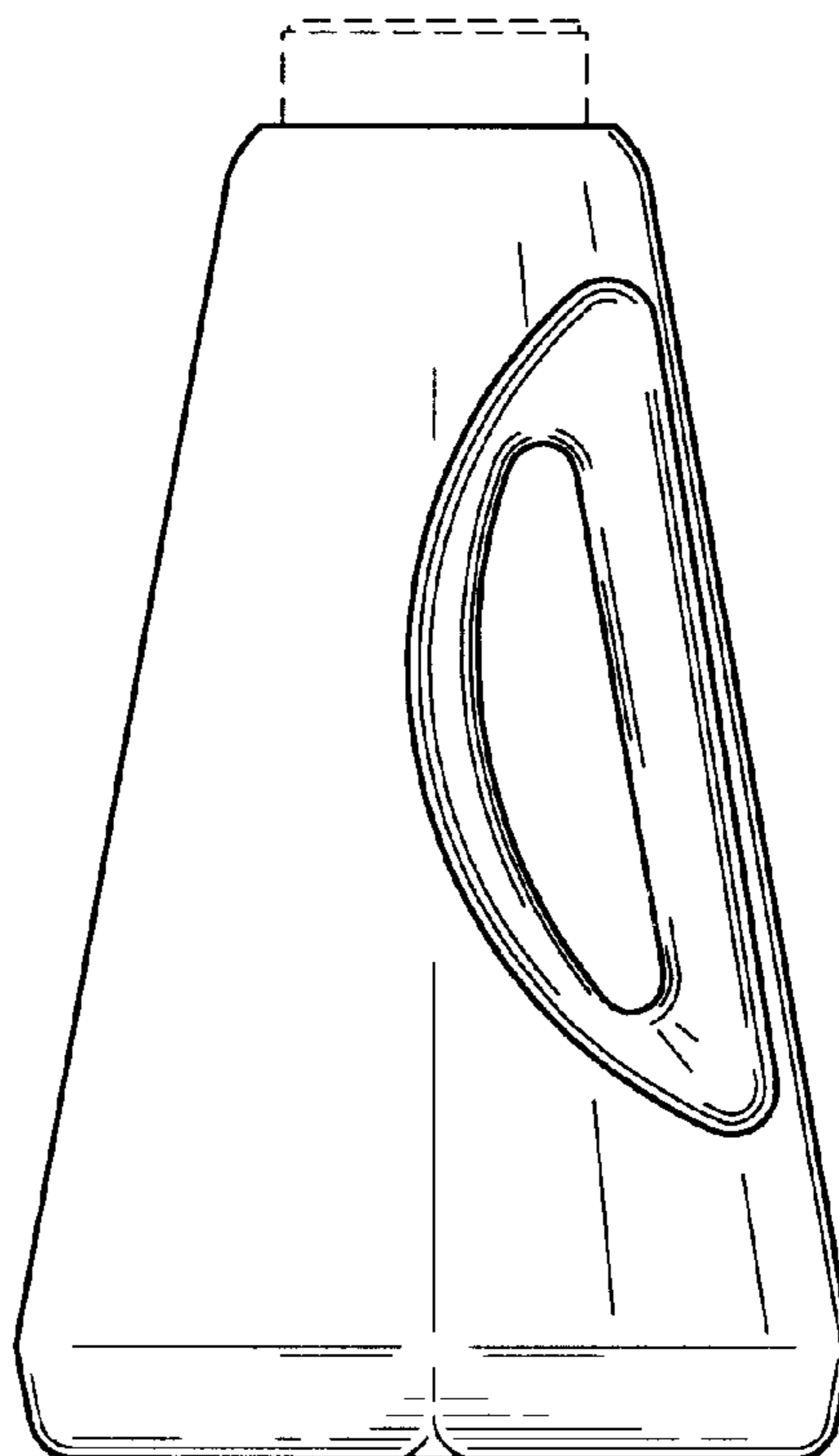
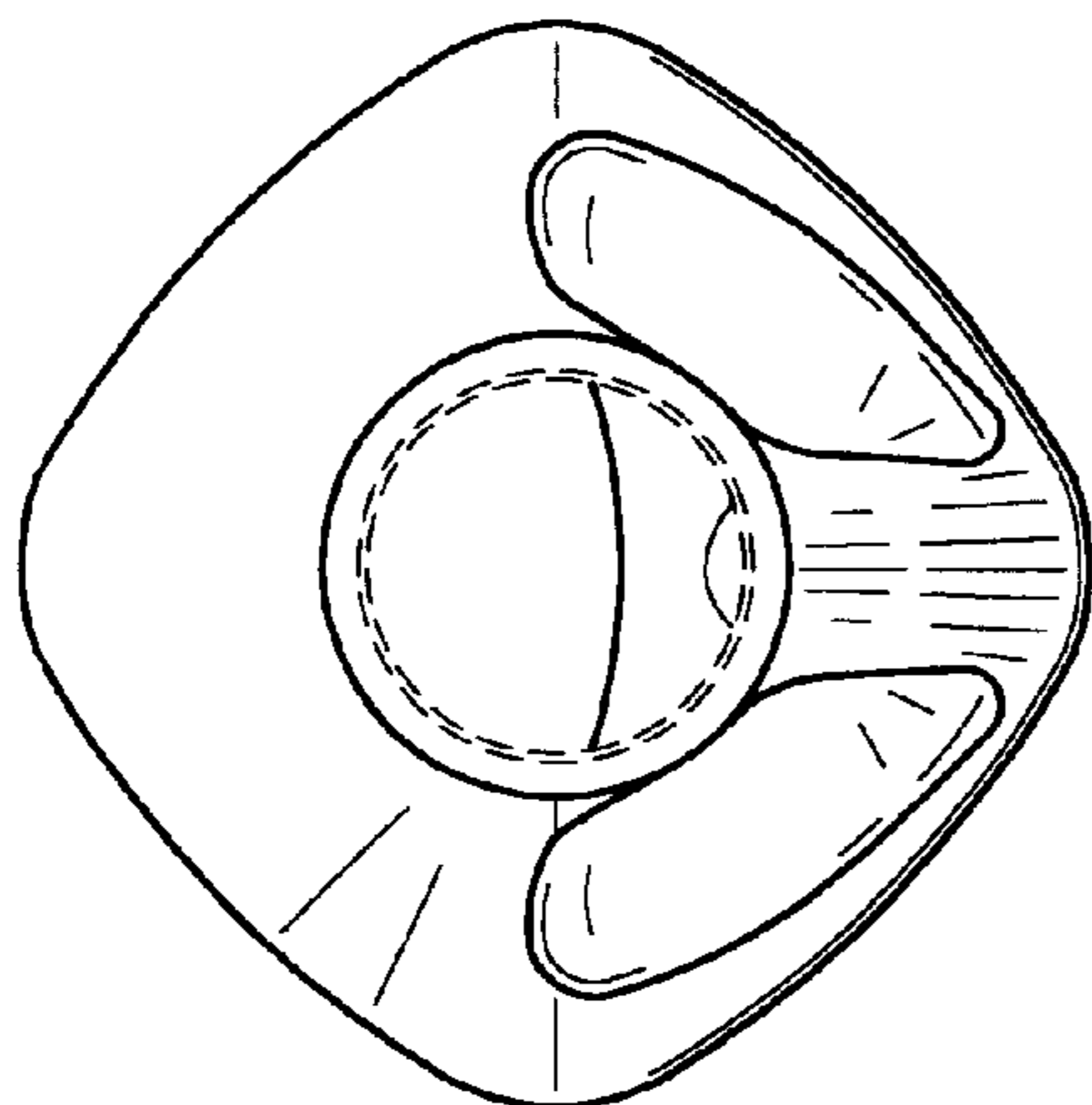
DESCRIPTION

FIG. 1 is a top view of a bottle embodying the design; FIG. 2 is a side view of a bottle embodying the design, the opposite side view being a mirror image thereof; FIG. 3 is a bottom view of a bottle embodying the design; FIG. 4 is a rear view of a bottle embodying the design; FIG. 5 is a front view of a bottle embodying the design; and, FIG. 6 is a perspective view of a bottle embodying the design.

The broken lines are for illustrative purposes only and form no part of the claimed design.

The horizontal solid line at the top shoulder edge defines the top boundary of the claim.

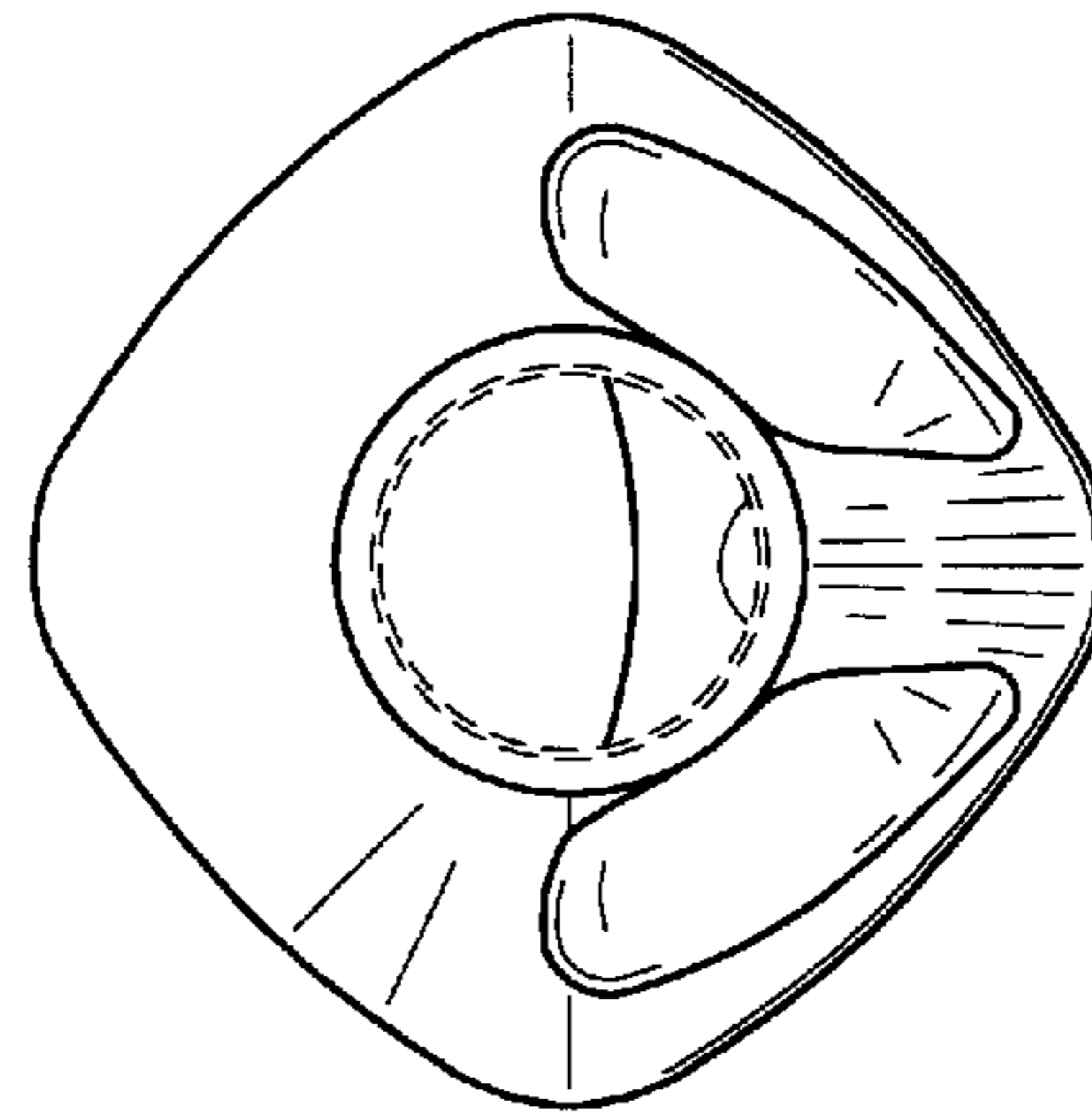

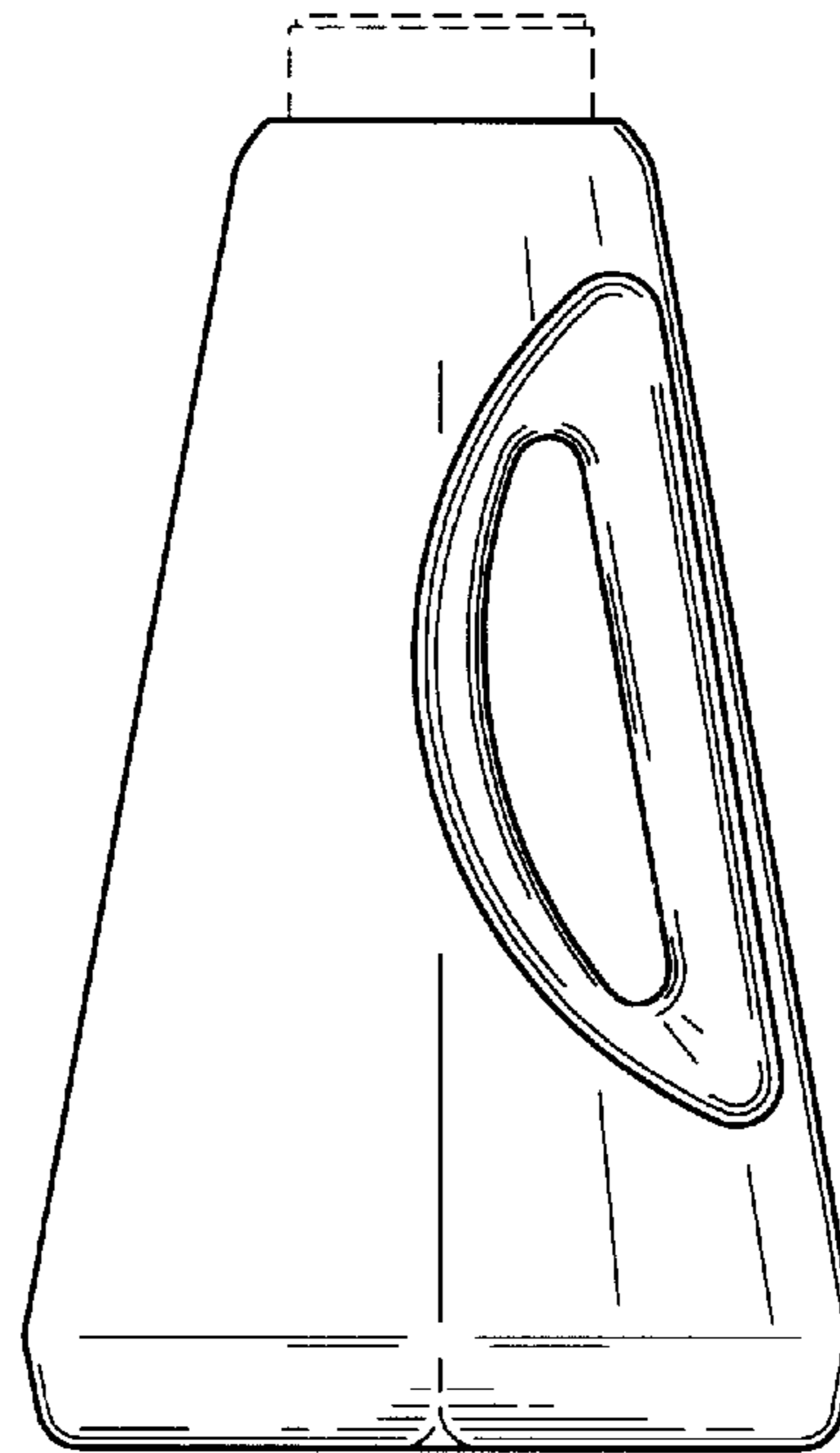

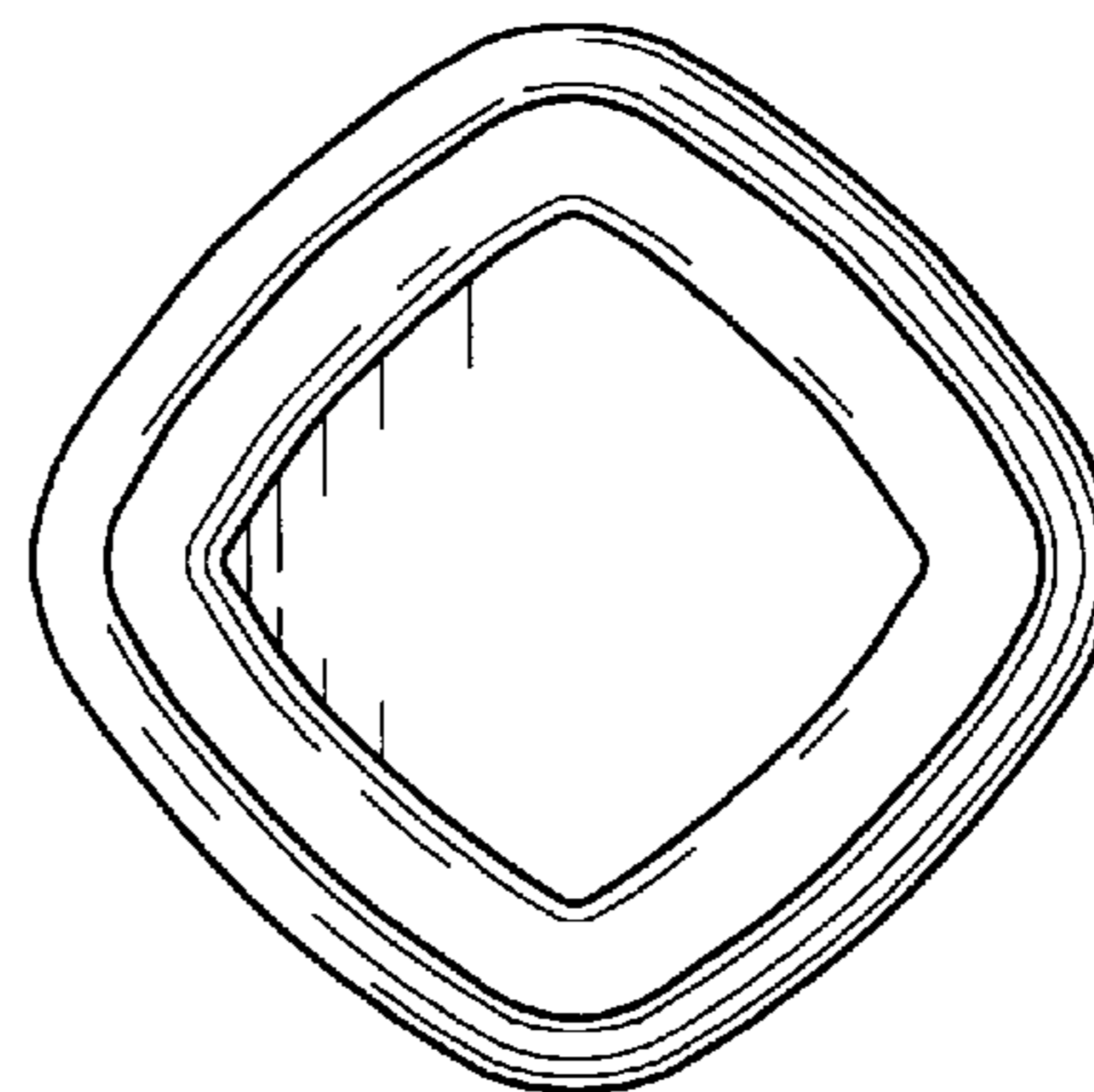

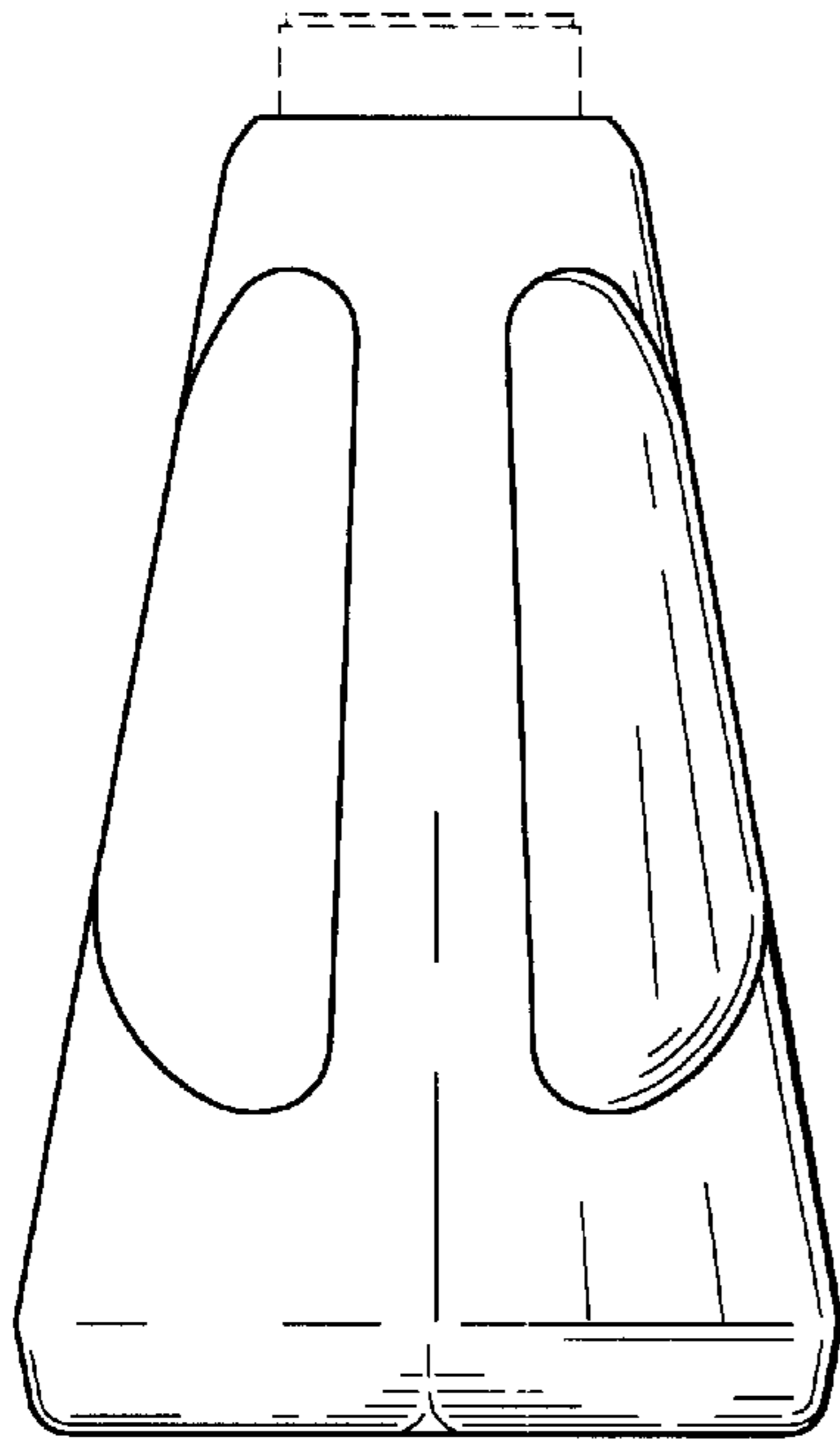

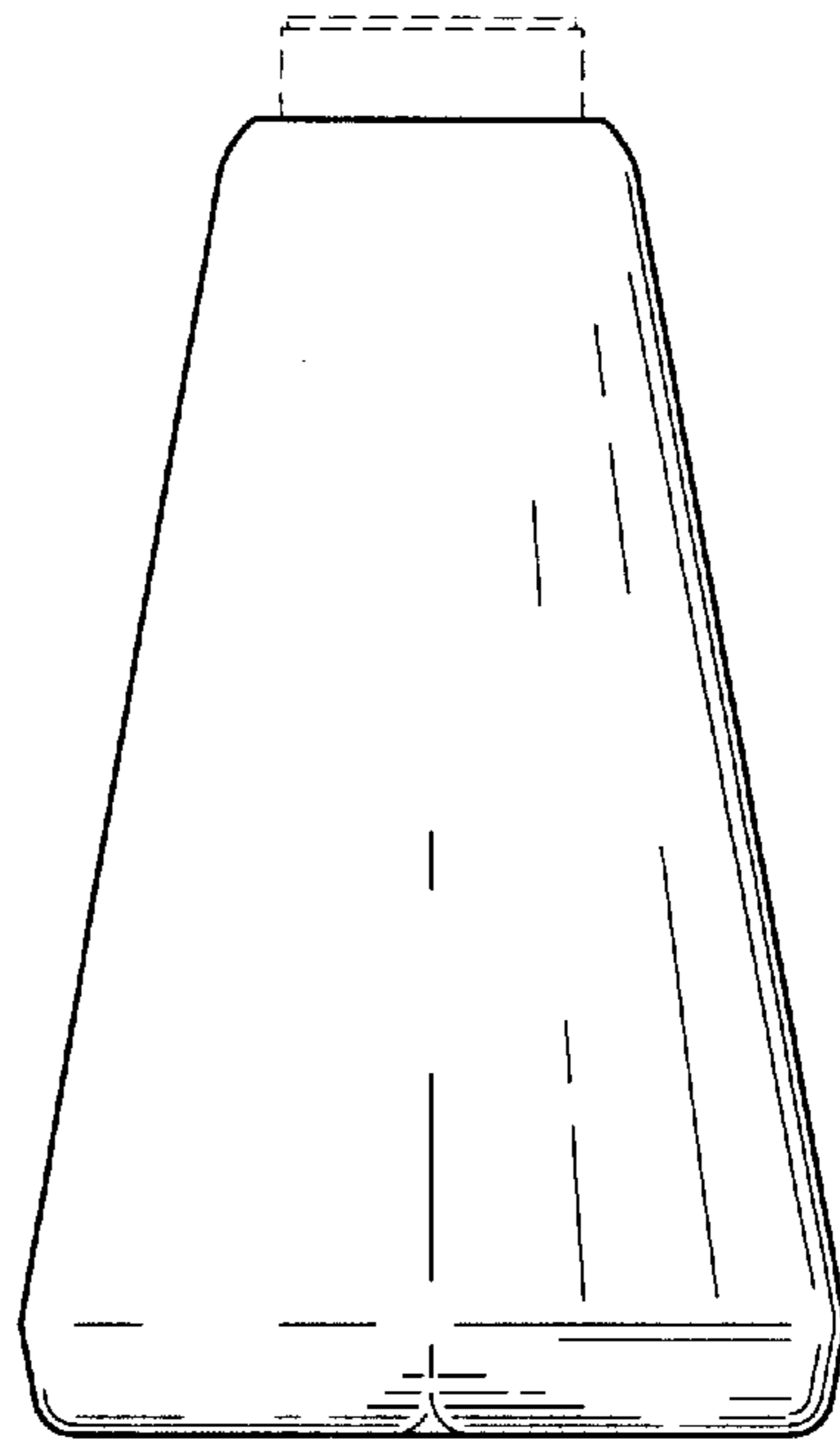

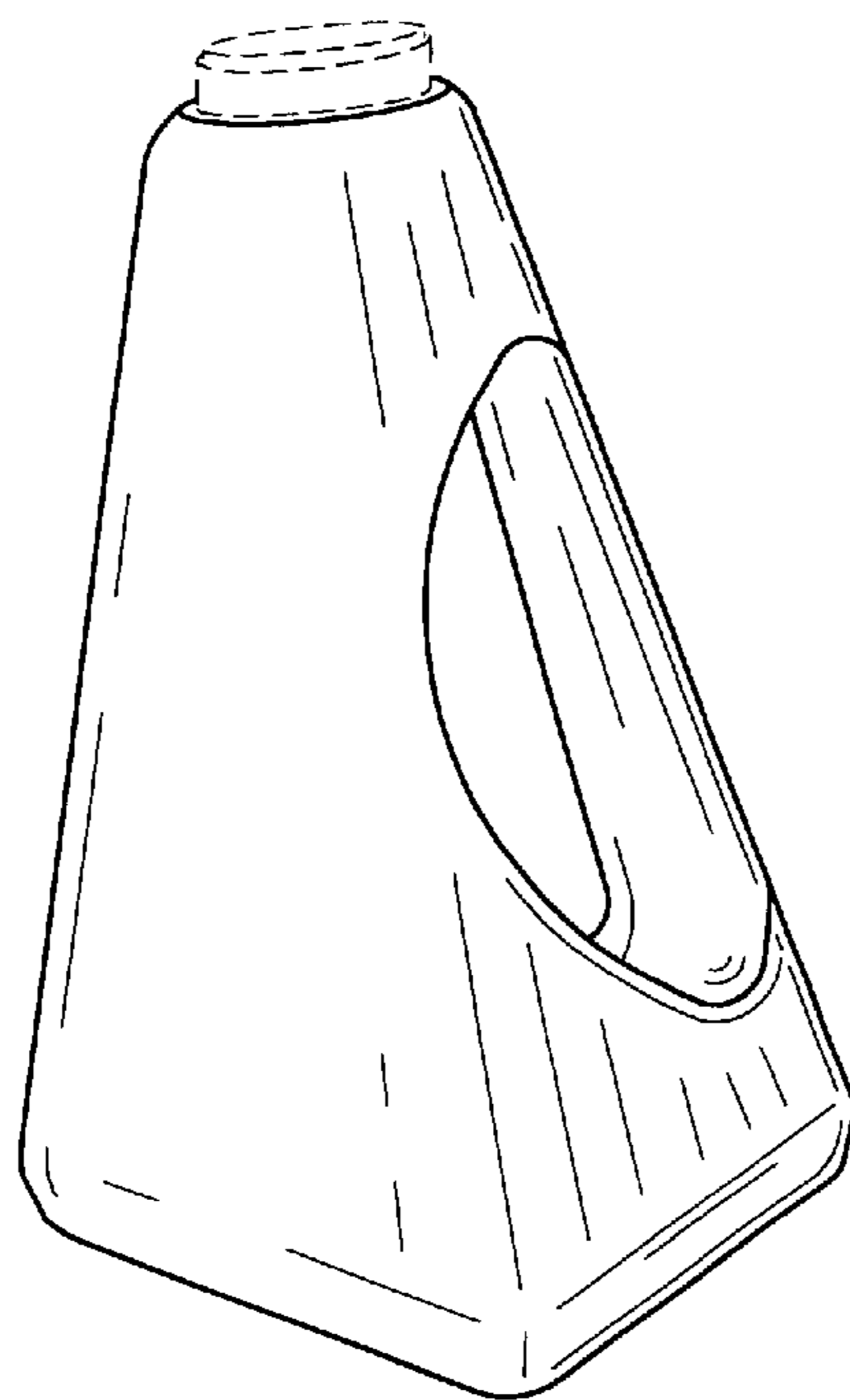
