FIG. 4 is another side view of the portion of a watch housing shown in FIG. 1;

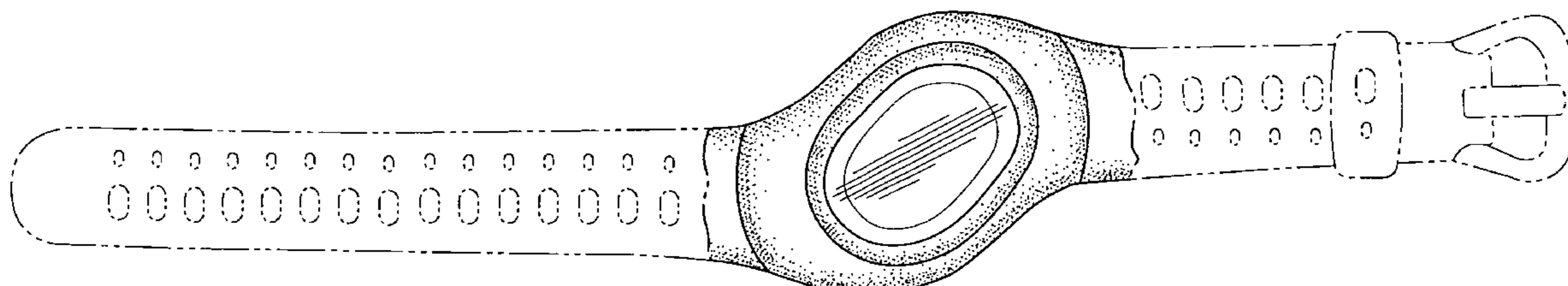
FIG. 5 is a front elevation view of the portion of a watch housing shown in FIG. 1; and,

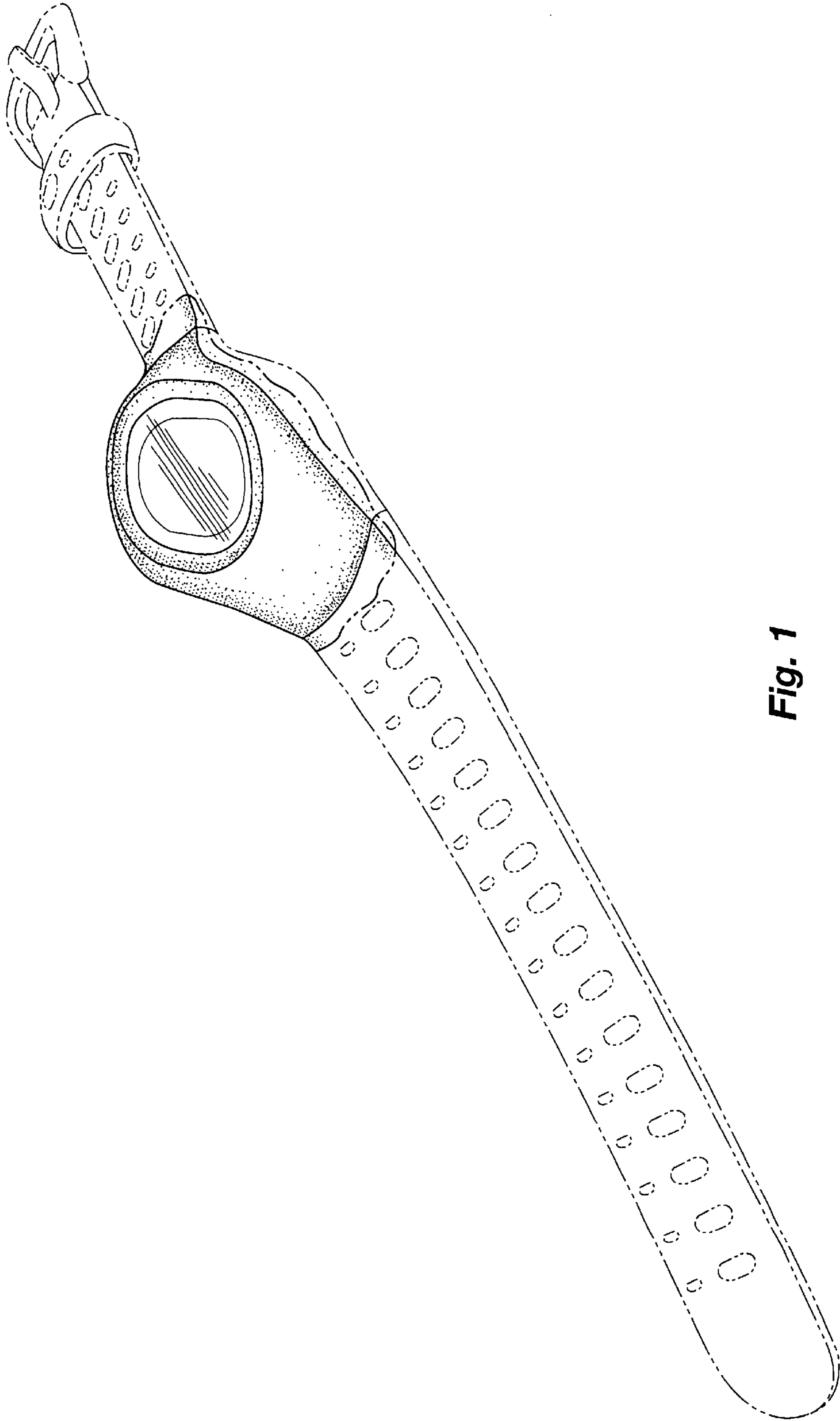

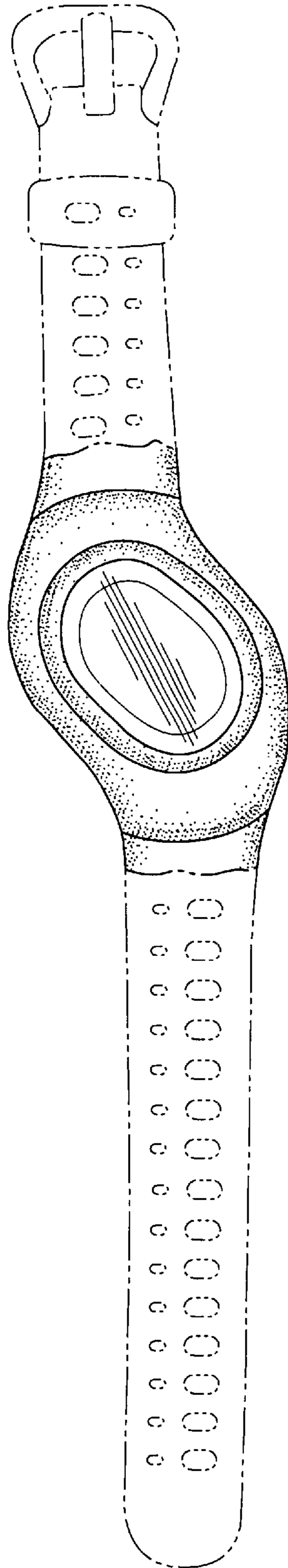

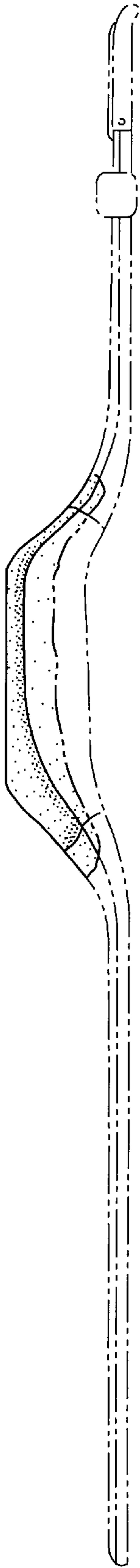

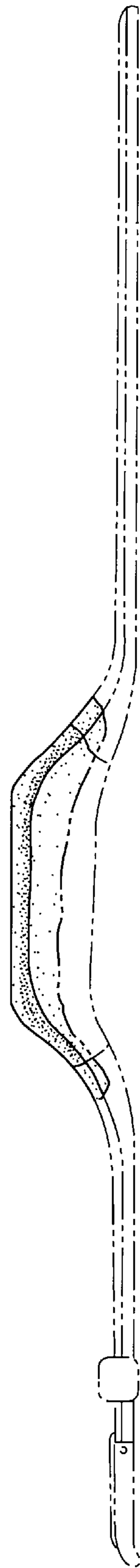

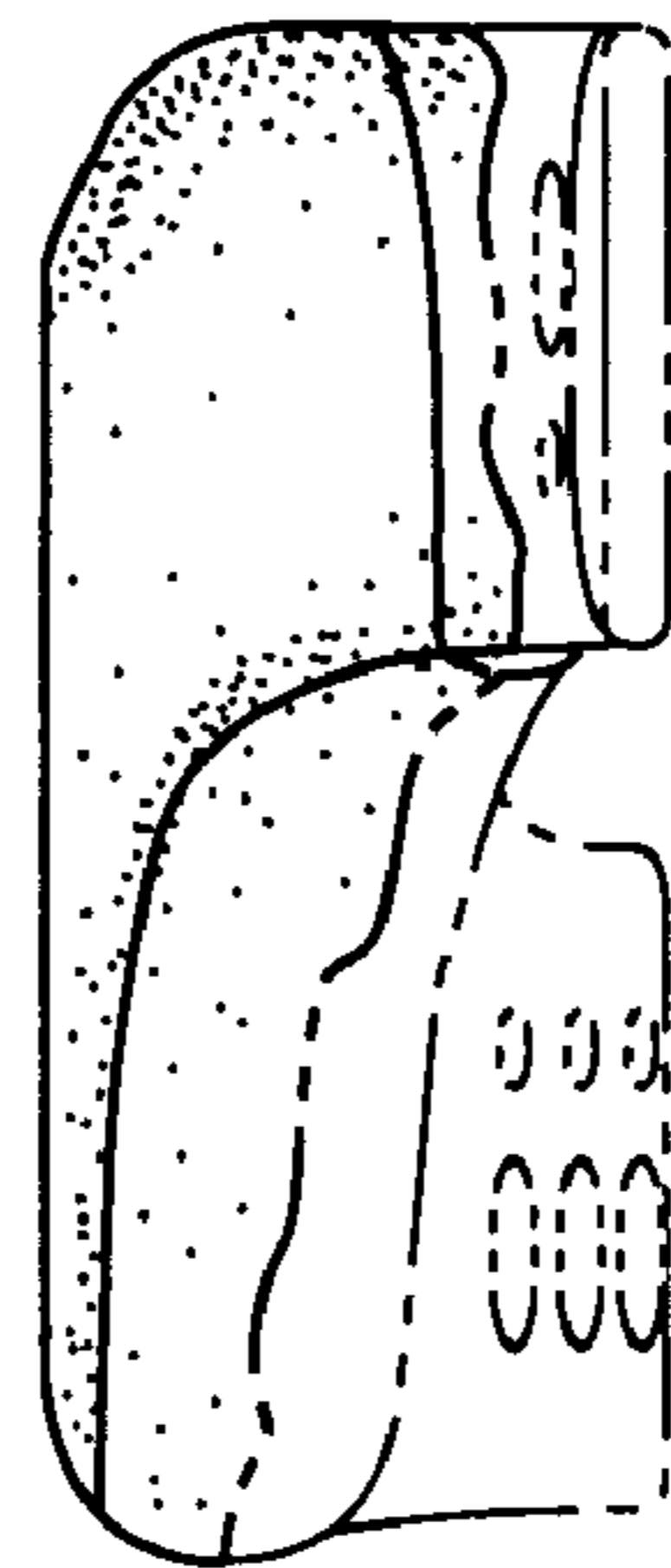

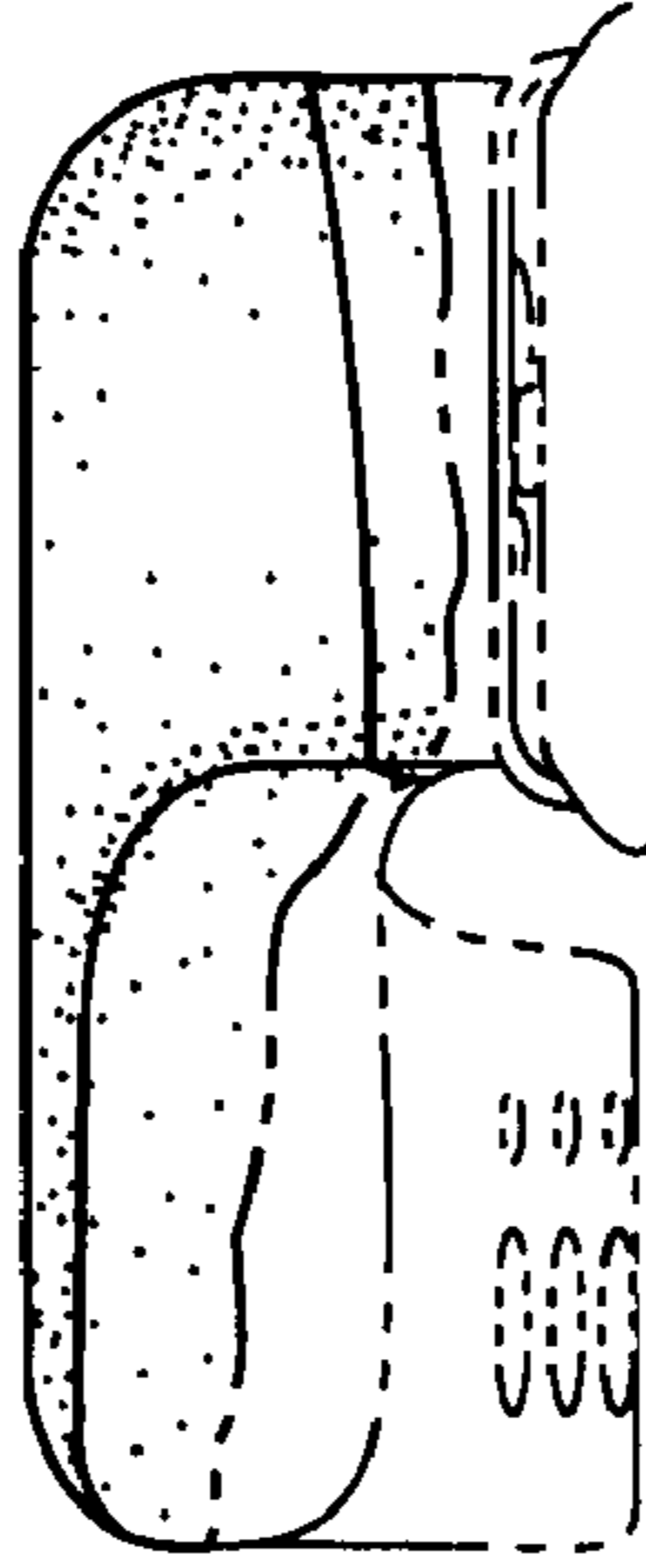
