FIG. 7 is a perspective view of a highlighter of FIG. 1 with the marking tip exposed and the cap positioned on the bottom of the highlighter barrel.

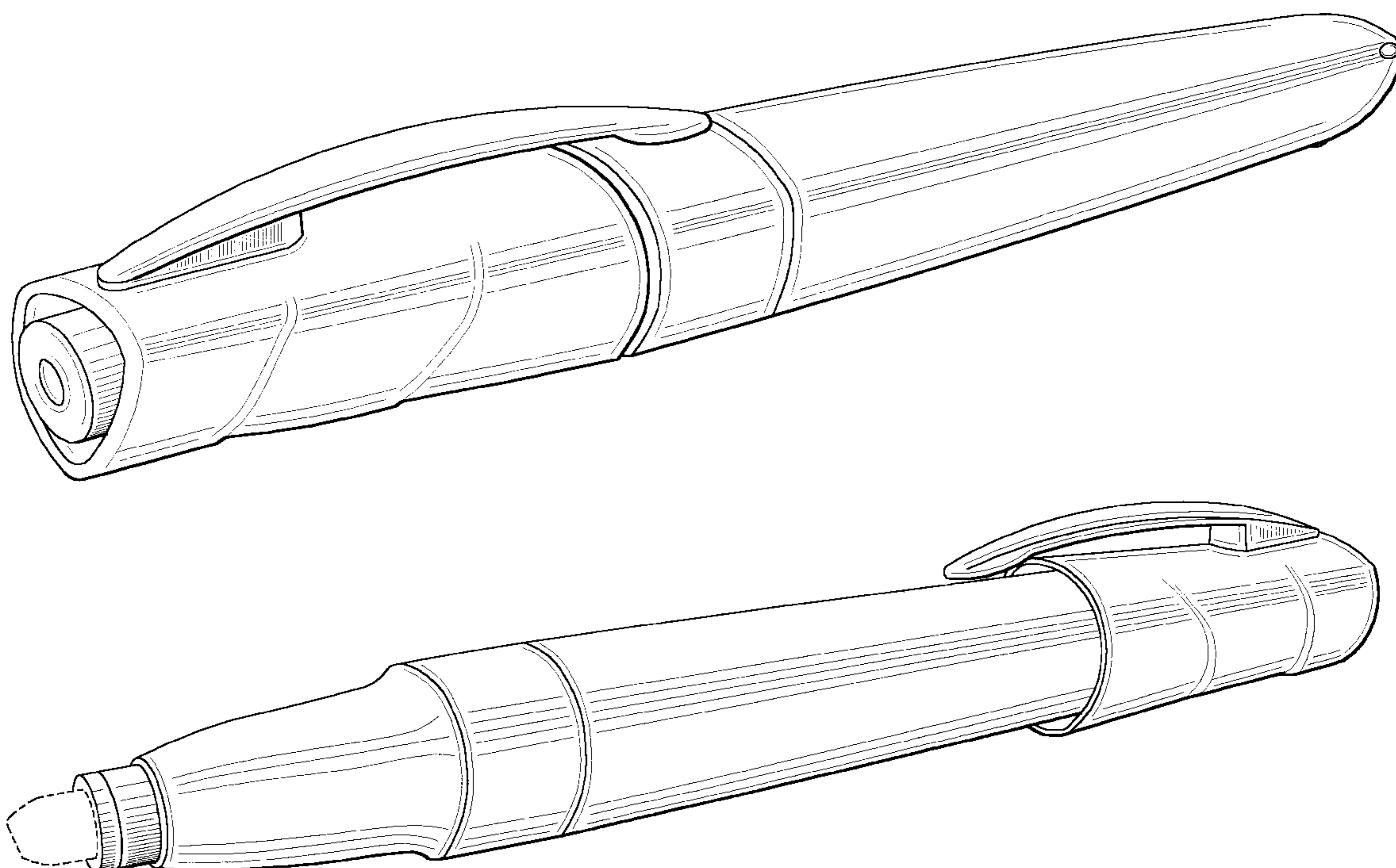

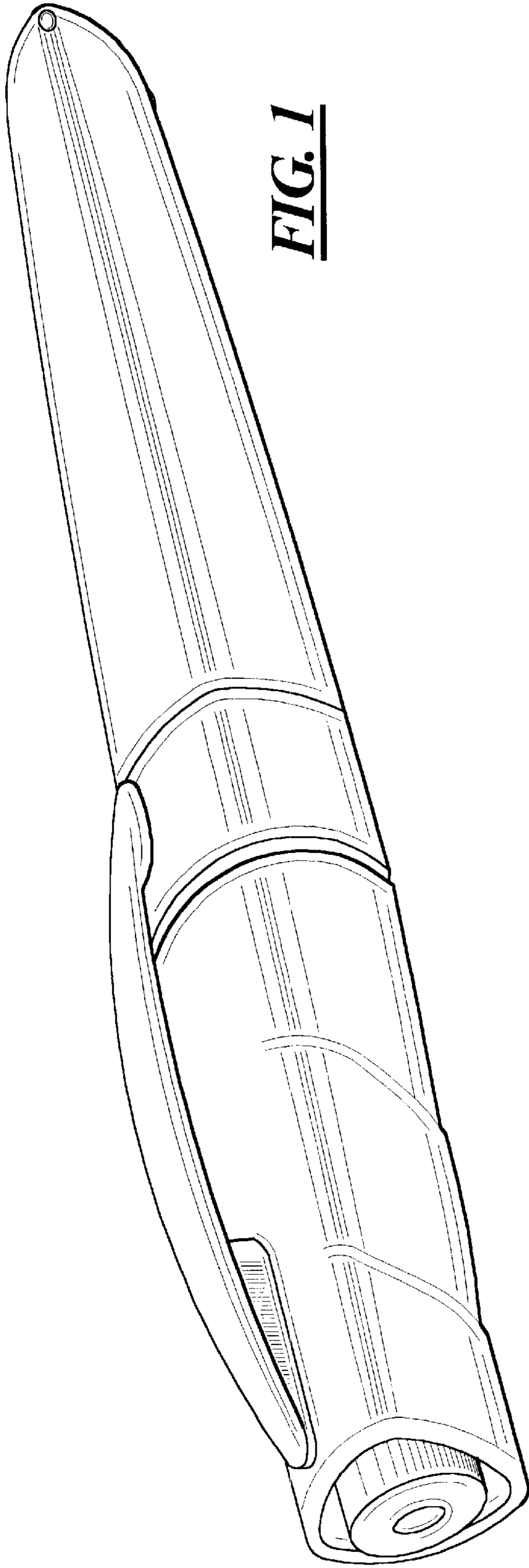

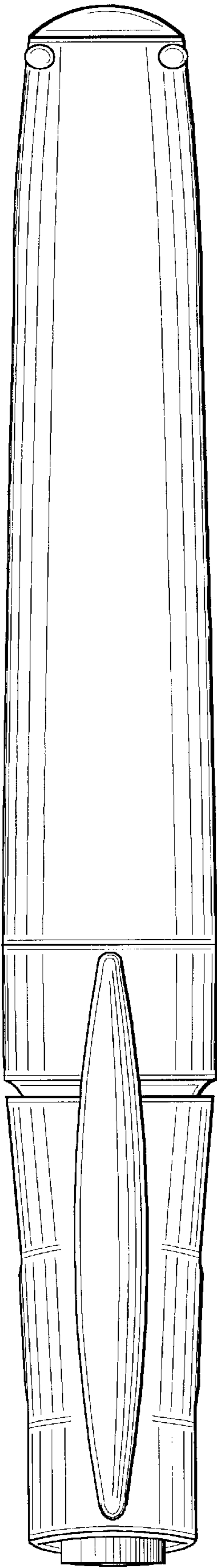

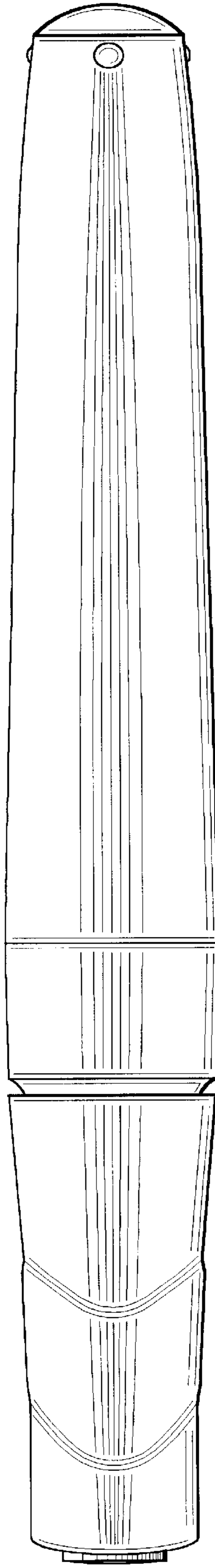

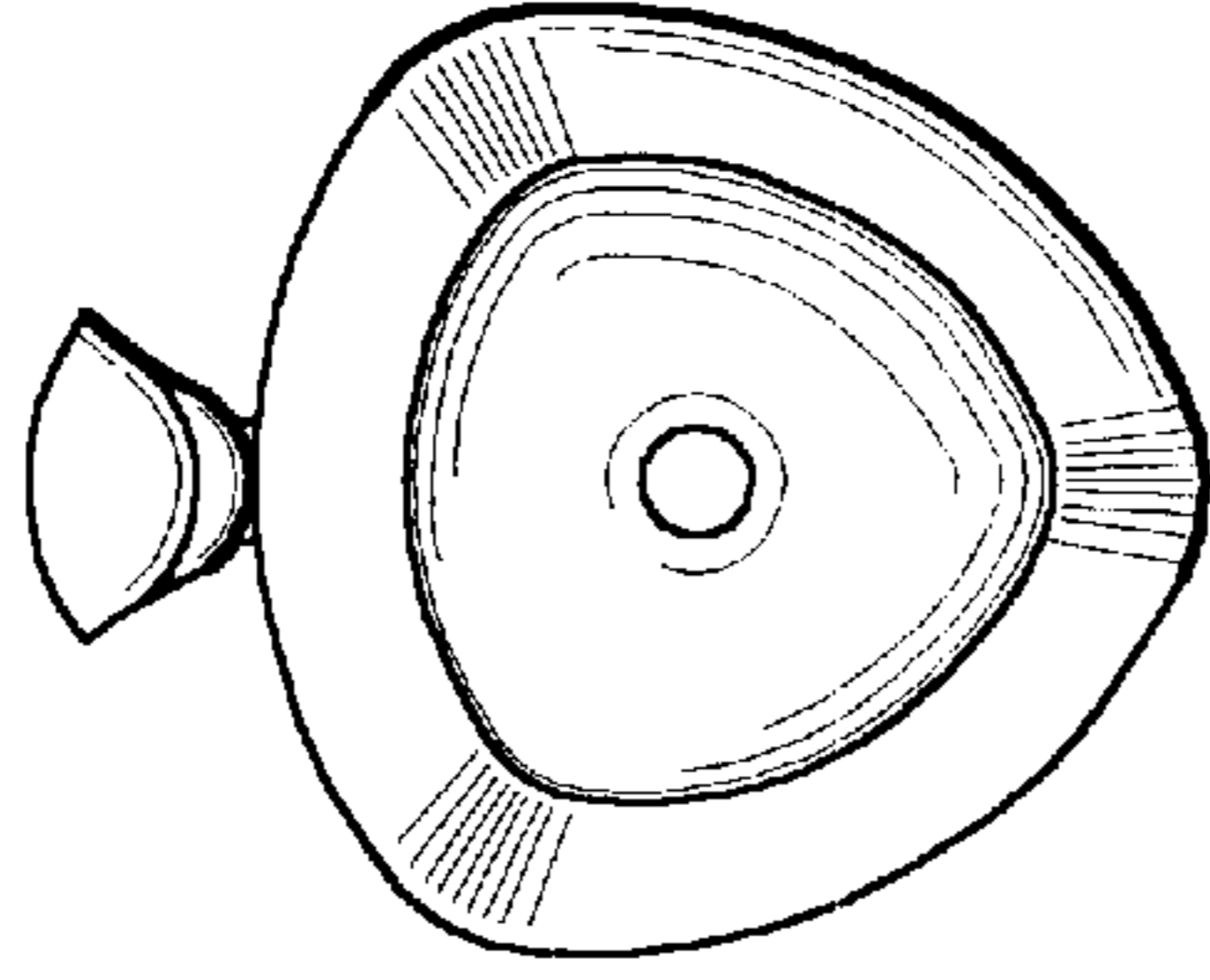

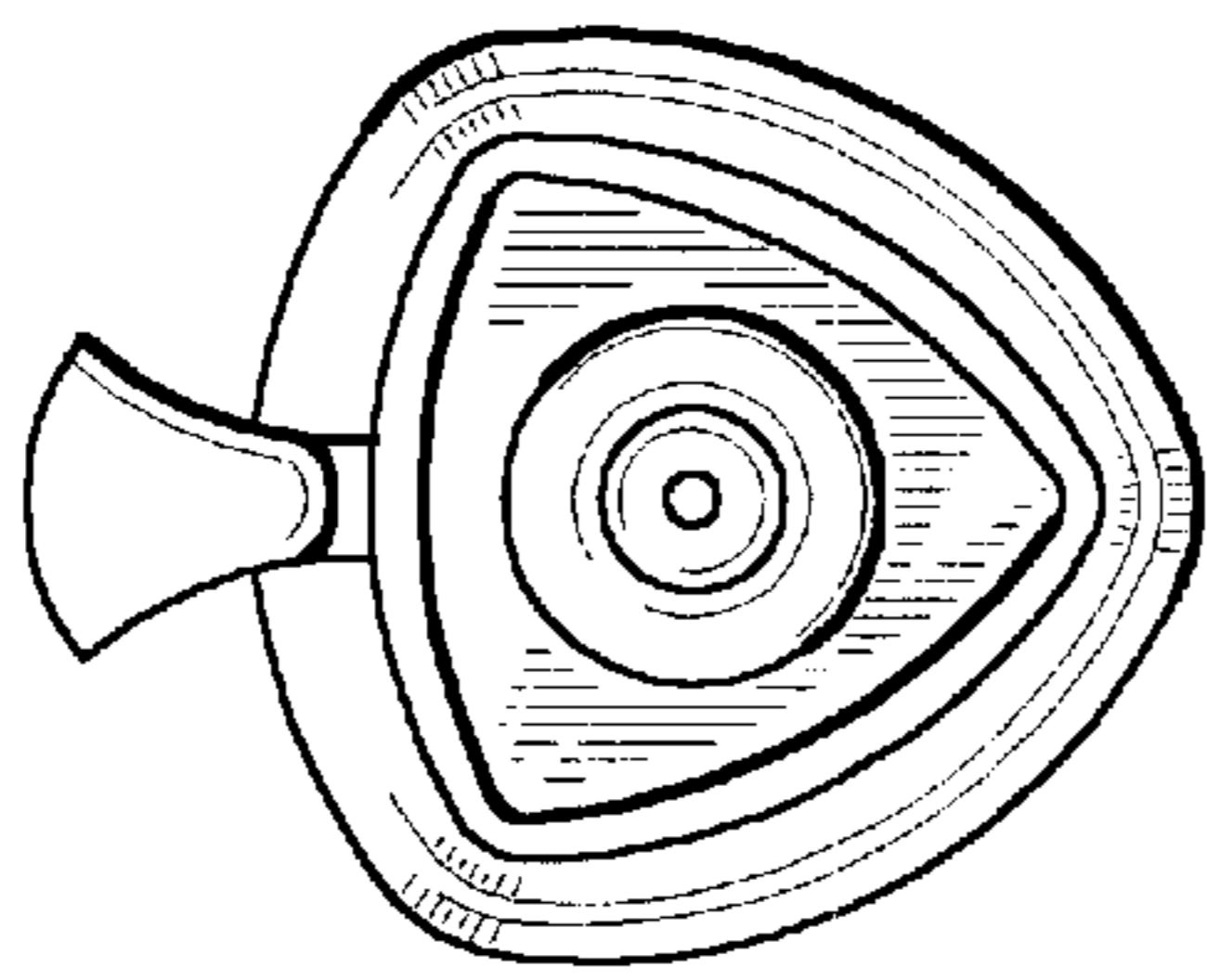
