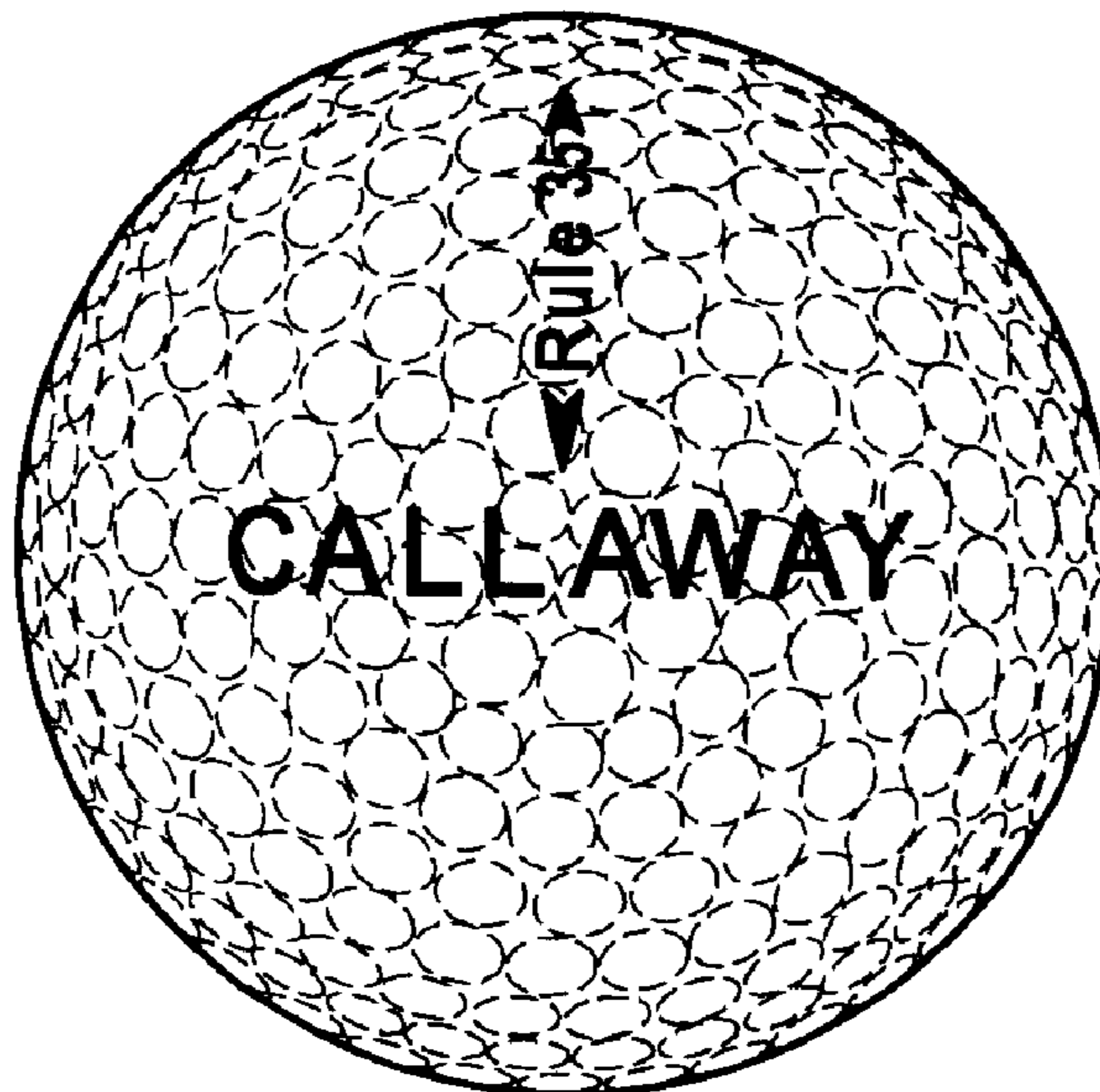
CLAIM

DESCRIPTION

FIG. 1 is a perspective view of a golf ball of the present invention;
 FIG. 2 is a front view thereof;

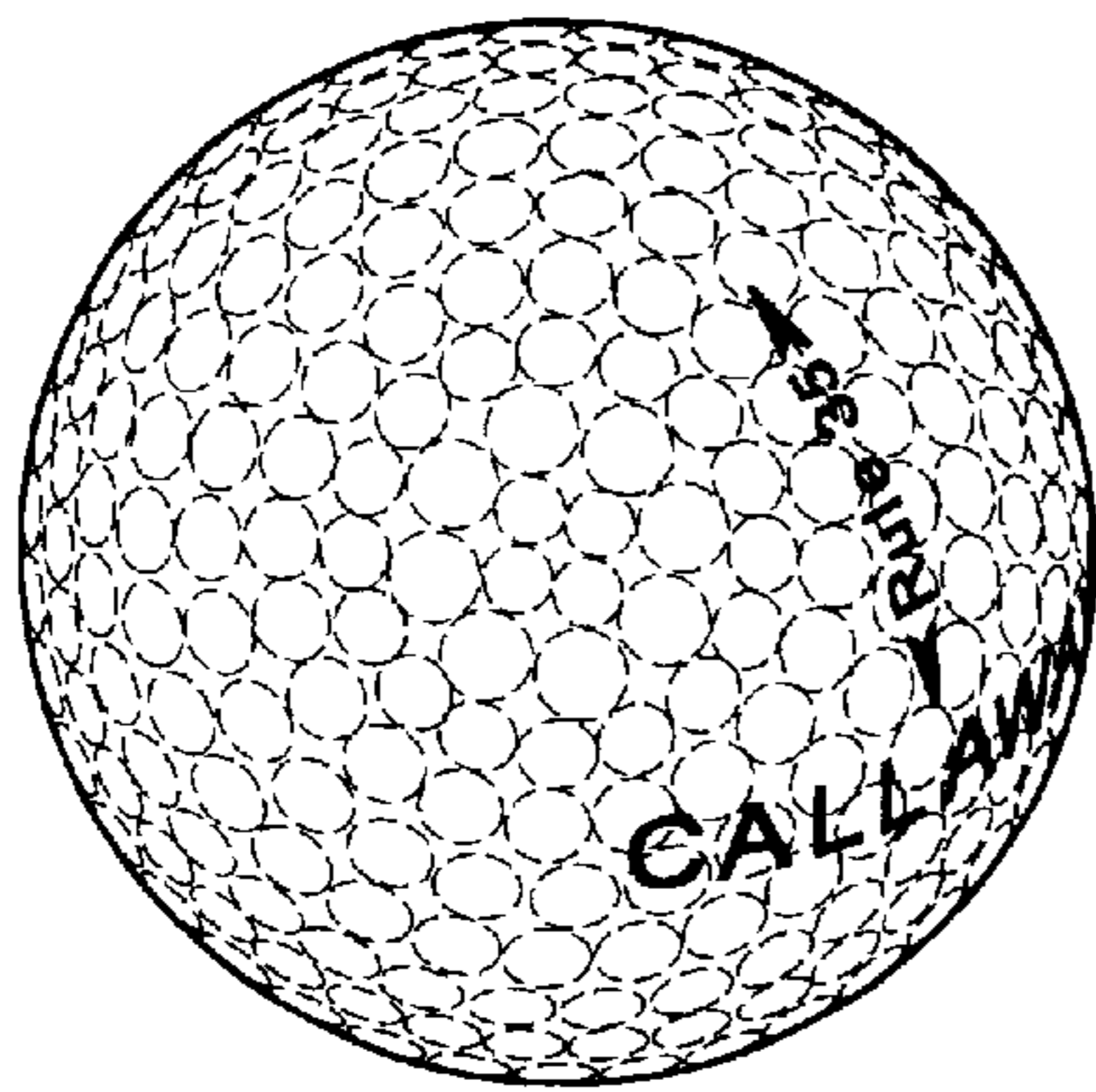

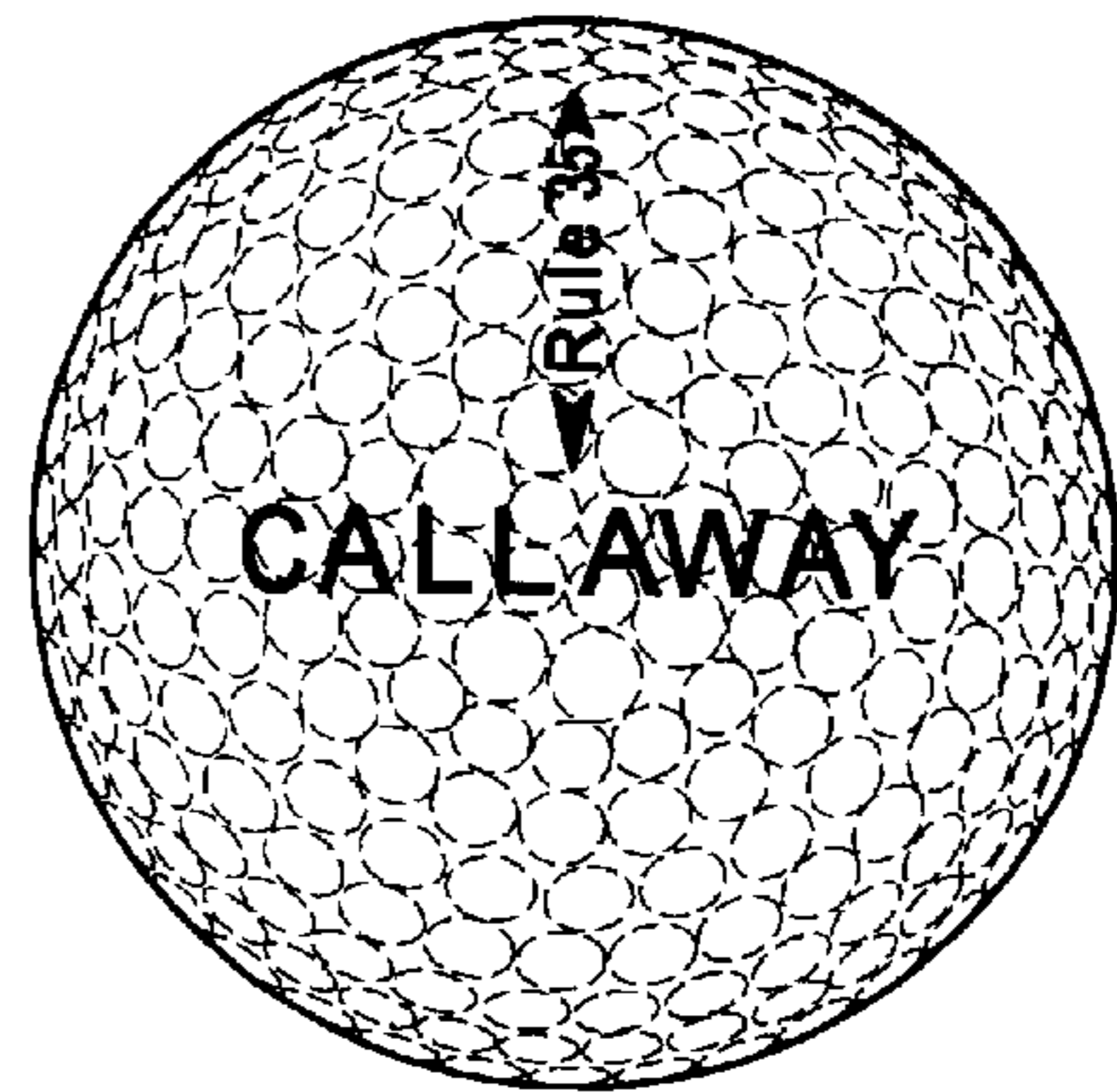

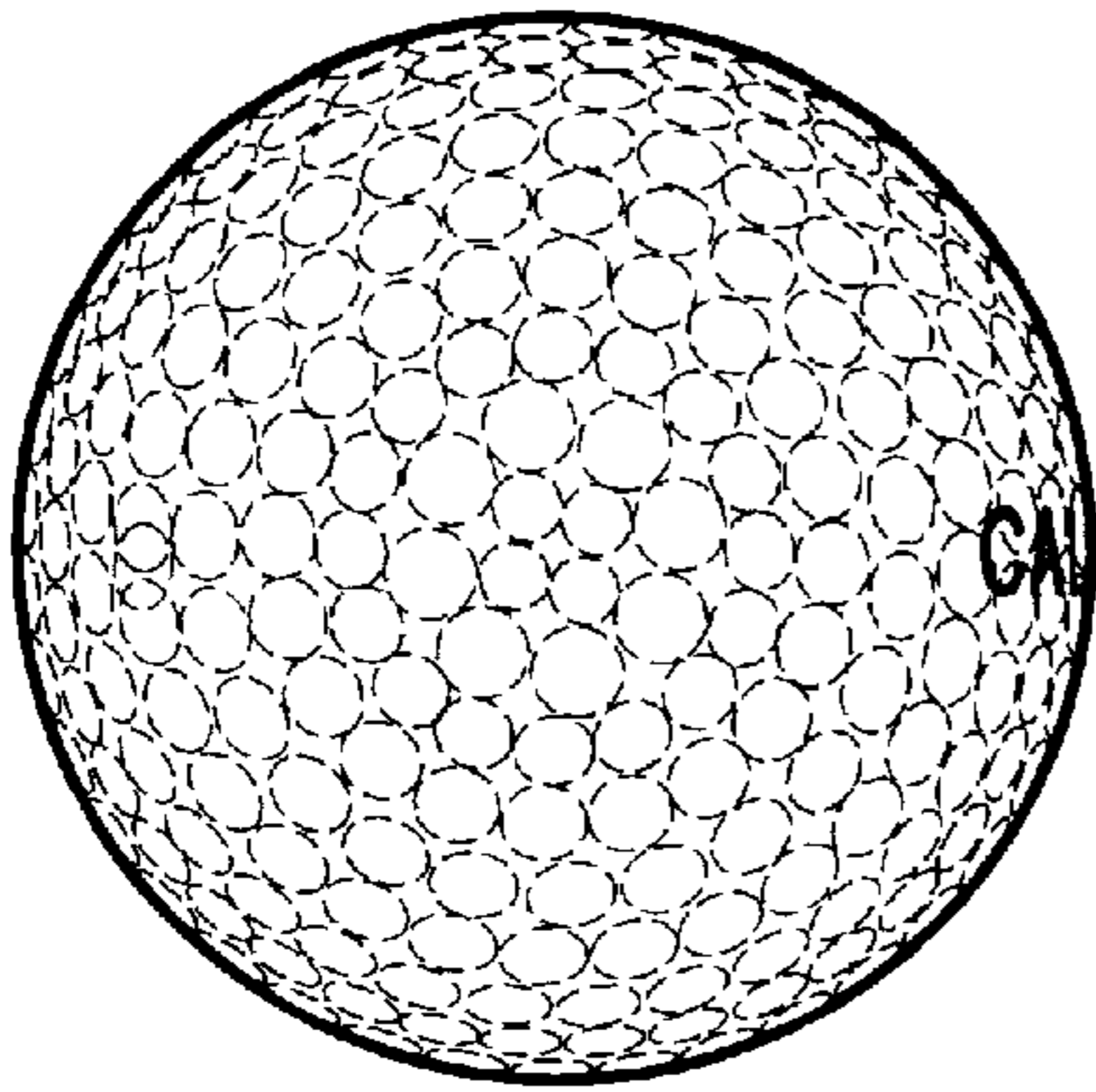

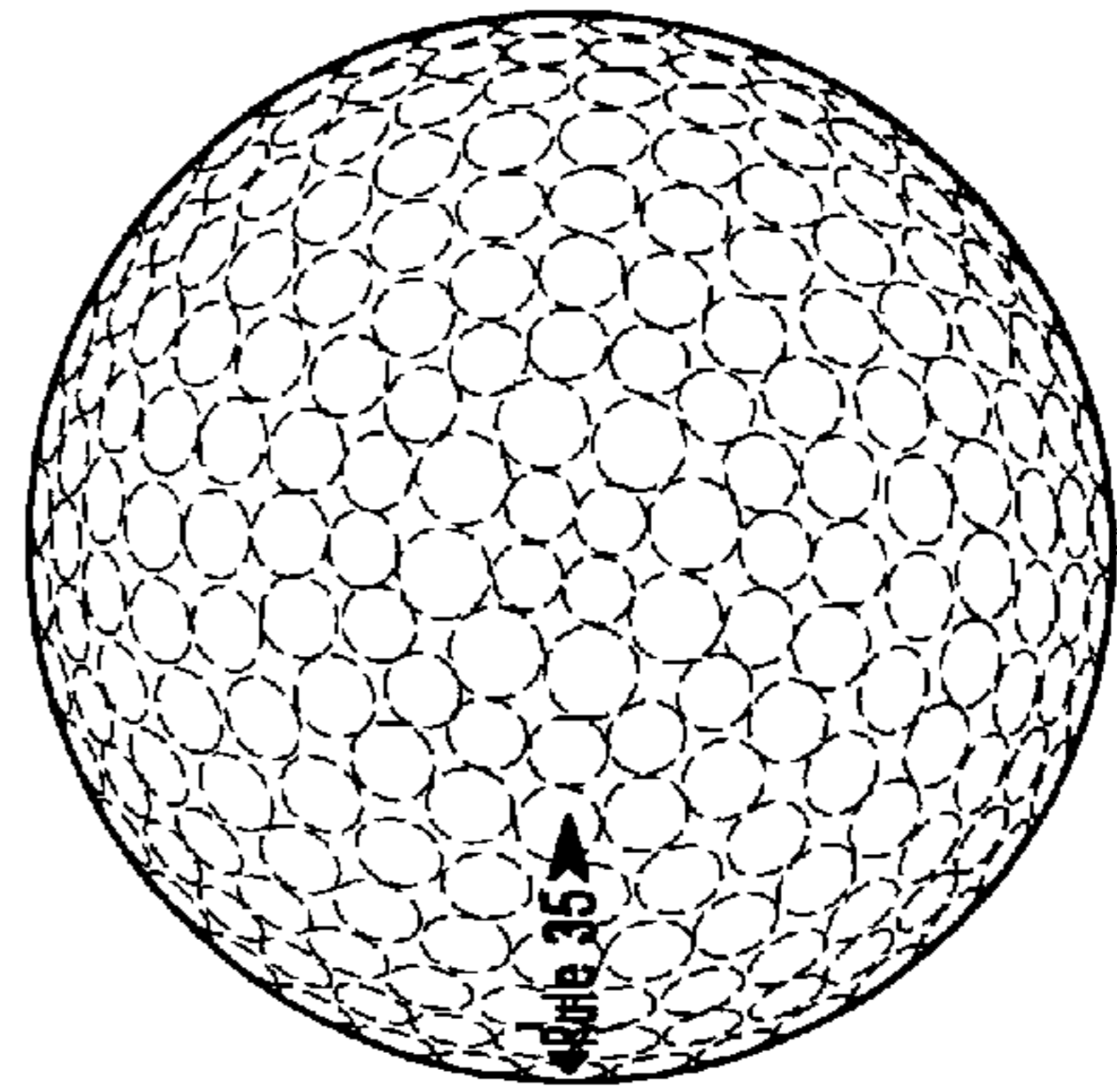

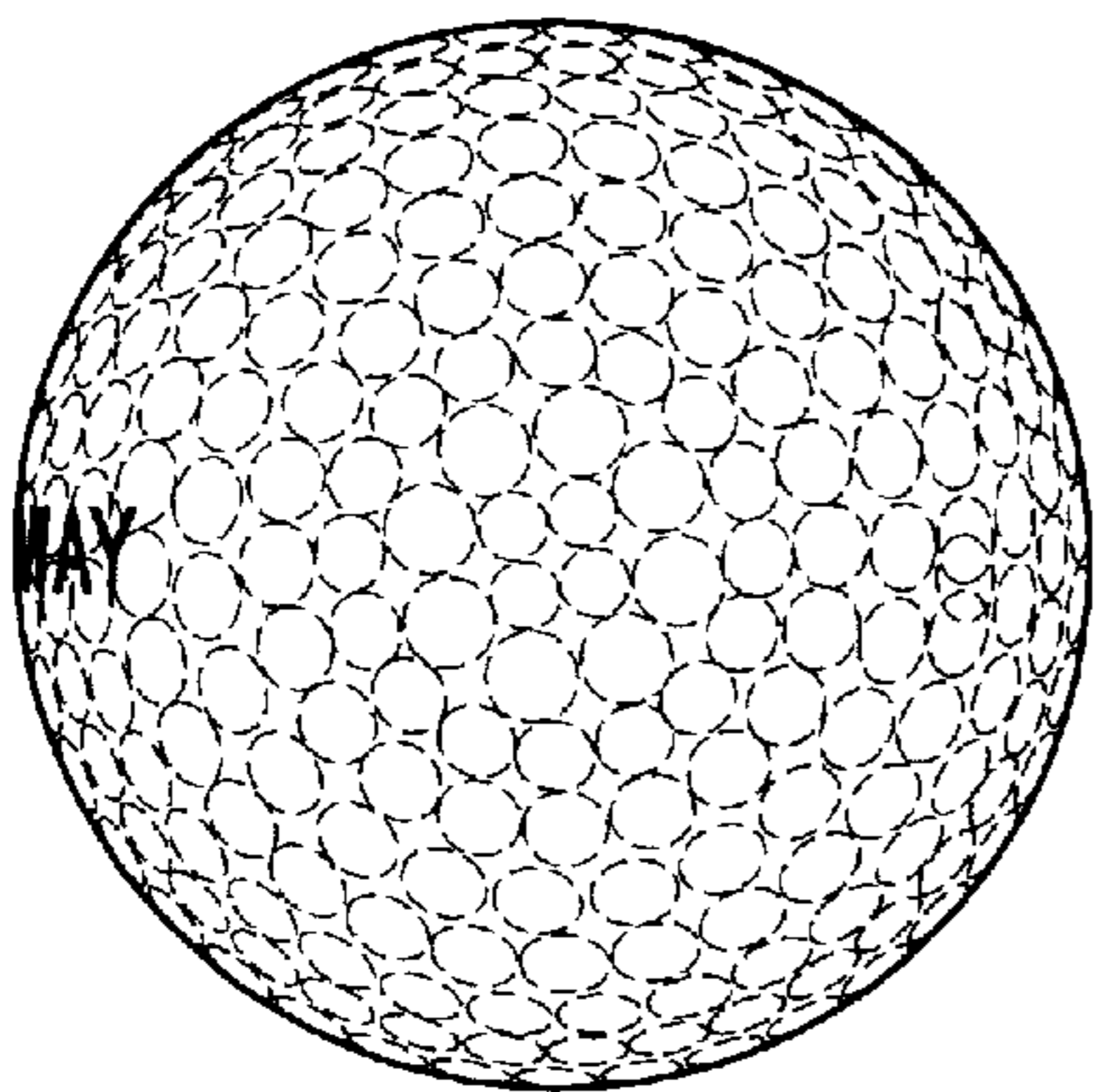

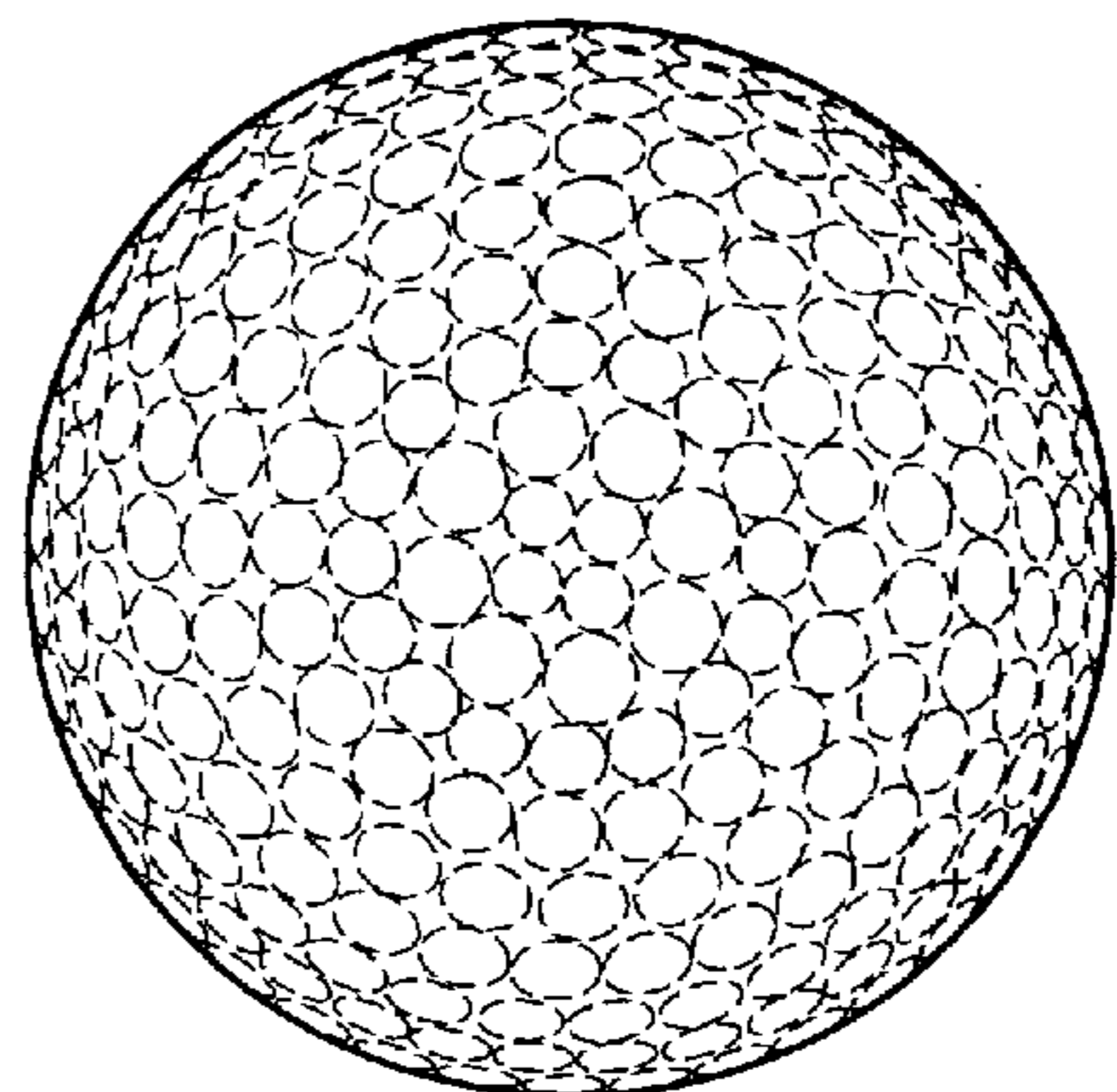
