(57) **CLAIM**

The ornamental design for a respirator facemask assembly, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a respirator facemask assembly according to the present invention;

FIG. 2 is a front view of the respirator facemask assembly illustrated in FIG. 1;

FIG. 3 is a right side view of the respirator facemask assembly illustrated in FIG. 1, the left side view being the mirror image thereof;

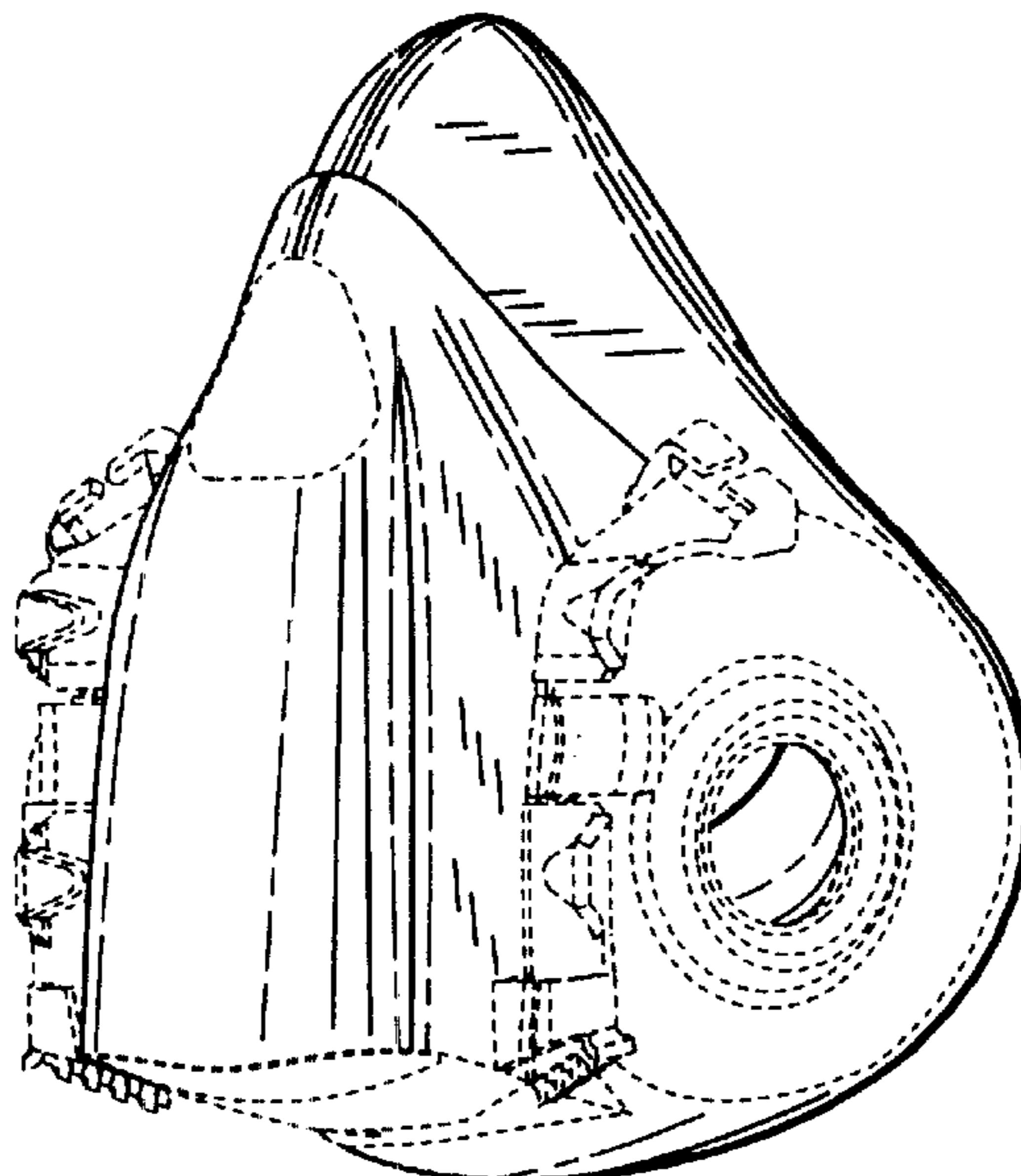
FIG. 4 is a rear view of the respirator facemask assembly illustrated in FIG. 1;

FIG. 5 is a top plan view of the respirator facemask assembly illustrated in FIG. 1; and,

FIG. 6 is a bottom plan view of the respirator facemask assembly illustrated in FIG. 1.

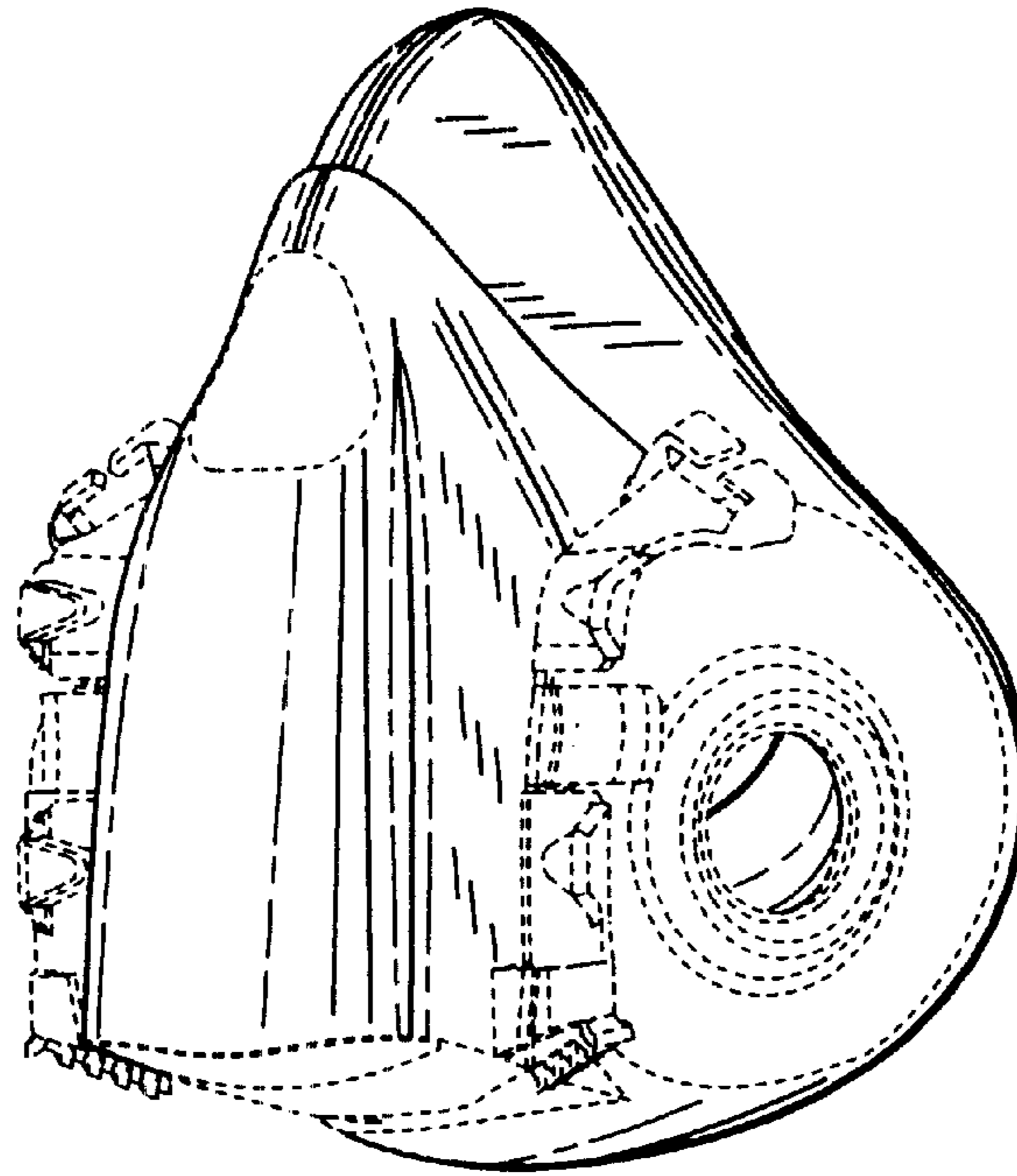

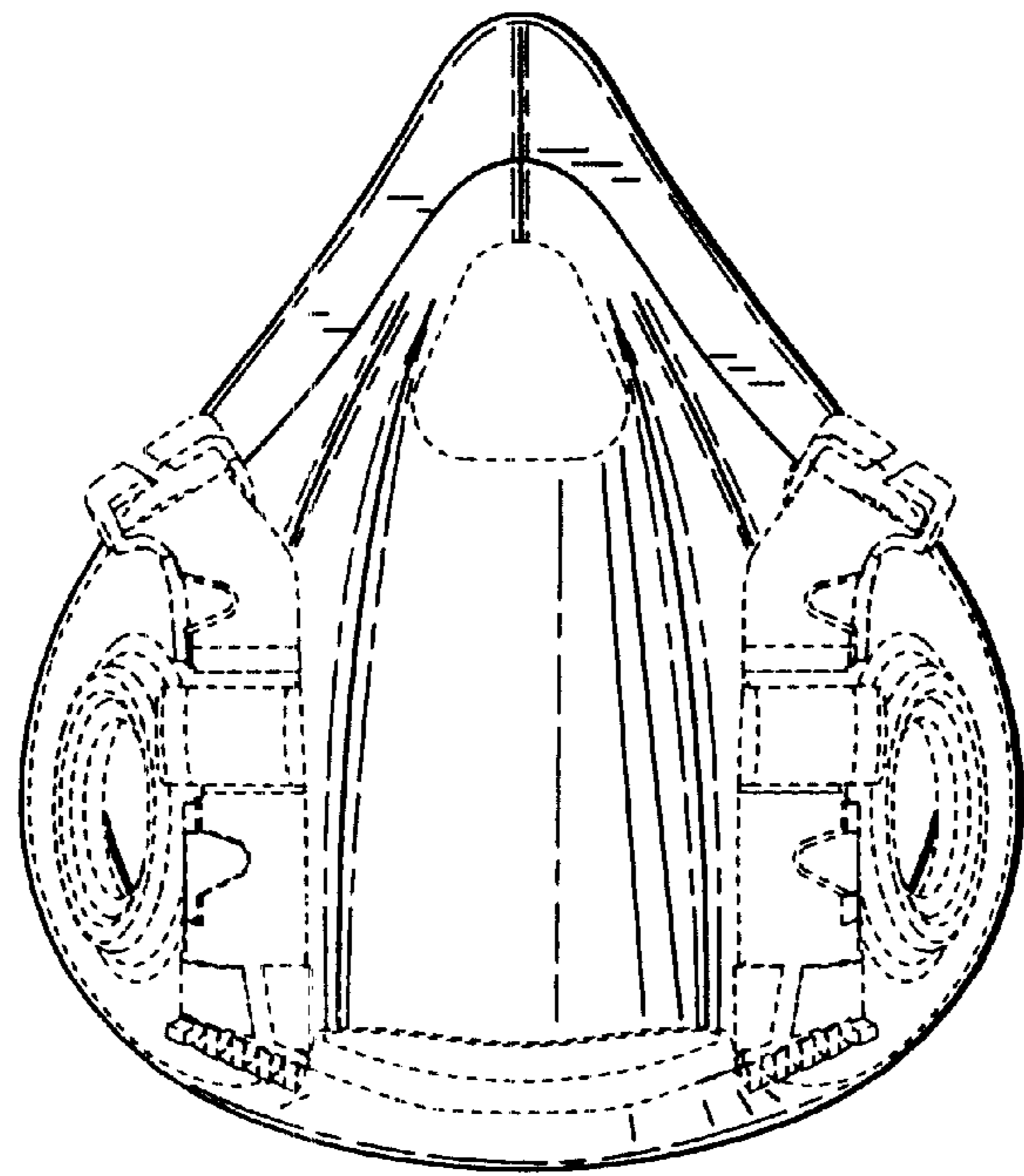

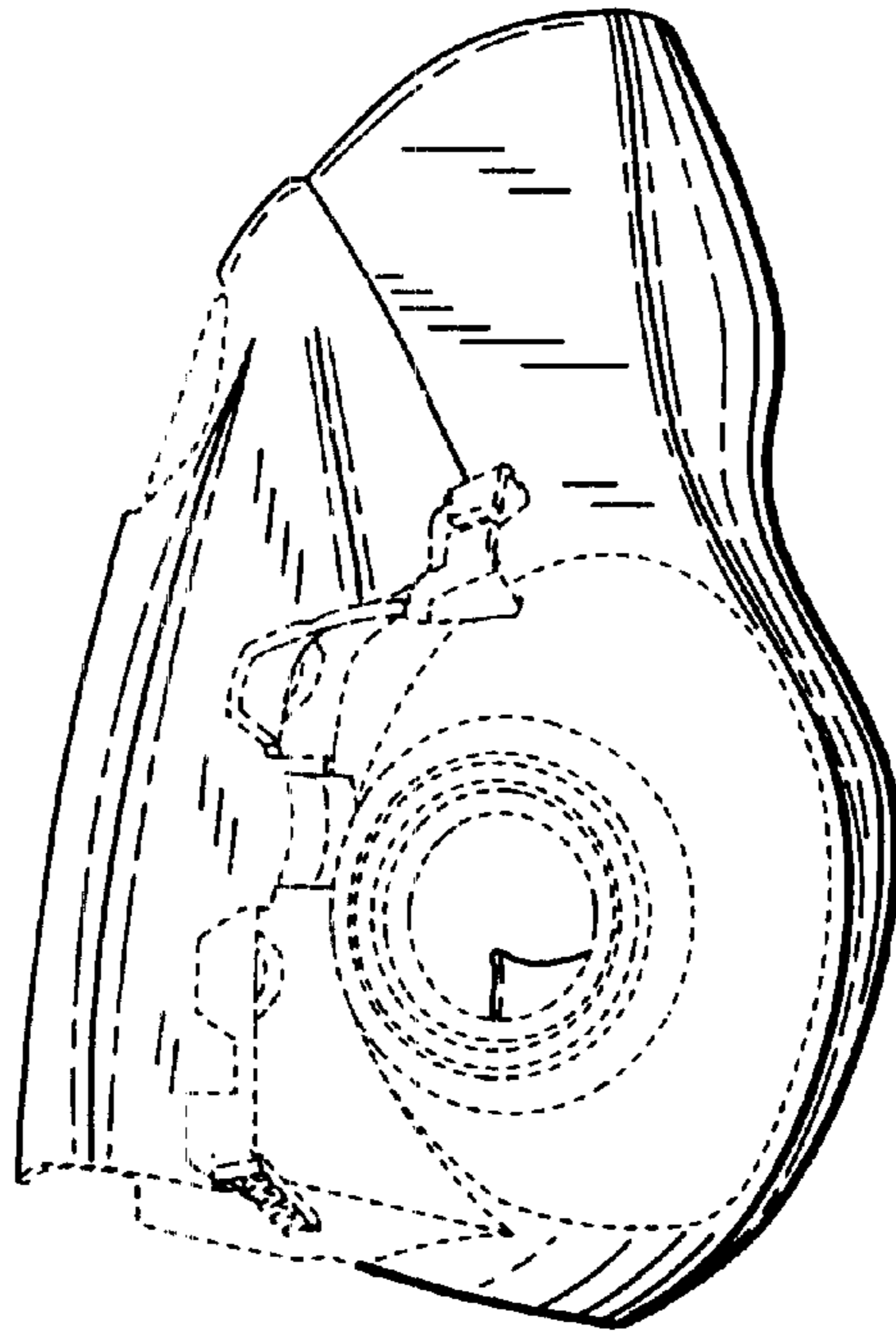

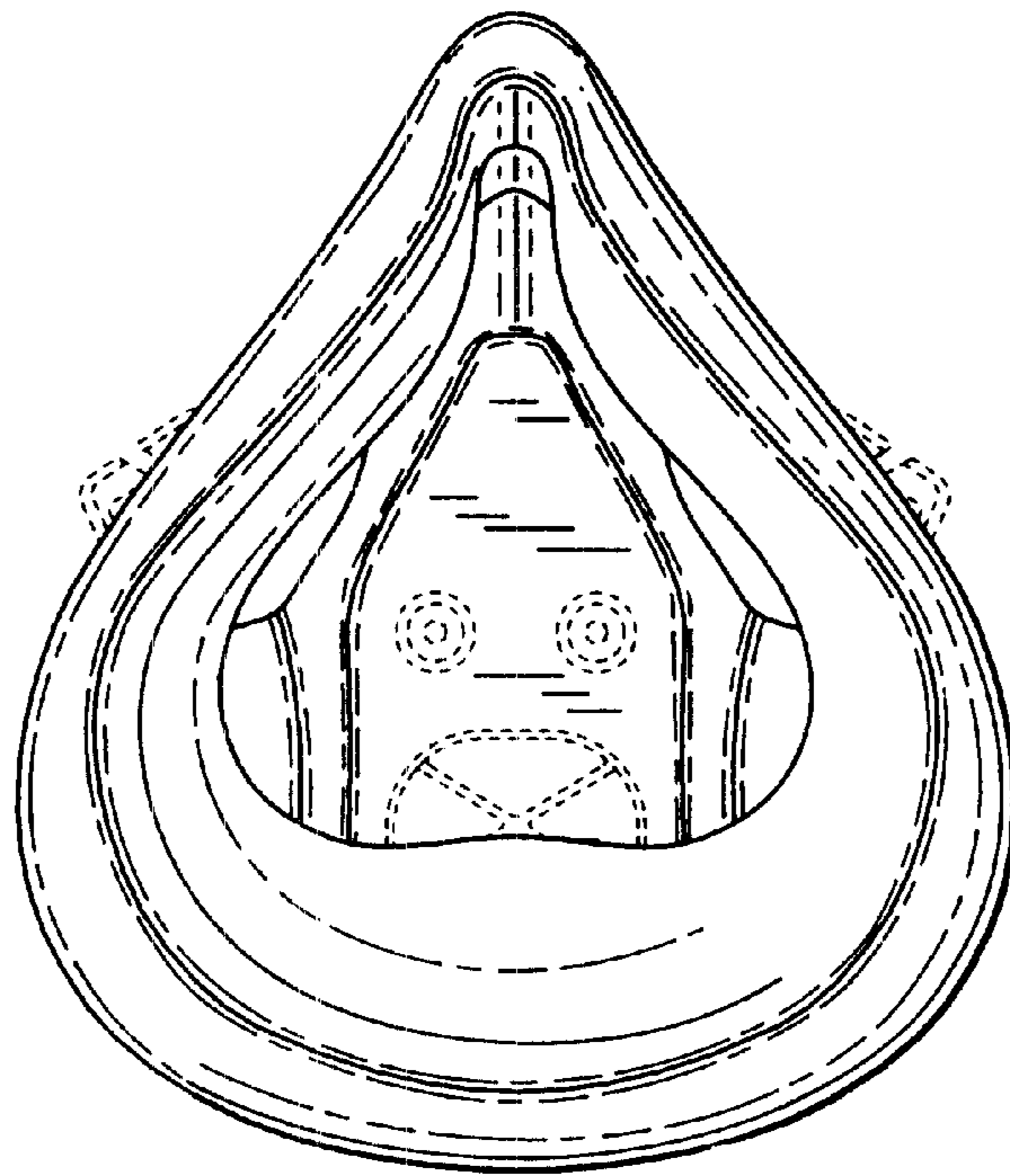

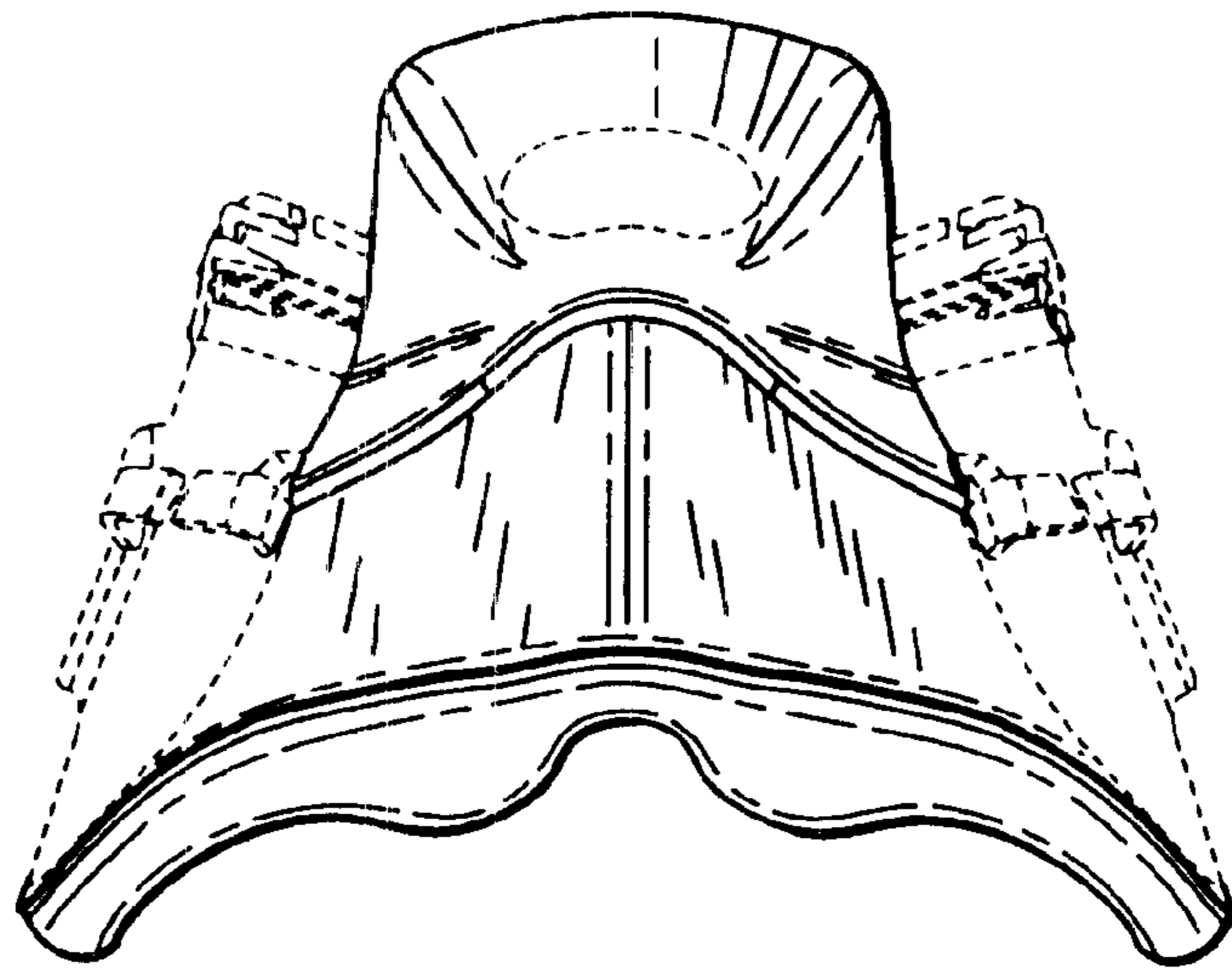

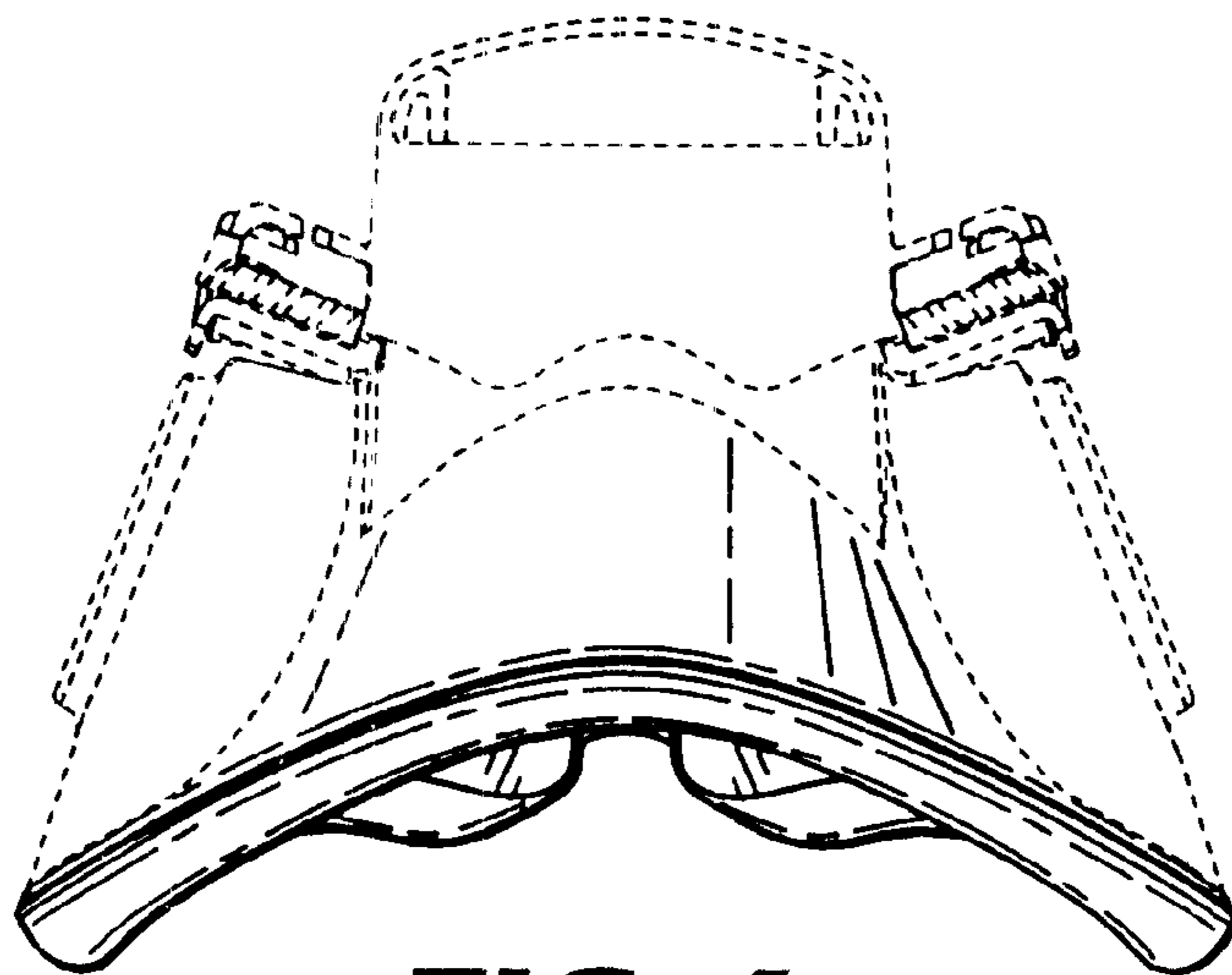
