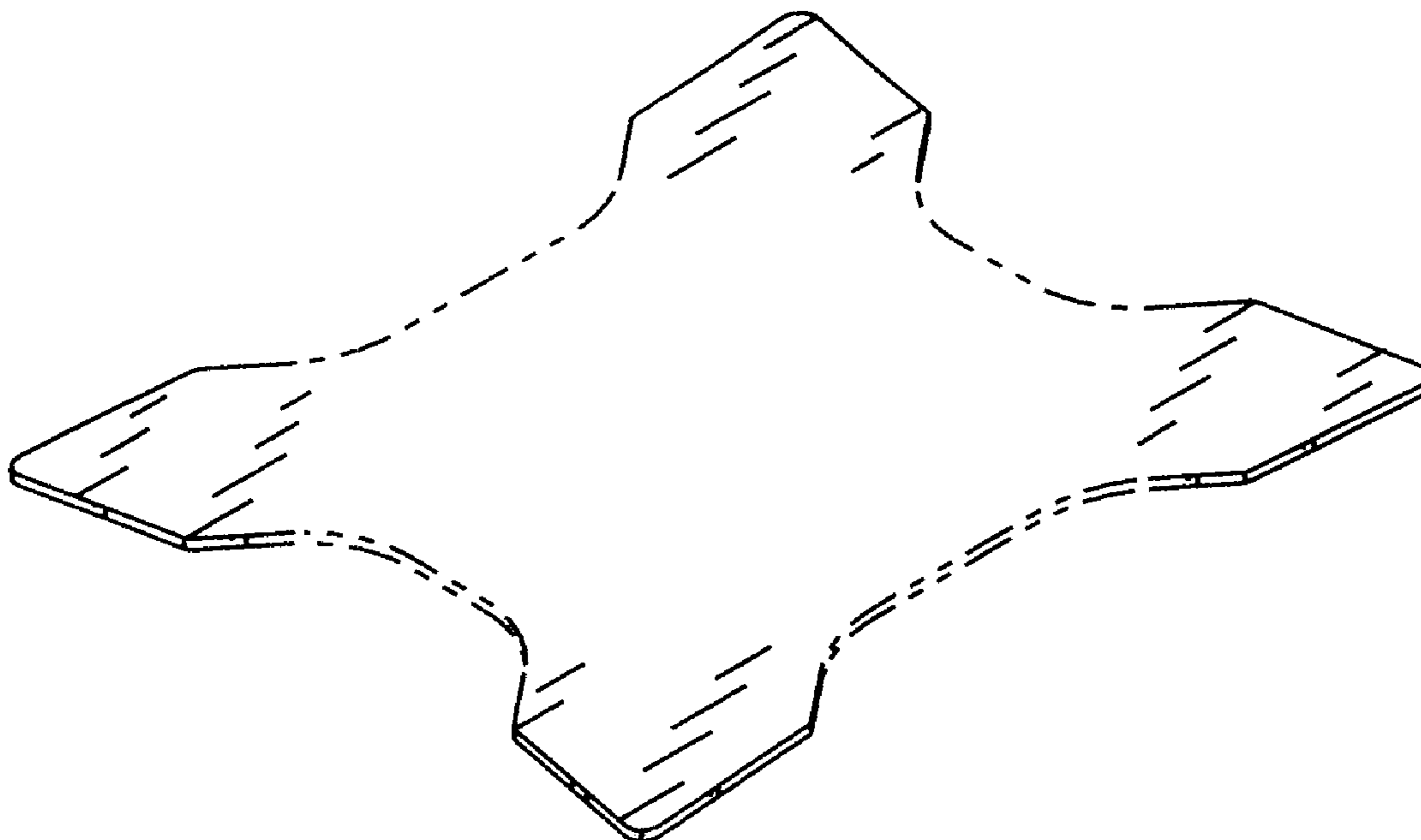
The ornamental design for a medical article, as shown and described.

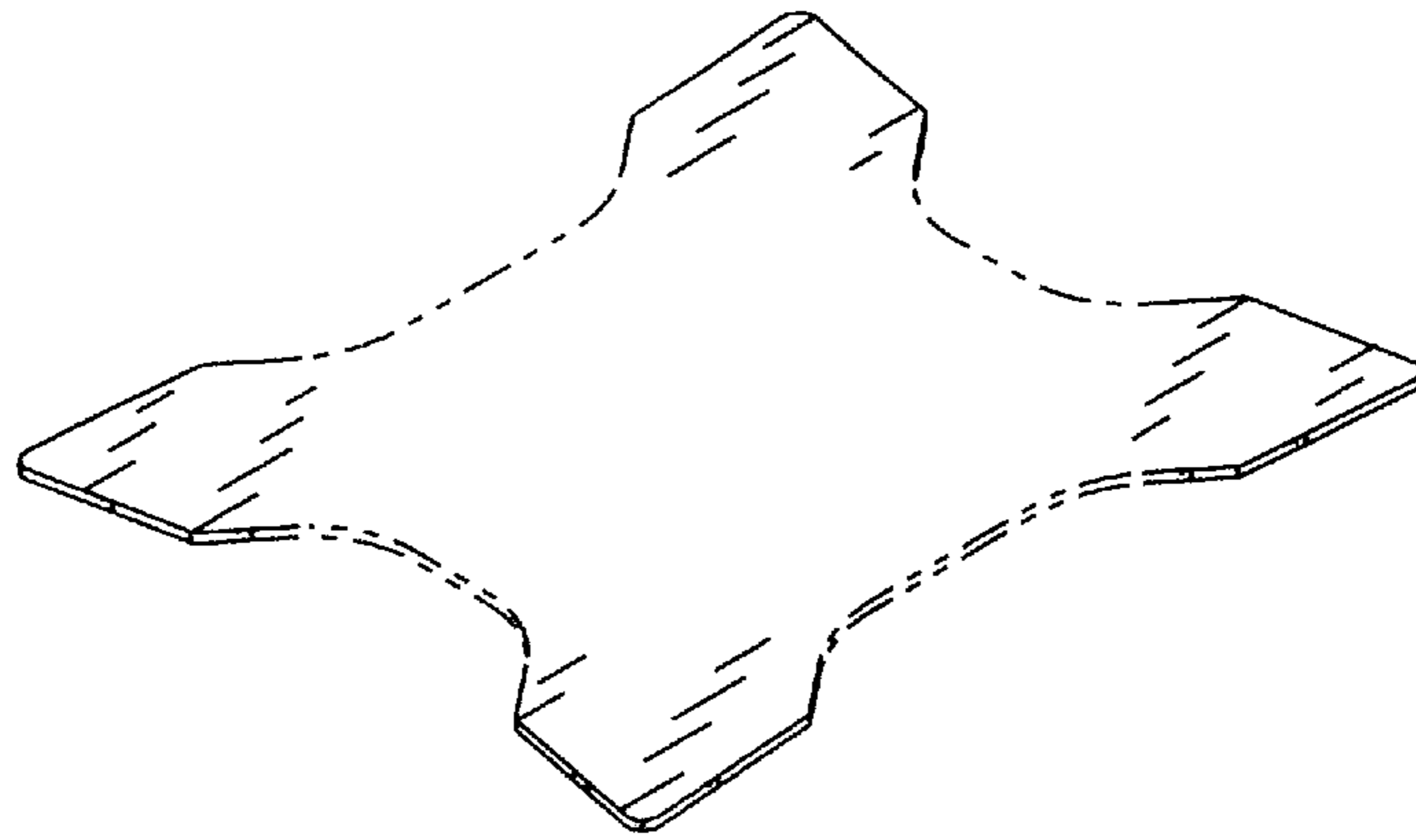
**DESCRIPTION**

FIG. 5 is a side view thereof.

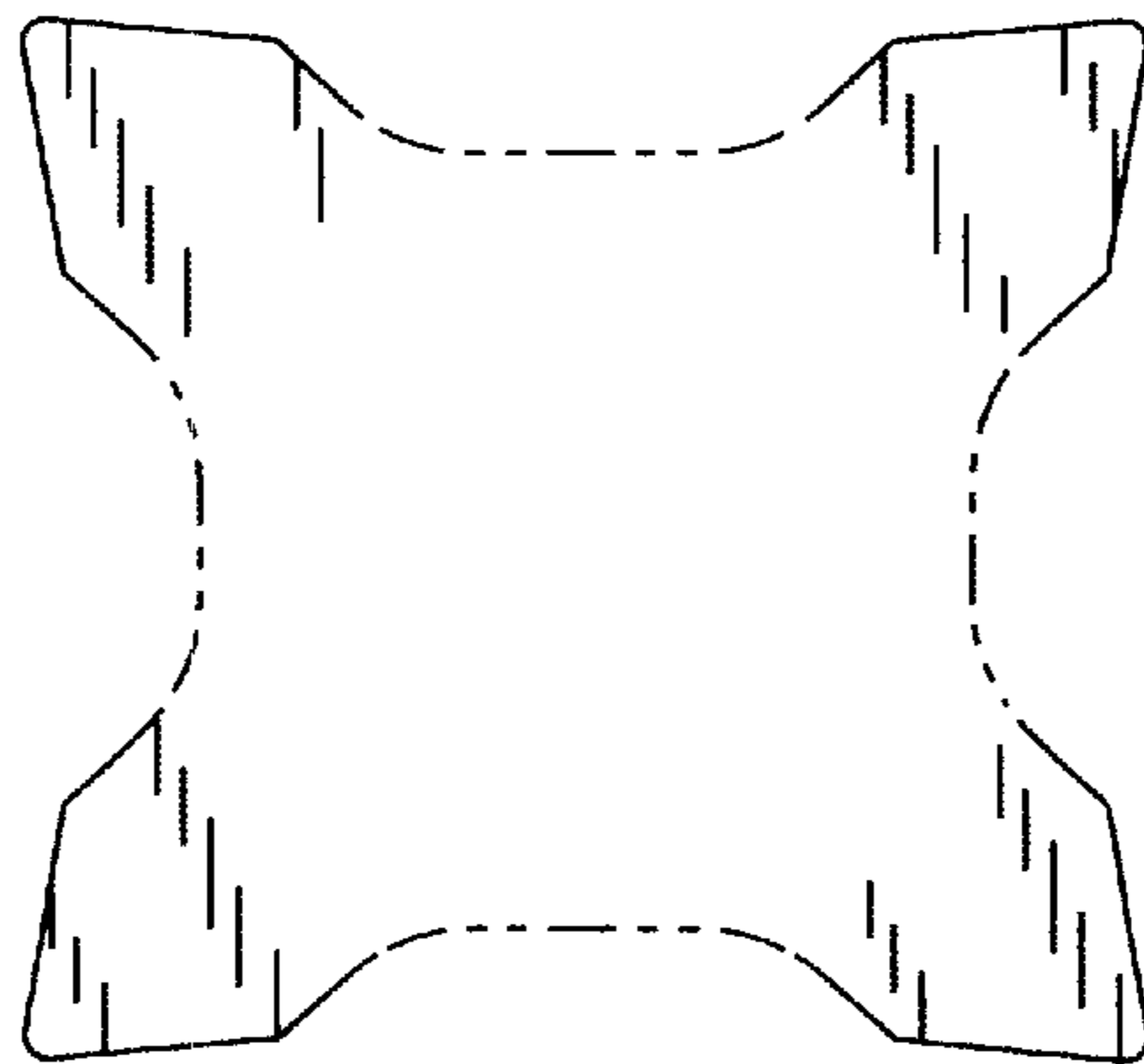

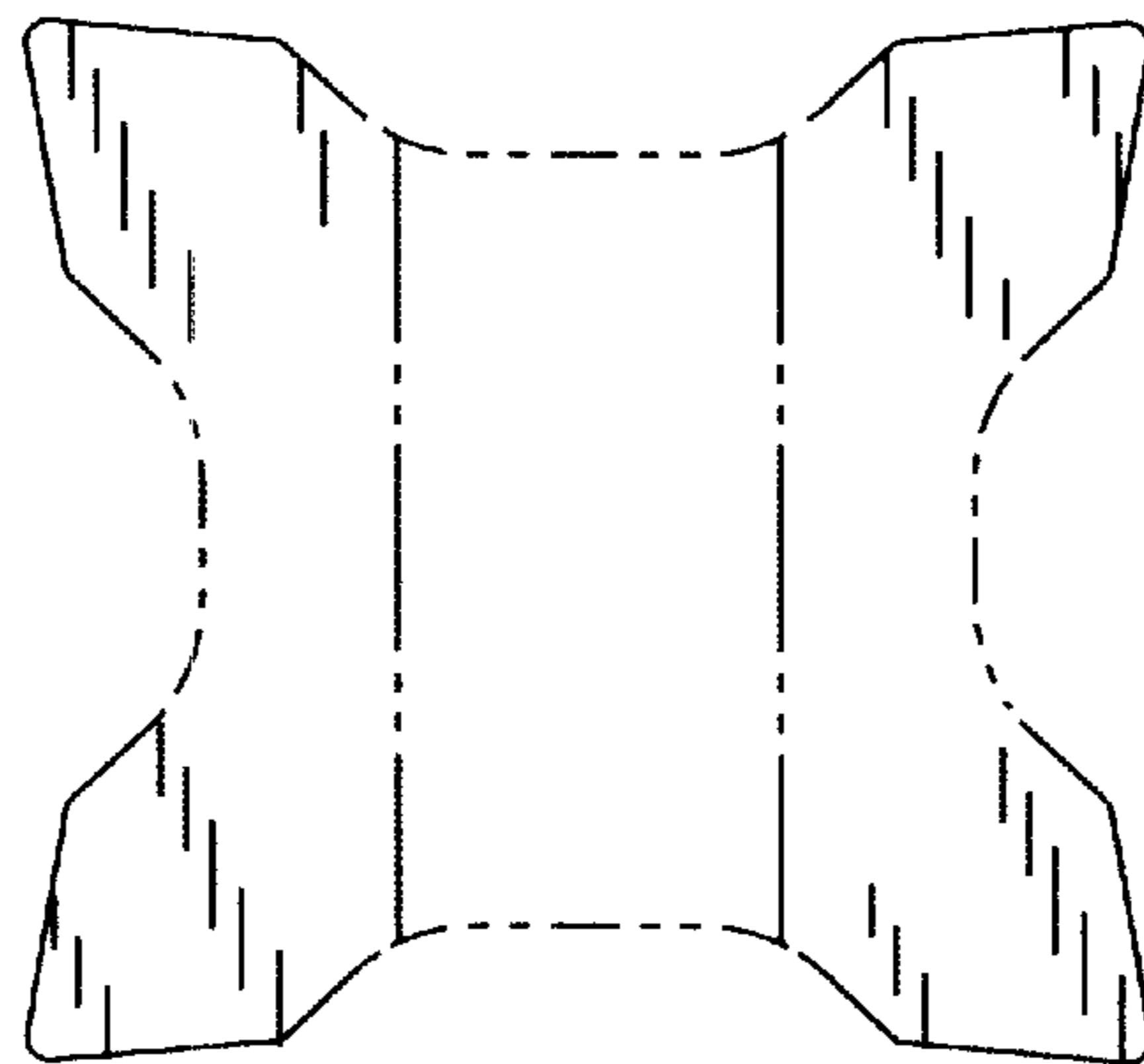




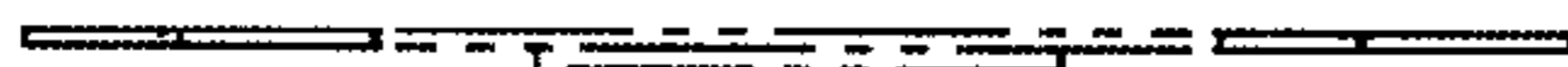

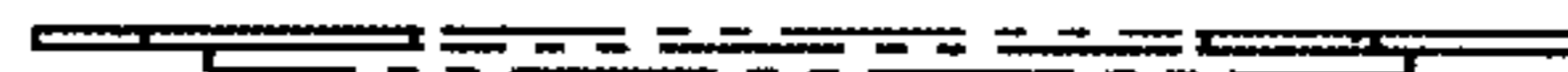
