**DESCRIPTION**

FIG. 1 is a front elevational view of a helmet chin cover showing my new design;  
FIG. 2 is a rear elevational view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a bottom plan view thereof;  
FIG. 5 is a right side elevational view thereof; and,  
FIG. 6 is a sectional view taken along line 6—6 of FIG. 5.  
The dotted areas in all views represents surface shading and should not be confused as representing a specific pattern.

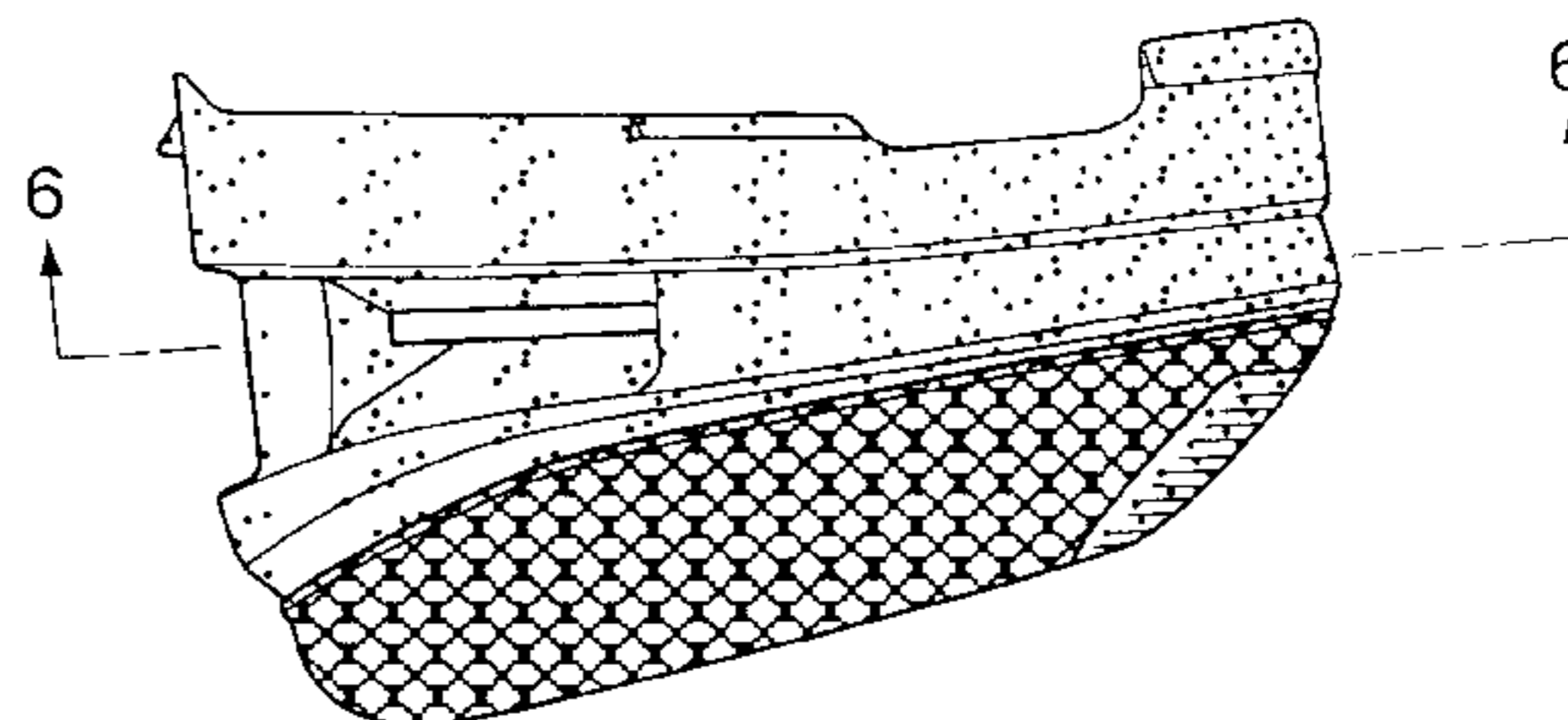
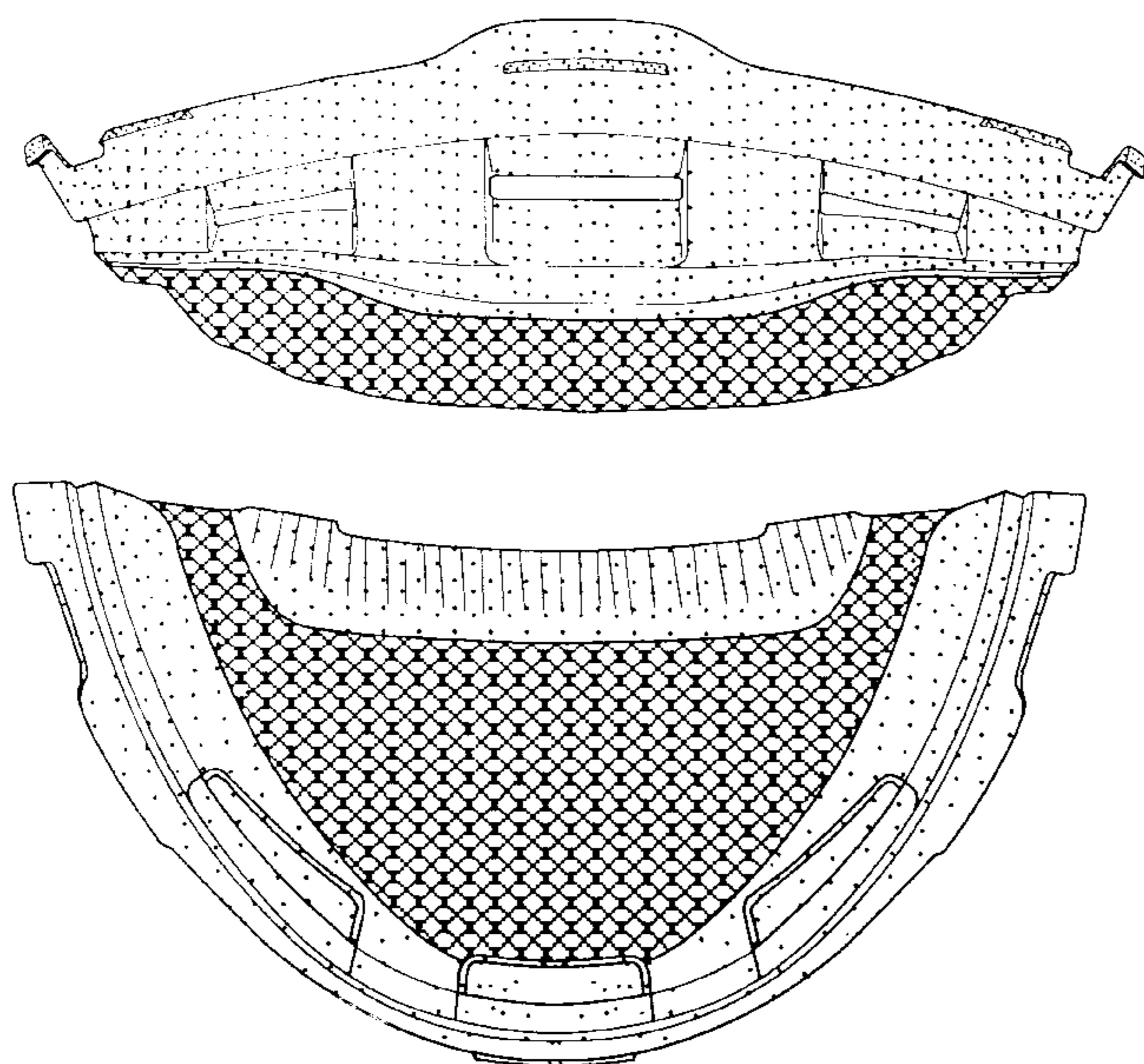

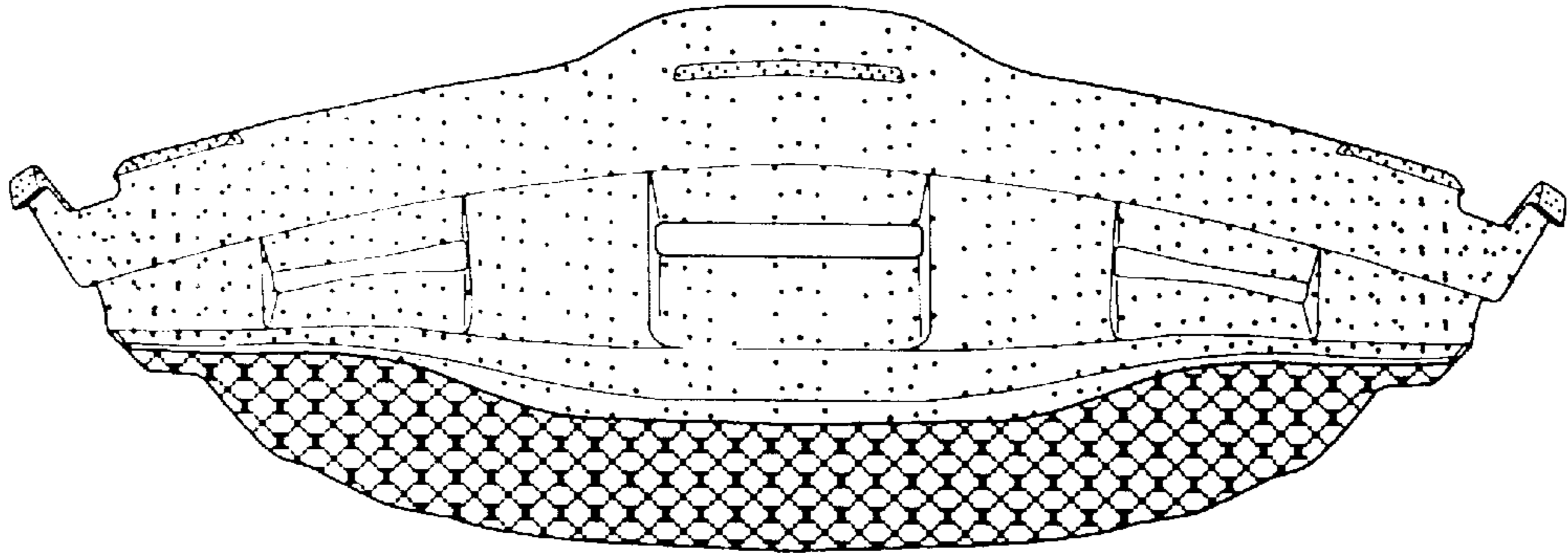

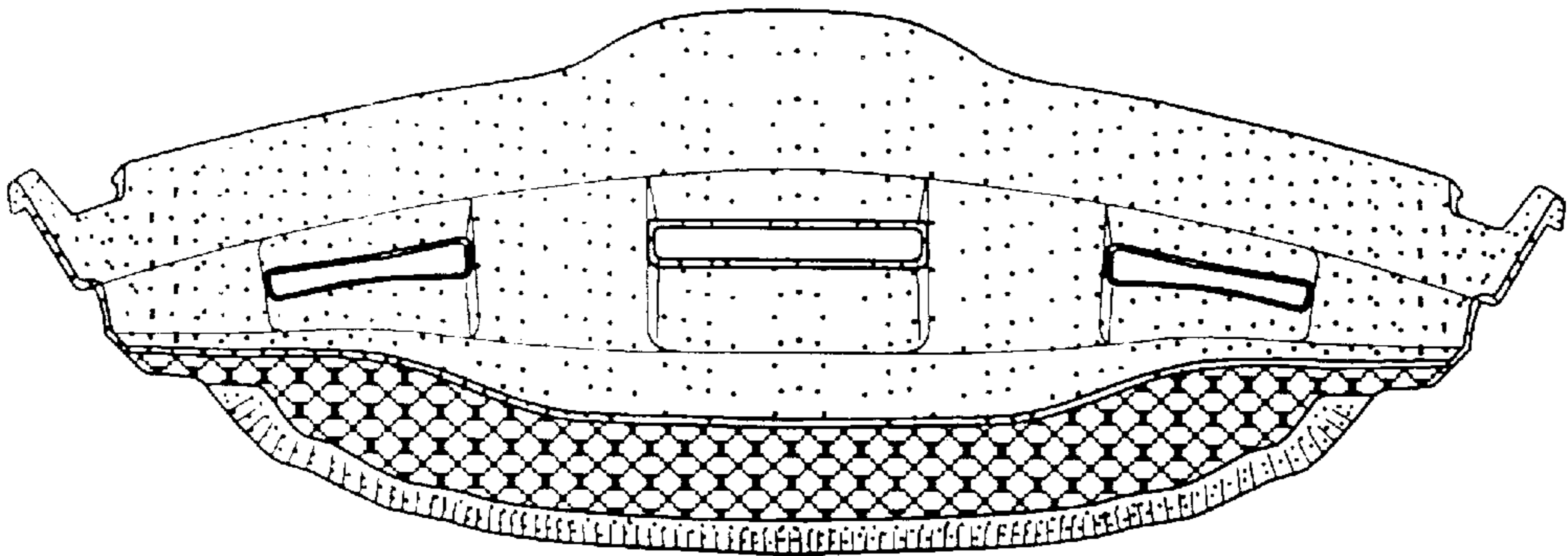
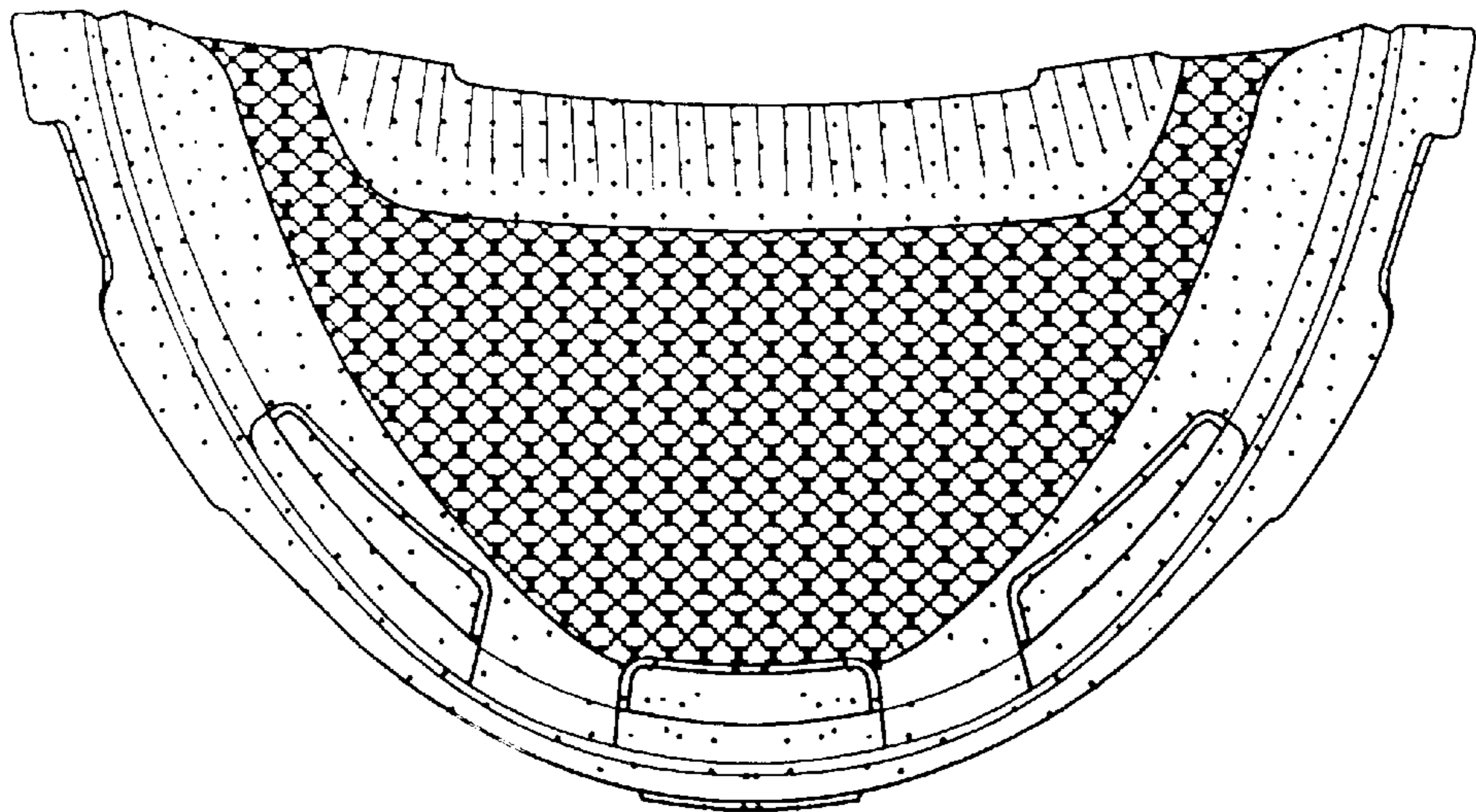
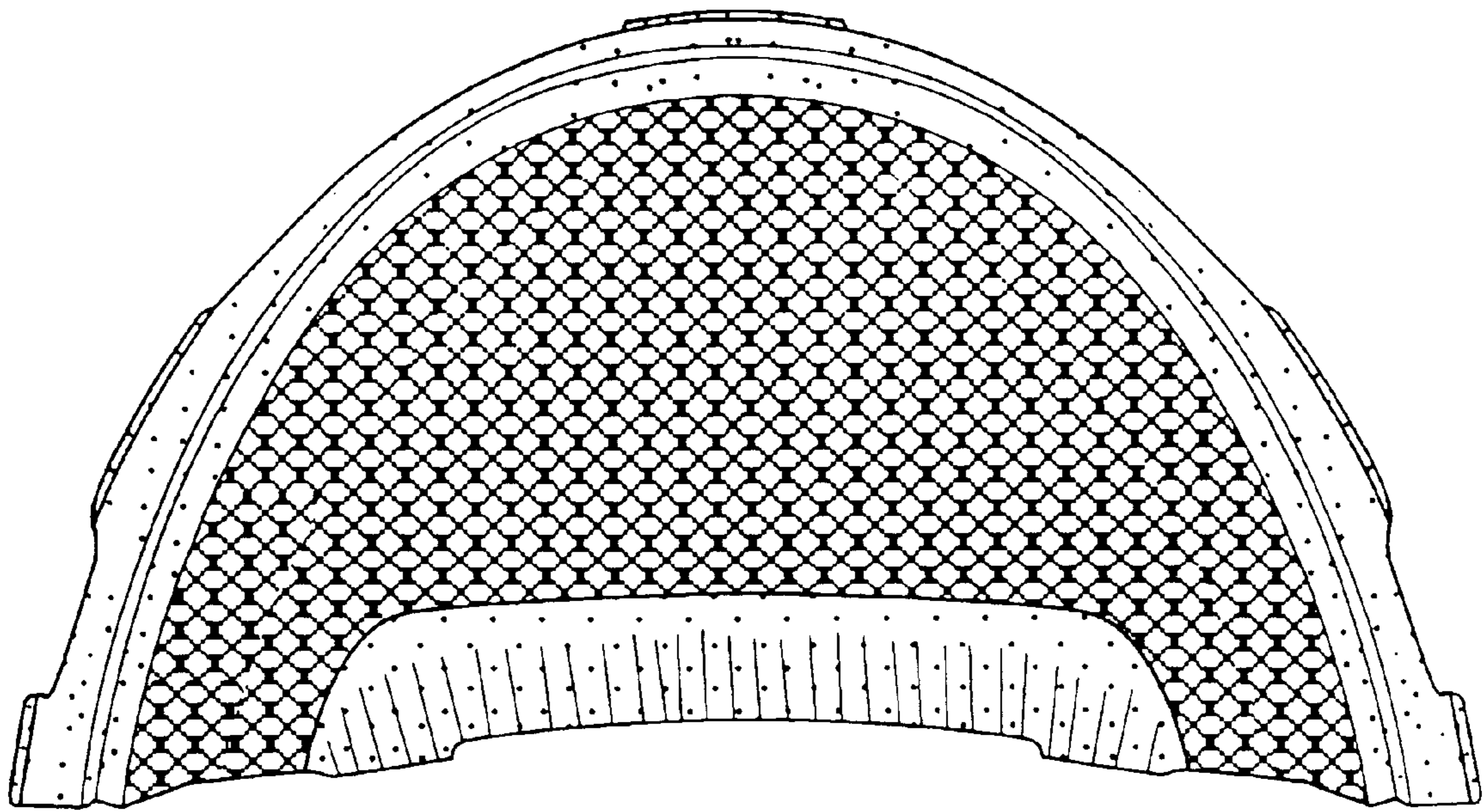


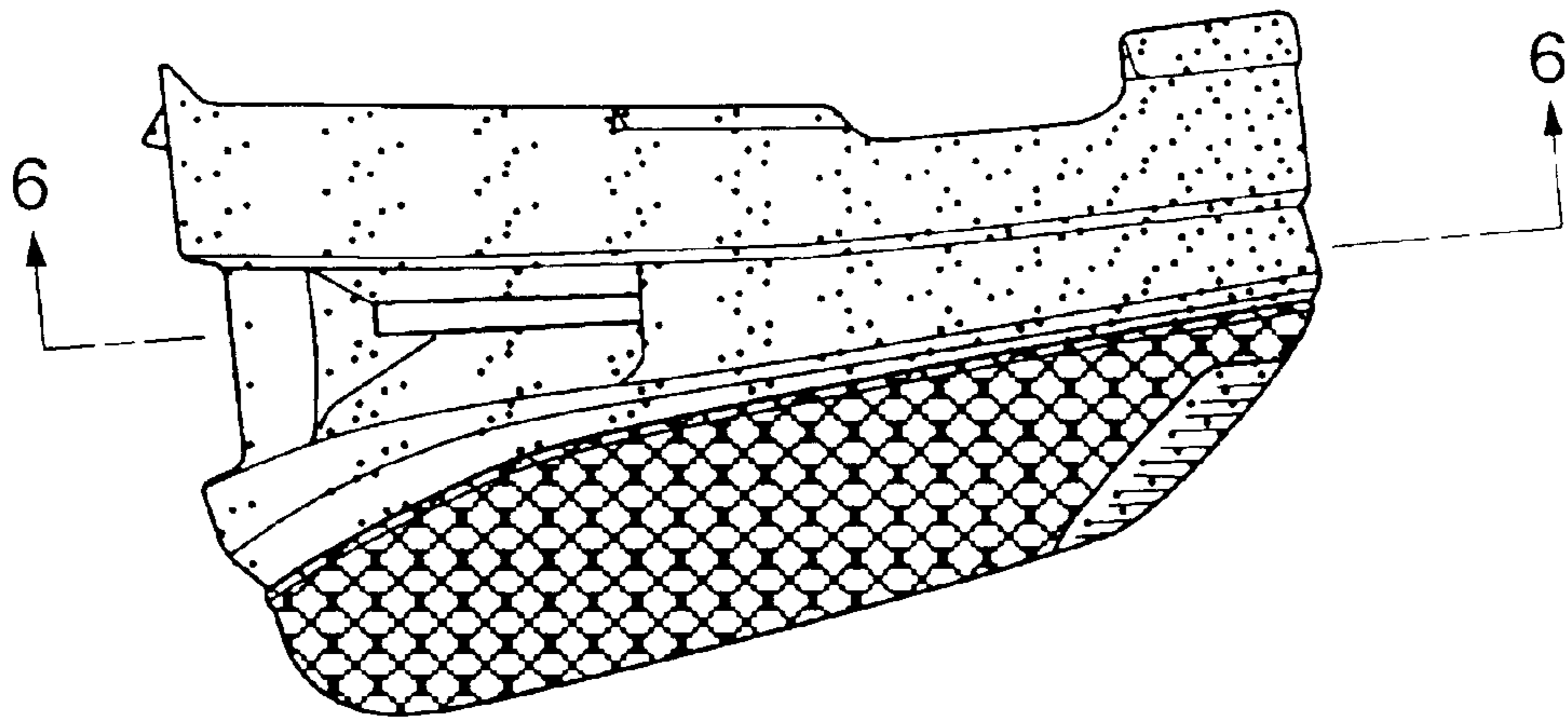
