DESCRIPTION

FIG. 1. is a top front perspective view of a hair brush showing my new design.

FIG. 2. is a front elevational view thereof.

FIG. 3. is a rear elevational view thereof.

FIG. 4. is a left side elevational, a right side view is symmetrical to the left side elevational view.

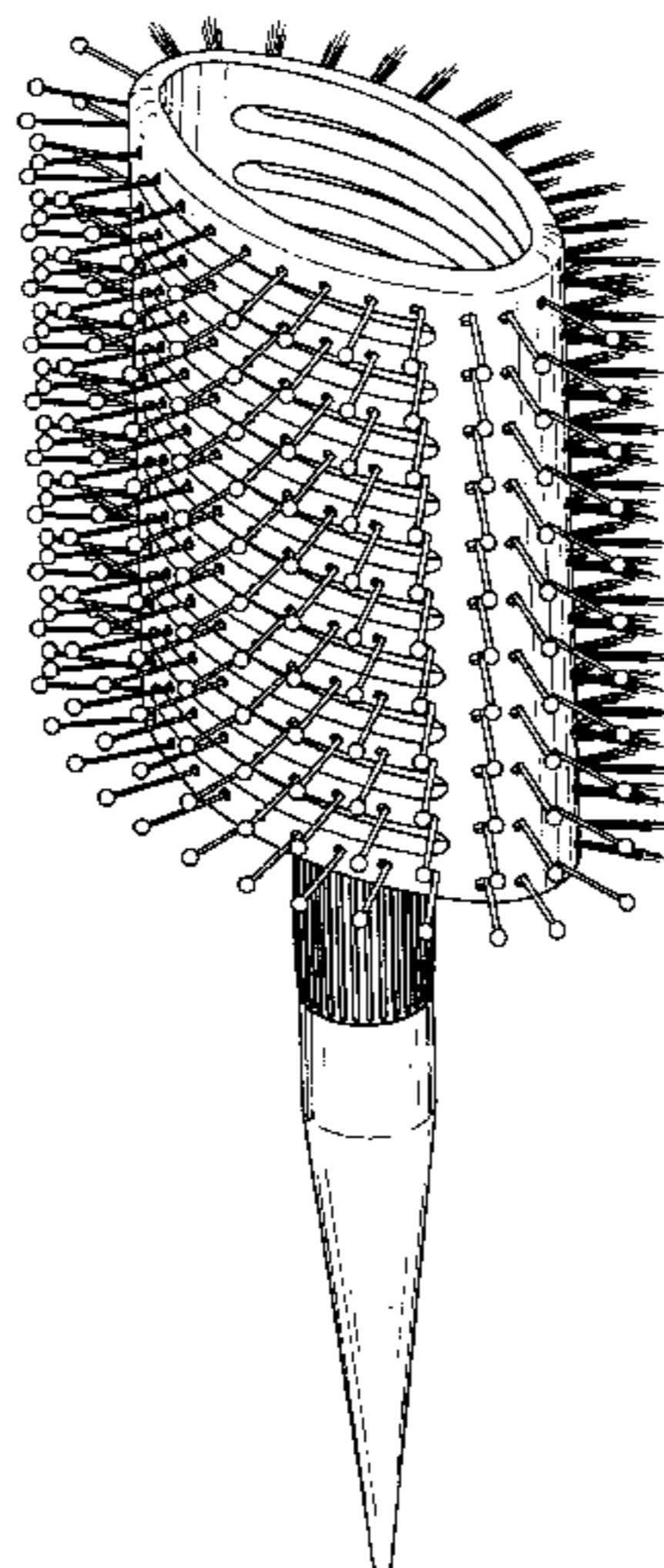
FIG. 5. is top plan view thereof.

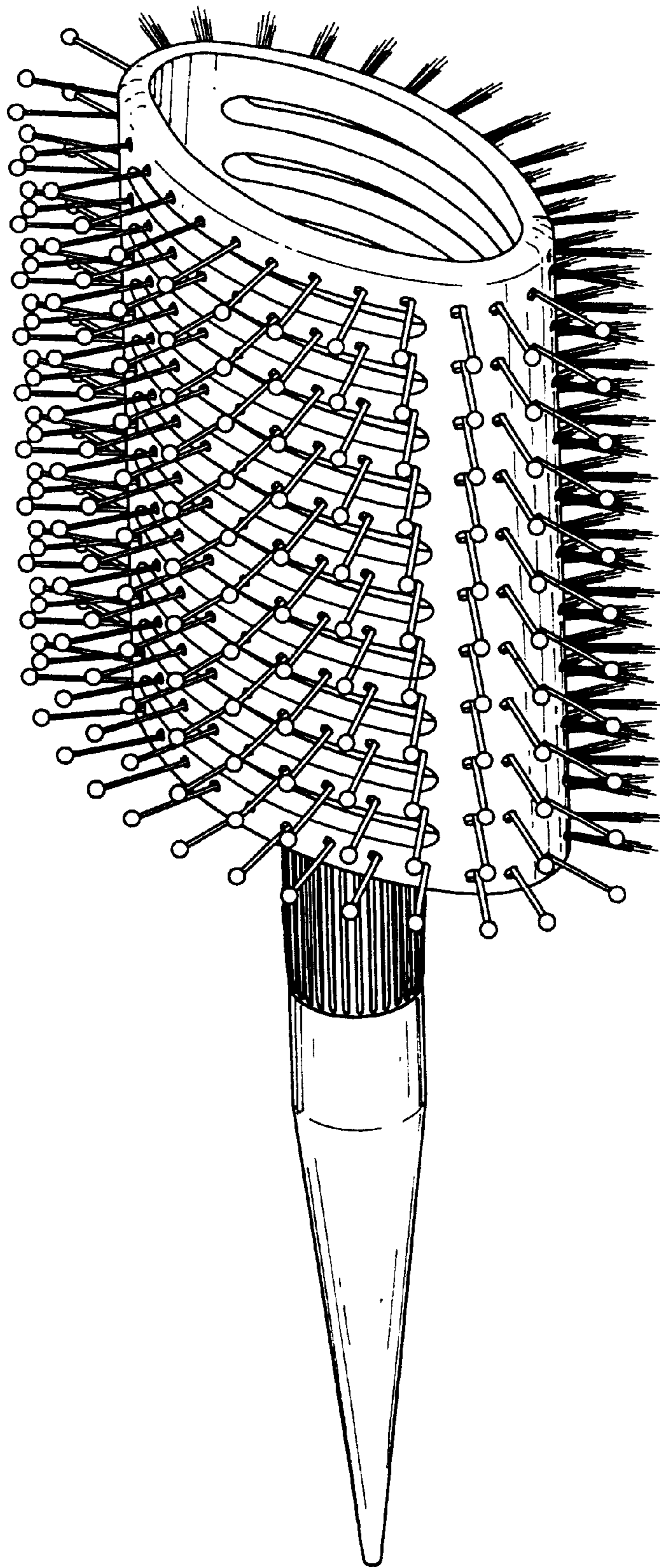

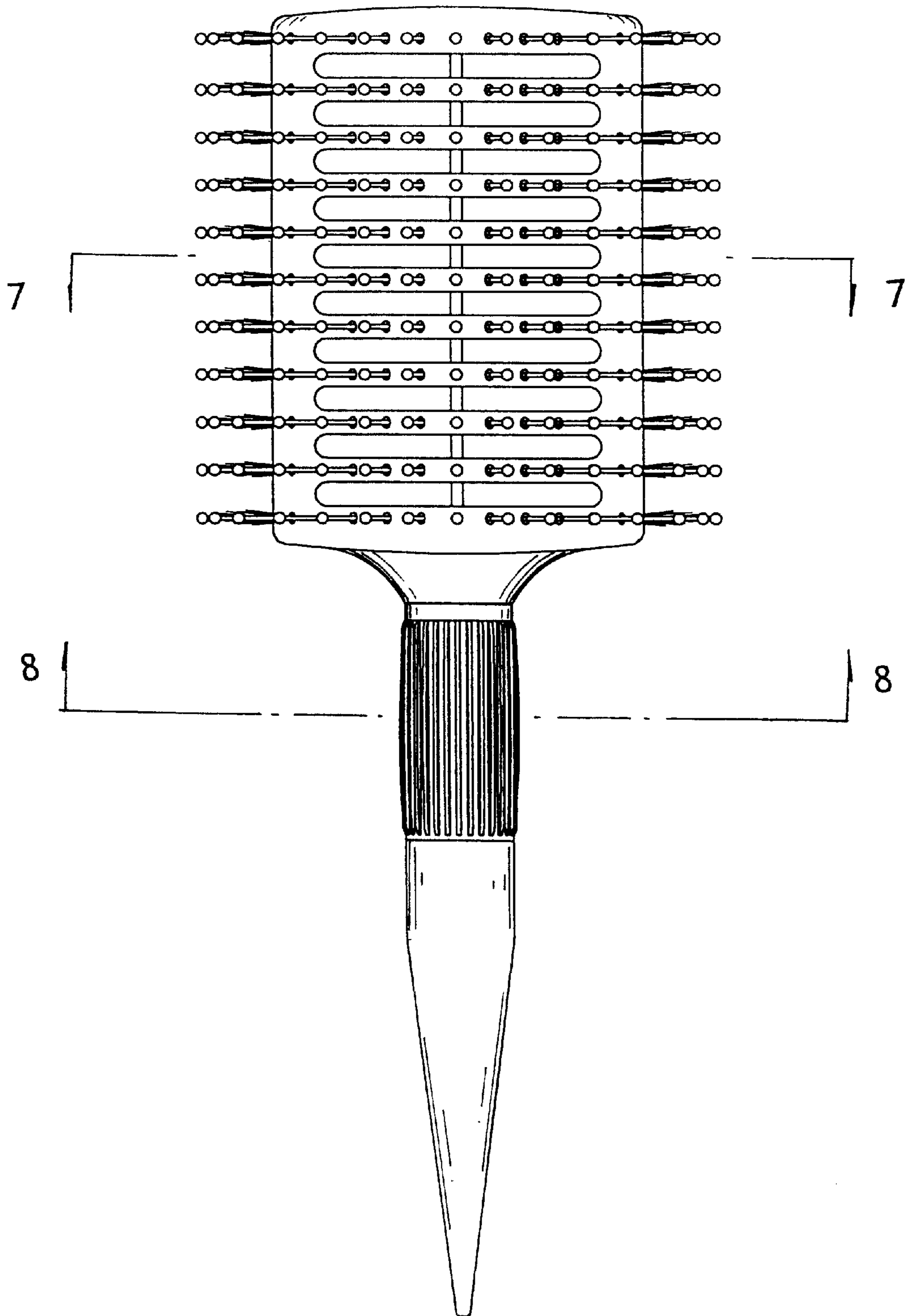

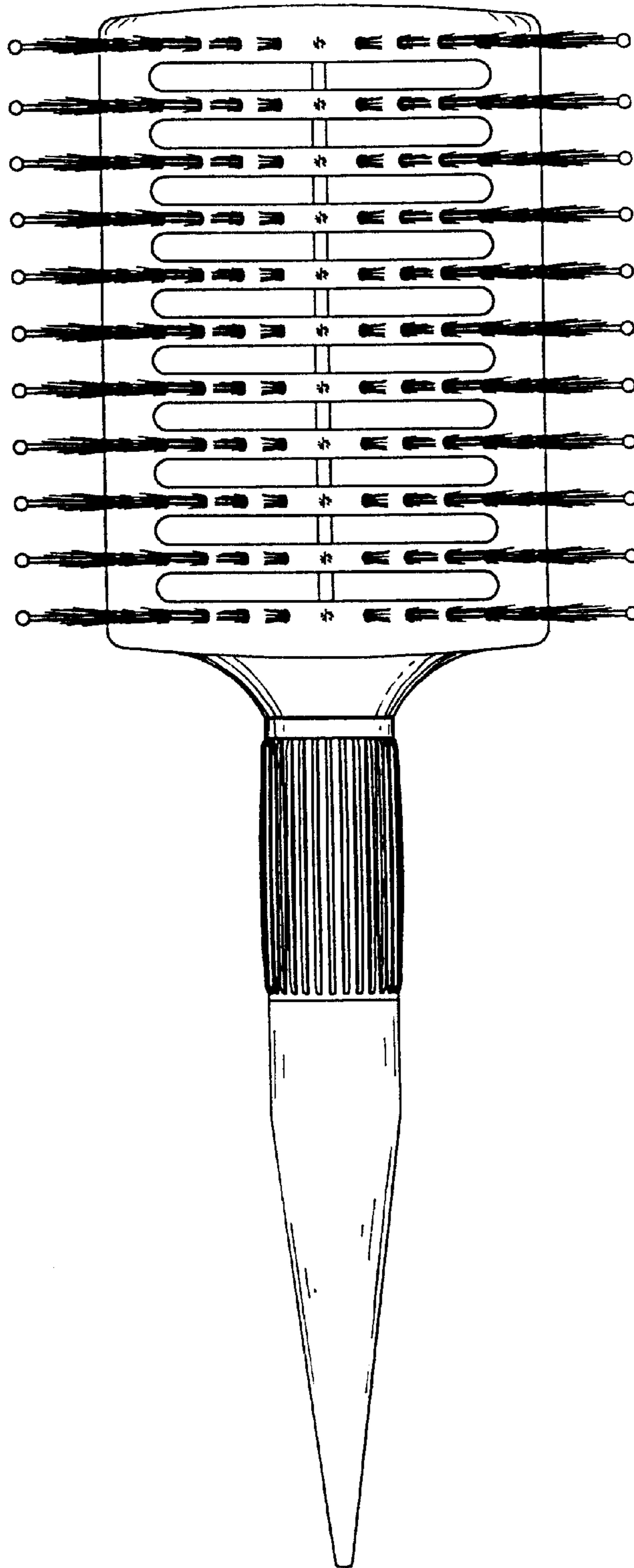

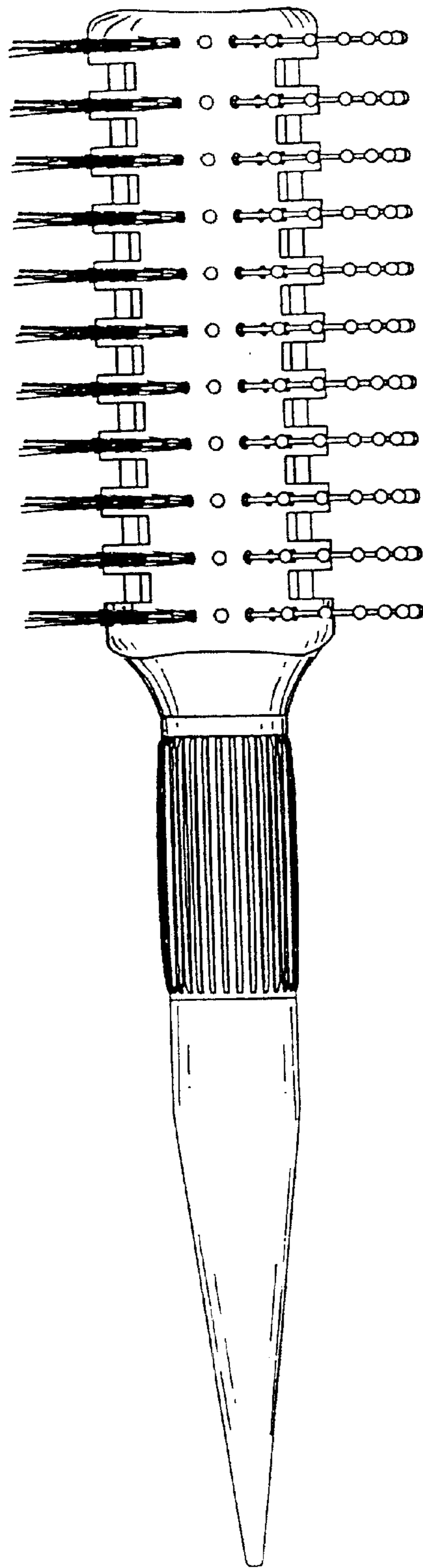

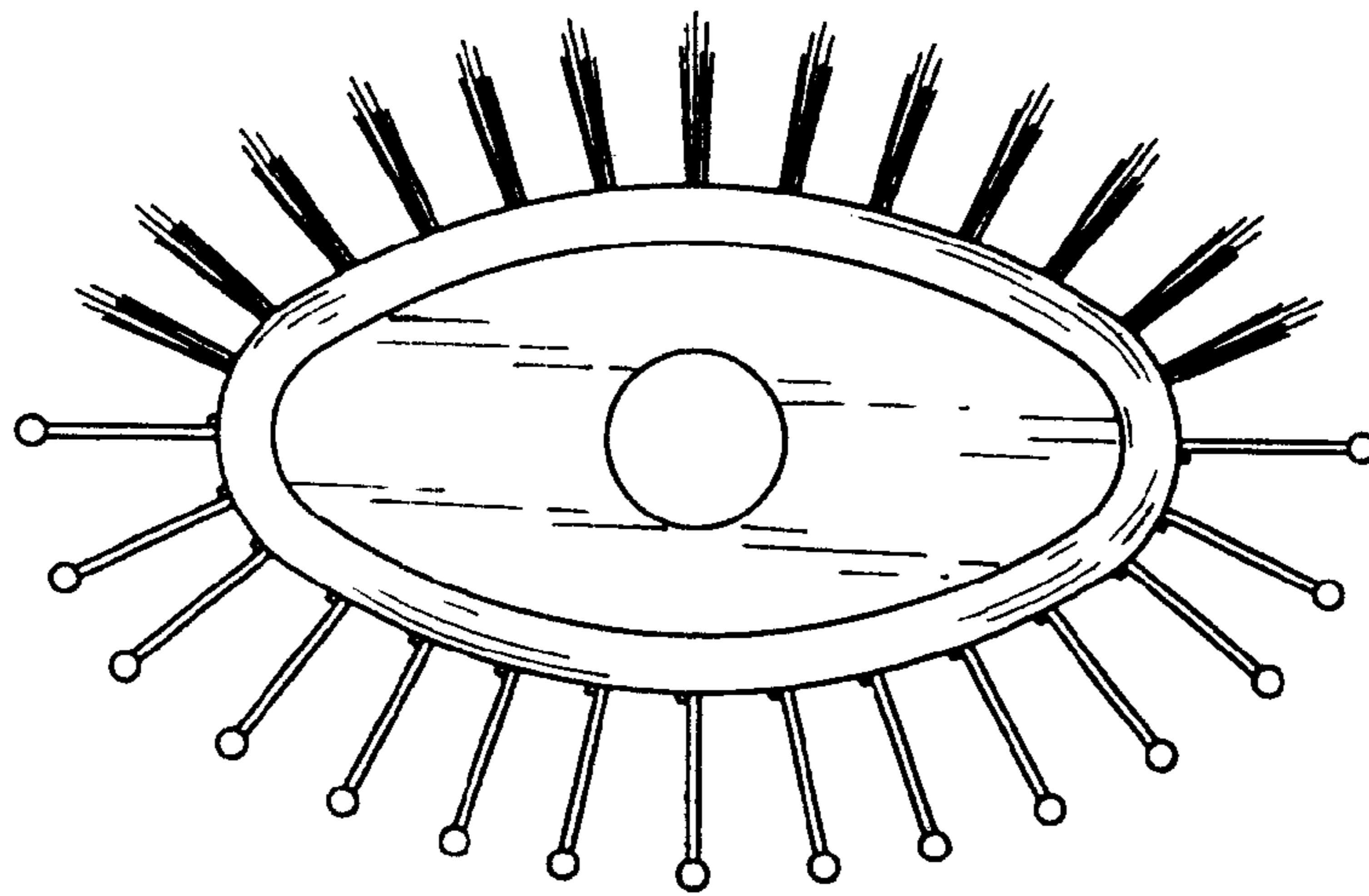

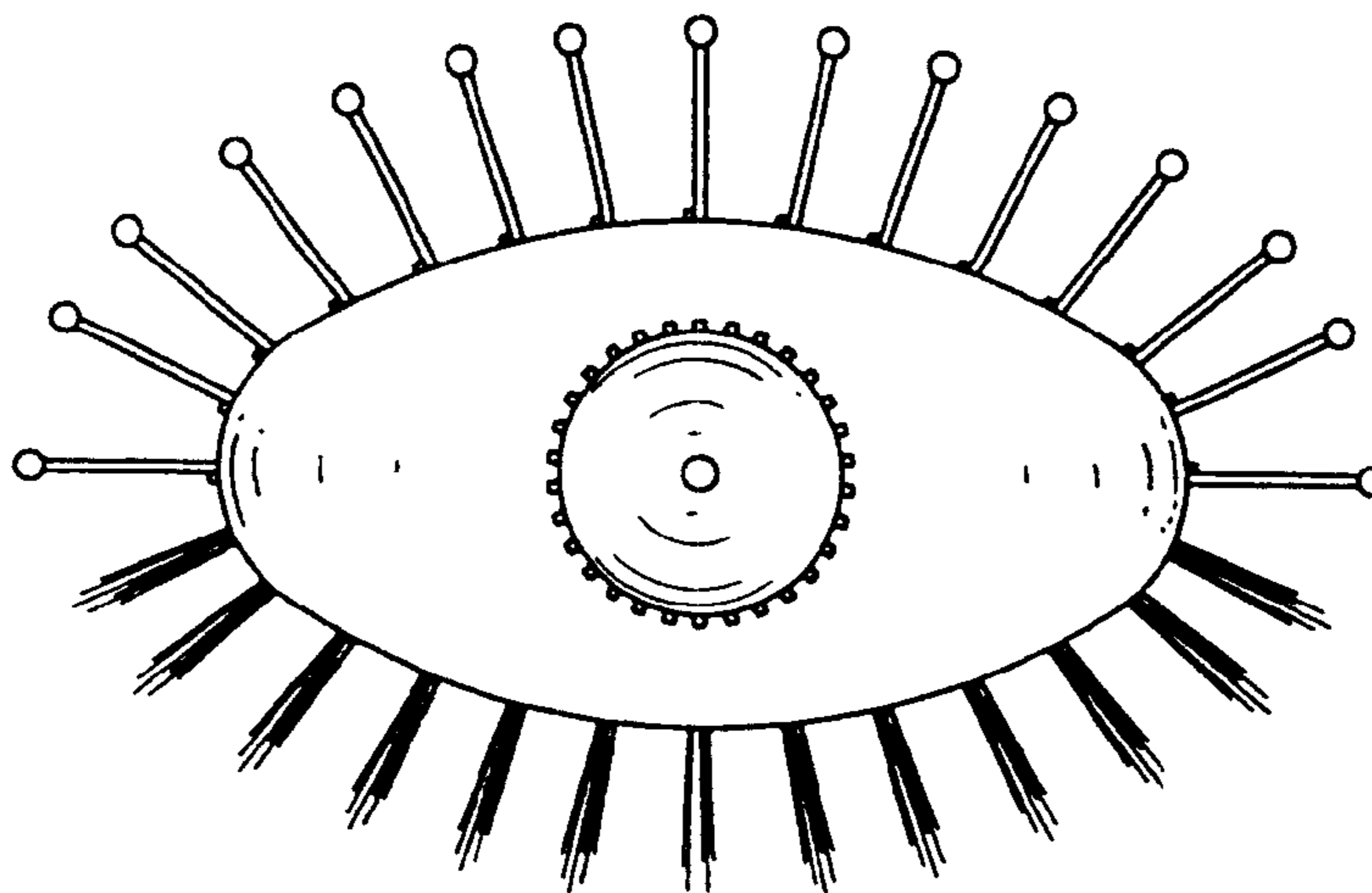

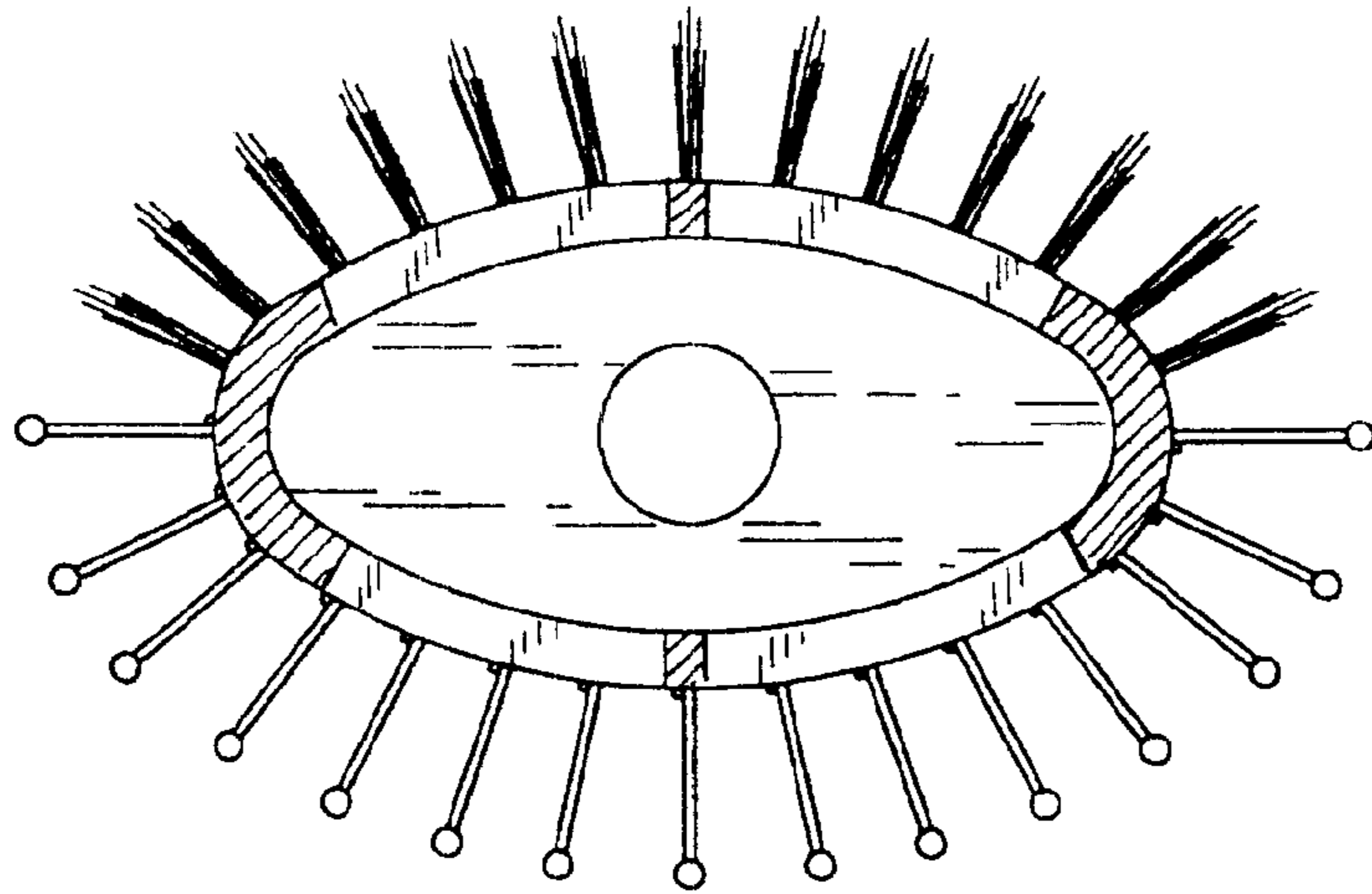

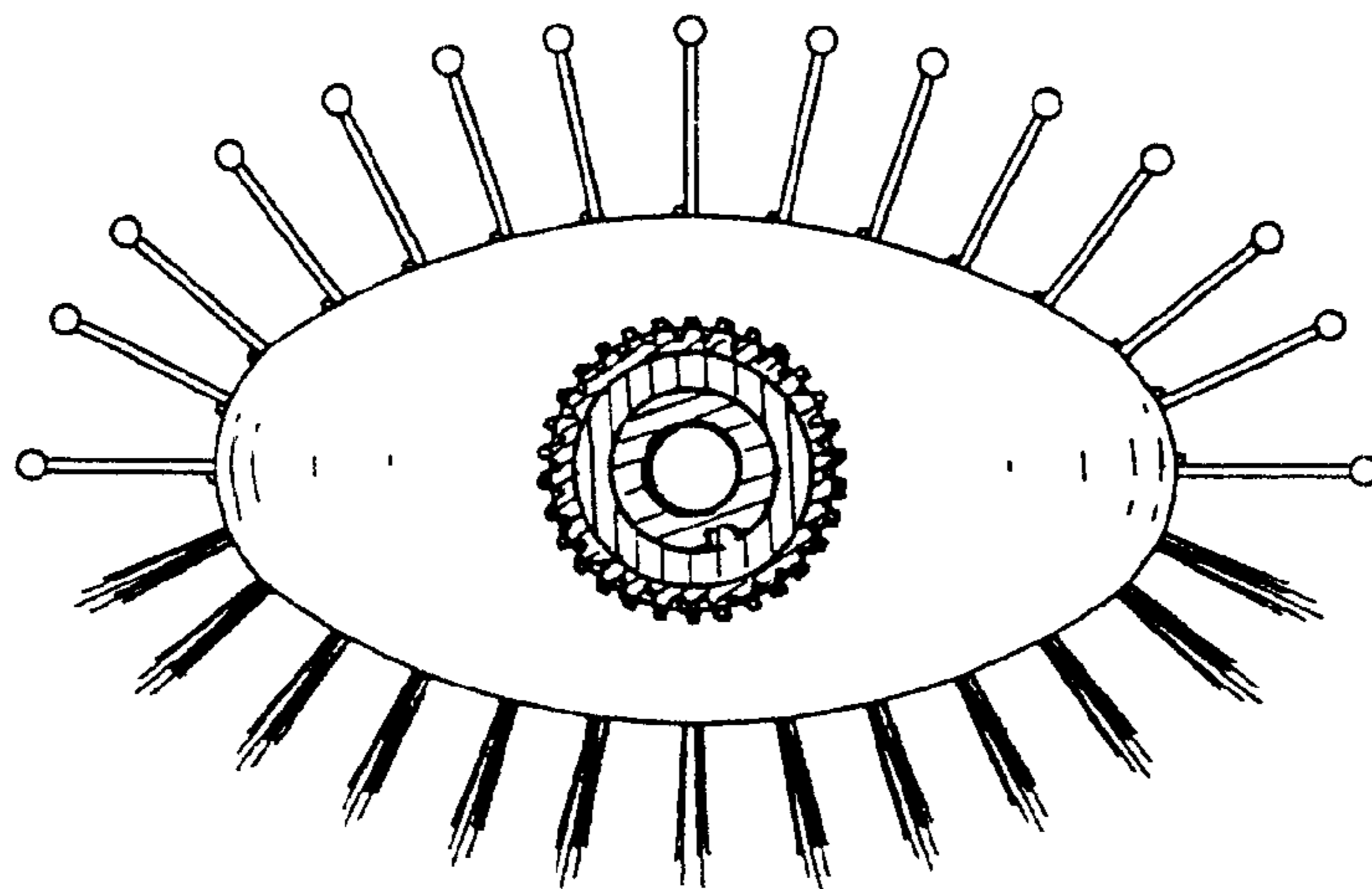
