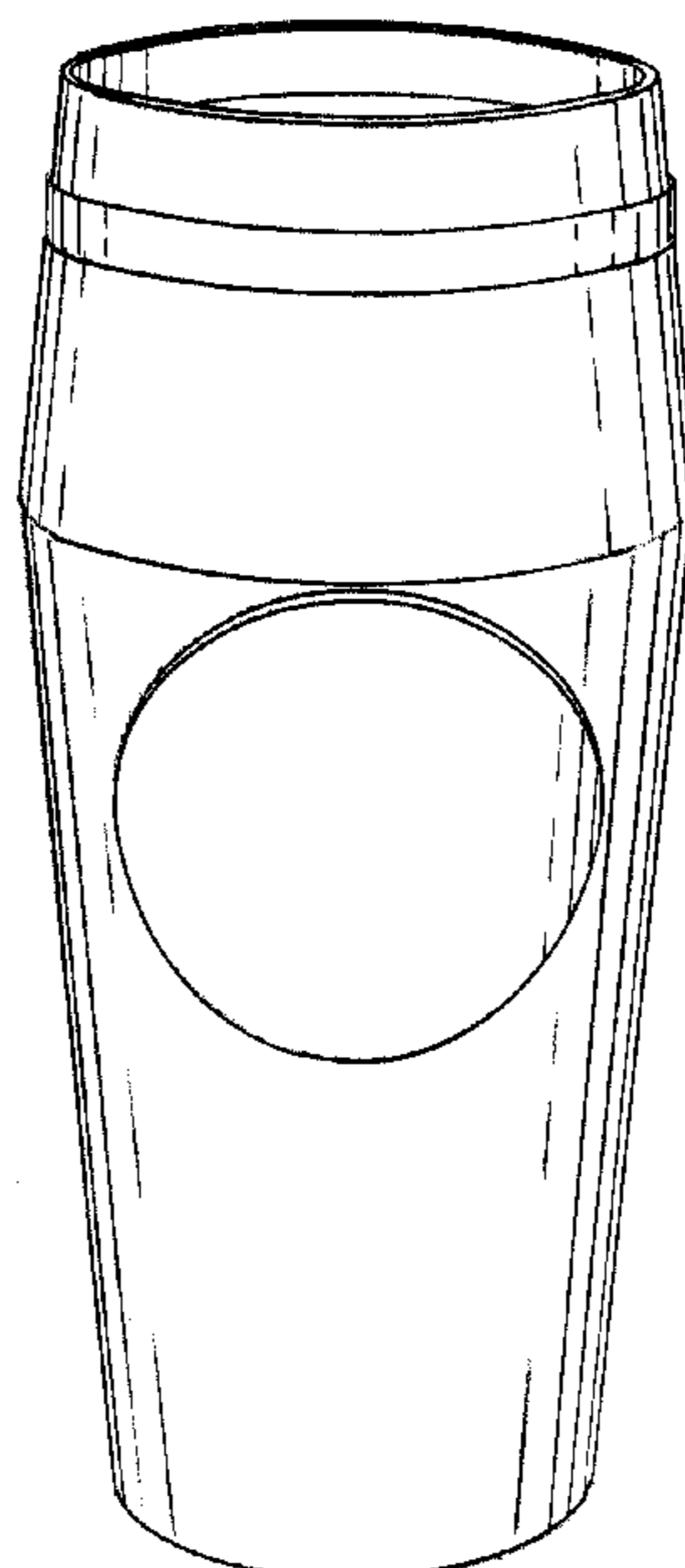
(57) **CLAIM**

The ornamental design for a medallion tumbler, as shown and described.

**DESCRIPTION**

FIG. 1 is a top front perspective view of a medallion tumbler showing my new design.  
 FIG. 2 is a side elevational view of the design, the other side elevational view being a mirror image thereof.  
 FIG. 3 is a rear elevational view of the design.  
 FIG. 4 is a top plan view of the design; and,  
 FIG. 5 is a bottom plan view of the design.

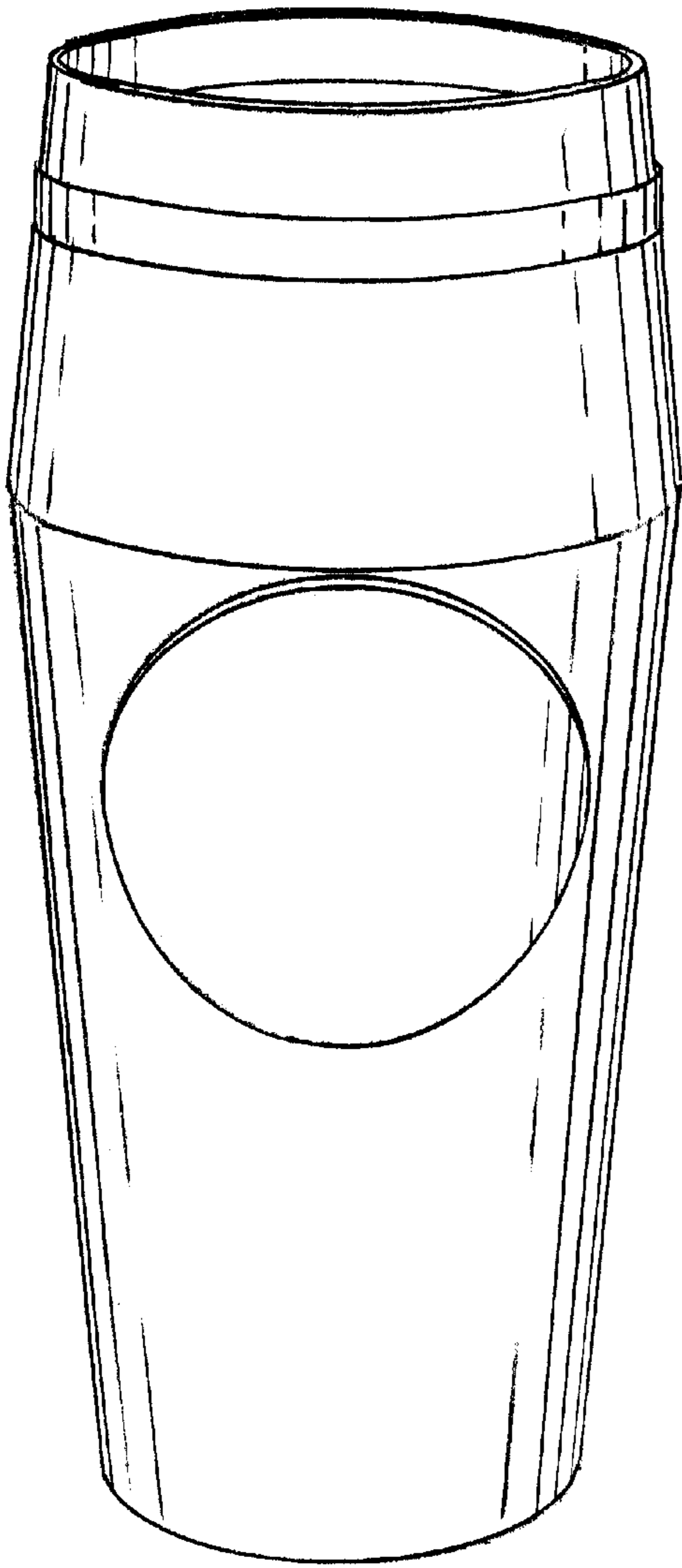

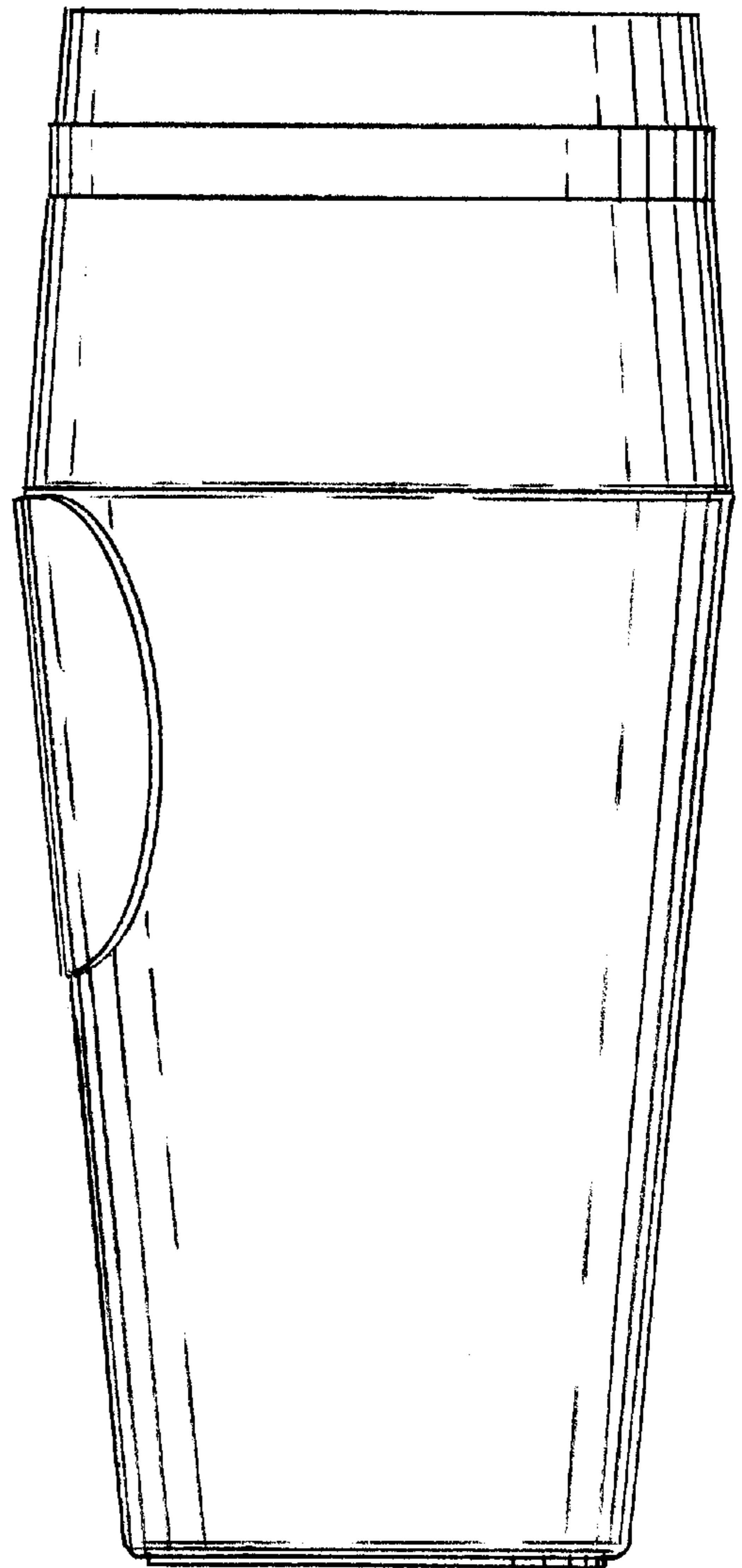

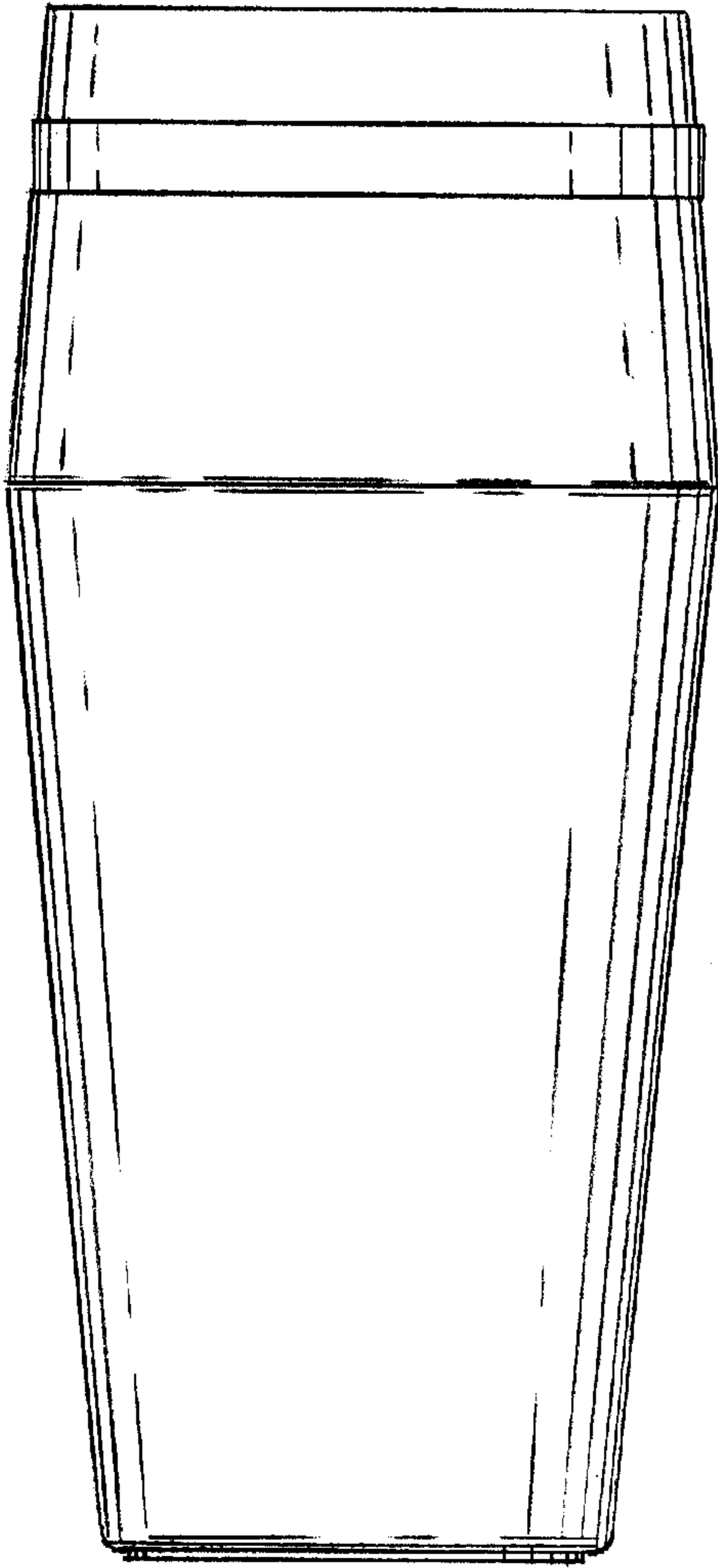

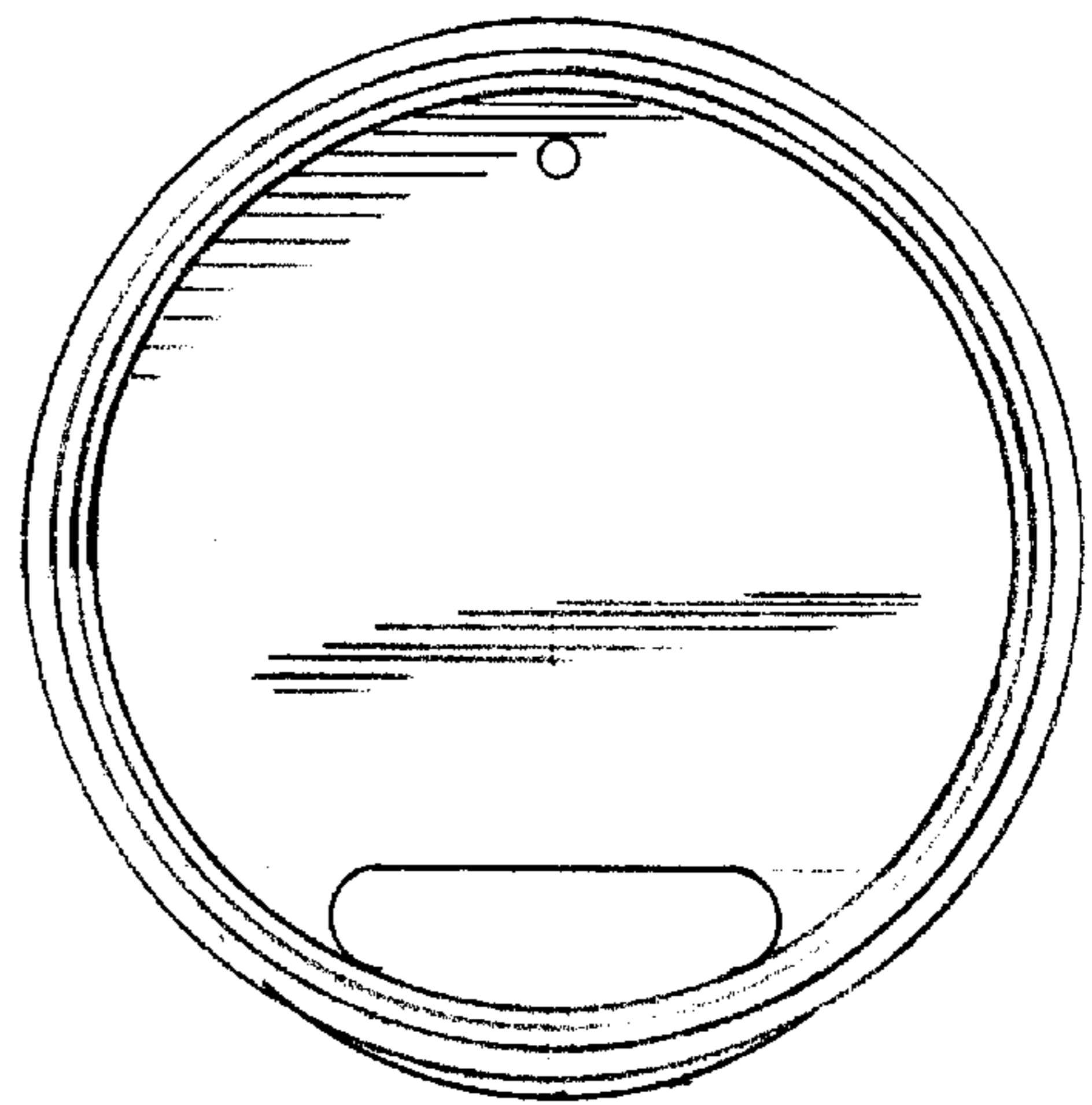

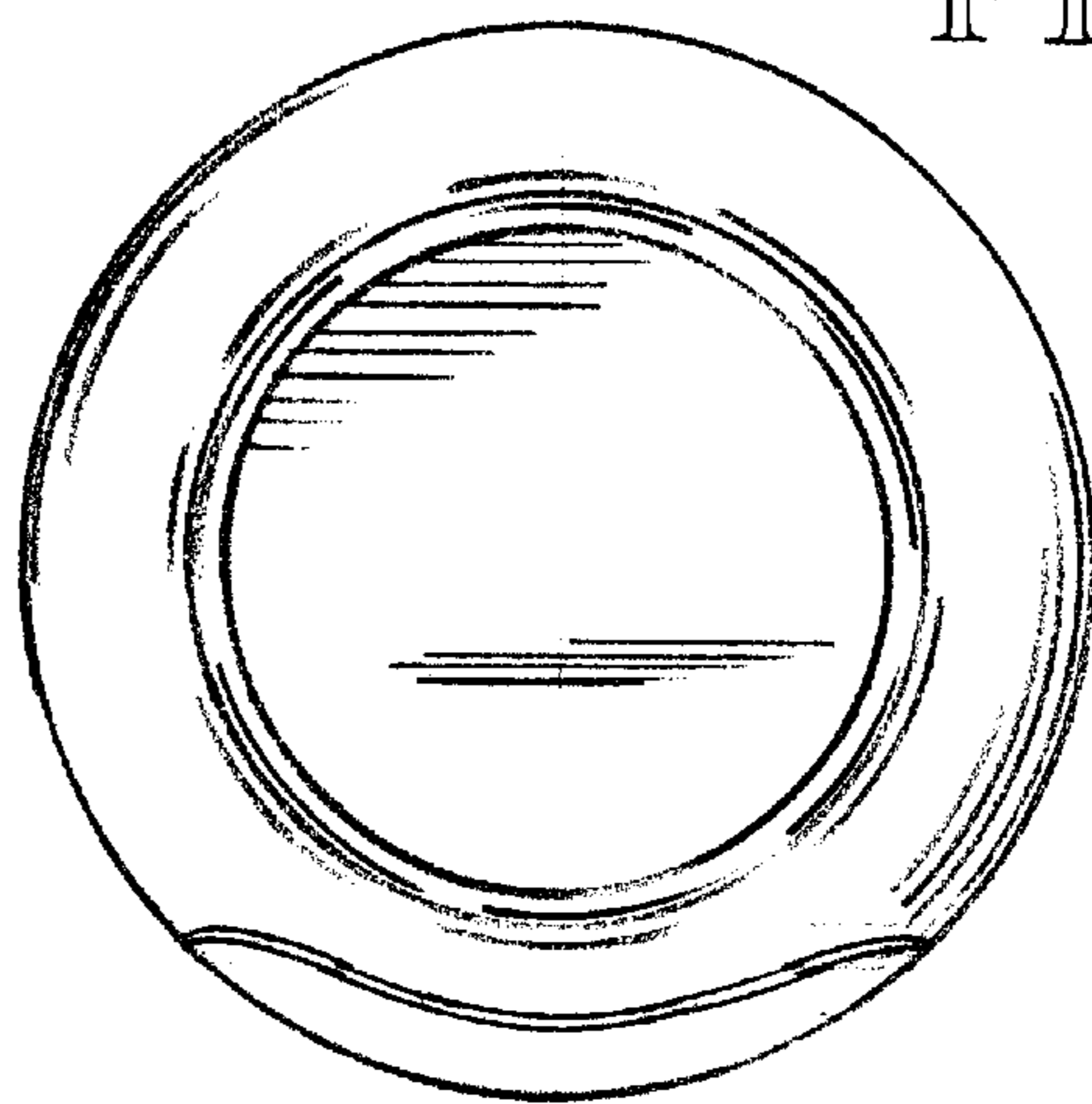
