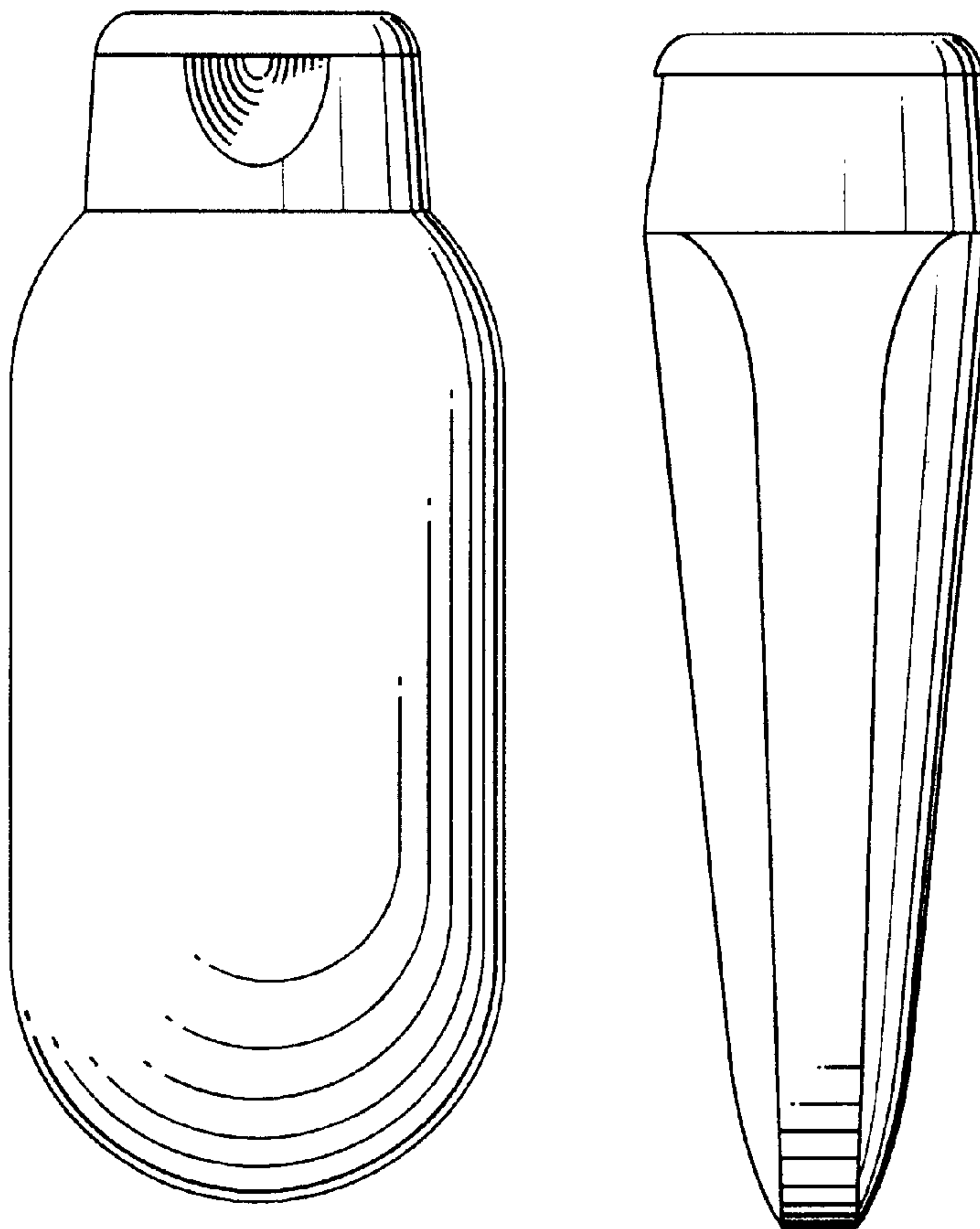

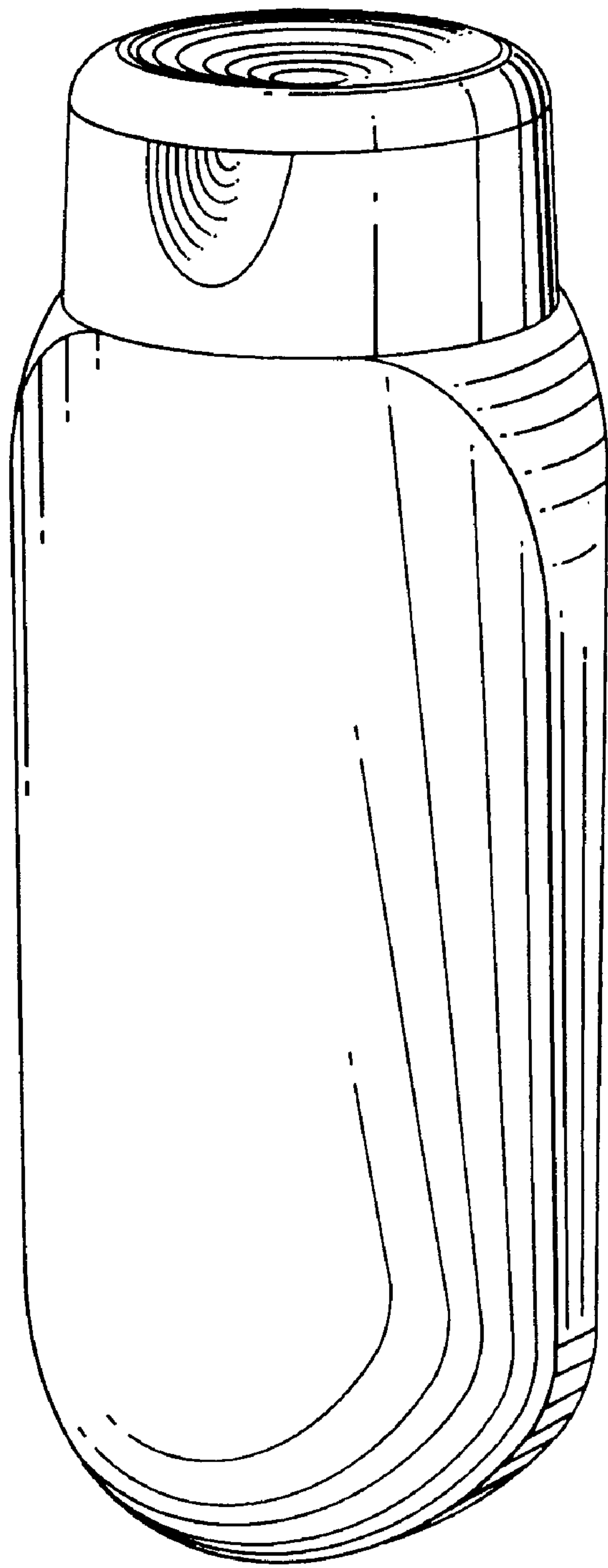
An ornamental design for a bottle and cap, as shown and described.

**DESCRIPTION**

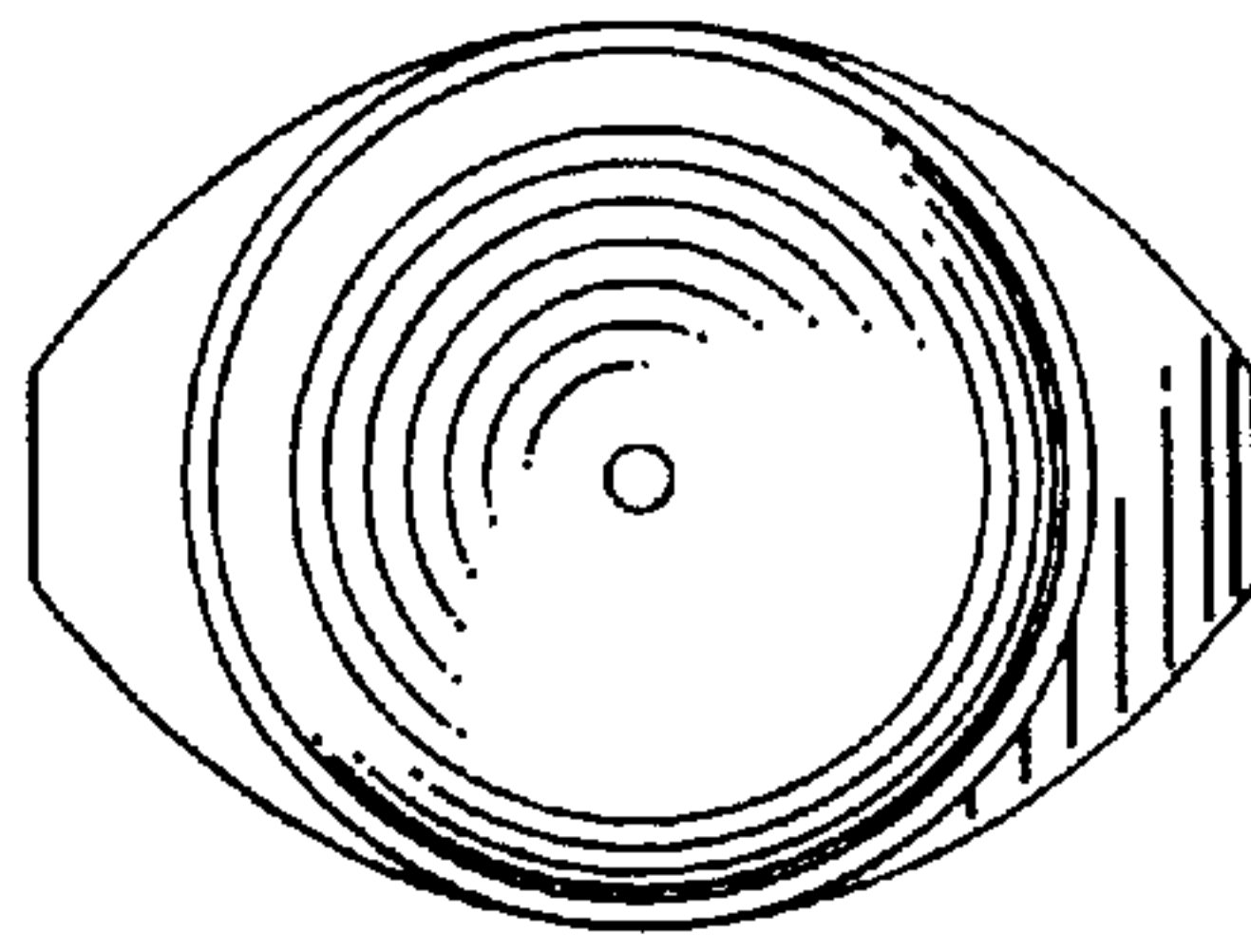
FIG. 1 is a perspective view of the bottle and cap of the instant design;

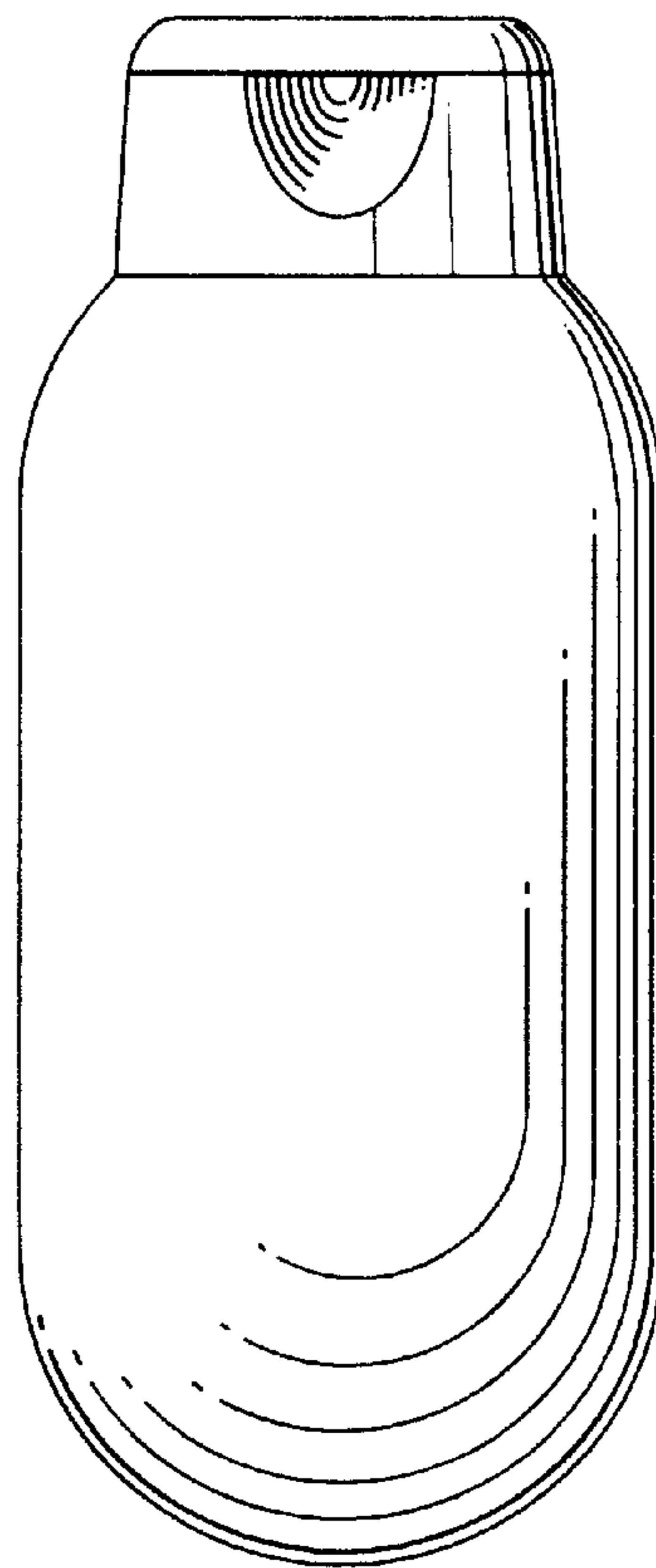




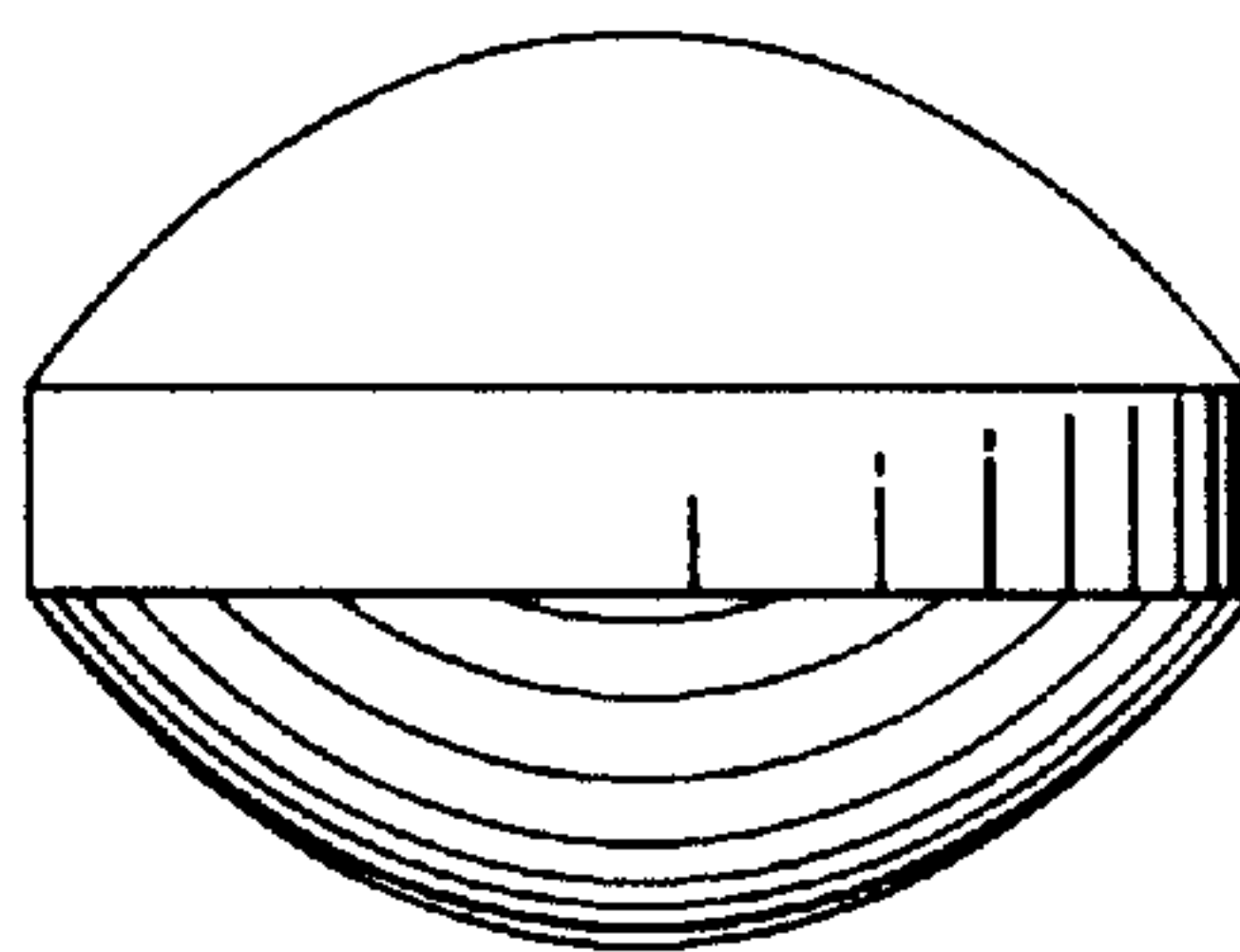

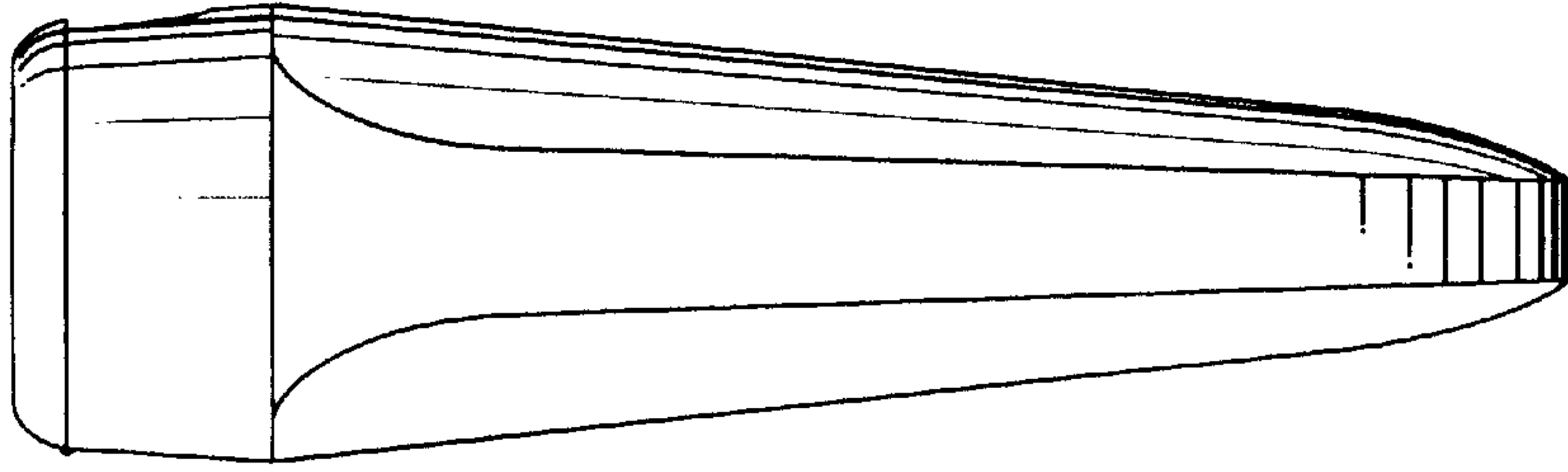

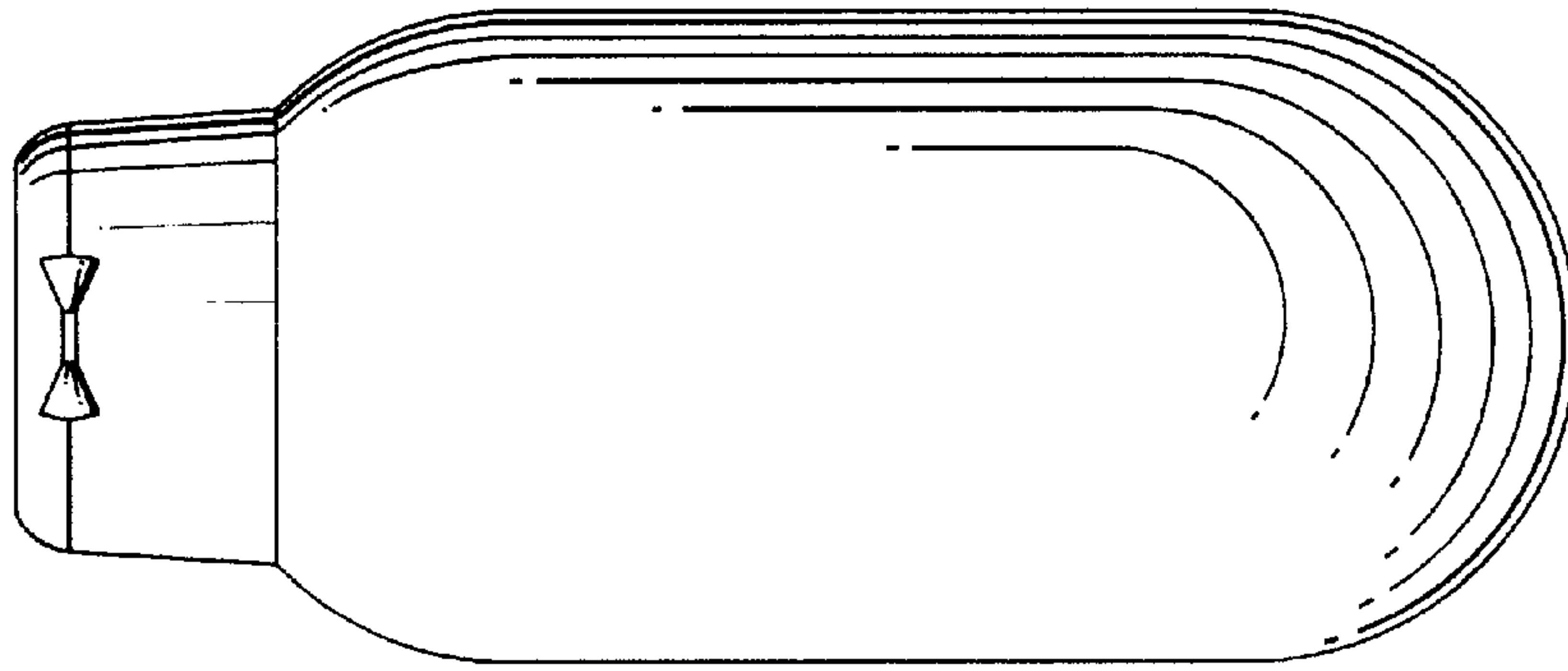

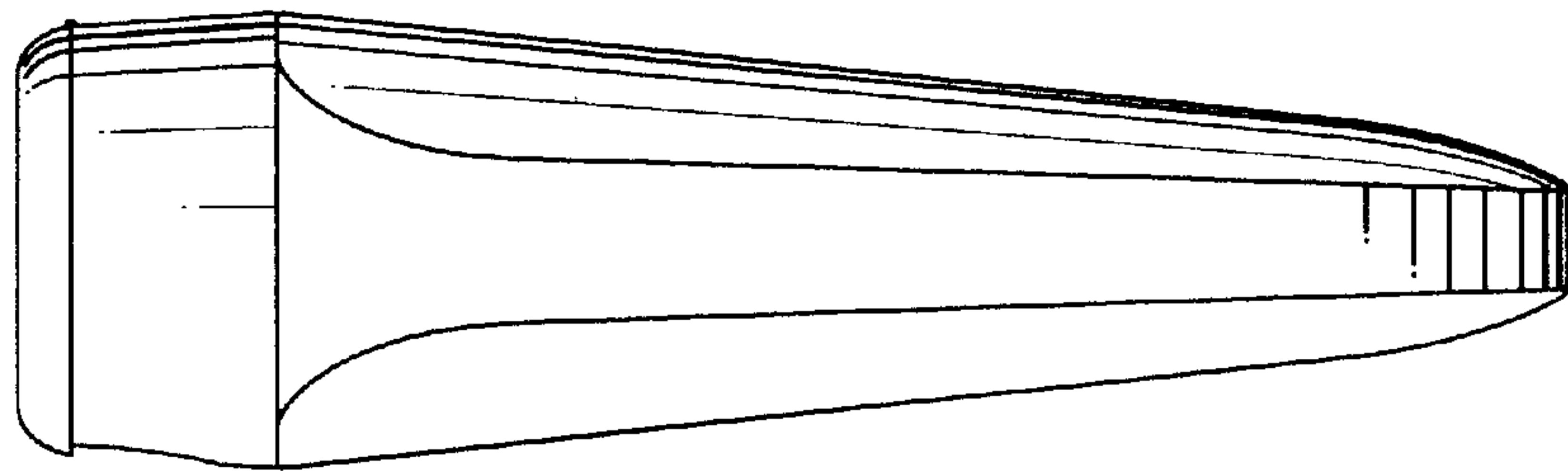
