(57) **CLAIM**

We claim the ornamental design for a toilet seat, as shown in the attached drawings.

DESCRIPTION

FIG. 1 is a perspective view of a toilet seat showing our new design;

FIG. 2 is a front view of the embodiment shown in FIG. 1;

FIG. 4 is a top side view of the embodiment shown in FIGS. 1-3;

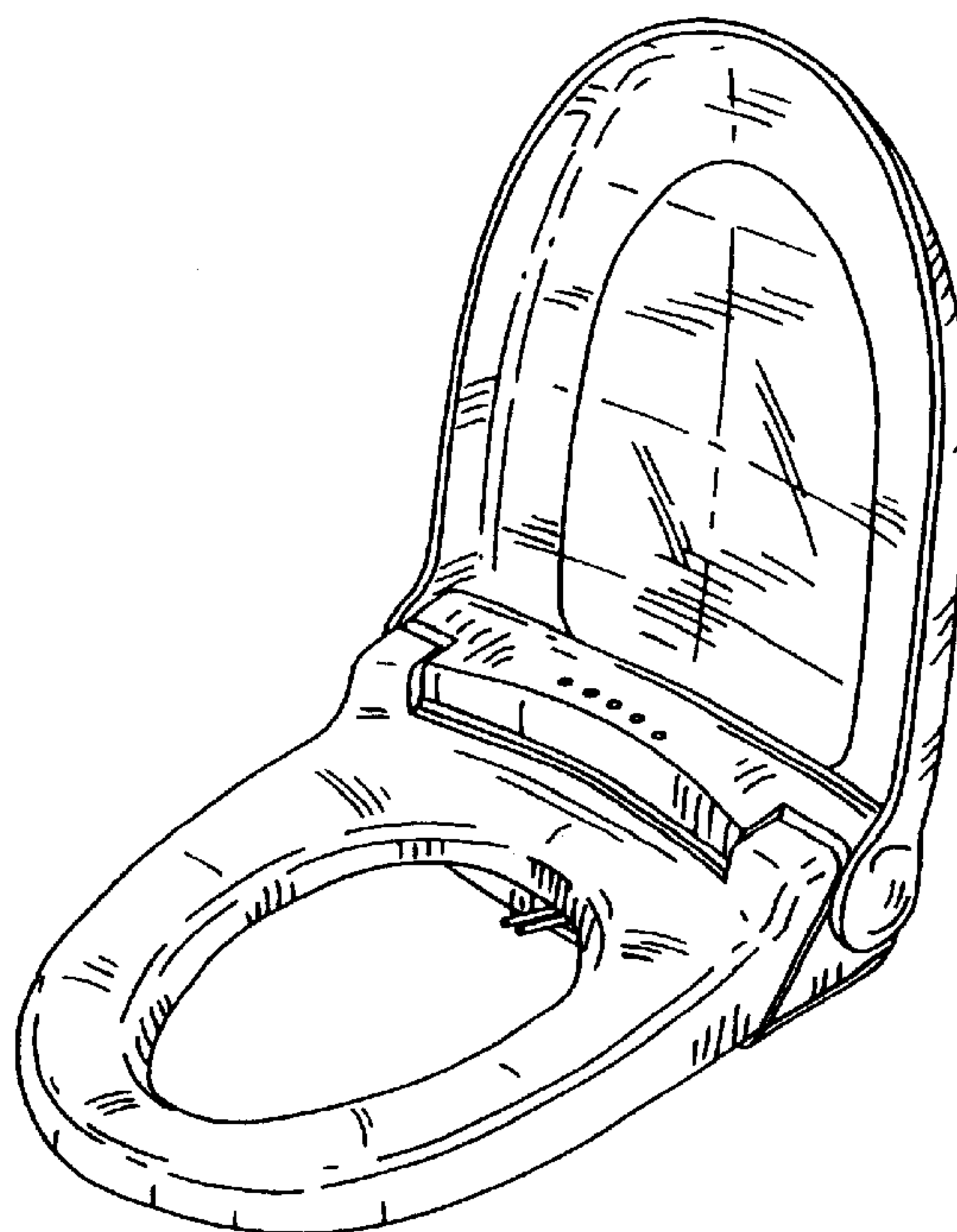
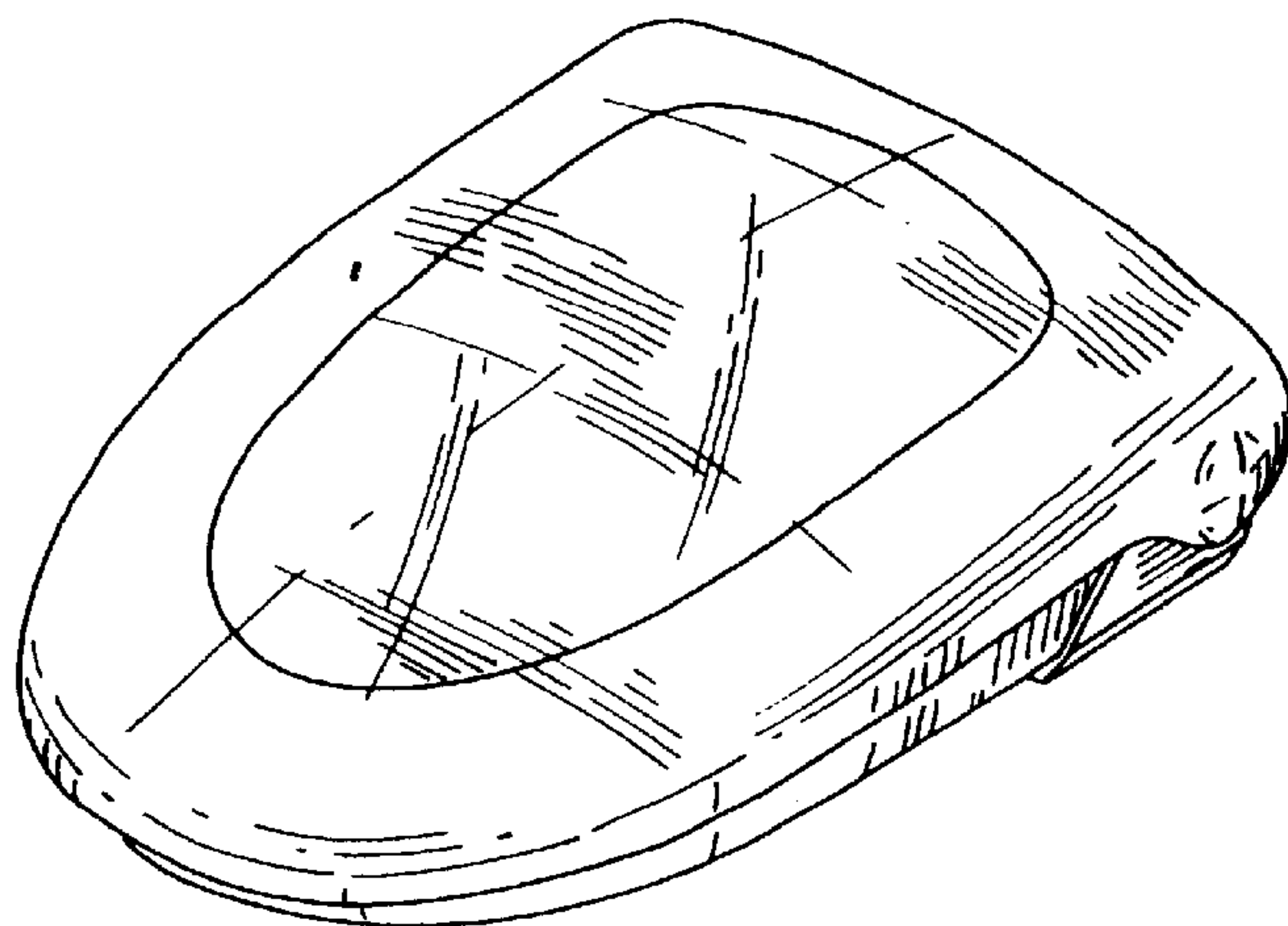
FIG. 5 is a left side view of the embodiment shown in FIGS. 1-4;

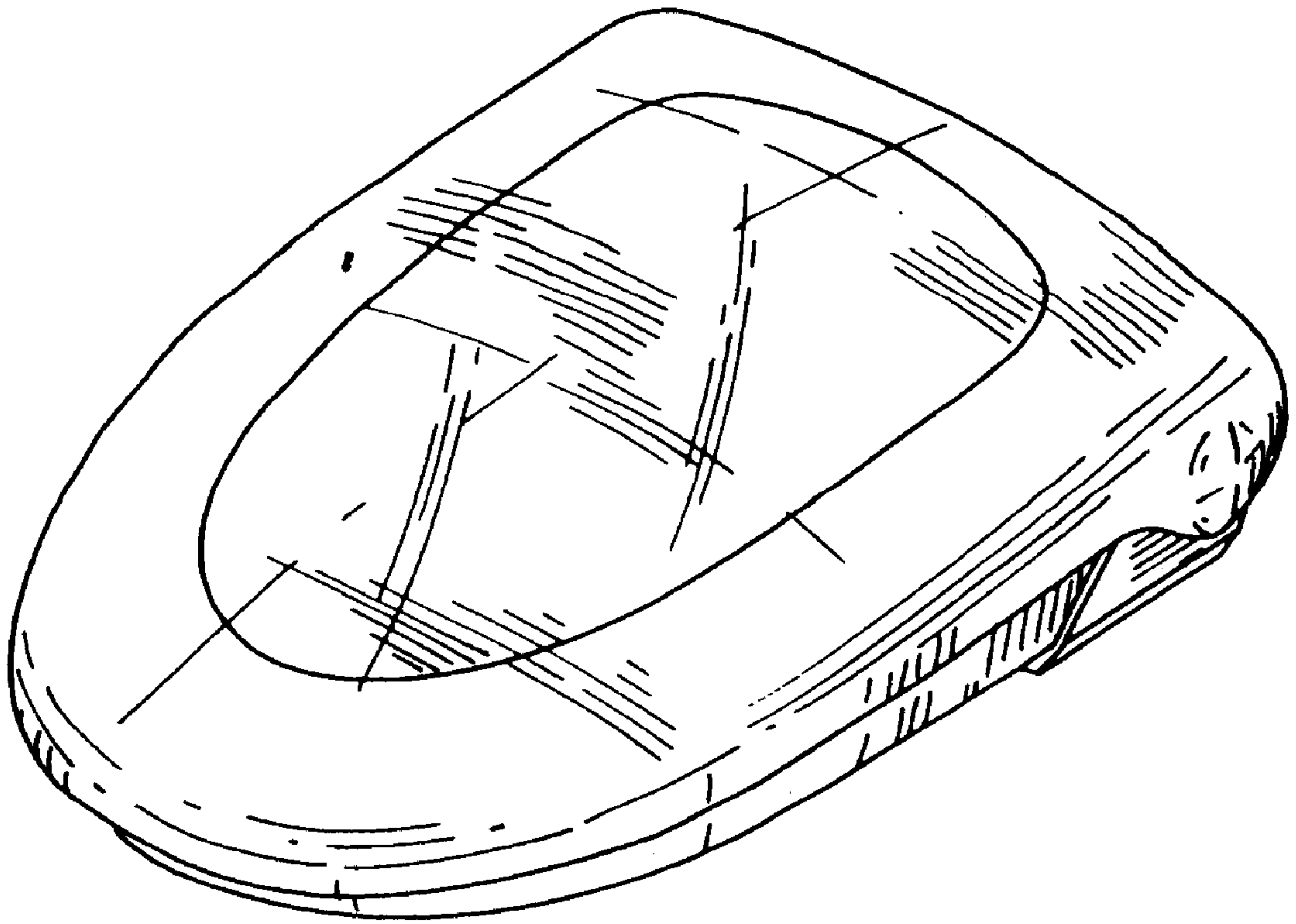

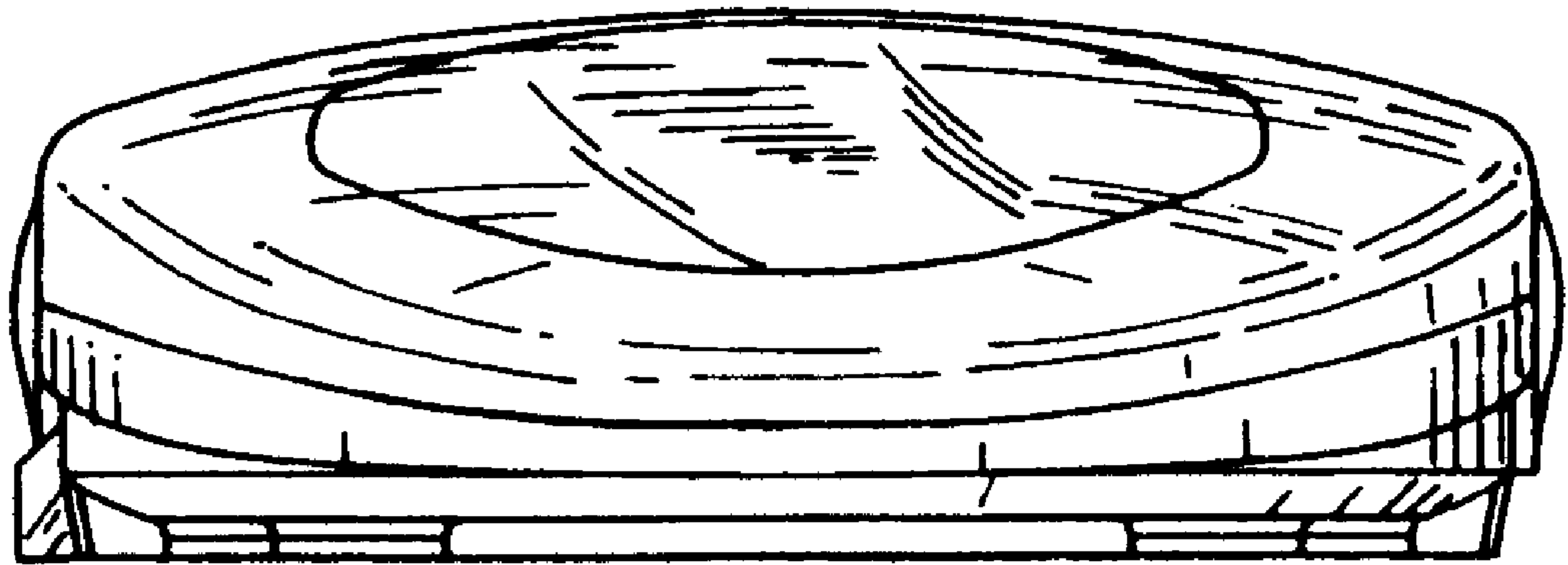

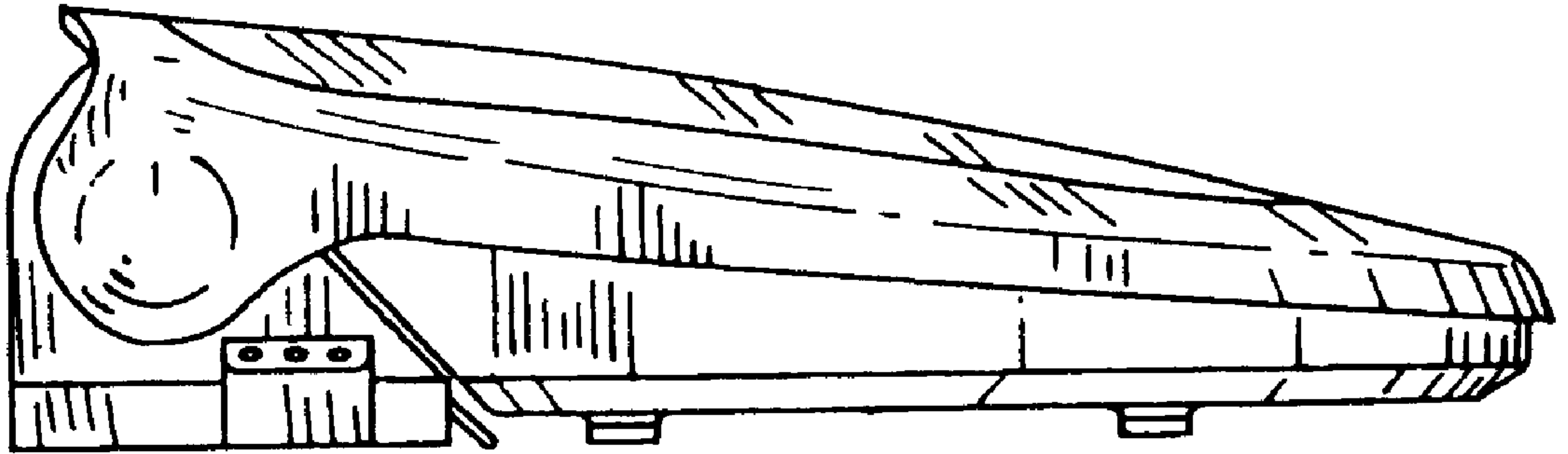

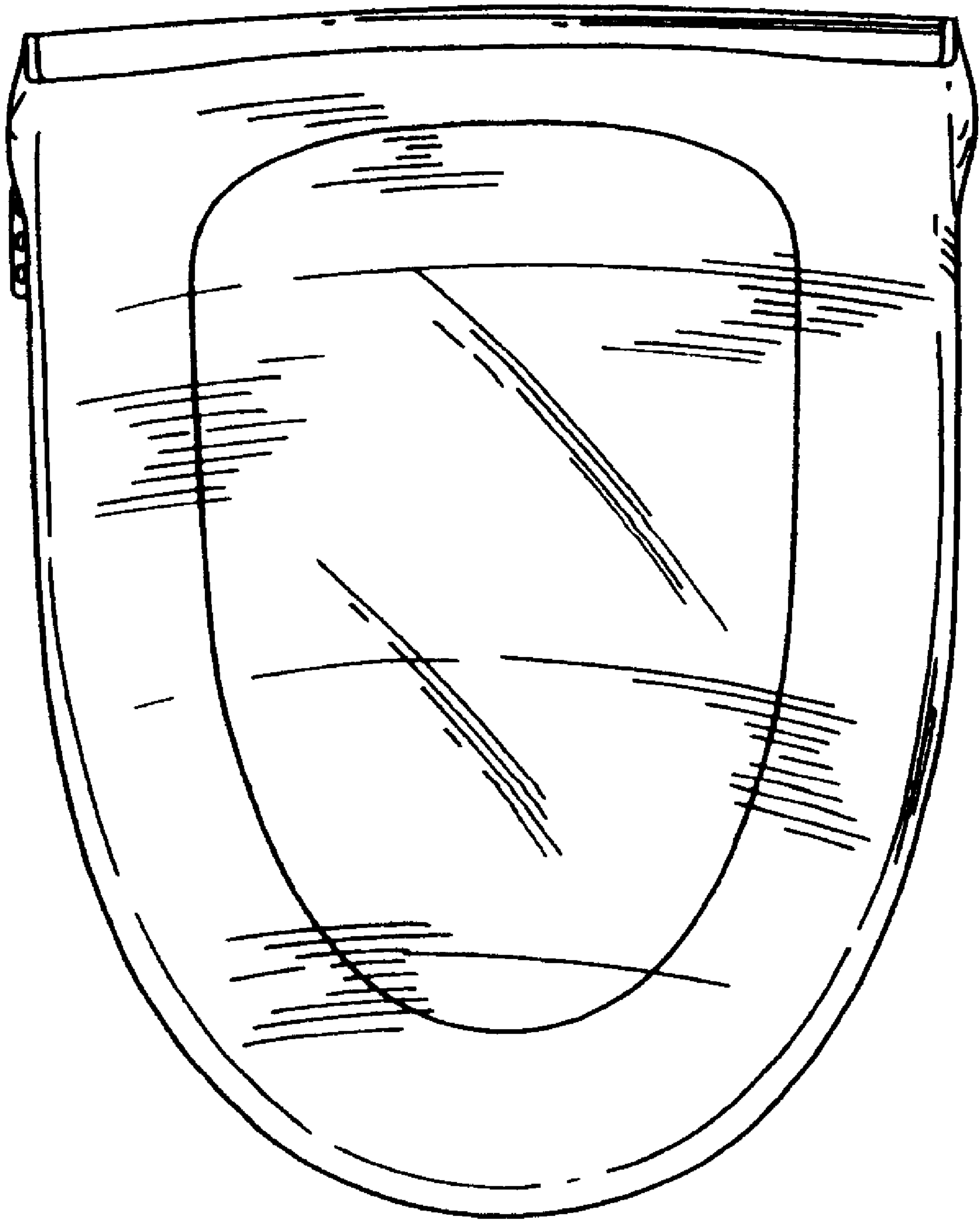

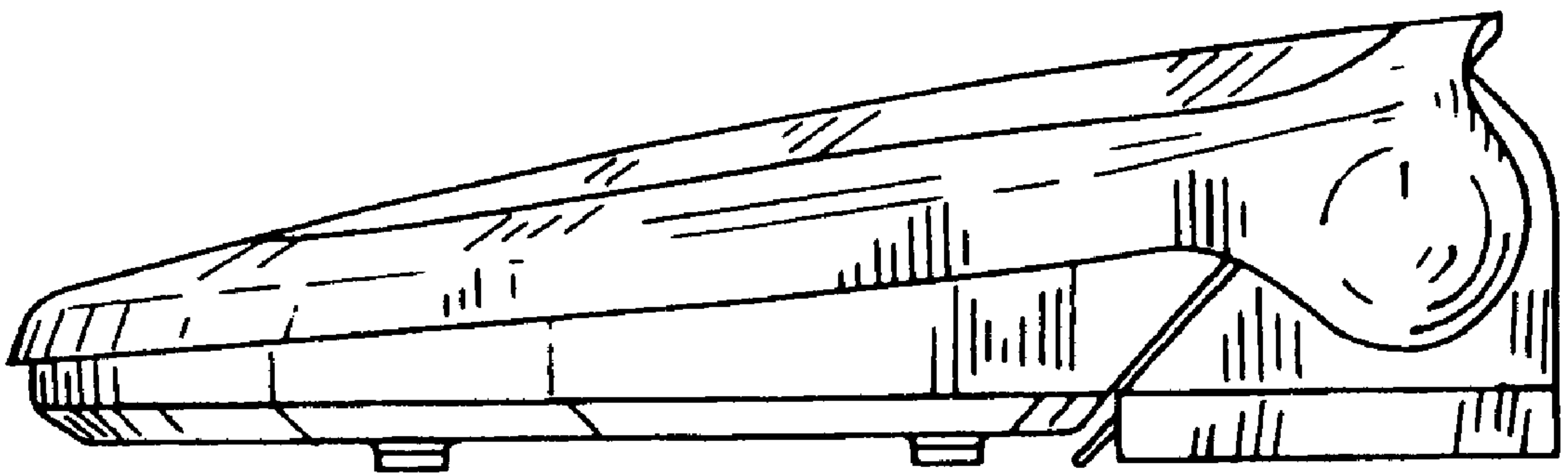

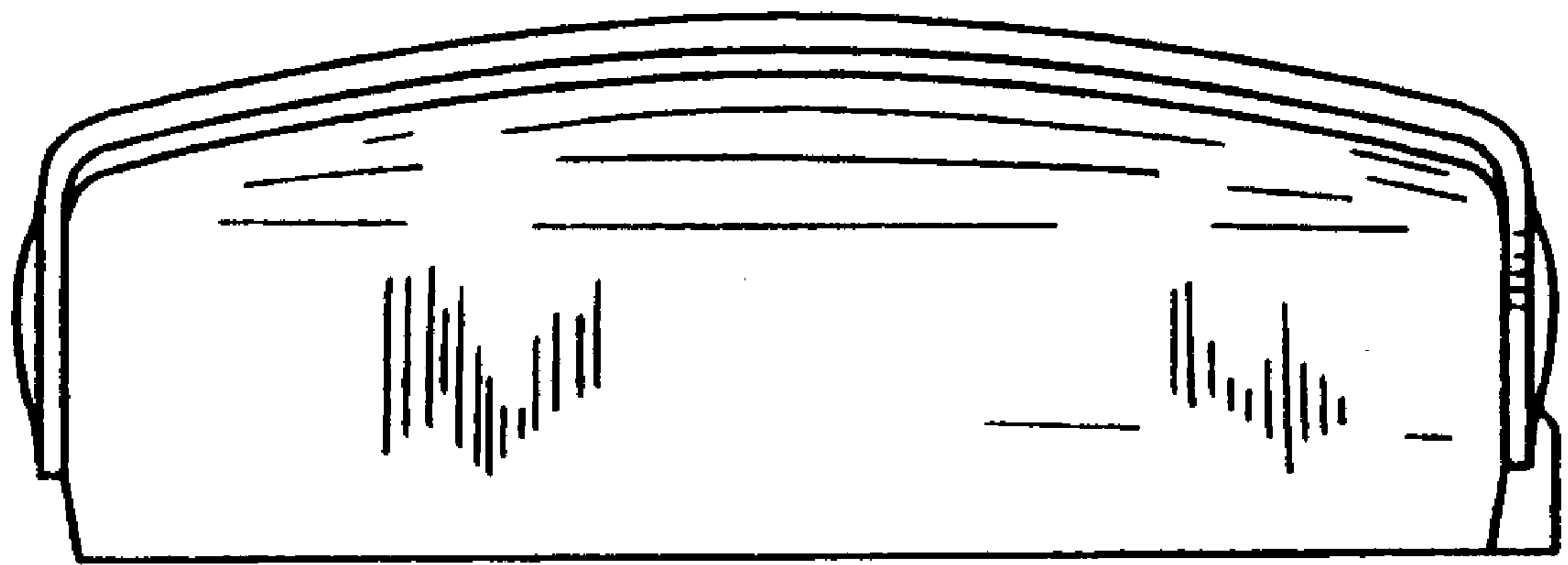

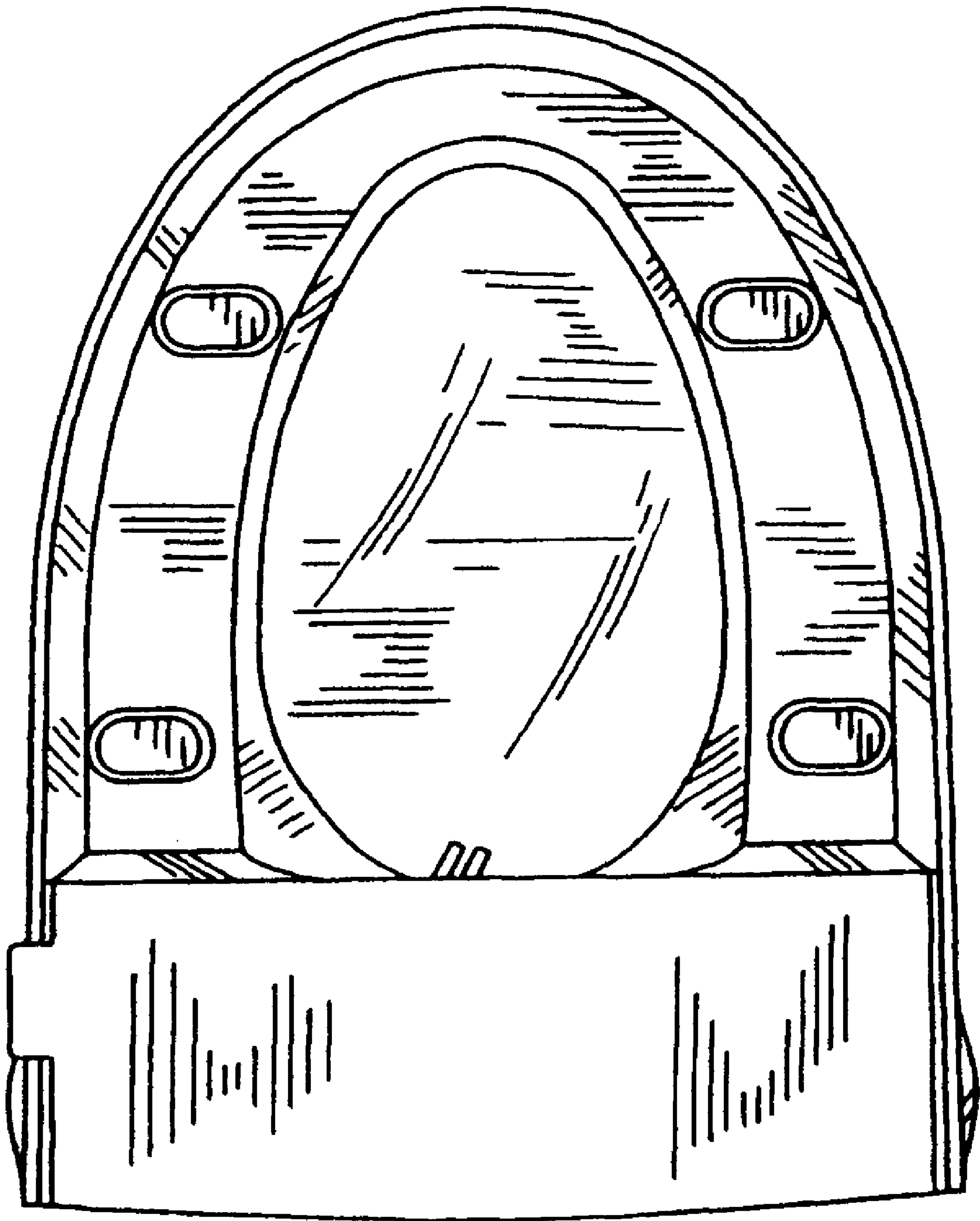

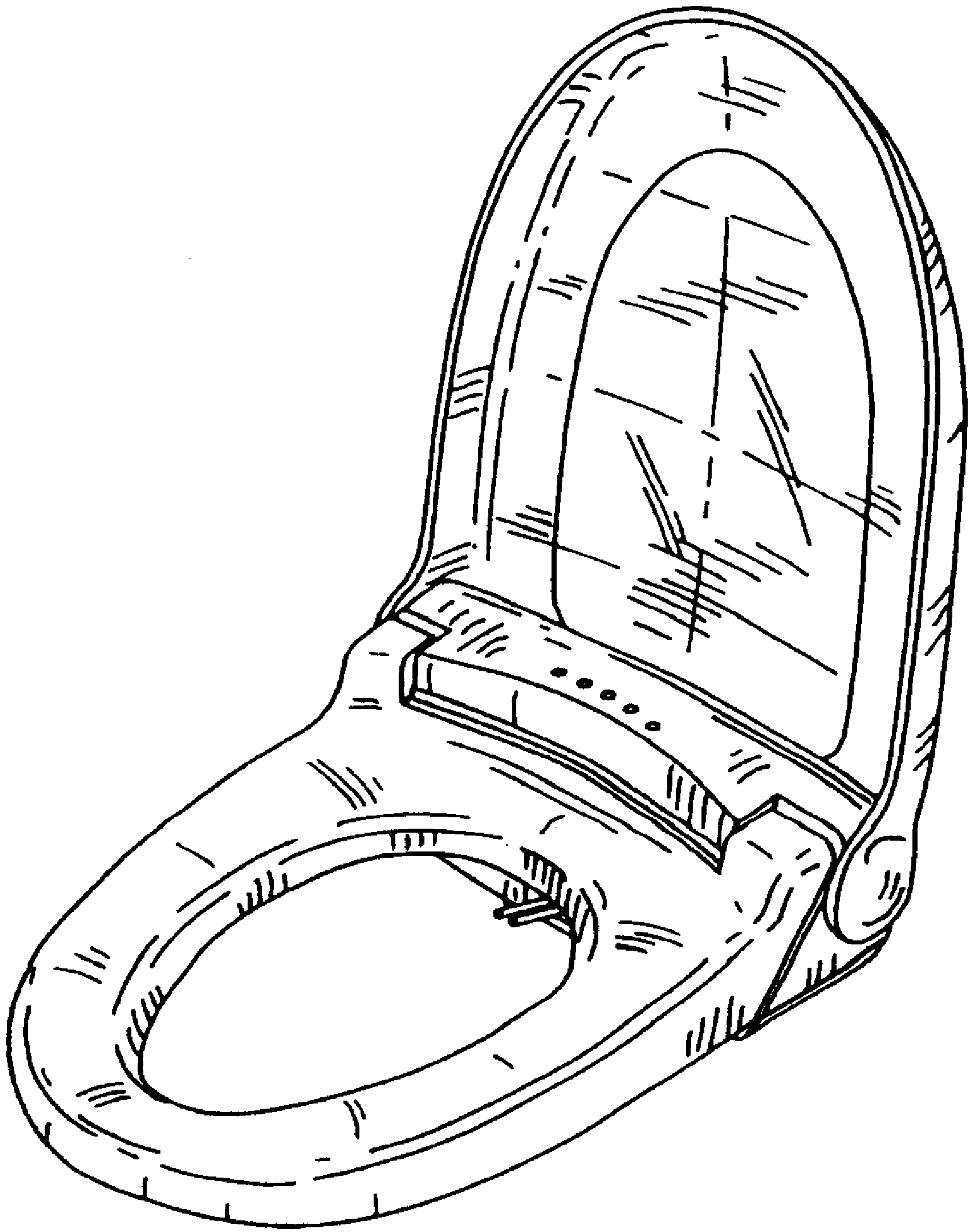
