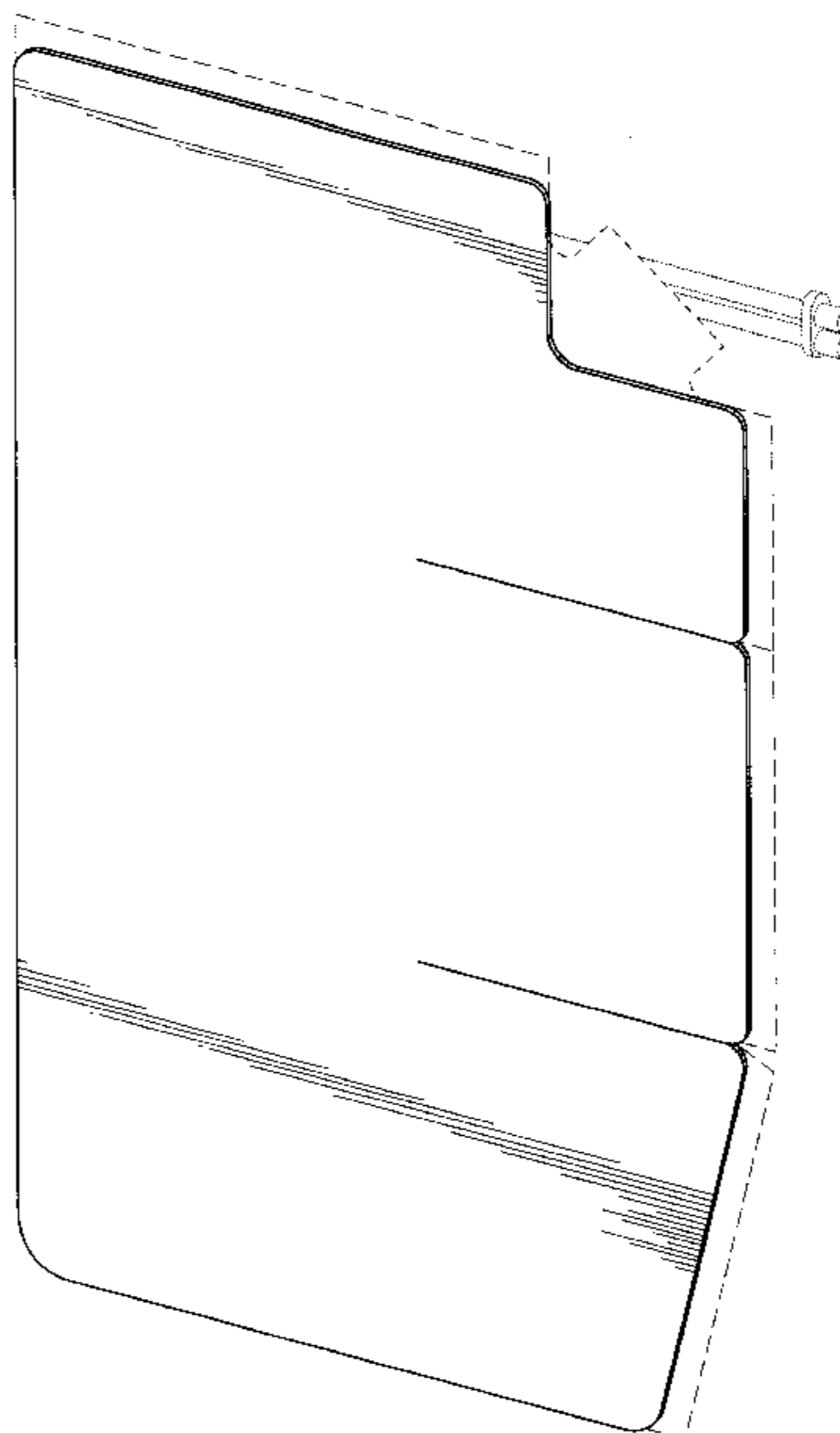
(57) **CLAIM**

The ornamental design for a medical back pad, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a medical back pad, showing our new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a side elevational view thereof;  
FIG. 5 is a side elevational view thereof, opposite that shown in FIG. 4;  
FIG. 6 is a top plan view thereof; and,  
FIG. 7 is a bottom plan view thereof.  
The broken line showing is for illustrative purposes only and forms no part of the claimed design.

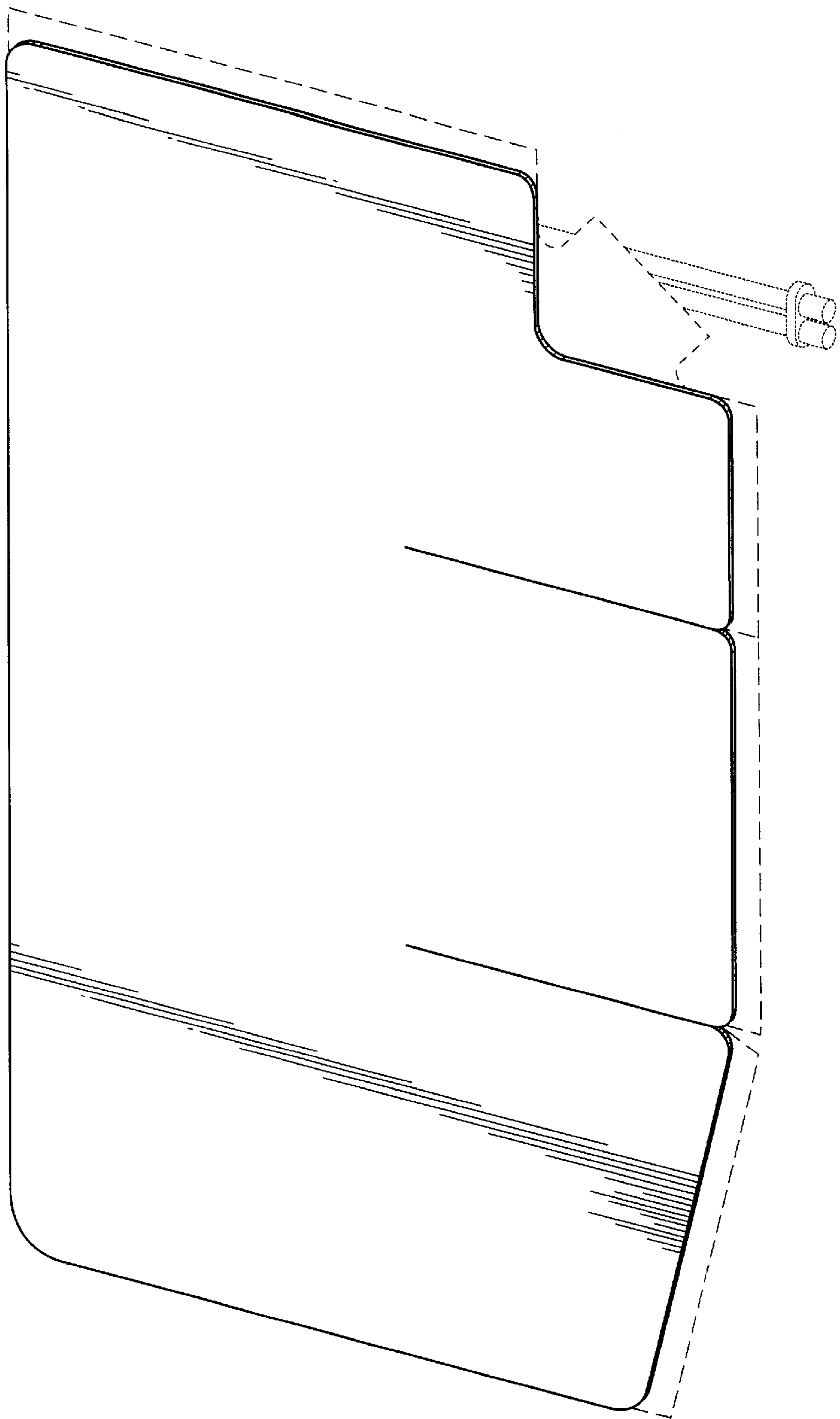

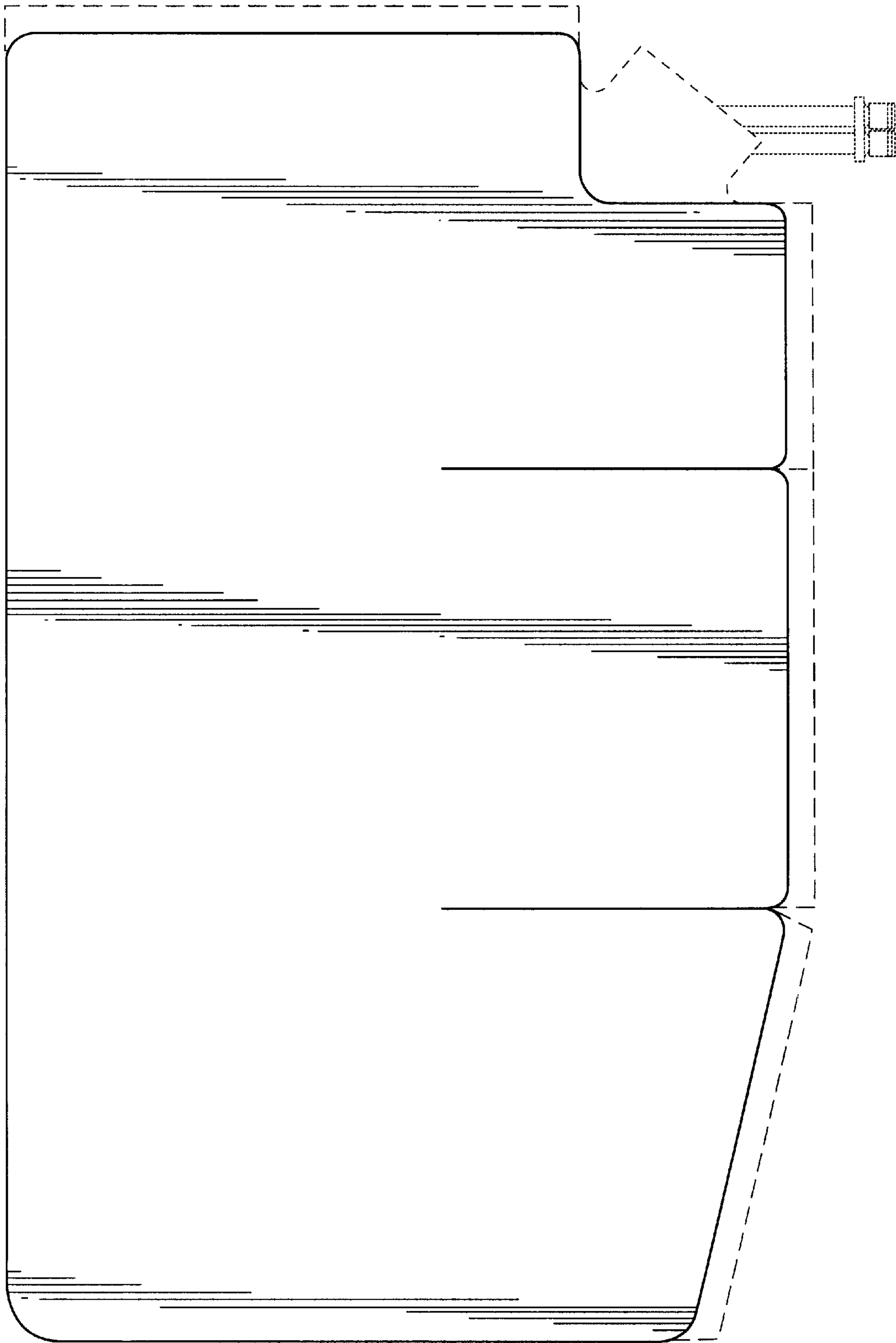

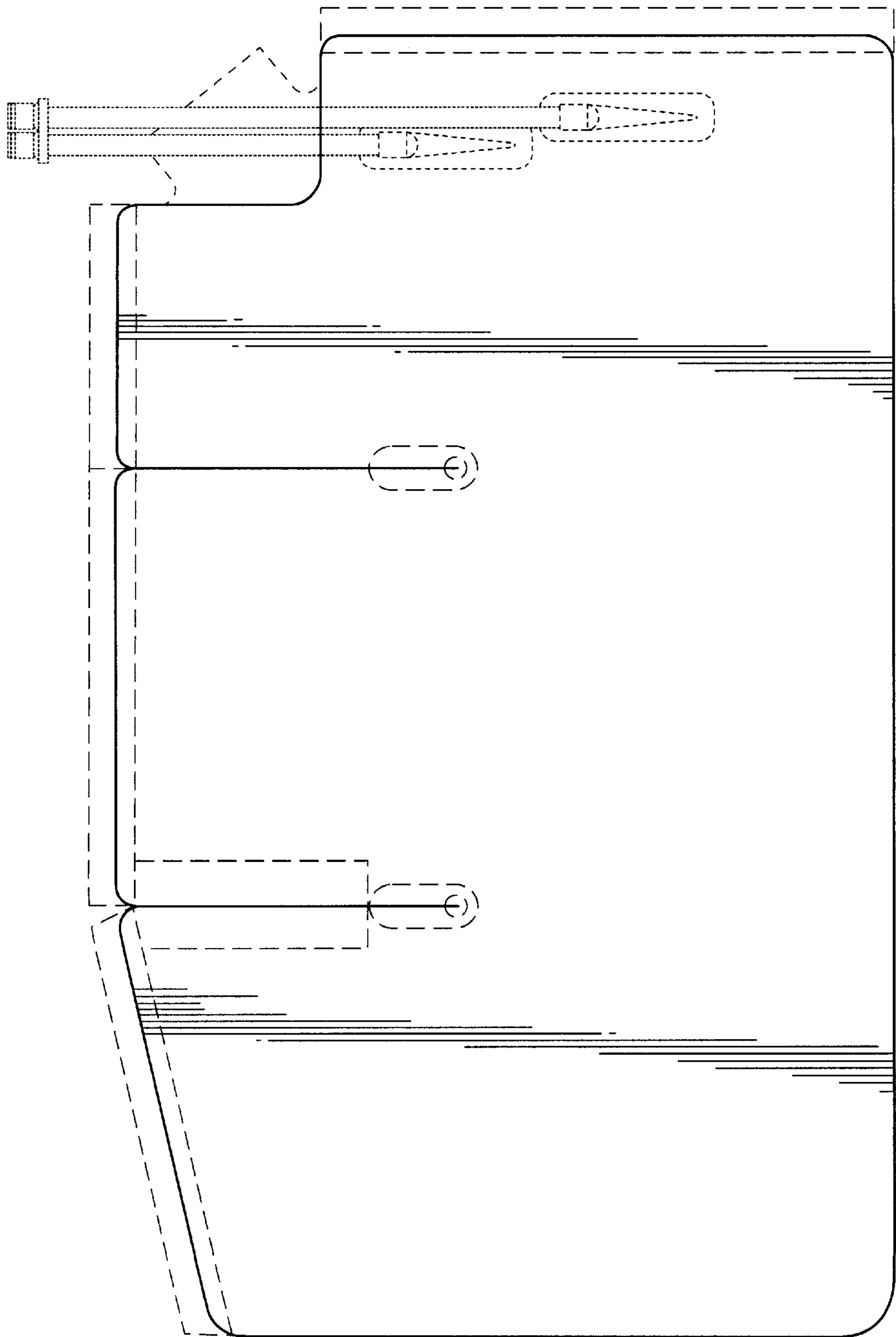

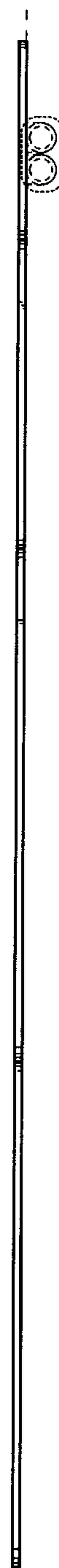

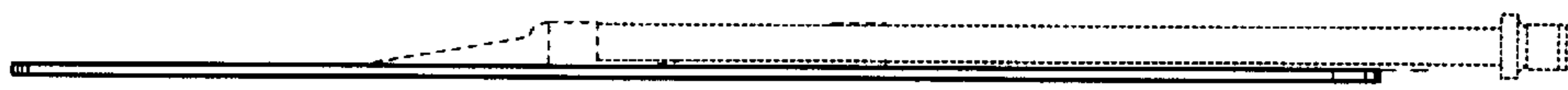

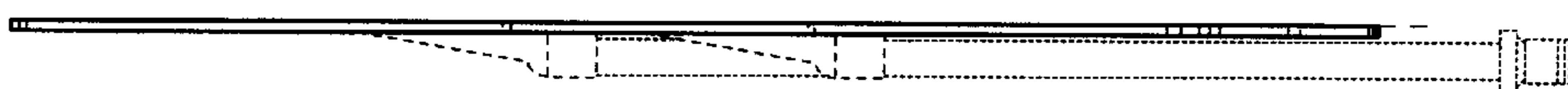
