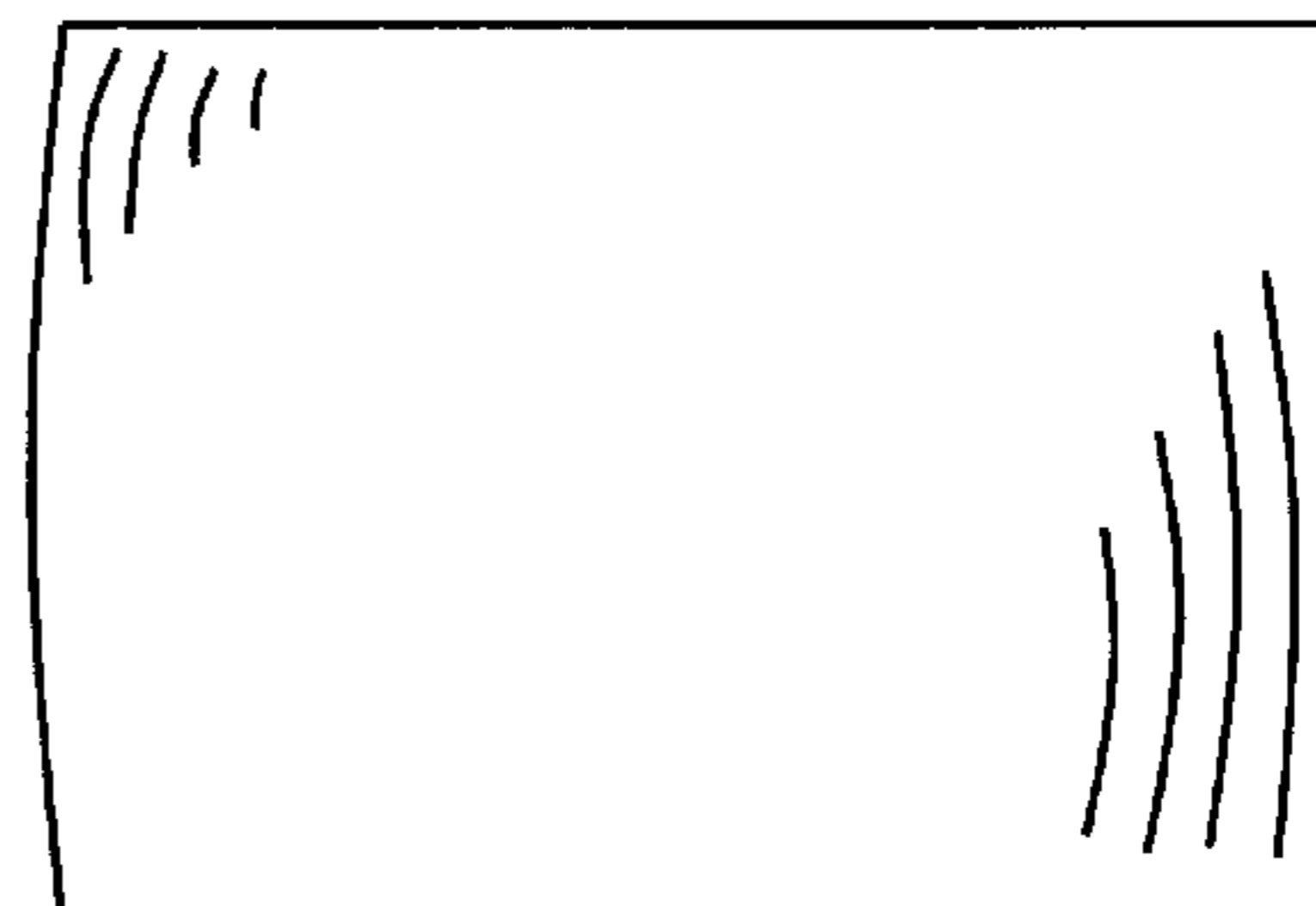
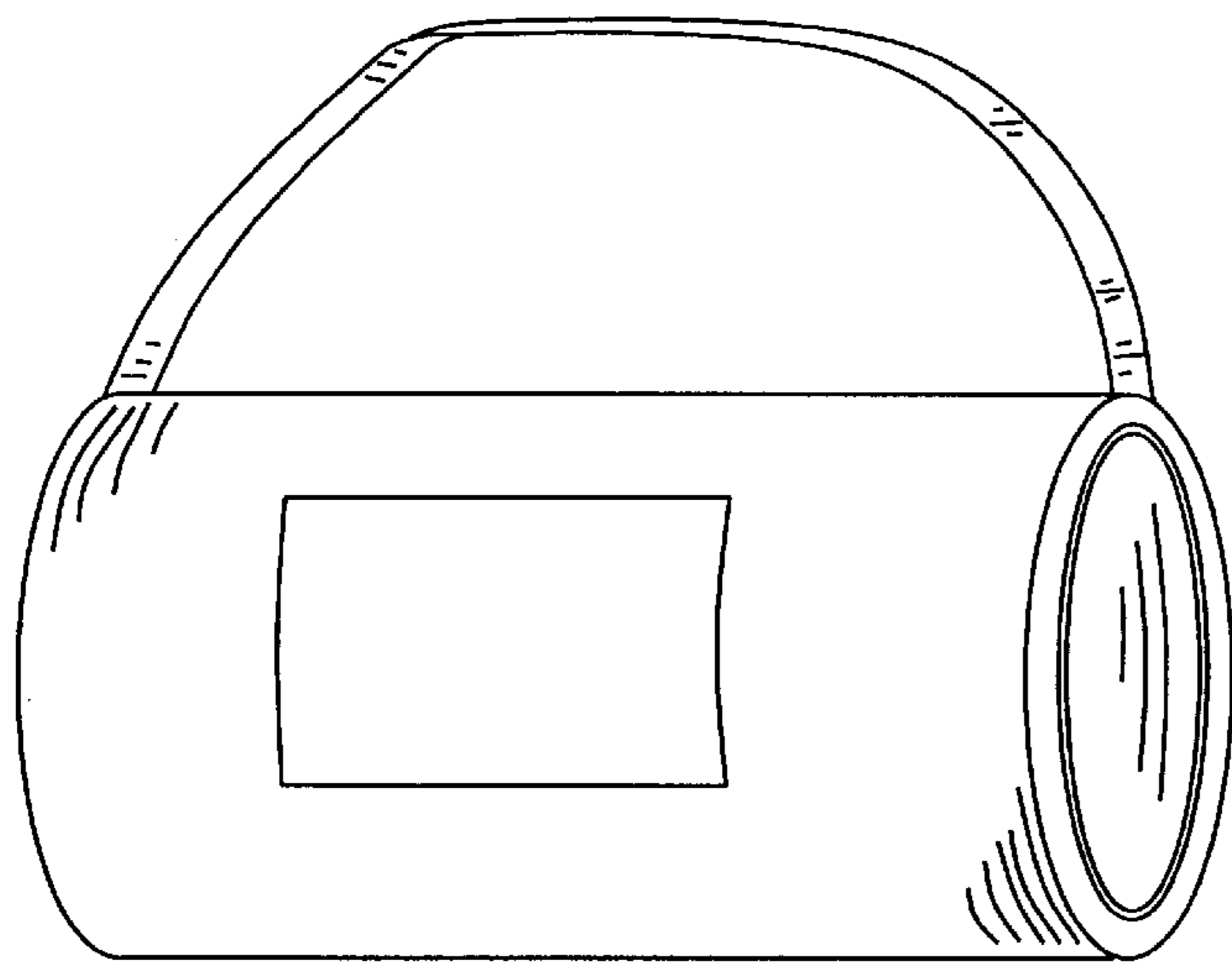
(57) **CLAIM**

The ornamental design for the combination beach pillow and tote bag, as shown and described.

**DESCRIPTION**

FIG. 1 is an exploded perspective view of the combination beach pillow and tote bag with the inner support removed; FIG. 2 is an exploded perspective view of the combination beach pillow and tote bag with the inner support removed showing the interior of the support; FIG. 3 is a front view of the combination beach pillow and tote bag of FIG. 1; FIG. 4 is a rear view of the combination beach pillow and tote bag FIG. 1; FIG. 5 is a bottom view of the combination beach pillow and tote bag FIG. 1; FIG. 6 is a perspective view of the combination beach pillow and tote bag of FIG. 1 reversed for use; FIG. 7 is a top view of the combined beach pillow and tote bag of FIG. 1 on an enlarged scale; and, FIG. 8 is a side view of the combination beach pillow and tote bag of FIG. 1 also on an enlarged scale.

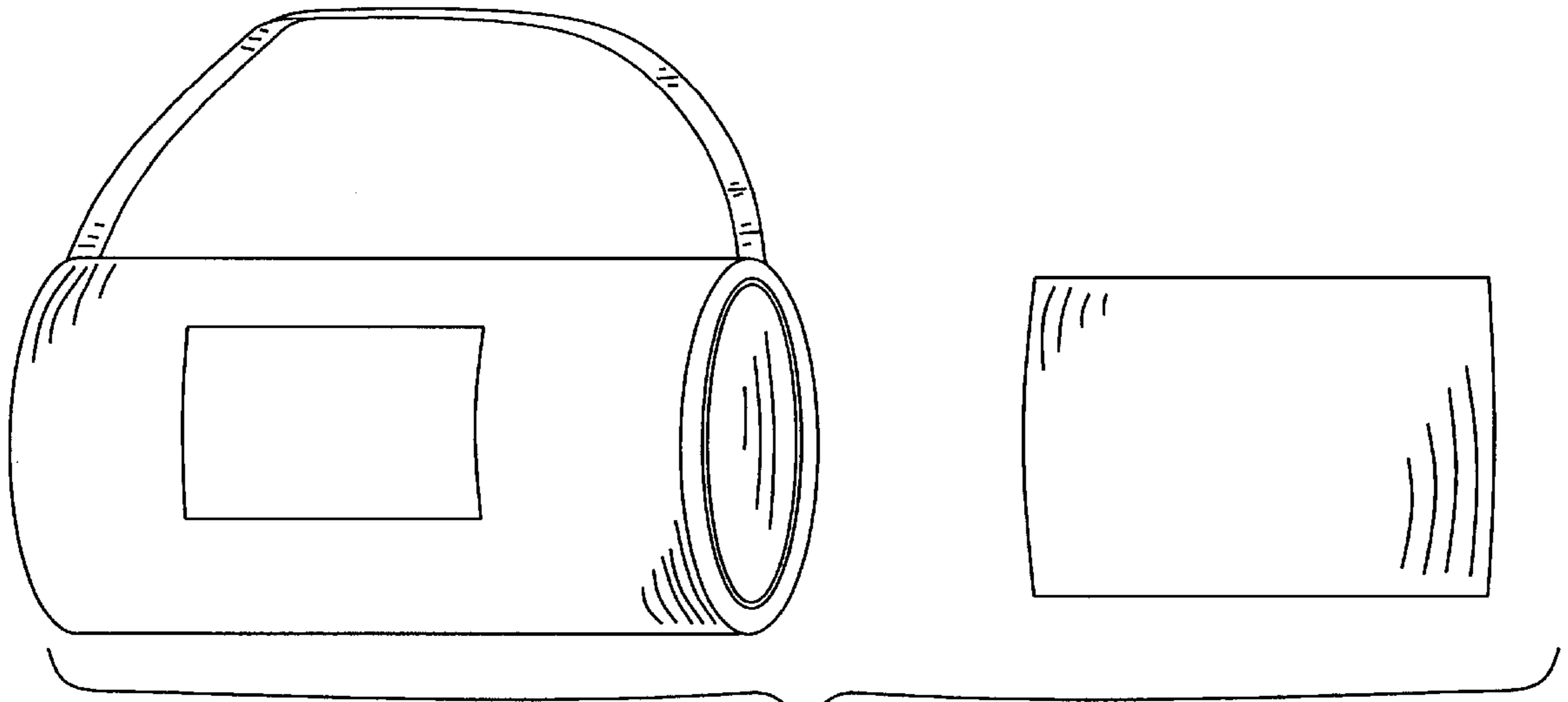

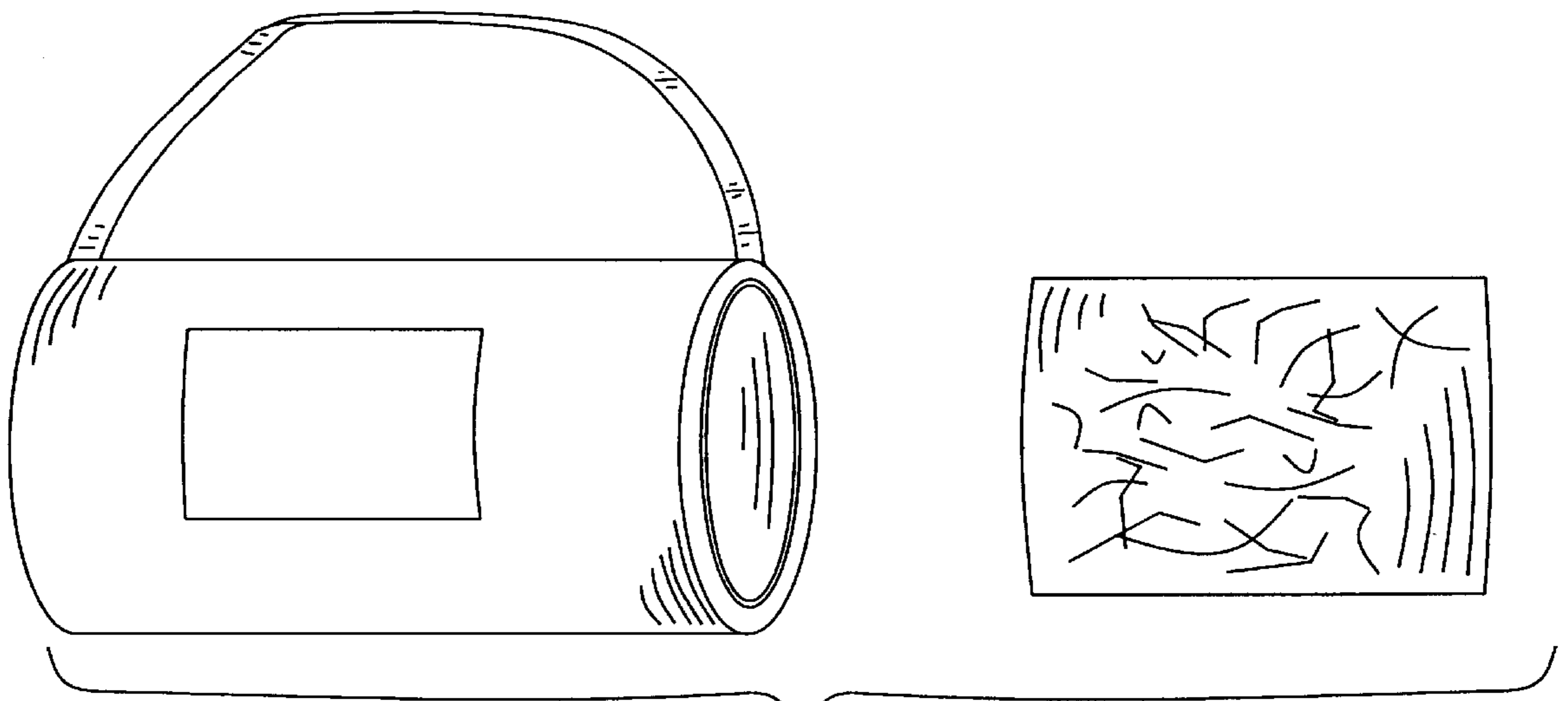

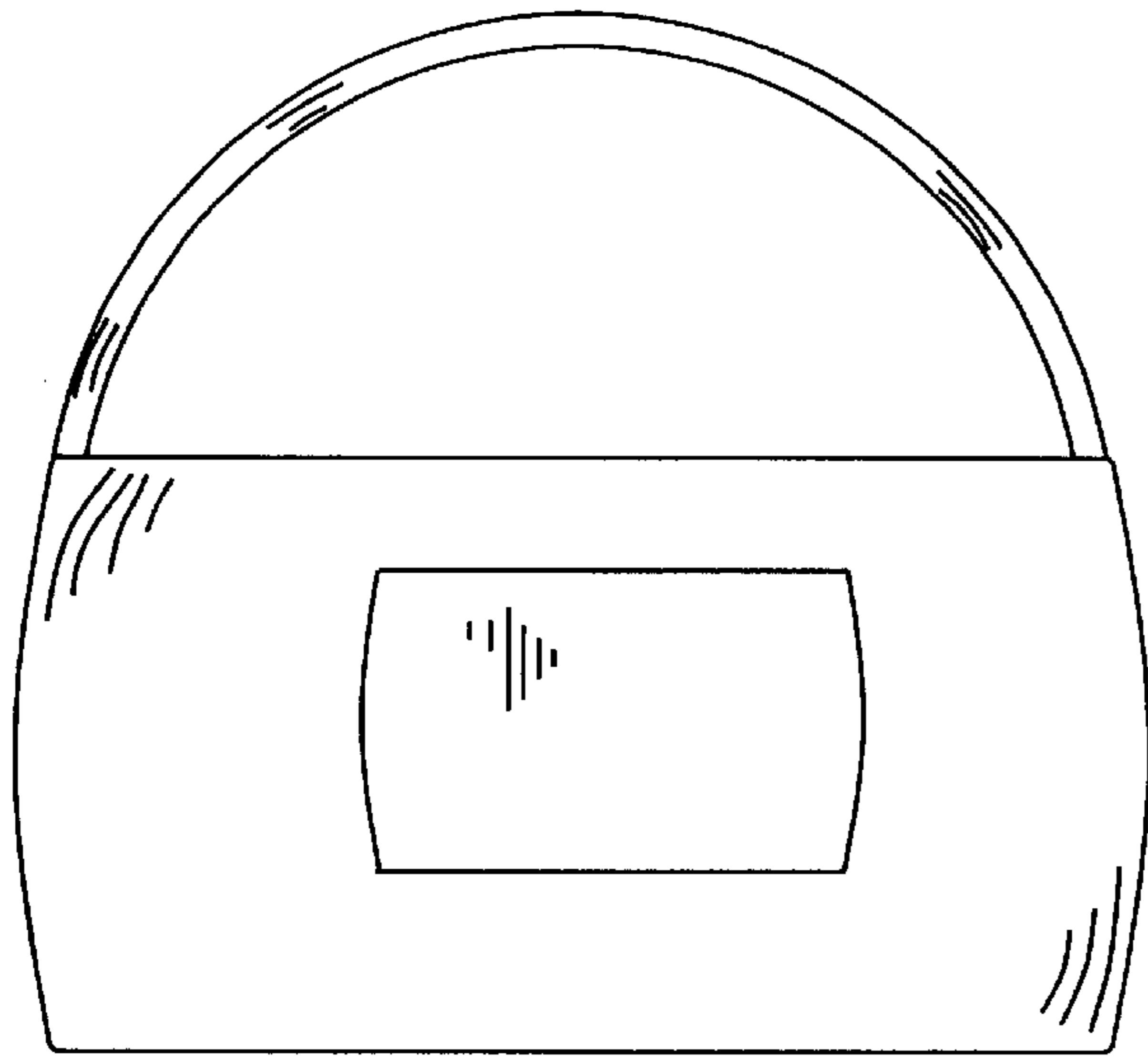

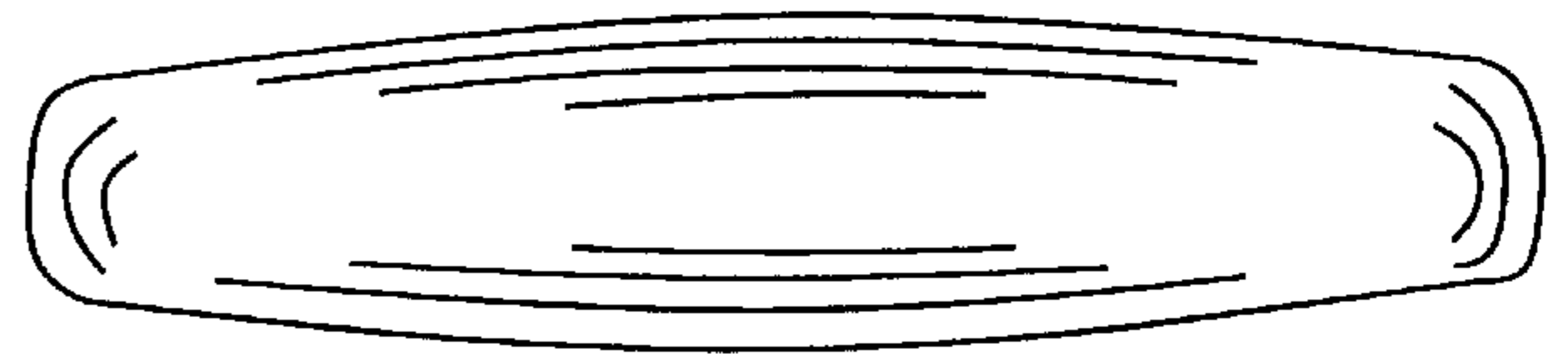

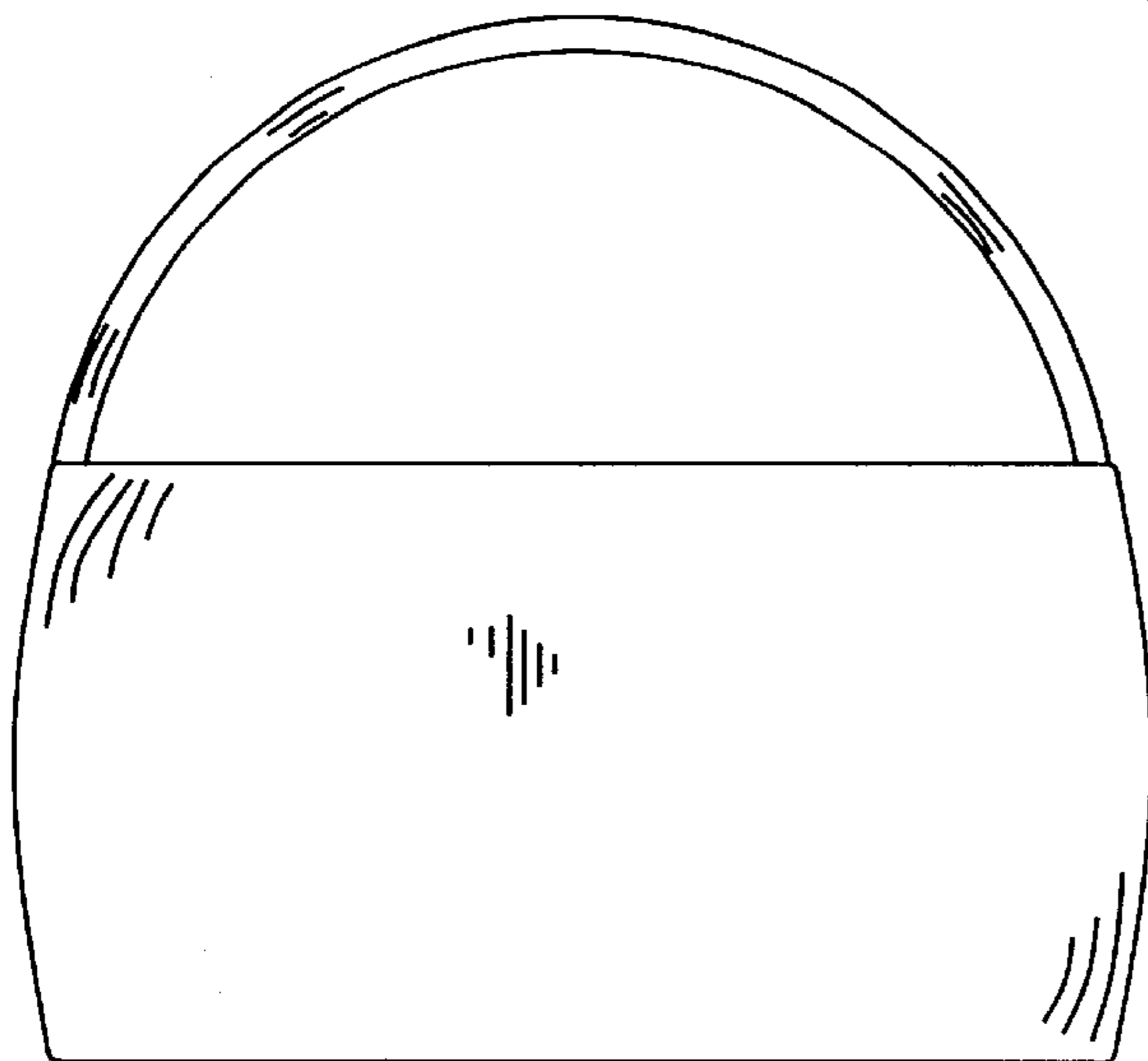

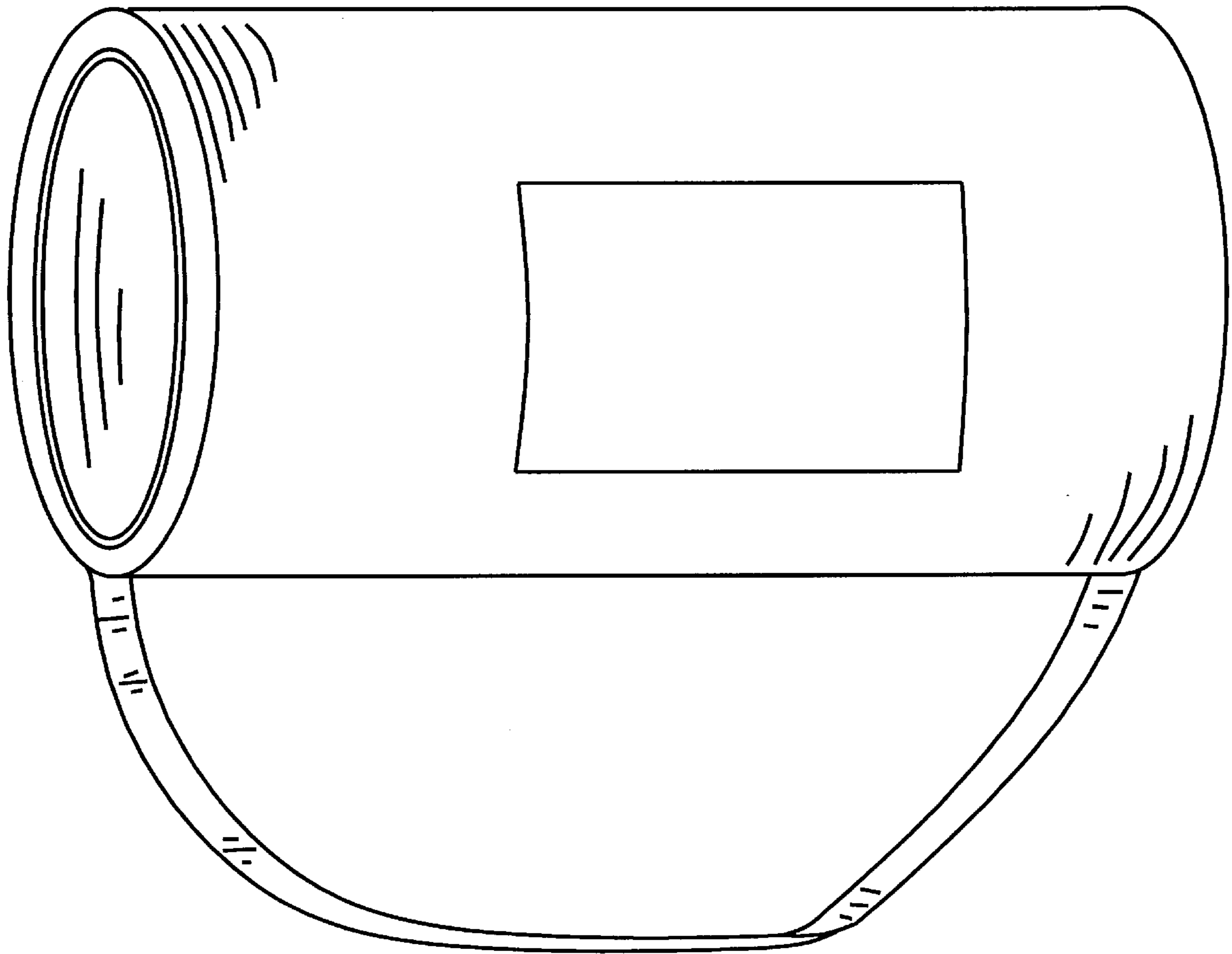

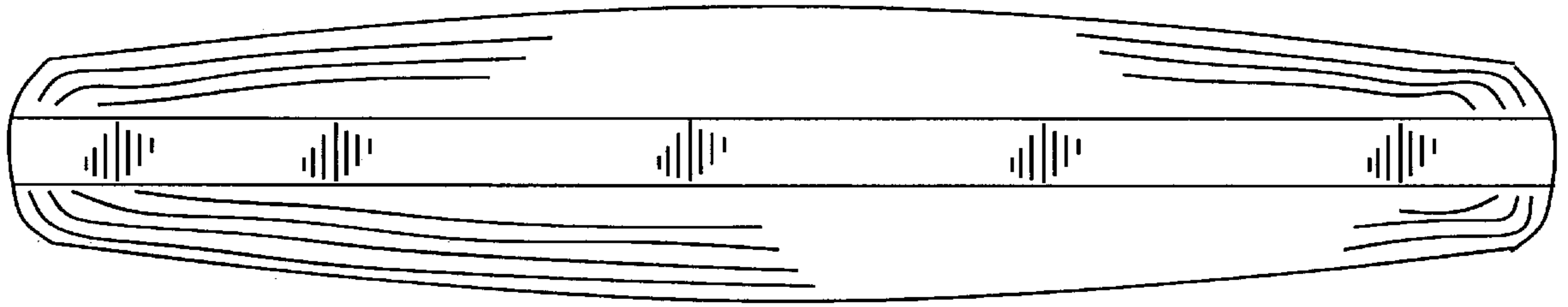
