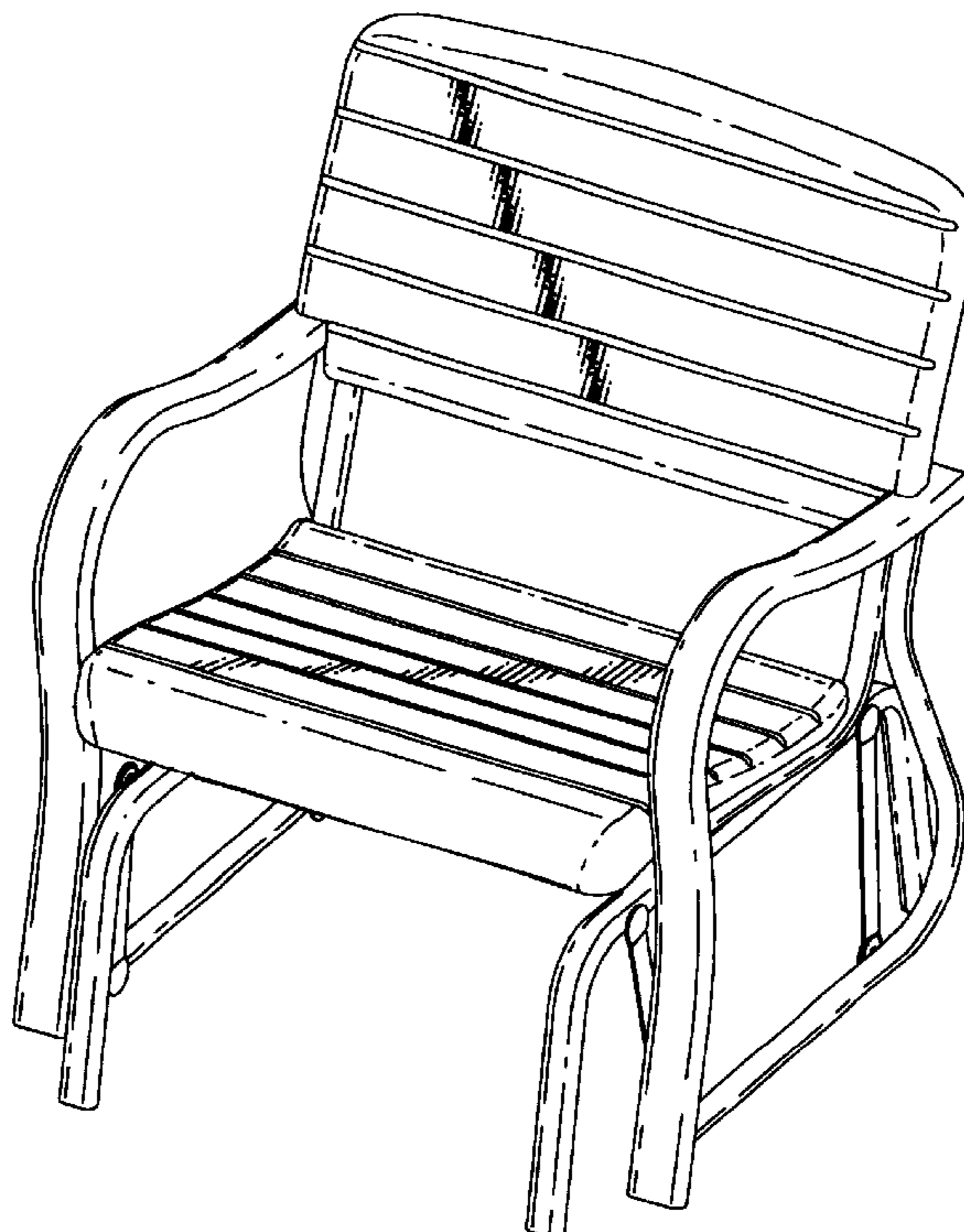
(57) **CLAIM**

The ornamental design for a glider chair, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a glider chair; FIG. 2 is a front view of the glider chair shown in FIG. 1; FIG. 3 is a back view of the glider chair shown in FIG. 1; FIG. 4 is a left side view of the glider chair shown in FIG. 1, with the right side view being a mirror image thereof; FIG. 5 is a top view of the glider chair shown in FIG. 1; and, FIG. 6 is a bottom plan view of the glider chair shown in FIG. 1.

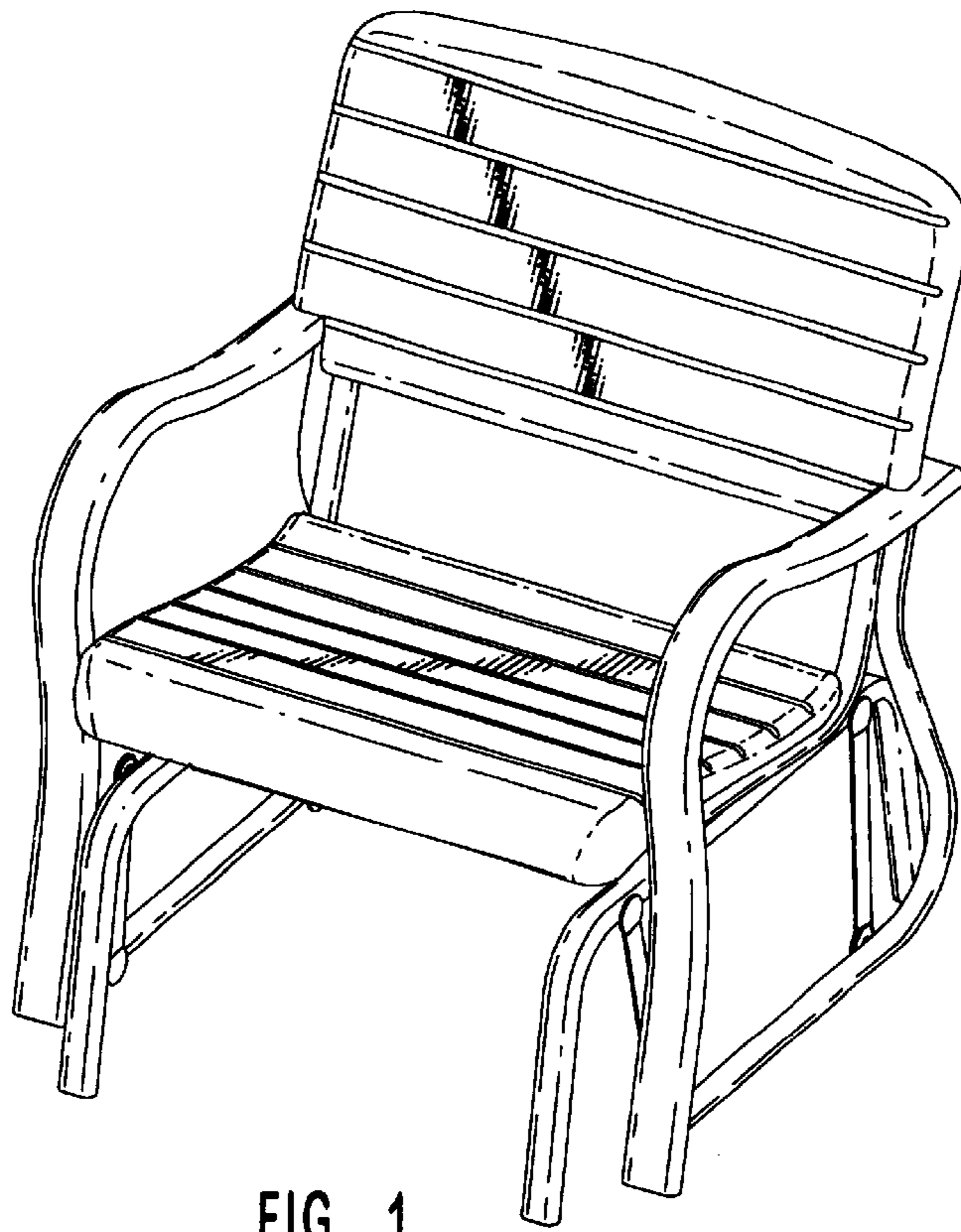

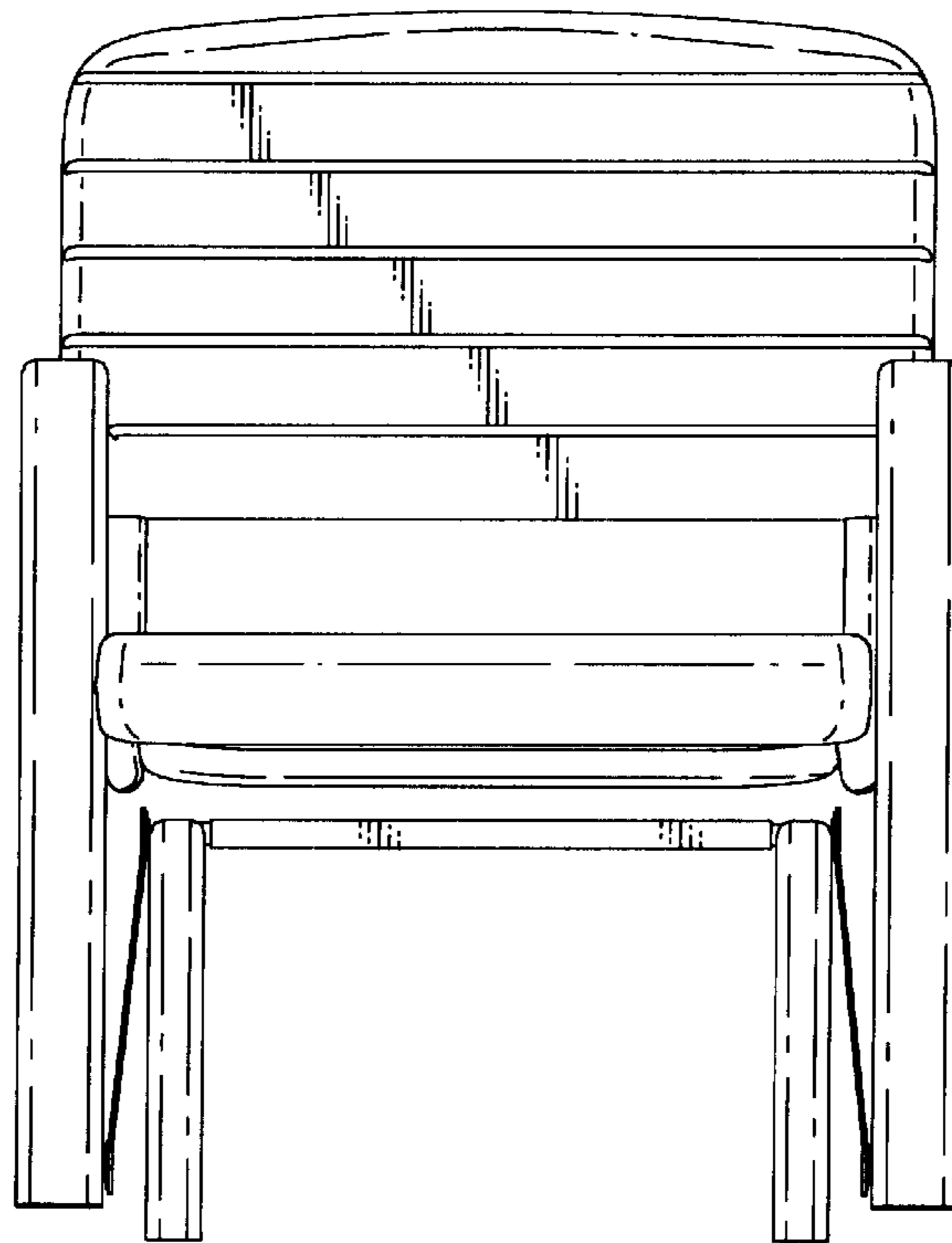

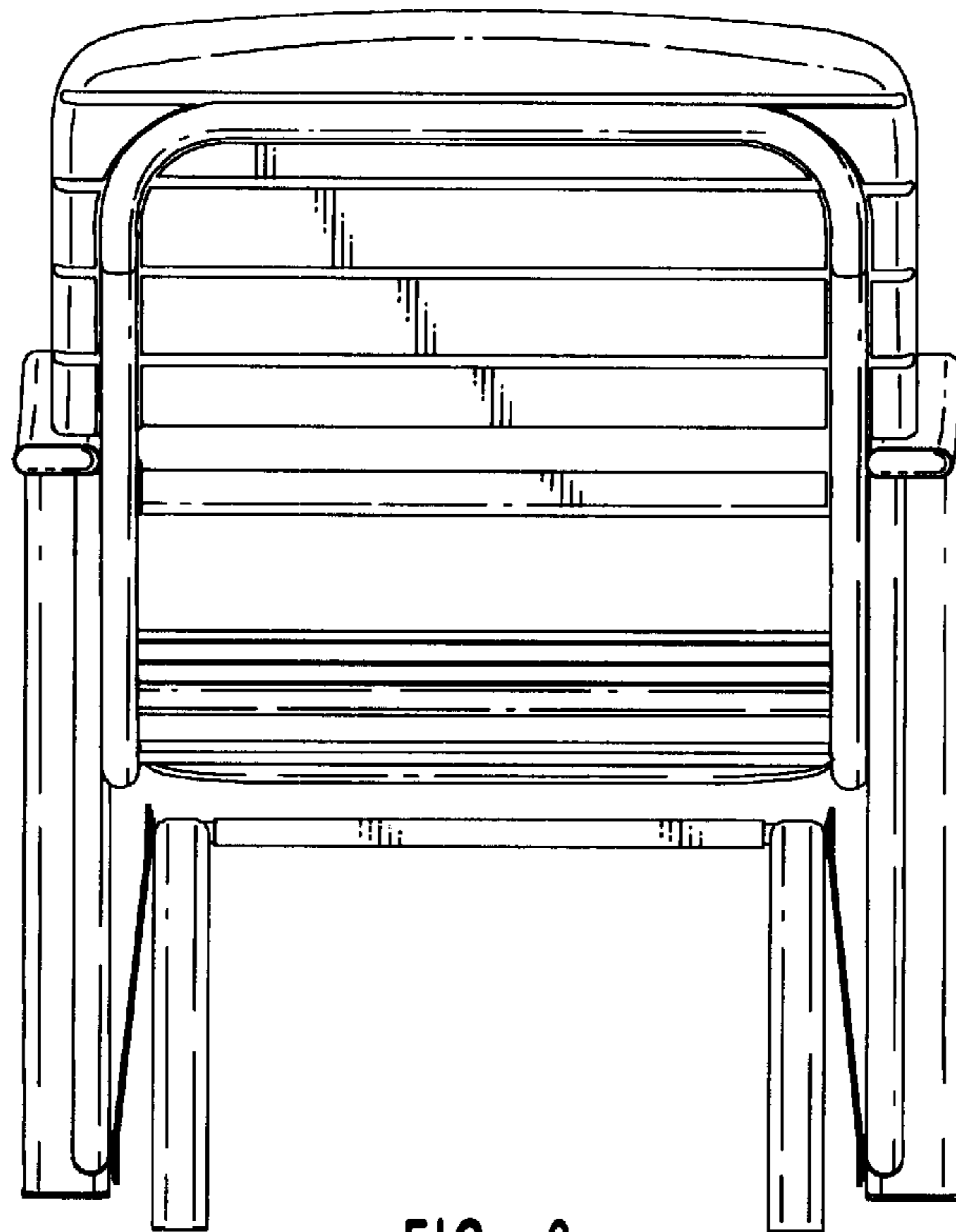

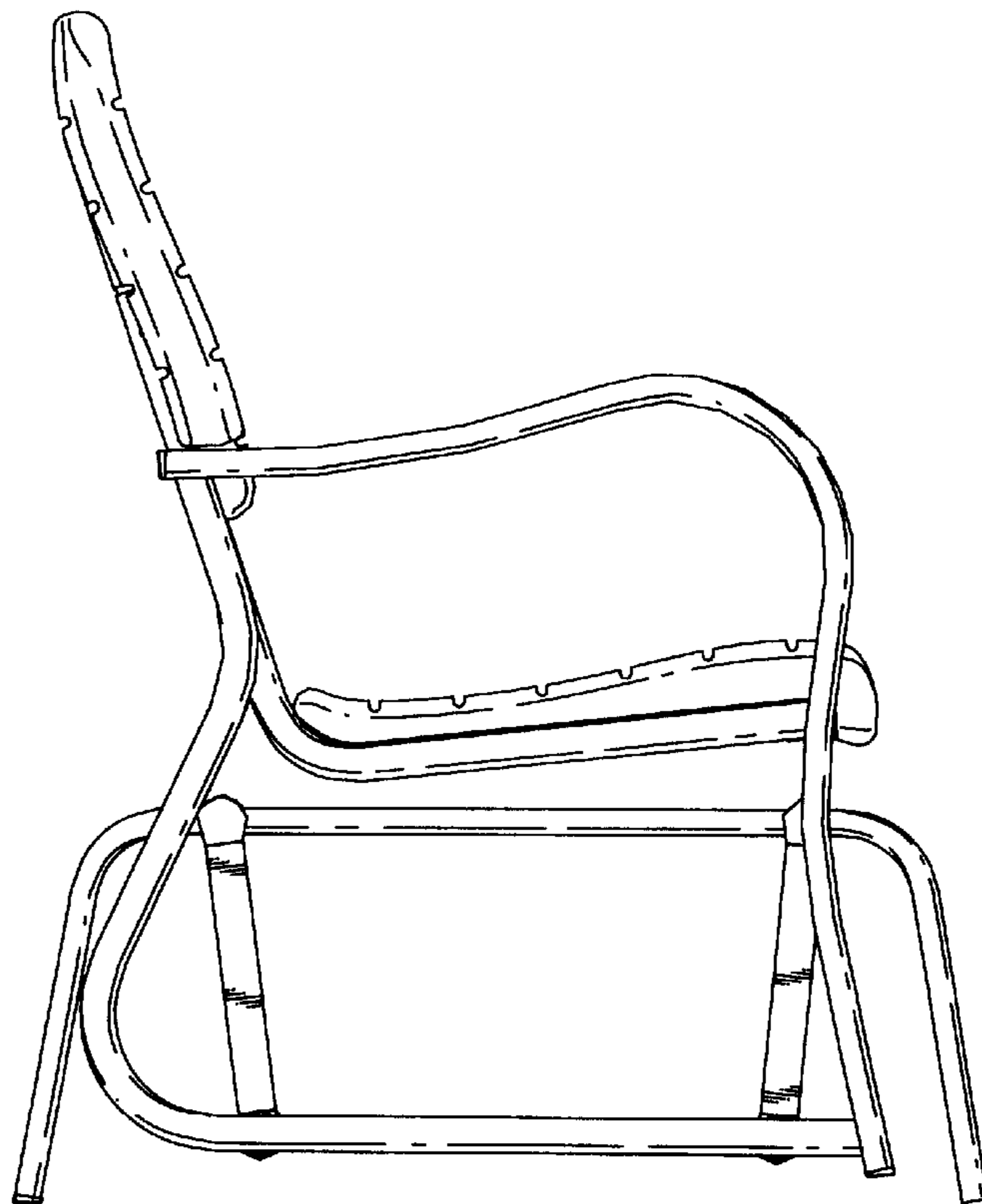

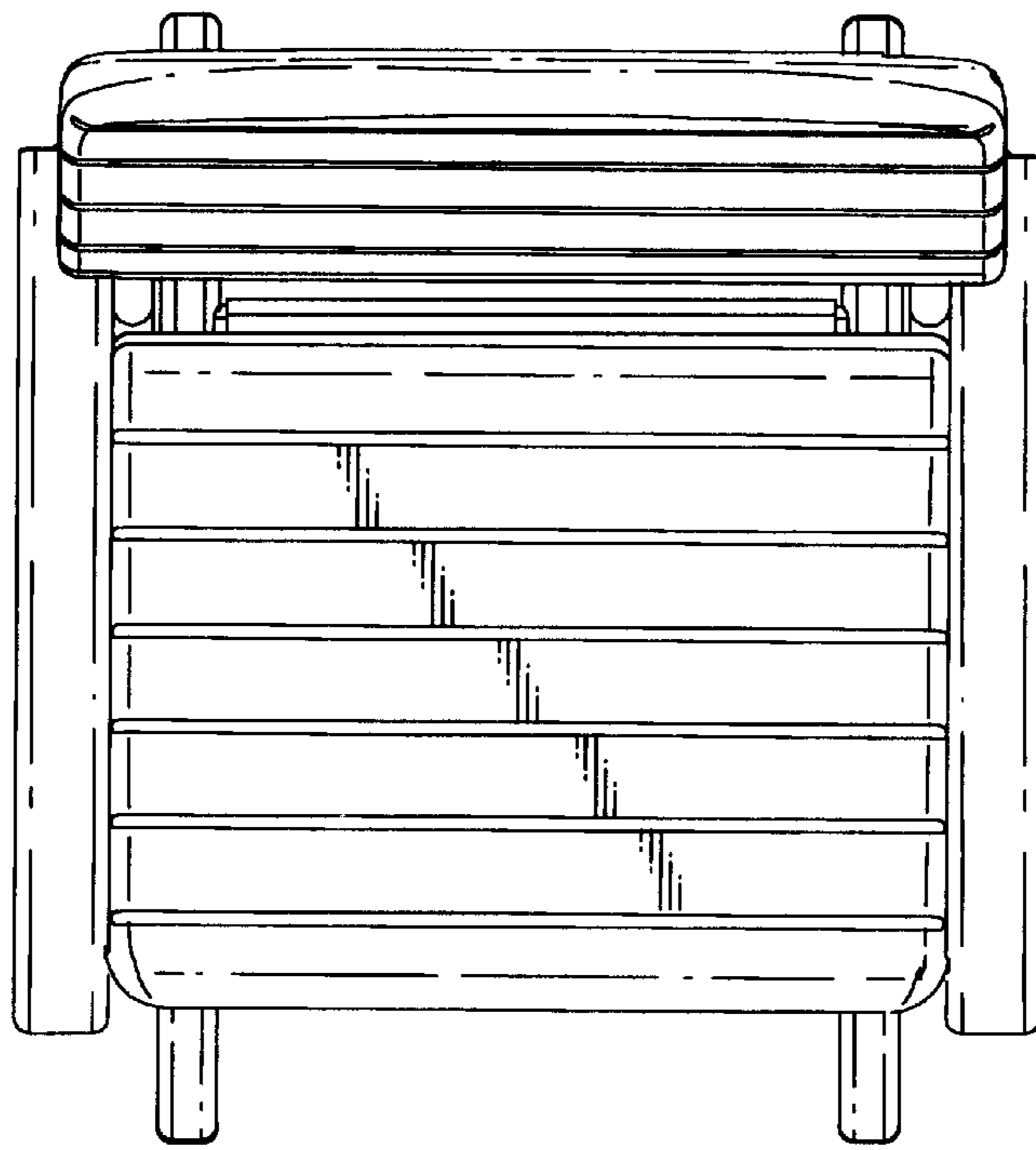

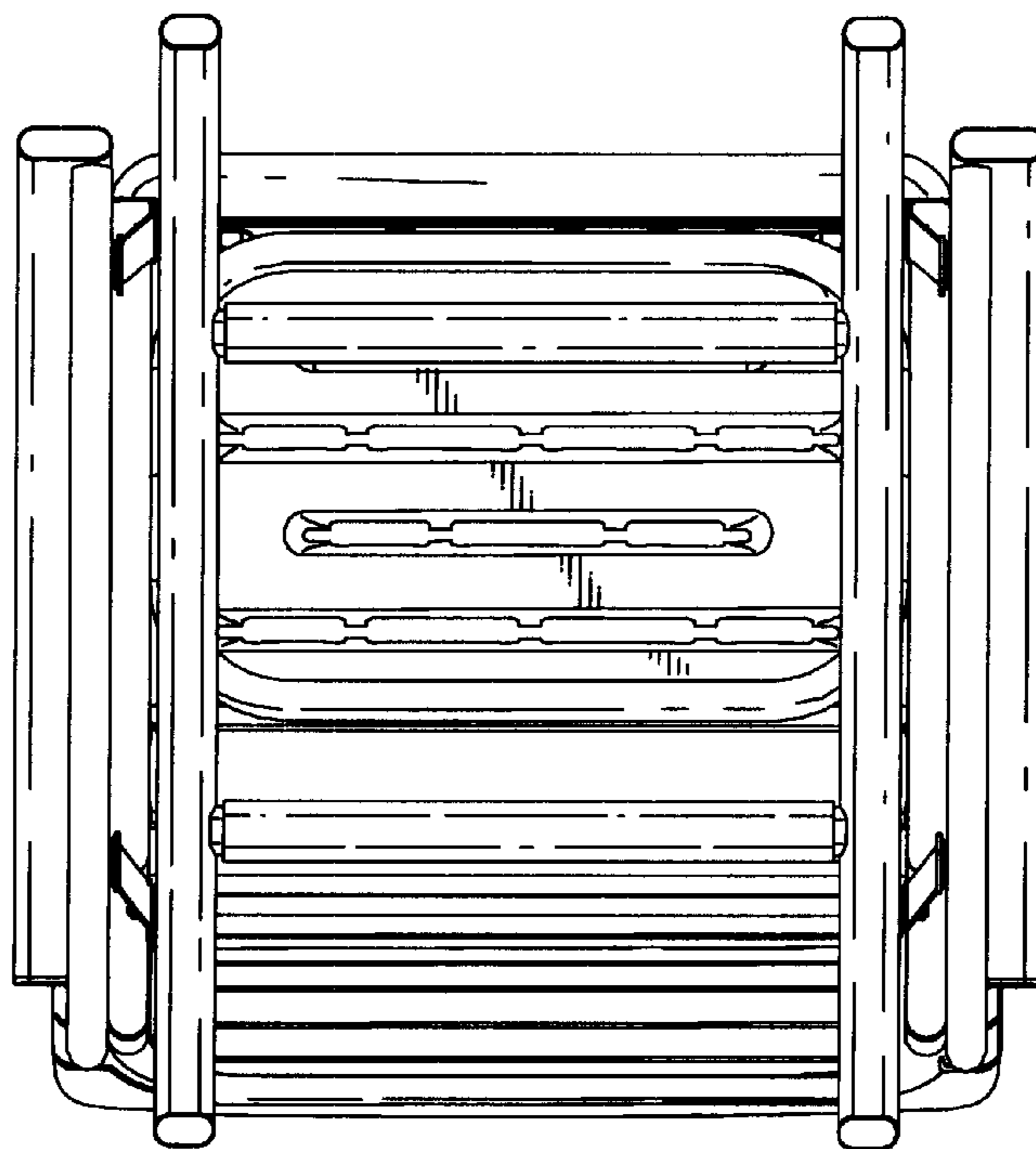
