(57) **CLAIM**

The ornamental design for an auxiliary handle for circular saw, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear perspective view of a first embodiment of the present new design for an auxiliary handle for circular saw; FIG. 2 is a left side view thereof; FIG. 3 is a right side view thereof; FIG. 4 is a front view thereof; FIG. 5 is a rear view thereof; FIG. 6 is top view thereof; FIG. 7 is a bottom view thereof; FIG. 8 is a left side view of a second embodiment of the present design for an auxiliary handle for circular saw; FIG. 9 is a right side view thereof; FIG. 10 is a front view thereof; FIG. 11 is a rear view thereof; FIG. 12 is top view thereof; FIG. 13 is a bottom view thereof; FIG. 14 is a left side view of a third embodiment of the present new design for an auxiliary handle for circular saw; FIG. 15 is a right side view thereof; FIG. 16 is a front view thereof; FIG. 17 is a rear view thereof; FIG. 18 is top view thereof; and, FIG. 19 is a bottom view thereof.

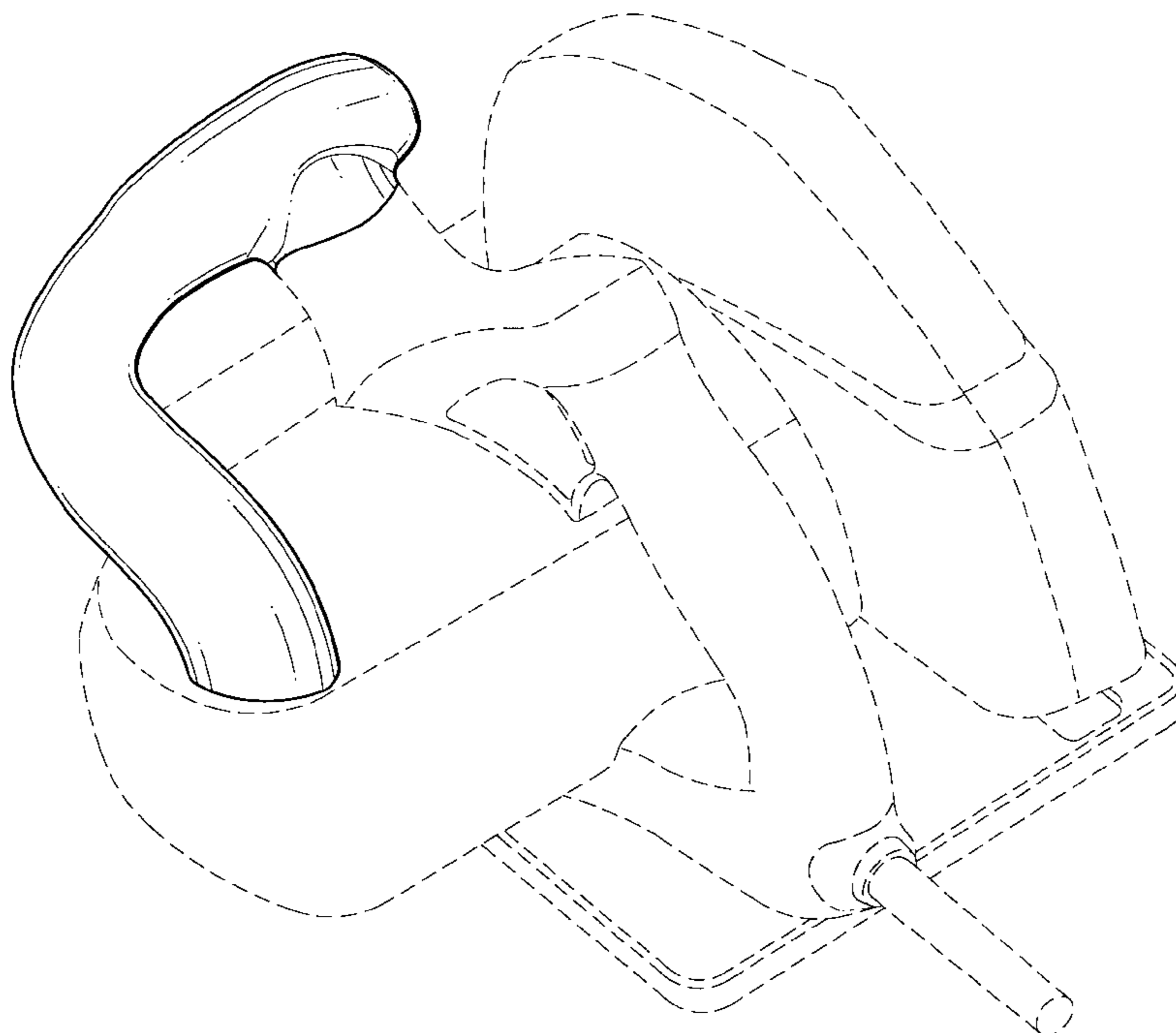
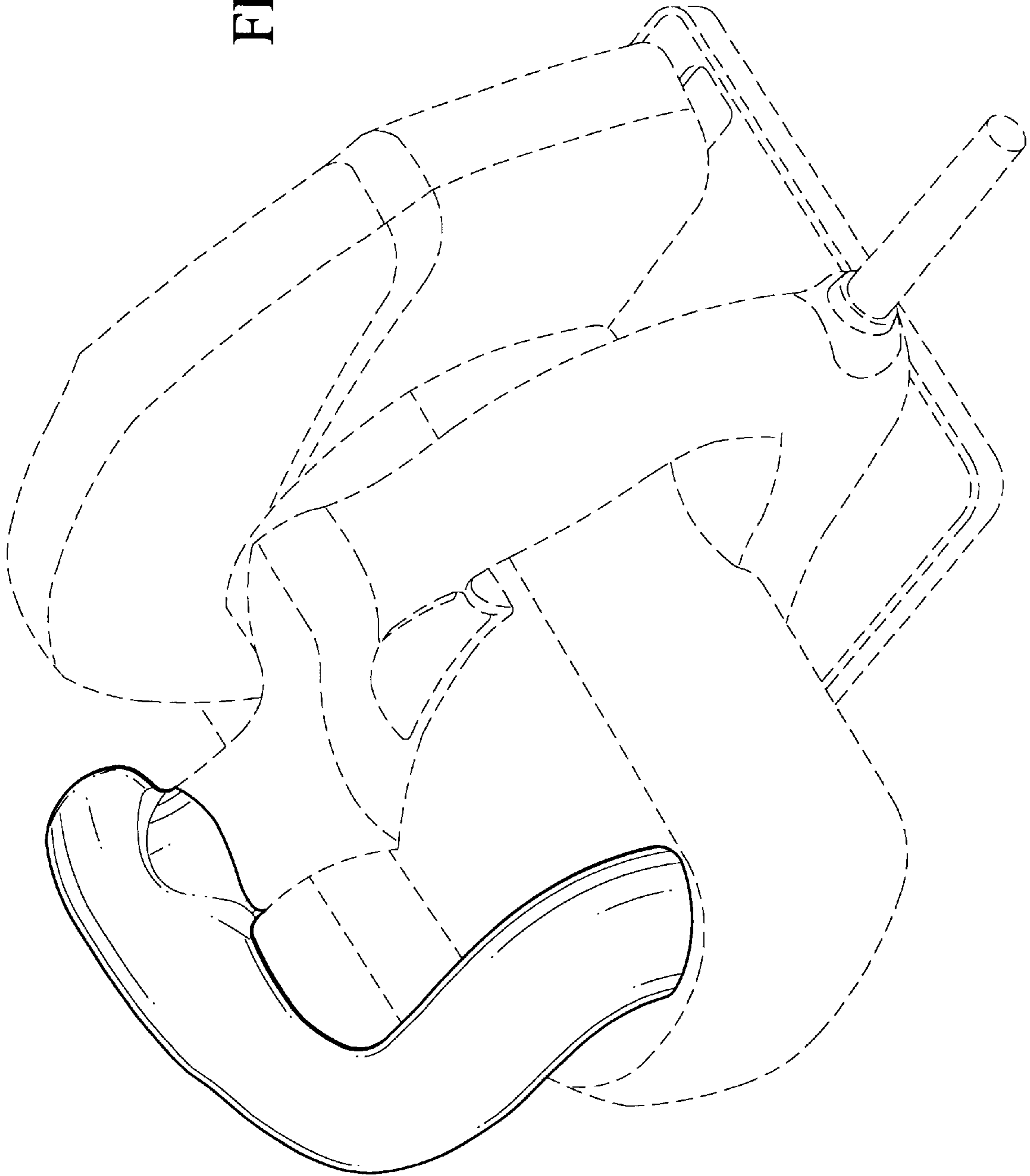

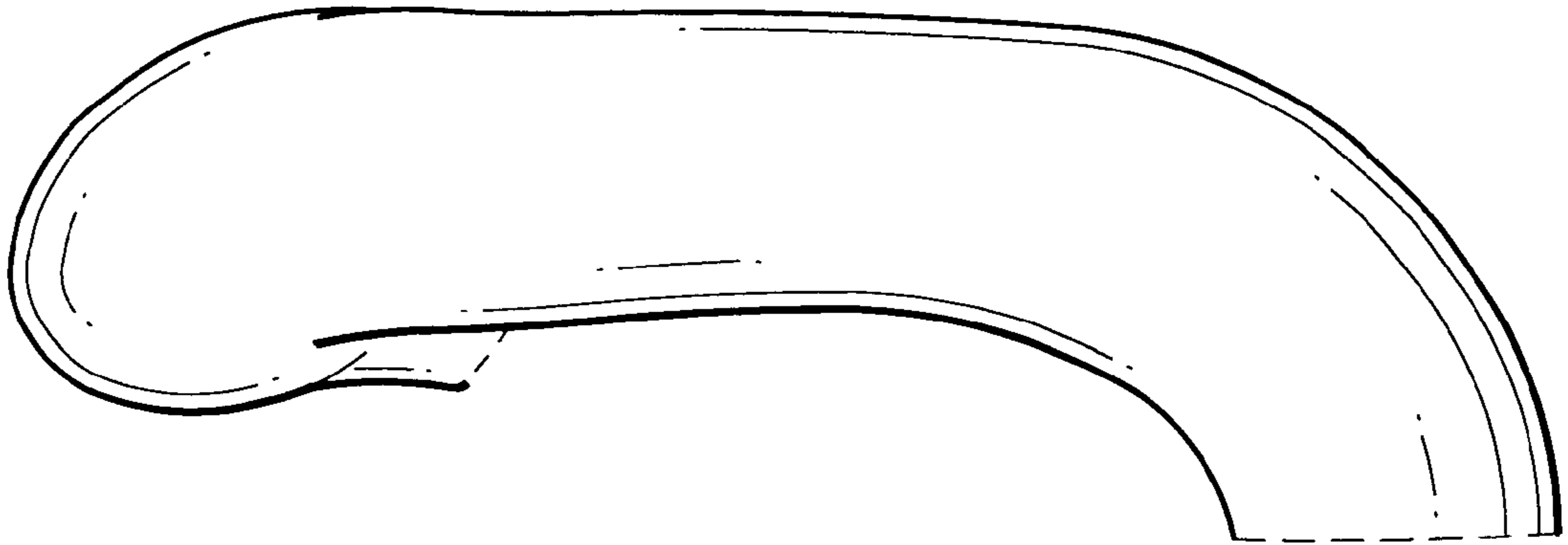

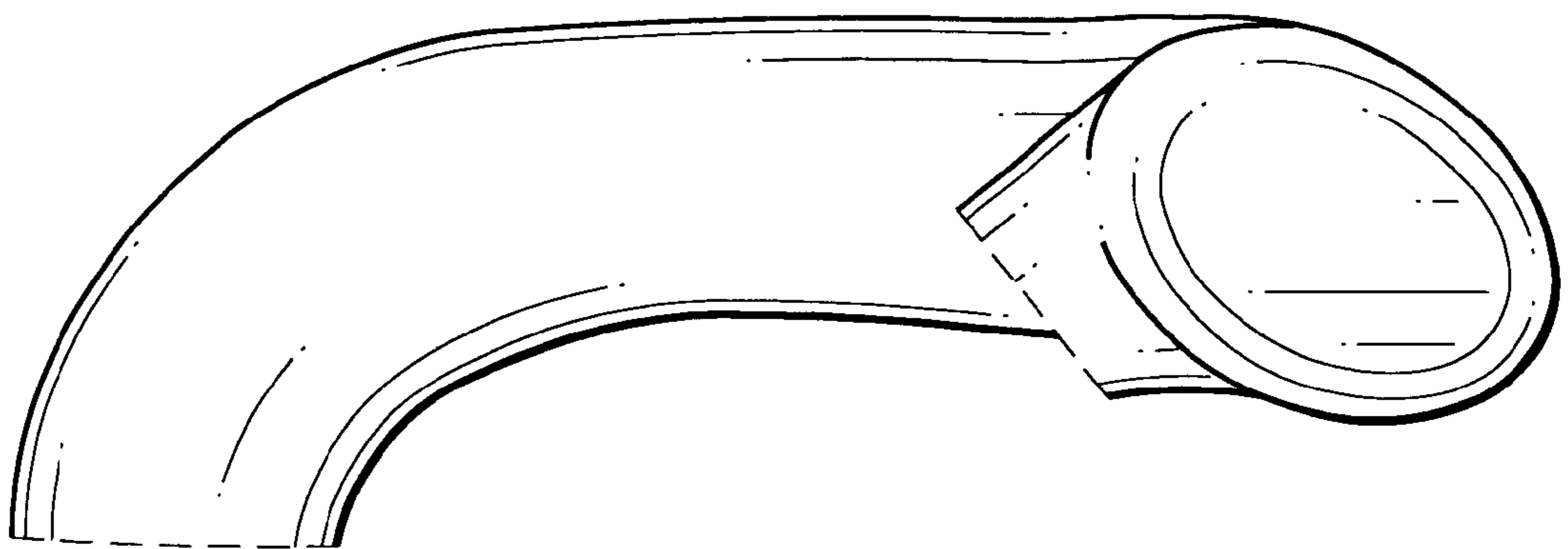

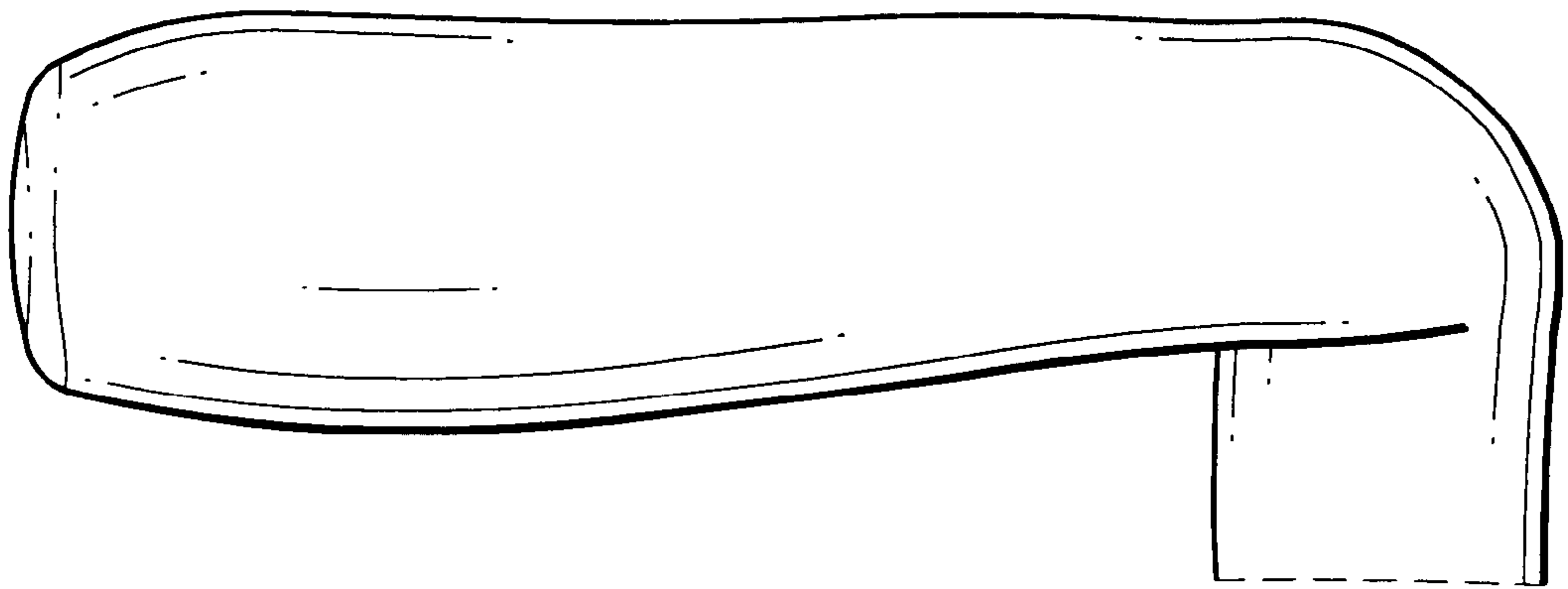

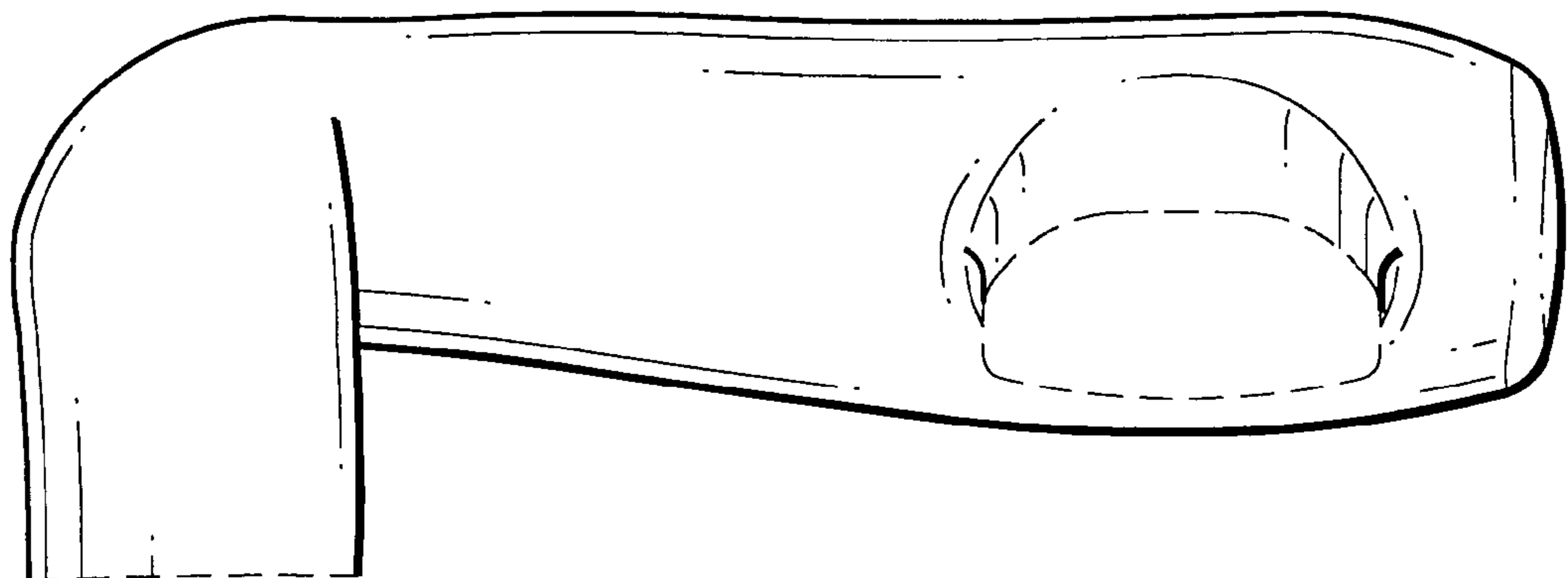

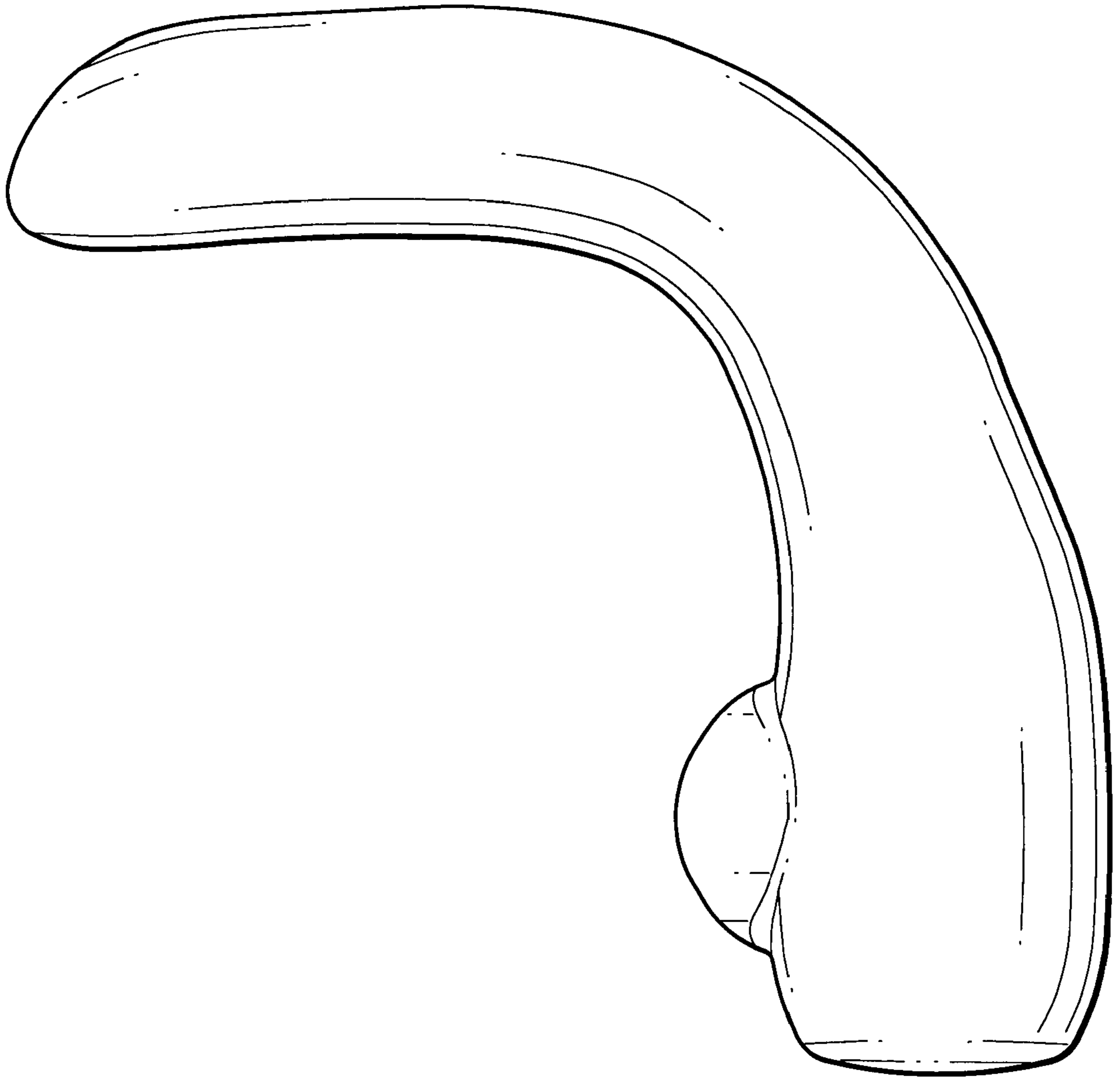

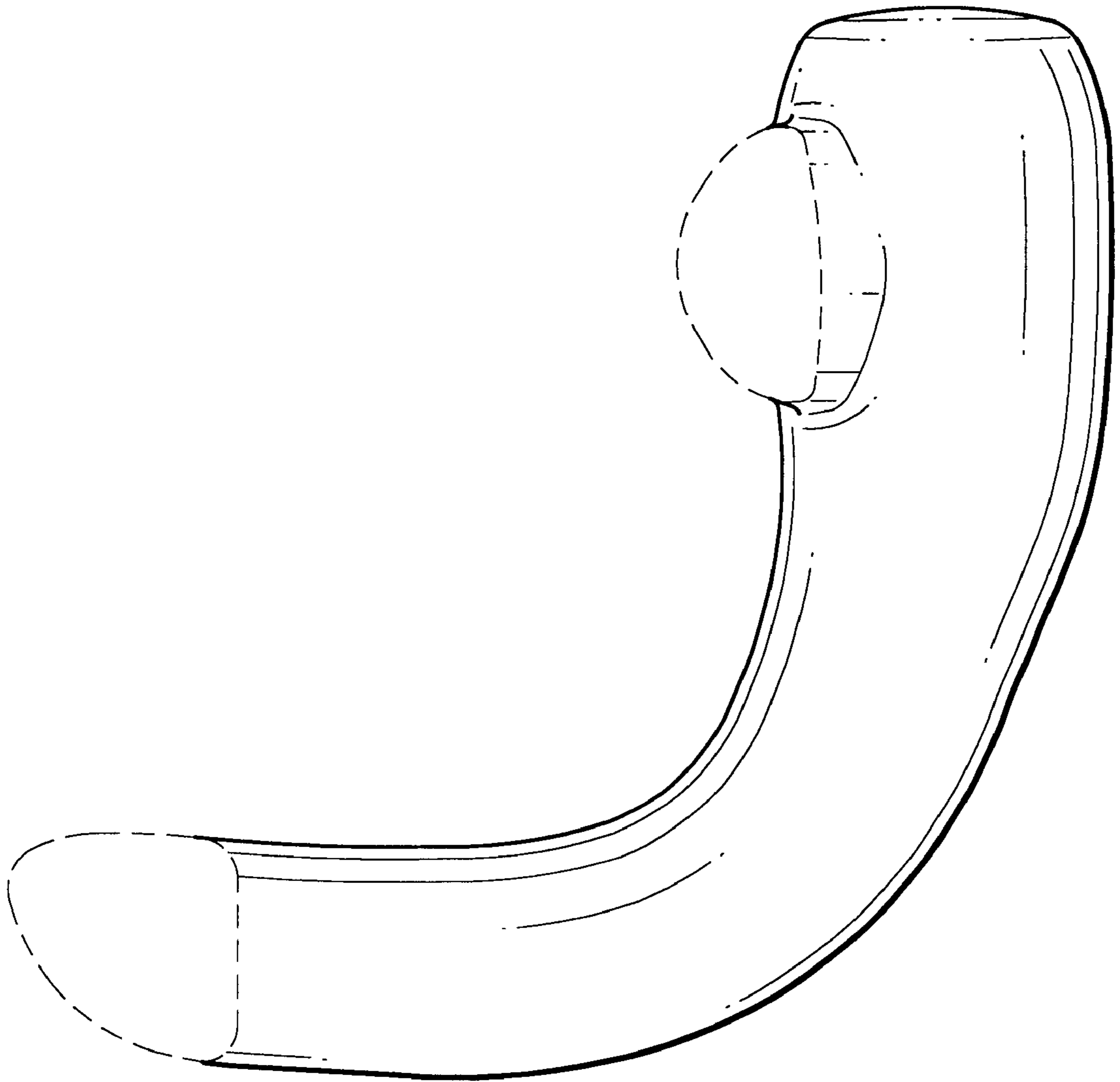

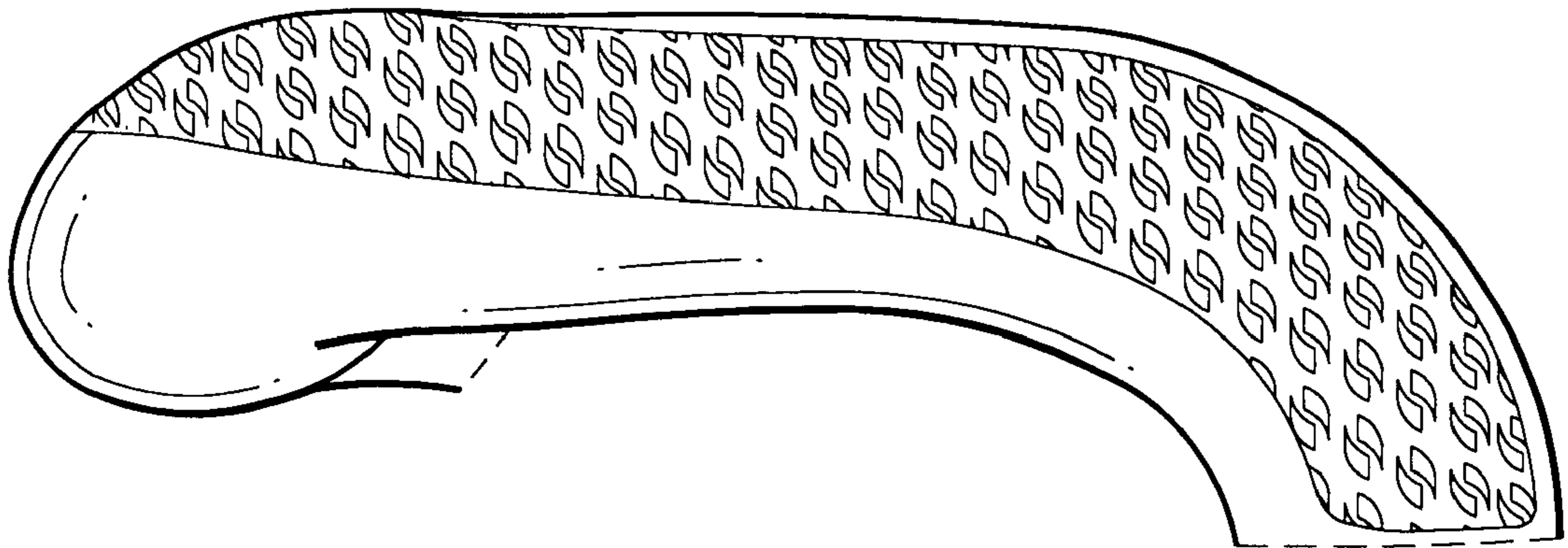

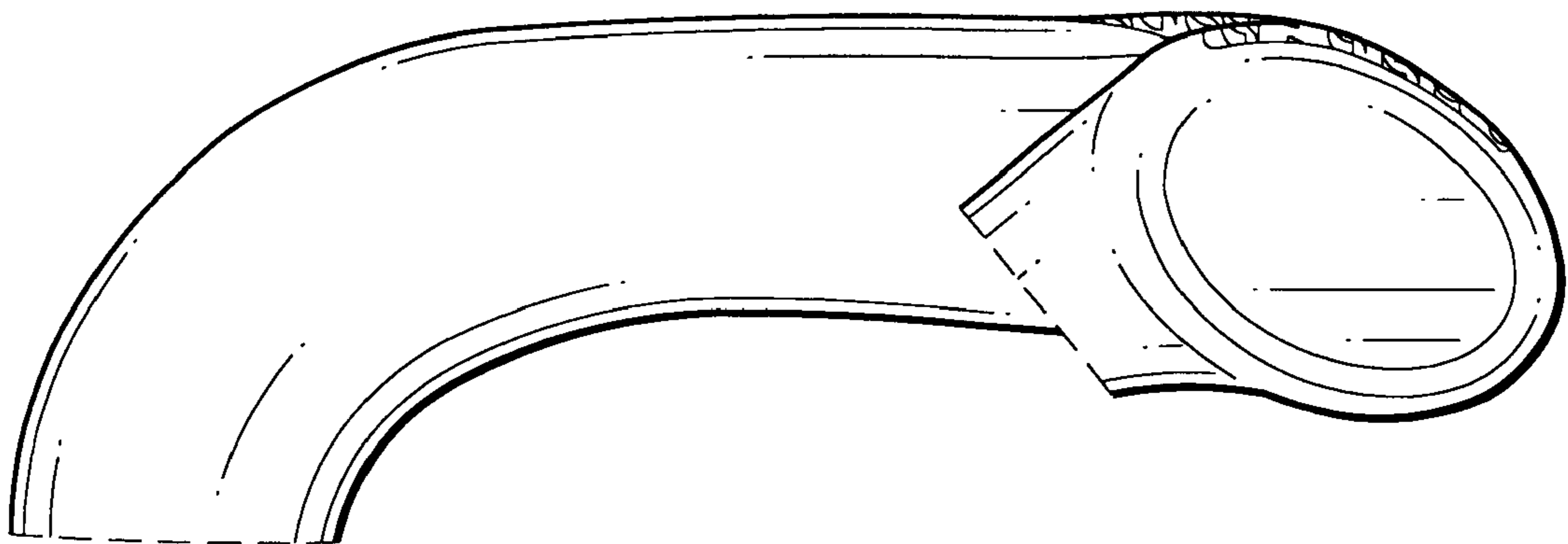

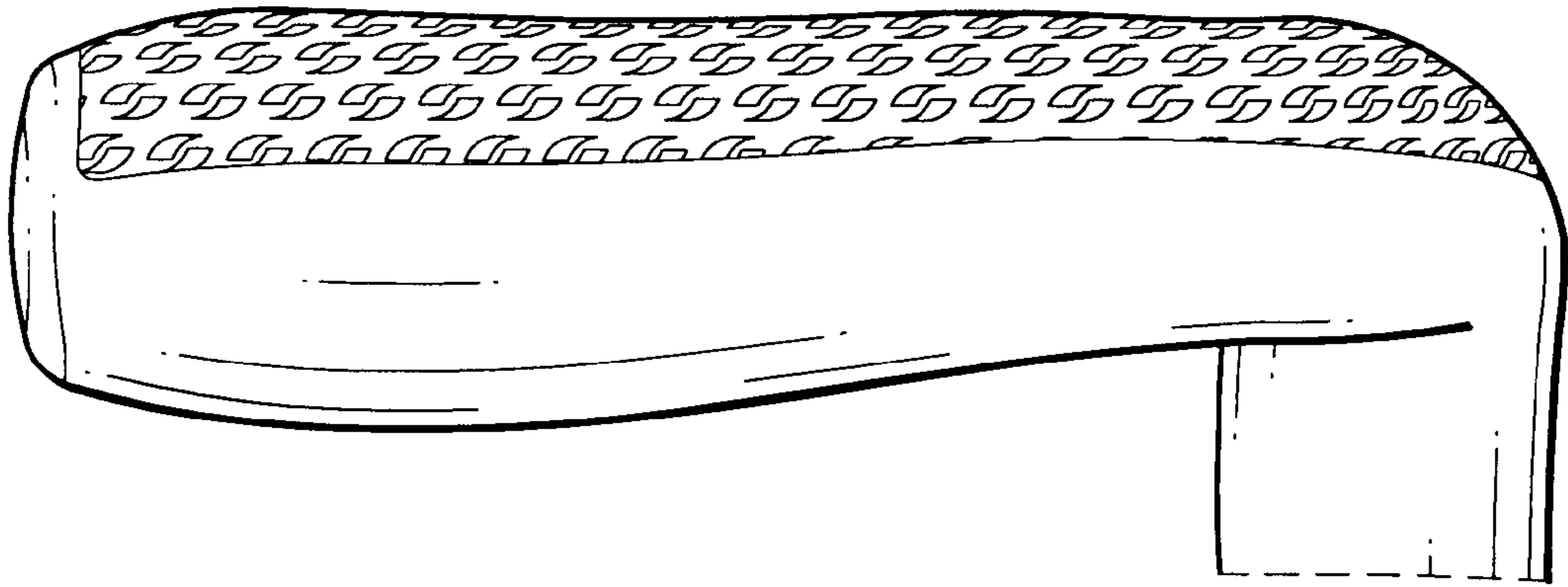

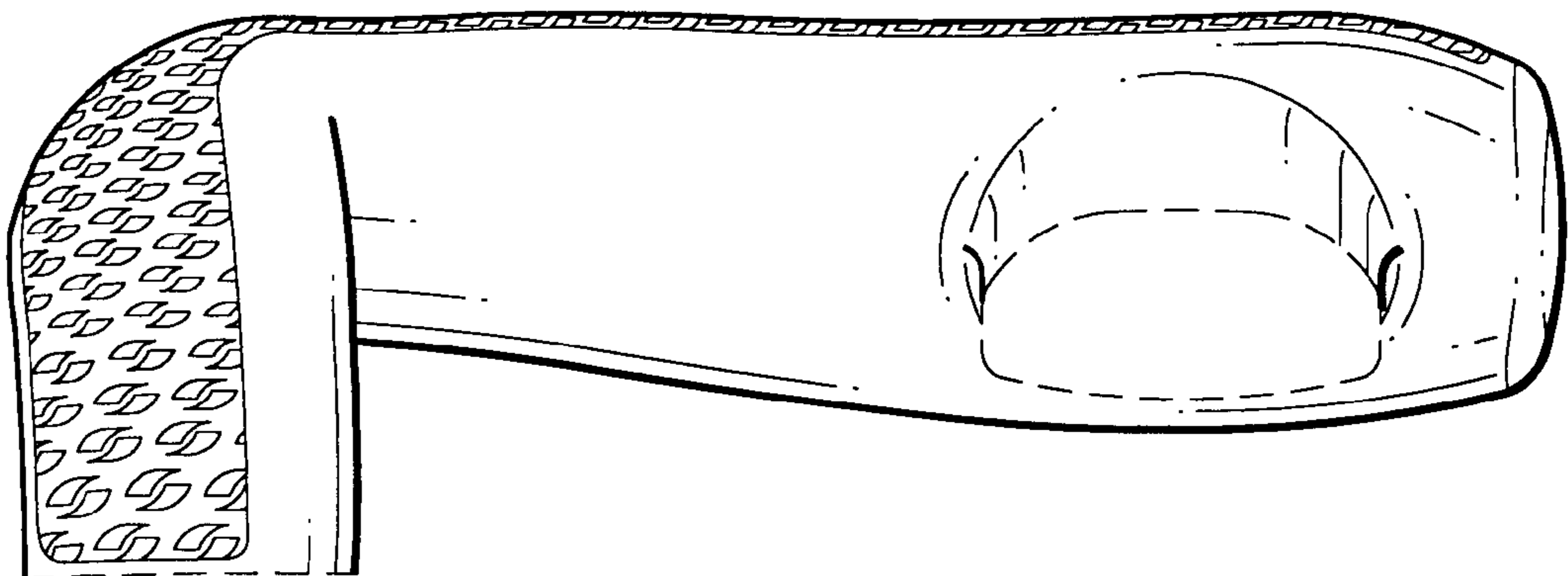

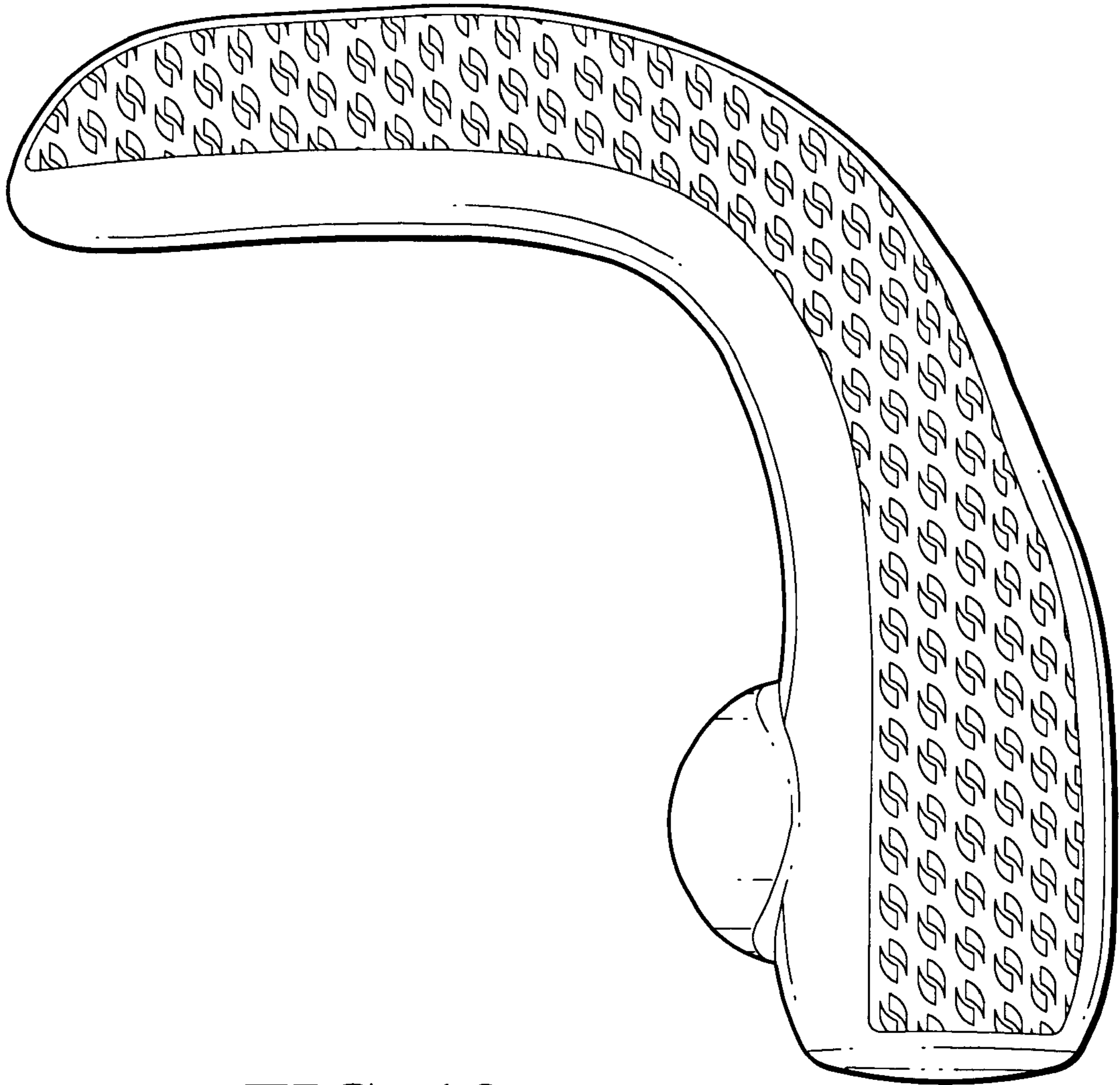

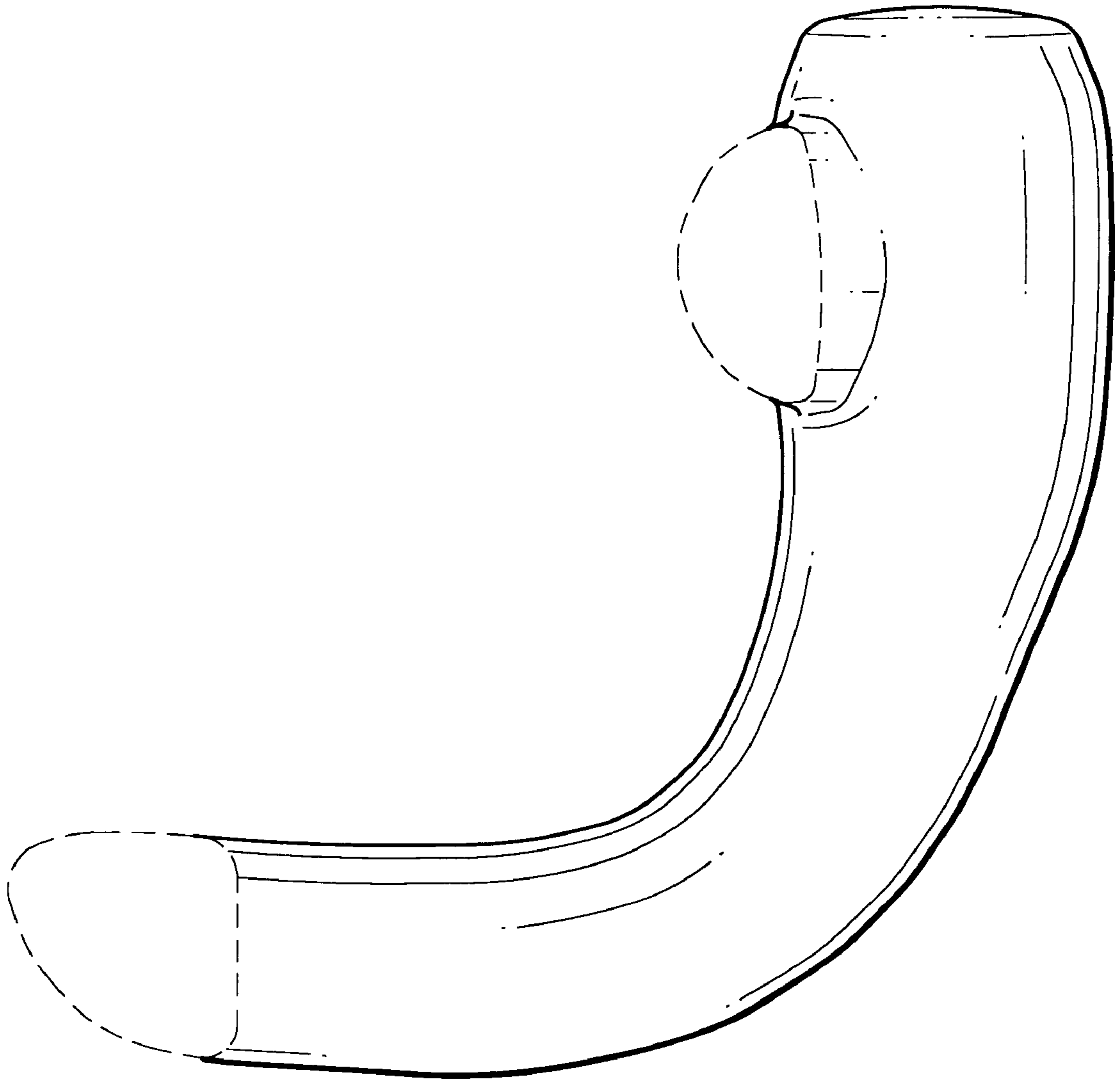

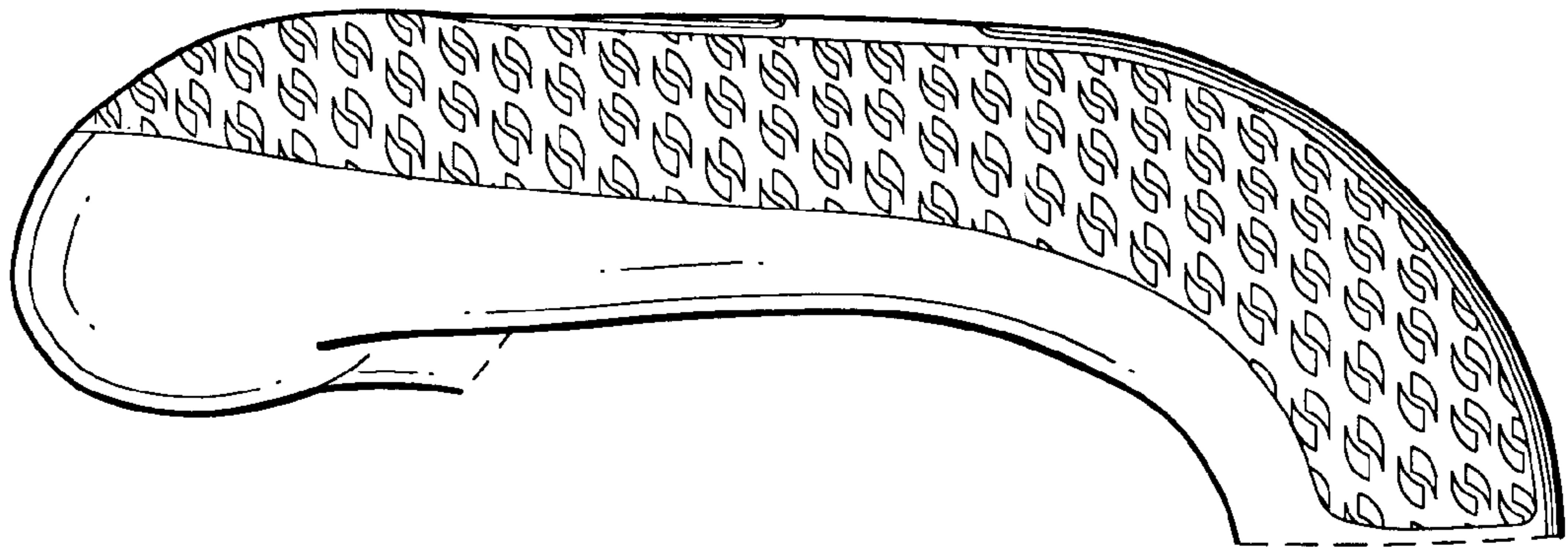

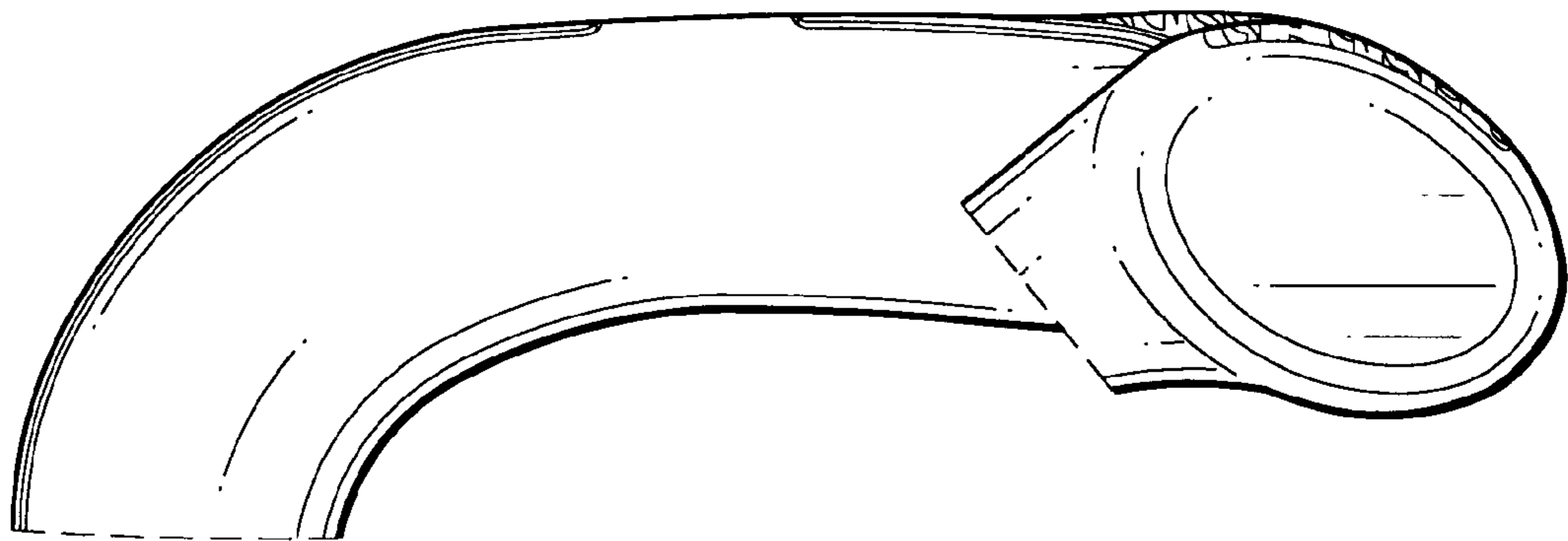

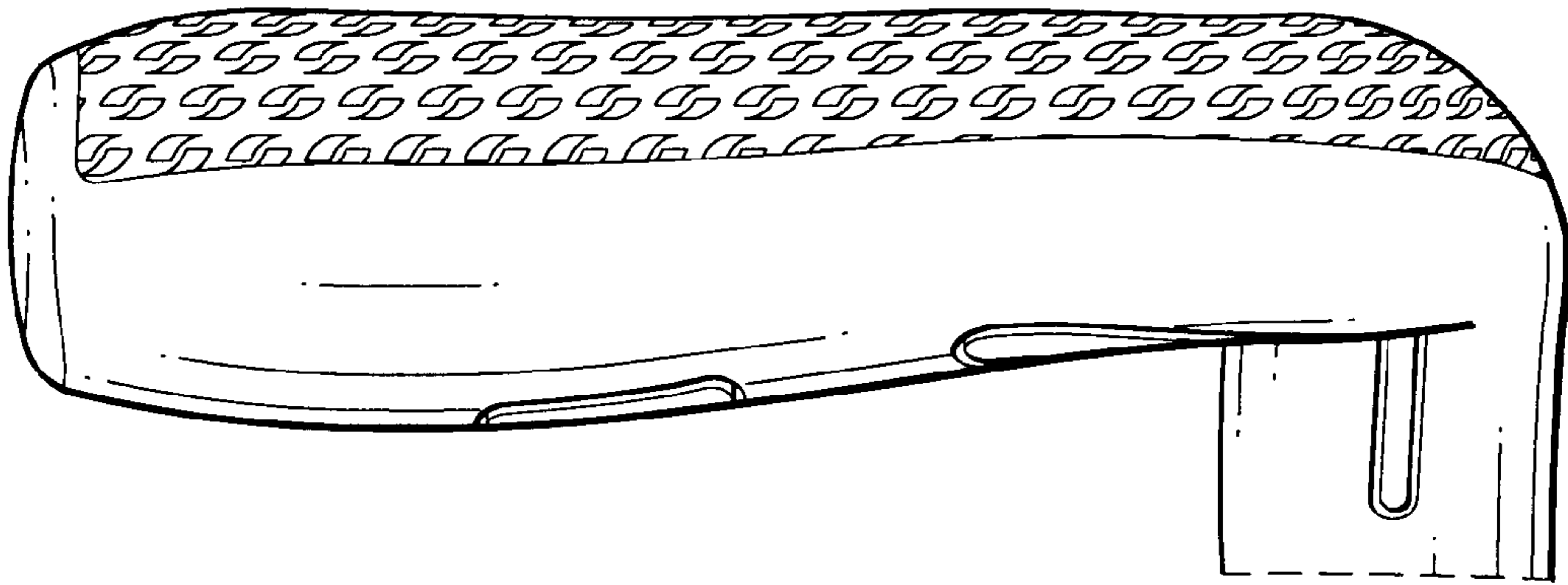

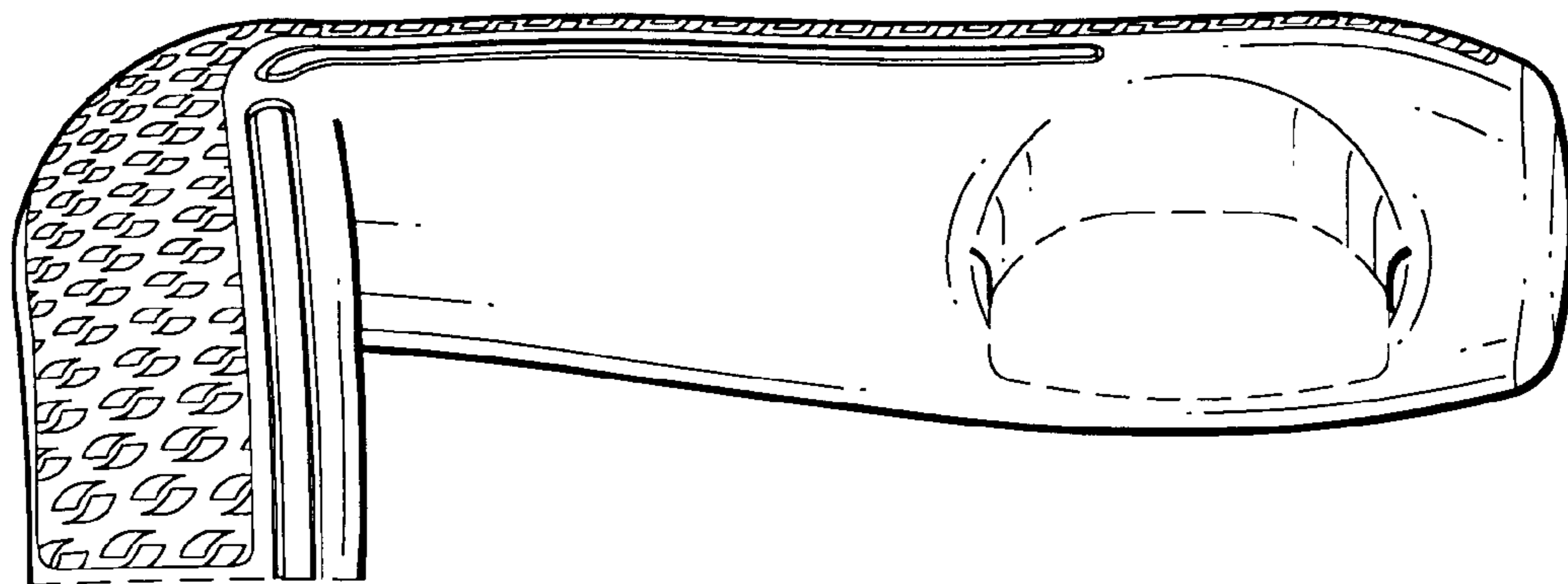

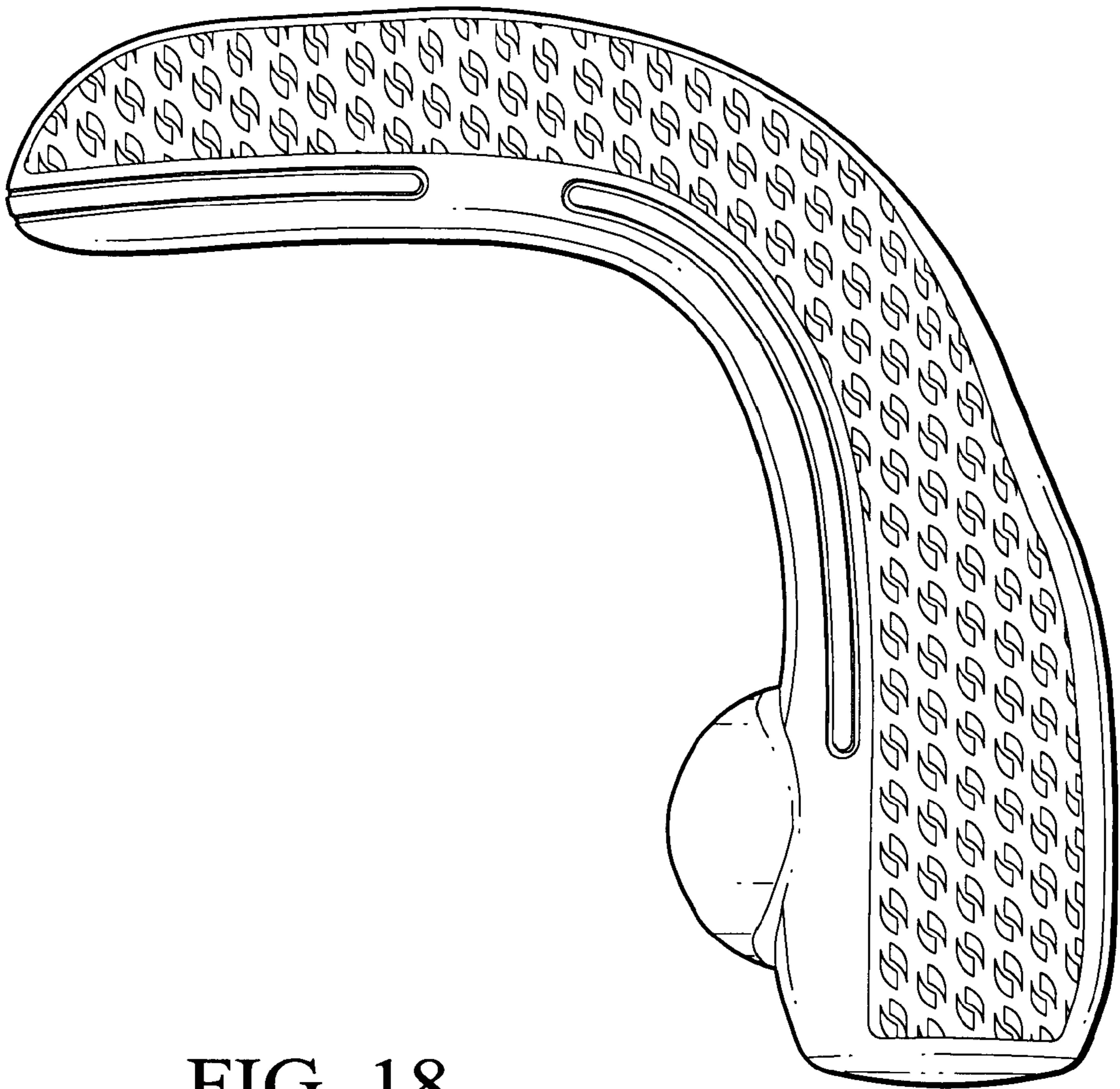

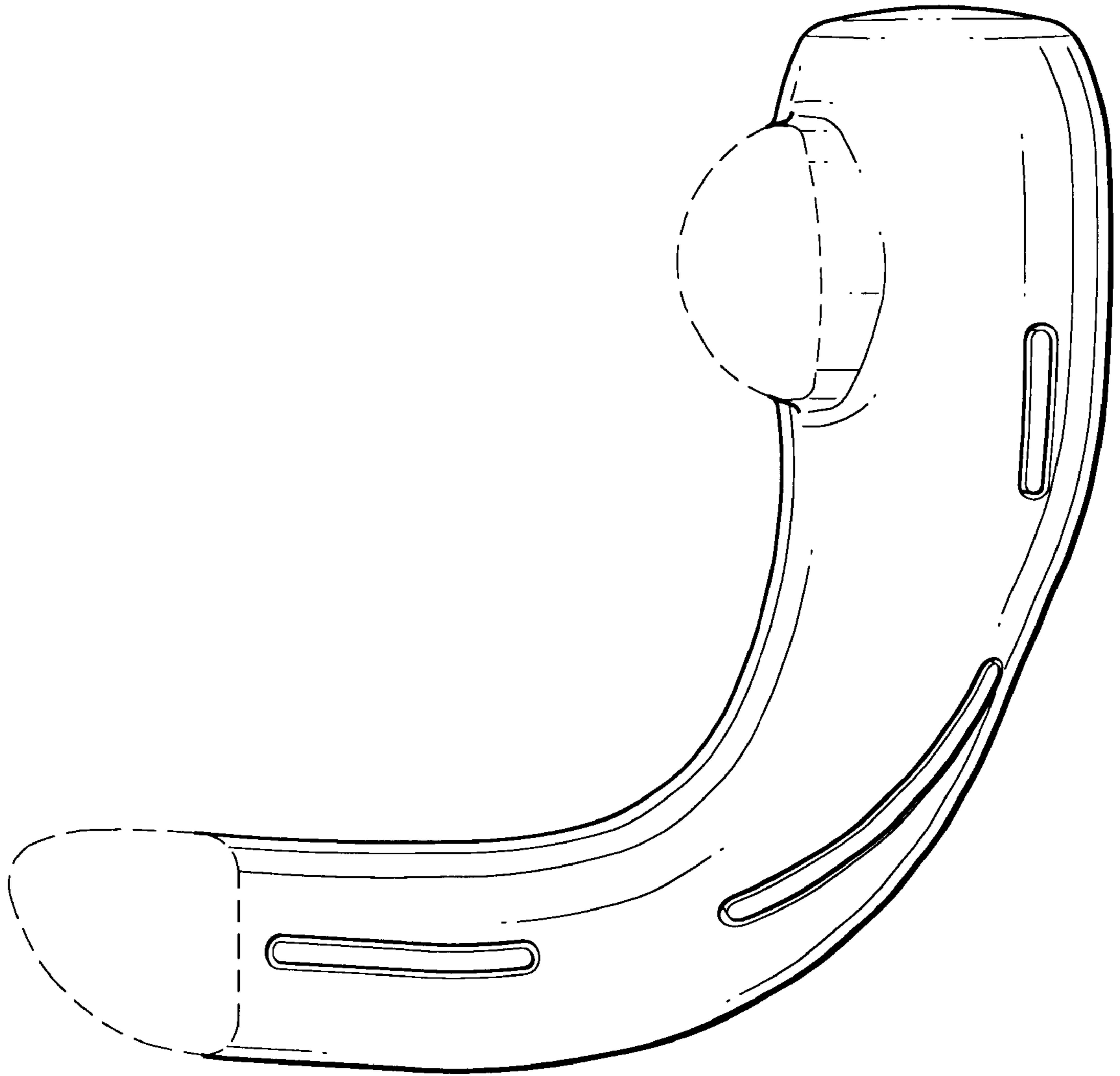
