**DESCRIPTION**

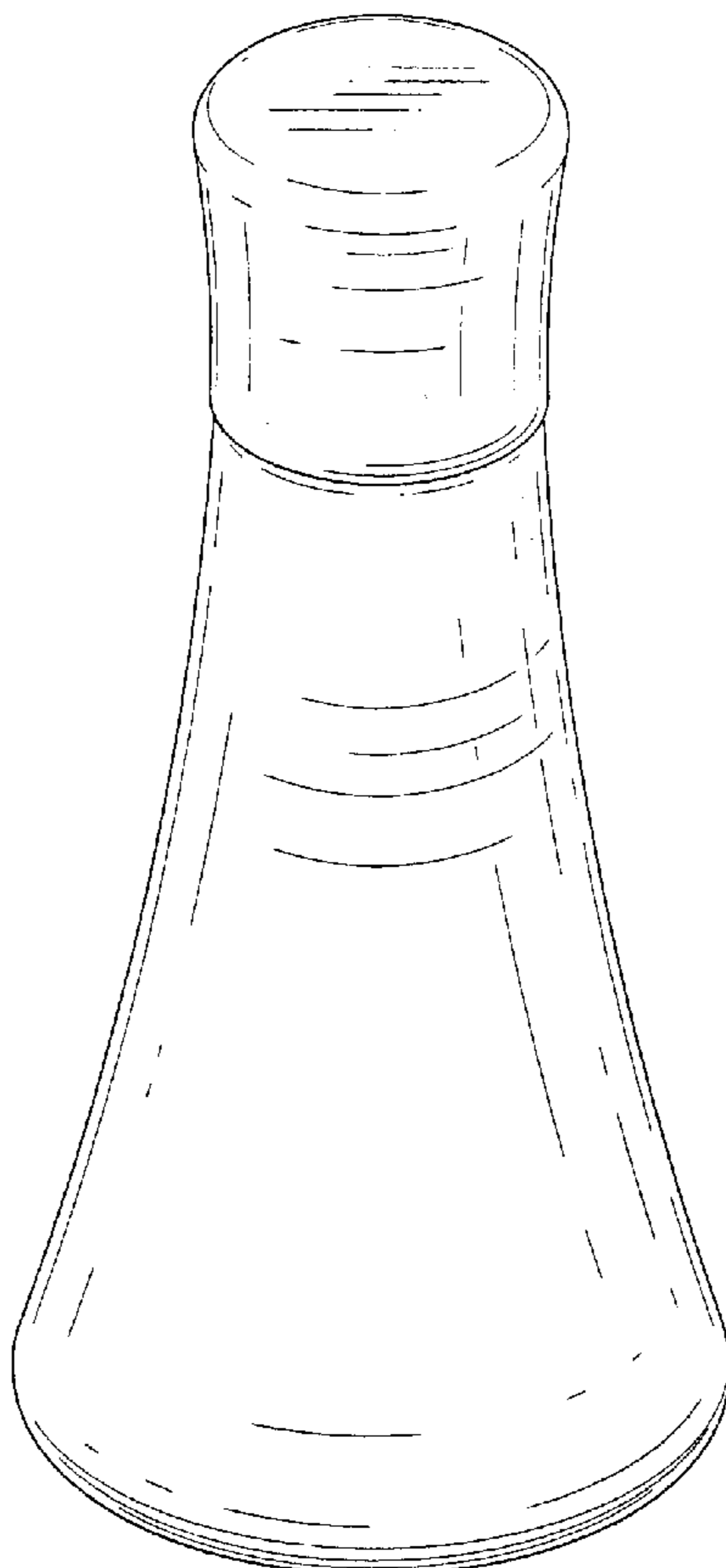
FIG. 1 is a perspective view of a container, embodying our new design;

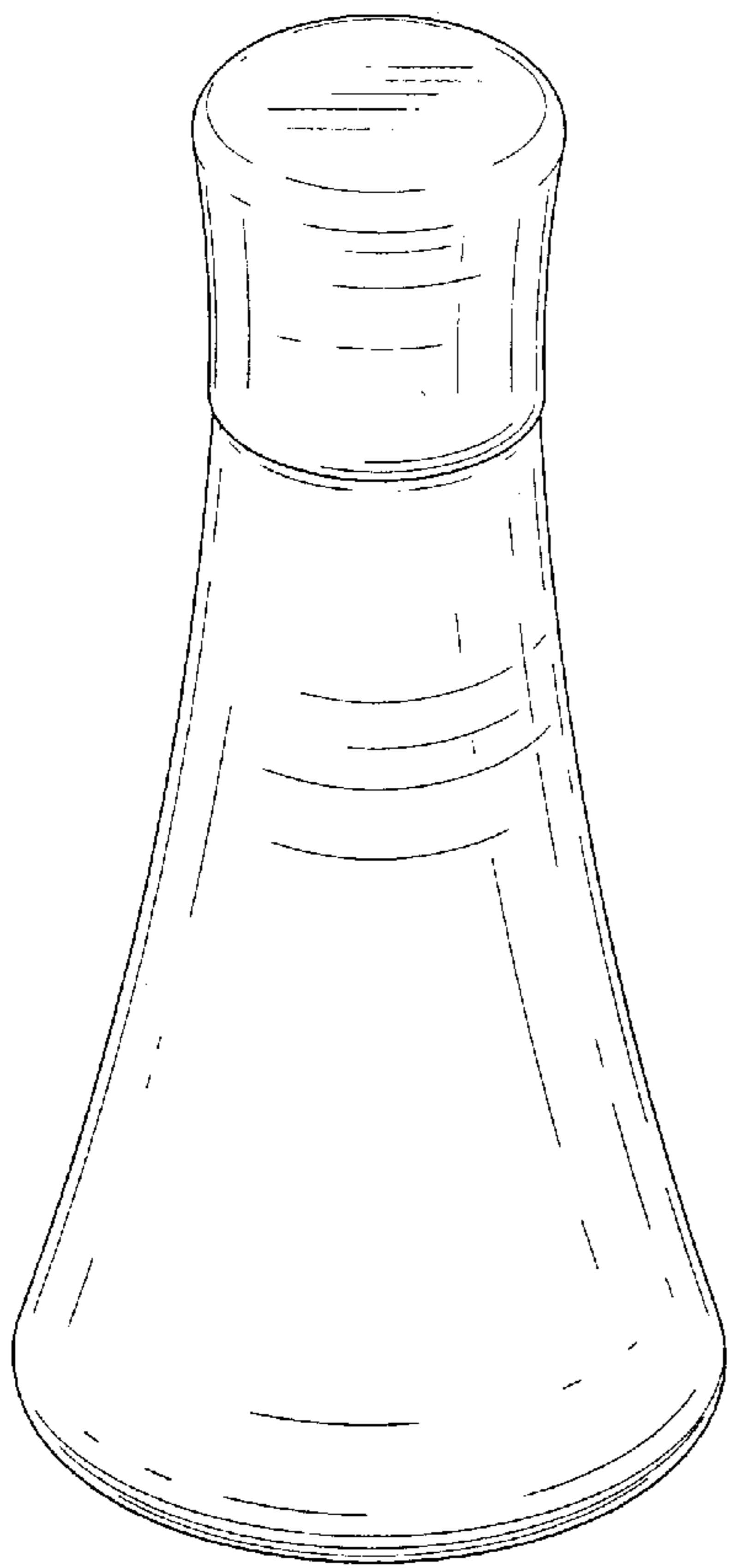

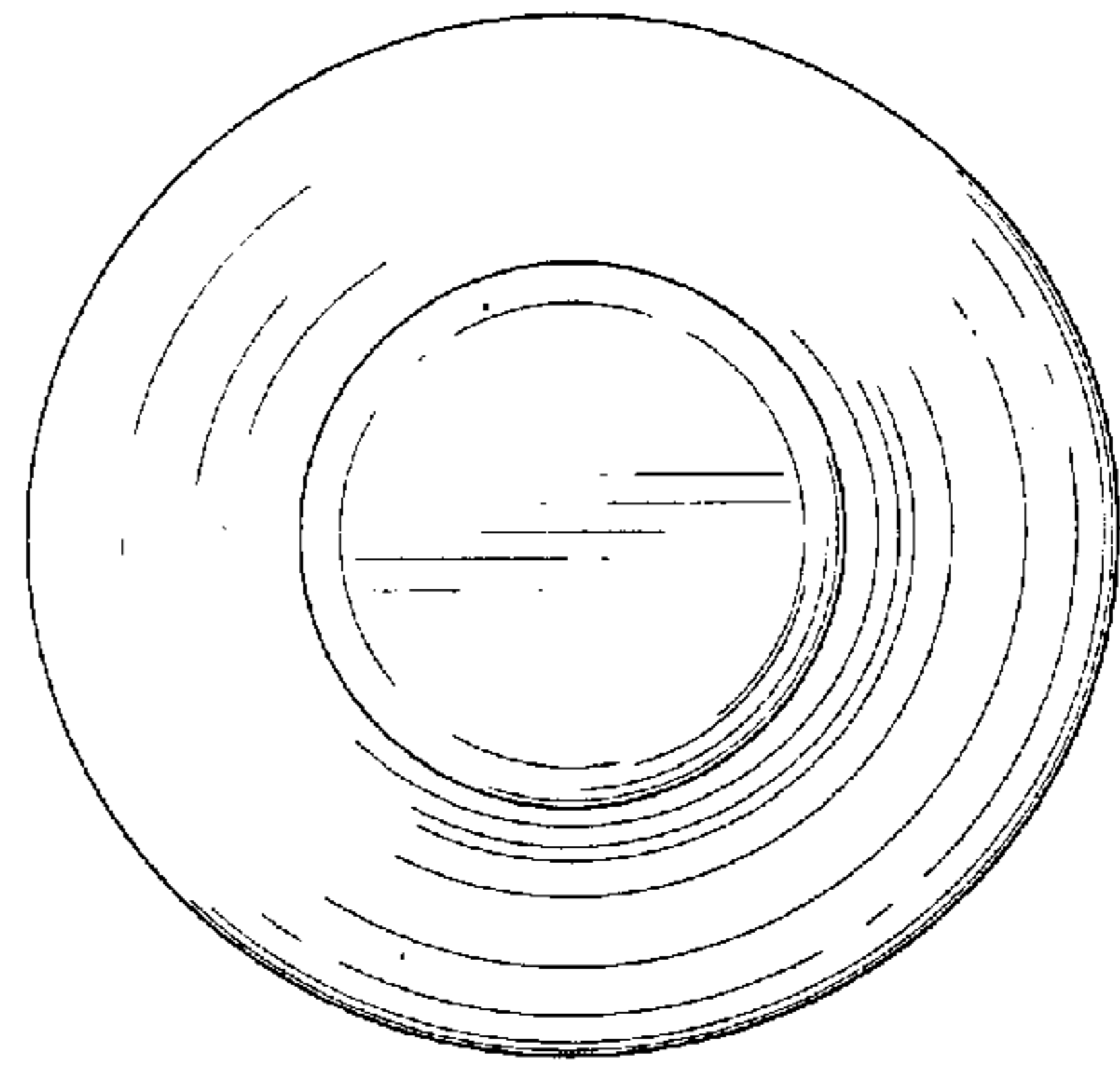

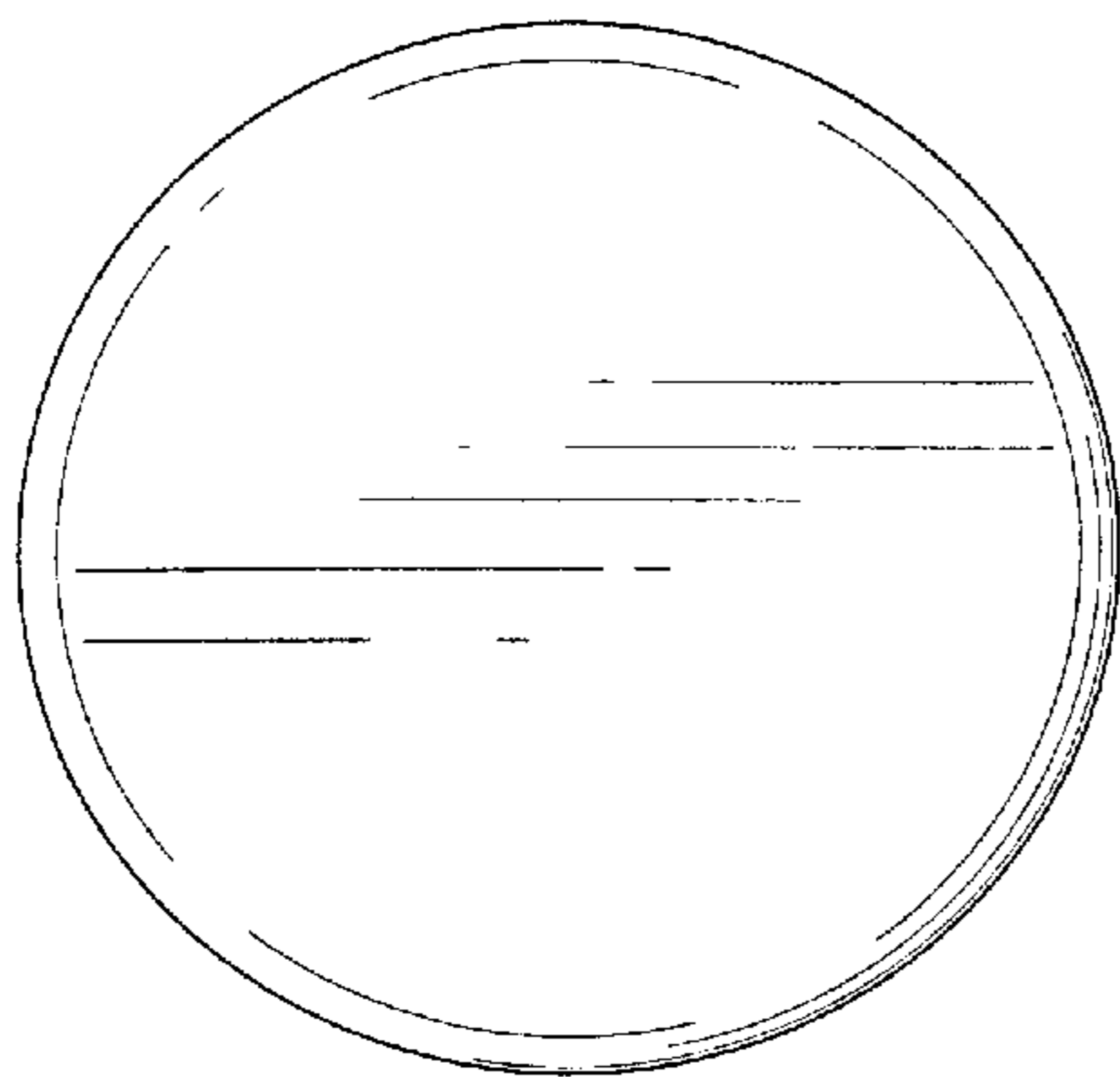

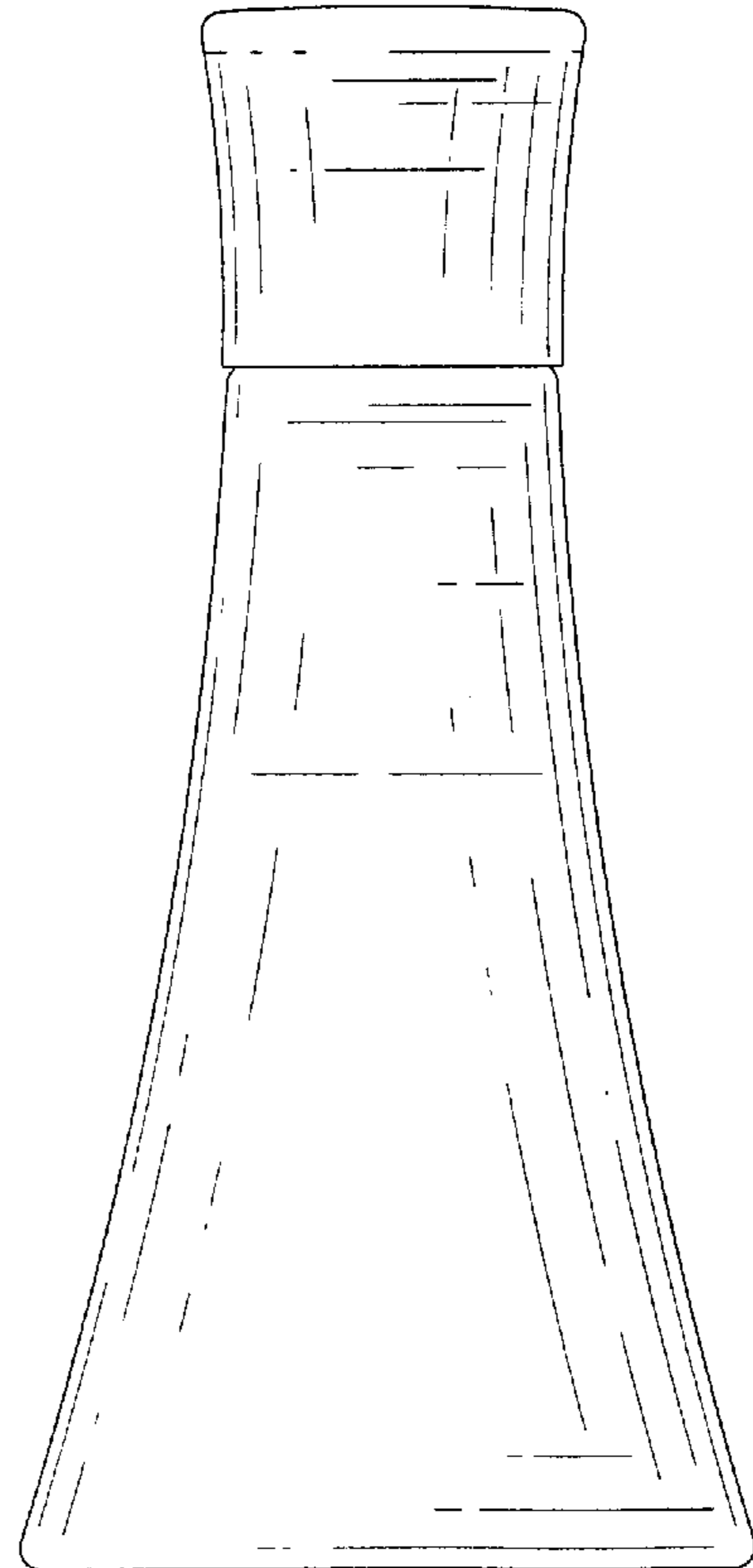
