The ornamental design for a bottle with handle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a bottle with handle showing our new design;

FIG. 2 is a front elevational view, the rear view being a mirror image thereof;

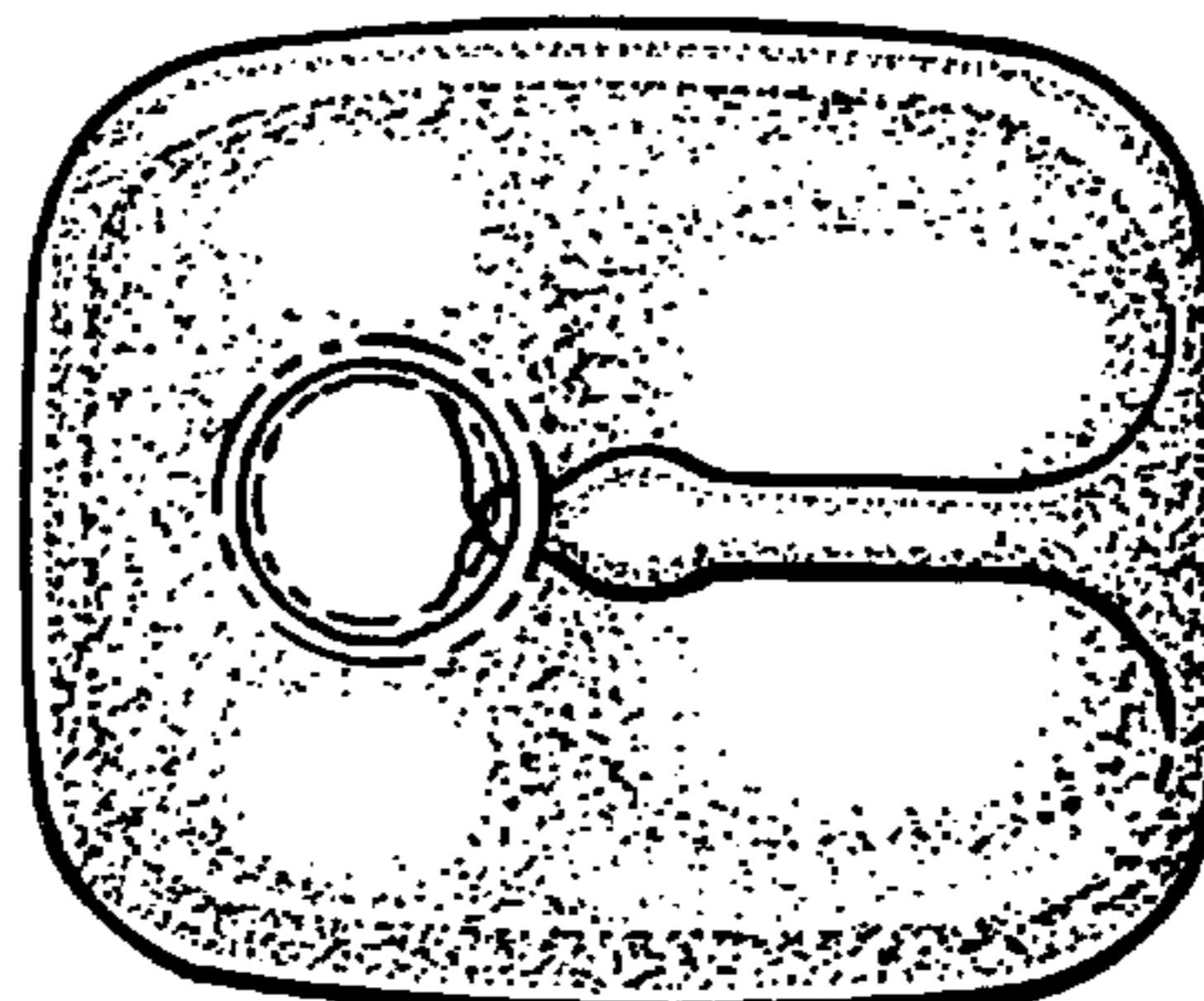
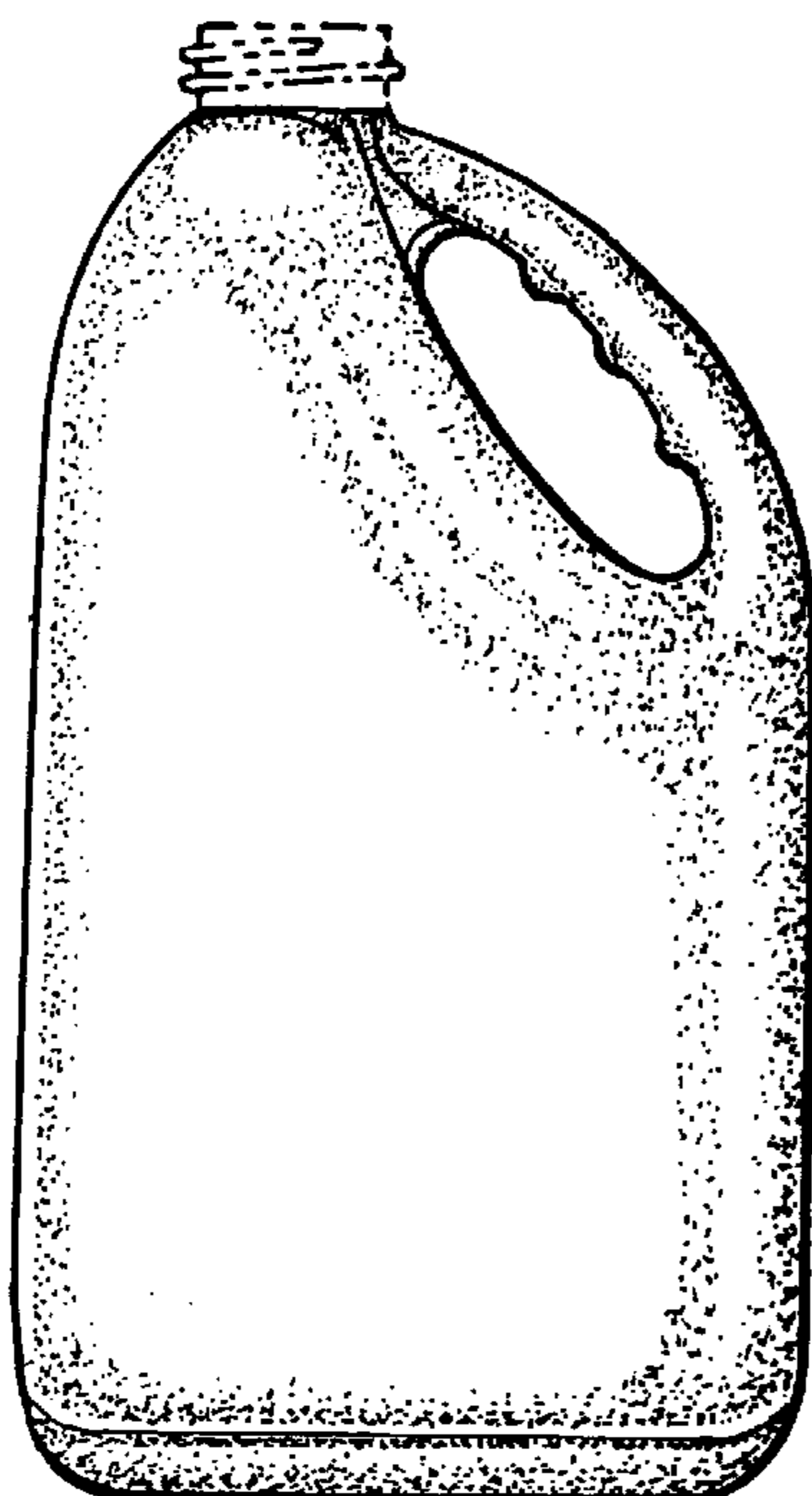
FIG. 3 is a side elevational view taken from the right in FIG. 2;

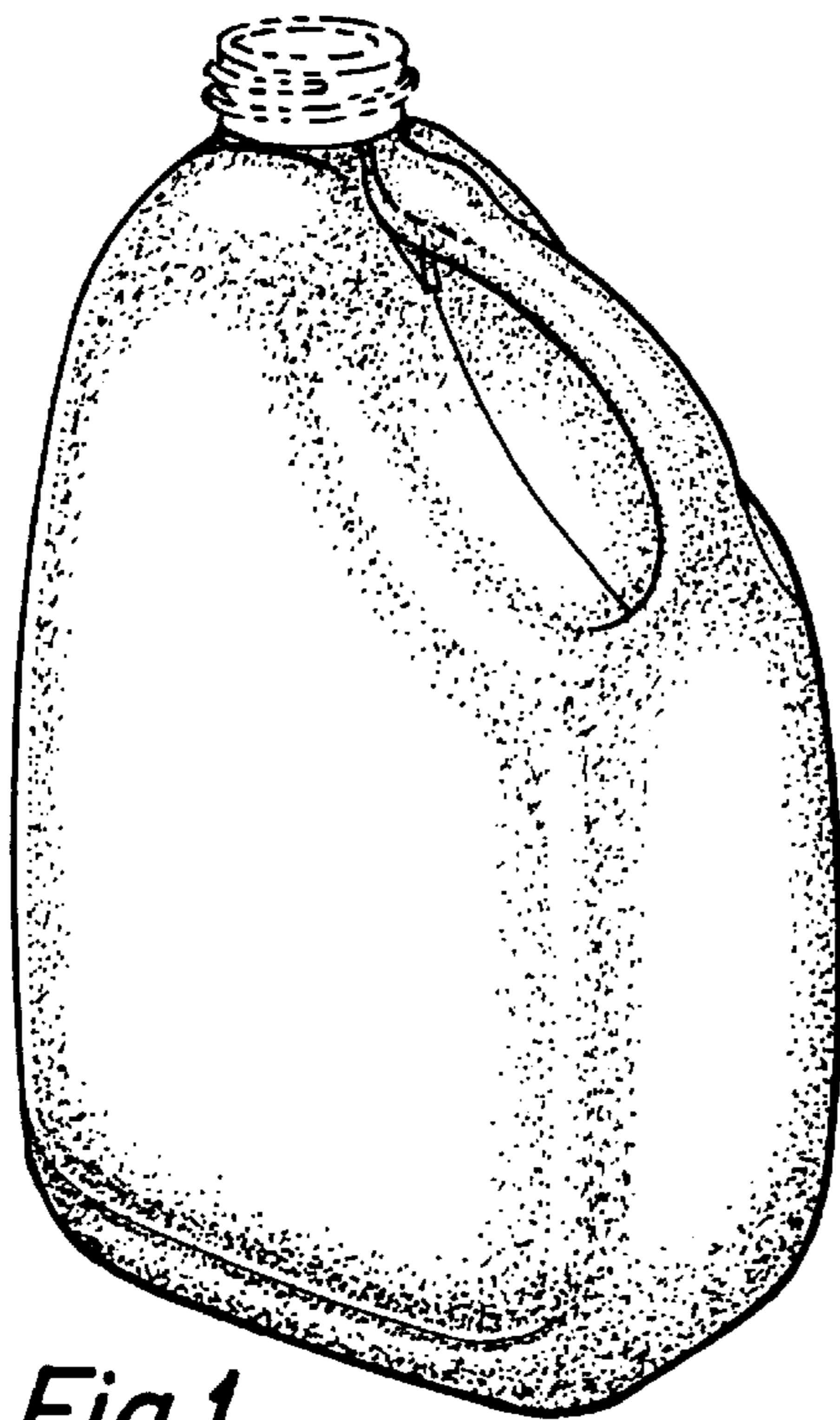

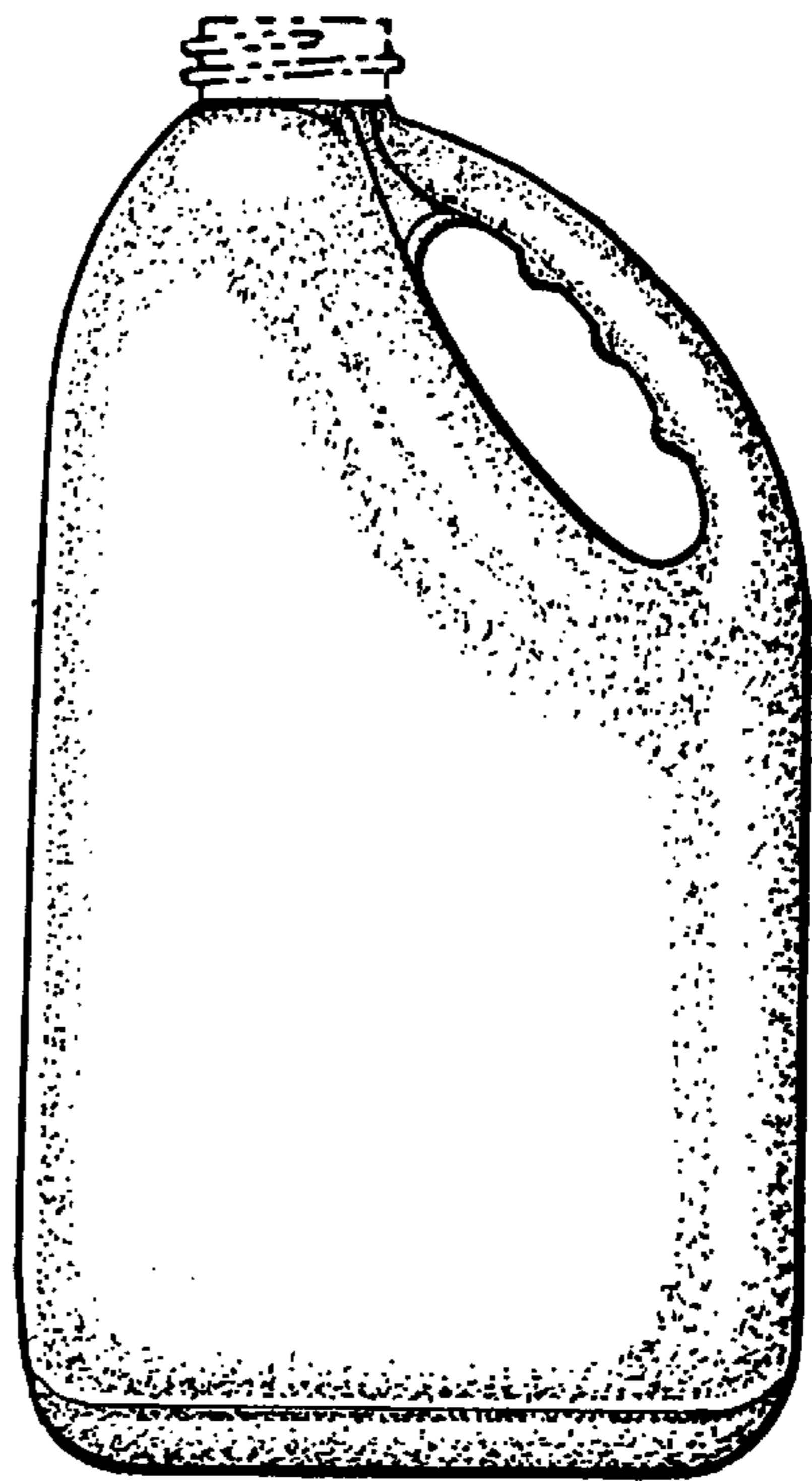

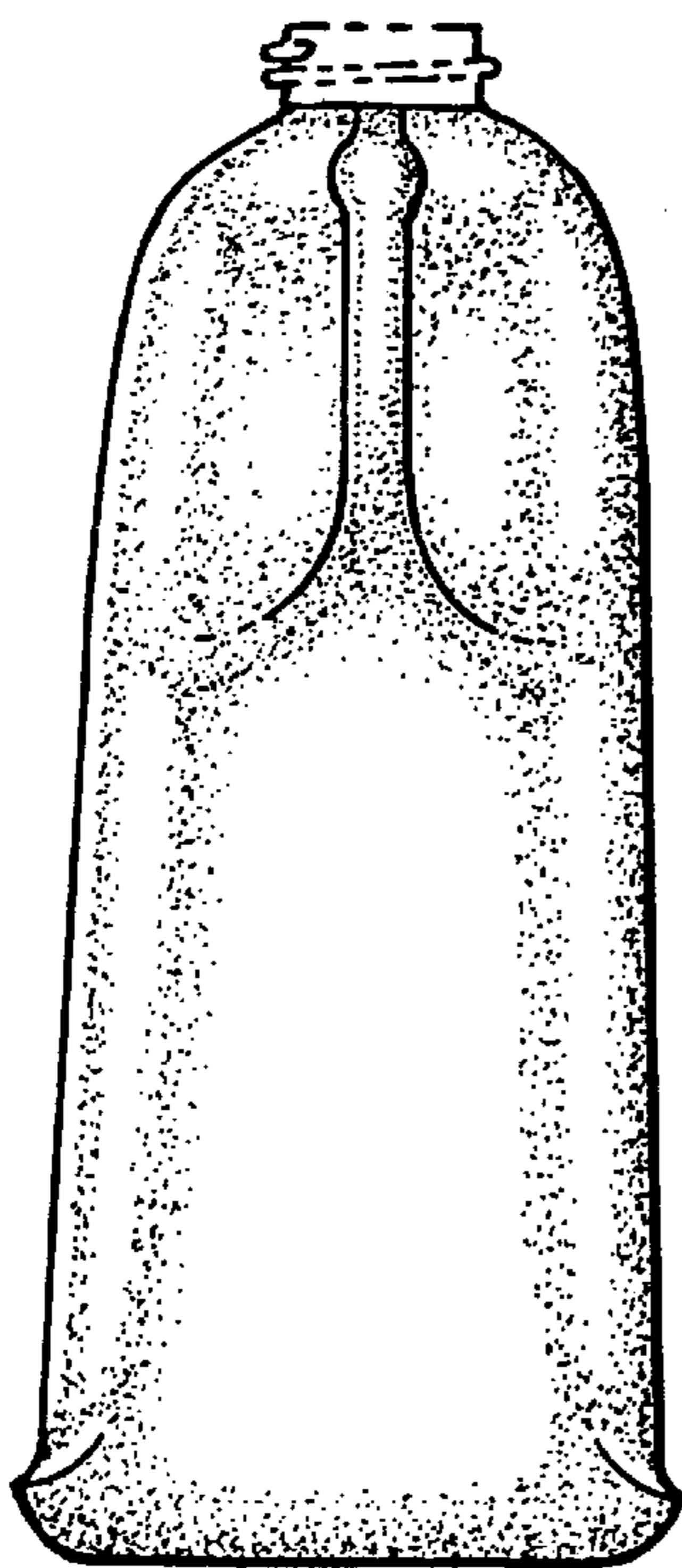

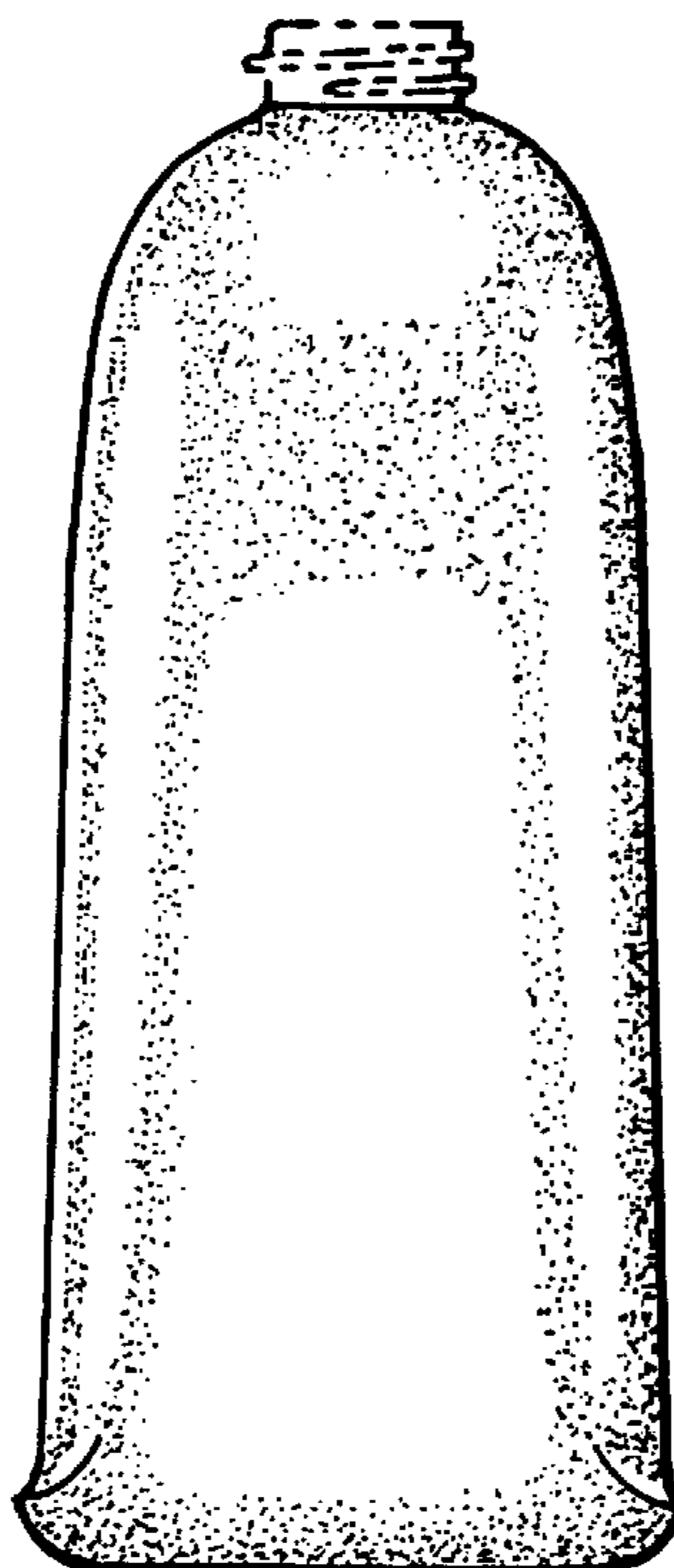

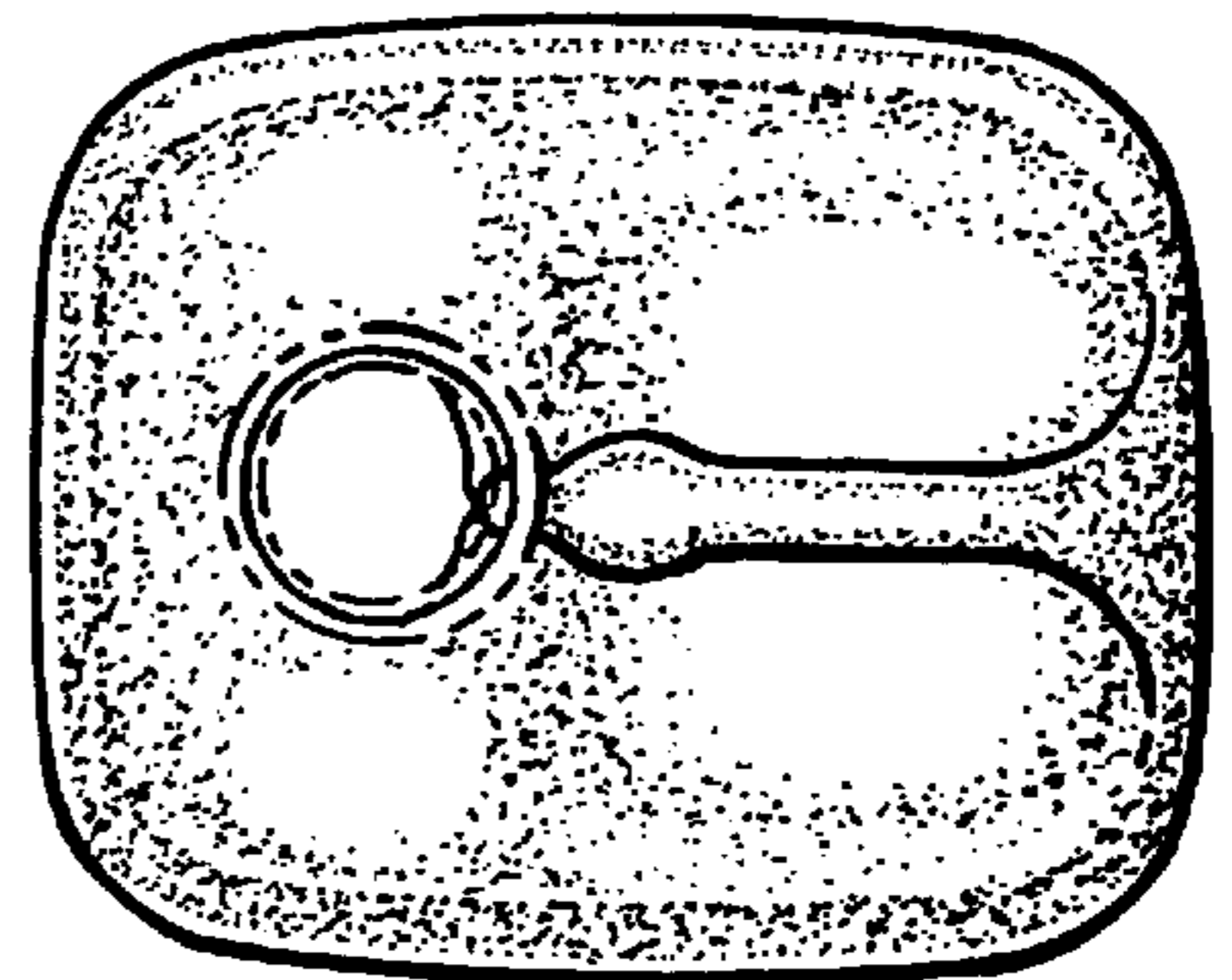
