(57) **CLAIM**

I claim the ornamental design for a display device, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of the ornamental display device;

FIG. 2 is a top view of the first embodiment, the bottom view being substantially a mirror image of the top view;

FIG. 3 is a front view of the first embodiment, the back view being substantially a mirror image of the front view;

FIG. 4 is a left side view of the first embodiment, the right side view being substantially a mirror image of the left side view;

FIG. 5 is a perspective view of a second embodiment of the ornamental display device;

FIG. 6 is a top view of the second embodiment, the bottom view being substantially a mirror image of the top view;

FIG. 7 is a front view of the second embodiment, the back view being substantially a mirror image of the front view;

FIG. 8 is a left side view of the second embodiment, the right side view being substantially a mirror image of the left side view;

FIG. 9 is a perspective view of a third embodiment of the ornamental display device;

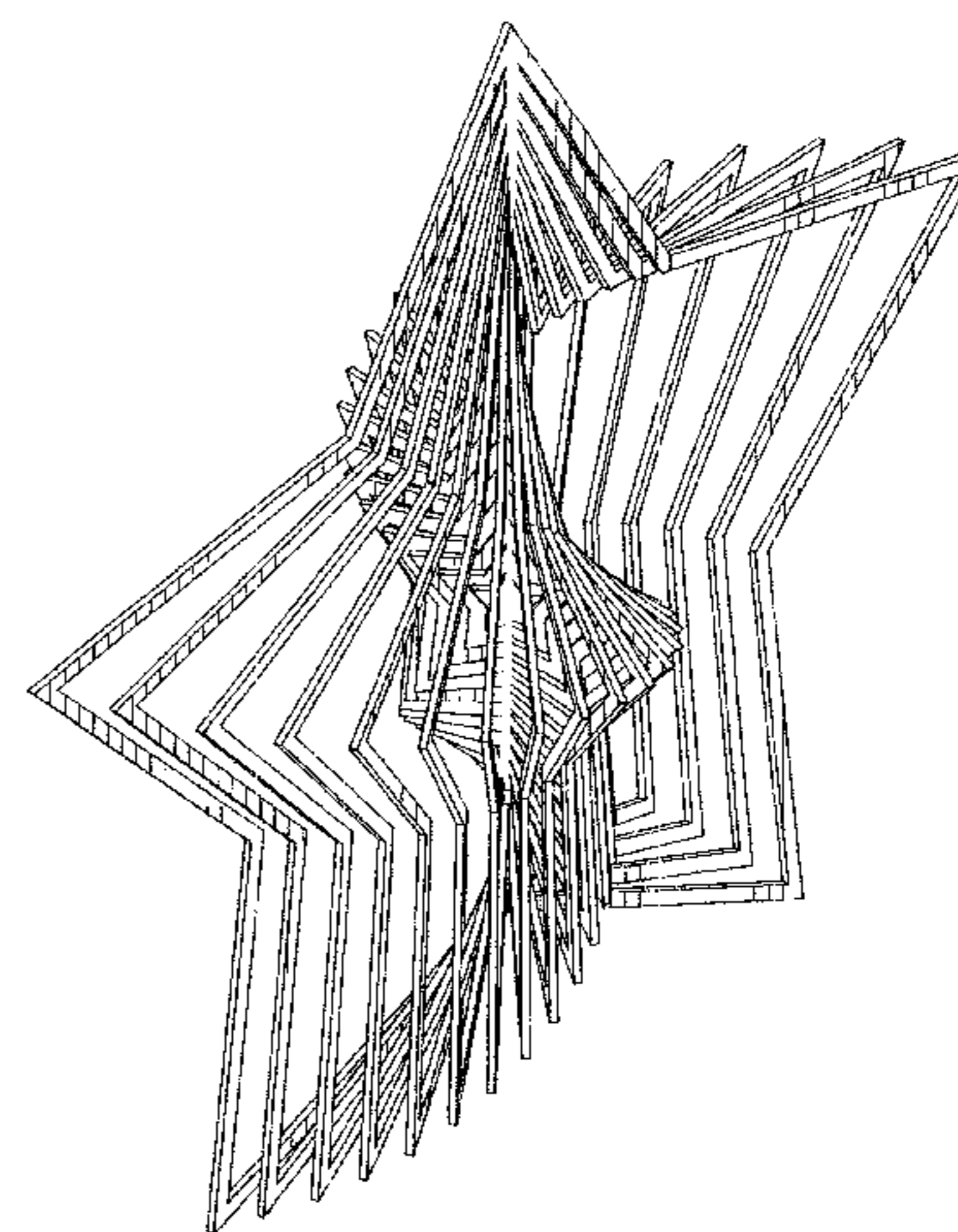
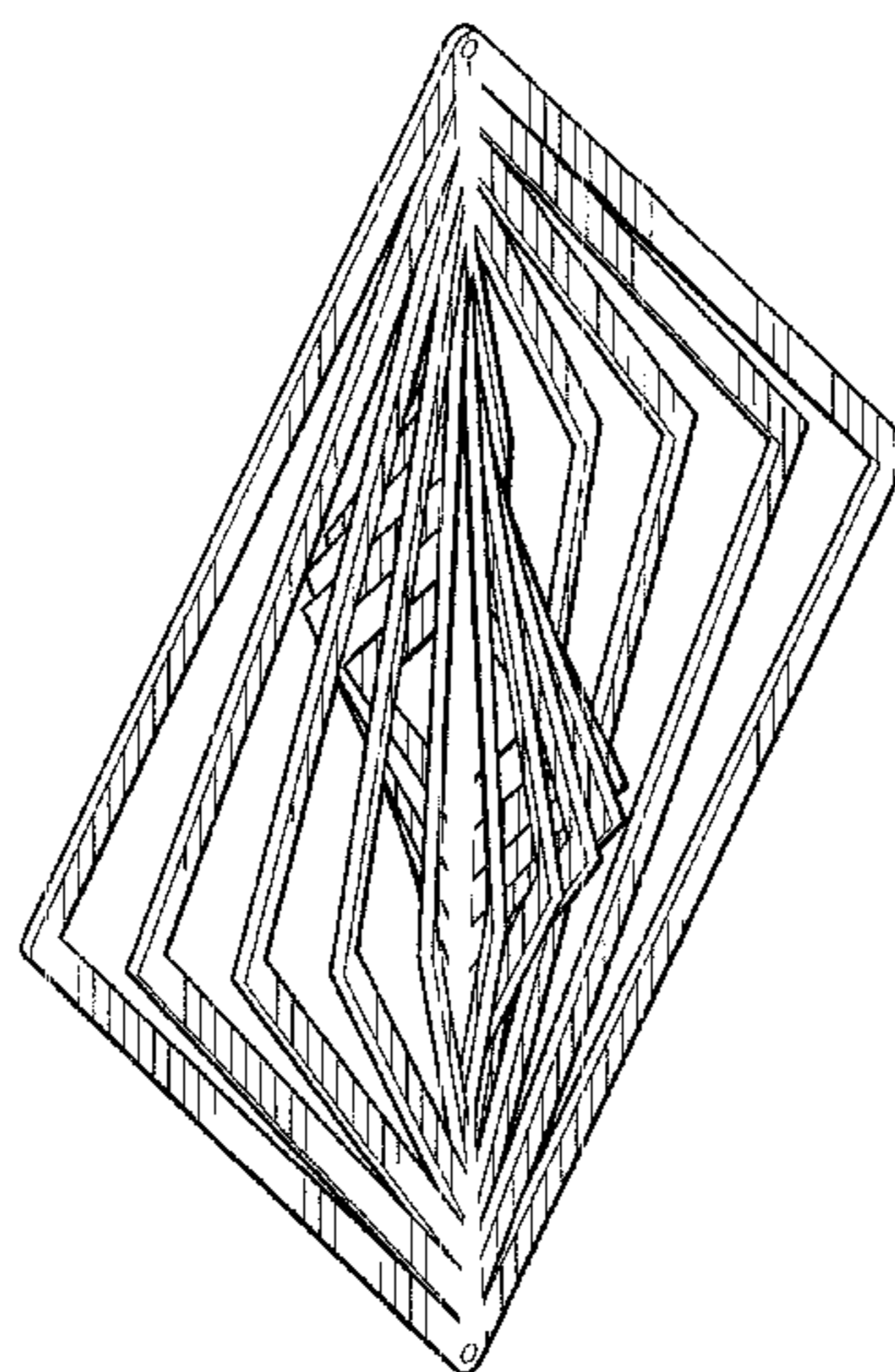
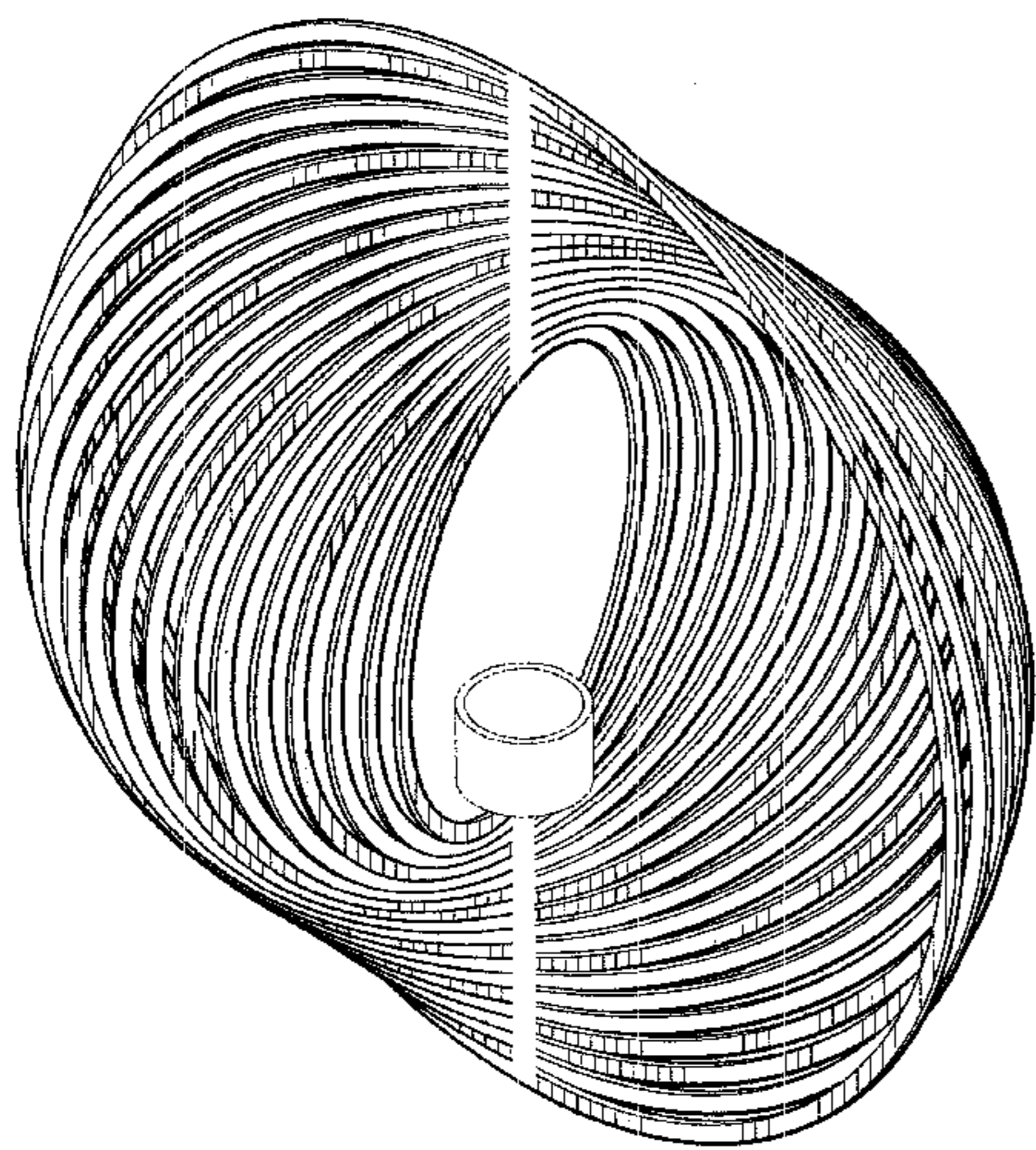
FIG. 10 is a top view of the third embodiment, the bottom view being substantially a mirror image of the top view;

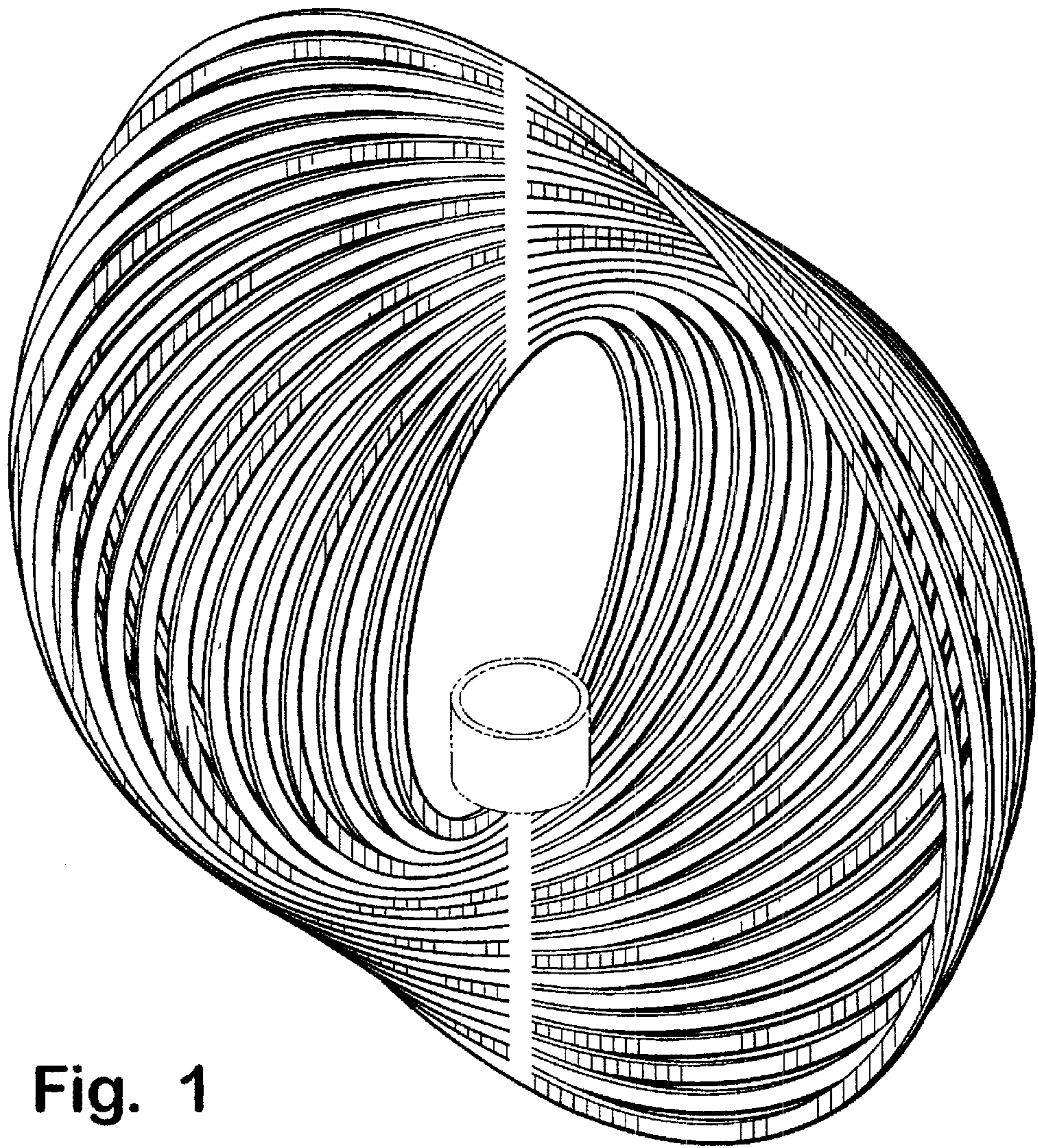

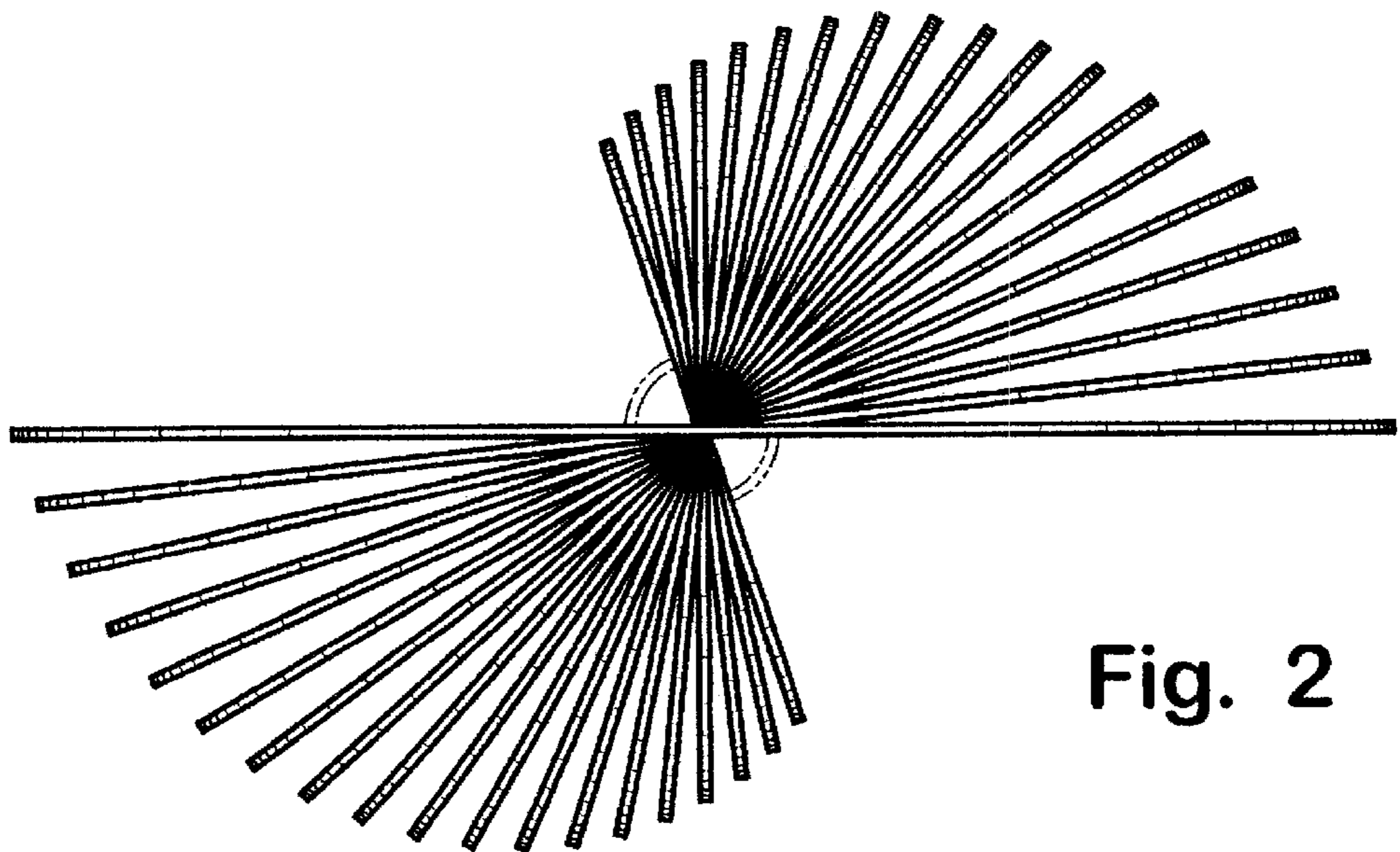

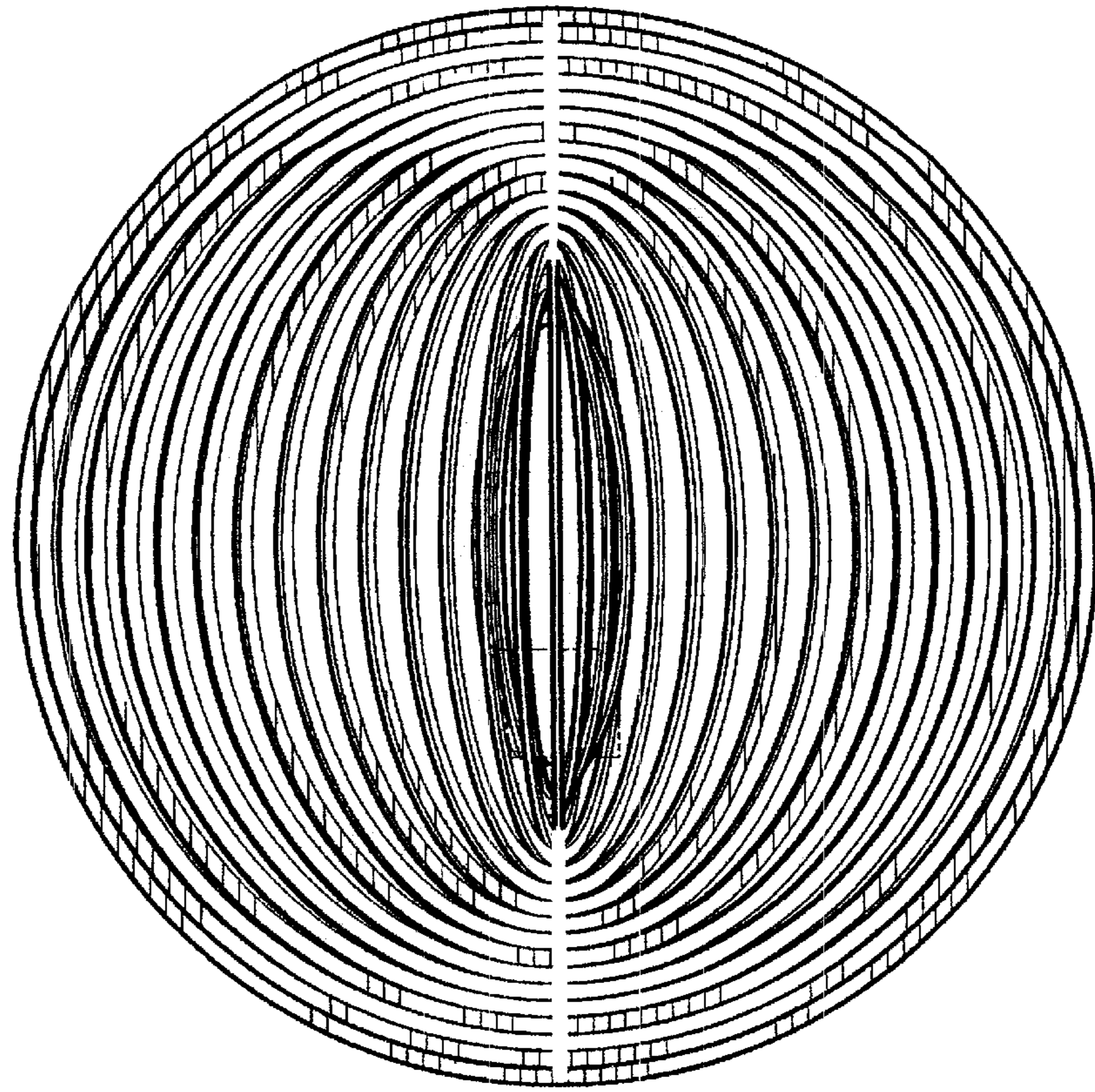

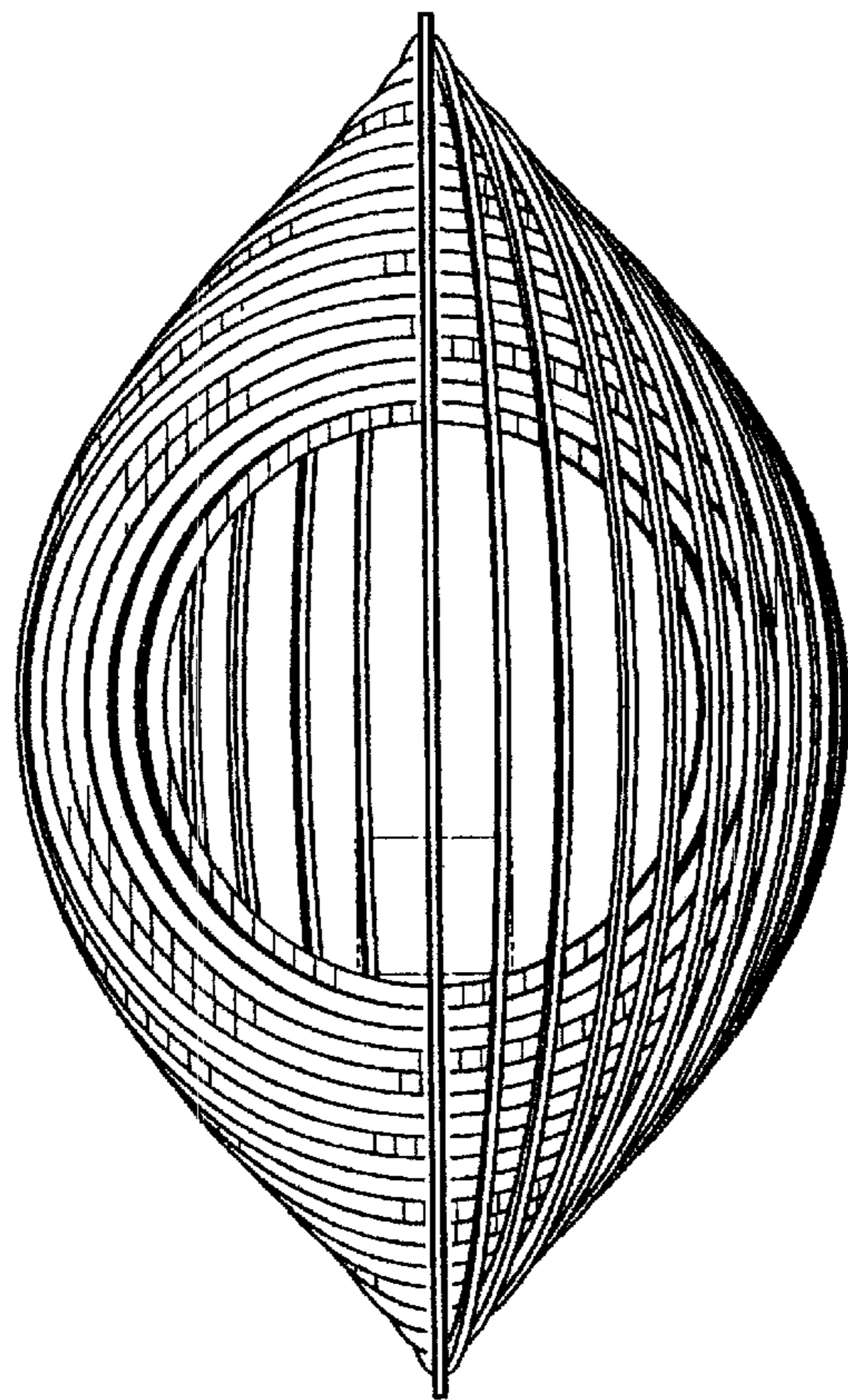

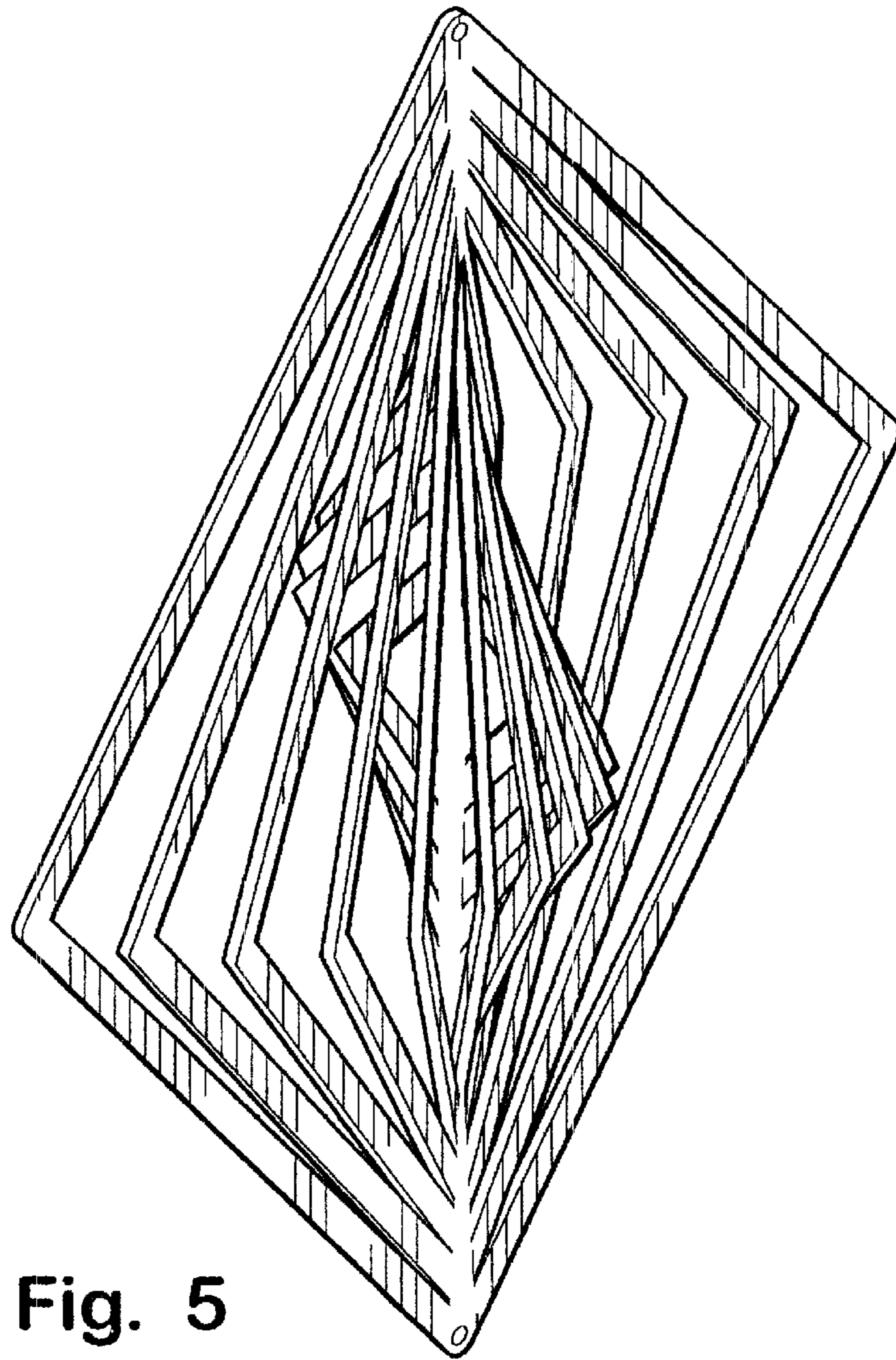

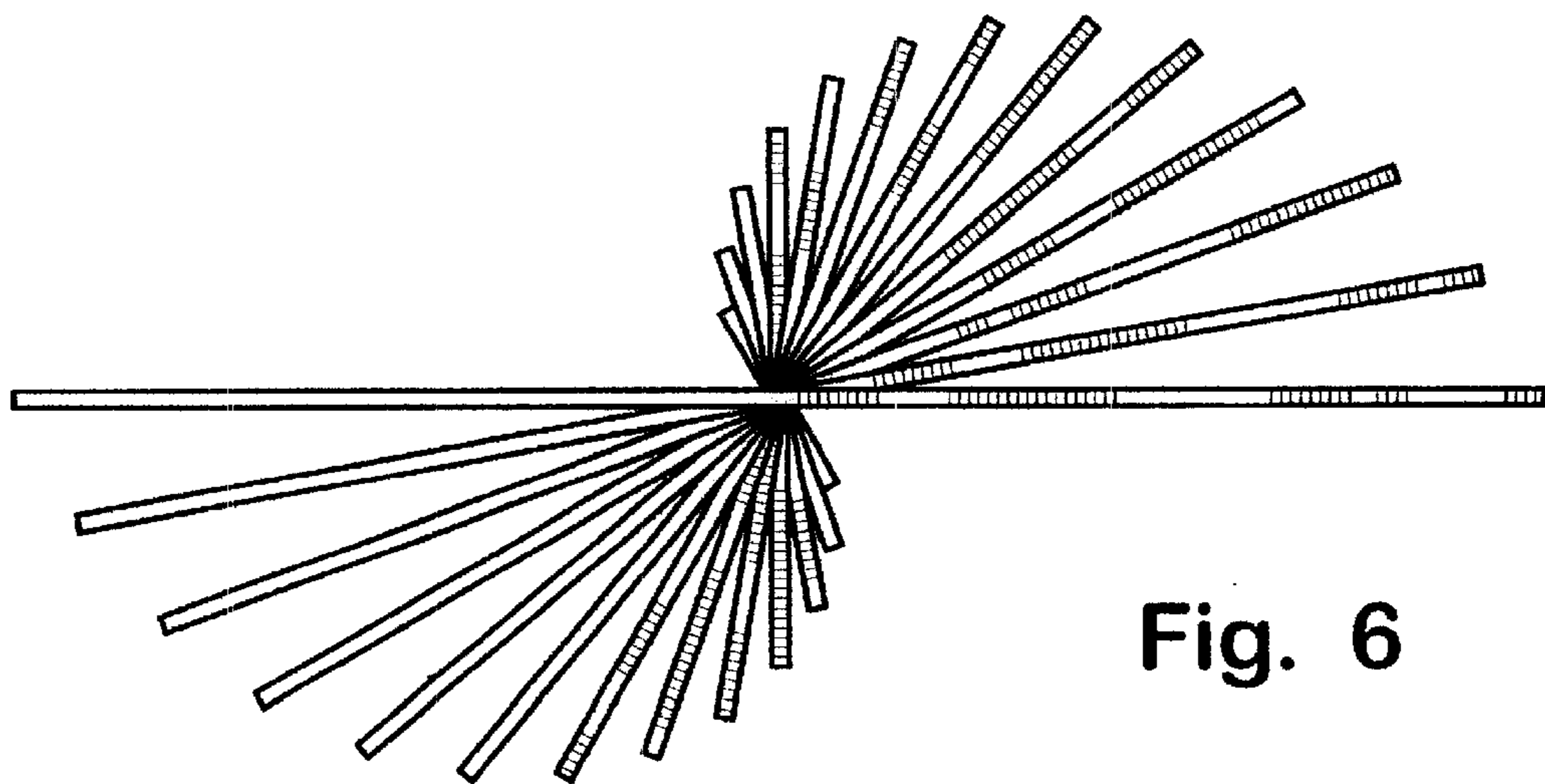

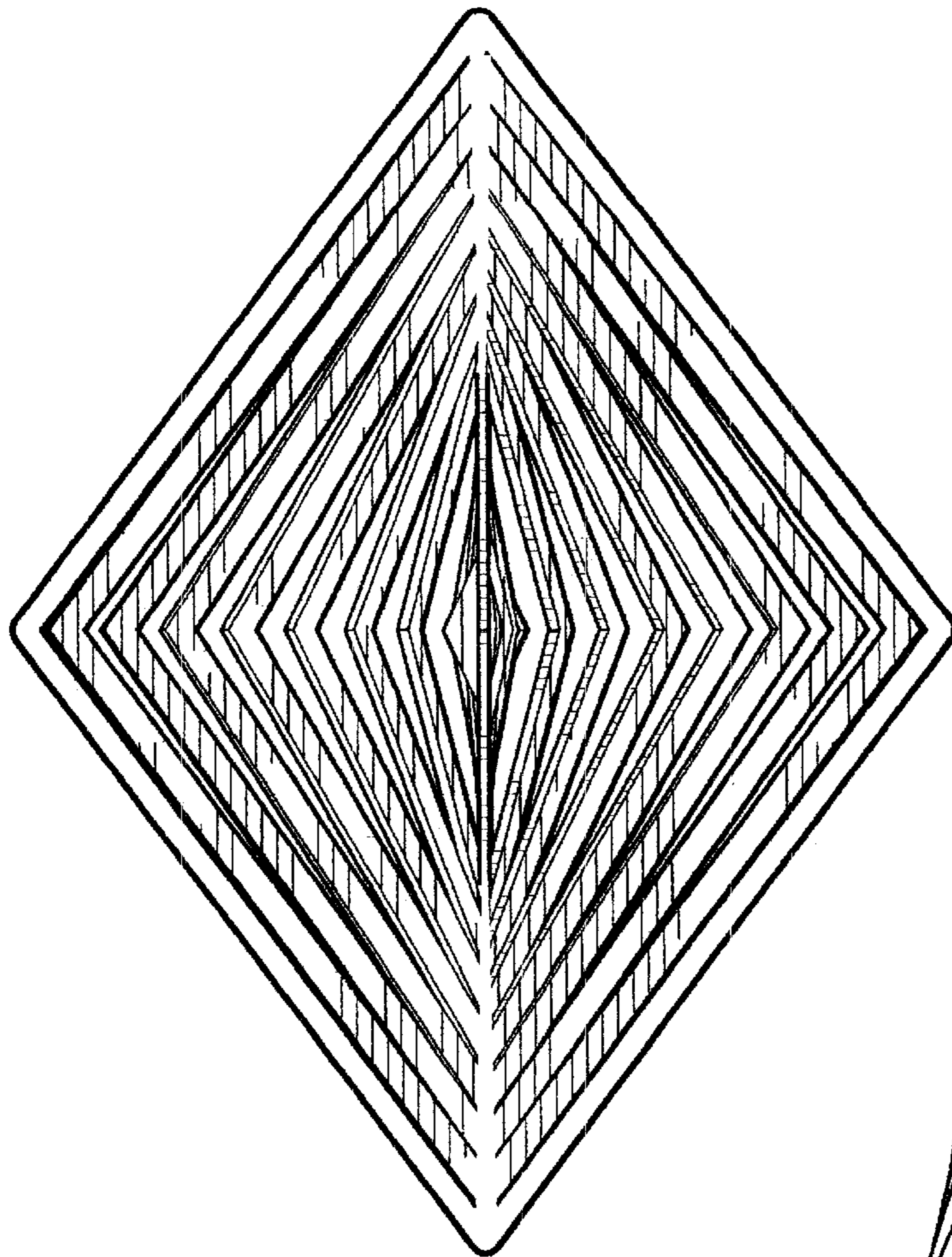

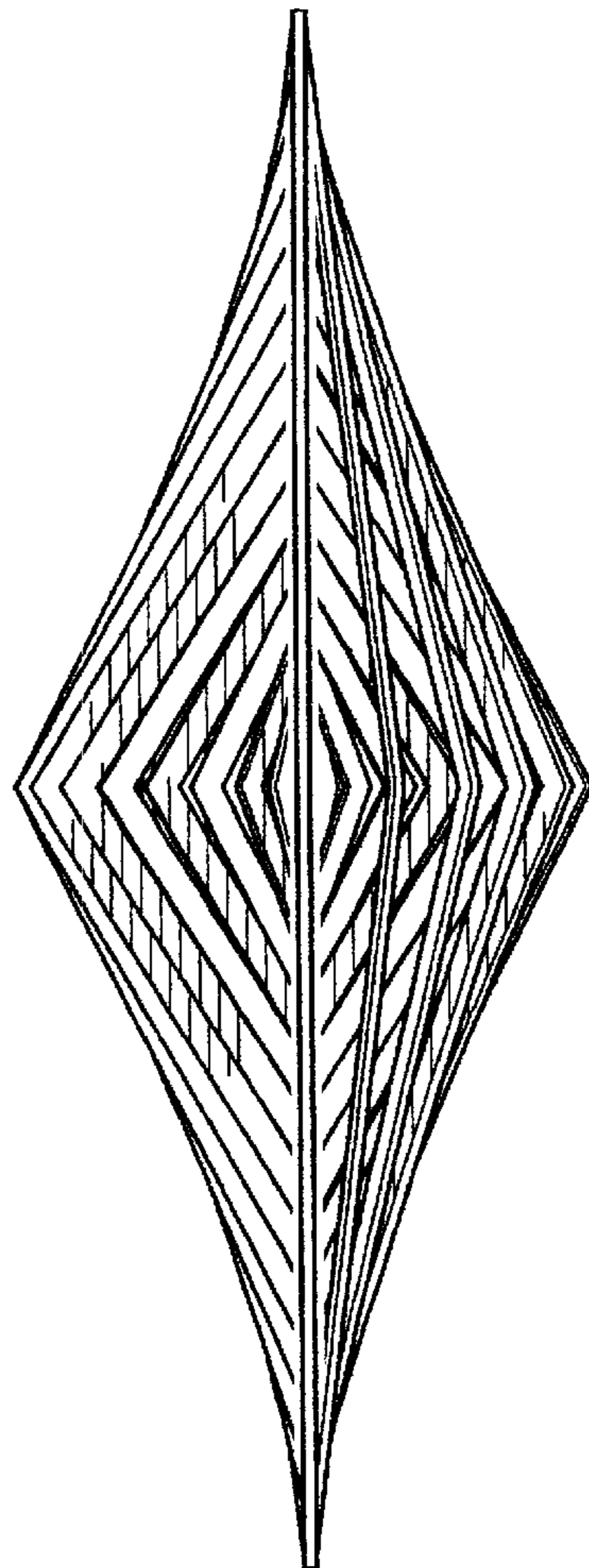

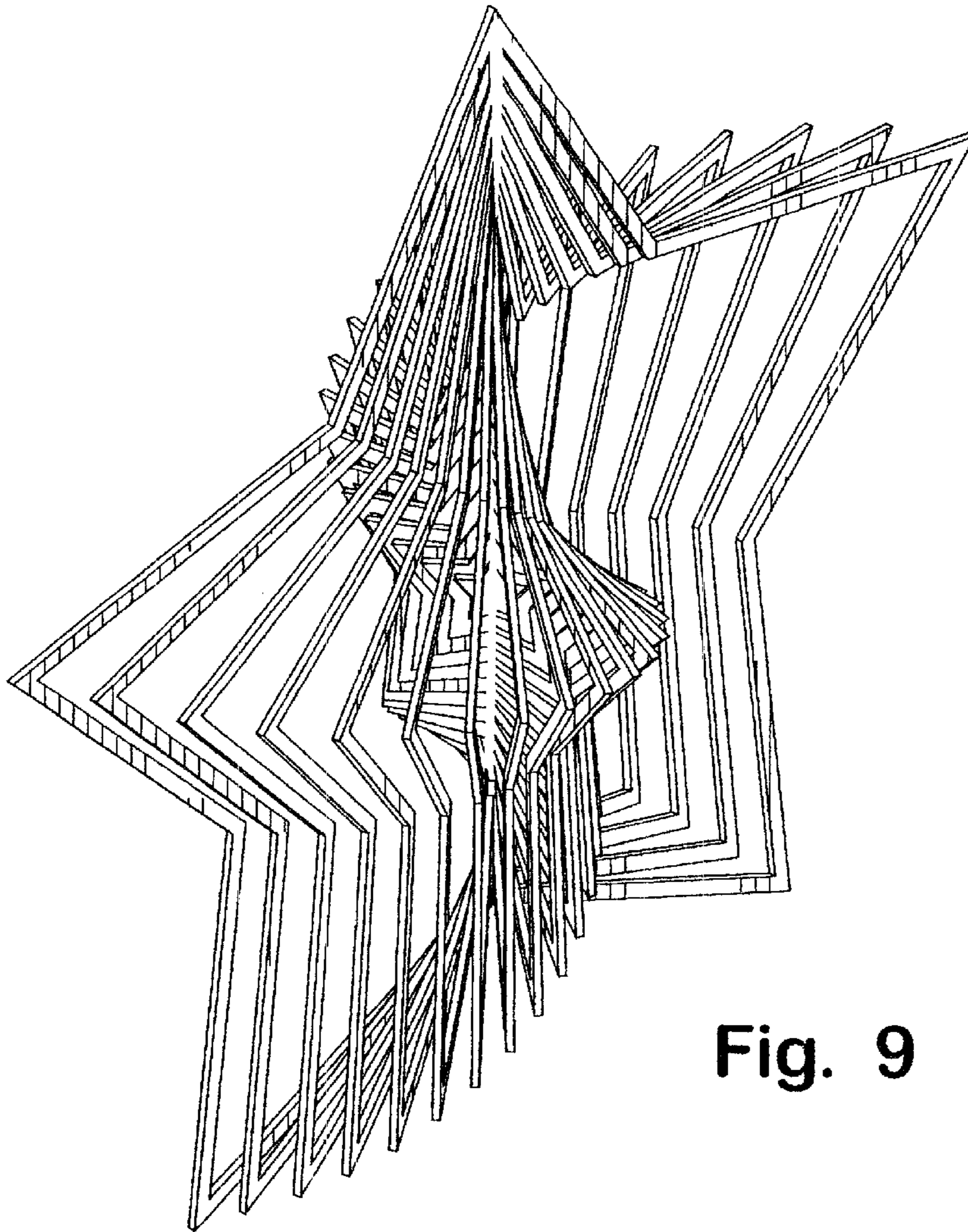

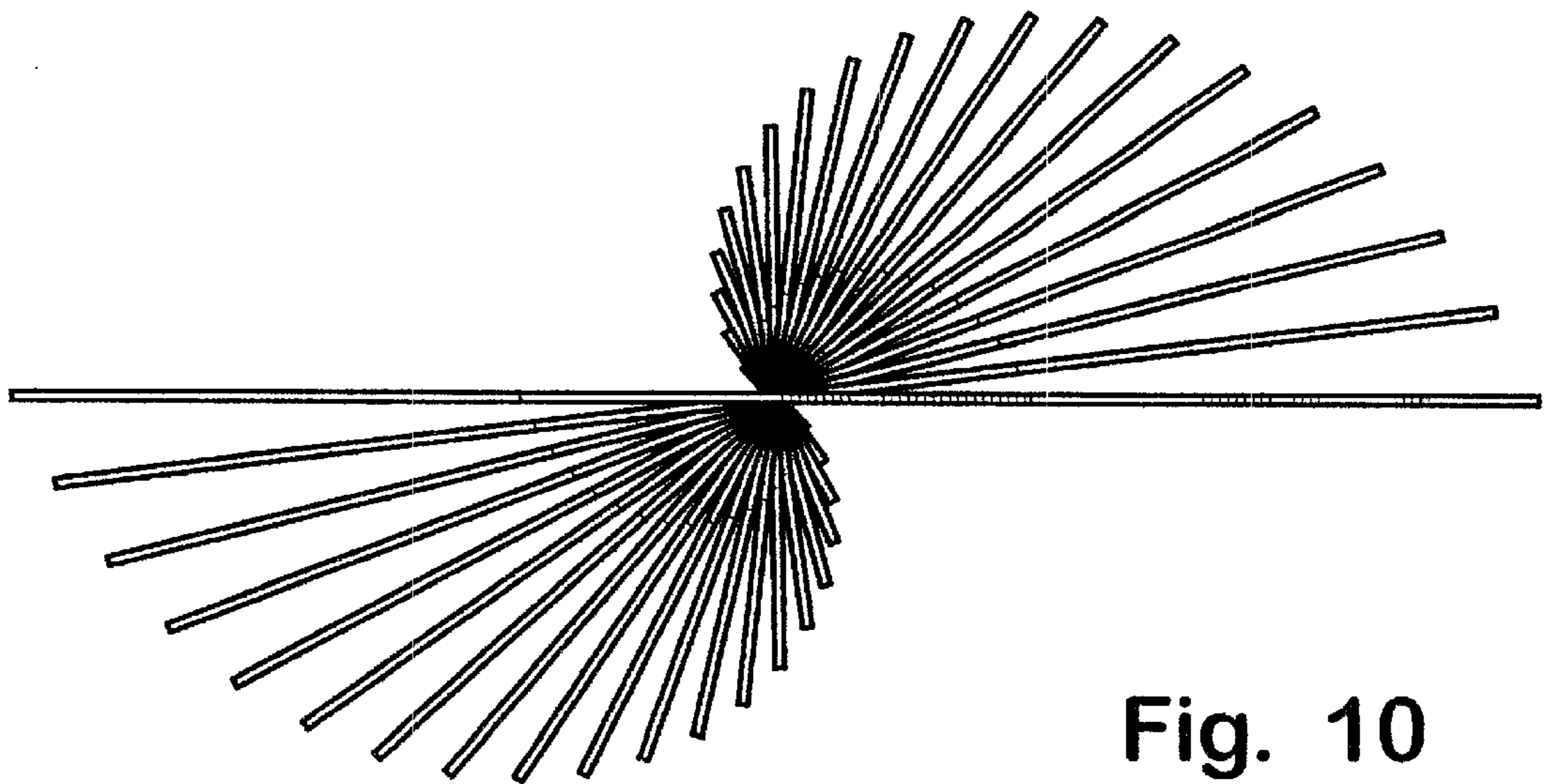

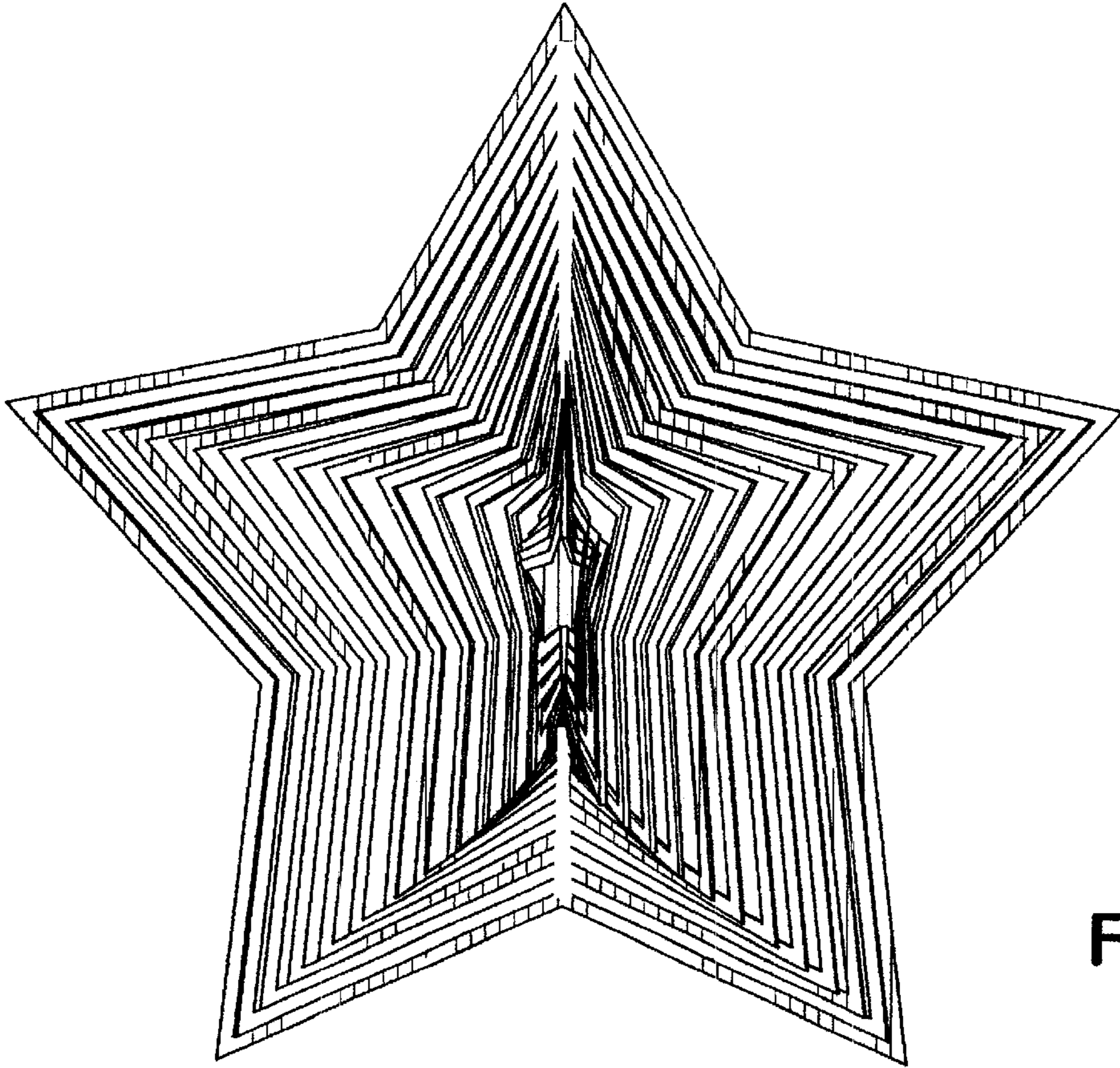

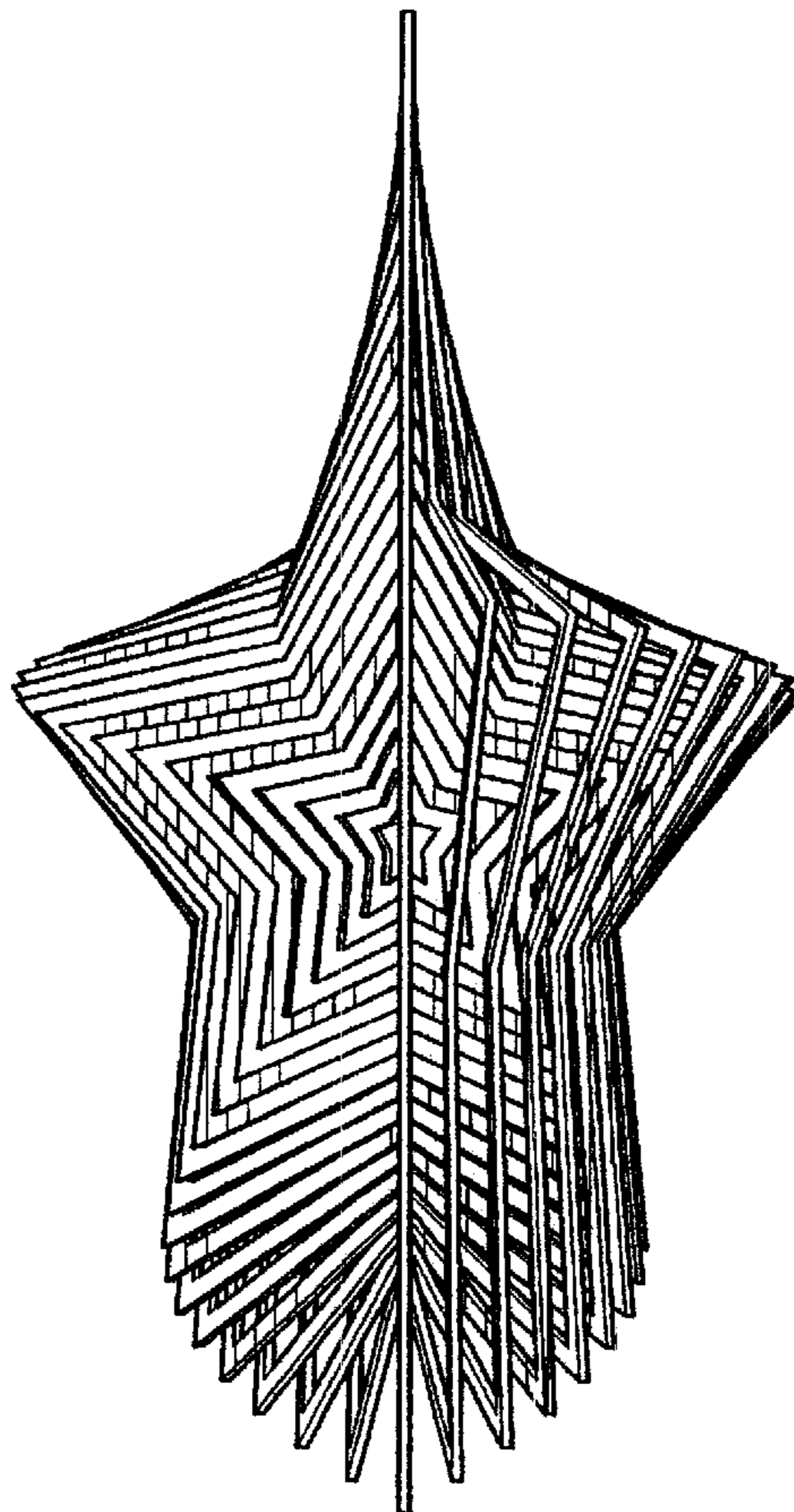
