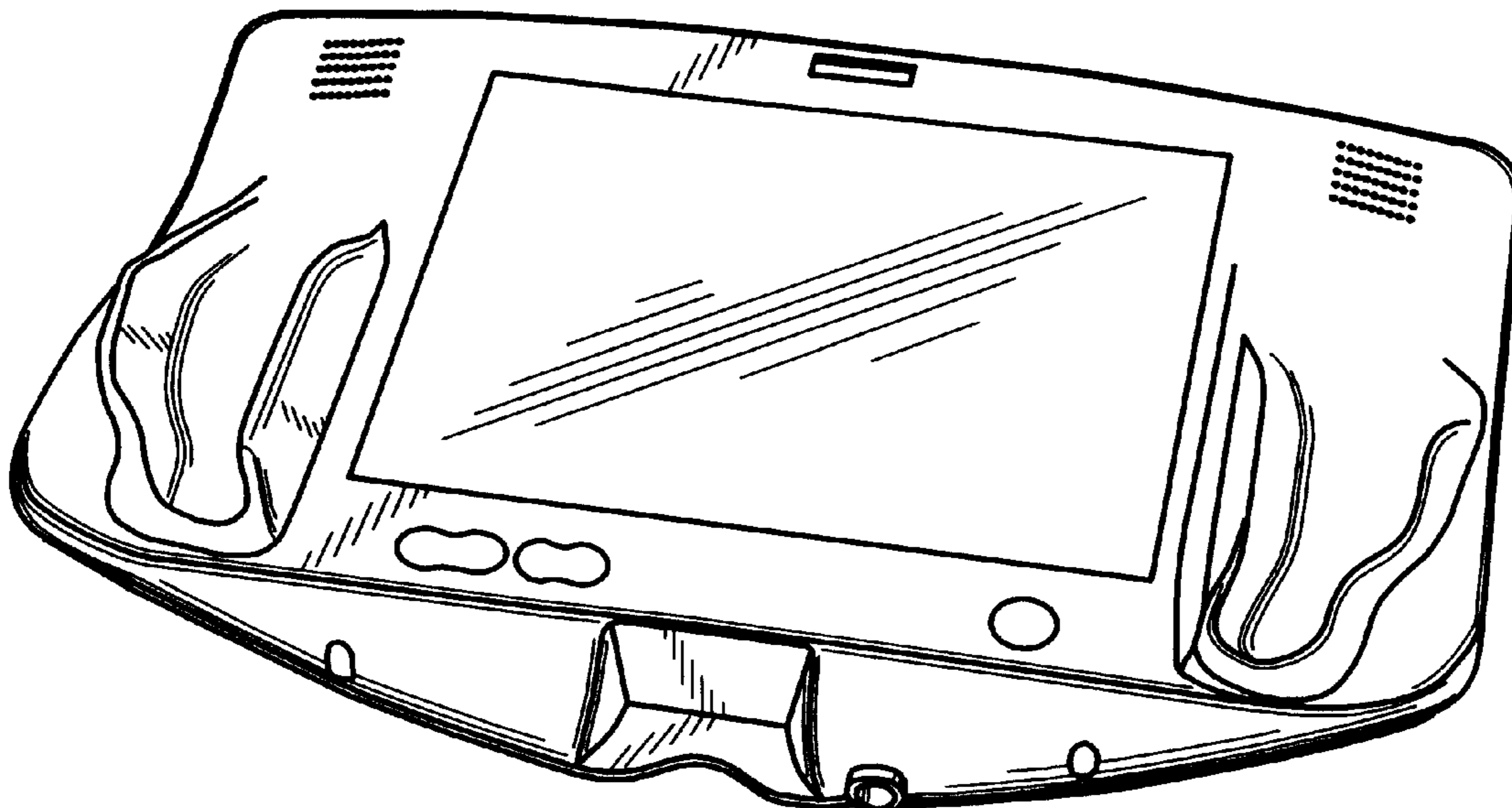

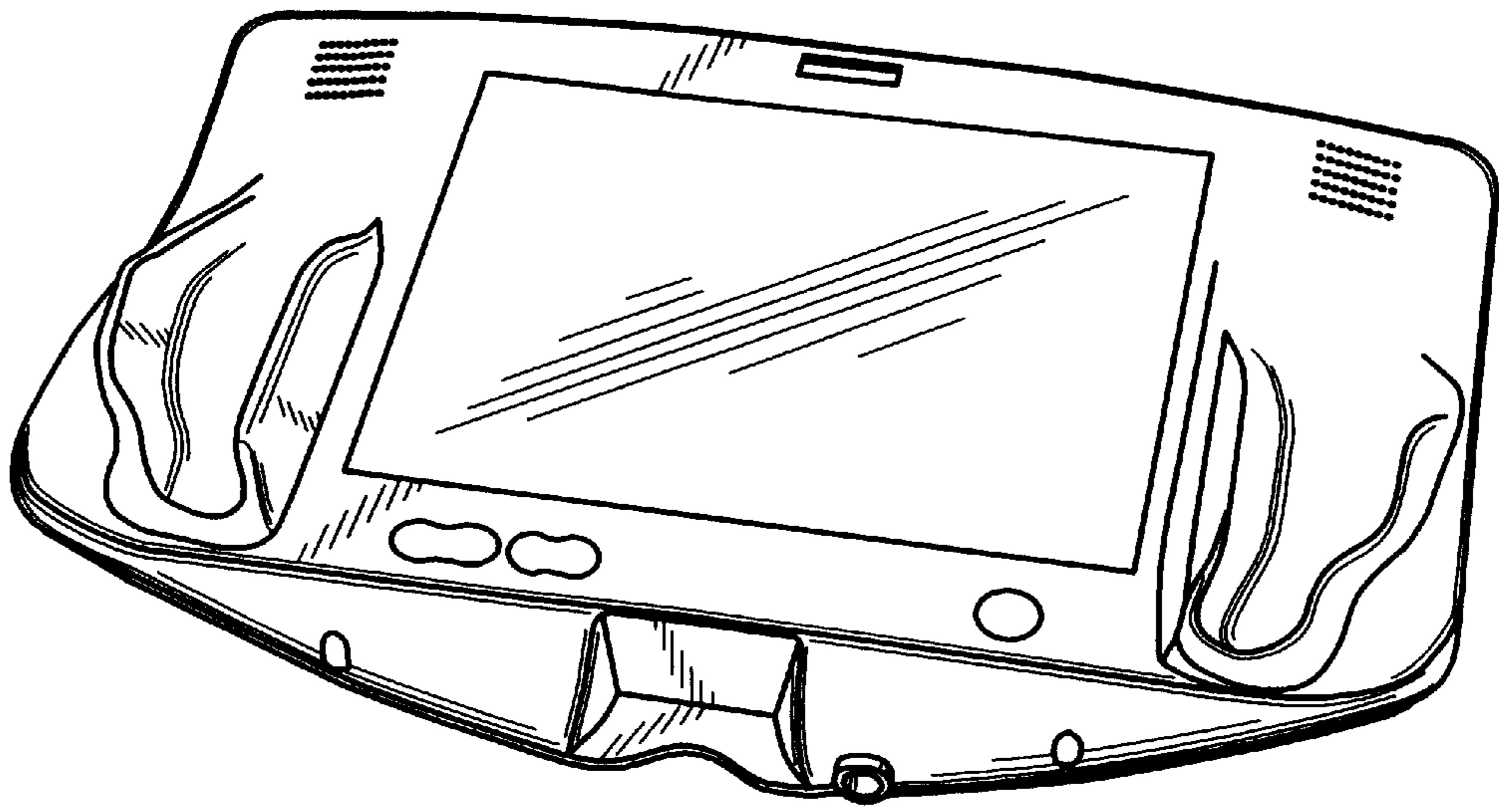
I claim the ornamental design for a communication center with display, as shown and described.

**DESCRIPTION**

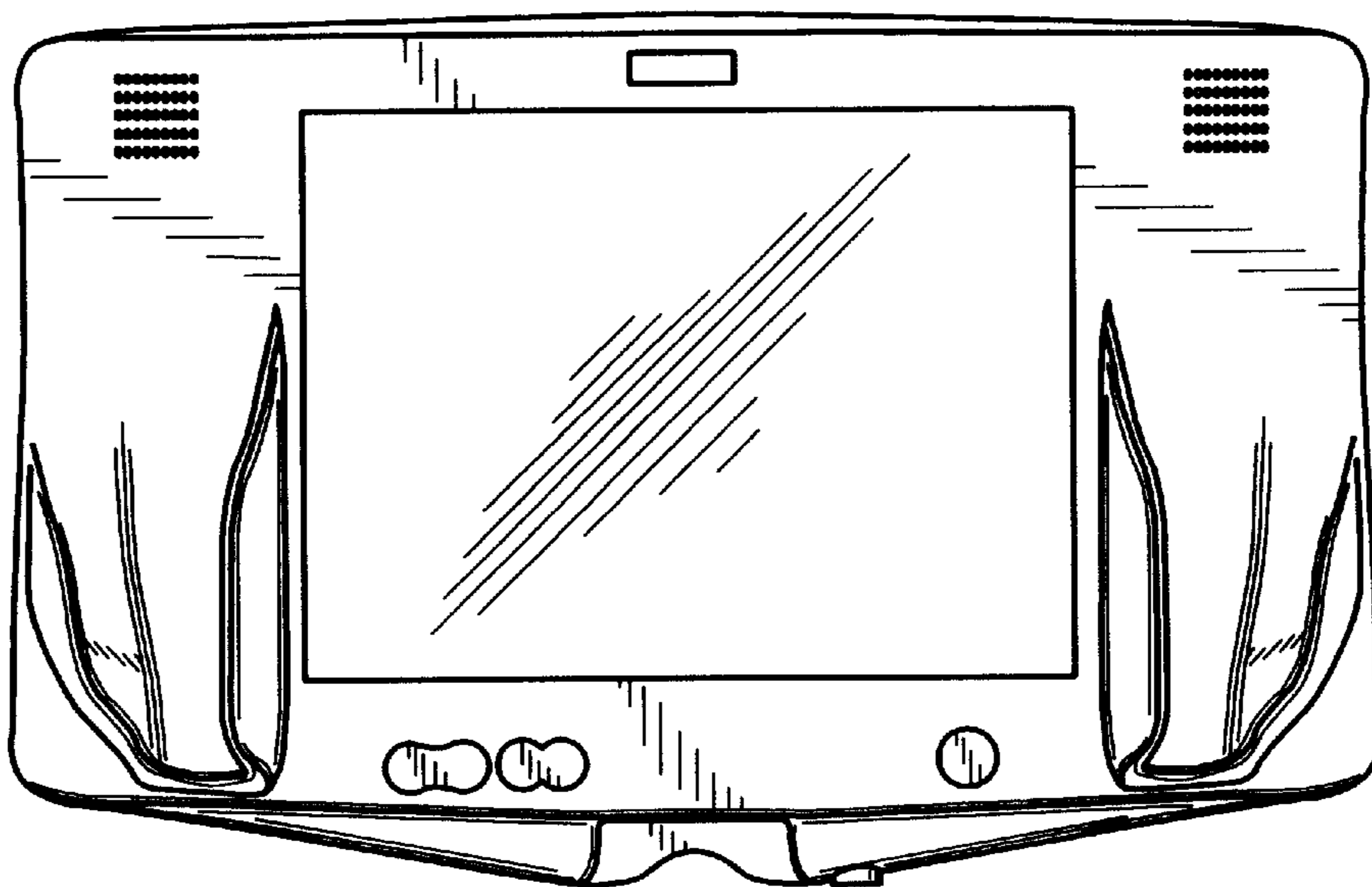
FIG. 1 is a perspective view thereof;

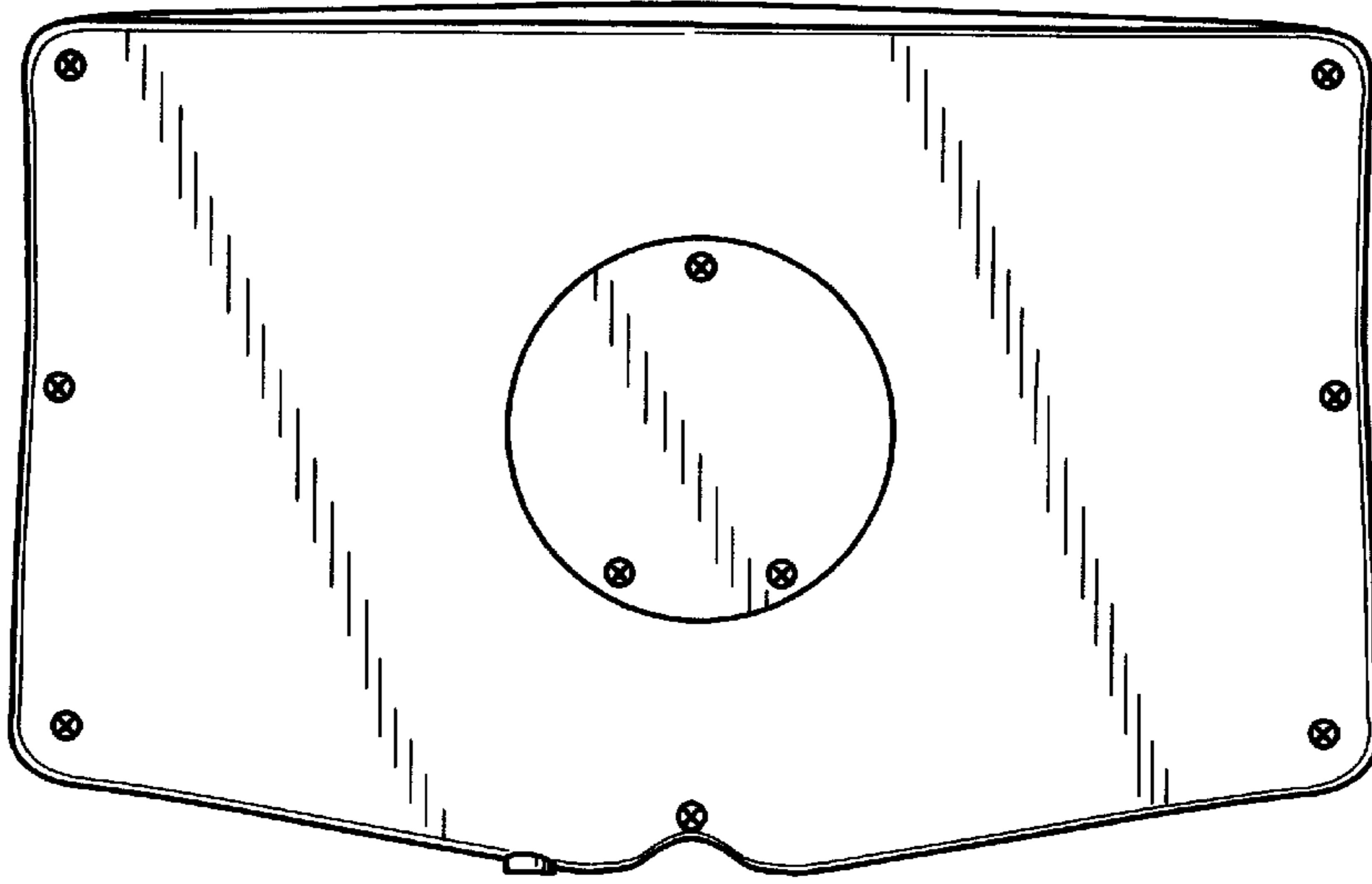

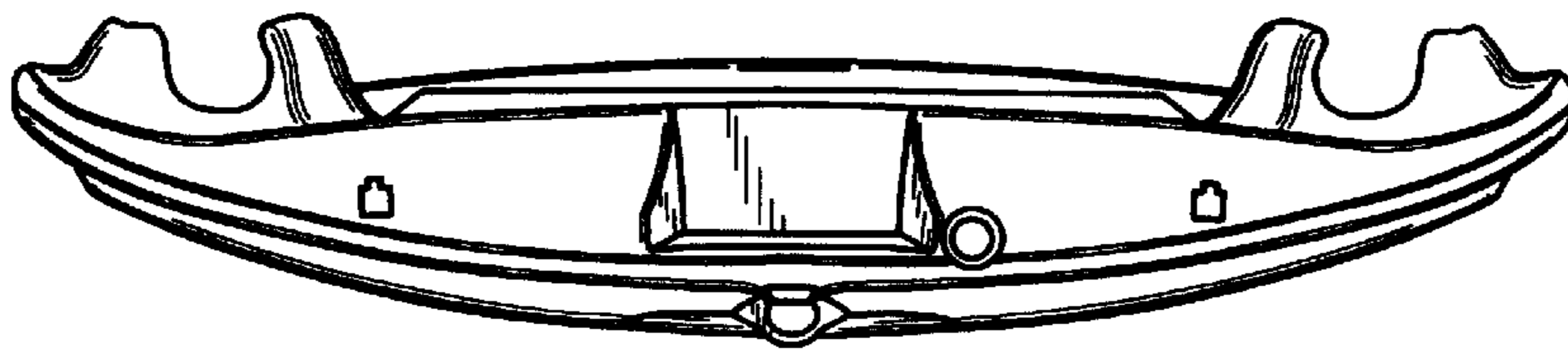

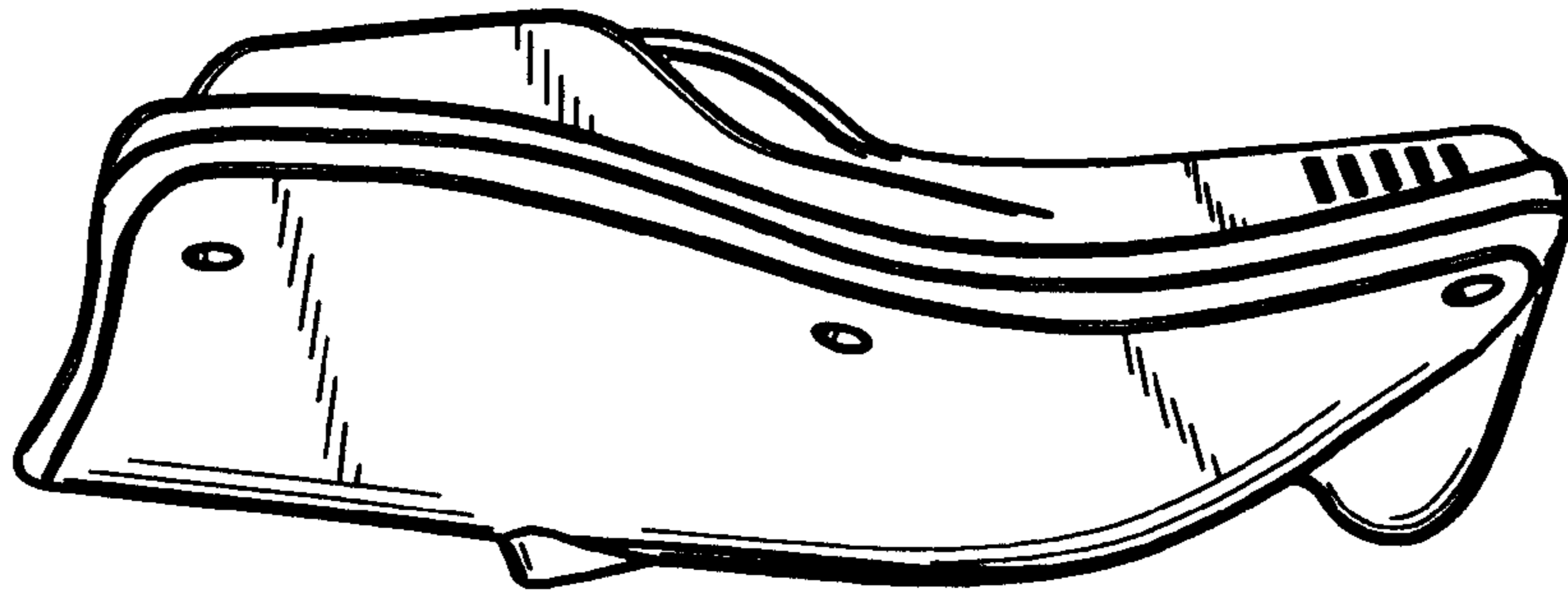

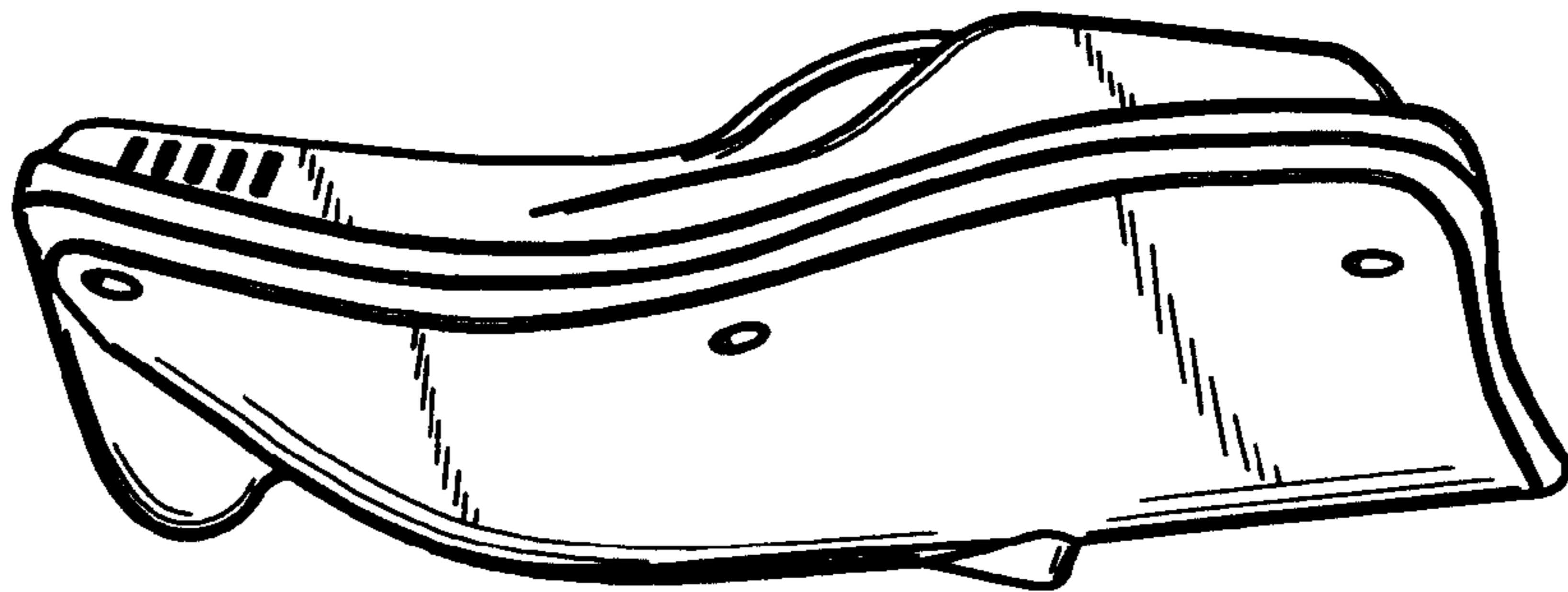
