The broken line drawing of a computer display in both views is for illustrative purposes only and forms no part of the claimed design.

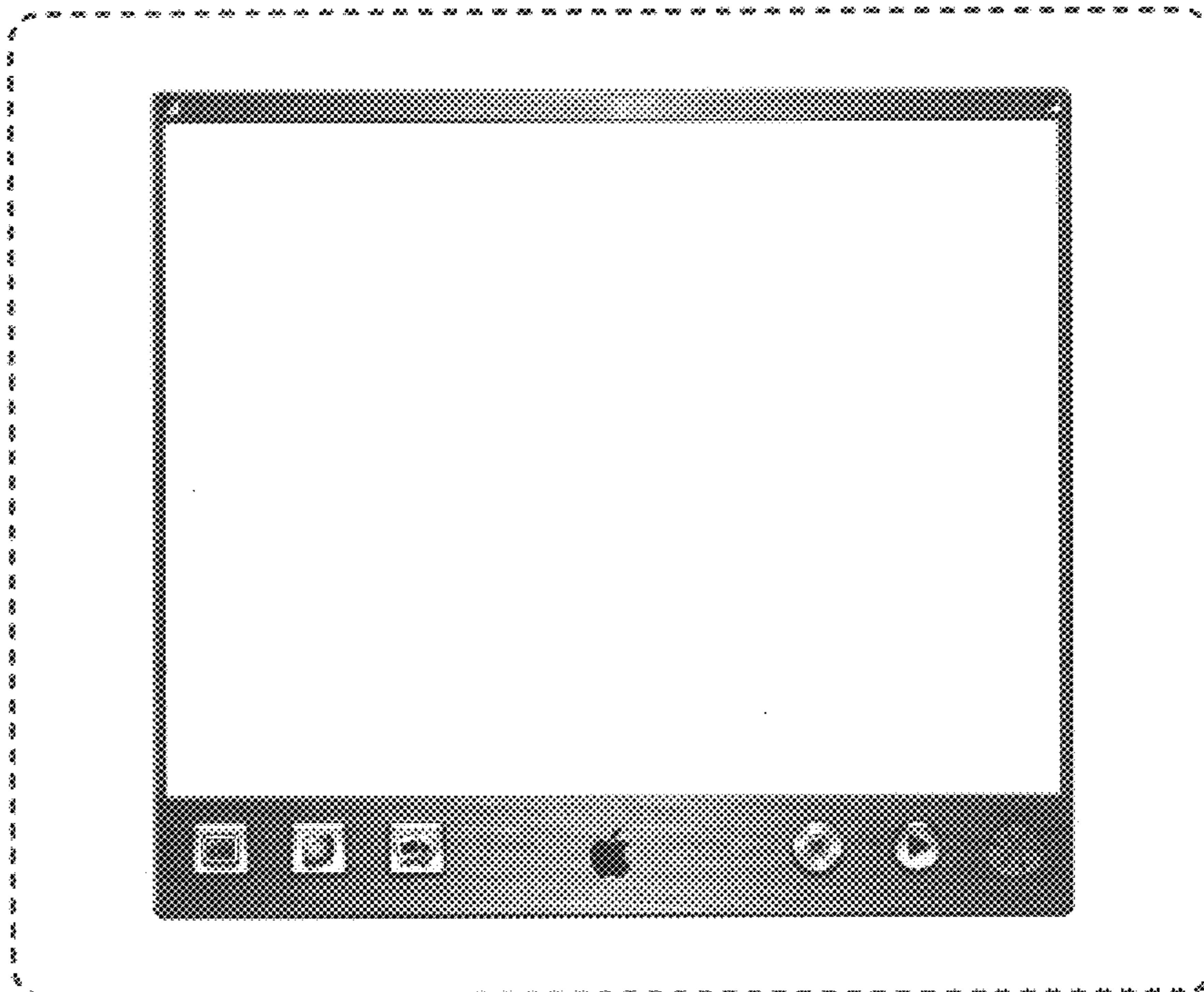

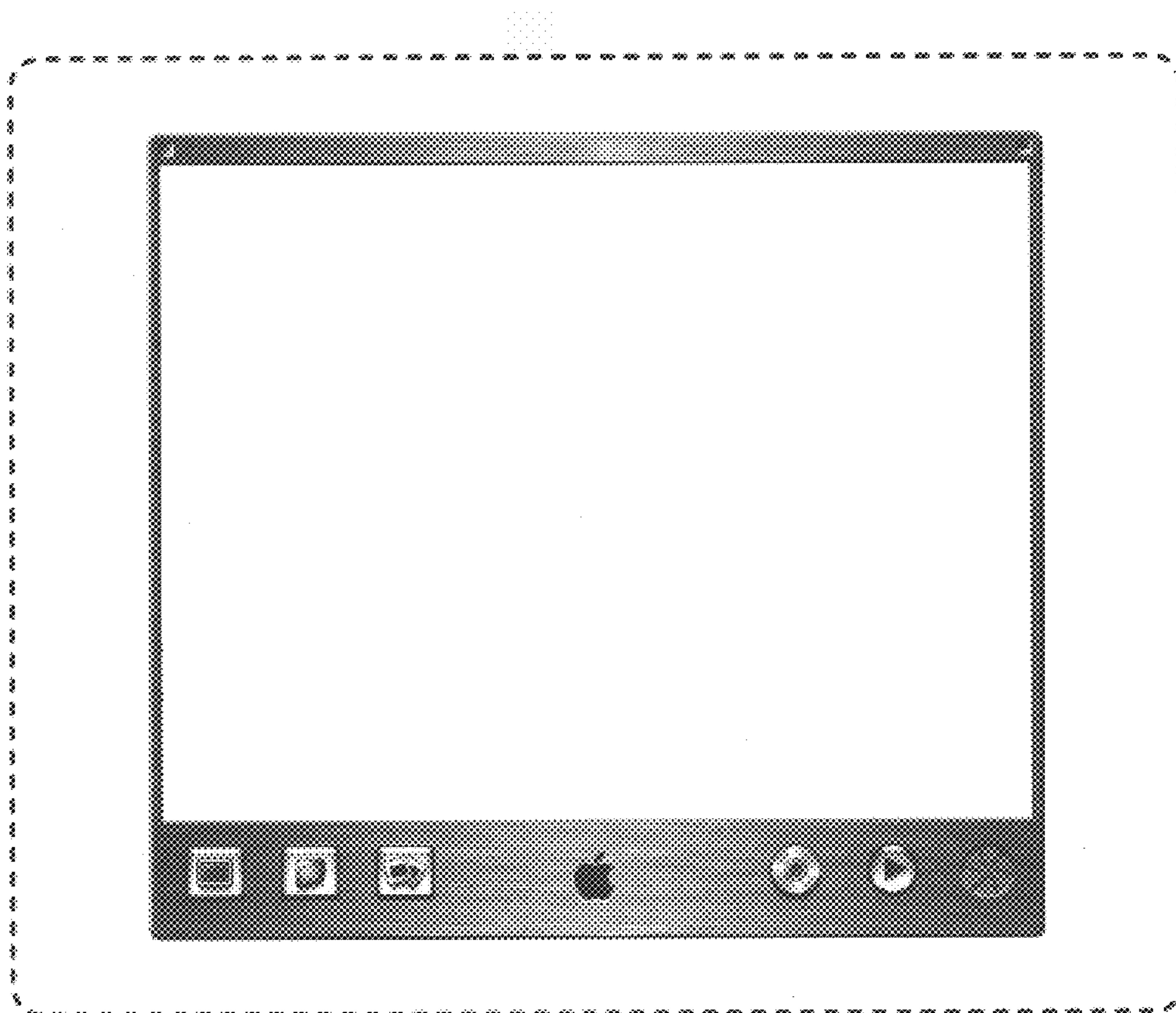
