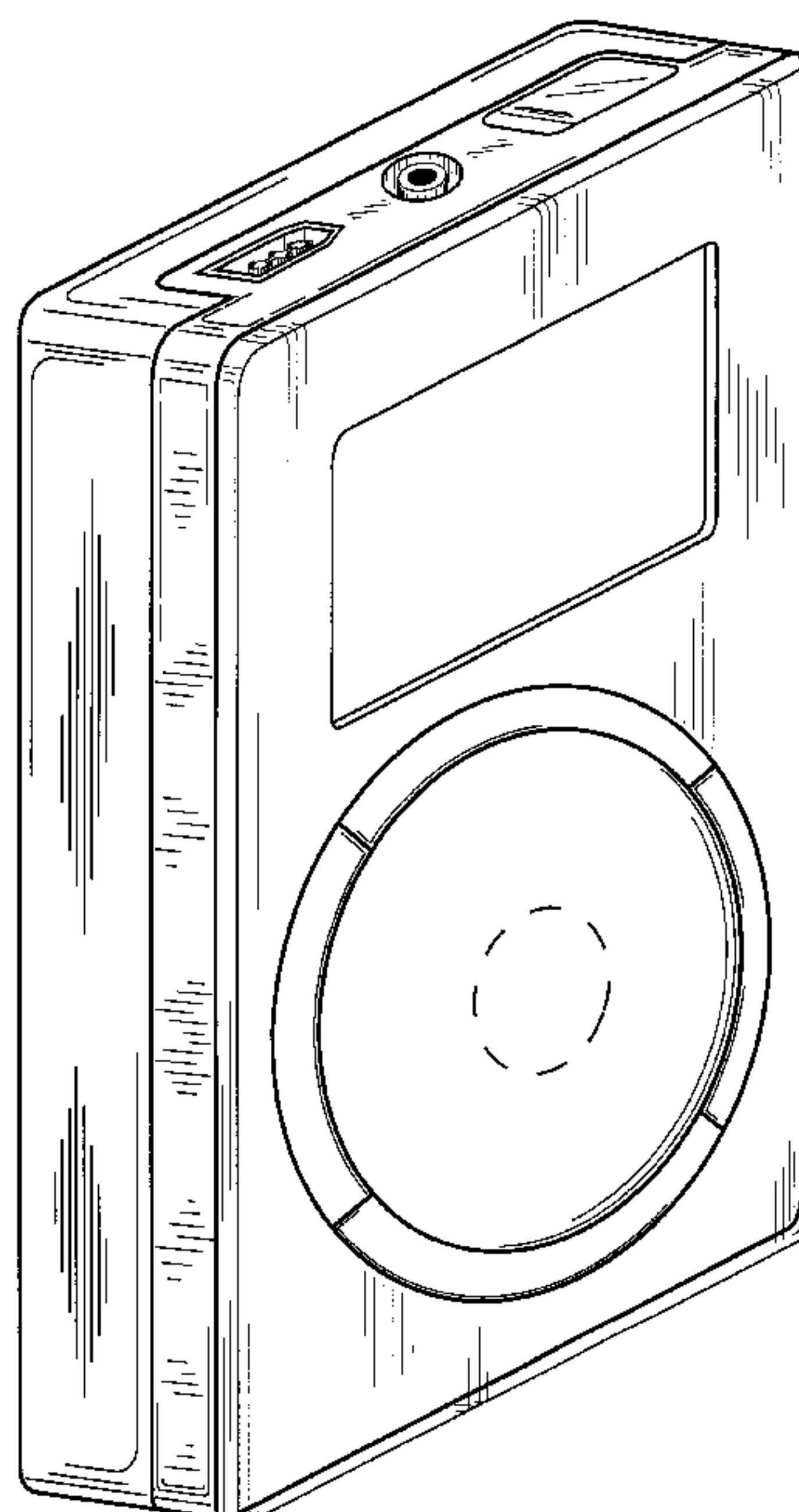
(57) **CLAIM**

We claim the ornamental design for a media player, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a media player in accordance with the present design.
FIG. 2 is a front view for the media player shown in FIG. 1.
FIG. 3 is a left side view for the media player shown in FIG. 1.
FIG. 4 is a right side view for the media player shown in FIG. 1.
FIG. 5 is a bottom view for the media player shown in FIG. 1.
FIG. 6 is a top view for the media player shown in FIG. 1; and,
FIG. 7 is a rear view for the media player shown in FIG. 1.

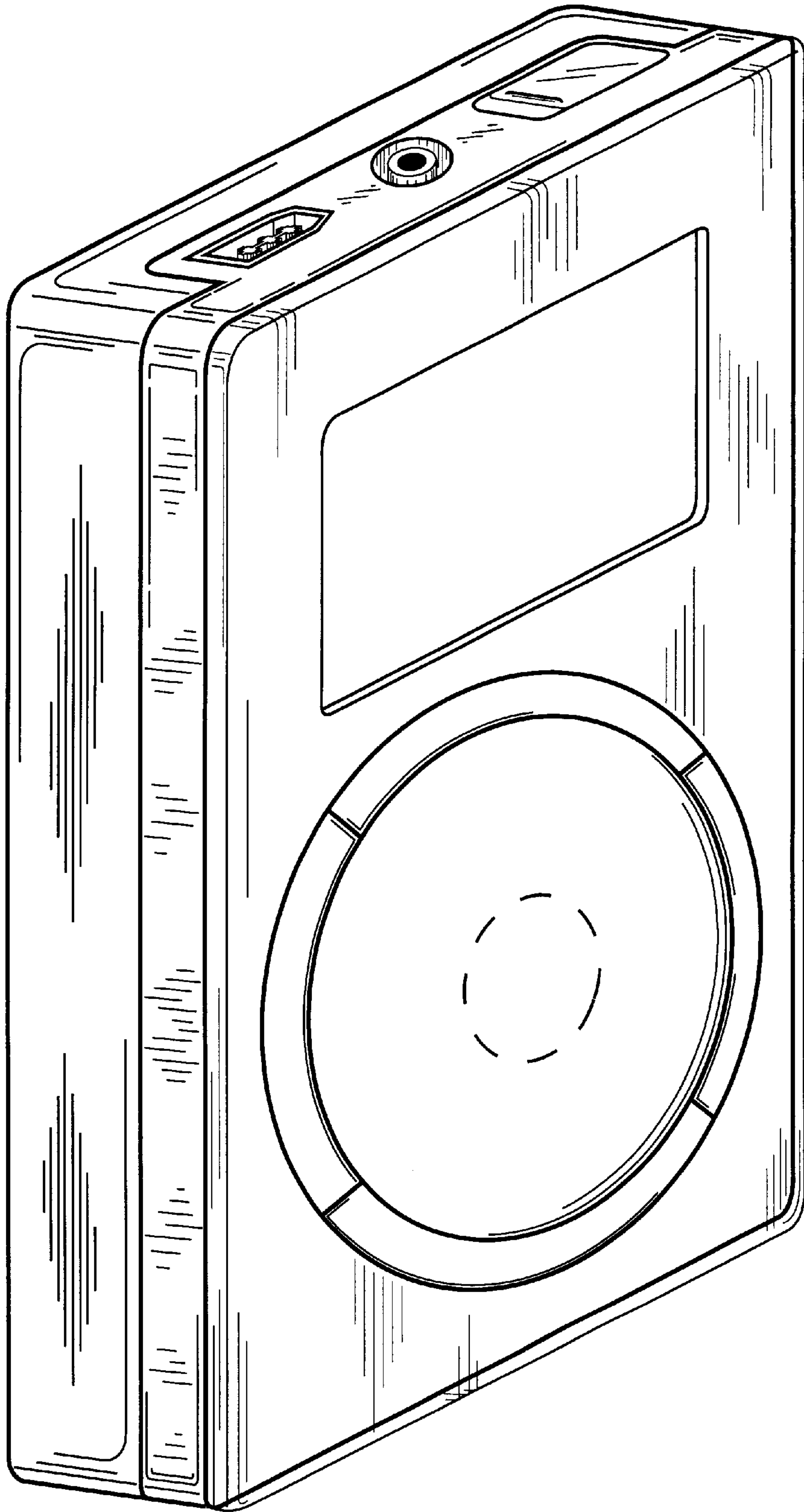

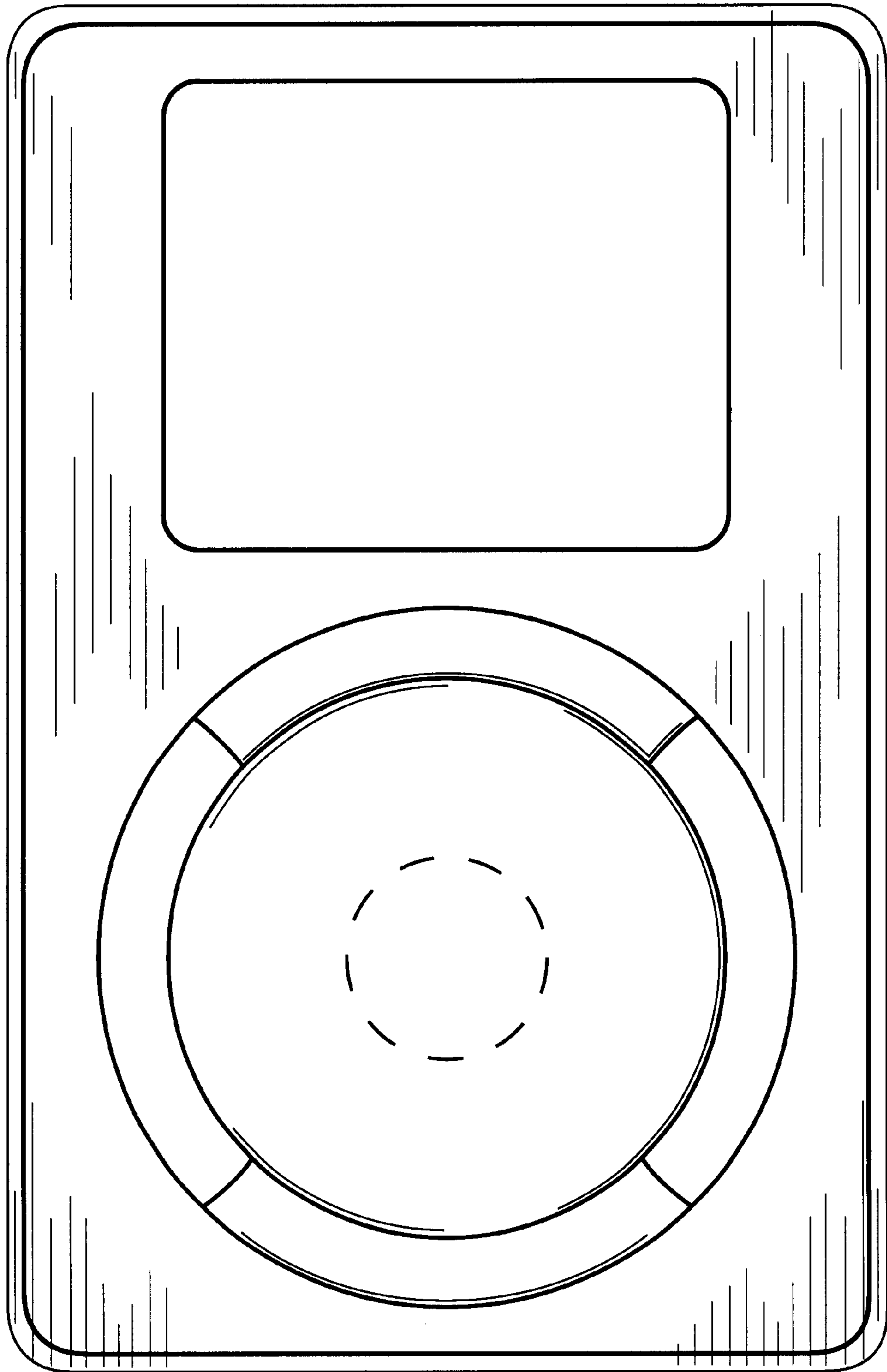

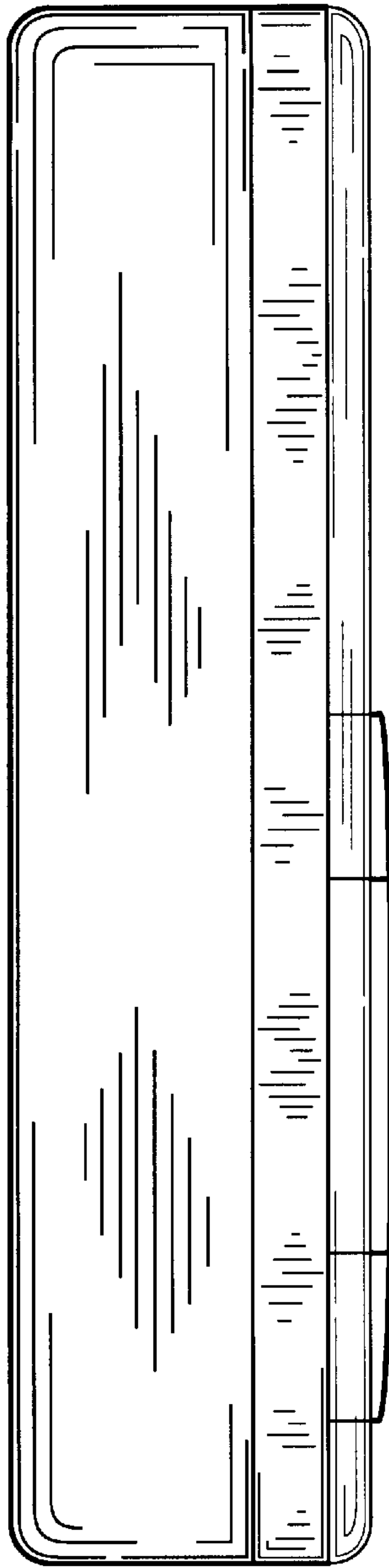

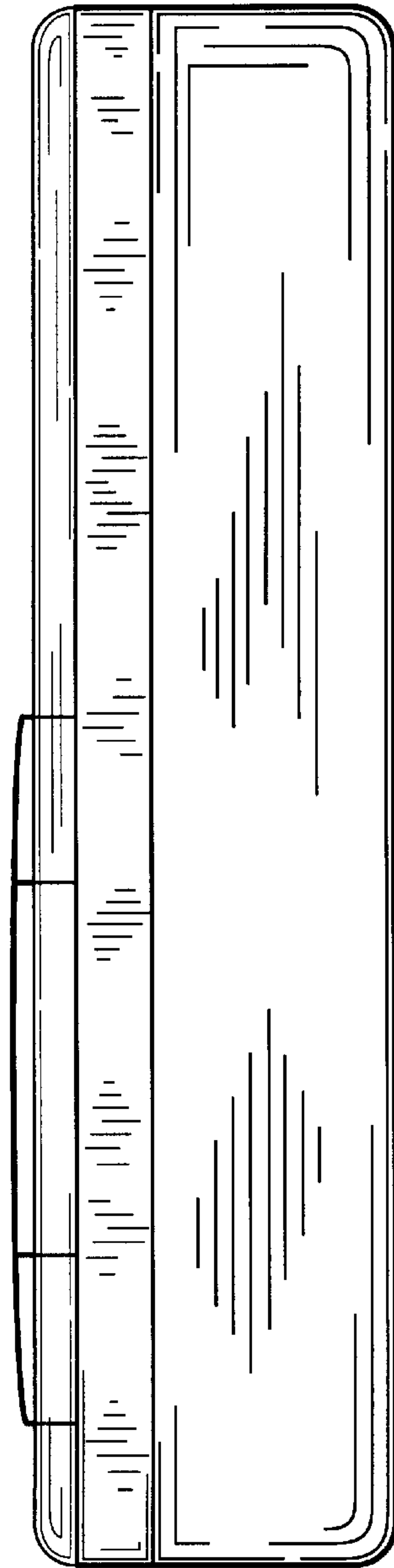

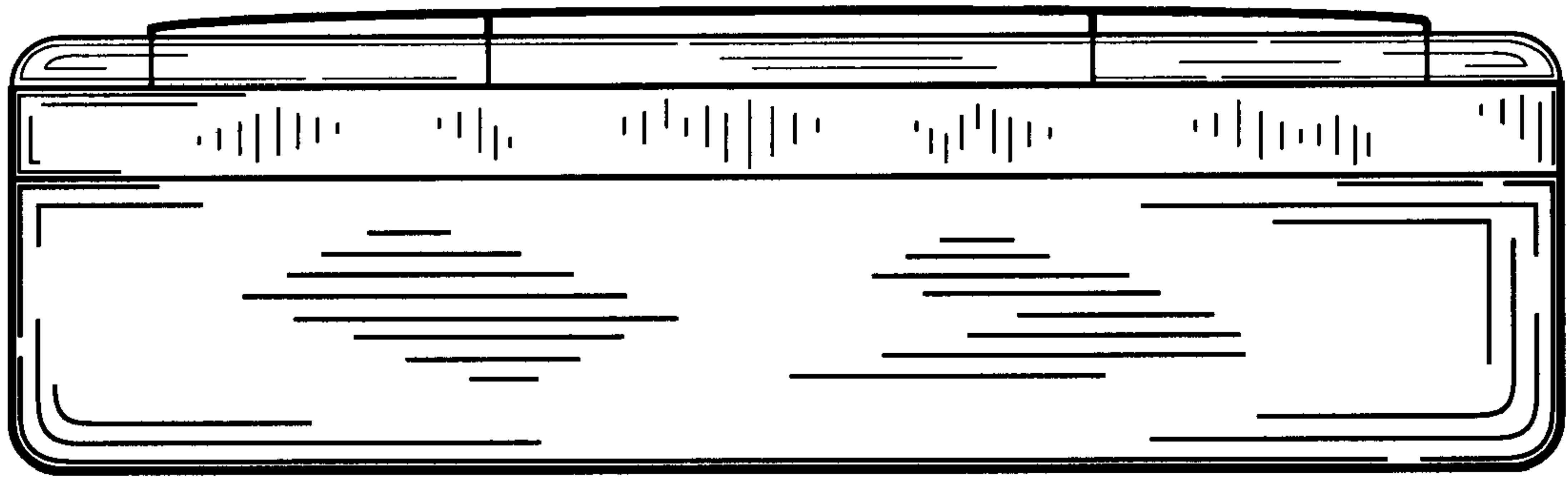

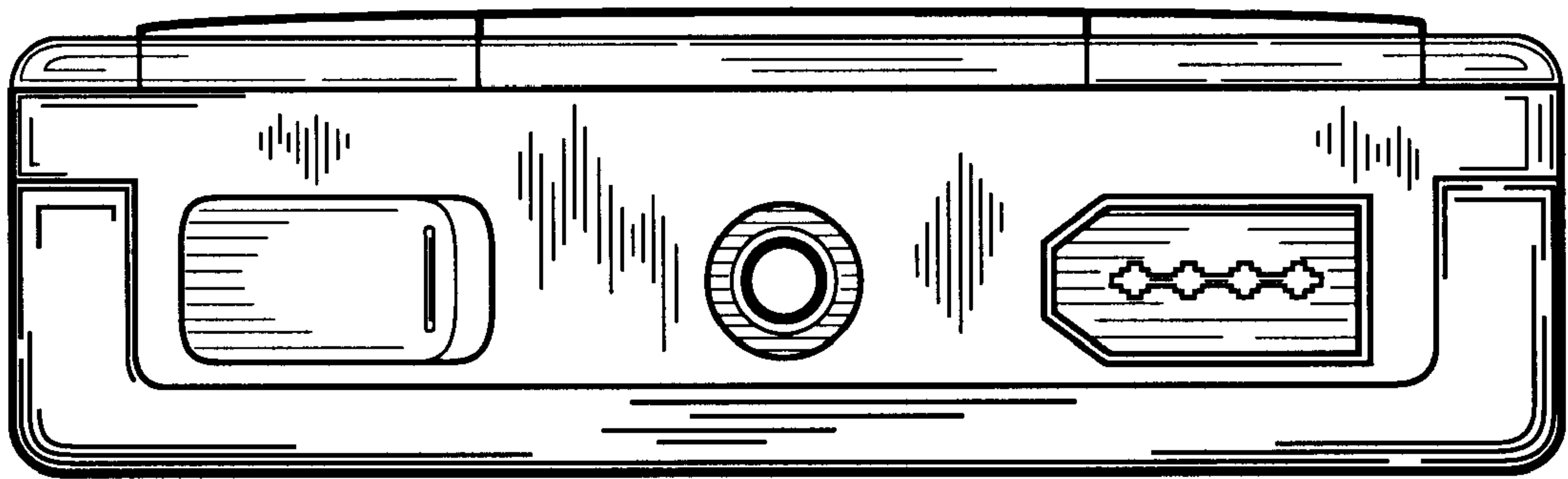

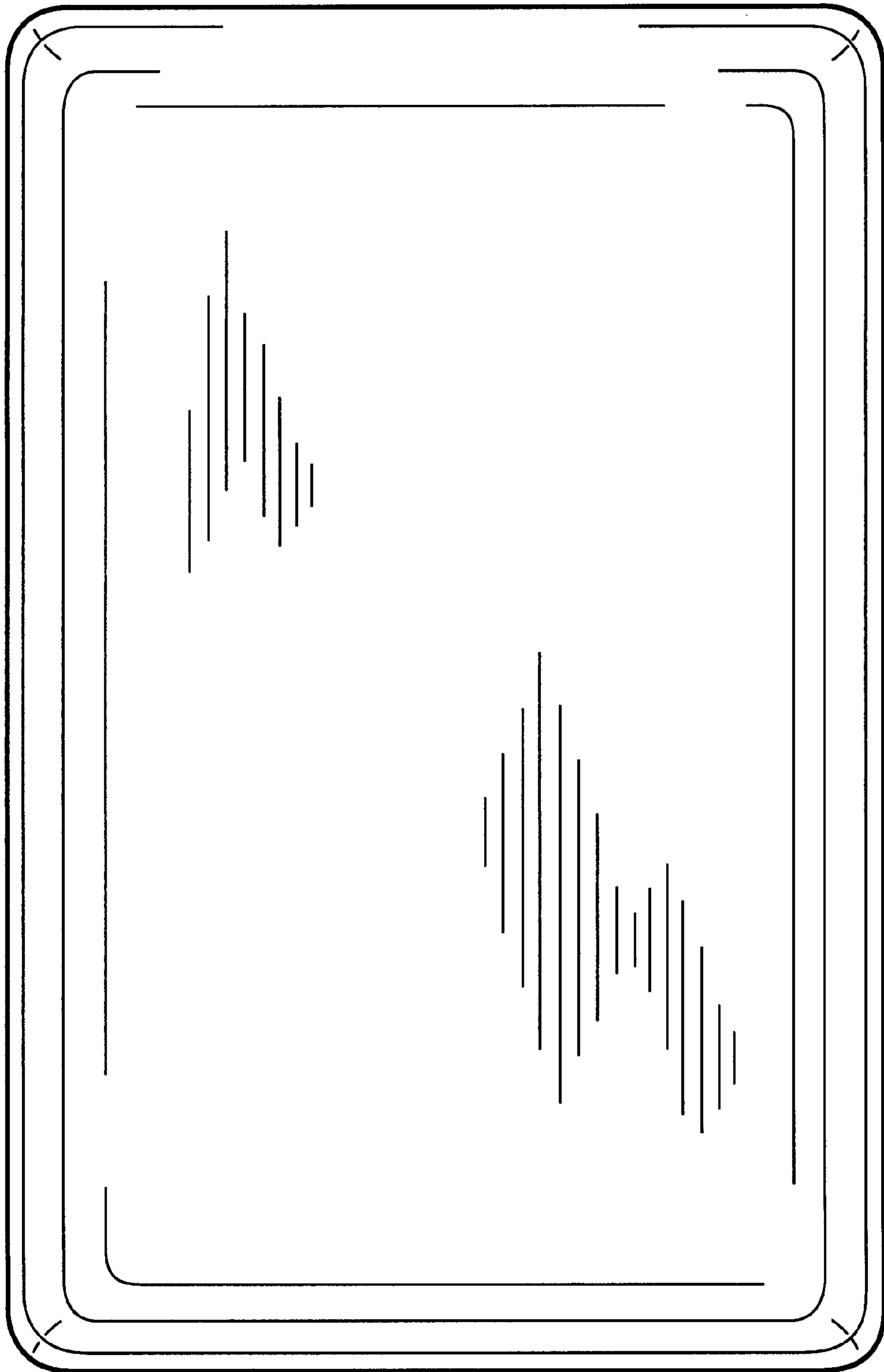
